The following Extract from the proceedings of the Kight Hon'ble the Governor General in Council, in the Legislative Department, under date the 30th November 1840, is published for general information.

Read a second time the Draft of proposed Act date the 3rd June 1839, and published in the Calcutta Gazette of the 8th of the same month, for the protection of moveable and immoveable property against wrongful possession in cases of

Resolution .- The Right Hon'ble the Governor General in Council resolves, that the following amended Draft on the subject, be republished for general information:

ACT No. - OF 1840.

Act for the protection of moveable and immoveable property against wrongful possession in eases of successions.

1. Whereas much inconvenience has been experienced, where persons have died possessed of moveable and immoveable property, and the same has been taken upon pretended claims of right by gift or succession; the difficulty of ascertaining the precise nature of the moveable property in such cases, the opportunities for misappropriating such property and also the profits of real property, the delays of a regular suit when vex-actiously protracted, and the inability of heirs when out of possession to prosecute their rights, affording strong temptations for the employment of force or fraud in order to obtain possession. And whereas, from the above causes, the circumstance of actual possession, when taken upon a succession, does not afford an indication of rightful title equal to that of a decision by a Judge after hearing all parties in a summary suit, though such summary suit may not be sufficient to prevent a party removed from possession thereby from instituting a regular suit,and whereas such summary suit, though it will take away many of the temptations which exist for assuming wrongful possession open a succession will be too tardy a remedy for obviating them all, especially as regards moveable property. And whereas it may be expedient prior to the determination of the summary suit to appoint a Curator to take charge of property upon a succession, where there is reason to apprehend danger of misappropriation, waste or neglect, and where such appointment will, in the opinion of the authority making the same, be beneficial under all the circumstances of the case. And whereas it will be very inconvenient to enterfere with successions to estates by the appointment of Curators, or by summary suits unless satisfactory grounds for such pro-ceedings shall appear, and unless such proceedings shall be required by or on the behalf of parties giving satisfactory proof that they are likely to be materially prejudiced if left to the ordinary remedy of a regular suit;It is hereby enacted, that whenever a person

dies leaving property, moveable or immoveable, it shall be lawful for any person claiming a right by succession thereto, or to any portion thereof, and being out of possession, to make application to the Judge of the Court of the District where any part of the property is found or situate for reliel, either after actual possessiog has been taken by another person, or when opposition is

apprehended.

II. And it is hereby enacted, that it shall be lawful for any agent, relative, or near friend, or for the Court of Wards in cases within their cognizance in the event of any minor disqualified or absent person being entitled by succession to such property as aforesaid, and being out of possession to make the like application for relief.

III. And it is hereby enacted, that the Judge to whom such application shall be made shall,

in the first place enquire by the solemn declaration of the complainant, and by witnesses and documents at his discretion, whether there be strong reasons for believing that the party in possession is holding possession unlawfully, and that the applicant, or the person on whose behalf he applies is really entitled, and that the ap-

plication is made bond fide.

IV. And it is hereby enacted, that in case the Judge shall be satisfied of the existence of such strong grounds of belief but not otherwise, he shall cite the party in possession and give notice of vacant or disturbed possession by publication, and after the expiration of a reasonable time shall determine summarily the right to possession 'subject to regular suit as hereinafter mentioned) and shall deliver possession accordingly-provided always, that the Judge shall have the power to appoint an officer who shall take an inventory of effects, and seal or otherwise secure the same upon being applied to for the purpose without delay, whether he shall have concluded the enquiry necessary for citing the

party in possession or not.

And it is hereby enacted, that in case it shall further appear, upon such application and examination as aforesaid, that danger is to be apprehended of the misappropriation or waste of the property before the summary suit can be determined, and that it is likely to be attended with manifest benefit to the party out of possession, provided he be the lawful owner by succession, and that the delay in obtaining security from the party in possession, or the insufficiency therect is likely to expose the party out of possession to considerable risk, provided he be the lawful owner; it shall be lawful for the Judge to appoint one or more Curators with the powers hereinafter next mentioned, whose authority shall continue according to the terms of his or their respective appointments, and in no case beyond the determination of the summary suit and the confirmation or delivery of possession in consequence thereof. Provided always that, in the case of land, the Judge may delegate to the Collector or to his officer the powers of a Curator, and also that every appointment of a Curator in respect of any property be duly published.

VI. And it is hereby enacted, that the Judge shall have power to authorize such Curator, either to take possession of the property generally, or until security be given by the party in possession or until inventories of the property shall have been made or for any other purpose necessary for securing the property from misappro-priation or waste by the party in possession. Provided always, that it shall be entirely discretionary with the Judge, whether he shall allow the party in possession to continue in such possession on giving security, or not, and any continuance in possession shall be subject to such orders as the Judge may issue touching inventories, or the securing of deeds or other ef-

VII. And it is hereby enacted, that the Judge shall exact from the Curator security for the faithful discharge of his trust, and for rendering satisfactory accounts of the same as hereinafter Smentioned, and may authorize him to receive out of the property such remuneration as shall appear reasonable, but in no case exceeding 5 per centum on the personal property and on the annual profits of the real property, all surplus monies realized by the Cufator shall be paid into Court, and invested in public Securities for the benefit of the persons entitled thereto upon adjudication of the summary suit. Provided always, that although security shall be required

from the Curator with all reasonable despatch; and, where it is practicable, shall be taken go-nerally to answer all cases for which the person may be afterwards appointed Curator, yet no delay in the taking of security shall prevent the Judge from immediately investing the Curator

with the powers of his office.

VIII. And it is hereby enacted, that in all matters regarding the propriety of citing the party in possession, of appointing a Curator, and of nominating individuals to that appointment, the Judge shall demand a report from the Collector, and the Collector is hereby required to furnish the same. In cases of urgency the Judge may proceed, in the first instance, without such report, and he shall not be obliged to act in conformity thereto, but in case of his acting otherwise than according to such report, ho he shall immediately forward a statement of his reasons to the Court of Sudder Dewance Adawlut, and the Court of Sudder Dewanee Adawlut if they shall be dissatisfied with such reasons, shall direct the Judge to proceed conformably to the report of the Collector.

IX. And it is hereby enacted, that the Curator shall be subject to all orders of the Judge regarding the institution or the defence of suits, and that all suits may be instituted or defended in the name of the Curator on behalf of the estate, provided that suits concerning the estate which would be triable before the Judge appointing the Curator shall be triable in the Zillah or City Court nearest to that of such Judge.

X. And it is hereby enacted, that pending the custody of the property by the Curator, is shall be lawful for the Judge to make such allowances as upon a summary investigation of the rights and circumstances of the parties interested, he shall consider that necessity may require, taking at his discretion, security for the repayment thereof with interest, in case the party shall, upon the adjudication of the summary suit, appear not to be entitled thereto.

XI. And it is hereby enacted, that the Curator shall file monthly accounts in abstract, and at the period of every three months, if his administration last so long, and upon giving up the possession of the property file a detailed account of his administration to the satisfaction of the

Judge.

And it is hereby enacted, that after XII. the Judge of any district shall have appointed any Curator, such appointment shall preclude the Judge of any other district within the same Presidency from appointing any other Curator, provided the first appointment be in respect of the whole of the property of the deceased. if the appointment be only in respect of a portion of the property of the deceased, this shall not preclude the appointment within the same Presidency of another Curator in respect of the residue or any portion thereof; provided always, that no Judge shall appoint a Curator or entertain a summary suit in respect of property which is the subject of a summary suit previously instituted under this Act before another Judge- and provided further, that if two or more Curators be appointed by different Judges for several parts of an estate, it shall be lawful for the Sudder Dewanee Adawlut to make such order as it shall think fit for the appointment of one Curator of the whole property.

XIII. And it is hereby provided, that this Act shall not be put in force, unless the aforesaid application to the Judge be made within six months of the decease of the proprietor, whose property, is claimed by right in succession,

XIV. And it is hereby enacted, that this Act shall not be put in force to contravene any act of settlement, or in cases in which the deceased proprietor shall have given legal directions for the possession of his property after his decease in the event of minority or otherwise in opposition to such directions, but in every such case so soon as the Judge having jurisdiction over the property of a deceased person, shall be satisfied of the existence of such directions, he shall give effect thereto, appointing the person indicated thereby to be Curator under this. Act if so desired:

XV. And it is hereby provided, that this Act shall not be put in force; for the purpose of disturbing the possession of the Court of Wards of any Presidency; and in case a minor, or other disqualified person whose property shall be subject to the Court of Wards, shall be the party on whose behalf application is made under this Act, the Judge; if he determines to cite the party in possession and also to appoint a Curator, shall invest the Court of Wards with the Curatorship of the estate, penning the suit without taking such security as aforesaid, and in case the minor or other disqualified person shall, upon the adjudication of the summary suit appear to be entitled to the property, possession shall be delivered to the Court of Wards.

XVI. And it is hereby provided, that nothing in this Act contained shall be any impediment to the bringing of a regular suit either by the party whose application may have been rejected, before or after citing the party in pospession, or by the party who may have been evicted from the possession under this Act.

XVII. And it is hereby enacted, that the decision of the Judge upon the summary suit under this Act shall have no other effect than that of settling the actual possession; but that for this purpose it shall be final, not subject to any appeal or order for review.

Ordered, that the Draft now read be published for general information.

Ordered, that the said Draft be reconsidered at the first Meeting of the Legislative Council of India after the 1st day of March next.

The following Extract from the Proceedings of the Right Hon'ble the Governor General in Council in the Legislative Department, under date the 30th November 1840, is published for general information,

Read a second time the Draft of a proposed Act dated the 3d June 1839, and published in the Calcutta Gazette of the 8th of the same month, for facilitating the collection of debts on successions and for the security of parties in paying debts to the representatives of deceased persons.

Resolution—The Right Hon'ble the Governor General in Council resolves, that the following amended Draft on the subject, be republished for general information:

ACT NO. — OF 1840.

Act for the fecilitating the collection of debts on successions and for the security of parties paying debts to the representatives of deceased persons.

1. Whereas the use of Probates and Letters of Administration in regard to the property of deceased British subjects and other persons

subject to the Supreme Courts, in their Ecclesiastical Jurisdiction, has been found very expedient, as well for enforcing the rights of persons entitled to such property by succession, as also for the security of all persons having trans-actions with them. And whereas the occasional use of Propates and Letters of Administration in respect of the property of deceased Natives of India though voluntarity adopted by their representatives for the sake of the advantages, arising therefrom, has been attended with much expence and inconvenience, besides creating much legal doubt as to the effect of the authority conferred. And whereas it is expedient to give an express legislative sanction to Probates and Letters granted by the Supreme Courts in respect of the property of deceased Natives, and to authorize instruments having the like effect with Probates and Letters of Administration being granted by the Mofssil Courts, but, in either case, for the purpose of recovering debts only, and the security of debtors paying the same ;-

No debt recoverable without a certificate.

It is hereby enacted, that no debtor of any deceased person shall be compelled in any Court of Law to pay his debt to any person clai-

ming to be entitled to the effects of any deceased person or any part thereof, except on the production of a certificate to be obtained in manner hereinafter mentioned, unless the Court shall be of opinion that payment of the debt is withheld from fraudulent or vexatious motives, and not from any reasonable doubt as to the party entitled.

Manner of obtaining certificate.

District Court within the jurisdiction of which any part of the property of the deceased may be found shall have authority to grant a certificate under this Act. The applicant in his petition shall set forth his title. The Judge shall issue notice of application, inviting claimants, and fixing a day for hearing the petition, and in these matters shall proceed as laid down in the Rules in Sections and of Act No.

Government Notes and Dividends.

VII. And it is hereby enacted, that a person certified as aforesaid, may be empowered to receive inter-

est on Government Notes and Dividends on Shares of any Bank or parts thereof, and to uc-gotiate such Securities. He may be also empowered to receive a share of such interest or dividends or to negotiate a share of such Securities. These powers (which shall only arise by express words in the certificate) may be exer-- cised in regard to Government Notes and Certificates of Shares of any Bank, existing within the local jurisdiction of the Supreme Court of that Presidency in which is situate the Court by whom those powers are conferred.

VIII. And it is hereby enacted, that where a certi-Payments under ficate shall have been grantcertificate void by reason of previous ed in cases in which such certificate would be valid, certificate. but for the previous grant of a certificate, all payments made to the person holding the later certificate in ignorance of the grant of the previous certificate shall be held good against Claims under such previous certificate.

IX. And it is hereby enacted, with regard to the real and personal property of deceased persons whose

void. personal property may by law pass to their personal representatives without any Probate or Letters of Administration obtained in any of Her Majesty's Courts of Justice, that no certificate in respect of any such real or personal property shall be valid. If made after a Probate or Letters of Administration granted in respect of the same, provided assets belonging to the deceased were at the time of his death within the jurisdiction of the Court granting the Propate or Letters of Administration.

And it is hereby pro-Bonafide fay- sided, that where a certificate shall have been granted ments protected. in cases in which such cerficate would be valid, but for a Probate or Letters of Administration previously granted, all payments made to the person holding the certificate in ignorance of the previous granting of the Probate or Letters of Administration, shall be held good against claims under the Probate or Letters of Administration so previously granted.

X'l. And it is hereby

Probate or Let- enacted, that no Probate or ters after previous Letters of Administration grant of Certificate, shall be valid for the purpose of the recovery of debts or the security of debtors, after a certificate

granted in respect of the same property for which. such Probate or Letters of Administration shall have been granted, provided assets belonging to the deceased were at the time of his death within the jurisdiction of the Court making such appointment or granting such certificate.

XII. And it is hereby provided, that where Probate or Letters of Administration may have granted, in cases in which such Probate or Let-

ters of Administration would be valid, but for the previous grant of a certificate, all payments made in ignorance of the previous grant of the certificate shall be held good against claims under such previous certificate.

XIII. And it is hereby Effect of Probates declared and enacted, that all Probate and Letters of Administration granted by any of Her Majesty's Courts in cases in which any assets

belonging to deceased persons were, at the time of their deaths, within the jurisdiction of the Court granting the Probate or Letters of Administration, shall have the effect of Probate and Letters of Administration granted in respect of the property of persons whose personal property cannot by law pass to his per-sonal representative without a Probate or Lettors of Administration, but for the purpose of the recovery of debts only, and the security of debtors paying the same ; except so far as is in this Act provided, and except that this Act shall not be construed to make the taking out of Probate or Letters of Administration necessary for succession to property in any case in which it is not now necessary.

XIV. And it is hereby provided, that nothing in this Act contained shall be held to extend to the real or personal property of any person whose personal property cannot by law pass to the personal representative without a Probate or Letters obtained in one of Her Majesty's Courts

THE 23D NOVEMBER, 1840. The following Act passed by the Right Honoble the Governor General of India in Council, on the 23d November 1840, is hereby promulgated

for general information. ACT No. XXII. of 1840.

An' Act for the punishment of Vagrants within the Towns of Calcutta and of Madras, and the Islands of Bombay and Colaba extorting Alms by offensive and disgusting exhibitions and pruc-

Whereas great inconvenience is experienced in the Towns of Calcutta and of Madras, and in the Islands of Bombay and Colaba, from Mendicants who endeavour to extort alms by offensive and disgusting exhibitions and practices ;-

It is hereby enacted, that persons within the Town of Calcutta or of Madras or within the Islands of Bombay and Colaba who shall seek to extort alms by offensively exhibiting any bodily ailment or deformity, or by any offensive or indecent practices or by inflicting, or thereatening to inflict, bodily injury on themselves, shall be liable, on conviction before any Justice of the Peace, to imprisonment with or without labor for a term not exceeding one calendar month.

II. And it is hereby enacted, that all persons guilty a second time of any of the above offences, shall be liable, on conviction before a Justice of the Peace, to imprisonment with hard labor for a term not exceeding twice the period assigned for the first offence, and for the same term upon any subsequent conviction.

III. And it is hereby enacted, that persons guilty of any of the offences abovementioned who shall violently resist any Peace Officer attempting to apprehend them, shall be liable, on conviction before a Justice of the Peace, to imprisonment with or without hard labor for a term not

exceeding three calendar months.

IV. And it is hereby enacted, that it shall be lawful for the Governor General in Council from time to time, by notice in the Gazette, to extend the provisions of this Act to any towns or districts besides the places specified in this Act. T. H. MADDOCK,

The following Act passed by the Right Honorable the Governor General of India in Council, on the 30th November 1840, is hereby promulgated for general information.

ACT NO XXIII. OF 1840.

An Act for executing within the local limits of the jurisdiction of Her Majesty's Courts Legal Process issued by authorities in the Mofussil.

I. Whereas great inconvenience has been experienced, in consequence of the difficulty of procuring the attendance as witnesses before the Mofussil Authorities of persons resident within the local limits of Her Majesty's Supreme Courts, and, in consequence of justice being often frustrated by reason of persons and property within such limits being exempted from process issued by such authorities, which has also occasioned inconvenience to the inhabitants within such limits, in suits in the Mofussil Courts to which

they are parties;-

It is hereby enacted, that any Writ, Warrant, or other Process issued by any Court, Judge, or Magistrate in the territories beyond the local limits of the Supreme Courts of Calcutta, Madras and Bombay respectively, may be executed within those limits in manner following—A copy of such Writ, Warrant, or other Process authenticated as such by the attestation of the Court, Judge, or Magistrate signing or issuing the same, accompanied by a certified translation in the English language, shall be presented to any Judge of Her Majesty's Courts, who may thereupon, under his hand and signature, indorse and direct the same to be executed within the local limits of any of Her Majesty's Courts by the Sheriff or by any Justice of the Peace according to the nature of such Writ, Warrant or other

II. And it is hereby provided, that upon the delivery of every such Writ, Warrant or Process so indorsed as aforesaid to any such Sheriff as aforesaid, every such Sheriff shall make a memorandum of the date of such delivery, and shall execute such Writ, Warrant or Process in like manner as if the same had originally issued from any of Her Majesty's Courts and had been delivered at the date as appearing by the memoran-

dum ; and such Sheriff shall make no distinction as to priority or otherwise between the execu-tion of any Writ. Warrant or other Process originally issued from any of Her Majesty's Courts, and the execution of any Writ, Warrant or other Process, under this Act. But every Writ, Warrant and other Process, whether ori-ginal or indersed as aforesaid shall, amongst ginal or indorsed as aforesaid, shall, amongst each other, be subject to the same rules touching the mode and order of execution as are now established in respect of Writs, Warrants, and other Process originally issued from Her Majesty's Courts of Justice.

III. And it is hereby enacted, that every such Sheriff shall be liable to be proceeded against in Her Majesty's Courts of Justice for all matters touching the execution of any Writ, Warrant or other Process executed under this Act, in like manner as if the same had originally issued from any of Her Majesty's Courts of Justice. And all persons and property seized or detained under any Writ, Warrant or Process executed by virtue of this Act shall be dealt with in like manner as if such persons or property had been seized or detained under the like Writ, Warrant or other Process issued from any of Her Majesty's Courts of Justice.

IV. And it is hereby enacted, that all persons disobeying or obstructing the execution of any Writ, Warrant or other Process indorsed under this Act, shall be punishable in Her Majesty's Courts of Justice, in like manner as if the same had issued from such Courts; Provided always that, in the case of process for the atten-dance of witnesses, Her Majesty's Courts shall be governed by the like rules touching expences and other matters as are established in regard to

Subpoenas issued from such Courts.

V. And it is hereby enacted, in the case of persons seized or detained by virtue of any Writ. Warrant or other Process executed under the authority of this Act by any Justice of the Peace or by any Sheriff, it shall be the duty of every such Sheriff or Justice of the Peace if so required by the indorsement of the Judge, to deliver the party in custody to such authority or persons as shall be particularly specified in such indorsement, been and who shall have charged with the execution of the Writ, Warrant or other Process by the authority, originally issuing the same, and for that purpose to cause the party in custody to be conveyed to any place within the Company's territories foyond the local limits of the jurisdiction of Her Majesty's Courts.

. VI. And it is hereby provided, that in the case of any Writ, Warrant or other Process required to be indersed under the authority of this Act, it shall be lawful for the Judge who shall be required to indorse the same, to remit the same for amendment to the authority issuing the same if the same shall appear to to defective in

any matter of form.
VII. And it is hereby provided, that in the case of any Writ, Warrant on other Brocess required to be indorsed under the authority of this Act, for the seizure or detention of any person, it shall be lawful for the Judge who shall be required to indorse the same to direct by indorsement that bail (the amount and number of Sure? ties to be specified in such indorsement) may be taken; and for this purpose to call for such decuments and to make such enquiry as he shall

think proper.

VIII. And whereas it is expedient, that of fenders sentenced by the Molussil authorities to imprisonment with or without hard labour,

It is with feelings of the deepest concern, that I forward for the information of the Honorable the Governor of Bombay in Council, the Report of a reverse which has befallen a Detachment of this Brigade under command of Major Clibborn, sent to the relief of the Murree Fort of Kahun, at present held by a Detachment of the 5th Regiment Native Infantry; the details of this disastrous occurrence are fully entered into by Major Clibborn, and it is evident, that our total ignorance of the impracticability of the road, of the opposition that was likely to be offered, and of the Stations where water was procurable (notwithstanding this very spot was so recently the scene of Lieutenant Clarke's misfortune) had led to this severe check to our Arms.

I should premise, that in consequence of arrangements made by the late Brigadier Stevenson, C. B. to

relieve the Kahun Out-post, whose provisions are half allowance, were calculated to last till the 10th instant only, I directed the march of a Force of the strength, noted in the margin, on the 12th ultimo from Sukkur, under Major Clibborn's Command. My instruction to that Officer were to leave 200 of his own Regiment and a two month's supply of provisions in the Fort, and to bring away the Detachment of the 5th Regiment Native Infantry. The information received from the Political authorities was such, as to lead me to believe, that the strength of the Force was not only fully adequate to overcome any opposition that it might meet with, but that its numbers were greater than the exigency of the service required. To avoid all risk however, I objected to withdraw a single Man; but the impracticable nature of the Country, and the want of Water on the road, has set all my calculations

at defiance. The behaviour of the Troops (many of them young Recruits recently joined the Ranks) under severe privation, when attacked by an overwhelming Force, merits the highest praise; and the cool and determined conduct of Major Clibborn under such trying circumstances, although his efforts were unavailing, termined conducted Major Clibborn under such trying circumstances, although his efforts were unavailing, entitles him to the greatest credit. The long list of killed, including, I regiet to say, four European Officers, and the very small proportion of wounded (so contrary to the usual contingencies on such occasions) shews the undaunted bravery with which the Troops fought; their galantry was however unavailable against the pressing want of thirst; and they had the mortification of being obliged to sacrifica their Gues, Treasure, Stores and Materials, from inability to move them, and retreat before an Enemy they had defeated. In addition to the heavy loss the service has sustained in the Officers who fell in the action, I have to regret the death of Captain Heighington of the Ist Grenadiers, of over-exertion and fatigue, the day after his eturn from the Hills; but I sincerely trust, that this will be the last of our casualties.—Major Clibborn notices the gallant bravery of Lieutenant Lock of the Poona Irregular, and Lieutenant Malcolm of the Scinde Horse, and the great number of their Men who fell, shows, how nobly they did their duty. and the great number of their Men who fell, shows, how nobly they did their duty.

It is unnecessary for me to comment any further on this melancholy disaster, as the report will, Itrust, prove to His Excellency the Governor in Council, that nothing was wanting on the part of either Officers or Men, to endeavour to carry thro' the service on which they were ordered; circumstances over

which they had no controll, have led to their failure; but altho' unfortunate, I trust they may not be deemed unworthy of the praise they have so nobly sought.

SIR,

It is with feelings of the deepest pain, that I have to acquaint you, for the information of the Officer Commanding in Upper Scinde, with the total failure of the Convoy intended to have thrown supplies into the Murree Fort of Kahun. The impracticability of the route, defended by an active Enemy, and the absolute want of Water at the Pass of Nufoosk have been the cause of this sad disaster.

I must here observe, that on the 29th ultime, the Convoy encamped at the mouth of the Pass of Surtof, where Lieutenani Clarke's party was cut up, and at 2 A. M. on the morning of the 30th August, commenced the ascent over this Mountain Pass, one mile in extent; and by unceasing exertions on the part of the Seapoys, the Guns and Stores were dragged and convoyed to the halting ground on the top, by 6 o'clock P. M. through a burning sun:—there we halted till 2 A. M. of the 31st, to rest the Castle, but the Troops were obliged to be under Arms the greater part of the night, in consequence of the Enemy's Skirmishers firing into our Camp, and the Men therefore got little rest after their severe labour of the previous day. At 2 A. M. we marched for the encamping ground below the Pass of Nufoosk, distance 6 miles. At day light we approached slowly on a good road to the foot of the second range of Mountains, through which lay the route to Kahun, and here the road strikes off to the right immediately under the base of the Mountain, passing over ruts and ra-vines that presented obstacles to the passage of the Guus, which were surmounted by the cheerful and uncea-sing exertions of the Seapoys; but their labours were greatly increased by the upsetting here of one of the 12 pr. Howitzers with the Limber and Horses; however, after great perseverence and labour, the advance of the Convoy consisting of six Divisions of Infantry, about 450 Strong, 2-12 pr. Howitzers, and 50 of the Sinde Horse, arrived at the halting ground. On approaching the Mountains, we could perceive considerable bodies of the Enemy crowning the heights, who kept up a brisk fire on the Convoy while approaching its ground. The Guns were placed in position to enfilled the summit of the Pass in front of us, which to our wearied and exhausted Troops rose in a zig-zag course up the side of a precipitous Mountain. It was now 10 A. M. and the heat fearfully oppressive.—A Letter from Captain Browne, in Kahun, of the 27th ultimo, reported that abundance of Water had fallen, and no doubt we should find a sufficiency at our ground. The reports of the Guides on arrival were, that there was no Water, and the little remaining in the wretched Pauckauls from the last halting ground on the top of the Surtof Pass (where neither Water or Forage exists) was dried up. Under these circumstances it was evident, that the whole Force and Cattle must perish from thirst, unless the Pass of Nufoosk be carried, beyond which, water was said to be procurable, and the Fort of Kahun distant about 6 miles. I waited anxiously till a past I A. M. for the arrival of the Rear Guard, consisting of 1st and 2nd Com- the Right Flank Company of the 1st Grenadier Regiment, one Howitzer, and the Poona manies about 160 Horse under Lieutenant Lock. At 2 A. M. the dispositions for attacking the Pass were made, and the Left Flank Companies of the 1st and 2nd Grenadier Regiments attached to the Convoy were appointed to storm the Height, supported by the remaining divisions, 317 Strong, leaving the Colors of the Regiment under charge of the Right Flank Company. During the whole of the morning we were exposed to the fire of muskery, taken, no doubt, from Lieutenant Clarke's party. At about 2 P. M. the Flank Companies of the 1st and 2d Grenadiers were led on with admirable coolness and order by Captain Raitt, 1st Grenadiers, supported by the remaining Companies, 1st Grenadiers, and 50 Volunteers Poonah Auxiliary Horse, under Lieutenant Lock, who kept up a galling fire on such of the Enemy as appeared above the crest of the Mountain, and the Howitzer threw Shrapnel, shells to clear the head of the Pass, while the storming party advanced up the steep face of the Mountain .- It was perceived that the road, at all times barely practicable for Guns, had been altogether destroyed, and in many places admitted of only one Man advancing at a time, and in other parts breast-works surmounted by thorn-bushes were built across the road. The Enemy opened a heavy fire, and many fell, but the ledge of the head of the Pass was gained, and the party ready to rush on, when a dense mass of the Enemy rose above the crest of the Mountain, and overwhelmed the storming party with musketry, and showers of stones; while others fell on them with their Sabres, committing a fearful havock on the retreating Scapoys. I immediately ordered in the advance Companies to the support of the Guns and Colors; about eight hundred of the Enemy rushed down the Mountain with the most determined gallantry, and with such impetuosity, that I had barely time to form them, and some confusion ensued, greatly to be attributed to the numerous raw Recruits, I was obliged to put into the Ranks for the present service.—The Men however fought well, and kept up so, brisk a fire, that with several well-applied rounds of Grape from Captain Stamford's Howitzers, the Enemy was repulsed with considerable slaughter, leaving about 200 and upwards lying dead on the Field, and in the Nullah around.

I lament to report, that our loss in the assault has fallen heavily on the European Officers and the service; and his Regiment have sustained a severe loss in Captain Raitt, 1st Grenadiers, who fell leading the storming partys. I also lament to report the loss of Lieutenant Moore, 1st Grenadiers, and Lieutenant Franklin, and Ensign Williams, 2d Grenadiers, killed; and Lieutenant Lock of the Poona Auxiliary Horse (who with 50 Men of the Ressallah gallantly volunteered to act as Skirmishers in the assault) was severely wounded, but I am happy to say, he is out of danger. The accompanying report will place the Commanding Officer in

possession of the heavy loss that my Regiment has sustained in the action at the Pass of Nufoosk, and it was during the attack of the Enemy on the Colors of the Regiment, that the greatest part of the Convoy was driven off.

The Enemy had been repulsed with great slaughter, and most of their influential Men were lying dead around us; yet the Pass remained in their possession, and their numbers were very great;—in fact, the combined tribes of the Beelochees amounting to several thousands. At this period, about \( \frac{1}{2} \) past \( 3 \) P. M. the heat was dreadfully intense, and the sufferings of the Men and Cattle, from exhaustion and thirst, became painfully apparent; and the Guide Meer Hussain having reported, that they had discovered Water in a Nullah about & a coss off, I immediately ordered the whole of the Puckaul Bheesties, and Camel Puckauls, with the Gun Horses under the Escort of fifty of the Irregular Horse to proceed for Water, and many of the Officers' Horse accompanied the Escort; but the heat and thirst increased, and the cries of the wounded and dying for Water! Water! was unceasing. The few bottles of Beer among the Officers' baggage, given at first to allay the wants of the greatest sufferers, gave rise latterly to scenes of absolute frenzy and dispair. In this manner we remained till sun-set, anxiously awaiting the arrival of the Water-party, while an occasional fire of Musketry from the heights, replied to by our Guns, continued. About suu-set some strugglers from the Water-party came in, reporting that the Water-party had been surrounded in a Nullah; others that the Guides had acted treacherously, and led off the whole party to Surtof. Under these circumstances it became necessary to determine what should be done; I had already lost about 150 Men of my small Force, (small, when the nature of the country and the size of the Convoy, were to be considered) the re-mainder were infeebled with thirst, and the exertions of the two previous days; and to add our different difficulties, most of the Camel-men, Dooly-bearers &c. had absconded during the action, after plundering the Commissariat of loads of Flour, &c. The Gun Horses were gone, and the Men of the Golundauze so prostrated from fatigue and thirst, that latterly they could scarcely rise to fire a Gun. In this state, I found it impossible, allowing that I made a successful attack on the Pass, to Convoy either the Stores or Guns over it, particularly as the road had been destroyed, and after a mature deliberation. I found that it would be impracticable to carry out the object of the Convoy to throw provisions into Kahun; and further that unless the Water-party, Horses, &c. returned soon, my whole Force, Cattle and Followers, must perish of thirst; the sad alternative devolved upon me, of deciding on the abandonment of the unfortunate Garrison of Kahun, the Stores and Materials of the Detachment, and the chance presented itself by a rapid retreat to the water at Surtof, of saving my Troops and numerous Followers, with such Carriage and Stores as their infeebled state would permit me to bring off; I therefore resolved, unless the Gun Horses and Water arrived by 10 P. M., to move of quietly with my Troops; and such continuing to be the case at that hour, I directed Captain Stamford to spike his Guns, and we moved off with as much quietness as the frantic state of the Men would permit. I am grieved to add, we were obliged to abandon everything, Stores, Guns, Camp Equipage, &c. the desertion of the Camel-drivers having put it out of my power to remove them. The wounded were carried on Camels, and by day-light we had partly descended the Pass of Surtof, when the Baggage and Stores, with all the Treasure, Regimental, and the remainder of the Commissariat fell into the hands of the Enemy. Many Followers were here massacred. Without food or Tents, it was impossible that the Detachment could rest till it reached Poolajee, and a merciful Providence had enabled me to conduct with safety to this place the Detachment under my Command.— Many deaths have occurred from the heat and incessant marching; but I hope to see the Men recover after a few days rest.—At present I have put the whole under Horse sheds at Poolajee, and have every hope, with assistance from Mejor Smee at Lehree, on being able to move on shortly to Sukkur; for, excepting its Arms and the Colors of the Regiment, the Detachment is completely disorganized.

I forgot to mention, that the unfortunate Water-party was surrounded in a Nullah, and with the exception of 25 Gun Horses, a few Followers and private Horses, was cut up; the Survivors joined us on the march during the whole progress, at this inclement season of heat, of this Detachment I have been indebted to Lieutenants Lock and Malcolm, for their cheerful and arduous exertions, and therefore respectfully mention their names, as deserving every commendation. In conclusion of this mortifying tissue of disasters, occasioned solely by the intense heat, thirst, and too sanguine reports of a route altogether impracticable, if opposed by a determined and active Enemy such as the Murrees have proved themselves to be, I, as the unfortunate Commander of the above responsible Convoy, earnestly solicit, that a rigid enquiry may be instituted into my conduct.

THE MAJOR OF BRIGADE, UPPER SINDE,

SIR.

I have the honor to address you, with reference to my report of the 4th instant, conveying the disastrous intelligence of the failure of my Convoy, to effect the relief of Kahun; as on reperusal of that report, on my arrival here, I find that from having only partially noticed the exertions of individual Officers under my Command, an erroneous impression may have been conveyed, that I was dissatisfied with the conduct of the majority, whereby, not only much injustice would be done both to the 1st Grenadier Regiment and Detachment 2nd Grenadiers under my orders, but also to the Officers serving with them on that arduous sorvice, I had every reason to applaud the generally correct and Soldier-like manner in which the laborious duties of the Convoy were carried on both by Officers and Men, whether on Picquet, Rear Guard, or other duties that unavoidably exposed them to the heat of this scorching region.

In forwarding a general list of recommendations, I omitted to express my obligations to Ensign Stanley, 5th Regiment Native Infantry, who joined my Corps at Poolajee, to assist in bringing down Captam Browne's Detachment 5th Regiment Native Infantry, when relieved from Kahun, and who took charge of one of the Howitzers, in the action of Nufoosk with considerable effect, and on every occurrence throughout this service, proved himself a good and Zealous Officer.

In addition to the Officers previously mentioned in my report of the 4th instant, who fell in the gallant discharge of their duty, Captain Heighington, 1st Grenadier Regiment (since dead) commanded the Rear Guard on the 31st August, and brought it in safety, although greatly retarded by the difficulties of the road.—Lieutenant Peacocke, 1st Grenadiers, and Ensign Evan Grant (now 3rd Regiment Native Infantry) were present with the left support in the action of Nuroosk, and Ensign and Acting Adjutant Panning, 1st Grenadier Regiment, commanded the right support, the latter Officer did every thing that could be expected from such young and inexperienced Soldiers.

The arrangements made for the conveyance of the Sick and Wounded by Mr. Assistant Surgeon Kirk, of the 1st Grenadier Regiment, and their safe arrival here after so long and fatigueing a march, sufficiently testifies the care and ability exercised by this Gilicer, and I have great pleasure in acknowledging his valuable assistance.

My anxiety to remove any false impressions, or rectify omissions that rendered my report of the 4th instant incomplete, penned as it was, while oppressed with excessive fatigue, will, I trust, be sufficient excuse for troubling the Officer Commanding in Upper Sinde with this communication.
