The Right How'ble the Governor in Council having sanctioned the publication of a weekly paper to be styled the "Bombay Government gazertone in the Bombay Government gazertone is hereby given, that after this day all advertisements and other public pass pers of the government, will be printed in the Bombay Government of Azerte only: and all orders or other miblic nacices, appearing in that paper, under the signature of the secretaries, or other public officers of the government, are hereby ordered and directed to be conformed to and obeyed accordingly. It is not intended that public intelligence, or private advertisements, and notifications should be inserted in the government gazette.

Bombay Castle, 18th January 1832.

When official notifications from the government are inserted in the Bombay Government Gazette, no communication on the same subject will be made in vorting to any department concerned; but all public officers are required to take notice of such official notifications in the same manner as if they had been directly communicated to them by letter from the secretary's office, and as heads of offices alone will be furnished by government with the Bombay Government concerned; they will be expected to communicate to their subordinate officers all orders which may in any manner concern them.

The Bombay Government Gazettes furnished by government to public offices are to be lodged with the records, and are not to be removed from the office.

The following Draft of a proposed Act was read in Council for the first time on the 5th of April,

Act. No-of 1841.

An Act for amending the law with respect to the limitation of suits and summary proceedings.

1. Whereas it is expedient to extend to Her Majesty's Supreme Courts within the territories of the East India Company various amendments recently made in the English statute law respecting the limitation of suits. And whereas it is also expedient to modify the law with respect to the limitation of suits as administered in the Courts of the East India Company and to consolidate various enactments upon that subject applicable to different Presidencies. whereas it is also expedient to enact some provisions for limiting the period of certain legal pro-ceedings with reference as well to the law of England as to the Regulations of the different Presidencies ;-

It is hereby enacted, that so much of the statutes 2 and 3 Will. IV. Chap. LXXI., 3 and 4 Will. IV. Chap. XLII.; 3 and 4 Will. IV. Chap. XXVII. as relates to the limitation of suits, and so much of the same as relates to forms of action abolished by those statutes or any of them shall be extended to Her Majesty's Courts within the territories of the East India Company. Pro-vided always that wherever in those statutes any period is limited with reference to the time of passing the same, the corresponding period in the present Act shall be six months from the

time of passing thereof.

II. And it is hereby enacted, that the several Courts of the East India Company are prohibited, except for special and sufficient reasons to be stated on the face of the decree, from trying any suit other than for the recovery of immoveable property or of some right derived from such property, or any suit for reviving a decree as hereinafter mentioned, if the cause of action shall have arisen six years, before the commencement of such suit

III. And it is hereby enacted, that the Courts of the East India Company aforesaid are prohibited from trying any suit for the recovery of immoveable property or for any right derived out of such property if the cause of action shall have arisen twelve years before the commencement of such spirit. ment of such suit.

IV. And it is hereby enacted, that no decree of any Civil Court of the East India Company shall be executed summarily in the manner now prescribed by the regulations unless application for the same shall have been preferred within the period of one year from the date on which the

decree may have been passed.

V. And it is hereby enacted, that every application for the execution of a decree of any such Civil Court as aforesaid preferred after the expiration of one year from the time of passing thereof shall be considered as a suit instituted to revive the execution of the same, and shall be subject to the rules enacted by Regulation be subject to the reles enacted by Regulation IV. 1793 and the other regulations in force, for receiving, trying and deciding suits declared cognizable by Civil Courts of Judicature, and to the several Stamp Duties prescribed by Clause 8, Sch. B. Regulation K of 4829 on the institution of suits and appeals in those Courts; provided always, that no Stamp Duty or fees payable by the plaintiff in any such suit for reviving a decree shall in any case be recoverable from the defendant; and provided also that in any such suit the defendant shall not be allowed to im-

pugn the merits of the original decree,
VI. And it is hereby enacted, that if any person shall at the time of the cause of action first accruing be under any of the disabilities of in-fancy, idiotey, lunacy, or absence beyond seas, then such person, or the person claiming through him, may commence a suit in any such Civil him, may commence a suit in any such Civil Court as aforesaid within three years after the person to whom the right shall have first accrued as aforesaid shall have ceased to be under any such disability, or shall have died (whichever shall have first happened.) Provided always that the disability by reason of absence beyond that the disability by reason of absence beyond seas shall in no case be admissible beyond the

period of 20 years.

VII. And it is hereby enacted, in regard to suits in such Civil Courts as aforesaid, that when any person shall be under any of the disabilities aforesaid at the time when the cause of action first accrues, and such disability may have been removed or the party may have died under such disability, no further period for commencing a suit shall be allowed by reason of any disability of any other person.

VIII. And it is hereby enacted, in regard to suits in such Civil Courts as aforesaid that in every case of a concealed fraud the right to bring a suit shall be deemed to have first accruedat and not before the time at which such fraudshall, or which reasonable diligence might have

been first known or discovered.

IX. And it is hereby enacted, in regard to suits in such Civil Courts as aforesaid that the cause of action for the recovery of immoveable property or rights derived therefrom shall be deemed to have first accrued when the claimant shall in respect of the Estate or interest claimed have been in possession or in receipt of the profit or of rent, and shall while entitled thereto have been dispossessed or have discontinued in such possession or receipt, then such cause of action shall be deemed to have first accrued at the time of such dispossession or discontinuance of possession, or at the last time at which any such profits or rent were or was so received. In other cases the cause of action shall be deemedto have first accrued when the claimant was first entitled to the possession of the state or interest claimed; provided always that no possession by a mortgagee or depositary, or any person claiming under them shall by deemed person claiming under them shall by deemed adverse so as to bar the remedy of any claimant by reason of length of time unless where the person claiming under any such mortugagee or depositary shall have held possession for the space of 12 years, without recognizing the title of the claimant and shall have obtained possession under a title bona fide believed to have con-

veyed an absolute right of property.

X. And it is hereby provided, in regard to suits in such Civil Courts as aforesaid that any acknowledgment in writing and signed shall preclude the person signing the same from pleading the aforesaid limitations against the party inwhose favor such acknowlegment may have been given, except so far as relates to the lapse of time after the date of such acknowledgment, or

the last of such acknowledgments.

XI. And it is hereby enacted, that all suits for penal damages brought in any such Civil-Courts as aforesaid shall be preferred within one year after the cause of action shall have arisen, and that no period, be allowed for disabilities in such cases.

XII. And it is hereby enacted, that no conviction before any Magistrate or Justice of the Peace for any offence punishable by fine, or by fine and imprisonment, shall be deemed valid unless the offence shall have been committed within one year from the date of such conviction.

XIII. And hereby provided, that this Act shall not extend to any suits for the recovery of the public revenue, or for any public

right or claim whatever.

XIV. And it is hereby provided, that all suits that may be now pending or that may be instituted within the period of six months from the date of the passings of this Act, shall be tried and determined in the same way that they might have been at any time before the passing of this Act.

Ordered, that the Draft now read be published for general information.

Ordered, that the said Draft be re-considered at the first Meeting of the Legislative Council of India after the 5th day of July next.

THE 12TH APRIL, 1841

The following Act passed by the Right Hon'ble the Governor General of India in Council on the 12th April 1841, is hereby promulgated for general information.

ACT No: 1 of 1841.

An Act for facilitating the collection of the Re-venue of Government and defining the interest intended to be conveyed by public sales for the realization of arrears of the Public Revenue in Putteeda rrec Estates.

Preamble: 1 The Regulations in force authorize the application of duress for enforcing the payment of arrears of the public revenue, only against the person and property of the Contracting Lumberdar leaving him to proseed against the Putteedars by suit or distraint. But with reference to the peculiar nature of these Coparcenaries the existing enactments appear to be insufficient, on the one hand for the protection of the rights of the Putteedars; and on the other hand for the punctual realization of the The Regulation are also dues of Government. deficient in not authorizing with sufficient distinctness the sale or transfer of the Puttees of defaulting Putteedars in Puttedarree Estates, and in not defin ing the interest intended to be conveyed by public sales of such Estates; H. A Putteedarree Estate in this Act is held

to be an Estate which consists of two or more separate portions or Puttees, or of which there may be proprietors possessed of separate properties and holding direct of the Government, but not parties in their own names to the contract withthe Government for payment of the public revenue. The proprietor who is a party in his own name is called a Lumberdar, and the proprietor who is not a party in his own name is called-

a Putteedar.

III. It is hereby enacted, that the following modes of duress may be enforced against ath Putteedars whose tenure and interest may have been defined by a Settlement formed according to Regulation VII, of 1822 as modified by Regulation IX. of 1833, whether every such Puteedar be in sole occupation of his Puttee, or hold it in common with others.

1st. Issue of Dustucks in the same manner, and under the same limitation, as authorized by

the rules in force for Lumberdars.

2d. Arrest, detention, imprisonment, destraint and sale of personal property as now authorized to be enforced against Lumberdars.

3d. Transfer of the defaulting Puttee in perpetuity to the members of any other Puttee which

may not be in arrear

4th. Annulment of the Settlement as regards. the defaulting Puttee, and lease thereof to the members of any other Puttee which may not be in arrear or to a stranger for any term not exceeding fifteen years.

5th. Sale of the defaulting Puttee by public auction in which case the members of the remaining Puttees who may not be in arrear are autho-

rized to bid.

IV. And it is hereby enacted, that on occasion of the sale by public auction of any Puttee, if the lot shall have been knocked down to a stranger, any Putteedar or other member of the coparcenary not being himself in arrear may claim to take the

said Puttee at the sum last bid, provided that the said demand of pre-emption be made on the day of sale and before the Collector shall have left the office, and provided that the claimant fulfil all the other conditions of the sale.

V. And it is hereby enacted, that the above methods be employed by the Collector or other Officer vested with the powers of Collector, un-der such limitation and control as Government or other superior revenue authorities shall see

fit to prescribe or enforce.

VI. And it is hereby enacted, that the sale of any Puttee by public auction, shall be effected in respect to the notice to be issued, the authority to be obtained, and the mode of conducting the sale according to the rules prescribed by Law from time to time for the sale of an entire Mehal, and the l'uttee after the sale shall have been duly confirmed shall be the absolute pro-perty of the purchaser, save and except the rights of those Reyots whose right to the permanent occupancy of their lands may have been recognized, and the rates of rent payable by whom may have been adjusted and recorded at the last settlement.

VII. And it is hereby enacted, that in case of the lease or other temporary transfer of any Puttee as above said, no member of that Puttee shall be entitled to cultivate any land therein during the term of such transfer, or in case of absolute sale no member of the Puttee shall be entitled to hold or cultivate any land therein-from, and after the month of Bysack next succeeding such sale, unless the said member of such sold or transferred Puttee shall first execute a written engagement to payment to the purchaser or transferree at the rate demanded by the purshaser or transferree. Provided that it shall be competent to the Collector, subject to the orders of the Commissioner and the Sudder Board of Revenue, if the rate cannot be fixed by private bargain between the parties to cause the same to be fixed by a jury of the vicinage in the mode directed by Sections V. to X. Regulation IX, of 1833

VIII. And is is hereby enacted, that a copy of the Jumma Wasil Bakee and detailed Kuteo-nee of the Tehsildar signed and sealed by him, and countersigned by the Cannoongoes and Putwarry exhibiting in detail the amount paid by and arrear due from each Puttee shall be taken to be sufficient evidence of the arrear due from that Puttee, and these papers shall invariably be filed with the Collector's proceedings.

IX. And be it enacted, that the Collector be empowered to give possession to all purchasers and transferrees under this Act in the mode authoriz-

ed by Clause III. Section XXIII of Regula-tion VII. of 1822.

X. And it is hereby enacted, that nothing contained in this Act shall be the indefeaseble right of Government to hold the entire body of proprietors and the entire estate responsible for the amount of the whole Jumma, and to enforce the existing regulations for the transfer or sale of the whole estate whenever it shall appear to them just and expedient. In every such case it is hereby declared in modification of Regulation X1. of 1822, that the ontire proprietary rights of every member of the coparcenary shall be annulled and forfeited, and the provision of Sec-tion V. of this Act shall be applicable to every member of the Coparcenary

XI. And it is hereby enacted, that the Governor General in Council may extend the provisi-ens of this Act to any, district to which with reference to the nature of the tenures prevalent tille. ... and hore.... and

therein its extension may be expedient, although no Settlement of such district may have been made under Regulations VII. of 1822 and IX. of 1833, and the Order of Government shall be sufficient authority for such extension.

No. 280 of 1841 .- Under the authority of the Supreme Government, and in accordance with the Bengal practice, the Honorable the Governor in Council is pleased to establish the following system of providing for the repairs of Batteries of Horse and Foot Artillery, to have effect from the 1st May next.

An allowance of Rupees fifteen for each Gun and its corresponding Ammunition Wagon, and Rupees five for each additional spare Carriage or Wagon is authorized to be drawn by the Officer in charge of the Company or Troop, from which he will supply Water, Tar, Grease, Iron, Steel, Wood, Charcoal, and such other articles, as are required for repair. This allowance however, will not be drawn for Guns stationed at the

Presidency where Batteries will be kept in repairs by the Ordnance Department as heretofore.

It is expected that the allowance above granted will provide for every kind of ordinary repair required for Carriages and consequently from the 1st May next, no requisition will be sanctioned on Arsenals for repairs, altho' under peculiar circumstances, Officers will be permitted to indent for such articles, as may not be otherwise procurable, the value of the Stores thus supplied being recovered from the indenting Officers by Divisional Paymasters under existing regulations.

When Officers have occasion to transfer or return into an Arsenal, for deposit or any other purpose, any of the Ordnance or Carriages for which they have been drawing the monthly allowance, the same are to be surveyed, and any repair required (accidents arising from service excepted) made at the expense of the

Officer delivering over charge.

The Gun contingent allowance will be drawn on monthly certificates countersigned by the local Commanding Officers of Artillery, enumerating the Carriages &c. and certifying their efficiency. The state of the wheels to be particularly noticed in the certificates.

No allowance will be granted for Ordnance Carriages lent from Arsenals for annual practice, all repairs

of such being undertaken by the local Commissary.

The following list shows the articles required to be repaired from the contingent allowance but supplied or renewed at the expense of Government on Indent.

Axes felling and all tools immediately attached to the Ordnance,
Boxes Ammunition.

Chains of all kinds. Drag Ropes. Ditto Store Limber.

The following articles are to be kept in repair and renewed from the contingent allowances: Port Fires. { Iron Sockets. Ditto Nippers.

Bitts Gun. Buckles Strap. Drifts Gun. Esses Iron. Fellies for the repair of Wheels. Helves or Handles for Tools. Leather. Linch Pins.

Spokes for wheels. Spunge heads rammer and hollow. Yokes. Washers. Wadhooks.

Wires priming.

Match. { Iron Stockets. Ditto loops.

All planks, fellies, spokes and other articles, which may be indented for upon Arsenals, in consequence of supplies not being otherwise procurable, will be issued for payment at rates fixed by the Military Board, by whom the Indents will be passed and recoveries arranged under existing regulations.

All damage done to Carriages by an enemy, will be repaired at the expence of Government.

Officers in charge of Batteries will immediately indent for such articles of equipment as are necessary to complete the established proportion of stores allowed to each gun &c. All deficiencies in which will, from the 1st May, be replaced by the Officer drawing the contingent allowance.

All field ordnance Carriages attached to Batteries of Horse or Foot Artillery are, from 1st May next, to be painted with two coats of good paint, at least once annually. Painters and materials to be furnished from

the nearest Arsenal under the authority of the Military Board.

No. 281 of 1841.—With reference to G. G. O. No. 280 of this days date, and with the view of a further assimilation of the Regulations in force under this Presidency as regards the preservation and repair of Field Batteries with those of Bengal, the Hon'ble the Governor in Council is pleased to sanction Train Establishments of Artificers for the use of the Guns attached to the Horse and Foot Artillery of this army in the following proportions, modifying so much of the scale laid down in Section IV, para. 44, page 13, and Section XLV11, Art. 85, page 205 of the 2d supplement as is affected thereby.

These Artificers will be entirely independent of Quarter Master's Establishments allowed per Battalion for repairs of Arms &c. which will remain in every respect as heretofore.

In the event of it being found necessary at any time to entertain Temporary Establishment, in excess of the above scale for a Field Battery divided on service, the Divisional or Station Commanding Officer au-

thorizing the increase, will obtain, through His Excellency the Commander in Chief, the sanction of Govern-

ment for the same.

It is expected that the Establishment of Artificers now sanctioned, together with the contingent allowance for materials &c. granted under this date will be adequate to the performance of all ordinary repairs where two or more Batteries are stationed together, the Senior Officer of Artillery in the Division is authorized to join the Artificers of the whole for the purpose of executing any heavy work that may be required; as per Military Code, Sec. 47, paras. 22, and 23, page 417, and Sec. 4, para. 45, page 13, of the 21 supplement, and it is only when the necessary repairs cannot be effected by calling into requisition the united services of the several establishments present, that the Carriages &c. will be surveyed and repaired, on the report of the Committee in the noarest Arsenal.

9. Any increase of pay or allowance granted by this order is to be drawn in arrears from the date on which the new Pay Table had operation.

10. Referring to the Pay Table published in G. G. O. No. 520 of 1840, it is to be observed that the rates of Pay therein laid down for Her Majesty's Cavalry after 10 years service, and for Her Majesty's and rates of Pay therein land down for ther Majesty's Cavairy after 10 years service, and for ther Majesty's and Hon'ble Company's Infantry after 7 years service, are inapplicable, since good conduct pay is to be drawn in the manner directed in G. G. O. No. 141 of 1841, and the additional penny per diem for length of service was disallowed by a Royal Warrant dated 24th December 1822, from the 24th January 1823, which Warrant was subsequently made applicable to the Hon'ble Company's Troops.—The additional pay for length of service of Her Majesty's Dragoons after 17 years, and of Her Majesty's Infantry after 14 years, will not be admissible for men inlisted on, or after the 1st September 1836.

11. Soldiers of the Company's service inlisted after the 1st November 1836 will not be entitled to the additional pay for length of service after 14 years, as laid down in the Tables of pay for Company's Troops. But they will receive good conduct pay under the G. G. O. No. 424 of 1837 if their claim thereto has been admitted.

Note.—To prevent any misunderstanding on the point, it is hereby notified, that the period of 7, 14, 21, and 28 years required of men, preferring chims, to good conduct pay, must be bona fide service, the rule under which 2 years Service in India counted for 3 years, claims to the additional pay for length of Service. does not obtain with regard to good conduct pay.



NOTIFICATION.

- 1. With reference to the Notification issued by this Government on the 24th December last, relating to the operations of the Detachment under the Command of Major Clibborn when endeavouring to relieve the British Out-post at Kahun, in the month of August last, the Honorable the Governor in Council is pleased to publish for general information, the Finding and Revised Finding of a Court of Inquiry assembled at Sukkur, for the purpose of investigating the conduct of Major Clibborn and the Detachment under his Command, on the above occasion.

Brigadier T. Valiant, K. H. M. 40th Regt. Lieut .- Col. Wymer, Rengal 38th Regt. N. I. Major Farrell, Bombay 6th do. do. ,, Lloyd, Bombay Artillery. Captain Hutt, Officiating Judge Advocate.

The Court of Inquiry, of which Major General Brooks was President, and the Officers named in the margin, were Members, assembled at Sukkur on the 10th November last, and after examination of such evidence as they deemed requisite, the Court, on the 20th of the same month, unanimously recorded their finding (No. 1.)

- 3. On a careful consideration of the evidence recorded on the Court's proceedings, the Honorable the Governor in Council, for the reasons assigned in a letter to the Adjutant General of the Army, (No. 2.) felt himself compelled to direct the Court to re-assemble, for the purpose of revising their proceedings, and to require them to state, on what evidence, or on what information, the several conclusions they had arrived at were founded.
- 4. In conformity with these instructions, the Court, with the exception of Lieutenant Colonel Wymer, (who had intermediately proceeded on detached service) re-assembled at Baug, on the 4th February last, and revised their Original Finding, as in No. 3.
- 5. The Hon'ble the Governor in Council having carefully considered the whole of the evidence adduced before the Court, in support of their conclusions, deems it expedient to publish the following remarks.
- 6. With respect to the positive declaration made by the Court in the Original Finding, that Major Clibborn in his advance and choice of road to Kahun, placed an undue confidence in the guide Meer Husson, the Court in their Revised Finding state, that it was not Meer Husson, but another guide named Buchan Shaw who was heard communicating with the enemy, and without referring to any evidence state, that they "were and still are under theimpression that Major Clibborn was too easily led by his guides." - I has qualified conclusion, differs widely from the broad assertion made in the first instance by the Court, and which as it strongly impugned Major Clibborn's prudence and judgment, ought not, in justice to that Officer, to have been made, except on good and sufficient evidence. It is however apparent from the Court's proceedings, that Major Clibborn was well aware of Meer Husson's character, and that Officer has satisfactorily explained, that Major Choporn was well aware of Meer Husson's character, and that Univer has satisfactority explained, why with this knowledge, when compelled by the dreadful sufferings of his Men, after the action to search for water at all hazards, he permitted this man, accompanied however by other persons whose interests were opposed to his, to lead the watering party.—The Governor in Council therefore, feels himself called on to state, that the Court's declaration, that "Meer Husson caraestly pressed the advance by Nufcosk, that he was heard communicating with the enemy—yet Major Clibborn allowed himself to be led into the toil," is altogether unsupported by evidence.
- 7. With reference to the Court's opinion, that Major Clibborn "fell into the fatal but too common "error of holding his enemy in contempt," it now appears from the revised finding, that this opinion is not founded on any evidence, but from the circumstance of Major Clibborn having endeavoured to force the pass founded on any evidence, but from the circumstance of Major Clibborn having endeavoured to force the pass of Nufoosk when in the Court's opinion there was no prospect of success.—It may however be remarked, of Nufoosk when in the Court's opinion there was no prospect of success.—It may however be remarked, that Major Clibborn felt, and as the result fully proved, justly felt, every confidence in his Troops, although from obstacles apart from the prowess of the enemy, he was unable to carry into full effect, the service on which he had been detached.—To infer however from such failure, that Major Clibborn held his enemy in contempt, appears to the Governor in Council to be a conclusion, not warranted either in reason or justice
- 8. With respect to the important, and as far as regards Major Clibborn, the highly condemnatory fact o. With respect to the important, and as the Major Clibborn did not sufficiently reconnective in search of water, but trusted too much to the report of others- There were trees and herbage within 300 yards

of his position, which in such a desolate region, ought to have attracted his notice, and had he searched, it is now known, he would have found water on the spot," it appears from the explanation afforded in the revised finding, that this conclusion also was not the result of any evidence before the Court, but an inference drawn from the circumstance of water having been found on the spot about a month afterwards; and from a sketch of the ground made by Dr. Kirk, in which trees and green herbage are represented." The Governor in Council deeply regrets to find that this Court, composed of Five Field Officers of rank and experience could, on such untenable grounds, have recorded, as a positive fact, which was not the fact, that water actually existed, but that through Major Clibborn's culpable neglect it remained undiscovered, within three hundred yards of his position, and this regret is greatly, enhanced by the fact, that Major Clibborn in a Narrative which he submitted to the Court states, that he did send an Officer with a Company of Sepoys in search of water, without success, except as respects the small supply which was found in the vicinity of his position, which speedily became exhausted. In justice to Major Clibborn, the Governor in Council deems it proper to publish a report which has been received from Lieutenant Peacocke, the Officer who was employed on the above occasion, confirmatory of Major Clibborn's statement No. 4.

- 9. In regard to the Court's opinion that the route to Kahun by Deyrah, offered fewer obstacles, and ought therefore to have been selected by Major Clibborn in preference to that by the pass of Nufoosk, it appears to the Hon'ble the Governor in Council, that in coming to this conclusion, the Court did not sufficiently consider the difficulties of the former route, and entirely lost sight of the fact, that this route is fifty miles longer, that it has two marches, 19 & 20 miles each, without water, and that in a narrow gorge a mile and a half in length, it offers equal, if not superior advantages, for defence, and that nothing is adduced on the Court's proceedings to shew that the enemy might not with equal facility have assembled on this route. It moreover appears that the Court's opinion in favor of the Deyrah route, was in part founded on "careful drawings made by Dr. Kirk of the three passes and gorges which present "ed the chief obsructions to the advance of Troops" by the Nufoosk route, but from the annexed declaration by this Officer (No. 5) it is clear, that whatever value may attach to these drawings, they could in no way aid Major Clibborn's judgment in determining which of the two routes to follow, in-as-much as they were not prepared, until after the advance on Nufoosk had] actually taken place, a fact which ought to have been ascertained by the Court, since Dr. Kirk's evidence on other points, appears on their proceedings.
- 10. The Court in their original Finding have observed, "before Major Clibborn entered the hills, he "received information from Captain Brown that the Murres were assembling in force at Nufoosk, and destroying the road." In their revised finding the Court have explained that they came to this conclusion, because the fact of the pass having been broken up and stockaded was, to the certain knowlege of the Court, known at Hyderabad at the end of August, and therefore Major Clibborn should not have been ignorant of it. It does not appear from the proceedings, from whence the Court's knowledge on the above point is derived, but from the annexed letter (No. 6) from the Officer, who in the first instance was declared to have turnished the information to Major Clibborn, it is clear, not only that no such information was furnished, but on the contrary that Major Clibborn was informed by Captain Brown, in a letter dated only four days before his arrival at Nufoosk, that he (Captain Brown) had heard that the road had not been destroyed, and that the Murrees had not assembled in any numbers for some days past, and that although he afterwards received information to the contrary, he had no means of further communication with Major Clibborn. In this instance also, the Court had it in their power to avoid making an erroneous statement to Major Clibborn's prejudice, in-as-much as Captain Brown appeared as a witness before them.
- 11. The Hon'ble the Governor in Council caunot allow to pass by without severe animadversion, the reflections made by the Court in their original finding, on certain measures adopted by the Right Hon'ble Lord Keane, and which appear to him to be totally unconnected with the subject, the Court was directed to investigate. The conduct of the Court, in presuming to express an opinion upon those measures, is viewed with decided disapprobation, and it must be obvious, that Lord Keane having left India in March 1840, can in no way be held responsible for the result of military operations undertaken five months subsequent to his departure from this Country.
- 12. The Governor in Council is also of opinion, that the animadversions made by the Court on the conduct of the late Brigadier Stevenson, are unsupported by evidence, and that as this Officer was not responsible for the original occupation of the Fort of Kahun, in a Country strong and difficult of access, and remote from support or relief, or for the resolution which had been come to of relieving and not removing the Garrison, the preliminary measures he had adopted, and which were arrosted by his death, for this relief, are not fairly liable to censure, but were judicious with reference to the means at his disposal.
- 13. In regard to the subsequent proceedings of his temporary successor, Major Forbes, the Governor in Council is unable at present to pass any opinion, further than that before recording an unfavorable judgment on the conduct of a zealous and meritorious Officer, the Court were in justice bound to require from him an explanation of his proceedings, but which they most unaccountably neglected to do, although Major Forbes was residing on the spot during the whole period the Court were assembled at Sukkur.—In their comments also respecting the size of the convoy entrusted to Major Clibborn, the Court omitted to take into consideration, that it was intended to augment the Garrison of Kahun, by substituting a somewhat stronger detachment for that under Captain Brown, which was to be withdrawn, and the extent of Carriage in consequence necessary to transport provisions for the relieving force.
- 14. The Hon'ble the Governor in Council has remarked with much dissatisfaction the opinion offered by the Court in their Revised Finding, that such a Court "has a right to draw inferences, and express an "opinion upon what is known to the Members to be facts arising from circumstances under investigation;" Were a principle of this nature to be once admitted, evidence produced before Courts similarly constituted, would in many cases, as it has been permitted to do in the present instance, become secondary to vague reports and insinuations.

- 15. On a final review of the whole of these proceedings, the Honorable the Governor in Council has the highest gratification in thus publicly recording his opinion, that Major Clibborn, and the Officers and Troops under his Command, have well performed their duty to Government, and that they are fully entitled to his strong and unqualified acknowledgments, for their conspicuous gallantry and zealous devotion to the service, under circumstances of almost unparalleled difficulty and suffering, originating in causes beyond human control. On the other hand it is with extreme pain and regret, that the Governor in Council feels himself called upon to condemn, in the strongest terms of reprehension, the unsatisfactory manner in which the Court, of which Major General Brooks was President, have throughout conducted this investigation, and the rash and erroneous conclusions recorded on their proceedings.
- 16. The views taken by this Government of these proceedings, as now promulgated, have met the full concurrence and approbation of the Right Hon'ble the Governor General of India in Council, and that high authority cordially joins with this Government in the sense which it entertains, as, above expressed, of the fortitude and gallantry of Major Clibborn, and of the Officers and Troops under his command, in the action of Nufoosk.
- 17. The total want of accuracy, judgment and discretion, which has been evinced by Major General Brooks throughout these proceedings, leaves to the Hon'ble the Governor in Council no other than the painful alternative of removing that Officer from the responsible Command of the Field Force in Upper Sinde, and in pursuance of this resolution, orders have been issued from the Military Department for the following arrangements being carried into immediate effect.
- 1st. The Hon'ble the Governor in Council is pleased to appoint Major General Sir John FitzGerald, K. C. B. to the Command of the Field Force in Upper Sinde, vice Major General Brooks removed.
- 2d. Major General Brooks will, on the receipt of this order. deliver over temporary charge of the Sinde Field Force, to Brigadier England, of Her Majesty's 41st Regiment.
- 3d. Brigadier Valiant, K. H. is directed to deliver over charge of his Brigade to the next Senior Officer, and return to Bombay and resume command of the Garrison.

Friday, the 20th November 1840.

At a Court of Enquiry held at Sukkur, pursuant to Adjournment.

Present, the same Members as on Tuesday last.

The Court is closed, and having carefully considered all that has been brought before them, record their opinion as follows.

The Court having carefully investigated every thing connected with the unfortunate affair of Nufoosk, come to the following conclusion.

- 1st. That the remote and original cause of the disaster rested with Lord Keane, His Excellency having reduced the number of Troops and crippled the Commissariat to such a degree, that the former were not able to occupy the different posts in sufficient force to protect themselves, much less to act off-ensively should such a measure become necessary, and the latter from want of means, precluded the possibility of furnishing the supplies absolutely requisite for their support.
- 2nd. Owing to the above causes the month of May had arrived before even the small Detachment under Captain Brown was established at Kahun, altho' Major General Sir Thomas Willshire had determined, that a force of double the strength should be sent early in March.
- 3rd. To an error of judgment on the part of Brigadier Stevenson in pushing a Force within the Hills at such a season when he knew he had not the means of feeding them, and no inconvenience either in a Political or Military view would have arisen from the delay of a few months when all risk of the subsequent misfortunes would have been avoided. He apparently did not consider that the arrangement had been determined on at a favorable season and with the supposition of full means.
- 4th. To the want of information and instructions given to Captain Brown by Brigadier Stevenson and after his death by Major Forbes, for altho' Captain Brown early in August made the most urgent application for supplies, the season was so unfavorable that they ought, in the opinion of the Court, to have sent him orders at once to place his garrison on half or even quarter rations, which would have enabled him to hold out until the favorable season for relief came round.
- 5th. To the want of a proper understanding between Brigadier Stevenson and Lieutenant Postans, the Assistant Political Agent in immediate charge of Northern Cutchee, the former having determined on throwing in supplies without any communication withithe Political authorities, and actually equipped a Force of 1200 Bayonets, 6 Guns, and a strong body of Irregular Horse for that purpose.
- 6th. To the want of foresight and judgment of Major Forbes, (who Commanded after the death of Brigadier Stevenson) and who sent out 1200 Camels and 600 Bullocks, under about half the number of Troops, ordered for this service by his predecessor, and without any consultation with the Political authorities. This measure

the Court unhesitatingly condemns, -Orders sent to Captain Brown to puthis Men on quarter rations would have answered every purpose, as he had provisions, as events subsequently proved, to enable him, to hold out until the 15th October without such a precaution .- Nor can the Court avoid noticing the uselessness of such an enormous convoy when 200 Camels would have supplied the Garrison of Kahuu with Provisions for

7th. The Court consider Lieutenant Postans, the Political Agent, in immediate charge of the Country they were to pass thro', highly culpable, for not having accompanied the convoy, and in having in the only communication placed on record, which is a private one, so far misled Major Forbes, as to state that in his opinion 400 Infantry, and 200 Horse would prove sufficient to protect the convoy proceeding to Kahun, against any Force the Murrees could bring against it.

8th. The first point to be noticed with reference to Major Clibborn, is his opinion as to the adequacy of his Department for the duty entrusted to him. He states, that it was his conviction two thousand Men would not suffice for the duty to be performed, but that he ma de no application for an increase to his strongth because, he says, he knew that none could be afforded, nor did he request any reduction in the amount of the supplies. This statement is most un satisfactory, a slight calculation would have shewn him how wholly unnecessary was the immense charge entrusted to him, and the same Force destined for service by Brigadier Stevenson, might have been employed by Major Forbes.

9th. The second point relates to the Route selected by Major Clibborn from Phoolajee to Kahun.

The Court differ entirely with him as to the obstacles he would have had to encounter, accurate surveys of the three Routes from Phoolajee and Lehree to Kahun, were made last year by Lieutenant Jacob of the Artillery, and Dr. Kirk; in addition to these, the latter Officer had made careful drawings of the three passes and gorges which presented the chief obstructions to the advance of Troops. A reference to Captain Jacob's re port will shew, that the road over the Nufoosk pass was made by him and until he constructed it the pass was impracticable excepting to foot passengers. Now before Major Clibborn entered the hills he received information from Captain Brown that the Murrees were assembling in force at Nufoosk and destroying the road, on these grounds alone then he ought not to have selected the route in question; but there is another instance of the want of judgment of Major Clibborn. He was warned by Lieutenant Postans not to place reliance on Mee-Hossein, and he himself doubted his fide lity. This man earnestly pressed the advance by Nufoosk, he was heard communicating with the enemy, yet Major Clibborn allowed himself to be led into the toil. Major Clibborn beyond doubt should have gone by Deyrah; the only difficulty along the whole course is a narrow gorge a mile and a half beyond Deyrah. At that place there is abundance of water and forage, and in the event of resistance he might have halted any length of time and taken steps for turning or forcing the pass.

10th. The only remaining point to be noticed is, Major Clibborn's conduct previous to, and during the action. Here he in the first intance fell into the fatal, but too common error, of holding his enemy in contempt.—His plan of attack was most injudicious. He admits the pass might have been turned from the left but gives as a reason for his not having attempted it, that it would have required to detach 400 Infantry. The Court entirely differ with Major Clibborn on this point. If two Flank Companies were considered by him sufficient to make a direct attack on the whole concentrated force of the enemy in front with every description of artificial as well as natural obstacle to overcome, the same number of Men would have been capable of turning it, and had Major Clibborn adopted this plan, making at the same time a false nave been capable of turning it, and nad major Citoborn adopted this plan, making at the same time a talse attack in front, to be converted into a real one when he saw our Troops crowning the height, there can be no doubt the pass of Nufoosk would have been carried with comparatively little loss on our side. The Court is also of opinion that Major Clibborn did not sufficiently reconnoitre in search of water, but trusted too much to the report of others. There were trees and herbage within 300 yards of his position which in such a desolate region ought to have attracted his notice and had he searched, it is now known he would have found water on the spot.

Having performed a painful duty in animadverting on the conduct of various individuals, we have increased pleasure in recording our opinion of the patient, enduring fortitude, and determined gallantry of every individual of this brave but unfortunate Detachment, which is above all praise.—T'is true our arms have met with a reverse, but the honor of the Bombay Troops remains untarnished.

TO THE ADJUTANT GENERAL OF THE ARMY.

Bombay Castle, 24th December 1840. . .

I am directed by the Honorable the Governor in Council to acknowledge the receipt of your letter dated the 10th instant, forwarding for the consideration of Government, the proceedings of a Court of Inquiry

assembled at Sukkur, and of which Major General Brooks was President, for the purpose of investigating the Military conduct of Major Clibborn and the Detachment under his command, on the occasion of his retreat from the pass of Nufoosk, after a severe action with the Murree tribe of Belloochees, on the 31st of August last.

- 2. In reply I am desired to state, that the Governor in Council regrets to be compelled to express his disapprobation, at the manner in which this investigation has been conducted, and to dissent from the greater part of the reasoning and opinions recorded at the close of the Court's proceedings. In the opinion of Gomernment some of the Court's conclusions, are not only unsupported by any evidence recorded on the proceedings, but are in some instances at variance with the evidence.
- 3. The Governor in Council requests therefore, that His Excellency the Commander in Chief will be pleased to cause this Court of Inquiry to be re-assembled as early as practicable; for the purpose of revising their proceedings, and that they be required to state, on what evidence, or on what information, their conclusions on the several points noticed in their report are founded, but more especially on the following, which more particularly relate to Major Clibborn.
- 1st. That Major Clibborn in his advance and choice of the road to Nufoosk, placed any and undue confidence in the guide Meer Husson.
 - That "he fell into the fatal but too common error, of holding his enemy in contempt."
- That he did not sufficiently reconnoitre for water, but trusted too much to the report of 3rd. others.
- 4th. That "there were trees and herbage within 300 yards of his position, which in such a desolate region, ought to have attracted his notice, and had he searched, it is now known, he would have found water on the spot" that is to say, on the 31st August 1840.
- 5th. That the route to Kahun by Deyrah, offered fewer obstacles to an advancing force than that by the pass of Nufoosk, and consequently that Major Clibborn ought to have preferred the former.
- 6th. That information had reached Major Clibborn before he entered the Hills, that the Murrees were destroying the road leading by the pass of Nufoosk.
- 7th. That the same force destined for the relief of Kahun by the late Brigadier Stevenson, might have been employed by Major Forbes.
- 4. I am further desired to express the surprise and regret of the Governor in Council, that the Court have not recorded any opinion of the personal conduct of Major Clibborn under the almost un-paralleled trying circumstances, in which he was placed in his advance to, and retreat from, the pass of Na-foosk; In submitting their revised proceedings, the Governor in Council is of opinion, that the Court should, in justice to Major Clibborn, be requested to supply so important an omission.
- 5. The Governor in Council also requests that Major General Brooks be informed, that the Court's proceedings are full of errors of the Copyist, so that their report is in some instances, scarcely intelligible.

No. 3.

Proceedings of a Court of Enquiry re-assembled at Baugh, on Wednesday the 4th day of February 1841, pursuant to instructions received from the Adjutant General of the Army.

Present, the same Members as before, with the exception of Colonel Wymer, absent on Command at Candahar.

Read a letter from Mr. Secretary Willoughby, No. 2,333 of 1840, calling on the Court to state, on what evidence, or what information their conclusions on the several points noticed in their report, " are founded, but more especially on the following, which more particularly relate to Major Glibbora."

The Court proceed to answer the several questions contained in Mr. Secretary Willoughby's letter, premising, that a Court of Enquiry is differently constituted from a Court Martial, the latter having to pass sentence, as well as give an opinion, are bound to confine themselves strictly to the evidence that appears before them, but a Court of Enquiry they consider has a right to draw inferences, and express an epinion, apon what is known to the Members to be facts arising from the circumstances under investigation.

Question 1st .- "That Major Clibborn, in his advance and choice of road to Nufoosk placed any, and un-"due confidence in Meer Hoossein."

Reply —As Major Clibborn advanced, he had occasion, in more instances than one, to doubt the fidelity of Meer Hoossein. On the night of the 28th August the pickets opened a fire on Meer Hoossein's people, one man was seized, who stated he was only bringing goats into Camp by Meer Hoossein's orders; on another occasion, it is stated, that some Beeloochees commenced harassing the Baggage, eight (3) of whom were cut up by a party of the Poenah Horse, and a Goolam of Meer Hoossein and a Boy made prisoners; Circumstances of so suspicious a nature ought to have excited his attention, yet the Court are surprised to find, that tances of so suspicious a nature ought to have excited his attention, yet the Court are surprised to find, that although Major Clibborn was wringed of this man's suspected fidelity, both by Mr. Postans, and the guide although Kyhoree, that he is the man who was allewed to suggest and direct the watering party, and they therefore decidedly recorded their opinion that Major Clibborn did place undue confidence in him.

Answer.—Major Clibborn, in his statement acknowledges the possibility of turning the pass, and upon such grounds the Court arrived at the conclusion, that at least the attempt should have been made, for in Major Clibborn's plan of attack the Court are unable to discover what prospect there was of success, while on the other hand, in the event of a reverse, which should have been provided for, the Cavalry, that might have been so useful as a reserve, were dismounted and thrown into a position that rendered it quite impossible for them to act in any capacity, being directed to form up as Skirmishers on foot, and scale an ascent that, by Lientenant Lock's evidence, was quite impracticable, and when they could not even find a footing.—The great natural strength of the position, independent of any artificial obstacles, which it ought to have been evident to Major Clibborn, the enemy would have prepared, together with what the Court consider positive information of the road being destroyed, in connection with the plan of attack which the Court have and still do condemn, together with Major Clibborn's admission, as recorded in his statement, that on the 31st August "they (the Beloochees) informed us, that several thousands of them "were ready to oppose us on the morrow"—again on the 31st I was "aware that the enemy were collected in "strength in my front" and again on the same day "we observed on the summit, crowds of the enemy shouting. "Bourishing their swords, and further on, a pillar of smoke rising to give notice of our approach"—Our these facts the Court came to the conclusion that, Major Clibborn did think too lightly of the enemy who were opposed to him, and felt that confidence in success that the occasion did not warrant.

Question 3d.—That he did not sufficiently reconnoitre for water, but trusted too much to the report of others.

Question 4th.—" That there were trees and herbage within 300 yards of his position which in such a desolate region ought to have attracted his notice, and had he searched, it is now known he would have found water on the spot, that is to say, on the 31st August 1840."

Answer.—The cold season in this country is the dry one during which great inconvenience is experienced in many parts from want of water which is almost entirely derived from the snow that falls in the higher ranges of hills, this begins to melt early in March, and by the end of that month the whole of the springs and mountain streams are in full vigour and continue so until the cold season again comes round; the wet season commences in the middle of May and terminates about the commencement of September, although rain some times falls until a later period; there is no regular monsoon as in India, but the rain falls in heavy thunder storms, that vary in duration from six hours to several days. Captain Brown found water on the spot in abundance one month afterwards, this moreover is the spot on which the supply of water found there by Lieutenant Clarke induced him to halt in opposition to the advice of his guide, and where he and his detachment were cut up; water was stated by Major Clibborn himself to have been found there by Captain Brown, and again repeated by the latter officer in his evidence before the Court though not recorded, it having been distinctly admitted before by Major Clibborn, consequently the Court consider they had a right to conclude that water was to be found at the end of Angust, as if for example, water was known to exist on any spot on the esplanade in October, the Court would not conceive it necessary to call evidence to prove its existence in the end of August, and as it is a well known fact that the practice of concealing water is resorted to on all occasions as a means of defence by the inhabitants of this country, an act in which they are proverbially expert, the Court are of opinion that in a case of such vital importance Major Clibborn should have carefully searched for water himself instead of trusting to the report of others, the Court were immediately led to the opinion on this subject they at first recorded, from a sketch of theer provessed as there in stated.

Question 5th.—That the route to Kahun by Deyrah offered fewer obstacles to an advancing Force than that by the pass of Nufoosk and consequently that Major Clibborn ought to have preferred the former.

Question 6th. - That information had reached Major Clibborn before he had entered the Hills, that the Murrees were destroying the road leading by the pass of Nufoosk."

Answer.—The Court have concluded, that Major Clibborn should have taken the route by Deyrah, for he was acquainted with the fact, that the Murrees were in force in the pass of Nufoosk, and had destroyed the road; it is true that Captain Brown in his letter only mentions his suspicions of their having done so, which from his position shut up in Kahun were the utmost he could say, but a little reflection should have convinced Major Clibborn how natural it was that such should be the case, for it was by this road our Troops had gone to Kahun so successfully before, and therefore the one by which they would naturally look for his advance and prepare accordingly. Major Clibborn should have attached greater importance to that information, and in his choice of roads considered that by the Deyrah route there was abundance of water and supplies within 1½ mile of the only material obstacle opposed to his passage where he could have refreshed and made any preparation that might be necessary for forcing or turning the gorge either of which might have been accomplished in the opinion of the Court, judging from the drawing by Dr. Kirk that was laid before it, and admitted to be a just representation, while by this route the Murrees would have been less prepared with every preconcerted, plan of opposition or resistance.—In addition to all this, the pass of Nufoosk was well known to be quite; impracticable, till cleared and made by Lieutenant Jacob, while the fact of its having been broken up and stockaded was to the certain knowledge of the Court, known at Hyderabad at the end of August, and therefore Major Clibborn should not have been ignorant of it.

Question 7th.—That the same Force destined "for the relief of Kahun by the late Brigadier Stevenson" might have been employed by Major Forbes."

Answer.—In a letter dated the 8th August, Major Forbes states, that the arrangements of Brigadier Stevenson required considerable modification on account of the inefficiency of the Commissariat. The Courts have therefore recorded their opinion, that they considered the enormous convoy sent under Major Clibborn wholly unnecessary, as one half of it would have been sufficient to supply the Garrison and Followers with full rations for 12 months, and had its amount been reduced, the practicability of which was obvious, more than sufficient Carriage would have been available for the equipment of the Force originally destined for this service by Brigadier Stevenson.

" I am further directed to express the surprize and regret of the Governor in Council, that the Court have or not recorded any opinion of the personal conduct of Major Clibborn, under the almost un paralleled try-ing circumstance in which he was placed in his advance to, and retreat from, the pass of Nufoosk."

When the Court expressed its high commendation of "the patient, enduring fortitude, and determined gallantry of every individual of this brave but unfortunate detachment." Major Clibborn was as a matter of course included, but the Court considered they did their duty better to the Government by confining their or course induct. The several points of the question submitted for their investigation, rather than by passing any comprehensive opinion or sentence of praise or censure on the whole, conceiving that any such notice belonged rather to the prerogative of the convening authority, who being in possession of other information than that belonging to the Court, could from the evidence now brought forward, and the Court simple opinion in detached facts, draw a more correct conclusion than the Court had it in its power to addice; For these reasons the Court refrained from expressing its opinion on Major Clibborn beyond what is there recorded, but they consider it but justice to that Officer now to state, that though they on cool delibera-tion may discover errors of judgment and other faults that they deem it but right to point out, that they are by no means insensible to the dreadful physical disabilities under which that Officer and his Detachment labored, and which they are of opinion are entitled to carry weight and consideration in passing any final comment or opinion on the whole. One point must be self evident to the most casual observer that Brigadier Stevenson, his successor, and their Lieutenants were all in their several capacities burdened with the per-Sterenson, his successory and control of the sterenson of a dry without any sufficient means of carrying it on, each apparently was unwilling to declare that inability or oppose the instructions received, however much they themselves may have been conscious of their own weakness, hence dangerous risks were encountered, that should never have been hazarded, and however much the Court may censure the judgment of the individuals who incurred these risks, they do not blame the Soldier on whom the danger devolved, and who in his choice of alternatives determined at all hazards to oppose it.

With reference to the 1st and 2d Paragraphs of the Court's opinion, the Court did not deem it necessary to call any evidence beyond what appeared on the face of Major Clibborn's statement as the facts were notorious to every one in Scinde, but as information is now called for, the Court annex the accompanying letter from Ross Bell Esquire, Political Agent, No. 309,* which will be seen most fully to substantiate all that they have deposed to.

The Court further feel it due to themselves to state, that although the letter from officiating Secretary Major E. M. Willoughby to the Adjutant General of the army, No. 4369 of the 19th October 1840, calls on them, for their opinion of the Military conduct of Major Clibborn and his detachment, the letters which accompanied it from the Officiating, Secretary to the Government of India to the Secretary to the Government of Bombay, as well as a copy of a letter to Ross Bell Esquire also from the Secretary to the Government of India, and which formed part of the instructions sent for their guidance direct, that "enquiries shall be carefully instituted in regard to all the circumstances connected with the disaster" which attended the detachment under Major Clibborn and Major Clibborn himself might very justly complain of the manner in which the Court had animadverted on his conduct, had no notice been taken of the arrangements made by Major Forbes, placing him in that position, for the same reason the Court consider they could not in justice to the latter Officer omit to point out what appeared to them errors in judgment in his predecessor, and this brought them to what they considered the remote, though direct and original cause.

In paragraph 9 the Court have stated, that this man, the guide Meer Hoossein, was heard conversing with the enemy, this is an oversight in the names of the guides, as it was Buchan Shaw who was thus heard conversing with the enemy, and not Meer Hoossein the Court were and are still under the impression, that Major Clibborn; was too easily led by his guides to follow that road, but were in error in pointing out any one in particular, with this excepion the Court adheres in very respect to their former opinion-

TO MAJOR GENERAL BROOKS,

Commanding Scind Field Force, and President of Court of Inquiry.

I have the honor to acknowledge the receipt of your letter dated the 3rd instant, and in reply to state, that on the 29th of January 1840, I had an interview with His Excellency Sir John Keane, for the purpose of arranging, regarding the amount of Force to be left in Upper Scind. Major General Willshire, Brigadier, Stevenson, and Lieutenant Colonel Macdonald being present; I had previously discussed the subject with Major General Willshire, who agreed with me in considering it necessary that four Regiments of Native Infantry, along with strong Details of Artillery and Irregular Horse, should be left for the purpose of occupying the various posts in Upper Scind and Cutchee. His Excellency after having fully discussed the subject, decided on leaving the 1st Grenadiers, along with the 5th, 22d and 23d Regiments Native Infantry, and strong Details of Artillery and Irregular Horse, I also brought to the notice of His Excellency the inafficient state of the Commissariat Department which he decided should be remedied and placed on a proficient state of the Commissariat Department which he decided should be remedied and placed on a proficing without loss of time. On the 31st of January orgent business called me to Khyrpoor. I reflected to Sukkur, on the 6th February and learned to my surprise, that the 22nd Regiment of Native Infantry, had some days previously been remanded to the Presidency, no intimation of this was conveyed to fantry, had some days previously been remanded to the Presidency, no intimation made by him in the me by His Excellency Sir John Keane, either previous or subsequent to the alteration made by him in the strength of the Force left in this Country. rom Sukkur before I returned, and I discussed with Brigadier Stevenson, the expediency of requesting the Commander in Chief to rescind his order for the removal of the 22nd Native Infantry. We were both of opinion that the measure was a desirable one, but he expressed great unwillingness to interfere with an arrangement made by the Commander in Chief, and stated, that altho' the duty would be heavy, he considered the Force under his Command strong enough to provide for the Posts which had been determined on in Scinde and Cutchee. On enquiring of Brigadier Stevenson as to the state of the Commissariat Department, I learned with regret that no arrangement had been made by His Excellency Sir John Keane, for rendering it efficient, and that it had been left in the same crippled state as it was during the previous season when the Army advanced .- Brigadier Stevenson said, he would lay before the proper authorities a detailed statement of his wants, and I am aware that he used every exertion to have them remedied. The occupation of Kahan had been decided on in the month of January by Major General Willshire and myself. The last interview I had with Brigadier Stevenson who succeeded that Officer in the Command, was on the 7th of February 1840 .- We discussed the arrangements requisite with reference to the occupation of various Posts, and amongst others, of Kahun. The principal difficulty contemplated was a deficiency of carriage. Brigadier Stevenson considered that 4 Companies of N. I. two Guns, and a Ressallah of Irregular Horse, with six months provisions would suffice for the occupation of Kahun, and on parting from, me he stated, that he would immediately proceed to Lehree and push on the Detachment mentioned, along with the necessary supplies, to Kahun. I am able to state, that Brigadier Stevenson lost no time in going to Lehree. Before his return however I was taken ill and obliged to proceed on sick certificate to the Western Hills. I am unable therefore to state the circumstances which contributed to delay the advance of our Detachment to Kahun, further than that it was owing to the inefficient state of the Commissariat Department. This also must have been the reason why Brigadier Stevenson did not send so strong a party as was originally determined on. No communication was made by him to me regarding the reduced strength of the Detachment sent to Kahun, nor did I learn, until the month of June, that its march from Lehree had been delayed so long as the beginning of May, or that the necessary supplies for six months had not accompanied it. Captain Brown, who Commanded the Detachment, will be able to explain the causes which delayed his advance until so late in the season. As far as I have been able to ascertain, the weakness of his detachment, deficiency of his supplies, and the protracted halt at Phoolajee, arose from a want of carriage and Commissariat Establishment.

I de hereby declare that, on the morning of the 31st August last, I was sent by Major Clibborn with my Cempany (a little under sixty strong) to protect a party of Bheesties and Camp Followers, who were going for water which had been discovered a little to the right of the bottom of the Pass of Nutoosk, and about a quarter of a mile from the place where the Men were drawn up. On my arriving at the spot I found there was a small pool of water at the bottom of a very deep and precipitous cleft in the rock. The descent was so abrupt, that had it not been for some occasional tufts of strong coarse grass, it would have been nearly impossible for any one to reach the water, and quite so for any body to return. As it was, it required great caution, and as only two or three could proceed at the same time the supply was slow and scanty. Not withstanding which, so small was the pool, that in about half an hour, it was completely exhausted.

My Dear Clibbern,—I perfectly recollect writing to either poor Raitt or yourself on the 27th August, a small note from the Fort, in which as well I recollect, I mentioned that I had just heard from a Cossid that the Murrees had not destroyed the road up the Nufoosk pass; also that I had not seen the Murrees in any numbers for some days past, and likewise that I thought there would be plenty of water on the road up, as heavy rain had fallen round Kahun 2 days before. On a reference to my note hoat I find heavy rain did fall on the 25th, also on the same date the following remark, A message "on the road up, as heavy rain had fall on the 25th, also on the same date the following remark, "A message book, I find heavy rain did fall on the 25th, also on the same date the following remark, "A message, from Dost Allie, Podah Murree's brother, offering submission &c."—On the 28th, one day only after I had written you, I received information of the enemy's intention to oppose you—but had no means of informing you of this, as the Cossid on the 27th was the last I saw—and no money would induce a man in the fort to venture out on such errand. Regarding the water, I remember it fell so heavily, that I remarked to Erskine, I trusted it would not damage your convoy, by filling the nullas through which you were then marching.
