Proclamation.

TERRITORIAL DEPARTMENT, REVENUE-OPIUM.

1st, Notice is hereby given, that Passes for the free transit of Malwa Opium to Bombay, for importation by Sea, will be granted on application to the Opium Agent at Bombay, or to the Resident and Opium Agent in Malwa, on payment of Bombay Rupees one hundred and twenty five (125) per chest of 140 lbs weight.

2nd. For the convenience of importers. Passes will be granted for Maunds, instead of Chests, should it be desired; but in no case will a Pass be given for less than 30 Maunds or ten Chests.

3d. Passes abtained at Bombay, will not be given open to the persons taking them out, but enclosed in a sealed letter of advice to the Opium Agent in Malwa, who will countersign each Pass before the Opium is dispatched; persons taking out Passes for Malwa Opium, that may have left that Province, will be required to satisfy the local authorities, in whose District the Drug may first arrive, that it is the actual produce of Malwa, and in the event of its proving otherwise, the same will be confiscated, and the Pass Money forfeited.

No Daties will be exacted on account of the Hon'ble Company's Government, on Opium protected by Passes; it will however, be liable, should occasion require to examination at the dif-ferent Nakas and Chowkies, when in transitu, and also on its arrival at Bombay, with the view of ascertaining that the quantity correspond with that specified in the Pass, but there will be no detention or obstruction by the Officers of Government, beyond what may be necessary for the diligent prevention of any Opium being conveyed into the Territories subordinate to this Presidency.

The Owners of the Opium will have to make their own arrangements for its transport. make the transporter to the transporter to the transporter the despatches will be accompanied by one or prove Chuprasees or Peons, as the Resident and the Opium Agent in Malwa shall consider advi-

seable, but the providing of Escorts for the protection of the Drug will rest with the Owners, and Government will not be answerable for any casualties that may befal the same.

6th. It is left to the option of persons taking out l'asses, to pay at the rate of Bombay Rupees seventeen (17) per chest, in commutation of Customs and Duties that may be due to the Native States through whose Territories the Opium is conveyed, or to pay those Duties themselves, Opium, for which this commutation money may have been paid, shall be allowed to pass equally free from Customs and Duties, whether examined at, and despatched from, Indore, or Rutlam, or other Marts in Malwa.

7th. Persons residing at Ahmedabad, Baroda, Surat, or other places, desirous of exporting . Malwa Opium, under a Pass, will de furnished with the same on application to the British authorities resident at such places.

8th. The Hon'ble the Governor in Council guarantees that the price to be paid for the Passes and in commutation of the Duties to Native States. shall continue as now fixed, to the 1st of October 1842, but the guarantee here given will not debar the Government from continuing to grant Passes after the expiration of this period, should it think fit to do so, without a further Proclamation.

9th. For the convenience of indiviouals, deposits of Company's Paper will be received on account of sums payable for the Passes and Duties specified in Articles 1st and 6th, interet being payable to Government on the same, until redeemed, at the rate of 5 per cent per annum, and the deposit should be redeemed on or before the arrival of the Drug at Bombay, from which period the charge on account of interest will be doubled.

10th. Hoordies may be received by the Opium Agent in Malwa, for Passes taken out there, payable to the Optum Agent in Bombay, within six days after sight; if not redeemed within that period, a deposit of Company's Paper, or substantial Security must be given by the parties concerned, interest being charged at the rate of 5 per cent,

until the arrival of the Opium which will be detained until payment be made. If Security be not forthwith produced, the Hoondies will be returned as dishonored, and the Opium seized on

11th. The Holders of Passes are to take the Opium to Indore, Rutlam, or any other place in Malwa, that may suit the wishes and convenience of both parties, to be weighed by persons who will be appointed by the Opium Agent in

Malwa to perform that duty.

12th. Fifteen days notice must be given to the Opium Agent in Malwa, or his Assistant by all persons about to make exportations under Licenses previously to the production of the Opium at the place of weighment, in order that he may be better prepared to receive, weigh and

dispatch it.

13th. Only one dispatch will be allowed un-der a Pass or License, which dispatch may or may not, at the option of the holder of the Pass, be to the full quantity mentioned in it, but if a smaller quantity be exported, no drawback or refund from the sum paid for the Pass, will be allowed, on account of such deficiency, excepting in the case of Parties taking Passes at Bombay, who will be allowed a refund on account of such deficiency, on a report thereof being made to this Government by the Opium Agent in Malwa, but in the event of the actual dispatch containing a greater quantity of Opium than that for which the Pass was taken out, such excess shall be paid for at the rates specified in the 1st article of this Proclamation, and shall by way of security for payment, be liable to detention by the Collector of Customs at Bombay until paul for.

14th. In weighing the Opium, an allowance

of three lbs will be allowed for each Chest of 140 lbs on account of leafage and dustage.

With the exception contained in arti-15th. cle 8th, the Hon'ble the Governor in Council reserves to himself the right to adopt, from time to time, such measures as he may conceive to be necessary, to prevent the illicit trade in Opium, and to secure the object of Government in sauctioning the present arrangement.

FORT WILLIAM. LEGISLATIVE DEPARTMENT.

THE 23D AUGUST, 1841.

The following Act passed by the Right Honorable the Governor General of India in Council on the 23d of August 1841, is hereby promulgated for general information :

ACT NO. XIV. OF 1841.

An Act for the better Regulation of Markets in the Island of Bombay and Colaba.

I. It is hereby enacted, that whoever shall sell or expose for sale as good meat the flesh of animals that have died, or other noxious and unholesome provisions of any kind, or shall use any false weights or measures for the purpose of fraud, or shall be guilty of any nuisance affecting the public health in any Market within the Islands of Bombay and Colaba, shall be liable on conviction before a Magistrate of Police to a

fine not exceeding 200 Rupees.

11. And it is hereby enacted, that it shall be lawful for any Magistrate of Police from time to time to examine all weights and measures used in any Market within the said Islands, and all provisions exposed for sale therein, and to cause such weights and measures as he shall find to be false, and such provisions as he shall find to be noxious and unwholesome, to be forthwith destroyed-and every person obstructing any Magistrate of Police in the premises, shall be liable on summary conviction before the Petty Sessions to a fine not exceeding 200 Rupees, or to imprisonment with or without hard labor for three months.

ACT NO. XV. of 1841.

An Act for exempting Residents within Calcutta from giving Security in Suits in the Mofussil

Courts on certain occasions.

1. Whereas great inconvenience has been experienced by Residents within Calcutta by reason of their being obliged to give security in suits in the Mofussil Courts, under Regulation IX of 1819, Section 7. And whereas there is no occasion for requiring such security, now that by Act No. XXIII of 1840, property within Calcutta is liable to be seized under the process of the Mofussil Courts: -

It is hereby enacted, that Section 7, Regulation JX. of 1819, of the Bengal Code, is hereby

repealed.

The following Act passed by the Right Hon'ble the Governor General of India in Council on the 30th of August 1841, is hereby promulgated for general information.

ACT No. XVI. of 1841. An Act concerning the taking of Oaths of Qualification by Justices of the Peace.

1. Whereas inconvenience has arisen in con-

sequence of pursuing the course heretofore deem-

ed necessary for taking of Oaths by Justices of Peace, in order that they may be duly qualified to act under Commissions of the Peace :- It is hereby enacted, that all persons who are or shall be nominated and appointed in any Commission of the Peace, shall be capable of acting as Justices of the Peace in every respect, according to the tenor of such Commission, upon taking and subscribing in any Civil or Criminal Court of Justice within the places in and for which any such Commission shall have issued before the Officer presiding in such Court, whether such Officer be a Justice of the Peace or not, the Oaths appointed to be taken by Justices of the Peace; and the subscription of such persons to the said Oaths shall be deposited and kept with the Records of the Courts of Justice in which the said Oaths shall have been administered.

And it is hereby enacted, that every Justice of the Peace who, before the passing of this Act, shall have had administered to him the Oaths of qualification by any other Justice of the Peace, shall be deemed to have been duly qualified to act as a Justice of the Peace from the time of taking such Oath, and shall continue so qualified notwithstanding such Oath may not have been taken in a Court of Justice as required by any previous Law, or by this Act.

The following Act passed by the Right Hon'ble the Governor General of India in Council on the 30th of August 1841, is here by promulgated for general information.

ACT No. XVII, of 1841.

An Act for amending the proceedings in Appeals before the Court of Sudder Dewanny and Niza-mut Adawlut in the Presidency of Fort William in Bengal.

I. It is hereby enacted, that it shall be competent to cither of the Courts of Sudder Dewanny and Nizamut Adawlut, within the Territories subject to the Presidency of Fort William in Bengal, by an Order, under the signature of the Register of such Court, to transfer to such Register the duty of preparing appealed causes for trial, and of executing the decrees and orders of the said Courts, and to authorize him to issue the necessary process, and to proceed thereupon agreeably to the Rules prescribed by the gene-

ral Regulations of Government.

II. And it is hereby enacted, that in proceedings before the said Courts it shall not be necessary to take any security for costs, and it shall be competent for the said Courts of Sudder Debe competent of the said Country and Nizamut Adawlut to frame such Rules of practice for the due exercise of the Civil and Criminal Jurisdiction vested by the Regulations in those Courts, as may from time to time be found requisite. And such rules when so framed shall be submitted to the Governor General of India in Council; and after the same shall have been approved by the said Governor General of India in Council, they shall be of the same force as if they were inserted in this Act.

The following Act passed by the Right Hon'ble the Governor General of India in Council on the 30th of August 1841, is hereby promulgated for general information :

ACT No. XVIII. of 1841.

An Act for consolidating and amending the enactments concerning the exportation of Military

1. It is hereby enacted, that Arms, Ammunition and Military Stores (with the exception of Arms in the possession of Individuals for private use) shall not be exported, or otherwise taken from the territories of the East India Company, without a license from a public Officer or Officers for each Presidency, to be indicated by the Governments of the respective Presidencies, for the purpose of granting such licenses, and a full compliance with all such rules and conditions as may be prescribed for the guidance of such Officer or Officers in regard to such exports by the aforesaid Governments respectively. And any Arms, Ammunition or Military Stores which any person shall export, or attempt to export, or take as aforesaid, contrary to this Act, shall thereby become forfeited, on the award of the Officer or Officers authorized as aforesaid to grant licenses, or the Collector of Customs, and every person offending in the premises contrary to this Act shall be liable, on conviction before a Magistrate, to a penalty not exceeding 500 Rupees.

II. And it is hereby enacted, that any person who shall collect or keep in one place, or within places not exceeding three miles in distance from each other, any quantity of Gunpow-der exceeding fifty pounds, without a license from such Officer as aforesaid, shall be liable, on conviction before a Magistrate, to a penalty not exceeding 500 Rupees, and such Gunpow-der shall become forfeited on the award of the Officer or Officers authorized to grant licenses as aforesaid, or the Collector of Customs.

III. And it is hereby enacted, that it shall be lawful for any of the Governments aforesaid, to allow at any port or ports, the exportation of Arms, Ammunition and Military Stores as aforesaid, without any such license as aforesaid, as they shall deem expedient.

The following Act passed by the Right Hon'ble the Governor General of India in Council on the 6th of September 1841, is hereby promulgated for general information. ACT No. XIX. or 1841.

Act for the protection of moveable and immoveable property against wrongful, possession in cases

Whereas much inconvenience has been experienced, where persons have died possessed of moveable and immoveable property, and the same has been taken upon pretentled claims of right by gift or succession; the difficulty of ascertaining the precise nature of the moreable property in such cases, the opportunities for misappro-priating such property and also the profits of real property, the delays of a regular suit when

vexatiously protracted, and the inability of heirs when out of possession to prosecute their rights, affording strong temptations for the employment of force or fraud in order to obtain possession. And whereas, from the above causes, the circumstance of actual possession, when taken upon a succession, does not afford an indication of rightful title equal to that of a decision by a Judge after hearing all parties in a summary suit, though such summary suit may not be sufficient to prevent a party removed from possession thereby from instituting a regular suit. And whereas such summary suit, though it will take away many of the temptations which exist for assuming wrongful possession upon a succession will be too tardy a remedy for obviating them all, especially as regards moveable property. And whereas it may be expedient, prior to the determination of the summary suit, to appoint a Curator to take charge of property upon a succession, where there is reason to apprehend danger of misappropriation, waste or neglect, and where such appointment will, in the opinion of the authority making the same, be beneficial under all the circumstances of the case. And whereas it will be very inconvenient to interfere with successions to estates by the appointment of Curators, or by summary suits, unless satisfactory grounds for such proceedings shall appear, and unless such proceedings shall be required by or on the behalf of parties giving satisfactory proof that they are likely to be materially prejudiced if left to the ordinary remedy of a regular suit ;-

It is hereby enacted, that whenever a person dies leaving property, moveable or immoveable, it shall be lawful for any person claiming a right by succession thereto, or to any portion thereof, to make application to the Judge of the Court of the District where any part of the property is found or situate for relief, either after actual possession has been taken by another person, or when forcible means of seizing possession are

apprehended.

II. And it is hereby enacted, that it shall be lawful for any agent, relative, or near friend, or for the Court of Wards in cases within their cognizance in the event of any minor, disqualified, or absent person being entitled by succession to such property as aforesaid, to make the

like application for relief.

111. And it is hereby enacted, that the Judge to whom such application shall be made shall, in the first place enquire by the solemn declaration of the complainant, and by witnesses and documents at his discretion, whether there be strong reasons for believing that the party in possession or taking forcible means for seizing possession has no lawful title, and that the applicant, or the person on whose behalf he applies is really entitled, and is likely to be materially prejudiced if left to the ordinary remedy of a regular suit, and that the application is made bona fide.

: IV. And it is hereby enacted, that in case the Judge shall be satisfied of the existence of such strong ground of belief but not otherwise, he shall cite the party complained of and give notice of vacant or disturbed possession by pub-lication, and after the expiration of a reasonable time shall determine summarily the right to possession (subject to regular suit as hereinafter session (subject to regard the possession accor-mentioned) and shall deliver possession accor-dingly—provided always, that the Judge shall have the power to appoint an officer who shall take an inventory of effects, and seal for otherwise secure the same, upon being applied to for have concluded the enquiry necessary for citing-

the party complained of or not.

And it is hereby enacted, that in case it shall further appear upon such application and examination as aforesaid that danger is to be apprehended of the misappropriation or waste of the property before the summary suit can be determined, and that the delay in obtaining security from the party in possession, or the insufficiency thereof is likely to expose the party out of possession to considerable risk, provided he be the lawful owner; it shall be lawful for the Judge to appoint one or more Curators with the powers hereinafter next mentioned, whose authority shall continue according to the terms of his or their respective appointments, and in no case beyond the determination of the summary suit and the confirmation or delivery of possession in consequence thereof. Provided always that, in the case of land, the Judge may delegate to the Collector or to his officer the powers of a Curator, and also that every appointment of a Curator in respect of any property be duly pub-

VI. And it is hereby enacted, that the Judge shall have power to authorize such Curator, either to take possession of the property generally, or until security be given by the party in possession, or until inventories of the property shall have been made, or for any other purpose necessary for securing the property from misappropriation or waste by the party in possession. Provided always, that it shall be entirely discretionary with the Judge, whether he shall allow the party in possession to continue in such possession, on giving security, or not, and any continuance in possession shall be subject tosuch orders as the Judge may issue touching inventories, or the securing of deeds or other ef-

VII. And it is hereby enacted, that the Judge shall exact from the Curator security for the faithful discharge of his trust, and for rendering satisfactory accounts of the same as hereinafter mentioned, and may authorize him to receive out of the property such remuneration as shall appear reasonable, but in no case exceeding 5 per centum on the personal property and on the annual profits of the real property. All surplus monies realized by the Curator shall be paid into Court, and invested in public Securities for the benefit of the persons entitled thereto upon adjudication of the summary suit. Provided always, that although security shall be required from the Curator with all reasonable despatch, and, where it is practicable, shall be taken generally to answer all cases for which the person may be afterwards appointed Curator, yet no delay in the taking of security shall prevent the Judge from immediately investing the Curator with the powers of his office.

VIII. And it is hereby enacted, that, where the estate of the deceased person shall cousist wholly or in part of land paying revenue to Government, in all matters regarding the propriety of citing the party in possession, of appointing a Curator, and of nominating individuals to that appointment, the Judge shall demand a report from the Collector, and the Collector is hereby required to furnish the same. In cases of ur-gency the Judge may proceed, in the first instance, without such report, and he shall not be obliged to act in conformity thereto, but, in case of his acting otherwise than according to such report, he shall immediately forward a statement of his reasons to the Court of Sudder Dewanny Adawlut, and the Court of Sudder Dewanny Adawlut, if they shall be dissatisfied with such reasons, shall direct the Judge to proceed conformably to the report of the Collector.

IX. And it is hereby enacted, that the Curator shall be subject to all orders of the Judge regarding the institution or the defence of suits, and that all suits may be instituted or defended in the name of the Curator on behalf of the estate. Provided that an express authority shallbe requisite in the sunnud of the Curator's appointment for the collection of debts or rents; but such express authority shall enable the Curator to give a full acquittance for any sums of

money received by virtue thereof.

X. And it is hereby enacted, that pending the custody of the property by the Curator, it shall be lawful for the Judge to make such allowances to parties having a prima facie right thereto as upon a summary investigation of the rights and circumstances of the parties interested, he shall consider that necessity may require; taking, at his discretion, security for the repayment thereof with interest, in case the party shall, upon the adjudication of the summary suit, appear not to be entitled thereto.

And it is hereby enacted, that the Curator shall file monthly accounts in abstract, and at the period of every three months, if his administration last so long, and upon giving up the possession of the property file a detailed account of his administration to the satisfaction of

the Judge.

XII. And it is hereby enacted, that the accounts of any such Curator as is above described shall be open to the inspection of all parties interested, and it shall be competent for any such interested party to appoint a separate person to keep a duplicate account of all receipts and payments by such Curator. And if it be found that the accounts of any such Curator are in arrear, or if they shall be erroneous or incomplete, or if the Curator shall not produce them whenever he shall be ordered to do so by the Judge, he shall be liable to a fine not exceeding. one thousand Rupees for every such default.

X-111. And it is hernby enacted, that after the Judge of any district shall have, appointed any Curator, such appointment shall preclude the Judge of any other district within the same Presidency from appointing any other Curator, provided the first appointment be in respect of the whole of the property of the deceased. But if the appointment be only in respect of a portion of the property of the deceased, this shall not preclude the appointment within the same Prosidency of another Curator in respect of the residue or any portion thereof; provided always, that no Judge shall appoint a Curator or entertain a summary suit in respect of property which is the subject of a summary suit previously instituted under this Act before another Judge and provided further, that if two or more Curators be appointed by different Judges for several parts of an extate, it shall be lawful for the Sudder Dewauny Adamlut to make such order as it shall think fit for the appointment of one Curator of the whole property.

XIV. And it is hereby provided, that this Act shall not be put in force, unless the aforesaid application to the Judge be made within six months of the decease of the proprietor, whose

preperty is claimed by right in succession. shall not be put in force to contravene any public act of Settlement. Neither in cases in which the deceased proprietor shall have given legal directions for the possession of his property after his decease in the event of minority or others

XVI. And it is hereby provided, that this Act shall not be put in force, for the purpose of disturbing the possession of the Court of Wards of any Presidency, and in case a minor, or other disqualified person whose property shall be subject to the Court of Wards, shall be the party on whose behalf application is made under this Act, the Judge if he determines to cite the party in possession and also to appoint a Curator, shall invest the Court of Wards with the Curatorship of the estate pending the suit without taking such security as aforesaid, and in case the minor or other disqualified person shall, upon the adjudication of the summary suit appear to be entitled to the property, possession shall be delivered to the Court of Wards.

XVII. And it is hereby provided, that nothing in this Act contained shall be any impediment to the bringing of a regular suit either by the party whose application may have been rejected, before or after citing the party in possession, or by the party who may have been evicted

from the possession under this Act.
XVIII. And it is hereby enacted, that the decision of the Judge upon the summary suit under this Act shall have no other effect than that of settling the actual possession; but that for this purpose it shall be final, not subject to any

appeal or order for review.

XIX. And it is hereby enacted, that it shall be lawful for the Governments of the respective Presidencies to appoint public Curators for any district or number of districts. And the Judge having jurisdiction shall nominate such public Curator or Curators in all cases where the choice of a Curator is left discretionary with him under the preceding provisions of this Act.

XX. And it is hereby enacted, that whenever a person dies leaving moveable or immoveable property within the docal limits of the jurisdiction of any of Her Majesty's Supreme Courts, and such Court shall be satisfied that danger is to be apprehended of the misappropriation and waste of the property before it can be ascertained who may be legally entitled to the succession to such property, it shall be lawful for the said Court to authorize and enjoin the Ecclesiastical Registrar, or one or more Curators to collect such effects and hold or deposit or invest the same in such manner and place and upon such security and subject to such orders and directions as the Court may deem expedient. ACT No. XX. OF 1841.

Act for facilitating the collection of debts on successions, and for the security of parties paying debts to the representatives of deceased persons.

I. Whereas it is expedient to provide greater accurity for persons paying to the Representa-tives of deceased Hindoos, Mahomedans, and others not usually designated as British Subjects, debts which are payable in respect of the estates of such deceased persons, and to facilitate the col-

lection of such debts by removing all doubts as to the legal title to demand and receive the same:-

It is hereby enacted, that No debt recovera- no debtor of any deceased ble without a certifi- person shall be compelled in any Court of Law to pay

his debts to any person claiming to be entitled to the effects of any deceased person or any part thereof, except on the production of a certificate to be obtained in manner hereinafter mentioned or of a Probate or Letters of Administration, unless the Court shall be of opinion that payment of the debt is withheld from fraudulent or vexatious motives, and not from any reasonable doubt as to the party entitled.

II. And it is hereby en-Manner of obtain- acted, that the Zillah or. District Court within the jurisdiction of which any

part of the property of the deceased may be found shall have authority to grant a certificate under this Act. The applicant in his petition shall set forth his title. The Judge shall issue notice of application, inviting claimants, and fixing a day for hearing the petition, and upon the appointed day or as soon after as may be convenient shall determine the right to the certificate, and grant the same accordingly.

Ill. And it is hereby Effect of certifi- enacted, that the certificate of the District or Zillah cale. Judge shall be conclusive

of the representative title against all debtors to the deceased, and shall afford full indemnity to all debtors paying their debts to the person in

whose favor the certificate has been granted.

IV. And it is hereby.

Sucurity taken enacted, that the District from grantee of cer- or Zillah Judge may take tificate. such security as he shall think necessary from any person to whom he shall grant a certificate for rendering an account of debts received by him, and for indem-

nity of persons who may be entitled to the whole or any part of the monies received by virtue of such certificate, whose right to recover the same by regular suit against the holder of the certificate is not affected by this Act.

V. And it is hereby en-Decision of Judge acted, that the granting of such certificate may be suspended by an appeal to the

Court of Sudder Dewanny Adawlut, which Court may declare the party to whom the certificate should be granted, or may direct such further proceedings for the investigation of the title as it shall think fit. The Court may also upon peti-tion, after a certificate shall have been granted by the District or Zillah Judge, grant a fresh certificate in supersession of the certificate granted by the District or Zillah Judge, and such fresh certificate shall not affect any payments made to the person to whom any former certificate may have been granted without notice that the same has been superseded, but shall entitle the por-son named therein to receive all monies that may have been recovered under the first certificate from the person to whom the same may have been grauted.

Local extent of enacted, that every certifipower given by cer- cate shall give authority to the person to whom the tificate. same is granted throughout

the Presidency within which the same is granted and no certificate subsequently granted in respect of the same property shall be valid or effectual except as hereinafter mentioned.

Government Notes and Dividends.

VII. And it is hereby enacted, that a person certified as aforesaid, may be empowered to receive in-

terest on Government Notes and Dividends, or on Shares of any Bank or parts thereof and to negotiate such Securities. He may be also empowered to receive a share of such interest or dividends or to negotiate a share of such Securities. But these powers shall only arise by express words in the certificate.

Payments under certificate void by reason of previous certificate.

VIII. And it is hereby enacted, that where a certificate shall have been grauted in cases in which such certificate would be valid, but for the previous

grant of a certificate, all payments made to the person holding the latter certificate in ignorance of the grant of the previous certificate shall be held good against claims under such previous certificate.

Certificate after previous grant of Probate or Letters void. IX. And it is hereby enacted, with regard to the property of deceased Hindoos, Mohometans and other persons not usually designated by the term Brit

tish Subjects, that no certificate in respect of any such property shall be valid, if made after a Probate or Letters of Administration granted in respect of the same, provided assets belonging to the deceased were at the time of his death within the local jurisdiction of the Court granting the Probate or Letters of Administration.

Bona fide payments protected.

X. And it is hereby
provided, that where a certificate shall have been
granted in cases in which

such certificate would be valid, but for a Probate or Letters of Administration previously granted, all payments made to the person holding the certificate in ignorance of the previous granting of the Probate or Letters of Administration, shall be held good against claims under the Probate or Letters of Administration so previously granted.

Probate or Letters after previous grant of Centificate.

XI. And it is hereby enacted, that no Probate or Letters of Administration shall be valid for the purpose of the recovery of

debts or for the security of debtors, after a certificate granted in respect of the same property for which such Probate or Letters of Administration shall have been granted, provided assets belonging to the deceased were at the time of his death within the jurisdiction of the Court granting such certificate.

Bond fide payments protected.

XII. And it is hereby provided, that where Probate or Letters of Administration may have been grant-

ed, in cases in which such Probate or Letters of Administration would be valid, but for the previous grant of a certificate, all payments made in ignorance of the previous grant of the certificate shall be held good against claims under such previous certificate.

XIII. And whereas under Act No. XIX. of 1841, Curators may be invested with certain powers which are conferred on persons obtaining certificates under this Act, and which belong to Executors and Administrators, it is hereby enacted that Curators appointed under the said Act

shall not exercise any powers which; but, for that Act, would lawfully belong to such persons obtaining certificates, Executors for Administrators where a certificate, Probate or Letters of Administration has been actually obtained; but all persons who may have paid debts or rents to a Curator authorized by a Judge to receive the same shall be indemnified and the Curator shall be responsible for the payment of the same to the person who has obtained a certificate, the Executor, or Administrator, as the case may be.

XIV. And it is hereby

Effect of Probates and Lecters granted to Representatives of Hindows and others.

AIV: And it is hereby declared and enacted, that all Probates and Letters of Administration granted by any of Her Majesty's Courts in cases in which

any assets belonging to deceased persons were, at the time of their deaths, within the local jurisdiction of the Court granting the Probate or Letters of Administration, shall have the effect of Probate and Letters of Administration granted in respect or the property of British Subjects but for the purpose of the recovery of debts only, and the security of debtors paying the same; except so far as is in this Act provided.

XV. And it is hereby provided that nothing in this Act contained shall be held to extend to the property of any person usually designated as a British Subject.

The following Act passed by the Right Hon'ble the Governer General of India in Council on the 6th of September 1841, is hereby promulgated for general information:

And the better Prevention of Local Naisancess 1. It is hereby enacted, that it shall be lawful for any Magistrate, when the public benefit and comfort are in question, to cause unlawful obstructions and nuisances to be removed from thoroughfares and public places, and to suppress or cause to be removed to a different place, trades or occupations injurious to the health or comfort of the community, and to prevent such construction of buildings and such disposal of combustible substances as may appear to him likely to occasion conflagration, and to cause the removal of buildings in such state of weakness, as by the probability of their falling, may appear to

him to expose individuals to danger. 11. And it is hereby enacted, that, in exercising the authority conferred by the above section, the Magistrate shall after holding such eaquiry as may satisfy him of the necessity of proceeding under this Act, issue an injunction, which, if practicable, shall be served personally on the parties concerned; but if such service shall be impracticable or very inconvenient, the injunction shall be notified by oral proclamation. and a written notice thereof small be set up at such place or places as may be best a tapted for conveying information to the parties concerned, And in case such injunction be not obeyed, the Magistrate may compel observance thereof by force, and panish disobedience by line not exceeding 200 Rupees or by imprisonment without labor for any period not exceeding one month, and if the Magistrate finds it necessary to mour expence in removing noxious or dangerous articles or buildings, it shall be lawful for him to sell the same or their materials by public auc-

tion in order to defray the charge, delivering any surplus that may remain to the owner. And any surplies and a strate to compel, it shall be lawful for the Magistrate to compel, under the like penalty, the owners of tanks or wells adjacent to any public thoroughfare to fence the same in such manner as to prevent dan-

ger to the public arising therefrom.

III. And it is hereby provided and declared, that it shall be lawful for any person affected by such injunction or written notice as is above described, if he shall object thereto, to claim, by written petition to be presented to the Magistrate within the period of ten days if reasonably practicable, if not, within the shortest reasonable further time from the receipt, of such injunction or the publication of such notice, that a Jury or Punchayet may be appointed to try and decide the question ; and the Magistrate shall, on receiving such petition, pass order thereupon for the appointment of a Jury or Punchayet, which shall consist of not less than five persons, whereof the President and one-half of the other Members shall be nominated by the Magistrate from the residents in the vicinity, and the remaining Members shall be nominated by the party petitioning. And the Magistrate shall suspend the further execution of the injunction or order pending such enquiry, and be guided by the decision of the said Jury which shall be according to the opinion of the majority. Provided however that if the petitioner shall by neglect or in any other way prevent the appointment of such Jury or Punchayet, or if, from any cause the Jury so appointed shall not decide and report within a reasonable time to be fixed in the order for their appointment, their functions shall cease from the date of the expiration of such period, unless they be continued by special order of the Magistrate, and if from any of the above causes no decision be made by a Jury or Punchayet, the Magistrate's order shall take effect as if not opposed.

IV. And it is hereby provided that all the proceedings of Magistrates under the authority of this Act shall be subject to the like appeal as other orders of Magistrates according to the Regula. tions of the respective Presidencies.

V. And it is hereby enacted, that this Act shall not be applicable within the local limits of

Her Mujesty's Courts of Justice.

ACT No. --- OF 1841.

An Act for Amending such parts of the Bengal and Madias Codes as concern the dismissal of Suits and Appeals for neglecting to proceed in the

I. It is hereby enacted, that if a Plaintiff or Appellant in any Court shall, at any time, neg-lect to proceed in his Suit or Appeal for six weeks, the Suit or Appeal shall be dismissed; and it shall not be necessary to give the Plaintiff or Appellant any notice previous to dismissing his Suit or Appeal. The Suit or Appeal shall be dismissed as of course after the expiration of six weeks without any proceeding on the part of the Court, or of the Defendant, or otherwise, or assignment of any reasons, unless the Plaintiff or Appellant, upon special application, shall have previously satisfied the Court of the propriety of allowing further time. The Court shall record upon the proceedings the reasons at large for allowing further time in all cases in which further time may be allowed, but it shall not be necessary to specify the reasons for refusing any application for further time.

II. And it is hereby enacted, that in all cases in which a Suit or Appeal is dismissed under the preceding Section the Court shall award to the Defendant or Respondent the costs he may have incurred in the Sait or Appeal. But such dismissal shall be no impediment to the institution of a new Suit or Appeal, where the party is not precluded by lapse of time, or otherwise than by the mere circumstances of having instituted the suit or Appeal dismissed and of such dismissal, and such dismissed Suit or Appeal shall not prevent lapse of time under the Law of Limita-

tions being incurred.

III. And it is hereby enacted, that Clause 2, Section 27, Regulation X XIII. 1814, of the Bengal Code, is repealed, and no appeal shall lie sgainst the decision passed in accordance with the provisions of the preceding Clauses of this Act, other than a summary appeal on the fact of default.

Ordered, that the said Draft be re-considered at the first Meeting of the Legislative Council of India after the 13th day of December next.
