RESOLUTION OF THE RIGHT HONORABLE THE GOVERNOR GENERAL.

FINANCIAL DEPARTMENT.

Allahabad, 23d June, 1842.

The Governor General observes, that a Comparative Statement of Civil Charges in Bengal and the North Western Provinces, from the 1st of May 1830 to the 1st of May 1841

Years.	Cos. Rs.	(compiled from the books of the Civil Auditors) exhibits a gradual increase of Charges during the last six years of that series, amounting to Ninety-nine Lakhs of Rupees under the several heads of Salaries and Commission, Establishment, and Contingencies, while under those heads in the previous years of that series (until 1834 35) no material or regular increase took place.

2d. The Governor General is pleased to appoint a Committee of Finance to consider and report, from time to time, upon the Civil Charges of Bengal and the North Western Provinces, with power to send for Papers and Records, and to require explanations of the several Charges from the several Officers of the Government.

3d. The Governor General is pleased to appoint T. H. Maddock Esq., Secretary to the Government of India, in the Secret and Political Departments, in charge of all the Civil Departments with the Governor General.

Lieutenant Colonel J. Stuart, 34th N. I. Secretary to the Government of India, in the Military Department, and

C. G. Mansel Esq., Junior Secretary, in all the Civil Departments with the Governor General,—to be Members of the Committee.

F. Currie Esq., Judge of the Sudder Dewanee and Nizamut Adawlut, North Western Provinces, and

J. Thomason Esq., Member of the Sudder Board of Revenue, North Western Provinces,—to be temporary Members of the Committee;—and to nominate Lieutenant H. M. Durand, His Lordship's Private Secretary, to be Secretary to the Committee.

4th. The Governor General directs, that all orders of the Committee shall be signed by the Secretary; but the Reports of the Committee will be signed by the several Members thereof.

5th. The Governor General desires, that the Committee will, in the first instance, give their attention to the Charge under the head of Contingencies which in Bengal alone has increased more than Fifty Lakhs of Rupees in the course of the last eight years.

6th. The Committee will keep a Record of all their proceedings, and such Record will be submitted to the Governor General by the Secretary of the Committee on the first day of every week.

7th. The Governor General refers the Committee to the Returns of all Civil Offices and the

THE 24TH JUNE 1842:

The following Draft of a proposed Act was read in Council for the first time on the 24th of June 1842.

ACT No. — OF 1842.

An Act concerning the terms of Leases granted by Zemindars and Proprietors.

It is hereby enacted, in modification of Sections II. and III. Regulation XIV. of 1812, of the Bengal Code, that Zemindars or other Proprietors of Land may grant leases, or fix the rent of any land tenure, for any period not exceeding the terms of their own respective engagements with Government. Provided always, that in case any lease shall be granted, or the rent of land be fixed for any longer period, the lease or engagement fixing the rent shall be null and void only for the excess beyond such terms respectively.

Ordered, that the Draft now read be published for general information.

Ordered, that the said Draft be reconsidered at the first Meeting of the Legislative Council of India, after the 24th day of August next:
