GENERAL ORDER BY THE HON'BLE THE PRESIDENT IN COUNCIL.

Forth William, 7th April 1843.

In continuation of General Orders, No. 180 of the 21st July, and No. 276, of the 1st December 1841, the fol-lowing Act passed by the Honorable the President of the Council of India in Council in the Legistative Department on the 28th of October 1842, with the assent of the Right Honorable the Governor General of India, is published for general information.

#### "ACT No. XII. of 1842."

"An Act for the better Regulation of Military Bazars and defining the liabilities of Camp Followers."

I. It is hereby enacted, that no person residing within the limits of any Military Cantonment, and carrying on trade therein, or who shall have been a trader at any Military Cantonment, shall be allowed to recover in any Mili-tary Court of Requests for the Native Troops, of the East India Company held within any such Cantonment any debt contracted in the way of trade, or for the loan of money, within any such Cantonment by any person subject to the jurisdiction of such Court, unless the person seeking to recover the debt shall at the time of contracting thereof have been registered as a Military Bazarman within any such Cantonment.

II. And it is hereby declared, that all persons serving with any part of the Army and receiving public pay in any capacity, menial servants, and other Camp Followers of every description shall be subject to the provisions of Act No. XI of 1841, and No. XXVIII. of 1841, in like manner as enlisted Soldiers. #### ACT NO. X. OF 1843.

An Act for the Administration of Justice and Col-lection of the Revenue in the Districts of Kurnool and Bunganapilly.

Administration of Civil and Criminal jus-tice and Police and Superintendence of all Revenue affairs in the Districts of Kurnool and Bunganapilly vested in an Agent to be appointed by Govern-ment of Fort St. George with Assistants simiarly appointed.

It is hereby enacted, Ι. that from and after the First day of September 1843, the Administration of Civil and Administration of Civil and Criminal Justice, the Super-intendence of the Police, and the Collection of Su-perintendence of the Re-venues of every description within the Districts of Kurnool and Bunganapilly shall vest in such Agent to the Governor of Fort St. George as shall be appointed by the

Governor in Council of Fort St. George, and shall be exercised by the said Agent with the aid of such Assistants as may be appointed by the said Governor in Council.

Government of Fort St. George may pre-scribe rules for guid-ance of Agent and his Subordinates.

enacted, that upon the re-ceipt of any Criminal trials referred by the Agent under the Rules which may be hereafter prescribed by the Governor in Council, the Foujdaree Udalut shall pro-

ceed to pass a final judgment, or such other order as may after mature consideration, seem to the Court requisite and proper, in the same manner as if the trial had been sent up in ordinary course from a judge of Circuit.

Civil appeals to be decided by Suder Uda-lut as appeals from the Court of Sudder Udalut shall proceed to try and determine it, in the same manner as Appeals from

the Provincial Courts.

FORT WILLIAM, HOME DEPARTMENT, LEGISLATIVE, THE 22D JULY, 1843. The following Act passed by the Right Hon'ble the Governor General of India in Council on the 22d July 1843, is hereby promulgated for general information.

Act No. XI. or 1843. An Act for regulating the service of Hereditary Officers under the Presidency of Bombay. Whereas it has been found, that the Freamble. provisions of Regulation XVI. 1827 of the Bombay Code, are insufficient to secure the efficient discharge of the duties of Hereditary Officers.

**Hereditary Officers:** 

I. It is hereby enacted, that Sections XVII. and XVIII of Regulation XVI. of 1827 of the Bombay Code, be rescinded. II. And it is hereby enacted, that all Hereditary

Officers of whatever denomination, belonging to, or employed in the management of the Land Revenue, employed in the management of the Land Revenue, or of the Customs or Town Duties, or Excise, or other Revenue, or in the Police, or in the Civil Adminis-tration of the country, shall render the usual services of their respective Offices, as far as the same may be required by the Collector, or other Officer under whose control they may be placed by usage or the orders of Government. orders of Government.

And it is hereby enacted, that when the of an Hereditary Office fall in more than III. duties of an Hereditary Office fall in more than one Department, it shall be competent to the Governor in Council of Bombay to prescribe what Officer shall be vested with the control of such Office.

IV. And it is hereby enacted, that it shall be com-petent to the Collector or other Officer to whom the duties of an Hereditary Office are, as provided in Clause II., to be rendered, when the performance of those duties is claimed in rotation by different sharers, those duties is claimed in rotation by different sharers, to require, that the sharers in the wuttun shall no-minate a fit and proper person from among their number, who shall hold the Office as the Represen-tative of the family either during life, or for such term, not being less in each instance than (five) 5 years, as the Collector or Controlling Officer shall deter-mine with the sanction of the Governor in Council, and in the event of the sharers not so nominating, when required one or more of their number within a when required one or more of their number within a reasonable period to be fixed by the Collector or Controlling Officer, the Collector or Controlling Officer shall himself exercise the power of selec-tion, subject to the approval of the Governor in Council. V. A

And it is hereby enacted, that it shall be competent to the Collector or controlling Officer to refuse to confirm the nomination by the sharers of any to confirm the nomination by the sharers of any in-dividual, if he shall have reason to think, that from age or personal disqualification the duties of the Of-fice will not be properly performed by him, or if from character and past conduct the person nominated be considered unworthy of trust, provided that the grounds of such refusal shall be recorded in writing, and that an appeal from such devision shall, lie to the and that an appeal from such decision shall lie to the Governor in Council, whose order thereon shall be final.

VI. And it is hereby enacted, that the Collector or Controlling Officer shall have power to punish Officiating Hereditary Officers for misconduct or neglect of duty by suspension from office, pay, and emo-lument or by fine not exceeding the computed official emolument of their offices for three months, and to levy the said fine in the mode authorized for realizing

levy the said fine in the mode authorized for realizing Revenue demands. VII. And it is hereby further enacted, that the Collector or Controlling Officer, in cases of miscon-ductor incompetency on the part of an Officiating Hereditary Officer, shall have power to dismiss such Officer from his employment, but no such dismissal shall take place, except on an investigation recorded in writing, which shall be submitted for the approval and sunction of the Governor in Council. and sunction of the Governor in Council.

And it is hereby enacted, that, in conduct-ing the investigation prescribed in the preceding Section, the Collector or Controlling Officer shall have the same authority as a Magistrate in compelling the attendance of parties and witnesses, and the pro-duction of papers, and in taking evidence.

Anditis hereby enacted, that if any Here-ditary Officer is incapable of personally discharging the daties of his or her office by reason of sex, mino-rity, mental or bodily infirmity, or manifest incapa-city, it shall be lawful for the Collector or Control-ling Officer to call upon him or her, or his or her Guardians to appoint a Deputy, subject to his ap-proval, and on the party or patties failing to appoint a fit Deputy within a reasonable period, the appoint-ment shall be made by the said Collector or Con-trolling Officer.
