FORT WILLIAM.
LEGISLATIVE DEPARTMENT.
THE 25TH NOVEMBER 1842.
The following Act is passed by the Hon'ble the President of the Council of India in Council, on the 25th of November 1842, with the assent of the Right Hon'ble the Governor General of India, which has been read and recorded men read and recorded.

Ordered, that the Act be promulgated for general

information.

Act No. XIV or 1842.

An Act for giving greater facility in the abatement and prosecution of Naissances in and through the Towns and Islands of Bombay and Colaba.

I. It is hereby enacted, that no person shall throw, or deposit, or cause to be thrown or deposited any entensive matter or thing whatever on any open space of ground continuous to any public thorough for each

offensive matter or thing whatever on any open space of ground contiguous to any public thoroughfare on the Islands of Bombay or Colaba.

II. And it is hereby enacted, that the owner or occupier of every such open space shall on a written order from the Court of Petty Sessions for such purpose forthwith enclose the same with a fence or wall, and in default thereof for the space of ten clays, the said Court shall cause such enclosure to be made, and the expence thereof shall be defrayed by the Municipal Fund, and the said owner or occupier shall be liable to a penalty not exceeding twice the

the Municipal Lund, and the said owner or occupier shall be liable to a penalty not exceeding twice the amount so expended.

III. And it is hereby enacted, that it shall be lawful for the said Court of Petry Sessions to order and direct, that proper and suitable drains or gutters for the conveyance of wastage, water, filth and other offensive matter proceeding from the houses or premises of any of the inhabitants or occupiers thereof, shall be made and built by the owners of such houses. mises of any of the inhabitants or occupiers thereof, shall be made and built by the owners of such houses in such manner as the said Court of Petty Sessions shall direct, and upon such owners failing so to do, and also to keep the same in repair, for the space of ten days after notice to that effect shall have been given by the said Court, the said Court may cause such drains or gutters to be built or repaired, and the expense thereof shall be defrayed out of the Municipal Fund, and the said owners shall be liable to a penalty not exceeding twice the amount of such

a penalty not exceeding twice the amount of such expense; provided always, that a default in the making or repairing such drains or gutters has created or is likely to create a public nuisance.

IV. And it is herely enacted, that the owner or occupier of any house or tenement having a privy erected upon his premises shall have such privy shut out by a sufficient wall or fence from the view of correspondents.

V. And it is hereby enacted, that every privy, sink, drain, water courses, compound, yard, lane or passage adjoining or belonging to any house or premises shall be kept clean by the owners or occupiers thereof, so that the same shall not become a public

thereof, so that the same shall not become a public nuisance.

VI. And it is hereby enacted, that no person shall throw or deposit any filth or rubbish on the roof or weather-boards of any buildings, or suspend therefrom any article whatever so as to project over any street or public thoroughfare. Nor shall any person bathe himself or wash any animal or clothes, or throw any offensive matter, or thing whatever in or into any of the public tanks or wells, and the Governor in Council is hereby empowered from time to time by Proclamation to declare, what tanks or wells hall be deemed Public, and also which of such Public tanks or wells may be used for the purpose of bathing and washing linen therein.

VII. And it is hereby enacted, that it shall be lawful for the Court of Petty Sessions to require any person, owner or tenant, keeping a public brothel or lodging houses for Prostitutes, or disorderly character of any description in any of the more public roads or streets of Bombay and Colaba, to shut up the same or to remove such tenants from the premises, and on

his failing to do so within the time specified in a no-tice to be given to him to that effect, he shall be deemed to have offended against the provision of this

VIII. And it is hereby enacted, that no person shall keep a Coffee Shop, Eating House, or any place of public resort, other than a legally licensed Tavern or Spirit Shop, without the permission or license of the Court of Petty Sessions, which Court is hereby empowered to grant such permission or license in writing, and which may be revoked by the said Court on good and sufficient cause.

IX. And it is hereby enacted that the provision of the said that the provision of the said court on good and sufficient cause.

on good and sunction cause.

IX. And it is hereby enacted, that all offences against this Act shall be summarily enquired into and decided by the Court of Petty Sessions, and every offence for which there is not a special penalty shall be punishable by a fine not exceeding two hundred

X. And it is hereby enacted, that all fines imposed under this Act shall, be paid into the General Treasury for the benefit of the Municipal Fund.

An Act for declaring and amending the law regard-ing the condition of Slavery within the Territories of the East India Company,

It is hereby enacted and declared, that no public Officer shall in execution of any decree or order of Court, or for the enforcement of any demand of Rent or Revenue sell or cause to be sold any person or the right to the compulsory labor or services of any person on the ground that such person is in a

II. And it is hereby declared and enacted, that no rights arising out of an alleged property in the person and services of another as a slave shall be enforced by any Civil or Criminal Court or Magistrate

within the Territories of the East India Company.

III. And it is hereby declared and enacted, that no person who may have acquired property by his own industry or by the exercise of any art, calling or own industry or by the exercise of any art, calling or profession, or by inheritance, assignment, gift or bequest shall be dispossessed of such property or prevented from taking possession thereof on the ground that such person or that the person from whom the property may have been derived was a slave.

IV. And it is hereby enacted, that any Act which would be a penal offence if done to a free man, shall be equally an offence if done to any person on the pretext of his being in a condition of slavery.

Ordered, that the Draft now read be published for general information.

Ordered that the said Draft be re-considered at the first meeting of the Legislative Council of India after the 6th day of April next.

An Act for regulating inquiries into the truth of matters implicating the public conduct of Officers not removeable without the sanction of Government.

I. Whereas it is expedient to amend the provisions contained in the Regulations concerning inquiries into the truth of matters implicating the public conduct of European Officers, and to extend the same to all Officers not removeable without the sanction of Government:

of Government:

It is hereby enacted, that Regulations III. of 1809, II. of 1810. VI. of 1811, and VIII. of 1822, of the Madras Code, be repealed.

II. And it is hereby enacted, that in the Territories subject to the Presidency of Fort St. George in Madras, whenever either the Courts of Suddur and Foujdaree Adawlut, or the Board of Revenue, shall be of opinion that substantial grounds exist for making a regular and formal inquiry into the truth of any imputation of official misconduct affecting any Officer subject to their controll respectively, and not removeable without the sanction of Government, they shall submit the documents on which their opinion may be founded, together with a statement of they shall submit the documents on which their opinion may be founded, together with a statement of the charges reduced to distinct articles which they may propose to be made the subject of a regular investigation, to the Governor in Council of Fort St. George, for his consideration and orders.

III. And it is hereby enacted, that any charge or information, of the description aforesaid, may be preferred direct to the Courts of Suddur and Foujdaree Adawlut, or to the Board of Revenue, respectively, who shall examine the complainant or informant circumstantially upon oaths, or upon solemn affirm—

circumstantially upon oaths, or upon solemn affirmation if he be entitled to be exempted from taking an oath, and require the party accused to explain or reply to any matters they may deem to need explanation and make such further inquiries, upon oath or affirmation upon the subject as they may judge pro-

IV. And it is hereby enacted, that any charge or 1V. And it is hereby enacted, that any charge or information may also be made before any Judge, Magistrate, or Collector, for any acts of the description beforementioned committed within their jurisdiction respectively, who shall examine the complainants or informants circumstantially upon oath, or upon solemn affirmation if he be entitled to be exempted from taking an oath, and shall transmit the deposi-tion so taken to the Suddur and Foujdaree Adawlut, or to the Board of Revenue, according as the person accused may be subject to those Authorities respec-

V. And it is hereby provided, that it shall not be lawful for the Courts of Suddur and Foujdaree Adawlut, or the said Board, respectively, to act upon any such charge or information, unless the person prefering the same shall make oath or solemn affirmation in case he be entitled to be exempted from taking an oath, that he believes the facts on which the charge is grounded to be true.

VI. And it is hereby provided, that it shall be

vII. And it is hereby provided, that it shall be lawful for the Courts of Suddur and Poujdarce Adawlut and for the said Board, respectively, to dismiss any such charge or information, where they do not see any substantial reason for entering further into the inquiry. Provided, that on every occasion when they shall dismiss any such charge or information, they shall dismiss any such charge or information, they shall submit the same, together with all the circumstances of the case, in like manner, as is provided in Section II. of this Act.

VII. And it is hereby provided, that the said Courts of Suddur and Foujdarce Adawlut, and the said Board, respectively, may at any stage of the inquiry

Courts of Suddur and Foujdaree Adawiut, and the said Board, respectively, may at any stage of the inquiry into such matters as aforesaid, require the person preferring such charge or information as aforesaid to furnish such security as may be deemed reasonable that he will attend and prosecute the charge to a con-clusion, and in the event of security being so required all proceedings shall be stayed until the same shall be furnished accordingly.

furnished accordingly.

VIII. And it is hereby provided, nevertheless, that if any matter of the nature aforesaid, affecting such Officer as is mentioned in the second Section of such Officer as is mentioned in the second Section of this Act, shall appear in the course of any proceed-ings, whether preliminary or otherwise, which shall come before or be reported to either of the Courts of Suddur and Foujdaree Adawlut, or the said Board, respectively, those authorities shall act upon such matter, or institute such inquiry upon oath or affirma-tion as aforesaid, into the same as they shall deem

proper for the purpose of such reference as aforesaid proper for the purpose of such reference as aforesaid to the Governor in Council of Fort St. George, although no charge or information be preferred as aforesaid; and in such cases it shall not be necessary, before acting upon or instituting any inquiry con-cerning any matter so appearing in the course of proceedings, to require any oath or affirmation in regard

to the truth of such matter.

IX. And it is hereby enacted, that if the Governor in Council of Fort St. George, upon such reference as is mentioned in the second Section of this Act, shall concur with the Authority by which it may be submitted, or if such Governor in Council whell from information of the description afternation shall, from information of the description aforesaid that may be laid before him in respect of any Officer not directly subject to the Courts or Board above named, deem it necessary to institute proceedings against any such Officer, he shall appoint a Commissioner or Commissioners, for making a regular and formal inquiry into the truth of the matters referred. And it is hereby enacted, that it shall be competent to the Governor in Council by an Order of Council to determine in all cases where such Commissioner or Commissioners shall hold their sittings—as well within the local limits of Her Majesty's Supreme Court, as beyond those limits.

X. And it is hereby enacted, that on the appointment of every such Commission, the said Governor in Council shall direct whether the Commission shall be placed under the control of any of the Anthorities aforesaid, or shall actimmediately under the authority of Government, and all Commissions appointed as aforesaid shall be guided by the instructions which they may receive in this behalf from the Government.

XI. And it is hereby enacted, that the Commissions and the Commissions are the commissions and the commissions are the commissions.

And it is hereby enacted, that it shall be the duty of Commissioners appointed under this Regulation, after receiving the plaint or charge, and the documents from which the same may have been prepared, to call upon the person accused for his reply to the accusation, to examine upon oath, or under a solemn declaration, the witnesses named by the accuser or the accused; to receive any further writ-ten documents offered in support of, or against the accusation; and to call for and take any further reactisation, and to tail for any be indicated by the witnesses adduced or documents exhibited by either party, and may appear to be necessary for the ascertainments of facts, or the discovery of the truth or falsehood of the charges, or of any part thereof.

XIV. And it is hereby enacted, that for the dis-

charge of the duties specified in the preceding Section, or any other functions which may be delegated to a Commission under this Regulation, such Commission when holding its sittings without the local limits of the Supreme Court of Madras shall be vestwith the same powers as are exercised by the ed with the same powers as are exercised by the Zillah Courts, except that all process to cause the attendance of witnesses, or other compulsory process, shall be served through the Zillah Judge in whose jurisdiction the Commission may be held, and executed by the Zillah Judge in whose jurisdiction the witness or other person upon whom the process is the becaused may reside.

XVI. And it is hereby enacted, that the provisions of Act XXIII. of 1840 shall be applicable for all the purposes of such Commissions aforesaid, in the same way as that Act is now applicable to Courts

within the Provinces.

XVII. And it is hereby enacted, that in the event of any witness duly summoned by ordinary subpoena, or by subpoena ducesticum, through the medium of the Supreme Court (according as is prescribed in Act No. XXIII. of 1840) not attending before such Commissioner or Commissioners aforesaid, refusing to give evidence, or to produce such documentary evidence as may be called for by such Commissioners, that it shall be lawful for such Commissioner or Commissioners to issue process of arrest and search, and such process shall be executed through the Supreme Court, in the same manner as is prescribed in the Act for the execution of other process through the instrumentality of Her Majesty's Supreme Court of Judicature.

XVIII. And it is hereby enacted, that the provisions of Act XV. of 1835 shall be applicable (in cases of a Commission sitting within the limits of the Supreme Court) to the purposes of this Act-Provided, however, that in the case of any Euro-Provided, however, that in the case of any European British subject, rendering himself amenable to any of the penalties set forth in this Act, the Commissioner or Commissioners shall have the power to commit such person to the custody of the Superintendent of Police, for eventual trial before the Supreme Court, in the case of perjury or for temporary imprisonment under the award of such temporary imprisonment under the award of such Commissioner or Commissioners.

XIX. And it is hereby enacted, that on the close of the evidence for the prosecution and defence, the accused shall be at liberty to record any observation upon the result of the inquiry which he may think necessary for the vindication of his conduct and character. The accuser, or the person appointed to conduct the prosecution on the part of Government, shall also be at liberty to record any remarks on the subject of the prosecution which he may deem requi-

XX. And it is hereby enacted, that as soon after the conclusion of the proceedings as circumstances shall permit, the Commissioner or Commissioners shall, when the Commission shall be instructed to act immediatly under the authority of Government, submit directly to the Government to which he or they may be subordinate, and in other cases to the Controlling Court or Board, the proceedings under the Commission, accompanied by translations of papers not in the English language, together with a summary of the pleadings and evidence, and his or their opinion of the merits of the case.

XXI. And it is hereby provided, that it shall be lawful for the said Governor in Council, or the Controlling Court or Board, upon consideration of the report of any such Commission as aforesaid, to direct the Commissioner or Commissioners to take further evidence, or to give further explanation of his or their opinion or opinions connected with the case

investigated, and the Commissioner or Commissioners are authorized and required to take such further evidence, and to give such further explanation.

XXII. And it is hereby enacted, that the Suddur and Foujdaree Adawlut, or the Board to which any report of a Commissioner or Commissioners may be submitted as aforesaid after due consideration of the same, and after obtaining such further evidence or explanations as they may require, shall submit the whole of the proceedings and documents received by them to the Government, together with their opinion whether any and what charges have been established against the accused.

XXIII. And it is hereby provided, that whenever a Special Commission may be appointed under the Provisions of this Act, the said Governor in Council will determine, on a view of the nature and circumstances of the case, whether the accused Officer shall be suspended from the discharge of the functions of his office; and if so, whether he shall be permitted to draw the established allowances of his office, or

XXIV. And it is hereby provided, that the Governor in Council on consideration of the report and nor in Council on consideration of the report and proceedings submitted to him in pursuance of Sections XX. and XXII. of this Act, will pass such decision on the case as may appear to him most consonant to the principles of justice and consistent with the powers possessed by Government in matters of this description; and in the event of his deeming it necessary that the party acquired should be because sary that the party accused should be brought to trial by a public prosecution before a competent. Court of Law, will issue the necessary instructions for that purpose to the Law Officers of Government. But whatever proceedings may be held, or whatever decision or order may be passed by Government, individuals deeming themselves aggrieved by any public Officer, will be at all times at liberty to seek redress according to the ordinary forms prescribed by

were, however, failed by the steadiness of the troops, and the good dispositions of Brigadier Monteath, C. B., and the Officers commanding our advanced and rear guards, especially Lieutenant Colonel Richmond, 33d regiment native infantry, and Major Skinner, Her Majesty's 31st. It is gratifying to me to have to state, that a predatory enemy was unable to capture from us the least article of our baggage or stores, and that the only loss sustained of this kind, which could be deemed of importance, arose from the total exhaustion of a portion of our carriage animals, when our march was necessarily doubled, to enable us to rejoin the Head Quarters at Tezeen. I beg to enclose a return of casualties on the 9th, 10th and 11th instant.

I have the honor, for the information of Major General McCaskill, K. H., to transmit to you reports from Lieutenant Colonel Bolton, Her Majesty's 31st regiment; Lieutenant Cononel Richmond, 33rd native infantry, and Major Skinner, Her Majesty's 31st regiment, detailing the occurrences on the rear guards, from Soorkhab to this place.

In regard to those circumstances that came under my own observation and arrangement, I beg to say, that immediately on leaving Soorkhab, the enemy began to show themselves on the heights and to fire on the troops, and as we approached the Jugdulluck pass, observing that their numbers were becoming formidable, and that they were gradually closing in upon our left, it occurred to me that their object was to allow the main column to get through the pass, and then to attack the baggage when it should be collected at the gorge.

This opinion (and I found it fully confirmed afterwards) induced me to send and direct Lieutenaut Colonel Richards mond. Commanding the advance, to halt on arriving at the entrance of the pass, and there wait my further instruc-

Having halted the main column, I allowed the ammunition and the whole of the baggage to pass on, and when every thing was up, I then directed Lieutenant Colonel Richmond to proceed with the advance down the pass and to occupy the heights on each side, which was very properly done by that officer.

On this operation being completed, I then passed every thing down, and on the rear guard joining me, I moved off with the main column through the pass to the great disappointment of the enemy, no doubt, (as they did not get a single thing) and arrived in camp at half past 8 P. M., a sharp fire having been kept up on the column through

On the march from Jugdulluck to Kuttur Sung, from the circumstance of the enemy being in force all round the camp, I directed the advance guard to move off and allowed the baggage to proceed in its rear, and when about two-thirds of it had left the ground, I followed with the main column, leaving the remainder to the care of the rear

On this occasion no loss was sustained, except what is detailed in Lieutenant Colonel Richmond's report; the main column arrived in camp at 20 minutes after 4 P. M.

On the march from Kuttur Sung to this place, I despatched the whole of the baggage immediately after the advance guard, then moved in rear of it with the main column, leaving the godown bullocks to be looked after by the rear guard.

During the march very little molestation was experienced from the enemy; but I am sorry to say, that in consequence of the two marches having been performed in one, an elephant, the camp equipage of Major Delafosse's troop of artillery, many camels, bullocks, and some private property were lost, owing to the cattle, from their previous exhausted state, not being equal to the work.

The waggons of Captain Alexander's troop required to be pulled nearly the whole way by the men of Her Majesty's 31st regiment, and one waggon was dragged altogether (the horses having been taken out) by the sepoys of the 33d and 60th regiments; the main column arrived in camp at 20 minutes past 7 r. M. It may not be unnecessary for me to report that the sepoys when called upon to perform the labor of dragging the waggon, came forward with a cheerfulness, and did the work with a spirit that was remarkable and deserving of the highest praise.

The march from Gundamuck to Soorkhab was conducted in the ordinary manner, and nothing deserving of mea-

SIR,

I have the honor to report, for the information of Brigadier Monteath, C. B., that when the ground we occupied at Kuttur Sung was quite clear of baggage, I withdrew the picquets from the heights above it and advanced them to those nearest the ascent to the road above until the guns and waggon were passed up, which was accomplished by \{\frac{1}{2}} past lla.m. I then withdrew my posts by the heights on my flanks and continued towards Seh Baba, where I arrived without any molestation about 3 r. m. the necessity of dragging the guns up the many hills on the road rendering our progress slow. From Seh Baba to Tezeen, the rear guard was very much delayed by the many animals who fell exhausted from the heaviness of the march. I am afraid there was much loss of grain and baggage cattle. I destroyed, I hope every thing that had been left in the rear, and that the enemy gained nothing by the failure of our cattle.

On ascending the hill at the entrance to the Tezeen valley, a party of the enemy, from the base of the hills on our left, fired into us, but without effect; two shrapnell shells thrown among them with great precision silenced their fire, and they fled to the heights out of shot, leaving, I think, some killed or wounded below. I pushed on when these people were dispersed, and reached camp at a little before 8, without casualty.

SIR.

I have the honor to report for the information of Brigadier Monteath, C. B., commanding the 4th infantry brigade, that the rear guard this morning, under my command, did not leave Jugdulluck until the whole of the bag-

gage had cleared the ground about 11 o'clock A. M.

As the enemy appeared in great numbers all around, and gradually closing on us, I directed the guns to be placed in a commanding position on our line of route, to cover the picquets, which soon after withdrew, on signals previously arranged, and formed on the low ground in front, in skirmishing order, slowly retiring, and ultimately, forming on both flanks of the guns. The enemy, as I expected, instantly rushed forward from all directions, expect our rear, but were checked by the very effective fire of the guns, ably directed by Captain Lawrence, Political Agent, who volunteered his services, and by Lieut. Abercrombie.

who volunteered his services, and by Lieut. Abercrombie.

As the high ground, we occupied, afforded good cover, I determined to hold it with two companies of infantry, until the guns could be withdrawn, and dragged up the steep hill in our rear, an operation which required the aid of

the remainder of the infantry.

At this time, the enemy kept up a sharp fire, but all I desired was accomplished in good order; and having secured new positions in the rear, I recalled the two companies, left in position, and commenced my march, occupying new posts where necessary, which were withdrawn in succession, until the enemy ceasing to annoy us, and the country becoming a little more open, enabled me to recall all the covering parties and prosecute my march towards camp, where I arrived about 5 o'clock P. M., bringing every thing safely in, excepting one bullock-load of commissariat grain found on the road, which was given to the men of the irregular cavalry, also a few bullocks and two camels left on the road, which were destroyed, being unable to proceed.

The troops, both European and native, were very steady, and exerted themselves cheerfully in dragging the guns. Our casualties, I am glad to say, were few, one Officer (Lieut. Brooke.) two men of Her Majesty's 31st foot,

and two sepoys of the 60th regiment native infantry, were wounded.

I beg to report to you, for the information of Major General Pollock, C. B., that the force of the 2d column under my immediate command, as detailed in the margin, was attacked by the predatory tribes of the mountains, on its march from Tezeen, from which point it was separated from your

Infantry. 4th brig. under Brigr. Monteath, C. B. Her Majesty's 31st regiment. Wing 33d native infantry, re-inforced by wing 60th native infantry. 2d and 16th regiments native infantry.

Head Quarters, up to the date of its arrival at Gundamuck. The most serious opposition which it encountered, was in the defile of Jugdulluck, celebrated for the previous conflicts between the Ghilzies, and our troops last year, and during the late advance on Cabool,

I broke up from my encampment at the foot of this pass, early on the morning of the 18th instant, and mad [arrangements, as I advanced, in proportion, of course, to my numerical strength, for the occupation of the severa strong points which commanded the road Detached parties began to show themselves as my force reached the crest of the position, and after disposing flanking detachments on the domineering heights to the right and left, I awaited the approach of Brigadier Monteath with the main body of the column, before I descended into the lower ground beyond.

The necessity for this caution was soon demonstrated, for as the Brigadier took up his position on the plateau, partially occupied by the ruins of the well known fort, he observed the enemy collecting in force around him. He, therefore, very properly, determined to hold the head of the pass until the whole of the baggage and material had moved down towards the plain below, and the rear guard under Lieutenant Colonel Richmond should have joined him on the eminence. He placed his guns in battery, and their fire and that of the troops, completely held the enemy, who were very numerous, in check, and he reports with much satisfaction, that though the attempts of the Ghilzies were obstinate and persevering, they did not succeed in making themselves masters of a single article of baggage or military stores. A sharp conflict was, however, sustained upon particular points whilst the rear guard was coming up, in the one direction, and our long train of animals descending in the other. The Brigadier finally gave over charge of the position to Lieut.-Colonel Richmond and his rear guard, whom he counselled to retain it one quarter of an hour after his own troops advanced beyond it. The succession of lower eminences on either flank had, in the meantime, been crowned, so far as our limited means permitted, under my personal direction, by parties from the advanced guard from Jugdulluck to the valley of Soorkhab, and the baggage was thus protected from the attacks of the predatory bodies, which were hovering around it, along that whole line of road, Lieutenant Colonel Richmond and the rear guard were vigorously pressed by the Ghilzies, as they finally came down from the plateau, but every where most creditably repelled the enemy, and made their way late in the evendown from the plateau, but every where most cleated by tepered the enemy, and made then way late in the evening to our encampment at Soorkhab. I have to regret that Captain Burnett, 54th native infantry, who had been recently released from a captivety commenced at Ghuznee, was severely wounded on the heights, having volunteered his services with a party of the 16th native infantry. Brevet Captain Pender, Her Majesty's 31st foot, had received a bad hurt in a previous skirmish near Seh Baba. Throughout these affairs, the conduct of the troops employed, including the 2d and 16th native Infantry, temporarily attached to me, has deserved my highest approbation, and I feel it to be my duty to record, that on the advance to Cabool, and in retiring from it, the ment, and a wing of the 33d native infantry, (the remaining wing and the 6th Native Infantry, having been detained to garrison Jallalabad and Gundamuck) as well as their endurance of privations and fatigue, have been beyond all praise. No troops could in every respect have behaved better, and I feel myself to be deeply indebted to Brigadier Monteath, C. B, and to Lieutenant Colonel Bolton, Her Majesty's 31st, and Lieutenant Colonel Richmond, 33d native Infantry, for the able and gallant manner in which they have been led.

was performed in a most admirable manner by the men of Her Majesty's 31st regiment, I did not enter the Huft Kotul pass with the force under my command, until late yesterday evening.

For about one half of the way through, the troops met with no molesta-tion, but as the pass narrowed and became more difficult for the passage of the guns, the enemy took advantage of the stoppages occasioned by them, and from their positions, which the darkness rendered it impossible to perceive, except by the flashing of their fire arms, opened a sharp fire on the troops which was checked, in a considerable degree, on the right flank of the column by two companies of the 2d regiment and a party of Her Majesty's 31st regiment, detached by me for the purpose.

As this latter party, from the immediate necessity that existed for their services, was taken by me from the fatigued detail at the guns (with which I happened to be at the time) I sent it out under Brigade Major Lugard, who, in returning from the duty on which he was employed, had his horse severely wounded

The enemy having in the end come down sword in hand upon the rear and left flank of the column, I ordered Lieutenant Colonel Richmond, with the wing of the 33d regiment, and the picquets of the old ground that had joined on the march to keep them in check, which was satisfactorily done, until we had cleared the pass.

Enclosed I beg to send a 'return of killed and wounded.

Camp Gundamuck, 19th October, 1842.

SIR,

I have the honor of reporting, for the information of Major General McCaskill, k. n., that on arriving yesterday morning with the main column of the division in the Jugdulluck pass, I observed that the enemy were collecting in force on the heights; therefore, conceiving that an attack would be made upon the baggage, as well as upon the rear guard, I determined upon taking up a position, with the whole of my force, at the head of the pass, until all the baggage and material had gone through, and I had been joined by the rear guard under Lieutemant Colonel Richmond.

In pursuance of this determination, I placed the troops and two 9-pounders in position on the plateau at the head of the pass, from whence the heights on both sides are commanded for a considerable distance.

The fire of these and of the guns, completely held the enemy, who were very numerous, in check, and I had the satisfaction of seeing the whole of the baggage out of the pass without a single thing having been obtained by them; and on the arrival of Lieutenant Colonel Richmond with the rear guard, I resigned the position to him and marched on to protect the baggage, which had then become placed between the advance and the main column.

Lieutenant Colonel Richmond, who had been directed by me to remain in position for a quarter of an hour after my departure with the rear guard, consisting of six hundred and nineteen rank and file and two guns, reports that on his withdrawal, the enemy, to the extent of about six hundred men, came forward in a very determined manner and followed him up for a considerable distance, although frequently driven back by the fire of the troops and guns.

Enclosed I beg to transmit a return of killed and wounded, and ammunition expended in the main column and rear guard during the day.

Camp Gundamuck, 20th October, 1842,

As from what I have learnt, I have reason to think, that the reports of the former march from Soorkhab to Tezeen when the casualties in the force amounted to sixty-two, have not been forwarded to Government; and as I consider when the casualties in the force amounted to sixty-two, have not been forwarded to Government; and as I consider it very desirable it should be on record that the toils, dangers, and deserts of my brigade have not been in any degree less than those of the other portions of the army, I have to request, that Major General McCaskill will be good enough to express to Major General Pollock, my wish, that my three reports may be forwarded for the information of the Governor General.
