# Resident in the Persian Gulph.

The Notification of the 8th July 1831, alluded to in the above Advertisement is republished for general information.

GOVERNMENT ADVERTISEMENT.

The Right Hon'ble the Governor in Council is pleased to publish for general information the tollowing rules, instituted for the guidance of British Vessels visiting the Persian Gulf, and to announce, that if the Commander of any such Vessel shall fail to conform to these rules, he will forfeit all claims to the interference or good offices of the British Political Officers in the Persian Gult in his behalf.

Rules for the guidance of Vessels carrying a British Pass and Flag to the Persian Gulf.

On the arrival of a British Vessel in Bushire roads, an immediate report is to be made to the Resident in writing of the same, together with the date of sailing from her original port, and any other she may have touched at on her voyage. All Packets and Letters addressed to the Residency are to be forwarded along with the above report.

Three days previous to the date fixed 2nd. for the departure of any British Vessel from Bushire, a report in writing of the same is to be made to the Resident. In the event of its not being the intention of the Commander to remain three days, this report is to be made on the day of arrival.

rd. Previously to any Bristish Vessels leaving Bushire, a copy of the manifest of the cargo imported, and one of the cargo exported is to be furnished to the Resident.

In the event of a dispute arising be-416 tween the Commander of any British Vessel and any of the Native merchants of Bushire. and both parties consenting to reler the matter to the Resident, the decision of that officer as to the most advisable method of arranging the disagreement is to be obligatory upon the Commander making the reference.

5th. In the event of any complaints being made against the Commander or any of the Crew of a British Vessel, by any of the inhabitants of Bushire, the Commander is to be guided by the opinion of the Resident as to the measures to be adopted in consequence.

6th. In the event of any British Vessel purposing to touch at any of the Ports on the Arabian Coast between Burka and the month of the River Euphrates, an intimation of the same in writing is to be previously made to the Resident, and the Commander of the Vessel is to be guided entirely by the Resident's opinion.

All British Vessels entering the inner 7th. roads of Bushire to pay the established pilotage according to the rates sanctioned by the Government.

8th. The Commander of the British Vessel to be guided by the Customs of the Port in respect to the receipt and delivery of cargo.

The conveyance of the public packets 9th. from the Residency and giving a receipt for the same to be obligatory upon the Commanders of all British Vessels visiting Bushire.

THE 15TH FEBRUARY, 1845. The following Act, passed by the Governor General of India in Council on the 15th of February 1845, is hereby promulgated for general information.

# Аст No. 111. ог 1845.

An Act vesting Courts of Appeal with the discretion to require or dispense with Security for Costs from the Appellant.

Whereas it is not now by Law necessary within the Territories subject to the Presidency of Fort William in Bengal, to take any Security for Costs n Appeals before the Sudder Courts-and whereas no Security for Costs is now required by Law in Appeals from the decisions of Moonsiffs, and whereas it is expedient that Appeals from all Courts should be put in this respect upon a uniform footing:

It is therefore hereby enacted, that within the said Territories it shall not be necessary in any Court of Appeal of the East India Company to take any Security for Costs, but it shall be in the discretion of every such Court of Appeal to demand Secu-rity for Costs from the Appellant or not, as it shall see fit, before the Respondent is called upon to answer,-any Law or Regulation to the contrary notwithstanding.

THE IST MARCH, 1845. The following Act, passed by the Governor General of India in Council on the 1st of March

1845, is hereby promulgated for general information.

ACT No. 1V. OF 1845.

An Act to amend the Law regarding the Registration of Dreds.

I. It is hereby enacted, that from and after the passing of this Act, Deeds may be registered in any Registry Office within the Presidency of Fort William in Bengal, whether such office be in the District where the property or any part thereof to which such Deeds relate, is situated, or not.

II. Provided always, and it is hereby enacted, that when the Registry Office in which a Deed is registered, is in a District in which the whole of the property to which such Deed relates is not situated, it shall be the duty of the Register of the said Office to forward to the office of the District or Districts in which the whole or any part of such property is situated, a copy of the Deed as registered and endorsed in his office, the said copies to be furnished and attested as prescribed in Clause First, Section 2, Regulation XX. 1812, and the Register of any office receiving such copy so forwarded, shall duly register the same as if it had been presented to him in the first instance by the

party registering. III. And it is hereby enacted, that for every such copy required for transmission to any office as aforesaid the party registering shall pay the usual fee, and the Register receiving the same shall duly account for the same to the several Registers, to 7

whose offices copies may be transmitted for registry. IV. And it is hereby enacted, that a Memorial of any Deed shall be held to be duly registered according to Law, in respect to any property which may be situated in any one District, as soon as the original Deed or a copy thereof (as the

-case may be) shall have been registered in manner aforesaid in the Registry Office of such District, whether or not a copy thereof have been registered in all or any of the other Districts in which the property to which the Deed relates may be situated.
