THE 12TH FEBRUARY 1845.

BY THE JUDICIAL COMMITTEE OF THE PRIVY COUNCIL

Whereas by an Act passed in the 8th year of Her Majesty's Reign, intituled "an Act for " amending an Act passed in the fourth year of the Reign of His late Majesty, entitled " an Act for the better administration of "Justice in His Majesty's Privy Council; and to extend its jurisdiction and powers," it was enacted, "that it should be lawful for the Judicial Committee of the Privy Council; and the Judicial Committee of the Privy Council; and the Judicial Committee of the Privy Council; and the privy Council and the Privy " cil to make any general rule or regulation to be binding upon all Courts in the Colonies and other foreign settlements of the Crown, " requiring the Judge's notes of the evidence " taken before such Court on any cause appealed, and of the reasons given by the Judges of such Court, or by any of them, for or against the judgment pronounced by such Court, which notes of evidence and reasons should by such Court be transmitted to the "Clerk of the Privy Council within one cal-endar month next after the leave given by " such Court to prosecute any appeal to Her " Majesty in Council, and such order of the " said Committee should be binding upon all "Judges of such Courts in the Colonies or "foreign settlements of the Crown." Now therefore the Lords of the said Judicial Committee of the Privy Council are pleased to order as it is hereby ordered, that the reasons given by the Judges of any Courts of Justice. In the Colonies or other foreign settlements of the Crown the Crown, or by any of such judges for or against any judgement pronounced by such Court from which an Appeal shall lie to Her Majesty in Council, shall be by the Judge or Judges of such Court communicated in writing to the Registrar of such Court, or other officer whose duty it is to prepare and certify the transcript record of the preceedings in the cause, and that the same be by him transmitted in original to the Clerk of Her Majesty's Privy Council, together with documents and proceedings proper to be laid before Her Majesty in Council upon the hearing of the appeal.
Whereof the Judges of all such Courts in

the Colonies or foreign settlements of the Crown are to take notice and govern themselves accordingly.

It is a bright revolving light, 37 feet above

the level of the Sea, and may be seen in clear weather at a distance of 10 miles from a ship's deck. It will be lighted at Sun-set all the year round, and extinguished half-an-hour after day light

# REMARKS FOR SHIPS BOUND INTO

### SIMON'S BAY.

The Light Vessel is moored on the North side of the Roman Rocks, and distant therefrom one cable's length. It is a bright revolving light, 37 feet above the level of the Sea, and may be seen in clear weather at a distance of 10 miles from a ship's deck.

From this light the Compass bearings are, Whittle S. S. E. distance 7 miles, on

which there is only 12 feet water.

Miller's Point, S. \(\frac{2}{4}\) W. distance 4 miles.

Seal Island, E. \(\frac{1}{2}\) S. distance 6\(\frac{2}{4}\) miles.

Dock Yard Jetty, W. \(\frac{1}{4}\) N. distance 1\(\frac{1}{4}\)

miles

Ships steering or beating into False Bay from round the Cape of Good Hope, will open the Light clear of Miller's Point, (which is the point 7 miles and \$\frac{1}{2}\$ from Cape Point, off which, but close to, are some rocks above water,) when it bears N. \$\frac{1}{2}\$ E.; and if intending to beat up inside the Whittle, the light should not be brought to the Westward of N. by W. \$\frac{1}{2}\$ W., or to the Eastward of North, until you are certain of being within 5 miles of the light, when you must be Northward of the Whittle, and may bring the light, in standing to the Northward, to bear N. W. by W., working up towards her by short tacks, and passing to the North, leaving her on your Larboard hand, distant \$\frac{1}{2}\$ of a mile.

If outside the Whittle do not bring the light to the North of N. N. W. 1 W. or to the Westward of N. W. by W. 1 W., on ac-

count of Seal Island, and the rocks which lay off 13 miles to the Southward, turn up by short tacks until you are certain of being within 5 miles of the light, which will insure your being Northward of the Whittle, and may bring the light in standing to the Westward to bear North. With a leading wind bring the light to bear N. by W., you will be well inside the Whittle, and may run up keeping it on that bearing until within a of a mile of the light, when you must open it on your Larboard side, and round it not less than 1/2 a mile distant; when the light bears S. S. W. steer in West for the anchorage, and come to in 14, 12 or 10 fathoms according to the weather. If a fine night, you may choose a berth among the shipping; if otherwise, anchor in an outside berth for the night.

Ships rounding Hanglip must bear in mind, that the Whittle lies nearly in a direct line between that Cape and the Light Vessel, from which it bears, S. S. E.; therefore, if coming up with a fair wind outside the Whittle, bring it to bear N. N. W. 1 W., or N. W. and by

N., and run for it.

These remarks are principally intended for seamen not acquainted with Simon's Bay; of course, those who know the passage between Roman Rocks and Noah's Ark need not pass to the North of the former, but I would call their attention to the Phoenix Rock, and re-

commend their running for the anchorage at all times by a bearing of the light.

As I am aware of the great difficulty in judging of distances at night, and this Light Vessel being moored on the North side of the rocks to protect her from the S. E. gales,-I do recommend it as a fixed rule, that all Ships should at night pass to the Eastward, and haul round the North side of the Light

Vessel.

If you pass to the Southward bear in mind the passage between Noah's Ark and the Roman Rocks is barely ? of a mile; and as the light is to the Northward of these rocks two cables' length, do not come within full a mile of the light; but I do not recommend this passage to strangers.

The following Act, passed by the Governor General of India in Council, on the 19th April 1845, is hereby promulgated for general information:

#### ACT No. VIII. OF 1845.

An Act for amending Section 75 and Chap. XVII, of Regulation IV. of 1827 of the Bombay Code.

Whereas it has been deemed expedient to amend Section 75 and Chapter XVII. of Regulation IV. of 1827 of the Bombay Code, under which Security for the payment of costs or the performance of the orders of a Civil Court is demanded from public Officers in cases of Appeal which are carried on under the Authority and at the expense of Government:

It is heredy enacted, in modification of the Law above mentioned, that from the date of promulgation of this Act, no Security shall be demanded for the payment of costs or the performance of the orders of a Civil Court from any public Officer in cases of Appeal which are carried on under the Authority and at the groups of Government in the Rombiy and at the expense of Government in the Bombay Presidency.

The following Draft of a proposed Act was read in Council for the first time on the 19th April 1845:

Act No. — or 1845.

An Act to provide for the appointment of Nazirs in the Moonsiff's Courts.

I. It is hereby enacted, that so much of Clause 4, Section 5, Regulation VII. of 1832 of the Bengal Code, as enacts that certain duties assigned to the Nazir of the Judge's Court shall in the Moonsiff's Courts be performed by the Moonsiffs themselves, and that the Tullubanah levied in the Moonsiff's Court shall only be three-fourths of what is levied in the Judge's Court, is repealed.

II. And it is hereby enacted, that within the Territories subject to the Presidency of Fort William in Bengal, the Moonsiff's shall from and after the passing of this Act retain on their Establishments Nazirs to whom the provisions of Clause 8, Section 14, Regulation XXVI. of 1814 of the said Code shall be applicable.

An Act for regulating the Sentences to be passed for offiences not of an ignominious or atrocious

character

I. It is hereby enacted, that Sections III. and IV. Regulation II. of 1834 of the Bengal Code be

repealed.

II. And it is hereby enacted, that within the Territories subject to the Presidency of Fort William in Bengal, in all cases of conviction for any offence not of an ignominious or atrocious character or in which a sentence of imprisonment for five years or more shall not be passed, it shall be lawful for the Courts of the East India Company to sentence the offender, according to the extent of their power, to imprisonment with or without labour, or to fine, or to both; and in default of payment of such fine, to imprisonment with or without labour in lieu of such fine.

III. And it is hereby enacted, that the offences which for the purposes of this Act shall be taken to which for the purposes of this Act shall be taken to be not of an ignominious or atrocious character are all offences other than Murder, Dacoity, Highway Robbery, Burglary, Theft, Receiving stolen or plundered property, Forgery, Perjury, Arson, Rape, and attempts to commit any of those offences.

IV. Provided, that the imprisonment to be awarded under the second Section of this Act shall be without irons, except in the case of imprisonment awarded to a person who being a convict has escaped from a gaol, or other place of confinement, or

caped from a gaol, or other place of confinement, or from the custody of guards.

Ordered, that the Draft now read be published for general information.
