Grant Medical College.

The following regulations of the Grant Medical College which have been sanctioned by the Hon'ble the Governor in Council are pub-

lished for general information :-

As some months must yet elapse before the College buildings can be completed or the course of instruction entered upon, the Board of Education take this opportunity of calling the particular attention of those desirous of presenting themselves as candidates for admission, to the qualifications required of them as laid down in the 4th & 5th Regulations which will be strictly enforced.

REGULATIONS OF THE GRANT MEDICAL COLLEGE.

1. The Grant Medical College shall be under the Control of the Board of Education,

2. The course of medical instruction in the College will be carried on through the medium of the English language, in strict accordance with the system followed in Europe, and will, in the first instance, be conducted by three Professors one of whom shall be Superintendent of the College.

The details of management of the College, the charge of the Pupils, the Plan of Education, and other arrangements will be entrusted to the judgement and guidance of the Superintendent, subject to the control of the

Board of Education.

4. Admittance to the benefits of the College will be accorded, without exception of caste or creed to candidates between the ages of 16 and 20, who are of respectable connexions and general intelligence, who in addition to a grammatical knowledge of their vernacular language and of Arithmetic, as far as the rules of proportion, possess a through knowledge of English so as to be able to read and write it with accuracy, fluency and facility. Each candidate will be required to present a and facility. certificate of good conduct from the head master of the school in which he has studied, and also one expressly stating that he is possessed of the necessary information and capable of undergoing the examination proposed,

5. Candidates for admission will be examined at a stated annual period (to be afterwards fixed) by the Board of Education or parties deputed by them, the Superintendent and Professors of the College; and the books selected for testing the candidates knowledge of English will be "Milton's Paradise lost" Robertson's Histories, or works of a similar classical standard. The names of candidates found qualified will be entered in the College

register.

The Students will consist of two classes 1st Stipendiary Students, 2nd Free Students.

The Number of Stipendiary students will be limited to 20, and will consist of those Native candidates who have been considered the best qualified.

8. The Stipendiary students will each receive a monthly allowance from Government of (7) seven Rupees, to be increased accord-

ing to the following rules,
9. The Stipendiary students will be divided into three classes and each class will re-

ceive a different stipend, viz:-

1st Class Rs (7) seven per month. 2nd ,, ,, (9) nine ditto,

3rd ,, ,, (12) twelve ditto.

The formation of these classes will take place once a year, at the period fixed for the annual admission and registration of candidates, and will be conducted by the Board of Education, the Superintendent and Professors of the College, it being distinctly understood, that the classification will depend upon the acquirements and general conduct of the students, and not altogether upon the length of the period of their studies, Thus no pupil shall, during the first year of his studies, receive a higher stipend than (7) seven Rupees, and every student who at the end of two years is not considered qualified to be placed in the 2nd Class shall be removed to the list of free students, and an eligible free student be recommended by the Superintendent to fill the vacancy thus created in the stipendiary list, students shall not be eligible to the 3rd Class till they shall have been three years at the College, and those who at the end of four years are not considered qualified to rise to the 3rd Class shall be removed to the list of free students, and an eligible free student or one from the 1st Stipendiary Class be recommended by the Superintendent to fill the vacancy.

10. Stipendiary students will be required to prosecute their studies at the College for a period of not less than four years before they will be entitled to present themselves for examination for certificates of qualification to practice Medicine and Surgery and those who are unable to pass this final examination in six years will cease to receive their stipends.

Stipendiary students voluntarily leaving the College before presenting themselves for final examination will be required to refund the total amount received by them from the date of their registration up to the period of their

resignation.

12. Stipendiary students will be required to study the principles and practice of medicine and surgery, and the Collateral sciences in strict accordance with the mode adopted in the Medical Schools in Europe

13. The free students equally with those of the stipendiary class shall enjoy all the adadvantages of medical instruction which the

college will afford.

14. The Board of Education will exercise the right of dismissal of students from the college on just ground being shewn by the

Superintendent.

15. All students (stipendiary and free) who shall have been duly enrolled in the college Register and shall have completed their studies according to the rules and course prescribed to the stipendiary class, will be entitled and they only, to have certificates signed by the Superintendent to enable them to present themselves for final examination.

16. The final examination for certificates to practise medicine and surgery will be publickly held at a stated period annually under the instructions of the Board of education, by three or more medical officers unconnected with the College and specially, in each instance, nominated by Government for the purpose.

17. Successful candidates will receive certificates of qualification to practise medicine and surgery signed by the President of the Board of Education, the Superintendent and professors of the college and the professional

examiners.

18. In the event however of its coming, at a subsequent period, to the knowledge of the Board of Education, and being proved to their satisfaction, that any individual possessed of the certificate of qualification to practise medicine and surgery, has exhibited marked proofs of professional ignorance or been guilty of flagrant moral delinquency, it will be competent to the Board of Education to recommend to Government, to direct that the name of such individual be erased from the list of qualified licentiates of the college, and a notification of his degradation will be published in the Government Gazette.

19. The Superintendent shall make an annual report of the state of the college to the Board of Education for transmission to Government, and shall forward a copy to the

Medical Board.

GENERAL DEPARTMENT.

The Honorable the Governor in Council is pleased to publish the following Resolution by the Right Honorable the Governor General, and to declare that the Provisions contained in it in regard to the selection of candidates for public employment, and to the preference to be given to those who have been educated either in the Government Schools, or in those established by private Individuals or Societies, and "especially to those who have distin-"guished themselves in such schools by a "more than ordinary degree of merit and " attainment" shall be applicable to this Presidency.

RESOLUTION.

The Governor General, having taken into his consideration the existing state of educacation in Bengal, and being of opinion, that it is highly desirable to afford it every reasonable encouragement by holding out to those who have taken advantage of the opportunity of instruction afforded to them, a fair prospect of employment in the public service, and thereby not only to reward individual merit, but to enable the state to profit as largely and as early as possible by the result of the measures adopted of late years for the instruction of the people, as well by the Government as by private individuals and Societies, has resolved, that in every possible case a preference shall be given in the selection of candidates for public employment to those who have been educated in the Institutions thus established, and especially to those who have distinguished themselves therein by a more than ordinary

degree of merit and attainment, The Governor General is accordingly pleased to direct, that it be an instruction to the Council of Education, and to the several Local Committees and other authorities charged with the duty of Superintending Public Instruction throughout the provinces subject to the Government of Bengal, to submit to that Government at an early date, and subsequently on the 1st January in each year, returns (prepared according to the form appended to this Resolution) of students who may be fitted, according to their several degrees of merit and capacity, for such of the various public offices as, with reference to their age, abilities and other circumstances, they may be deemed qualified to

The Governor General is further pleased to direct, that the Council of Education be requested to receive from the Governors or

Managers of all Scholastic Establishments, other than those supported out of the public funds, similar returns of meritorious students, and to incorporate them, after due and sufficient enquiry, with those of the Government institutions, and also that the managers of such establishments be publicly invited to furnish returns of that description, periodically, to the Council of Education.

The returns, when received, will be printed and circulated to the heads of all Government Offices, both in and out of Calcutta, with instructions to omit no opportunity of providing for and advancing the candidates thus presented to their notice, and in filling up every situation, of whatever grade in their gift, to show them an invariable preference over others not possess-

ed of superior qualifications.

The appointment of such candidates to situations under the Government, will be immediately communicated by the appointing officer to the Council of Education, and will by them be brought to the notice of Government and the public, in their annual reports. It will be the duty of controlling officers, with whom rests the confirmation of appointments made by their subbordinates, to see that a sufficient explanation is afforded in every case in which the selection may not have fallen upon an educated candidate whose name is borne on the printed returns.

With a view still further to promote and encourage the diffusion of knowledge among the humbler classes of the people, the Governor General is also pleased to direct, that even in the selection of persons to fill the lowest offices under the Government, respect be had to the relative acquirements of the candidates, and that in every instance a man who can read and write be preferred to one who cannot.

Ordered, that the necessary instructions be issued for giving effect to the above resolution, and that it be published in the Official Gazettes

for general information.

And it is hereby enacted, that from and after the passing of this Act, any person may be appointed to be a Hindoo or Mahomedan Law Officer in any of the Courts of Justice under the Presidency of Fort William in Bengal, who shall have successfully passed through such an examination as the Government of the said Presidency shall from time to time prescribe.

II. And it is hereby enacted, that from and after the passing of this Act the said Pice shall be a legal tender throughout the Territories of the East India Company for the Company's Rupee, and the said Double Pice for the Company's Rupee, and the said Pie for 147 of the Company's Rupee.

III. And it is hereby enacted, that all Copper Coins of the weights specified in Section I of this Act, which may have been issued since the passing of Act XXI, of 1835, from any Mint within the Presidency of Bombay, shall be legal tender residently for the ways excelled is Section II. of pectively for the values specified in Section II. of

this Act within that Presidency,
VI. Provided always, that none of the said
Copper Coins shall be legal tender except for fractions of a Rupee.

The following Draft of a proposed Act was read in Council for the first time on the 4th of January 1845.

ACT No. - OF 1845. An Act to amend the Law regarding the issue of

Commissions of the Peace.

Whereas it is inconvenient to issue a new General Commission of the Peace whenever the Executive Government of any of the Presidencies of Fort William in Bengal, Madras or Bombay shall nominate and appoint any persons not named in

the General Commisson last issued to act as Justices of the Peace—It is hereby enacted, that the Supreme Court of Judicature of each of the said Presidencies shall and may from time to time upon the order or warrant of the Executive Government of such Presidency, issue separate Commissions to any persons not named in the General Commission of the Peace last issued, who by law are capable of being appointed to the office of Justice of the Peace, and who shall be nominated and appointed by such Executive Government to act as Justices of the Peace within and for such Presidency and the places subordinate therto, or within and for the Presidency Town, And all such Commissions share be issued in the name of the Queen's Majesty, her Heirs and Successors, under the Seal of the Supreme Court, and tested in the name of the Chief Jurtice of such Court and shall be filed of record in the Court of Oyer and Terminer of the Presidency or place wherein and for which the same shall be issued, as supplementary to the General Commission of the Peace late issued which shall remain in full force.

Ordered, that the Draft now read be published

for general information.

Ordered, that the said Draft be re-considered at the first meeting of the Legislative Council of India after the 4th day of April next.
