FORT WILLIAM. HOME DEPARTMEN, LEGISLATIVE,

THE 30TH AUGUST 1845. The following Act, passed by the Governor General of India in Council on the 30th August 1845, is hereby promulgated for general information:

ACT No. XIX. OF 1845. An Act for incorporating the Assam Company.
