

The following Act, passed by the Governor Ge-neral of India in Council on the 13th September 1845, is hereby promulgated for general information :

ACT NO. XXI. OF 1845. An Act respecting the appointment and powers of Agents for the suppression of Meriah Sacrifices in the Hill Tracts of Orissa.

the Hill Tracts of Orissa. 1. It is hereby enacted, that it shall be lawful for the Governor General in Council, by an Order in Council, to remove from the jurisdiction and superintendence of the Commissioner and Super-intendent of Tributary Mehals in Cuttack, any of the Tributary Estates specified in Section 2, Regu-lation II. of 1816 of the Bengal Code, and to place any such Estates under the jurisdiction and superintendence of such Officer (to be called the Accent for the Suppression of Meriah Sacrifices) Agent for the Suppression of Meriah Sacrifices) and his subordinates, as shall from time to time be appointed by the Government of Bengal in that behalf.

II. And it is hereby enacted, that it shall be lawful for the Governor General in Council by an Order in Council to remove from the jurisdiction and superintendence of the Agent to the Gover-nor General, South West Frontier, any portion the tracts of Country, comprized in that Agency, Agent and to place any such portion under the jurisdic-tion and superintendence of such Officer (to be tion and superintendence of such Officer (to be called the Agent for the Suppression of Meriah Sacrifices) and his subordinates, as shall from time to time be appointed by the Governor of Bengal in that behalf.

Bengal in that behalf. 111. And it is hereby enacted, that it shall be lawful for the Governor General in Council by an Order in Council to remove from the jurisdic-tion and superintenderce of the Collectors of Ganjam or Vizagapatam, exercised by them as Agents to the Governor of Fort St. George under Act XXIV. of 1839, any portion of the tracts of Country specified in Section II. of the said last mentioned Act, and to place any such portion under the jurisdiction and superintendence of such Officer (to be called the Agent for the Suppression

of Meriah Sacrifices) and his subordinates, as shall from time to time be appointed by the Government of Fort St. George in that behalf. IV. And it is hereby enacted, that it shall be lawful for the Governor General in Council, by an Order in Council, to remove from the operation of Zillah Rajamundry, and to place any such portion under the jurisdiction and superintendence of such Officer (to be called the Agent for the Suppres-sion of Meriah Sacrifices) and his subordinates, as shall be appointed by the Government of Fort St. George in that behalf. V. And it is hereby enacted, that all such Agents and their subordinates as shall be ap-pointed under this Act, shall in the exercise of their jurisdiction and superintendence, be guided by such instructions as they may from time to time receive from the Government of India through their respective Governments.

VI. And it is hereby enacted, that it shall be competent to the Governor General in Council, through the Governments of the aforesaid Presithrough the Governments of the aforesaid Presi-dencies respectively, to prescribe such Rules as he may deem proper for the guidance of such Agents and subordinates, and to determine to what extent the decision of the said Agents in Civil suits shall be final, and in what Suits an appeal shall lie to the Sudder Court, and to define the authority to be exercised by the said Agents in Griminal trials, and what Griminal cases they shall submit for the decision of the Sudder Court. shall submit for the decision of the Sudder Court.

Whereasit is expedient that the Governor General shall visit the North Western Provinces and other parts of India unaccompanied by any Member of the Council of India, it is enacted that during the absence of the Governor General from the General of Life is it shall be benefit for the Gov during the absence of the Governor General from the Council of India, it shall be lawful for the Go-vernor General alone to exercise all the powers which may be exercised by the Governor General in Council, except such powers as may by a Re-solution of the Governor General in Council be ex-ercised by the President in Council during the absence of the Governor General, and except the power of making Laws and Regulations. II. And it is further enacted, that this Act shall cemmence from the day on which it shall be notifi-ed by an Order published in the Official Gazette, that the Governor General has quitted Calcutta for the purpose of so proceeding as aforesaid.
