Legislative Council.

26th January 1856.

The following Act, passed by the Legislative Council, received the assent of the Most Noble the Governor General on the 21st January 1856, and is hereby promulgated for general information :-

ACT No. I. of 1856.

An Act to prevent the Sale or Exposure of Obscene Books and Pictures.

Whereas the practice of offering for sale or exposing to public view obscene Books and Pictures encourages immorality, and it is expedient to make provision for the prevention of such practice; It is enacted as follows:-

I. Whoever, within the territories in the possession

Penalty for the sale or exposure of obscene books, pictures, &c.

and under the Government of the East India Company, in any shop, bazar, street, thoroughfare, high-road, or

other place of public resort, distributes, sells, or offers, or exposes for sale, or wilfully exhibits to public view, any obscene book, paper, print, drawing, painting, or representation; or sings, recites, or utters any obscene song, ballad, or words to the annoyance of others; shall, upon conviction, as hereinafter provided, before a Magistrate, be liable to a fine not exceeding 100 rupees, or to imprisonment, with or without hard labour, for a period not exceeding three months, or to both.

II. It shall be lawful for any person whatsoever to Apprehension of offenders. abovenamed offences, and forthwith to deliver him to a Police Officer of the place where he shall have been apprehended, to be taken before any Magistrate having jurisdiction in such place; and it shall be the duty of every Police Officer to use his best endeavours to apprehend and to convey before a Magistrate any person that he shall find so offending, together with such obscene books, papers, prints, drawings, paintings, and representations, as may be found with such person.

III. Upon information given or charge preferred, upon oath or solemn affir-mation, a Magistrate, with-Mode of procedure by Magistrate.

in whose jurisdiction the offence may have been committed, may issue a summons for the appearance, or a warrant for the apprehension, of any person accused of any of the offences enumerated in Section I., and such Magistrate shall proceed under the rules of the general law to hear and determine the case. Provided that it shall not be necessary to require the presentation of a complaint in writing, nor to require the attendance of any complainant, any thing contained in Section VI. Regulation IX. of 1807 of the Bengal Code, or in Section XV. of Regulation IX. of 1816 of the Madras Code, or any other law, to the contrary notwithstanding.

Magistrate required to seize and destroy obscene

books, &c.

IV. Every Magistrate is required to destroy, or cause to be destroyed, all such obscene books, papers, prints, drawings, paintings, or representations as may

come within his power or control.

V. After the passing of this Act, it shall not be lawful for any person to import into any part of the Importation of obscene books, pictures, &c. prohi-bited. aforesaid territories any obscene book, print, or picture;

and every such book, print, or picture shall be forfeited and shall be seized by any Officer of Customs, and the same shall be destroyed by such Officer.

VI. All orders or sentences passed under this Act

shall be appealable in the Appeal from orders or sentences passed under this Act. usual manner under the Regulations and Laws that are or may be in force relating to appeals from the orders

of Magistrates or other Officers exercising the powers of a Magistrate.

VII. Nothing contained in this Act shall apply to any representation sculptur-Act not to apply to repre-sentations in temples, &c. ed, engraved, or painted, on or in any temple, or on any

car used for the conveyance of idols.

Conviction to be quashed merits only. Form of on merits only.

VIII. No conviction, order, or judgment of any Justice of the Peace shall be quashed merits only. Form of procedure, but only on the

merits; and it shall not be necessary to state on the face of the conviction, order, or judgment, the evidence on which it proceeds; but the depositions taken, or a copy of them, shall be returned with the conviction, order, or judgment, in obedience to any writ of certiorari; and if no jurisdiction appears on the face of the conviction, order, or judgment, but the depositions taken supply that defect, the conviction, order, or judgment shall be aided by what so appears in such depositions.

IX. The following words in this Act shall have the meanings hereby assigned to Interpretation. them, unless there be something in the subject or context repugnant to such construction (that is to say)-

The word "Magistrate" shall include Joint Magistrates and persons lawfully exercising the powers of a Magistrate, and Justices of the Peace.

Words importing the singular number shall include the plural number, and words importing the plural number shall include the singular number.

Legislative Council.

The following Bill was read a second time in the Legislative Council on the 19th January 1856, and was referred to a Select Committee, who are to report thereon after the 23rd of April next :-

A Bill to remove all legal obstacles to the Marriage of Hindoo Widows.

Whereas it is known that, by the law as administered in the Civil Courts established in the territories in the

possession and under the Government of the East India Company, Hindoo widows, with certain exceptions, are held to be, by reason of their having been once married, incapable of contracting a second valid marriage, and the offspring of such widows by any second marriage are held to be illegitimate, and incapable of inheriting property: and whereas many Hindoos believe that this imputed legal incapacity, although it is in accordance with established custom, is not in accordance with a true interpretation of the precepts of their religion, and desire that the Civil law administered by the Courts of Justice shall no longer prevent those Hindoos who may be so minded from adopting a different custom, in accordance with the dictates of their own consciences: and whereas it is just to relieve all such Hindoos from this legal incapacity of which they complain; and the removal of all legal obstacles to the marriage of Hindoo widows will tend to the promotion of good morals and to the public welfare; It is enacted as follows :-

I. No marriage contracted between Hindoos shall

No marriage between Hindoos to be invalid by reason of the woman having been previously married or be-trothed to another person since deceased.

be invalid, and the issue of no such marriage shall be illegitimate, by reason of the woman having been previously married or betrothed to another person since deceased, any custom and any

interpretation of Hindoo law to the contrary notwithstanding.

II. All rights and interests which any widow may by law have in her deceased Estate of deceased hushusband's estate, either by band to descend to next heirs on re-marriage of widow. way of maintenance or by inheritance, shall, upon her

econd marriage, cease and determine as if she had then died; and the next heirs of such deceased husband then living shall thereupon succeed to such estate. Provided that nothing in this

Section shall affect the rights and interests of any widow in any estate or other property to which she may have succeeded by inheritance otherwise than through her deceased husband, or to which she may have become entitled under the will of her deceased husband, or in any estate or other property which she may possess as stridhun, or which she may have herself acquired, either during the life-time of her deceased husband, or after his death.

The following Bill was read a second time in the Legislative Council on the 19th January 1856, and was referred to a Select Committee, who are to report thereon after the 23rd of April next :-

A Bill to facilitate the Remedies on Bills of Exchange, Hoondies, and Promissory Notes by the Prevention of Frivolous or Fictitious Defences to Actions thereon in Her Majesty's Supreme Courts.

Whereas bond fide holders of dishonored Bills of Exchange, Hoondies, and Promissory Notes, are often Preamble. unjustly delayed, and put to unnecessary expense in recovering the amount thereof by reason of frivolous or fictitious defences to actions thereon, and it is expedient that greater facilities than now exist should be given for the recovery of money due on such Bills, Hoondies, and Notes; It is enacted as follows:—

I. From and after the

day of All actions upon Bills of Exchange, Hoondies, all actions upon Exchange, &c. may be by writ of summons in the form or Promissory Notes commenced in any of Her Ma-jesty's Supreme Courts of contained in Schedule A.

Judicature within six months after the same shall have become due and payable, may be by writ of summons in the special form contained in the Schedule A to this Act annexed, and endorsed as therein mentioned.

II. Such writ of summons shall issue, without

Writ to issue on order of Judge obtained upon produc-tion of Bill of Exchange, &c. and affidavit showing that the amount is due, &c.

plaint filed, on an order to be obtained from a Judge of any of the said Courts upon production of the Bill of Exchange, Hoondie, or Promissory Note; and on

an Affidavit or Affidavits showing that the amount sought to be recovered is due to the plaintiff as the holder of such Bill of Exchange, Hoondie, or Promissory Note from the party sought to be charged thereon, and that such party is subject to the jurisdiction of the Court.

III. The service of such writ shall in all cases be personal, unless a Judge of Time and manner of service of writ.

the Court out of which the same is issued shall, upon special grounds, have directed that a particular mode of substituted service shall be good service thereof; and the time to be named therein shall in no case be less than twelve days including the day of service, and shall be increased in proportion to the distance of the defendant's residence from the Court, according to the usual practice of the Court in like cases.

IV. If the defendant shall not have obtained leave

Plaintiff, upon filing affidavit of due service, may at once sign final judgment as in the form contained in Schedule B.

to appear, and shall not have appeared to such writ according to the exigency thereof, it shall be lawful for a Judge of any of the said Courts, upon being sa-

tisfied by affidavit, and by the production of a copy of the said writ of summons and the endorsements thereon that the same has been duly served, and upon such further proof of such service, and of the truth of the plaintiff's demand (if any) as he may see fit to require, to order that the plaintiff be at liberty to sign judgment in the form contained in Schedule B to this Act annexed, for any sum not exceeding the sum endorsed on the writ, together with subsequent interest calculated to the date of judgment, and a sum for costs to be fixed by the Judges of the said Courts respectively (unless on special grounds the Judge shall see fit to allow the plaintiff more than such fixed sum, in which case the costs shall be taxed in the ordinary way); and the plaintiff may, upon such judgment, issue execution forthwith.

V. A Judge of any of the said Courts shall, upon the application of the de-fendant at any time within Defendant showing a defence upon the merits to have the period fixed by the writ leave to appear. of summons for obtaining

such leave, give leave to appear to such writ and defend the action, on the defendant paying into Court the sum endorsed on the writ; or upon affidavits, satisfactory to the Judge, which disclose a legal or equitable defence, or such facts as would make it incumbent on the holder to prove consideration, or such other facts as the Judge may deem sufficient to support the application, and on such terms as to security, making admissions, or otherwise, as to the Judge may seem fit; and in every such case the order giving leave to appear shall be filed by the defendant at the time of entering his appearance with the proper Officer, and no plea which is inconsistent with such order shall afterwards be received.

VI. After judgment, the Court or a Judge may, under special circumstances, Judge may, under special circumstances, set aside judgment, &c. set aside the judgment, and, if necessary, stay or set aside execution, and may give

The following Bill was read a second time in the Legislative Council on the 26th January 1856, and was referred to a Select Committee who are to report thereon after the 30th of April next :-

A Bill to improve the Law relating to Sales of Land for Arrears of Revenue in the Bengal Presidency. Whereas it is expedient to discontinue the practice

of obtaining the previous sanction of the Board of Preamble. Revenue to sales of estates for arrears of revenue, or other demands of Government, in the Province of Cuttack; and whereas it is just that a person having a lien upon an estate, and paying the money necessary to protect it from sale for arrears of revenue, should be reasonably secured; and whereas it is expedient to afford sharers in estates who duly pay their shares of the Sudder Jumma of their estates, easy means of protecting their shares from sale by reason of the default of their co-sharers; and whereas it is expedient to afford landholders, particularly absentees, facilities in guarding against the accidental sale of their estates for arrears of revenue by reason of the neglect or fraud of their agents; and whereas it is expedient to enforce the registration of dependent talooks existing at the time of settlement, and to give absolute security to such talooks when so registered; and whereas it is expedient to protect the holders of under-tenures created in good faith, not resumable by the grantors or their representatives and held at rents fully sufficient for the security of the public revenue, from loss by the avoidance of their tenures on the occasion of a sale of the superior estate for arrears of public revenue, for which such holders may not be in any degree responsible; and it is therefore proper for the above and other purposes to improve the law relating to sales of land for arrears of revenue in the Bengal Presidency; It is

gulations and Acts in force, are directed to be realised in the same manner as arrears of revenue, shall be paid up in each permanently settled district under their jurisdiction, and in each of the districts not permanently settled in the Province of Cuttack; in default of which payment the estates in arrear in those districts, except as hereinafter provided, shall be sold at public auction to the highest bidder. And the said Board shall give notice of the dates so fixed in the official Gazette, and shall direct corresponding publication to be made as far as regards each district, in the language of that district, in the office of the Collector, or other officer duly authorized to hold sales under this Act, in the Courts of the Judge, Magistrate, (or Joint Magistrate, as the case may be,) Principal Sudder Ameens, Sudder Ameens, and Moonsiffs, and at every Thaunah station of that district; and the dates so fixed shall not be changed except by the said Board by advertisement and notifications, in the manner above described, to be issued at least three months before the close of the official year preceding that in which the new date is, or dates are, to take effect.

IV. In the Province of Benares and in districts not permanently settled, with the exception of the districts in the Province of Cuttack, no sale shall take place for arrears of land revenue or other demands of Government, without the special sanction of the Board of Revenue previously obtained in each several case of sale. Provided that the said Board, at the time of authorizing such sale, shall fix the latest day on which in each case such arrears or demands shall be received.

V. Provided always, that no estate, and no share Proviso in the case of cer-in descriptions of arrear, shall be sold for the recovery tain descriptions of arrear. of arrears or demands of the descriptions mentioned below, otherwise than after a notification in the language of the district, specifying the nature and amount of the arrear or demand, and the latest date on which payment thereof shall be received, shall have been affixed for a period of not less than fifteen clear days preceding the date fixed for payment, according to Section III. or Section IV. of this Act as the case may be, in the office of the Collector or other officer duly authorized to hold sales under this Act, in the Court of the Judge within whose jurisdiction the land advertised lies, in the Courts of the Principal Sudder Ameens and Sudder Ameens of the district, and in the Moonsiff's Court and Police Thannah of the division in which the estate to which the notification relates, or a part of it, is situated, the same to be certified by the receipt of the officer at whose office such notification may have been affixed; and also at the cutcherry of the malgoozar or owner of the estate, or at some conspicuous place upon the estate, the same to be certified by the peon or other person employed for the purpose.

First,—Arrears due from estates in the Province of Benares.

VI. 'The Collector or other officer duly authorized

Notifications of sale to be issued, and no tender after latest day of payment to stop the sale. to hold sales under this Act shall, as soon as possible after the latest day of payment fixed in the manner prescribed in Section III. or

Section IV. of this Act, issue notifications in the language of the district, to be affixed in his own office and in the Court of the Judge of the district, and to be published in the official Gazette, specifying the estate or estates which will be sold as aforesaid, and the day on which the sale of the same will commence, which day shall not be less than fifteen or more than thirty clear days from the date of affixing the notification in the office of the Collector or other officer as aforesaid. And, except as hereinafter provided, all estates so specified shall, on the day notified for sale, or on the day or days following, be put up to public auction by and in the presence of the Collector or other officer as aforesaid, and shall be sold to the highest bidder. And no payment, or tender of payment, made after sunset of the said latest day of payment, shall bar or interfere with the sale, either at the time of sale or after its conclusion.

VII. Whenever an estate is notified for sale as provided by Section VI. of this Act, the Collector or other officer as aforesaid shall affix a proclamation in the language of the district in his own office, and as soon thereafter as may be in the Moonsiff's Courts and Police Thannahs within which the estate or any part of it is situated, and also at the cutcherry of the malgoozar or the owner of the estate, or at some conspicuous place upon the estate, forbidding the ryots and under-tenants to pay rent to the defaulting proprietor from the date of the day after that fixed for the last day of payment, on pain of not being entitled to credit in their accounts with the purchaser for any sums paid after the date aforesaid.

VIII. No claim to abatement or remission of revenue, unless the same shall have been allowed by the Claims against Government not to invalidate a sale. authority of Government, and no private demand or cause of action whatever, held or supposed to be held by any defaulter against Government, shall bar or render void or voidable a sale under this Act; nor shall the plea that money belonging to the defaulter, and sufficient to pay the balance or part of it, was in the Collector's hands, bar or render void or voidable a sale under this Act, unless such money stand in the defaulter's name alone and without dispute, and unless after application in due time made by the defaulter, or after the written agreement provided for in Section XV. of this Act, the Collector shall have neglected, or refused on insufficient grounds, to transfer it to the credit of the estate.

IX. The Collector or other officer as aforesaid shall, at any time before sunset of the latest day of payment Deposits receivable from persons not proprietors. determined according to Section III. or Section IV. of this Act, receive as a deposit from any person not being a proprietor of the estate in arrear the amount of the arrear of revenue due from it, to be carried to the credit of the said estate at sunset as aforesaid, unless before that time the arrear shall have been paid by a defaulting proprietor of the estate. And in case the person so depositing, whose money shall have been credited to the estate in the manner aforesaid, shall be a party in a suit pending before a Court of Justice for the possession of the same or any part thereof, it shall be competent to the said Court to order the said party to be put into temporary possession of the said estate or part thereof, subject to the rules in force for taking security in the cases of parties in Civil suits. And if the person so depositing, whose money shall have been credited as aforesaid, shall prove before a competent Civil Court that the deposit was made in order to protect an interest of the said person, which would have been endangered or damaged by the sale of the estate, or which he believed in good faith

would have been endangered or damaged by such sale, he shall be entitled to recover the amount of the deposit, with or without interest, as the Court may determine, from the proprietor of the said estate. And if the party so depositing, whose money shall have been credited as aforesaid, shall prove before such a Court that the deposit was necessary in order to protect any lien he had on the estate, the amount so credited shall be added to the amount of the original lien.

X. When a recorded sharer of a joint estate, held in common tenancy, desires to pay his share of the Government revenue separately,

he may submit to the Collector a written application to that effect. The application must contain a specification of the extent and nature of the interest held in the estate by the applicant. The Collector will then cause to be published in his own cutcherry, in that of the Judge, Magistrate, (or Joint Magistrate, as the case may be,) Principal Sudder Ameeus, Sudder Ameens, and Moonsiffs, and in the Police Thannahs in whose jurisdiction the estate or any part thereof is situated, as well as on some conspicuous part of the estate itself, a copy of the application made to him. If within six weeks from the date of the publication of these notices, no objection is made by any other recorded sharer, the Collector will open a separate account with the applicant, and will credit separately to his share all payments made by him on account of it. The date on which the Collector records his sanction to the opening of a separate account, shall be held to be that from which the separate liabilities of the share of the applicant commence.

XI. When a recorded sharer of a joint estate, whose share consists of a specific portion of the land of the estate, desires to pay his share of the Government

revenue separately, he may submit to the Collector a written application to that effect. The application must contain a specification of the land comprised in his share, and of the boundaries and extent thereof, together with a statement of the amount of sudder jumma heretofore paid on account of it. On the receipt of this application, the Collector will cause it to be published in the manner prescribed for publication of notice in the last preceding Section. In the event of no objection being urged by any recorded co-sharer within six weeks from the time of publication, the Collector will open a separate account with the applicant, and will credit separately to his share all payments made by him on account of it. The date on which the Collector records his sanction to the opening of a separate account, shall be held to be that from which the separate liabilities of the share of the applicant commence.

XII. If any recorded proprietor of the estate, whether the same be held in comSummary inquiry by the
Collector. object that the applicant has

no right to the share claimed by him, or that his interest in the estate is less than, or is of a different nature from that claimed by him, the Collector will institute a summary inquiry into the factof possession, and if he be satisfied that the applicant is really in possession of the share as claimed by him, he will open a separate account for his share, as directed in one or other of the last two preceding Sections. If, in the case of a claimant of specific land, the objection be that the jumma alleged by the applicant to be the separate jumma of his specific share of the lands of the estate is not the jumma which has been recognized as such by the other sharers, the Collector will make summary inquiry into the fact, and will reject or admit the application. The orders of the Collector under this Section shall be subject to appeal to the higher revenue authorities in regular course, and shall be subject to reversal or alteration by a regular suit in the Civil Courts, provided that such suit shall have been instituted within one year from the date

If in any case of a sale held according to the Entire estate may be sold provisions of the last preceding Section, the highest under certain conditions. offer for the share exposed to sale shall not equal the amount of arrear due thereupon to the date of sale, the Collector shall stop the sale, and shall declare that the entire estate will be put up to sale for arrears of revenue at a future date, unless the other recorded sharer or sharers, or one or more of them, shall within ten days purchase the share in arrear by paying to Government the whole arrear due from such share. If such purchase be com-pleted, the Collector or other officer as aforesaid shall give such certificate as is provided for in Section XXVII. of this Act, to the purchaser or purchasers, who shall have the same rights as if the share had been purchased by him or them at the sale. If no such purchase be made within ten days as aforesaid, the entire estate shall be sold, after the notification and in the form prescribed in Section VI. of this Act, in the same manner as if the

It shall be competent to the Collector at any time before the sale of an estate shall have commenced to exempt such estate from sale; and in like manner it shall be competent to the Commissioner of Revenue at any time before the sale of an estate shall have commenced, to exempt such estate from sale by a special order to the Collector to that effect in each case; and no sale of an estate shall be legal if held after the receipt of an order of exemption in respect to such estate. Application of purchase money first to the liquidation of purchase money first to the liquidation of all arrears due from the estate or share sold upon the latest day of payment; and secondly, to the liquidation of all outstanding demands debited to the estate or share of an estate in the public accounts of the district, holding the residue, if any, in deposit on account of the late recorded proprietor or proprietors of the estate or share of an estate sold, to be paid to his or their receipt on demand in the manner following: to wit, in shares proportioned to their recorded interest in the estate or share of an estate sold, if such distinction of shares were recorded, or if not, then as an aggregate sum to the whole body of proprietors upon their joint receipt. Provided that, if before payment to the late proprietor or pro-

Proviso. prietors of any surplus that may remain of the purchase money, the same be claimed by any creditor in satisfaction of a debt, such surplus shall not be payable to such claimant, nor shall it be withheld from the proprietor, except under precept of a Civil Court.

XXIX. If a sale made under this Act be annulled by a final decree of a Civil Court, execution of such decree of Court of sales under this Act.

Court, execution of such decree must be obtained before six months after the

date thereof; otherwise the party obtaining the decree shall lose all benefit therefrom. And when execution of such a decree is duly obtained, the party obtaining it shall not be restored to possession, until any amount of surplus purchase money that may have been paid away by order of a Civil Court be repaid by him, with interest at the highest current rate of Government Securities. And if such party shall neglect to pay any amount so recoverable, within six months from the date of such final decree, he shall lose all benefit therefrom.

XXX. Any suit brought to oust the certified purchase.

No suits on the ground of benamee purchase.

Other person not the certified purchase was made on behalf of another person, or on behalf partly of himself and partly of another person, though by agreement the name of the certified purchaser was used, shall be dismissed with costs.

XXXI. The annulment by a Commissioner or by Government of a sale made under this Act shall be publicly notified by the Collector or other officer as aforesaid, in the same manner as the becoming final and con-lusive of sales is required to be notified by Section XXVI. of this Act; and the

amount of deposit and balance of purchase money shall be forthwith returned to the purchaser with interest thereon at the highest rate of the current public securities.

XXXII. The party certified as the proprietor of an estate or share of an estate by purchase under this Act, shall be answerable for all instalments of the revenue of Government which may fall due subsequently to the latest day of payment aforesaid.

XXXIII. No sale for arrears of revenue or other demands, realizable in the Jurisdiction of Civil Courts same manner as arrears of in suits to amend sales. revenue are realizable, made after the passing of this Act, shall be annulled by a Court of Justice, except upon the ground of its having been made contrary to the provisions of this Act : and no such sale shall be annulled upon such ground, unless such ground shall have been declared and specified in an appeal made to the Commissioner under Section XXIV. of this Act: and no suit to annul a sale made under this Act shall be received by any Court of Justice unless it shall be instituted within one year from the date of the sale becoming final and conclusive, as provided in Section XXVI. of this Act: and no person shall be entitled to contest the legality of a sale, after having received any portion of the purchase money. Provided, however, Proviso.

that nothing in this Act contained shall be construed to debar any person considering himself wronged by any act or omission connected with a sale under this Act, from his remedy in a personal action for damages against the person by whose act or omission he considers himself to have been wronged.

XXXIV. In the event of a sale being annulled by a final decree of a Court of Justice, the purchase money to be refunded.

Thirdly,—Tenures of whatsoever description, and farms for terms of years, which have been created since the time of settlement, which have been duly registered under Section XXXVII. of this Act, and whereon no arrear of rent was due on the latest day of payment of revenue as fixed under Sections III. and IV. of this Act.

Fourthly,—Lands whereon dwelling houses, manufactories, or other permanent buildings have been erected, or whereon gardens, plantations, tanks, wells,

canals, places of worship, or burning or burying grounds have been made, or wherein mines have been

And such a purchaser as is aforesaid shall be entitled to proceed in the manner prescribed in Sections IX. and X. of Regulation V. of 1812 for the enhancement of the rent of any land coming within the fourth class of exceptions above made, if he considers the same to have been held at an unfair rent, and if the same shall not have been held at a fixed rent, equal to the rent of good arable land, for a term exceeding twelve years; but not otherwise.

Provided always, that nothing in this Section contained shall be construed to entitle any such purchaser as aforesaid to eject any khoodkasht kudeemee ryot, or any resident hereditary cultivator having a prescriptive right of occupancy at fixed rents, or at rents assessable according to fixed rules under the regulations in force, or to enhance the rent of any such ryot or cultivator otherwise than in the manner prescribed by the laws in force, or otherwise than the former proprietor at the

time of settlement may have been entitled to do. XXXVI. The following rules for the registration of talookdaree tenures, form-Registration of old talooking the first and second classdaree tenures. es excepted in the last pre-

ceding Section, shall be observed :

First,-The holder of the under-tenure shall be at liberty to apply for the registration of his under-tenure, by petition presented to the Collector of the district in whose jurisdiction the parent estate is situated, within three years from the date of the passing of this Act. The application shall contain the following particulars as far as the same are ascertainable:

1. The pergunnah or pergunnahs in which the tenure is situated.

The denomination of the tenure.

2. The denomination of the tenure.

3. The name or names of the village or villages whereof the land is composed, or wherein it is situated. The area of the land comprised in the tenure,

with its bounderies in complete detail.

The amount of rent and cesses payable annually for the tenure, and the duties, if any, required to be performed on account of it.

The date of the deed constituting the tenure, or the date when the tenure was created.

7. The name of the proprietor who created the tenure.
8. The name of the original holder of the under-

tenure.
9. The name of the present possessor, and if he be not the original holder, his relationship to that person, and the mode in which he succeeded to the tenure, whether by inheritance, gift, purchase, or otherwise, and whether he holds jointly or solely.

Secondly,-The Collector on receipt of such application shall serve a notice on the recorded proprietor of the estate in which the tenure is situated, with a copy of the application, and shall also cause a notice with a copy of the application annexed to be published at the places and in the manner prescribed by Section VI. of this Act, requiring the proprietor or any party interest-ed, within thirty days from the date of the issue of the said notice, to file any objection he may have to the registry of the tenure, or to any statement contained in the application. In the absence of any objection, the Collector, if after making due inquiry he is satisfied of the applicant's claim, shall register the tenure. If any objection is made, he shall require both parties, within a reasonable time, to produce their respective proofs, and shall fix a day, by notification in his cutcherry, for the summary investigation of the case. after such summary investigation he shall be of opinion that the applicant has failed to establish his claim, he shall reject the application. If after such investigation he shall be of the contrary opinion, he shall forthwith register the under-tenure in the provisional registry book. Any party dissatisfied with the Collector's award may, within one year from the date of the award, but not afterwards, institute a suit in the Civil Court for the reversal of the same, and after the final decision of the Civil Court, the tenure shall be dealt with according to such decision. If the decision be in favor of the claimant of the tenure, on his producing an authenticated copy of such final decree, the tenure shall be transferred from the provisional registry to the permanent registry book; but if the final decision be otherwise, on the proprietor producing an authenticated copy of the same, the tenure shall be erased from the provisional registry book.

XXXVII. The following rules for the registration of talookdaree tenures and Registration of new tafarms, forming the third class of tenures excepted in lookdaree tenures and farms. Section XXXV. of this Act, shall be observed.

All the rules prescribed in the last preceding Section shall apply to this class of tenures also, with the follow-

ing additional rules.

Immediately upon receipt of the application, the Collector shall cause whatever measurement, survey, and local enquiry he may deem necessary for the security of the Government revenue, to be made. When no objecthe Government revenue, to be made. tion on the part of the proprietor of the parent estate, or of any other party interested is filed; or when, if such objection is filed, the Collector after summary investigation may be of opinion that the applicant has established his claim so far as the rights of the proprietor and other private parties are concerned; before registering the tenure, the Collector shall satisfy himself that it was created in good faith so far as the interests of the Government revenue are concerned, and that the rent payable by the holder is not less than is fully sufficient to afford a fair proportion of the revenue assessed upon the parent estate. If the Collector be not satisfied upon this point, he shall reject the application. If he be satisfied upon this point, he shall register the tenure in the provisional registry book under the rules prescribed in Section XXXVIII. of this Act. Provided always that, in the case of such tenures created after the passing of this Act, no application for registration shall be received, unless the same be submitted within one month from the date of the deed constituting the tenure.

XXXVIII. Talookdaree tenures, for the registration of which application shall be made within the Protection of under-tenures provisionally registered. prescribed time shall, in case of the sale of the parent estate for arrears of revenue, be protected pending the summary investigation of the Collector, and shall be protected eventually by provisional or permanent registration, if the award of the Collector upon such application be in favor of the applicant, or in case of that award being against the ap-plicant, if that award be reversed by the final decision of a Civil Court.

XL. No Civil Court shall be competent to inter-fere with any award of any Restriction of Jurisdiction revenue authority passed under Sections XXXVI. and of Civil Courts.

XXXVII. of this Act, founded upon any consideration regarding the good faith in which a tenure may have been created so far as the interests of the Government revenue are concerned, or the adequacy of the rent for the security of that revenue.

XLI. After the expiration of one year from the date of registration in the Protection of under-tenures provisional registry book, the permanently registered. Collector shall transfer the

registration to the permanent registry book, unless it be shown that a Civil suit has been filed to annul the registration; in which case he shall suspend registra-

tion in the permanent registry book pending the final result of such suit. The entry in the permanent registry book shall be an effectual protection of the undertenure so registered, unless within sixty years from the date of registry a decree be passed at the suit of Government by a Civil Court, pronouncing the registration to have been obtained by fraud, to the injury of the Government revenue.

Provided that nothing in this Act contained shall be construed to entitle any purchaser of land at a public sale to demand a higher rate of rent from any persons whose tenure or agreement may be annulled as aforesaid than was demandable by the former malgoozar, except in cases in which such persons may have held their lands under engagements, stipulating for a lower rate of rent in consequence of abatements having been granted by the former malgoozars from the old established rates by special favor, or for a consideration, or the like, or in cases in which it may be proved that, according to the custom of the pergunnah, mouzah, or other local divi-sion, such persons are liable to be called upon for any new assessment, or other demand not interdicted by the regulations of Government.

No. 134 of 1856.—The Right Honorable the Governor in Council is pleased to republish the following General Order by the Most Noble the Governor General of India in Council, dated Fort William, 23rd January 1856, No. 132:-

"It appears from the Report of a Court of Inquiry held at Bolarum, the proceedings of which have been laid before Government, that, on the evening of the 21st of September 1855, a very serious outrage was perpetrated on the person of Brigadier Colin Mackenzie, Commanding the Southern Division of the Hyderabad Contingent, by certain Sowars and followers of the 3rd Regiment of Cavalry of the Contingent, during the celebration of the Festival of the Mohurrum at Bolarum.

The Most Noble the Governor General of India in Council having maturely considered the circumstances under which this lamentable occurrence took place, and having directed that the persons concerned in committing the deadly outrage upon the person of Brigadier Mackenzie shall be tried for the offence in the usual form, is pleased to promulgate for general information the conclusions to which he has come, and the measures which he considers it necessary to adopt on the present occasion.

It appears that, on the 20th of September, a Cantonment Order was issued at Bolarum by Brigadier Mackenzie, regulating the arrangements for conducting the processions of the different Regiments at the Station, so as not to interfere with one another; and the Order declared that no procession, music, or noise, would be allowed on any account whatever, from 12 o'clock on Saturday night the 22nd, to 12 o'clock on Sunday night the 23rd of September. On the 21st a subsidiary Order was issued, modifying this declaration; it having been ascertained that Sunday, the 23rd, was a day of the Festival, on which processions were indispensable to its due celebration.

The Orders thus issued were, in the opinion of the Governor General in Council, in their general tenor, unusually stringent. The first Order was not only unusual, but objectionable, in that it put forward the Mohurrum in direct conflict with the Christian Sabbath, and so introduced a religious element into the prohibition. But this Order was

It further appears that, on the evening of the 21st of September, a procession was observed by Brigadier Mackenzie proceeding along one of the roads by which the passage of processions had just been prohibited in orders. As the party approached his own residence, Brigadier Mackenzie sent word to them to be silent and to proceed to their own lines; but the messengers, of whom several were sent, were unsuccessful. Upon this disregard of his orders, the Brigadier himself went up to the procession to enforce compliance, and finding no obedience paid to him, and being met with shouts of defiance, he seized two standards after struggling with the bearers, and wresting a sheathed sword from the hand of one of the parties, the Brigadier struck the man with it. One or two followers, who were of the procession, were taken up, and the rest then dispersed. The standards and sword were quietly retained by the Brigadier.

Shortly afterwards, an armed mob, issuing from the Cavalry Lines, and having among them, as it appears, many Sowars, broke into Brigadier Mackenzie's garden, murderously assaulted him, and followed him into his house, threatening his life. By the same mob, Lieutenant Murray, Second in Command of the 3rd Cavalry Regiment, was wounded and knocked down, and violence was offered to several gentlemen and ladies who happened to pass

along the road where they were collected.

Some of the ringleaders have been arrested, and with them the law of the land will deal.

It is with sincere regret that the Governor General in Council finds himself bound to say that, in his opinion, the immediate and the real cause of the outrage by which Brigadier Mackenzie has so severely suffered, was the act of the Brigadier himself in rushing from his compound into the midst of a Mussulman rabble, roused by the excitement of the Mohurrum, and there seizing their standards and coming into personal conflict with them.

The Governor General in Council entertains a high respect for Brigadier Mackenzie, as a good and distinguished Soldier, and as honorable, conscientious, and gallant a gentleman as the ranks of the Army can show. His Lordship in Council therefore looks with not less regret than disapprobation on the intemperate act which has produced so much evil, and has brought down such grievous suffering upon the Brigadier himself. This Officer will be compelled by the severity of his wounds to quit Bolarum and proceed on leave to England.

But the act of the Brigadier did not justify the murderous violence of those with whom he interfered.

Neither did it justify the mutinous conduct of the Sowars of the 3rd Regiment of Cavalry.

It is clear to the Governor General in Council from the evidence before him, that the greater part of the Regiment in the lines was in a state of open mutiny; some rushed into the streets, cutting and hacking at the passers-by, and brutally assailing even women in their course.

Their European Officers were not allowed to approach them. They paraded without orders from their European Officers, and without any of the usual calls to parade, but by the direction of their Rissaldar. They were armed, mounted, and equipped. They sent out Videttes to watch the approach of other Troops sent for from Secunderabad, and acted as a military body guided by other orders than those of their regular European superiors.

Such proceedings are manifestly destructive of all discipline, and tend not less to destroy all confidence in the fidelity of Troops that serve the Government. They appear to the Governor General in Council to call for grave

animadversion and for severe punishment.

They appear to His Lordship in Council to call the louder for animadversion and punishment, that this is not the first time that the Hyderabad Cavalry has been guilty of violence towards their European Officers.

The Governor General in Council is convinced that he would be perfectly warranted in disbanding the whole Regiment, if he so pleased; but it is not his intention to have recourse to so sweeping a measure.

His Lordship in Council holds that, in every such case as this, it is to the Native Officers that the Government has a right to look for the maintenance of order and fidelity in the Corps. Native Officers have long been in the habit of thinking that, if they only keep themselves clear from any manifest participation in the disaffection of their Corps, if they abstain themselves from any overt act of disobedience or mutiny, no blame will be imputed to them, and they will be allowed to escape with impunity.

The Governor General in Council regards this as a most pernicious feeling, which Government should lose no opportunity of eradicating.

The Native Officers of the 3rd Cavalry of the Hyderabad Contingent will accordingly now be dealt with as responsible for its conduct.

That they could have exercised a control over their men is clear, for when one of their number, Jemedar Shah Mirza Beg, loyally refused to join their tumultuous parade, and ordered the 5th Troop to remain in their quarters though a very few men had in the first instance paraded, after the Jemedar's orders not a man of the Troop appears to have quitted the lines.

That, with the exception of Jemedars Shah Mirza Beg and Mozuffur Khan, the Native Officers did not control their men, is shown by the whole tenor of the evidence. They tolerated, if they did not abet, the mutiny; they did all they could to screen their men from blame or punishment; and they lent no assistance whatever to the authorities in their attempts to discover the men of the Regiment who were accused of having committed the murderous assault on the life of Brigadier Mackenzie.

Having regard to these considerations, the Governor General in Council has resolved on, and hereby directs the dismissal, from the Service, of the Native Commissioned Officers of the 3rd Cavalry, as a fitting and an effectual measure of punishment.

There will be several exceptions to it.

Jemedar Shah Mirza Beg, whose conduct was loyal and obedient, will of course be excepted. Officers who were on detachment, or were absent from the lines, or were confined by sickness, will also in justice be excepted. Jemedar Mozuffur Khan is also excepted, he having invited the interposition of the European Officers.

Jemedar Shah Mirza Beg is appointed Rissaldar in the Regiment, in the room of Rissaldar Meer Bundah Hussun now dismissed.

In making the necessary promotions in succession to the Native Officers dismissed, it is the desire of the Governor General in Council, that no man of the Corps who was present in the lines during the days of the tumult and mutiny shall receive advancement, unless he belonged to the 5th Troop.

The Orderly Sowar attached to Brigadier Mackenzie on the 21st of September, Guffoor Khan, Bargeer, is advanced to the Rank of Naib Duffadar.

The Governor General in Council considers it necessary to note the conduct of the Infantry Guard at the Brigadier's house on the 21st of September.

It is proved that the permanent Havildar's Guard made no attempt whatever to resist the mob, or defend the person of the Brigadier.

The Jemedar who came subsequently with another Infantry Guard, refused to seize the rioters who were pointed out to him.

Brigadier Mackenzie, it appears, had enjoined the Havildar's Guard not to load, when he first saw the mob coming; but that injunction was, in the opinion of the Governor General in Council, no justification to the Guard for not resisting, when it saw the mob actually cutting down its Officer before its eyes.

The plea of the Jemedar, that he would not take orders from the man who pointed out the culprits, is, in the judgment of the Governor General in Council, perfectly worthless.

Cowardice in a Soldier is as much to be condemned as mutiny. To defend his Officer is certainly not less his duty than to obey him.

For some men of the two Infantry Guards, there appears to be the palliation that they were placed where possibly they might not have distinctly seen what was passing; some were posted as sentinels; one had in charge a prisoner. But the Governor General in Council can see no palliation or excuse for the conduct of the leaders of these Guards; and His Lordship in Council holding the Commanders as mainly responsible, accordingly directs that Havildar Bowance Uppadiah, of the 3rd Infantry Regiment, and Jemedar Sumjawun, of the 3rd Infantry Regiment, of the Hyderabad Contingent, who commanded the two Guards, be dismissed the Service.

The Governor General in Council, in closing this statement of his views of the lamentable occurrences at Bolarum above detailed, feels constrained to observe, that the evidence before the Court of Inquiry has not left a favourable impression on his mind in regard to Captain Sutherland G. G. Orr, Commanding the 3rd Cavalry Regiment, nor satisfied His Lordship in Council that that Officer exhibited as much vigor, resolution, or determination to expose and punish the mutinous conduct of his Corps, as Government would have expected to see in the European Commandant of the Regiment.

The Governor General in Council embraces the present occasion to reiterate, in the strongest manner, the injunction so repeatedly given to Officers in the Service of Government, never to interfere with the religious observances of the Natives of India under their control, further than is actually necessary for the preservation of the public peace and the maintenance of discipline and order.

In conclusion, the Governor General in Council is pleased to direct, that this General Order, pointing out as it does the duties, responsibilities, and liabilities of Native Officers in cases of mutiny, shall be not only issued to the Hyderabad Contingent, but communicated to all other Forces and Contingents also under the immediate orders of the Government of India.

The Governor General in Council directs that all the honors and distinctions paid to the Commander-in-Chief in India, shall be continued to His Excellency Sir W. M. Gomm, K.C.B., until his departure for England.

NOTICE.

The following Rules, which, under the orders of the Government of India, have been issued for the guidance of the Officers of the Post Office, are published for general information:—

I. Letters arriving at the Presidency towns by Mail Steamers will be immediately sorted for delivery, without any reference to instructions which may have been received regarding change of address. Such changes will be left to be discovered by the Delivery Officers, and be corrected in the Forward and Unclaimed Departments of the Office.

II. A separate instruction will be required for every change of address, and no instruction will be

attended to for more than three months after its receipt.

III. Under Section XXIII. of Act XVII. of 1854, Forward Postage will be charged, in addition to all other Postage due or paid thereon, upon every letter without exception which may be re-directed in any Post Office. For example, if a letter posted in Calcutta, and addressed to Hooghly, is, under instructions which may have been received from the addressee, re-directed in the Calcutta Post Office, and sent to Barrackpore, Forward Postage will be charged in addition to the Postage which would have been due hadthe letter been despatched to Hooghly according to its original address.

IV. The practice of giving instructions to the Officers of the Post Office to intercept and re-direct letters not only imposes much labour upon them, but, in large Offices, seriously retards the delivery and despatch of the Mails. A Register of instructions regarding changes of address will be kept in every Post Office, but it must be understood that it is impossible to guarantee that they shall be attended to, except in the

case of letters received for delivery.
