Is hereby given, that Sealed Tenders will be received at this Office, from 11 to 12 o'clock, noon, on Friday the 22nd July 1853, for the exclusive privilege of selling Country Liquor and In-toxicating Drugs for the Town and Cantonment of Sholapoor, for one year from the date on which the sanction of the Military Board may be received at this Station.

2. The Troops composing the Cantonment of Sholapoor are as follows :-

Resident Population 10,000 1 Regiment of Native Light Cavalry, and Followers 962 1 Regiment of Native Infantry..... 1 Company of Native Foot Artillery, with No. 2 Light Field Battery 873 164 attached

3. No deduction will be allowed, except for Troops who may leave the Cantonment.

4. Detachments of 500 Men moving or sta-tioned within the Command are to be supplied with Liquor and Drug Shops by the Contractor.

5. Troops moving from the Station to be supplied with Liquor Shops by the Contractor, which are to remain until replaced by others from the Station they halt at.

The amount to be paid by the Contractor shall not be increased or decreased as Troops arrive in or depart from the Cantonment, except in cases where the strength of such Troops exceeds one-fourth the number of Sepoys and Followers stationed at the time of concluding the Contract.

7. It is hereby declared, that the Contractor is to take the Contract with all its advantages and drawbacks, as he will not be considered entitled to any remission in consequence of failure of seasons, or any other cause save those distinctly specified in the Contract. All petitions for remission of monthly payments will consequently not be attended to.

The Contractor to remain always with the Bazar Department, and have agents wherever, within the local limits of the said Command, they be required by order of the Superintendent of Bazars and Police; and the said Contractor will be held responsible for his or their agents fulfilling the terms of this Contract.

9. The Contractor shall not sell or permit to be sold any Liquor or Drugs whatever at any lower rates than those contained in his Contract.

10. The Tenders, &c. to be in Company's Rupees; and no person will be allowed to tender for the Contract unless he previously deposits in this Office the sum of Company's Rupees (1,500) one thousand and five hundred, in cash, which will be forfeited in the event of delay, evasion, or refusal to execute the necessary Deed of Contract, should the offer be accepted, in which case he must be prepared to add thereto such amount as shall complete a month's rent, to be deposited in the Collector's Treasury, until the expiration of his Contract.

11. The tenderer will be required to sign and execute the Deed of Contract, which will have been previously prepared, and to furnish at the same time two competent persons as securities for the due performance of the whole Contract.

Should the Contractor appear to the Officer Commanding the Station to have any interest or concern, either directly or indirectly, with any person whom Government may declare unworthy of being dealt with in the management of this Contract, or if he shall at any time fail in any one of the conditions of this Contract, it shall be lawful for the Commanding Officer of the Station, by order, to put an end to this Contract, without prejudice to the right of the said Company to damages on account of antecedent breach of contract; and in such case such money as shall have been advanced by the said Contractor shall not be repaid to him, but may be retained by the said Company.

13. The power is reserved to Government to reject even the best bid, should it see fit to do so.

14. The Contractor to defray the expenses of maintaining a Preventive Police, when and whereever it may be found necessary by the Commanding Officer, for suppressing clandestine sale of Spirits to European Troops.

15. The Contractor is bound to abide by the provisions of paragraphs 23, 24, 25, and 26 of G. O. C. dated 28th August 1852.

16. People exempted from the spirit of para.
23 of the above General Order are prohibited from taking out of the Shops any quantity of Liquor exceeding (1) one bottle, without a written pass from the Superintendent of Bazars and Police.

17. After these Shops are closed at 9 o'clock P. M. no Liquor whatever shall be clandestinely sold to any individual, on pretence of accident, sickness, or other necessity, without a pass from the Kotwal of the Camp Bazar.

18. Further particulars will be made known to any person or persons on application at this Office, every day, from 10 A. M. to 4 o'clock P. M., Sundays excepted.

The following Draft of a proposed Act was read in Council for the first time on the 27th of May 1853 :-

ACT No. -- or 1853. An Act to confer certain Powers on the Municipal Committees for improving the several Stations in the

Straits of Malacca.

Whereas it is expedient that the Municipal Committee of each of the stations of Penang, Singapore, and Malacca should be invested with the powers hereinafter mentioned; It is hereby enacted as follows :-

I. The said Municipal Committees may, subject to confirmation or disallowance by the Governor of the Settlement of Prince of Wales' Island, Singa-Municipal Committees to appoint Surveyors and other officers. pore, and Malacca, nominate, ap-

point, and employ, respectively, such surveyors, inspectors, and other necessary officers and servants, as may be necessary or proper for the execution of the powers hereby vested in them; and such surveyors, inspectors, officers, and servants shall receive such salaries as to the Governor of the Straits shall seem meet.

II. The management and control over all the streets

and roads within the said stations of the said Settlement, existing at the time of the passing of this Act, and of all parts of the said stations which shall hereafter become streets and roads, and the

pavements and other materials therein, and all erections and buildings, materials, implements, or other things provided for the said streets and roads by or under the authority of the Governor of the Straits, or by the Magistrates of the Settlements, or by the said Municipal Committees; and also the management and control of the public tanks, aqueducts, and canals, and of all sewers and drains, whether public or private, now made, or hereafter to be made, within the said stations, are hereby vested in the said Municipal Committees for the purposes of this Act.

III. The said Municipal Committees, by and with

Municipal Committees empowered to make or widen streets.

Municipal Committee to have manage-

ment and control over

streets, roads, drains,

the consent of the Governor of the Straits, may lay out, make, build, and construct streets within the said stations, and may alter

and widen narrow streets, regard being had to the compensation of owners of lands which may be required to be vested in the said Municipal Committees for any such purposes.

Power to Municipal Committees to pave and water streets, &c., erect pumps, &c., and make convenient tanks, &c.

IV. The said Municipal Committees, with the cousent and approbation of Governor of the Straits, shall pave and water such of the public streets, existing in the said stations at the time of the passing of this

Act, or at any future time, as they shall think fit, and it shall be lawful for the said Municipal Committees to excavate and provide convenient tanks or runs of water through the said stations, and to sink wells, and lay, erect, and place pipes, gutters, conduits, and pumps, in any of the said streets, and may remove and alter the same, when, and as the said Municipal Committees, respectively, shall think proper.

V. The said Municipal Committees, by and with the

Power to Municipal Committees to pur-chase lands, &c., for the purposes of this

consent of the said Governor of the Straits, may, by agreement, or in conformity with the provisions of Act XXII. of 1847, purchase, or take absolutely, or on lease, for such terms as they may think fit,

any water works, streams of water, lands, fixtures, or other property, which the said Municipal Committees may deem it necessary to purchase or take for any work

or purpose which they are required or authorized to do and execute under this Act, or the Act No. of 185; and when the said Municipal Committees take and purchase any lands for the purposes of this Act, otherwise than with the consent of the owners and occupiers thereof, they shall, in exercising the powers so given, be subject to the provisions and restrictions contained in the said Act No. XXII. of 1847, and the said Municipal Committees shall make to the owners and occupiers of, and all other parties interested in, any such lands, taken for the purposes of this Act, full compensation for the value of the lands so taken, and for all damages sustained by such owners, occupiers, and other parties, by reason of the exercise, as regards such lands, of the powers vested in the Municipal Committees by this Act, and the amount of such compensation shall be this Act, and the amount of such compensation shall be determined in the manner provided by the said Act No. XXII. of 1847, for determining questions of compensation with regard to lands purchased or taken under the provisions thereof; and all provisions of the said Act No. XXII. of 1847 shall be applicable to determine the amount of any such compensation, and to enforce the payment, or other satisfaction thereof. Provided, and it is enacted, that on the application of the provisions of Act No. XXII. of 1847 to any of the purposes of this Act, the same shall be read and interpreted, as if instead of any word or words therein used, importing a Justice or Justices of the Peace, or Magistrate or Magistrates of Calcutta, words had been used designating a Justice or Justices of the Peace of the said Settlement, and as if instead of any words therein used importing the Supreme Court of Judicature at Fort William in Bengal, or any Judge or Judges of the said Court, words had been used designating the Court of Judicature of Prince of Wales' Island, Singapore, and Malacca, or the Recorder of the said Court; and as if instead of any word or words therein used importing the Sheriff or Coroner of Calcutta, words had been used importing the Sheriff or Coroner of the said Settlement, or any deputy to be appointed by such Sheriff; and as if instead of words importing a jury of Calcutta, words had been used in the said Act importing a jury of the said Settlement, or any of the said stations there.

VI. The Municipal Committees, by and with the consent of the Governor of the Power to Municipal Committees to sell

Straits, may sell or dispose of any lands or other property vested in or acquired by them under the powers

herein contained, which it may appear to the Municipal Committees may be properly sold or disposed of; and for completing and carrying any such sale of lands into effect, the Municipal Committees may make and execute a conveyance of the lands sold and disposed of as aforesaid, unto the purchaser, or as he shall direct; and such conveyance shall be under the hands of three of the Members of the Municipal Committees, and under the seal of the Municipal Committees, and a receipt, under the hands of three of the Members of the Municipal Committees, shall be a sufficient discharge to the purchaser of any such lands for the purchase money in such receipt expressed to be received, and the money to arise from such sale shall be applied to such of the purposes of this Act as the Municipal Committees shall think fit.

VII. The said Municipal Committees may, from

lands, &c.

time to time, as they shall see fit, widen, deepen, embank, alter, arch over, amend, clean and scour out all or any of the sewers or drains, within the said stations,

as may be necessary, and also cleanse and drain off into any sewers or drains, or otherwise abate all stagnant any severs of thans, and other receptacles of foul water and filth, existing within the said stations, whether the same be the private property of any person or persons, or otherwise; and the said Municipal Committees, if they shall think fit, may take up, stop, fill in and discontinue any sewers or drains, which the in, and discontinue any sewers or drains, which they

shall deem useless or unnecessary; Provided always, that the expenses incurred in respect of any such works done or executed on the private property of any person, if not defrayed by such person on demand thereof, may be recovered by distress and sale of the goods and chattels of such person; and any two of the said Members of the Municipal Committees may issue their warrant of distress accordingly.

Power to Municipal Committees to enter, examine, and lay open houses, lands, &c., for that purpose. Compensation in certain cases.

VIII. Every Municipal Committee, and the Surveyor to the Municipal Committees, with such subordinate officers or persons as they may require, shall, when it shall be necessary or convenient, for the purpose of making any survey or examination of any

sewers or drains, or of making, or repairing, or cleansing any sewers, drains, or works, within the said stations, or of carrying into execution any of the powers entrusted to the Municipal Committees by this Act, have full power and authority, at all reasonable hours in the day time, to enter, examine, and lay open, or to direct their subordinate officers to enter, examine, and lay open, any house, building, or other erection, or any lands, without being liable to any action at law, or suit in equity, or any other legal proceedings or molestation whatsoever, for or on account of such entry, examination, or works, or of anything done, or to be done in any part of such house, building, erection, or land, in pursuance of this Act. Provided always, that except in cases of emergency, none of the persons above mentioned shall enter, examine, or lay open any house or building, or other erection, or lands which may be occupied at the time, unless with the consent of the occupier thereof, without previously giving the said occupier twenty-four hours' notice of their intended entry, and of the object thereof. Provided also, that compensation shall be made for any damage occasioned by such entry and works to all persons other than the owners and occupiers of any land or building in respect of which any private drain or sewer, or the state of drainage shall be inspected, cleansed, or repaired, and other than the owners or occupiers of any premises where any nuisance may exist, and other than the person who may have caused such nuisance; and provided also that in case no nuisance shall be found to exist in or on the house, building, or other erection, or land so entered, examined, and laid open as aforesaid, the said Municipal Committees shall, out of the rates and taxes aforesaid, cause the said house, building, or other erection, or lands, to be restored to the same state and condition in all respects as the same were in before they were so entered, examined, or laid open.

IX. If any house, building, or wall, or anything affixed thereon, within the limits of the said stations, be deemed by Power to Municipal

Committees in case of the Municipal Committees, or ruinous or dangerous their Surveyor, to be in a ruinous state, or badly built, or likely to buildings.

fall, and also dangerous to passengers, or the occupiers of neighbouring buildings, such Surveyor shall immediately cause a proper board or fence to be put up, for the projection of passengers, and shall cause notice in writing to be given to the owner of such house, building, or wall, or other thing, if he be known and resident within the said limits, and shall also cause such notice to be put on the door or other conspicuous part of the said premises, or otherwise to be given to the occupier thereof (if any), requiring such owner or occupier forthwith to take down, secure, or repair such house, building, wall, or other thing, as the case shall require; and if such owner or occupier do not begin to repair, take down, or secure such house, building, wall, or other thing, within the space of three days after such notice has been given or put up as aforesaid, and complete the same as speedily as the nature of the case will admit, the said Municipal Committees shall, with all convenient speed, cause all, or so much of such house, building, wall, or other thing, as shall be in a ruinous condition, or badly built, or likely to fall, and also dangerous

as aforesaid, to be taken down, repaired, rebuilt, or otherwise secured, in such manner as shall be requisite; and all the expenses of putting up every such fence, and of taking down, repairing, rebuilding, or securing such building, wall, or other thing, shall be paid by the owner thereof, if such owner can be found within the said limits, and if, on demand of the expenses aforesaid, he neglect or refuse to pay the same, then such expenses may be levied by distress on the goods and chattels of the owner of the said house, building, wall, or other thing, and any two Members of the Municipal Committees may issue their warrant of distress accord-

If any such house, building, wall, or other thing, or any part of the same, be pulled down by virtue of the powers aforesaid, the Municipal Materials may be Committees may sell the materials thereof, or so much of the same as shall be pulled down, and apply the proceeds of such sale in payment of the expenses incurred in respect of such house, building, wall, or other thing, and the Municipal Committees shall restore any overplus arising from such sale to the owner of such house, building, wall, or other thing, on demand; nevertheless the Municipal Committees, although they sell such materials for the purposes aforesaid, shall have the same remedies for compelling the payment of so much of the said expenses as may remain due after the application of the proceeds of such sale, as are hereinbefore given to them for compelling the payment of the whole of the said expenses.

XI. The said Municipal Committees, by and with consent of the Governor of the

Power to Municipal Straits, may construct, make, and Committees to make lay, or cause to be constructed, aqueducts, made, and laid, such reservoirs, sewers, drains, &c. canals, aqueducts, channels,

tanks, sewers, drains, bridges, banks, conduits, machinery, engines, waste-gates, stop-gates, stop-cocks, sluices, tunnels, water-pipes, and other works, as shall, in their opinion, be necessary and proper for obtaining water and supplying the same to the said stations, and for the effectual draining and cleansing of the said stations, and for the properly flushing and cleansing out such sewers, in, under, or across all or any of the streets therein, whether dedicated to the public use or not, and if needful through and across all under-ground cellars and vaults which they may find under any of the said streets, doing as little damage as may be; and also to cause such and so many rings and openings to be made or left in the sides of the said sewers, as will be sufficient for the making or branching any drain or drains from any or all of the houses built, and which may probably be built, adjoining or near thereto, into any of the said sewers, as the said Municipal Committees shall think necessary for that purpose; and in case it shall be found necessary for completing any of the aforesaid works to build, carry, or continue the same in, into, through, or over any enclosed lands, or other place, not being a public way, it shall be lawful for the said Municipal Committees to build, carry, or continue the same in, into, through, or over the said lands or other places accordingly, and the said Municipal Committees shall cause such sewers to communicate with, and empty themselves into any public river, stream, canal or water-course, whether within or without the said stations, or shall cause the refuse from such sewers to be conveyed by an appropriate channel to the most convenient site for its deposit, collection, and sale, and its application as manure for agricultural purposes or otherwise, as they shall deem most expedient, but so that the same shall in no case become a public nuisance or annoyance to the neighbourhood.

XII. If any building within the said settlement, by

Power of Municipal Committees in case of untenanted or abandoned houses.

reason of abandonment, or of disputed ownership or other cause, shall remain untenanted, and therehy become a receptacle for thieves and vagabonds, and be complained of by the neighbours as a nuisance, the Municipal Committees shall cause notice in writing to be put on the door or other conspicuous part of such building, requiring those concerned therein, whoever they may be, to take down or to secure the said building, in such manner as that strangers may not have access thereto; and if such notice be not complied with within a reasonable time from the date of such notice, the said Municipal Committees shall cause the necessary work to be executed, and all expenses incurred by the Municipal Committees in the execution of such work, whereby the nuisance caused by such building may have been removed, shall be levied in the manner herein-before provided in Section IX. of this Act.

XIII. The Municipal Committees shall cause all

Power of Municipal Committees to cut and clip all hedges lining public roads and foot naths.

hedges lining public roads and foot paths to be cut and clipped, so that they may not exceed a height of six feet, or overhang the road in a manner to form obstructions to the traffic thereon, and to damage the said roads, and shall give notice to own-

ers and proprietors of such hedges to reduce the same when requisite, and in the event of such notice not being complied with, within one week from the date of such notice, the Municipal Committees or their collector may cause the said hedges to be cut and clipped, in the manner required, and all expenses incurred in so cutting and clipping shall be paid by the owners and proprietors of the said hedges, and in the event of the said expenses not being paid by the said owners or proprictors within three days from the date of demand, the same shall be levied by distress on the goods and chattels of the said owners and proprietors.

XIV. The Municipal Committees shall cause to be

Power of Municipal Committees to define the proper limits of the towns of Penang, Singapore and Malacca, and to prevent houses being covered with exactly defined the proper limits of the towns of Penang, Singapore and Malacca, and shall cause a notification to be published in the local papers, so defining such limits, and from the date of the passing of this Act, the said Municipal Committees shall pre-

vent any dwelling-house, shed, or other building, which shall hereafter be erected within such limits, from being covered with attaps, leaves, or grass, and the said Municipal Committees, or their collector, may cause the coverings of any such buildings so erected, after the passing of this Act, and so covered, as aforesaid, to be removed, at the expense of the person or persons so covering the same, such expenses to be recovered in the manner provided by Section IX. of this Act.

XV. It shall be lawful for the said Municipal Com-

Power to Municipal Committees to enter on lands adjacent to works,

mittees, their collector, surveyor, or other officer, subject to the restrictions in this Act contained, to enter upon the lands of any corporation or person adjoining

to, or being within the distance of one hundred yards of the works by this Act authorized to be made, or any part thereof, for the purpose of depositing upon such lands, or any part thereof, any soil, gravel, sand, lime, brick, stone, or other materials, or for any other purposes connected with the formation of the said works, without making any previous payment, tender, or de-posit, the said Municipal Committees, their collector, surveyor, or other officer, doing as little damage as may be in the exercise of the several powers hereby granted to them, and making compensation for such temporary occupation or temporary damage of the said lands to the owners and occupiers thereof, from time to time, and as often as any such temporary occupation shall be taken or any such temporary damage done, and making compensation to the owners also for the permanent injury (if any) to such lands; and in case the parties differ respecting the amount of the compensation, or the respective shares of several claimants of compensation, then and in every such case the said disputes respectively shall be settled and adjusted by arbitration, or by

the verdict of a jury summoned and 'assembled in manner provided in Act No. XXII. of 1847, to be interpreted in the manner pointed out by Section V. of this Act. Provided always, that before the said Municipal Committees make any such temporary use as aforesaid of the lands adjoining or lying near to the said works, they shall give fourteen days' notice of such their intention to the owners and occupiers of such lands, and shall separate and set apart by sufficient fences so much of the lands as shall be required to be used as aforesaid from the other lands adjoining thereto.

XVI. The said Municipal Committees, when execut-

Municipal Committees, when executing works, to provide convenient roads, drains, &c. for use of adjoin-ing lands, when pre-sent roads, &c. are stopped, &c.

ing any works hereby authorized to be made, shall, at their own expense, make and provide a sufficient number of convenient roads, ways, watering-places, wells, water-courses, drains, and channels for the irrigation and for the use

of the adjoining lands, and for irrigating the same in those parts where the present roads, ways, watering-places, wells, water-courses, drains, and channels shall and may be taken away, or interrupted, injured, or rendered inconvenient or useless by reason of the execution of the said works, and in case of any difference arising between the said Municipal Committees and the owners of such adjoining lands, such difference shall be settled by arbitration, or by the xerdict of a jury summoned and assembled in manner provided in Act No. XXII. of 1847, to be interpreted as aforesaid.

XVII. The said Municipal Committees shall make

full compensation out of the rates Power to Municipal and taxes to be levied by them to Committees to make compensation out of all persons sustaining any damage by reason of the exercise of any rates, &c. nicipal Committees, or their officers or servants, under

and by virtue of this Act.

XVIII. It shall be lawful for the said Municipal

Committees to direct any prose-Power to Municipal cution before any Court of Jus-Committees to prose-tice of the Peace for any public cute in certain cases. nuisance whatsoever, which shall

be permitted, suffered, or committed, within the said station, and to order proceedings to be taken for the recovery of any penalties, and for the punishment of any persons offending against the provisions of this Act, and to direct and order the expenses of such prosecutions and other proceedings to be paid and borne by and out of the Funds placed at their disposal, under the provisions of this or any other Act.

XIX. It shall be lawful for the said Municipal

Power to Municipal Committees to prefer bill of indictment in certain cases.

Committees, if they shall not think fit to take any other pro-ceedings prescribed by this Act, to prefer any bill of indictment or information, or to take any other

proceedings against any person who shall obstruct or molest the said Municipal Committees, or their collector, surveyor, or other officer or servant, or any workman, or other person employed by them in the performance and execution of their or his duty, under, or by virtue, or in consequence of this Act, or who shall steal, take, or carry away, or wilfully deface or injure any property, article, or thing belonging to the said Municipal Committees, and in every such case it shall be sufficient to state generally the property, article, or thing, in respect of which such proceeding shall have been taken, to be the property of the said Municipal Committees.

XX. It shall be lawful for any of the Municipal

Power to Municipal Committees to arrest offenders unknown

Committees, their collector, surveyor, superintendents, overseers, or any servants or persons employ-ed by them, and for any Superin-tendent of Police, or policeman

employed in the said stations, and such other person or persons whom he or they shall call to his or their

assistance, without any summons or warrant, or other authority than this Act, to seize and detain any unknown person who shall commit any offence against the provisions of this Act, and to take him immediately to a police station, where he shall be detained, in default of bail, until he can be taken before any Justice of the Peace, who is hereby required to proceed and act with respect to such offender according to the provisions of this Act.

XXI. The Municipal Committees, or any one of their Members, or any person

Power to Municipal Committees to enter and inspect bazars, slaughter-houses, &c., and to seize unwholesome articles exposed

person appointed by them for that purpose, may at all reasonable times, with or without assistants, enter into and inspect any market, building, shop, stall, or place, kept or used for the sale of butcher's meat, poultry, fish, or vegetables,

or as a slaughter-house, and may examine any animal, carcase, meat, poultry, game, flesh, fish, or vegetables which may be therein; and in case any animal, carcase, meat, poultry, game, flesh, fish, or vegetables appear to be intended for the food of man, and to be unfit for such food, may seize, remove, and destroy the same, at the expense of the owner thereof, or the owner, occupier, or farmer of any such public market, bazar, or slaughter-house, or private shop, or stall, within the stations wherein the same shall be exposed, or allowed to be exposed for sale.

XXII. The Municipal Committees, or their surveyor, shall have full power and

authority to remove or order the Power to Municipal Committees to remove removal of any wall, fence, rail, obstructions in streets. post, or other obstruction or encroachment, crected or being with-

out lawful excuse in any street, or in or over any drain, sewer, or aqueduct, within the said stations.

XXIII. When any private tank or low marshy

ground shall appear to the Municipal Committees to be offensive Power to Municipal Committees to fill up unwholesome tanks. to the neighbourhood, or unwhole-

unwholesome tanks. some, it shall be lawful for the said Municipal Committees to require, by notice in writing, the owner thereof to cleanse or fill up the same, and if the said tank shall remain uncleansed or not filled up for seven days after such notice, it shall be lawful for the said Municipal Committees to enter into and upon the adjoining lands, and to cleanse or fill up the said tank as they shall think fit, and the expense incurred thereby shall be paid by the owner of such tank, to be recovered in manner hereinafter mentioned.

XXIV. The Municipal Committees may affix on or

Power to Municipal Committees to affix boards or plates to

to the wall of any house or com-pound, or in or to any wall with-in the said stations, as they shall think fit, any board or metal plate, to indicate the name of the street

in which such house, compound, or wall is situate, or any lamp for the purpose of lighting the street.

XXV. It shall be lawful for the said Municipal Committees, or their subordinate Power to Municipal Committees to kill dogs. officers, as they shall think fit, to be killed and destroyed, all dogs that may be found

loose in the said streets, and not accompanying their

owners or some person in charge of them.

Municipal Committees to repair streets,

XXVI. The said Municipal Committees shall, so far as the funds at their disposal will admit, keep in good and sufficient repair every street now or at any future time existing in

the said-stations.

XXVII. When any of the streets, sewers, or drains

Municipal Committees to take precautions when streets and drains under repair.

in the said stations are being made, or shall be under repair, the Municipal Committees, or their surveyor or other subordinate officer, shall take proper pre-

cautions against danger, by shoreing up and protecting the adjoining houses, and shall fix and place, or cause to be fixed and placed, such and so many bars, chains, or posts, across or in any of the said streets, to prevent the passing and repassing of carriages, carts, or other vehicles, cattle, or horses, during the time of such works and repairs being carried on as shall be necessary, and the said Municipal Committees, and their said surveyor, shall cause any sewer, or drain, or other works, during the construction or repair thereof by them, to be well and sufficiently lighted during the night, to prevent accidents.

XXVIII. The said Municipal Committees, so far as

Municipal Commit-tees to light the sta-

the funds at their disposal will admit, shall provide lamps, for lighting such parts of the said stations as the said Municipal

Committees shall consider to require the same, and shall keep the said lamps in fit order for public use, and shall keep and employ a sufficient number of persons to cleanse, prepare, repair, and light the same, and shall also, from time to time, as shall be required, increase or otherwise alter the number and situation of the said lamps, as to them shall appear necessary for the lighting of the said station.

The said Municipal Committees, and their XXIX. said surveyor and other officers, Municipal Commit-

shall cause all the public streets tees to keep town clean, remove dirt, &c. of the said stations, together with the foot pavements, or foot-

paths therein, from time to time, to be properly swept and cleansed, and all dust, dirt, soil, ashes, rubbish, and filth of every sort, which may be found thereon, to be collected and removed therefrom at convenient hours and times, and shall cause all or any of the privies, cess-pools, and drains, within the said stations, to be cleansed and emptied in a sufficient and proper manner by the owners or occupiers of the premises; and the said surveyor, or other subordinate officer of the Mu-nicipal Committees, shall give such orders and directions to the owners and occupiers aforesaid, as to the said surveyor or other officer as aforesaid, acting under the orders and control of the said Municipal Committees, shall appear proper and necessary, and the said Municipal Committees may, in their discretion, order and direct where and in what places, and how and in what manner, the dust, dirt, soil, night-soil, ashes, rubbish, and filth collected in the said stations, shall be deposited and disposed of.

XXX. The owners of any private drains in the said

Owners to prevent effluvia from drains,

stations shall, by providing proper traps or other coverings, or by ventilation, or by such other ways and means as shall be practicable

for that purpose, prevent as far as possible the effluvia of sewers and drains from exhaling from gully-holes, gratings, or any other openings whatsoever of drains or sewers, in streets or other places; and in case the owner of any private sewer or drain shall neglect or delay so to do, the surveyor of the said Municipal Committees shall give him notice to prevent as far as possible the effluvia of such sewer or drain from so exhaling, and if the same shall not be done by such owner within ten days after such notice shall have been given to him, the said surveyor shall forthwith provide and apply proper traps or other coverings, or such other means as aforesaid, so as effectually to prevent such effluvia from exhaling, and the expense incurred thereby shall be paid by the owner of such sewer or drain, to be recovered in manner hereinafter mentioned.

XXXI. If upon the representation of the surveyor

Municipal Commit-tees to issue certifi-cates, prohibiting im-proper burial places.

of the Municipal Committees, and after inquiry by such other ways and means as the Municipal Committees may think fit to direct, the said Municipal Committees

shall certify such certificate to be published in the local papers of the station, that any burial-ground situated

within the said stations is in such a state as to be dangerous to the health of persons living in the neighbourhood thereof, or that any church, or other place of public worship within the station, is dangerous to the health of persons frequenting the same, by reason of the state of the vaults or graves within the walls of, or underneath the same, and that sufficient means of interment exist within a convenient distance from such burial-ground, church, or place of public worship, it shall not be lawful, after a time to be named in such certificate, to bury, or permit or suffer to be buried, any further corpses or coffin in, within, or under the ground, church, or place of worship to which the certificate relates, except in so far as may be allowed by such certificate; and whosoever, after notice of such certificate, buries, or causes, permits, or suffers to be buried, any corpse or coffin, contrary to this enactment, shall for every such offence be liable, on conviction before a Justice of the Peace, to a penalty not exceeding five hundred Company's Rupees.

XXXII. No vault or grave shall be constructed or

No vault or burial place henceforth to be constructed without leave of Municipal Committees.

made within the walls of, or underneath any church, or other place of public worship, built in the said stations after the passing of this Act, and no burial-ground shall be made or formed within

the said stations after the passing of this Act, without the consent of the Municipal Committees first had and obtained, and whosoever shall bury, or cause, permit, or suffer to be buried, any corpse or coffin in any vault, grave, or burial-ground, constructed, made, or formed contrary to this enactment, shall, for every such offence, be liable, on conviction before a Justice of the Peace, to a penalty not exceeding Company's Rupees five hundred.

XXXIII. No writ or process shall be issued out

No writ to be sued out against them till after one month's notice, &c., action to be brought in three months. Municipal Committees may tender against, or served upon any Municipal Committees, or any collector, surveyor, or other officer, or person whomsoever, acting under the direction of the Municipal Committees, for anything done or intended to be done under the powers of this Act, until the

expiration of one month next after notice in writing shall have been delivered to him, or left at his office or place of abode, explicitly stating the cause of action, and the name and place of abode of the intended plaintiff, and of his attorney or agent in the cause; and upon trial of any such action the plaintiff shall not be permitted to go into evidence of any cause of action, except such as is stated in the notice so delivered, and unless such notice be proved, the Court shall find for the defendant; and every such action shall be brought or commenced within three calendar months next after the accrual of the cause of action, and not afterwards; and if any party shall have committed any irregularity, trespass, or other wrongful proceedings in the execution of this Act, or by virtue of any power or authority hereby given, and if before action brought in respect thereof such party shall make tender of sufficient amends to the party injured, such last mentioned party shall not recover in any such action when brought; and if no such tender shall have been made, it shall be lawful for the defendant in such action, by leave of the Court where such action shall be pending, at any time before issue joined, to pay into Court such sum of money as he shall think fit, and thereupon such proceedings shall be had as in other cases where defendants are allowed to pay money into Court.

Municipal Commit-tees and their servants not to be personally liable when act done bona fide.

XXXIV. No matter or thing done, or contract entered into, by the Municipal Committees, or any one of their Members, or by any collector, surveyor, or other officer or person whomsoever, acting under the direction of the Municipal Com-

mittees, shall, if the matter or thing were done, or the

contract were entered into bond fide, for the purpose of executing this Act, subject them or any of them personally to any action, liability, claim, or demand whatsoever, and any expense incurred by any such Municipal Committees, collector, surveyor, or other officer, or person acting as last aforesaid, shall be borne and repaid out of the funds under the control of the Municipal Committees.

Streets, drains, filth, &c., the property of Municipal Commit-tees as Trustees.

XXXV. All the streets existing within the said stations at the time of the passing of this Act, and all parts of the said stations, which hereafter be-come streets, and also the pavements, stones, and other materials

therein, and all erections, and building materials, implements, or other things provided for the said streets, by or under the authority of the Government of the Settlements, or by the Magistrates of the said stations, or by the said Municipal Committees, and also all public sewers and drains within the said stations, together with all works, materials, and things therewith connected and belonging, existing in the said stations at the time of the passing of this Act, or which shall hereafter be constructed and made therein by the said Municipal Committees, or otherwise; and also all canals, aqueducts, conduits, tunnels, water-works, cisterns, pumps, pipes, tanks, reservoirs, and wells, which now are or shall hereafter be provided, or lawfully applied to public use, and which are not the property of any private person, together with all buildings, engines, works, materials, and things therewith connected, existing in the said stations at the time of the passing of this Act, or which shall hereafter be constructed and made therein at the cost of the said Municipal Committees or otherwise; and also all lands surrounding and belonging to public tanks and slips of ground alongside of any street, drain, or aqueduct, not the property of any private person; and also all lands not legally appropriated, and also all dirt, dust, dry and liquid filth, ashes, and rubbish, to be collected from the streets, houses, privies, sewers, and cess-pools, and elsewhere within the said stations, shall be the property of, and are hereby vested in, the said Municipal Committees, as Trustees for the purposes of this Act.

Act not to exempt parties guilty of nuisauce from prosecution

or action.

XXXVI. Nothing in this Act contained shall be construed to render lawful any act or omission on the part of any person, which is, or but for this Act would be deemed and adjudged to be a nuisance at Com-

mon Law; nor to exempt any person guilty of a nuisance at Common Law from prosecution or action in respect thereof. Provided always, that if any person convicted of an offence under this Act shall have paid the whole amount adjudged to be paid under such conviction, and the costs thereof, or shall have suffered imprisonment in respect of such offence, in every such case he shall be released from all further or other criminal proceedings for the same offence.

Parties may make branch drains into public sewers, as Sur-veyor of Municipal Committees shall order. Penalty for offences against this Section.

XXXVII. It shall be lawful for any person at his own expense, to make or branch any drain into any of the sewers vested in the said Municipal Committees, or authorized to be made by virtue of this Act, or otherwise acquired by the said Municipal Committees; such

drain being made of such a size and in such a manner of communication in all respects as the said surveyor of the said Municipal Committees shall direct, and for that purpose to take up and remove, with the permission of the Municipal Committees, so much of the pavement and other materials of any street as may be required, unless the said Municipal Committees shall consent and agree, which they are hereby authorized to do, to form so much and such portion of such drain as shall lead from the point of communication in such sewer to the extremity of such street, and in case any person shall make or branch any drain into any of the said

of any premises, and also before making any sewer or drain for the purpose of draining water directly or indi-rectly from any land or tenement into any sewer under the jurisdiction of the said Municipal Committees, fourteen clear days' notice in writing shall be given to the Collector to the said Municipal Committees, by delivering the same to him, or leaving it at his office, by the person intending to build or rebuild such house, building, or wall, or to make such sewer or drain ; and every foundation of any such house, building, or wall, and the drains within the same, shall be laid at such level as the surveyor of the said Municipal Committees shall direct, and so as that no part of the said house, building, or wall shall project or encroach into or over the adjoining street, drain, or aqueduct, and so as that the said drains may be properly built with reference to the adjoining public drains, and every such branch-drain shall be made in such direction, manner, and form, and of such materials and workmanship as the said surveyor shall order; and the building or rebuilding of any such house, building, or wall, shall be under the survey and control of the said Municipal Committees, and their surveyor, so far as may be necessary to prevent any projection or encroachment in or over any street, drain, or aqueduct, and to insure that the level of the drains within such house, building, or wall shall be properly built with reference to the public drains; and in default of such notice as aforesaid, or if such building or drain shall be begun or made without, or in any respect contrary to, any order of the said surveyor, or of the provisions of this Act, it shall be lawful for the said Municipal Committees to cause such building to be demolished, and to cause such drain to be relaid, amended, destroyed, or re-made, as the case may require, and to cause the expenses thereof to be levied and repaid to them from and by the owner thereof, in manner hereinafter provided.

XL. Every person, upon conviction before any Justice of the Peace, on the testi-Ponalties for certain mony of one or more credible offences in the streets. witnesses, shall be liable to a penalty of not more than fifty rupees, or in default of payment thereof, to imprisonment, with or without hard labour, for any term not exceeding one month, who, within the limits of the said stations, shall commit any one of the following offences (that is to say):

Every person who shall throw or put, or cause, or order, or allow his servants to For throwing dirt, throw or put, or from whose pre-mises shall be thrown or put, any dirt, dung, mud, dust, ashes, garden or stable refuse, or rubbish of any kind, or the carcase of any dog or other animal, or any flesh or other part of an animal, or any animal matter, upon any of the public streets, except between the hours of midnight and seven in the morn-

Every person who shall throw or put, or cause or allow to be thrown or put, or For throwing bottles, from whose premises shall be glass, &c. thrown or put, any broken bottles, glass, china or crockery-ware, upon or into any street, drain, or aqueduct.

3. Every person who shall keep, or allow to be kept, for more than twenty-four hours, For keeping dirt, any dirt, dung, mud, dust, bones, &c. in houses. ashes, night-soil, or other rubbish of a perishable and noisome kind, in or upon any house, out-house, yard, or ground occupied by him.

4. Every person, being the owner or occupier of any private tatty, drain, sewer, For neglecting to cess-pool, tannery, or other receptacle of filth, who shall neglect or keep drains, &c. clean. refuse to keep the same in a clean and proper state, or to employ proper means to remove any noisome smell, or the filth therefrom, or who shall expose the contents of such privy to the view of the passers by in the street.

5. Every person, being the owner or occupier of any house, hut, building, or lands, For allowing house or ground to be in a filthy or unwholesome whether tenantable or otherwise, who shall suffer the same to be in a filthy and unwholesome state, or overgrown with rank and

noisome vegetation.

6. Every person who shall cause or allow the water of any sink, sewer, or drain, or For allowing offenother offensive liquid matter, besive liquids to drain inlonging to him, or running through, to tanks or water works. or being on his land, to run, drain,

or be carried into or upon any of the streets, tanks, aqueducts, or reservoirs, belonging to the Municipal Committees, or who shall commit or cause any act whatsoever whereby the water provided for the domestic use of the inhabitants of the stations shall be in any way fouled or corrupted, or who shall throw or put, or cause, or order, or allow his servants to throw or put, or from whose premises shall be thrown or put, any dirt, dung, mud, dust, ashes, night-soil, garden or stable refuse, or other rubbish, into any of the public sewers or drains, or into any reservoirs, tanks, aqueducts, or other water-works belonging to the Municipal Committees.

7. Every person who shall have or keep any common tatty, privy, or urinal, on any ground owned or occupied by For keeping common privy without license. him within the said stations, without a license first had from the Municipal Committees, who are hereby authorized to grant the same under the hand of their Collector; such license shall be granted for one year, and shall be renewed or not every year, according to the discretion of the Municipal Committees.

8. Every person, being the owner or farmer of any licensed tatty, privy, or urinal, within the said stations, who shall For keeping common privies filthy. suffer such tatty, privy, or urinal to be kept in a filthy and unclean state, or shall neglect to employ proper means for cleaning and regulating it.

9. Every person who shall wantonly or willfully destroy, injure, or deface any of For destroying lamps the lamps or lamp posts in the or street-boards, &c. said streets, or extinguish any

light therein, or abstract or take away from any of the said lamps any oil, or other matter or thing therein, or any part thereof, without the order of the said Municipal Committees, or of their said surveyor, or who shall wantonly or wilfully destroy, injure, or deface any board bearing on it the name of any street, or the number of any building or land within the said stations, or any notice of the said Municipal Committees fixed or posted up in any place.

10. Every person who shall displace, take up, or For injuring streets, taking up pavements, see.

streets, except between the hours of midnight and eight in the morning, or who shall carry, or cause to be carried, any night-soil, or urine, in such manner that any offensive smell or drainings issue therefrom, or who shall place or set down in any public place any vessel containing night-soil or urine, or who shall carry, or cause the same to be carried, in any other than covered carts or vessels, or who shall throw or deposit any night-soil in or upon any street.

For bathing in a public street, or upon, or in any public street, or upon, or in any of the tanks, reservoirs, aqueducts, water-works, or drains, belonging to the Municipal Committees, except in such of the said tanks, reservoirs; aqueducts, water-works, or drains, as the Municipal Committees shall set apart for that purpose.

14. Every person, who shall wash or cause to be washed any horse, dog, or other animals, &c., in tanks, aqueducts, &c.

on any street, in or near any tanks, reservoirs, aqueducts, water-works, or drains, belonging to the Muuicipal Committees, or on or in the road adjoining thereto, except in such of the said tanks, reservoirs, aqueducts, water-works, or drains as the said Municipal Committees shall set apart for that purpose.

house, hut, or building to flow or be carried through pipes, gutters, water-spouts, or other means on any part of any public street, or on any place but his own land, or the public drain, or who shall refuse or neglect to remove or alter the direction of any such pipe, gutter, or water-spout, after the expiration of ten days' notice for that purpose given by the surveyor of the said Municipal Committees; and any person, being the owner or occupier of any house, hut, or building in the said stations, which has not a drain on the same side of the street as such house, hut, or building, who shall convey the water from the said house, hut, or building in or upon any public street through pipes or waterspouts, the mouths of which shall be higher than two feet from the ground.

For projections over streets.

Any house, hut, or building, who shall cause or allow any verandah, balcony, sun-shade, or other part of any house, hut, or building, to overhang and project into any public street or public place, at a height of less than eleven feet from the level of the road-way, or to a distance exceeding four feet from the house, and who shall refuse or neglect to take down and remove such verandah, balcony, sun-shade, or other projection after the expiration of fifteen days' notice for that purpose given by the surveyor.

18. Every person who shall, after the passing of this Act, erect or set up any verstreets after passing of this Act, erect or set up any verandah, balcony, sun-shade, or other projection of any kind which may overhang and project into the road at any height, and to any distance, without license first obtained from the Municipal Committees, under the hand of their surveyor.

20. Every person who shall place, set up, or build in any public street within the stations any board, scaffolding, post, bar, rail, boards, or other thing by way of inclosure for

Every person who shall have been allowed by the Municipal Committees to set up any scaffolding, or deposit any bricks, stone, lime, sand, or other building materials on the public streets, and who shall not cause a light to be set up every night from sunset to sunrise on every such erection or obstruction.

22. Every person who shall build any wall or erect any fence or obstruction, or set up any post, so as to be an obstruction in streets, whether proprietor's right be in dispute or not.

23. Every person who shall set out, place, or expose, or cause to be set out, placed, or exposed in such public streets, &c. exposed, whether for sale or otherwise, any stall, booth, show board, basket, cask, or meat, fish, vegetable, fruit, groceries, or any other merchandize, or goods

of any kind, or any stone, bricks, carthen-ware, hardware, timber, or any other thing whatsoever, whether animal, vegetable, or mineral, in or upon any of the public streets, or on or over any drain, sewer, or aqueduct.

For sifting or cleansing grain, public streets. Sec.

24. Every person who shall sift or clean, or cause to be sifted or cleansed, or exposed for any other purpose any cotton, grain, seeds, rice, coffee, onions,

be levied by distress and sale of the goods and chattels of the party liable to pay the same, and the overplus arising from such goods and chattels, after satisfying such sum of money and the expenses of the distress and sale, shall be returned on demand to the party whose goods shall have been distrained; or instead of proceeding by distress and sale, or in case of failure to realize by distress the whole or any part of any penalties, forfeitures, or expenses imposed or incurred under the provisions of this Act, the Municipal Committees, or any one or more of their Members, if they think fit, may authorize their collector or other person to sue the person liable to pay such penalty, forfeiture, or expenses, or any part thereof, in the Court of Requests, and the costs, if any, incurred in any such suit, which are not recovered in the suit, may be defrayed out of the taxes levied under the provisions of Act

LVI. No distress levied by virtue of this Act shall be deemed unlawful, nor shall any party making the same be deemed a trespasser, on account of any defect or want of form in the summons, conviction, warrant of distress, or other proceeding relating thereto, nor shall any such party be deemed a trespasser ab initio on account of any irregularity afterwards committed by him; but all persons aggrieved by such defect or irregularity may recover full satisfaction for the special damage in an action on the case in Her Majesty's said Court of Judicature, or in the Court of Requests.

LVII. The Justice of the Peace by whom any such penalty or forfeiture shall be imposed, may, when the application thereof is not otherwise provided for, award not more than one-half thereof, or any less sum to the informer, if he shall think fit so to do, and shall award the remainder, or the whole thereof, to the said Municipal Committees, to be by them applied to the purposes of this Act as to them shall appear fit, and shall order the same to be paid over to the collector of the said Municipal Committees for that purpose, whose receipt shall be a good and sufficient discharge to the person so paying the same.

LYIII. If through any act, neglect, or default, on account whereof any person shall have incurred any penalty imposed by this Act, any damage to the property of the said Municipal Committees shall have been com-

mitted by such person, he shall be liable to make good such damage, as well as to pay such penalty, and if the amount of such damage shall not be paid on demand, the same may be recovered by action of debt, or on the case, in the said Court of Requests, or in Her Majesty's said Court of Judicature.

LIX. It shall be lawful for any Justice of the Peace to summon any person to appear before him as a witness in any matter in which such Justice matter in which such Justice shall have jurisdiction under the provisions of this Act, at a time and place to be mentioned in such summons, and require from him, on oath

or solemn affirmation, that he will testify the truth in such matter; and if any person so summoned shall without reasonable cause refuse or neglect to appear at the time and place appointed for that purpose, having been paid or tendered a reasonable sum for his expenses, if from distance or any other cause he shall be lawfully entitled to claim such expenses, or if any person appearing shall refuse to be examined on his oath or solemn affirmation, according to law, or to give evidence before such Justice, every such person shall, for every such offence, forfeit and pay a sum not exceeding two hundred rupees, or at the discretion of such Justice, shall be imprisoned for any term not exceeding one month.

LX. The following words and expressions in this Act shall have the several meanings hereby assigned to them, unless there be something in the Meaning of words in subject or context repugnant to such construction (that is to say): words importing the singular number shall include the plural number, and words importing the plural number shall include the singular number; words importing the masculine gender only shall include females; the word "person" shall include corporations, whether aggregate or sole; the words "oath," "affirmation," and "solemn affirmation," when used alone, shall include oath or affirmation, or other declaration lawfully substituted for an oath in such case by any Legislative Act of the Governor General of India in Council, or by any Act of the Parliment of the United Kingdom of Great Britain and Ireland extended to India; the word "street" shall include any public square, circus, street, court, alley, foot-path, highway, lane, road, thoroughfare, public passage, or other public place within the said stations; the word "lands" shall include messuages, buildings, walls, tenements, and hereditaments of any tenure, as well as lands; the words the "said Municipal Committees," shall mean the Municipal Committees for the time being appointed or acting under the provisions of Act No. of 1853, and the word "month" shall mean calendar month.

The following Extract from the Proceedings of the Governor General of India in Council, in the Legislative Branch of the Home Department, under date the 10th June 1853, is published for general information.

Read a second time the Draft of a proposed Act, dated the 5th November 1852, and published in the Calcutta Gazette of the 10th November 1852, for the amendment of Procedure in Cases of Appeal to the Sudder Courts in the Presidency of Fort William in Bengal.

Resolution.—The Governor General in Council resolves that the following revised Draft on the subject be published for general information:—

ACT No. - of 1853.

An Act for the amendment of Procedure in Cases of Appeal to the Sudder Courts in the Presidency of Fort William in Bengal.

Whereas it is desirable to simplify and shorten the procedure and modes of pleading in regular appeals to the Courts of Sudder Dewanny Adawlut in the said Presidency; it is enacted as follows:

I. Act IV. 1850, and Sections II. III. and IV.,

Act XXX. 1850, are hereby repealed, except as to appeals presented before the passing of this Act.

II. Every petition of regular appeal in a case appealable to the Sudder Court shall be presented to the Court in which the decision was passed within six weeks from the day of the decision; unless the Sudder Court shall, upon sufficient cause shown, extend the time for presenting such appeal. Such petition of appeal shall contain only notice that the party, being dissatisfied with the judgment, is desirous of appealing from it, except in cases of petitions under Section XIII. of this Act.

III. On presentation of a petition of regular appeal to the Court in which the decision was passed, notice thereof to the respondent, as well as a proclamation to the same effect, shall immediately issue from that Court. If the notice cannot be personally served, the proclamation shall at once be fixed upon the door of the respondent's dwelling-house, or in some conspicuous place in the village where he usually resides; or in cases in which the respondent may not have a fixed residence within the jurisdiction of the Company's Courts, the proclamation may be fixed upon the door of his house of business or cutcherry, or the notice may be served on his known local agent. In case the proclamation cannot be fixed or served in the manner above mentioned, it shall be affixed in the Court-house of the said last mentioned Court, and also in such other place, if any, as the said last mentioned Court shall direct. The Nazir shall return the order of notice or proclamation with an endorsement, stating at what times and places it may have been served or fixed up. The return of the Nazir is to be filed in Court, and to form a part of the record of the trial.

IV. The Rule in Section XI. Regulation VI. 1793, which directs copies of all original papers transmitted to the Sudder Dewanny Adawlut with the record of an appealed case to be made out and deposited in the Court in lieu of the originals, is hereby modified, and it shall be necessary to copy only the exhibits and any papers of importance which either of the parties may specify, including the pleadings, or any parts of them which may be desired by either of the parties.

V. The appeal record shall be certified to the Sudder Dewanny Adawlut as soon as conveniently may be

after the presentation of the petition of appeal.

VI. On arrival of the appeal record at the Sudder Court, notice shall be affixed in the Court-house of the Sudder Dewanny Adawlut, or given in such form and manner as that Court shall order by a Rule to be framed under Section II. Act XVII. 1841, requiring the appellant to file, within four weeks from the date thereof, his grounds of objection to the decision of the Court below. Within the said space of four weeks the appellant shall file in the Court of Sudder Dewanny Adawlut his grounds of objection to the decision. Such grounds of objection shall be stated distinctly and concisely, without any argument or narrative of facts; they shall be numbered consecutively, and shall be on paper bearing the stamp duty prescribed by Article 9, Schedule B, Regulation X. 1829. On failure to file the grounds of objection within the said space of four weeks, the appeal shall be dismissed, unless the appellant shall show reasonable cause to the satisfaction of the Court for his default, in which case the Court may allow him to file his grounds of objection within such further time as the Court may order. A separate paper, containing detailed reasons in support of the grounds of objection, may, at the option of the appellant, be filed on plain paper within the said period of four weeks, or such further time, if any, as may be allowed by the Court for filing the grounds of objection.

VII. On the filing of the grounds of objection by the appellant, notice shall be given to the respondent, in the manner prescribed by the preceding Section of this Act, requiring him to file his grounds of objection, if any, to the decision within four weeks from the date of such notice; and any grounds of objection to the decision, whether involved in the appeal or in the objection.

tions filed by the appellant, or not, may be filed by the respondent within the said space of four weeks, or within such further time as the Sudder Court may allow for that purpose, upon reasonable cause shown to the satisfaction of the Court for such extension of time.

VIII. At the expiration of such last mentioned space of four weeks, or of such extended time as may be allowed by the Court as last aforesaid, the record shall be considered complete, and the case ready for hearing. The grounds of objection, if any, which shall be filed by the respondent, shall be stated distinctly and concisely, without any argument or narrative of facts; they shall be numbered consecutively, and shall be on paper bearing the stamp duty prescribed by Article 9, Schedule B, Regulation X. 1829.

IX. If any of the grounds of objection filed by the respondent shall not be involved in the appeal, on the grounds filed by the appellant, but would be the ground of a separate petition of appeal by the respondent, such grounds of objection shall be on paper bearing, in addition to the stamp above named, the stamp which would have been required on a separate petition of appeal filed by the respondent, unless the respondent shall have presented a separate petition of appeal in the case; Provided that, if the suit in appeal be referred back for further investigation and decision, without a judgment on the merits of the case, the last mentioned stamp duty paid by the respondent shall be returned to him in the same manner as if such stamp duty had been paid on a separate petition of appeal.

X. A separate paper, containing detailed reasons in support of the grounds of appeal filed by the respondent, or in answer to the detailed reasons, if any, filed by the appellant, may, at the option of the respondent, be filed on plain paper within the period of four weeks allowed for filing the respondent's objections, or within such further time as may be allowed by the Court for

filing such objections.

XI. Either party may, by leave of the Sudder Court or any Judge thereof at any time before the hearing, amend his grounds of appeal, or add grounds of appeal to those filed, upon such terms and conditions, and within such time as the said Court or Judge may order. The said Court may also, upon the hearing of any appeal, allow either party to amend his grounds of objection, or to add further grounds, or to urge and be heard by himself or his vakeel, in support of any objection to the decision not included in his grounds of objection, upon such terms and conditions as to postponement of the cause, and as to the payment of costs or otherwise, as the Court may think just, to prevent the opposite party or his vakeel from being taken by surprise or otherwise. Without such leave of the Court, neither party shall be allowed to urge or be heard in support of any objection not included in his grounds of objection filed. But the Court shall not be confined to such grounds of objection on deciding the cause.

XII. If the grounds of objection filed by the appellant and respondent shall be upon points of law only, and shall not raise any question of fact, the Sudder Court, upon application on behalf of either party, may fix a day for the hearing and decision of the appeal, without regard to the place in which it may stand in the general list of appeals pending in the Court.

XIII. Appeals by paupers shall be preferred in all respects as heretofore; except that the distinct grounds of objection to the decision of the Court below shall be stated in the manner above mentioned, and written on plain paper, and presented within four weeks from the date of permission to appeal as a pauper. If detailed reasons for preferring the appeal be also presented, they shall be presented within the same four weeks.

XIV. If an appeal be preferred upon points of law only, without disputing any of the facts found by the judgment of the Lower Court, the appellant may give notice of his intention to appeal upon points of law only,

without specifying the points in his petition, and such notice shall bar him from any appeal upon the facts. If the appellant, in an appeal under this Section, shall intend to appeal against the construction put upon any document in the Court below, he shall give notice of such intention in his petition of appeal, in order that the document may be forwarded to the Sudder Dewanny Adawlut, and unless such notice be given, the appellant shall not be at liberty to controvert the legal construction put upon such document in the Court below. tion put upon such document in the Court below. The petition of appeal, however, shall merely give notice of the intention, but need not specify the objections to the construction put upon the document. An appeal under this Section shall be especially certified to the Sudder Dewanny Adawlut as an appeal of law only. In such appeal it shall not be necessary to forward to the Sudder Dewanny Adawlut any part of the record in the Lower Court, except the decree of the Court and the Nazir's return to the order for notice or proclamation of appeal, and any document of which the appellant may, in his petition of appeal, give notice of his intention to dispute the legal construction as above mentioned. In cases under this Section the respondent shall be bound to make appearance in the Sudder Dewanny Adawlut within six weeks from the serving of notice, or the affixing of the proclamation of appeal in the manner provided by Section III. of this Act. At the expiration of the said space of six weeks, the Sudder Dewanny Adawlut shall fix such day as it may deem proper for the hearing and decision of the appeal upon objections of law to be laid before it, without regard to the place in which it may stand in the general list of appeals pending in the Court, and the Court shall also fix a day for the parties to bring in and file their grounds of objection.

XV. If upon an appeal preferred upon points of law only, the respondent shall file grounds of objection, raising any question of fact, the Court may hear the appeal upon the questions of law, in the first instance, in the manner pointed out in the last preceding Section; and if their decision of the case upon points of law shall render it necessary to determine the objections on matters of fact, they shall send for the remainder of the record, and the case shall be set down for hearing in the list of regular appeals for decision upon objections on matters of fact, and shall be determined upon such objections, in the same manner as any other regular

appeal.

Upon the hearing of any appeal, the Court shall give judgment according to the justice of the case, without regard to any technical error or defect which does not affect the merits.

XVII. This Act extends only to the Presidency of

The following Draft of a proposed Act was read in Council for the first time on the 10th of June 1853:—

ACT No. or 1853.

An Act for amending the Law of Special Appeals.

Act No. III. of 1843 is hereby repealed, except as to cases in which a petition for appeal shall have been presented before the time fixed for the commence-

II. If any application for a special appeal shall have heen presented before the time fixed for the commence-ment of this Act, and no order shall have been passed thereon before the time so fixed, such application shall be heard and determined in the same manner as an

appeal presented under this Act; and all the provisions of this Act shall extend to such application and to the hearing thereof, and to all subsequent proceedings thereon; and also to the hearing and determination of the appeal if the same shall be admitted.

If any such application shall have been presented, and the appeal admitted before the time so fixed as above mentioned, the appeal shall be heard and determined according to the provisions of the said Act No.

III. of 1843, except only that the Court of Sudder
Dewanny Adawlut, or the Court of Sudder Adawlut, as the case may be, shall determine the appeal without reference to the points certified, and may call for or refer to any part of the proceedings which may be necessary.

IV. A special appeal shall lie to the Courts of Sudder Dewanny Adawlut at Calcutta, Agra, and Bombay, respectively, and to the Court of Sudder Adawlut at Madras, from any decision passed on regular appeal in any of the Civil Courts subordinate to the said Sudder Courts, respectively, on any of the following

grounds, namely :-

1st. On the ground that the decision hath failed to determine all matters in difference in the cause, or hath determined the same or any of them contrary to law or usage having the force of law.

2nd. On the ground of a misconstruction of any document.

3rd. On the ground of any ambiguity in the decision in a matter important to a determination of the matters in difference in the cause, upon the merits.

4th. On the ground of any substantial error or defect in procedure, or in the investigation of the case, provided such error or defect be apparent on the record, and shall have produced, or be likely to have produced, any error or defect in the decision of the case upon the merits. Provided always, that no such special appeal shall lie, nor shall any such decision be reversed, altered, or remanded by any of the said Sudder Courts, upon the ground that the decision of any question of fact is contrary to or not warranted by the evidence in the cause, or any probability deduced from the record.

V. A special appeal shall not be admitted unless a petition be presented to the pro-per Sudder Court within three Time for appeal and documents required. months from the date of the decision appealed against, or unless the petitioner can show just and reasonable cause to the satisfaction of the said Sudder Court for not having presented it within such limited period, and every such petition shall be accompanied by copies of the several decrees previously passed in the case.

VI. Every petition for a special appeal shall set forth concisely and under distinct Petition of special heads the particular grounds on which the application is made.

VII. The said Sudder Courts shall cause lists of the petitions which shall be present-ed for the admission of special Notice of appeal.

appeals to be prepared weekly, and to be affixed in the Court-houses of the said Sudder Courts, respectively. The said lists shall set forth the dates on which such petitions are likely to be brought on for hearing, and the said Sudder Courts shall cause extracts from the said lists to be transmitted to the Courts in which the decisions on regular appeal were passed; such extracts shall be affixed in some conspicuous place in the last mentioned Courts, and extracts therefrom shall be transmitted by such Courts to the Courts in which the original suits were instituted, and such last mentioned extracts shall be affixed in some conspicuous place in the said last mentioned Courts.

The time to be fixed by the Sudder Court for the hearing of any petition shall not be-less than six weeks from the date of despatch of the extracts referring to the same from the Sudder Court.

VIII. It shall be lawful for the said Sudder Courts,

Court may order amendment, or may admit or reject special appeal, or may refer it to lower Court for information or explana-

or any one or more of the Judges thereof, respectively, to hear applications for special appeals, duly presented as aforesaid, in the presence of the special appellant, or his vakeel, and also of the respondent or his vakeel, or such of

them as shall attend, and it shall be competent for the said Court, or for such Judge or Judges thereof, to call for and peruse any document forming a part of the record of the cause; or to order the amendment of the petition of special appeal forthwith, or within such time as they or he may order, not exceeding one month from the date of such order ; or to make an order of reference to the Court which pronounced the decree appealed from for further information or explanation; or to reject or admit such special appeal; or if it shall appear that the facts have not been sufficiently recorded, or that the case is otherwise so insufficient that the Sudder Court could not, if the appeal were admitted, pass a final decree thereon, to issue an injunction, setting forth the errors, irregularity, or other defects in the decision appealed against, and remanding the same to the Court by which the same shall have been passed, in order that such decision may be reviewed by the last mentioned Court, and such order or decree passed thereon as may be conformable to law. Provided always, that no such remand shall be ordered as aforesaid, except upon grounds whereon a special appeal will lie under this Act. If any such application shall be heard by only two Judges, and they differ in opinion as to adiniting the appeal, it shall be admitted.

IX. When any petition for a special appeal shall be rejected as aforesaid, the order

Order for rejecting special appeal to state reasons, and may be reviewed.

shall state the reason for disallowing each of the grounds set forth in such petition, and every such order of rejection may be once

reviewed by the same Judge or Judges of the said Sudder Courts, respectively, or by any Judge or Judges sitting for or instead of him or them, if they or he shall think fit to review the same. Provided, that no such review shall be allowed unless application for the same be made within three months from the date of such order.

How special appeal, when admitted, to be

X. When any special appeal shall be admitted, the same shall be heard and determined by the said Sudder Courts, or any three or more of the Judges thereof, and such hearing and

determination shall be upon all the grounds whereon a special appeal will lie under this Act.
XI. The existing Laws and Regulations of the Pre-

sidencies of Bengal, Madras, and Former laws unre-Bombay, relating to special appeals, shall continue in force, so pealed, to be in force. far as they are not inconsistent with, or repealed by, this Act.

XII. This Act shall commence and take effect from Commencement of and after the day of 1853.
