## Legislative Council of India.

18th June 1859.

The following Act, passed by the Legislative Council of India, received the assent of the Right Honorable the Governor General this day, and is hereby promulgated for general information :---

ACT No. XVI. OF 1859.

An Act to Explain Act. XXX. of 1858 (to Provide for the Administration of the Estate and for the Payment of the Debts of the late Nabob of the Carnatic).

Whereas doubts have arisen whether certain debts contracted by Prince Azeem Preamble

Bahadoor during the Jah infancy of the late Nabob of the Carnatic were debts or claims within the meaning of Section-XIV. or any subsequent Section of Act XXX. of 1858; and whereas it is expedient to remove such doubts, as well as other doubts which exist as to the power of the Supreme Court of Judicature at Madras to award costs in investigations under Section XXII. of the said Act, and as to whether cases so investigated are appealable to Her Majesty in Council; It is declared .and enacted as follows :

No debt contracted by the said Prince Azcem I.

Jah Bahadoor during the minority of the said late Debts contracted by Prince Azeem Jah Bahadoor during the minority of the Nabob. Nabob shall be deemed a

meaning of the said Section XIV. or any subsequent Section of the said Act, unless it shall be proved that it was necessary and proper that such debt should be incurred on behalf or for the use of the said Nabob, and that the same was so contracted ; or unless the Governor in Council of Fort Saint George shall dispense with such proof.

II. Upon any investigation under Section XXII. of the said Act, it shall be lawful for the Court, except Power to award costs. as otherwise provided by the said Act, to award costs to either party and to cause the same to be levied in the same manner as costs in an ordinary suit.

111. It is hereby declared that it was not the intention of the said Act to Appeal to the Queen in Council. exclude from appeal to Her in Council, any Majesty

awards orders or decisions of the said Supreme Court, made upon any investigation under Section XXII. as aforesaid.

## Legislative Council of India. 18th June 1859.

The following Bill was read a second time in the Legislative Council of India, on the 18th June 1859, and was referred to a Select Committee, who are to report thereon after the 22nd of August next :-

A Bill to empower Sessions Judges to pass Sentence in certain Cases without Reference to the Sudder Court.

Whereas it is expedient to empower Sessions Judges in the Presidency of Fort Preamble.

William in Bengal to pass sentence in certain trials without reference to Nizamut Adawlut; and whereas it is likewise expedient to remove the restriction now imposed by law upon Sessions Judges in regard to the minimum of punishment which they are competent to inflict in cases of perjury, and certain cases of forgery described in Clause 2, Section IX. Regulation XVII. 1817 : It is enacted as follows :

Clause 3, Section VI. and Clause 3, Section IX. I. Regulation XVII. 1817 of the Bengal Code are hereby Laws repealed and mo-

dified. repealed ; and Section IX. of the same Regulation, and Section IV. Regulation VI.

1832 of the same Code, are hereby modified.

Sentence by Sessions Judge in case of conviction of rape.

II. When a person is convicted of the crime of rape, if the circumstances of the case shall not appear to call for a more severe punish-

ment than imprisonment for seven years with labor in irons, the Sessions Judge before whom the trial is held shall himself pass sentence.

III. Sentence by Sessions Judge in case of conviction of a crime declared by the Sud-der Court to be a penal offence.

When a person is convicted in a trial held under the provisions of Re-gulation VI. 1832, of a crime declared by a precedent of the Nizamut Adawlut to be a penal offence, if the

circumstances of the case shall not appear to call for a more severe punishment than seven years' imprisonment with labor in irons, the Sessions Judge before whom the trial is held shall himself pass sentence. If, however, the crime of which the person has been convicted has not been declared to be a penal offence by a precedent of the Nizamut Adawlut, the Sessions Judge shall not proceed to pass sentence, but shall refer the case for the consideration of the Nizamut Adawlut, stating at length in the proceedings the opinion of the punchayer, assessors, or jury, and his own opinion, as to the crime proved, and the nature and extent of the punishment which should be awarded.

Sentence by Sessions Judge in case of conviction of perjury or forgery.

IV. When a person is convicted of the crime of perjury or subornation of perjury or of forgery or of procuring forgery, as defined

and made punishable by Re-gulations II. 1807 and XVII. 1817 of the Bengal Code, the Sessions Judge shall pass such sentence on the offender as he may consider adequate to the offence in reference to the particular circumstances of the case; provided that he shall in no case exceed the limit of the powers vested in him by Clause 2, Section IX. of the Regulation last mentioned.

V. If in any case coming under the provisions of this Act, the Sessions Judge

shall consider the sentence

a case to the Sudder Court. which he is empowered to pass inndequate to the guilt of the prisoner, he shall refer the case, with his sentiments for the sentence of the Nizamut Adawlut in conformity to Section VI. Act XXXI. of 1841, which is hereby declared applicable to such cases.

### Legislative Council of Endia.

#### 18th June 1859.

The following Bill was read a second time in the Legislative Council of India, on the 18th June 1859, and was referred to a Select Committee, who are to report thereon after the 22nd of September next :-

A Bill to Amend Act XXII. of 1855 (for the Regula-tion of Ports and Port Dues).

Whereas it is expedient that Port-dues, fees, and charges, leviable under Sec-tion XLIX. of Act XXII. of Preamble.

1855, shall be recoverable by the Collector of Customs, or other Officer authorised to collect such Port dues, fees, and charges, in any Port, other than the Port in which any such dues, fees, or charges may, under the said Act, have become due : It is enacted as follows :-I. If the Master of any Vessel in respect of which

Port dues, &c. payable in one Port, recoverable by Collector at any other Port.

any Port dues, fees, or char-ges shall be payable under the said Act, shall cause such Vessel to leave any Port with-

out having discharged such dues, fees, or charges, it shall be lawful for the Collector of Customs, or other Officer authorised to collect the same, to require, in writing, the Collector of Customs or other Officer as aforesaid, in any other Port to which such Vessel may proceed, or in which she may be, to levy such dues, fees, or charges; and every Collector or other Officer as aforesaid shall, on receipt of such requisition, proceed to levy such dues, fees, or charges in the manuer pre-

scribed in Section XLIX. of the said Act; and a certi-ficate purporting to be made and signed by the Collector of Customs or other Officer as aforesaid of the . Port where the Port dues, fees, or charges became payable, stating the amount so payable, shall be sufficient primd facie proof of such amount in any proceeding under the said Section, and also (in case the amount payable is disputed) in any subsequent proceeding under Section BIX. of the said Act.

Penalty for evading pay-ment of Port dues, &c.

II. If the Master of any such Vessel shall evade the payment of any Port dues, fees, or charges payable under the said Act, he shall be

liable, on conviction, to a penalty not exceeding five times the amount so payable. In any proceeding before a Magistrate for the adjudication of the said penalty, any such certificate as is mentioned in Section I. of this Act, stating that the Master has evaded such payment, shall be sufficient prima facie proof of the evasion, unless the Master shall show, to the satisfaction of the Magistrate, that the departure of the Vessel without having discharged the dues, fees, or charges payable was caused by stress of weather, or that there was lawful or reasonable ground for such departure.

III. This Act shall be read with, and taken as a part of, the said Act XXII. of Construction of Act.

1855, save that, any Magistrate having jurisdiction under the said Act in any Port, River, or Channel to which the Vessel may proceed, or in which she may be found, shall be deemed to have jurisdiction in any proceeding under this Act.

### Legislative Council of India.

A Bill for Regulating Public Conveyances in the Towns of Calcutta, Madras, and Bombay, and the several Stations of the Settlement of Prince of Wales' Island, Singapore, and Malacca.

Whereas it is expedient to regulate certain Public Conveyances in the Towns Preamble. of Calcutta, Madras, and Bombay, and the several Stations of the Settlement of Prince of Wales' Island, Singapore, and Malacca ; It is enacted as follows :-

Act IV. of 1841 (for Regulating Public Con-

veyances in the Islands of

Law repealed. Bombay and Colaba, and the Harbour of Bombay), and Sections LXXVIII., LXXIX. and LXXX. of Act XIII. of 1856 (for Regulating the Police of the Towns of Calcutta, Madras, and Bombay, and the several Stations of the Settlement of Prince of Wales' Island, Singapore, and Malacca), are hereby repealed, except as to any act or offence done or committed before this Act shall come into operation.

II. Every wheeled Carriage, whatever may be its form or construction, used Carriages to be registered.

Carriages to be registered. In standing or plying in any public street or road within any of the said Towns and Stations for the purpose of carrying persons for hire; and every wheeled Carriage, whatever may be its form or construction, which may be hired for such purpose for any time less than a day, or for a certain distauce, or by the job, although such Carriage does not ordinarily stand or ply for hire in any public street or road, shall be registered in the Office of the Commissioner of Police.

Form of Register.

I.

III. The following p articulars shall be entered in the Register :-

1st .- The number assigned to the Carriage in the Register ; such number to be, from time to time, assigned by the Commissioner of Police.

2nd.-The name and residence of the Owner of the Carriage.

3rd .- The number of persons the Carriage is permitted to carry.

The registration shall be made, and the numbers assigned, annually upon such day in each year as the Commissioner of Police shall appoint. Any person becoming possessed within the year of any such Carriage which has not been registered, may obtain registration on application at the Office of the Commissioner of Police. When any registered Carriage is transferred within the year, it shall be registered anew in the name of the person to whom it has been transferred. A fee of one Rupee shall be paid for such registration.

IV. Whoever keeps any Carriage required by this Act to be registered, without

Penalty for not registering. Penalty for not registering. being so registered, shall be liable to a fine not exceeding one hundred Rupees. Any Police Officer of the Town or Station where the Carriage may be, may seize any such Carriage (provided the same be not employed at the time of seizure in the conveyance of passengers), together with the horses or other animals drawing the same. If the Carriage, as aforesaid, be not claimed, or if the fine be not paid within ten days, such Carriage, together with the animals seized with it, may be sold by auction, and the proceeds applied to the payment of the fine, and all costs and charges incurred on account of the detention and sale, and the surplus (if any), if not claimed by the owner within a further period of twenty days, shall be forfeited to the State.

V. The owner of every Carriage registered under Baristry Plate this Act shall cause to be Registry Plate.

affixed, on some conspicuous place on the outside of the Carriage, a plate distinctly showing the registered number of the Carriage, and the number of passengers permitted to be carried.

VI. The owner of any Carriage required by this Act to be registered, having Penalty.

a plate affixed to his Carre without having registered the Carriage under this Act, or having a plate resembling the plates issued by the Commissioner of Police affixed to his Carriage, shall be liable to a fine of fifty Rupees.

VII. The Commissioner of Police may refuse to register any Carriage under Registry may be refused or this Act, or may cancel the cancelled. registration thereof whenever

it may appear to him that such Carriage, or any Horse or Harness used with any such Carriage, is unserviceable or unsafe, or otherwise unfit for public accommodation or use.

VIII. The rates or fares, as well for time as distance,

to be paid for Carriages ply-Fares how to be fixed. ing for hire in the public

streets in the said Towns and Stations, shall be fixed in the manner following :-

In the Towns of Calcutta and Madras such rates or fares shall, from time to time, be fixed by the Commissioner of Police, with the sanction of the local Government.

In the Town of Bombay such rates or fares shall, from time to time, be fixed by the Court of Petty Sessions, with the sanction of the local Government.

In the several Stations of the Straits' Settlement such rates or fares shall, from time to time, be fixed by the Quarter Sessions of the Station, with the sanction of the Governor.

The rates so fixed shall be published four times in the Government Gazette, and in such of the public Newspapers as shall be directed by the Commissioner of Police.

IX. The Commissioner of Police shall, from time to

X. Any driver of a Carriage registered under this

Act standing at any of the Stands for Carriages appointed by the Commissioner of Police, or plying for hire in the public streets, who re-

fuses or neglects, without reasonable excuse, to drive such Carriage to any place within the Town or Station where such Carriage may be, to which he is directed to drive by the person hiring or wishing to hire such Carriage, shall be liable to a fine not exceeding twenty Rupees.

XI. The driver of any Carriage registered under

Penalty for furious driving, damage by carelessness, wilful misbehaviour, drunkenness, and insolence.

this Act, who shall be guilty of wanton or furious driving, or cause hurt or damage by carelessness or wilful misbehaviour, or who shall be

drunk during his employment, or make use of insulting or abusive language or gesture, or otherwise misbehave, shall be liable to a fine not exceeding twenty Rupees, and, in case of hurt or damage, the Magistrate may order a sum not exceeding fifty Rupees to be paid by the proprietors of such Carriage, as compensation for the hurt or damage.

XII. Any driver of a Carriage registered under this

Driver causing obstruction in street.

Act, who suffers the same to stand for hire across any street or alongside of any

other Carriage, or who refuses to give way, if he conveniently can, to any other Carriage, or who obstructs or hinders the driver of any other Carriage in taking up or setting down any person into or from such other Carriage, or who wrongfully, in a forcible manner, prevents or endeavours to prevent the driver of any other Carriage from being hired, shall be liable to a fine not exceeding twenty Rupees.

XIII. If the driver of a Carriage, registered under this Act, leave the same Penalty for leaving Car-riage without control. without some proper person

to take care of it in any street or at any place of public resort or entertainment, whether it be hired or not, he shall be liable, on conviction, to a fine not exceeding twenty Rupees ; and any Police Constable may drive such Carriage to a place of safety.

XIV. Any proprietor or driver of a Carriage, the fares for which are fixed by Penalty for taking more than legal fare. this Act, who shall take, as a

fare, a larger sum than he is authorised by law to take, shall be liable to a fine not exceeding twenty Rupees, and the Magistrate shall order the amount of such overcharge to be forthwith paid to the party aggrieved. In default of payment such amount shall be recoverable as a fine.

Any driver of a Carriage, registered under this Act, if required to wait with Deposit may be demanded such Carriage at any place for waiting.

XV.

be a sufficient compensation, or refusing to account for

such deposit when paid, shall be liable to a fine not exceeding fifty Rupees.

Penalty for refusing to pay

XVI., If any person hiring a Carriage registered under this Act refuse to pay, on demand to the proprietor or driver of such Carriage,

the fare legally payable, or (if the Carriage be a Carriage not plying for hire in the public streets) the sum agreed to be paid, such fare or sum may be recovered before a Magistrate as a fine, together with such compensation to the proprietor or driver for loss of time in attending before the Magistrate as to the Magistrate seems reasonable.

XVII. Any person using a Carriage registered under this Act, who wilfully in-

Penalty for wilful injury jures the same, shall be liable to Carriage.

to a fine not exceeding twenty Rupees, and shall also pay to the proprietor of the Carriage compensation for the injury. The amount of such compensation shall be ascertained by a Magistrate, and shall be recoverable as a fine.

XVIII. All property left in any Carriage registered

under this Act, shall be deposited by the driver at the nearest Police Station, within twenty-four hours, if not

XIX. In case of any dispute between the hirer and

to drive to the Police Court of the Town or Station where the dispute may arise, when the complaint may be determined by a Magistrate without summons, or, if no Magistrate be at that time sitting, then to the nearest Police Station, when the complaint shall be entered and tried by a Magistrate at his next sitting.

If such proprietor, being duly summoned, shall neglect or refuse personally to appear, or to produce the driver according to such summons, without a reasonable excuse to be allowed by the Magistrate, he shall be liable to a penalty not exceeding forty Rupees, and so, from time to time, as often as he shall be so summoned, until such driver shall be pro-

On neglect on second summons, Magistrate may procead.

duced by him. Provided always, that if such proprietor shall neglect or refuse to appear and produce such driver,

on the second or any subsequent summons requiring him so to do, without a reasonable excuse to be allowed as aforesaid, it shall be lawful for the Magistrate to proceed to hear and determine the complaint in the absence of the proprietor and driver, or of either of them, and to give judgment against such proprietor for the fine incurred by reason of such offence.

XXI. No Palankeen shall ply for hire within any of the said Towns or Stations Palankeens.

unless duly registered at the Police Office. The Register shall state the number assigned to the Palankeen, and the name and residence of the owner. The registration shall be in force for one year, and every change of ownership within that time shall be therein noted. A fee of one Rupee shall be paid on registration. The owner of every such Palankeen shall cause to be painted on a conspicuous part of it the registered number thereof. The owner of every Palaukeen, plying for hire without being duly registered, or not having the prescribed number painted on it, shall be liable to a fine not exceeding twenty Rupees.

XXII. The Commissioner of Police may refuse to

First .- Number of the Boat.

Second .- Name and residence of the owner, and of the manjee.

The registration shall be in force for one year; and every change of the owner

The owner or manjee of every such registered Boat

shall cause to be painted on Name of owner or manjee, a conspicuous part of it the number, &c. to be painted. registered number thereof,

The owner or manjee of a Boat plying for passengers without being duly regis-Penalty.

sengers, or with a less crew, than is stated in the register, or not having the prescribed particulars painted on it, shall be liable to a fine not exceeding fifty Rupees.

XXV. Wheneverany accident shall occur to a Boat re-

gistered under this Act, which accident is attended with loss of the life of any one of the crew or passengers, the manjee, or if the manjee be not forthcom-

ing, the owner of the Boat, shall report the circumstances at the Police Office; and if the manjee or the owner, as the case may be, without lawful excuse neglect or delay to make such report, he shall be liable to a fine, not exceeding fifty Rupees.

XXVI. The Commissioner of Police may refuse to
