No. 2801.—The following draft Notification of rules which it is proposed to make under Section 7 of the Indian Explosives Act is published for the information of persons likely to be affected thereby. Notice is given that the draft will be taken into consideration on the expiry of one month from the date of this Notification, together with any objections or suggestions with respect thereto received before that date:—

In exercise of the powers conferred by Section 7 of the Indian Explosives Act, 1884, and with the previous sanction of the Governor General in Council, His Excellency the Governor in Council is pleased, in substitution of No. 27 of the rules published in Notification No. 4116 at page 559 of the Bombay Government Gazette for 1887, Part I, to make the following rule:

The officers hereinunder mentioned are authorized, within the areas respectively specified below,

- (a) to enter, inspect and examine any place, carriage or vessel in which an explosive is being manufactured, possessed, used, sold, transported, or imported under a license granted under the Indian Explosives Act, 1884, or in which they have reason to believe that an explosive has been or is being manufactured, possessed, used, sold, transported or imported in contravention of the Act or of the rules made under the Act;
- (b) to search for explosive therein;
- (c) to take samples of any explosives found therein on payment of the value thereof; and
- (d) at their discretion to seize, detain, remove, and, if necessary for the public safety, destroy any explosive found therein in respect of which there may be reason to believe that the provisions of the Act or of the Rules made under the Act have been contravened.
