A Bill to amend the Aden Port Trust Act, 1888. (As approved by the Select Committee on the 14th February 1895.)

Bo. A. V. of 1888. WHEREAS it is expedient to amend the Aden Port Trust Act, 1888, in manner hereinafter appearing; It is enacted as follows:-
