2nd. A Farish scholarship of Rupees (20) twenty monthly, to be awarded to the best Chemist

A minimum standard of proficiency will be fixed on, in each instance, and if this standard be not exceeded, the scholarship will not be awarded.

The successful competitor for the Farish Scholarship will be required to shew that he has not neglected his Anatomical studies; and the successful candidate for the Anderson schol-

arship, that he has not neglected Chemistry.

These scholarships will be held each for the period of two years, provided the incumbent

continues worthy of the distinction.

Students who have been irregular in their attendance or otherwise incorrect in their general demeanor, will not be permitted to compete for these honors.
