Under the provisions of Regulation VI. of 1834, the Judges of the Suddur Dewanee Adawlut have sanctioned the closing of the Civil Courts of the Native Judicial Functionaries of the Ahmednuggur Zillah, including those of the Khandeish Division, for six weeks, from the 15th proximo.
