day of it shall be competent to the Governor in Council of Fort St. George to appoint any Military Officer in the service of the East India Company, a Magistrate or an Assistant Magistrate in one or more Zillahs, and to confer on any Assistant Magistrate, by a special order, any of the powers of a Magistrate, any Law or Regulation to the contrary notwithstanding.

Ordered, that the said Draft be re-considered at the first meeting of the Legislative Council of India after the 5th day of December next.

ACT No. -- OF 1846. An Act to provide for the appointment of Constables and Peace Officers at the Settlements in the Straits.

Whereas by the Letters Patent for the establish-ing Her Majesty's Court of Jadicature at Prince of

Wales' Island, Singapore and Malacca, His late Majesty King George the Fourth, amongst other things authorized and empowered the said Court at their General and Quarter Sessions, from time to time to nominate and appoint such persons as the said Court should see fit to be and act as Constables, or to perform the duties performed by Constables, or to perform the duties performed by Constables and Sabordinate Peace Officers in that part of his United Kingdom called England as nearly as the different religious, customs and manners of the different inhabitants of the said Settlements and places should require on would admit and His said late. should require or would admit, and His said late Majesty authorized and empowered the said Court to direct that the said Constables and other Subor-dinate Peace Officers should have and exercise their authority in and over any particular District or Dis-tricts, or any particular class or classes, tribe or tribes of the inhabitants of the said Settlements of Prince of Wales' Island, Singapore and Malacca and places, aforesaid as the Court should see fit. And his said late Majesty authorized and empowered the said Court to compel all and every such persons to serve the said Offices to which they shall be appointed in like manner as persons may be compelled to serve the Office of Constable within that part of His United Kingdom called England so far as the religions, customs and manners of such persons would admit, and that before they should enter upon their respective Offices they should respectively take before the said Court the Oath of allegiance, and on Oath will and faithfully to execute the same

without favour or partiality, malice or hatred.

And whereas it is expedient that all Constables and Subordinate Peace Officers and other persons appointed to perform the duties of Police should receive pay in remuneration for the performance of

their duties.

And whereas by the 13th Section of Act XII. of And whereas by the 1sth Section of Act Art. of 1839, it was enacted that out of the Funds collected from the Assessment and Taxes leviable under that Act provision should be made in conformity with such instructions as might from time to time be issued by the Governor of Bengal for the efficient watchby the Governor of Dengal for the elicient watering, cleansing, lighting and repairing of the Streets and Thoroughfares in the Towns of George Town, Singapore and Malacca, and for the making and repairing of Roads and Bridges, and the effecting of other purposes necessary for the comfort and protection of the inhabitants of the incorporated Settlement therein aforesaid.

And whereas it is expedient that all Constables and Subordinate Peace Officers and other persons appointed to perform duties of Police should be appointed by the authorities from whom they receive

their pay and by no other.
It is therefore hereby enacted, that from and

after

no Constable or Subordinate Peace Officer or other person appointed to perform duties of Police shall be appointed by the said Court at their General and Quarter Sessions or otherwise: but every Constable and Subordinate Peace Officer and other person appointed to perform duties of Police except the Superintendent of Police shall be appointed by the Governor of Prince of Wales' Island, Singapore and Malacca, and that the Superintendent of Police Malacca, and that the Superintendent of Police shall continue to be appointed as heretofore by the

Governor of Bengal. Ordered, that the Draft now read be published for

general information.

An Act to declare and enact the competency of the Courts of Nizamut Adaptut and the Courts of Session to punish offences by fine.

Whereas doubts have arisen whether by the existing Law the Courts of Nizamut Adawlut and the Courts of Session within the Territories subject to the Presidency of Fort William in Bengal, have power generally to punish by fine offences for which the Law has not provided any specific punishment:

It is hereby declared and enacted, that it is competent to the said Courts to punish by fine, at the discretion of the Court, any offenders convicted before them of offences, for which the Law has not provided specific punishment, and in default of pay-

provided specific punishment, and in details of payment of the fine to sentence the offender to imprisonment with or without labor.

Provided always that the imprisonment to which such offender shall have been so sentenced, shall not exceed seven years in the case of sentences passed by the Courts of Session, or fourteen years in the case of sentences passed by the Nizamut Adaptit.

ACT No. ---- OF 1846.

An Act for regulating the proceedings in sertain cases of distraint for arrears of rent.

It is hereby enacted, in modification of Sec tion 9, Regulation VII. of 1709, Section 9, Regulation V. of 1800, and Clause 2, Section 17, Regulation V. of 1800, and Clause 2, Section 17, Regulation XXVIII. of 1803, all of the Bengal Code, that if any person not being such a defaulter as is therein mentioned or responsible for him, shall claim as his right property which has been distrained for arrears of rent due from the said defaulter, and shall within 5 days, reckoning from the day after attachment, enter into a bond before the Collector of the Zillah or the Commissioner appointed under Act I. of 1830 enter into a bond before the Collector of the Zillah or the Commissioner appointed under Act I. of 1839, with good security binding himself to institute before the Collector within 15 days from the date of such bond, a summary suit against the distrainer and defaulter for the trial of the right, and to restore the property or make good its value in case the claim be disallowed with all costs of suit and damages the distrainer shall impediately withdams. ages, the distrainer shall immediately withdraw the attachment.

the attachment.

Provided always and it is hereby enacted, that if the claimant shall not within the said 15 days institute such summary suit, it shall be lawful for the distrainer to recover the value of the property distrained, together with the expences of the attachment, by attachment and sale of the personal property of the claimant, or his surety, or both, unless the claimant shall restore the property, or, if the distrainer prefer it, make good its value.

And it is hereby enacted, that no suit to set aside the summary award of the Collector under this Act, shall be brought after the expiration of one year

shall be brought after the expiration of one year from the date of such award. Ordered, that the Draft now read be published for general information.

Ordered, that the said Draft be re-considered at the first meeting of the Legislative Council of India, after the 26th day of November next.
