NOTIFICATION.

GENERAL DEPARTMENT.

The Right Hon'ble the Governor in Council is pleased to pass the following Revised Rules connected with the Audit of Civil Accounts.

1st. It being absolutely necessary that all Public Accounts should be expeditiously audited and adjusted, they must, for that purpose, be framed with the greatest practicable accuracy, and sent for audit by the prescribed dates.

2nd. As Disbursing Officers are responsible for their payments, they are directed to be careful not to issue in full, allowances liable to partial stoppages or deductions; and they are prohibited, except upon emergent service, from making any advances of Cash, or payments, on account either of extraordinaries or of charges general, if not clearly authorized, without previously submitting the charges for audit, or obtaining the sanction of Government; and no correspondence, except to the extent, and under the Rules hereafter laid down, can be allowed regarding a disbursement which has been brought to account.

As the practice now observed in the Office of the Civil Auditor, is to prepare a separate audit on each month's disbursements, instead of (as formerly) on transactions of six months, the Right Hon'ble the Governor in Council is pleased to direct, that Audits shall be answered by all Disbursing Officers in (15) fifteen days from the date of the receipt, which date should be acknowledged by return of Post. In the event of it being necessary to call for further explanations by Re-audits and Extracts, the time to be allowed for the return of such documents, will be fixed according to circumstances, at the discretion of the Civil Auditor, who is authorized to make final all retrenchments prepared against any Disbursing Officer who does not strictly comply with these Rules,

In replying to Checks, the Right Hon'ble the Governor in Council directs, that the Disbursing Officers use their utmost endeavours to furnish explanations in as clear and concise a manner as

The Right Honorable the Governor in Council further enjoins on all Disbursing Officers, the absolute necessity of having their Vouchers concisely and legibly written. All Vouchers, whether in English or in the Native languages, should, as far as possible, be prepared on paper of the same size, and no extraneous matter allowed to be introduced therein. Disbursing Officers are requested to bring this prominently to the notice of their Mamlatdars, Native Agents, &c. &c., and other subordinates, in order that proper documents in the Native languages may at all times be transmitted to the Hoozoor Office, where the cash accounts are prepared.

In no case is the rule of sending for audit before payment, the Abstracts of Officers absent on leave to be deviated from; and Disbursing O.licers are strictly prohibited from paying to an Officer returning from short leave, his salary for the month during which he may have been absent, without previously sending his abstract for that month for audit. Even though the leave taken is for a few days only, and granted under Section XI. of the Absentee Rules, the abstract should nevertheless be sent for pre-audit, accompanied with a certifi-cate of the date of the Officer quitting and returning to his station.

As a general rule, checks made final by the Civil Auditor are to be credited at once to the Heads to which they were originally debited, on the receipt of the Auditor's intimation. And the Civil Auditor is hereby instructed to bring to the notice of Government any neglect on the part of Disbursing Officers, of the orders herein conveyed.

8th. When an appeal to Government is made against the decision of the Civil Auditor, no time must be lost in taking this step, and the party in this last resort must be aware of the necessity of stating clearly and fully every additional argument he may have to offer, as the decision of the Honorable Board will be final. Parties are enjoined to be careful that they do not appeal to the Government on insufficient grounds.

CONDITIONS OF COMPETITION APPLICABLE TO ALL THE SCHOLARSHIPS,

Competition for the Scholarships is open both to Free and Stipendiary Students.

The Scholarships will be held for a period of one year.

A minimum standard of proficiency will be fixed on, and should this standard not be exceeded, the Scholarships will not be awarded.

In the event of a Student being the successful competitor for more than one Scholarship, he shall, in addition to the award of one Scholarship, receive some honorary mark of distinction, but the second Scholarship shall pass down to the proficient in the next degree.

The presence of the Students in the College and Hospital will be ascertained by Roll-call at least four times daily thoughout the Session, and those Students who, during the Session, have been absent from more than 15 Roll-calls, exclusive of absence on recognized holidays, from sickness duly certified, and leave granted on unavoidable grounds, will not be permitted to compete for these Scholarships.

Those Students whose English Exercises, written during the Session, shew a marked want of attention to improvement in composition, will also be debarred from competing for these Scholarships.

Should the written exercises required as part of the examination for the Scholarships shew a marked want of attention to improvement in English composition, the writer will be held disqualified for a Scholarship, whatever his qualifications in other respects may be.

The successful competitors will be required to shew, by the result of the General Examination at the close of the Session, that they have not neglected any of the branches of study with which they may have been engaged during the Session: deficiency in this respect will disqualify for the Scholarships.

POST OFFICE NOTICES.

Notice is hereby given, that under instructions from the Government of India, letters posted in Bombay cannot be received for transmission by the Government Expresses despatched hence to Calcutta and Madras on the arrival of the Overland Mails, those Expresses being specially intended for Europe letters and intelligence.

The following Notification by H. M. Post Master General of London, is republished for general information:

BY COMMAND OF THE POST MASTER GENERAL.

NOTICE TO THE PUBLIC.

GENERAL POST OFFICE, MAY 1847.

The Post Master General having been informed by the Court of Directors of the East India Company, that on and after the first June next, persons in this country may forward private correspondence by the Government Express from Bombay to Calcutta, and Madras; all persons desirous of availing themselves of this privilege will be required to mark upon the covers of their letters the words "by Express from Bombay," and in addition to this special address it will not be necessary that all letters intended to be forwarded by the way of Southampton should be so endorsed as hitherto.

The postage to be charged in India on the delivery of letters sent by this Express, will be, in addition to the ordinary inland rates,

One rupee for every letter not exceeding half a tola in weight.

Two rupees for every letter above half a tola, but not exceeding one tola in weight. Four rupees for every letter above one tola, but not exceeding two tolas in weight, two tolas being the maximum weight of letters to be conveyed by Express.

On Newspapers.—Each newspaper office in Calcutta and Madras will be allowed to receive two newspapers at the ordinary rates of Inland postage; on all other newspapers forwarded by Express, a postage of five rupees each will be charged, and no newspaper will be received for the Express exceeding three tolas in weight.

N. B.—One tola and a quarter is nearly equivalent to half an ounce avoirdupois.

"Letters which individuals address on their private affairs to any Government officers must be sent post paid,"

Parties addressing the Post Master General or Deputy respecting their private letters and parcels, and superscribing "Service" on such communications, render themselves liable to the penalty prescribed in Section V. Act XX. of 1838.

Letters for Great Britain can be forwarded viâ Madras "prepaid" the whole way, on payment of the Steam postage in addition to the Express postage.

"Section XXVIII.—In order to protect as far as possible the Public Mails from the chance of of robbery, Officers in charge of Post Offices shall not knowingly receive money, bullion,

The Right Hon'ble the Governor in Council is pleased to publish for general information, the following Extracts from an Ordinance enacted by the Government of Mauritius in 1846, for giving premiums to Commanders of Vessels taking Mails, or Overland Newspapers, to that Settlement.

"Extracts from Ordinance No. 13 of 1846, Concerning Captains of Vessels.

"Article 22d. The following premiums shall be given to the Masters or Commanders of Vessels bringing Mails or Overland Newspapers to Manritius under the annexed conditions :-

"£ 30 for any Vessel touching expressly for the purpose of landing the Overland Post Office Mail, upon proof of the Vessel having sailed from the Port at which such Mail was taken on board, within five days after the arrival thereat of the said Mail.

"£ 30 for any Vessel bringing the same, upon proof of the Vessel having sailed within 48 hours of the arrival of the Mail as above described.

"£ 20 for any Vessel, upon proof of the Vessel having sailed within 5 days of the said arrival.

"And £ 10 for any Vessel not conveying the last Overland Mail, but bringing an Overland Newspaper of the latest date, not already received in the Colony, and which shall be delivered within 80 days after publication, and be made public in the Exchange Room immediately after the arrival of the said vessel."

LEGISLATIVE.

The 1st July, 1848.

The following Act, passed by the Governor General of India in Council on the 1st of July 1848, is hereby promulgated for general information.

ACT No. XVI. of 1848.

An Act to remove certain restrictions on the Salt Trade.

Whereas the Salt Trade in the North Western Provinces is burdened with unnecessary restrictions, it is enacted as follows:

enacted as follows:

I. Sections 49, 50, 85 and 93, of Regulation X. of 1819, of the Bengal Code, and so much of Section 48, of the same Regulation, as affects the importation of Salt from the North Western Provinces into the other Provinces of the Presidency of Bengal, also Section 2 of Regulation X. of 1826, of the same Code, shall be repealed from the First day of August in this year.

II. After the said first day of August, no Customs Duty shall be leviable upon Salt imported into the said North Western Provinces from the other Provinces of the said Presidency.

Whereas it is expedient to discourage gaming and wagering for money, It is enacted as follows:

1. All agreements, whether made in speaking, writing, or otherwise, by way of gaming or wagering, shall be null and void: and no suit shall be allowed in any Court of Law or Equity for recovering any sum of money or valuable thing alleged to be won on any wager, or entrusted to any person to abide the event of any game, or on which any wager is made.

11. The several Courts of Justice established by Royal Charter; instead of directing an issue to be tried on a

Charter, instead of directing an issue to be tried on a feigned wager for ascertaining any disputed fact, may issue summonses to witnesses, as well on the equity side as on the plea side of the Court, and cause them to be examined orally in open Court as witnesses in the cause; and the witnesses so summoned shall be bound to attend and give their evidence, in the same manner, and under the same penalties for neglect, or for giving false evidence, as any witness duly summoned to give evidence according to the practice of the Court before the passing of this Act.

ACT No. -- OF 1848.

An Act to simplify Indictments for Forgery.

For better avoiding the failure of Justice in Criminal

proceedings for Forgery, It is enacted as follows:

I. In any infrormation or Indictment laid or brought in the Courts established by Royal Charter, for forging, or in any manner uttering, any forged instrument or writing, it shall not be needed to set forth any exact copy thereof; but it shall be enough to describe such forged instrument or writing, in such manner as would sustain an indictment for stealing it.

CAP. XXI.

An Act to consolidate and amend the Laws relating to Insolvent Debtors in *India*. [9th *June* 1848.]

HEREAS an Act was passed in the Ninth Year of the Reign of His late Majesty King George the Fourth, intituled An Act to provide for the Relief of Insolvent Debtors in the East Indies until the First Day of March One thousand eight hundred and thirty-three: And whereas a certain other Act was passed in the Second Year of the Reign of His late Majesty King William the Fourth, intituled An Act to continue until the First Day of March One thousand eight hundred and thirty-six an Act of the Ninth Year of His late Majesty, for the Relief of Insolvent Debtors in India, whereby the said last-mentioned Act was continued in force until the First Day of March One thousand eight hundred and thirty-six: And whereas a certain other Act was passed in a Session of Parliament holden in the Fourth and Fifth Years of the Reign of His late Majesty King William the Fourth, intituled An Act to amend the Laws relating to Insolvent Debtors in India: And whereas by an Act passed in a Session of Parliament holden in the Sixth and Seven Years of the Reign of His late Majesty King William the Fourth, intituled An Act to continue until the First Day of March One thousand eight hundred and thirty-nine, and from thence to the End of the then next Session of Parliament, the several Acts relating to Insolvent Debtors in India, the first-mentioned Act, as amended by the said Act of the Session of the Fourth and Fifth Years of the Reign of His late Majesty King William the Fourth, was continued in force until the First Day of March One thousand eight hundred and thirty-nine, and from thence to the End of the then next Session of Parliament: And whereas by a certain other Act of Parliament passed in a Session holden in the Third and Fourth Years of the Reign of Her present Majesty, intituled An Act to continue until the First Day of March One thousand eight hundred and forty-five, and from thence to the End of the then next Session of Parliament, the several Acts relating to Insolvent Debtors in India, the said Acts of the Ninth Year of the Reign of King George the Fourth, and of the Session of the Fourth and Fifth Years of the Reign of King William the Fourth, were continued until the First Day of March One thousand eight hundred and forty-five, and from thence until the End of the then next Session of Parliament: And whereas by a certain other Act of Parliament passed in a Session holden in the Ninth and Tenth Years of Her present Majesty, intituled An Act to continue until the First Day of March One thousand eight hundred and forty-seven, and from thence to the End of the then next Session of Parliament, the several Acts relating to Insolvent Debtors in India, the said Acts of the Ninth Year of the Reign of King George the Fourth, and of the Session of the Fourth and Fifth Years of the Reign of King William the Fourth, were continued until

the First Day of March One thousand eight hundred and forty-seven, and from thence to the End of the then next Session of Parliament: And whereas it is expedient to consolidate the Provisions of the said Acts into One Act, and to amend the Laws relating to Insolvent Debtors in India: Be it therefore enacted by the Queen's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That the said Acts of the Ninth Year of the Reign of King George the Fourth, and of the Session of the Fourth and Fifth Years of the Reign of King William the Fourth, shall be and the same are hereby continued until the Thirty-first Day of July One thousand eight hundred and forty-eight, and that from and after that Day the same, and also the said Act of the Session of the Ninth and Tenth Years of the Reign of Her present Majesty, shall be and stand repealed, save as to all Acts, Matters, and Things which before then shall have been done under the Provisions of the said Three last-mentioned Acts or of any W. 4. c. 47, of them, and save as to all Rights, Exemptions, and Discharges whatsoever un3. & 4 Vict.

Courts established under 9 G. 4. c. 73. for Relief of Insolvent Debtors, continued with the same Powers as heretofore.

II. And be it enacted, That the Courts established under the first of the said recited Acts for the Relief of Insolvent Debtors in the East Indies shall be continued and shall continue to be Courts of Record, with all the same Powers as heretofore, and each shall continue to be styled "The Court for the Relief of Insolvent Debtors," and to be holden before any One Judge of the Supreme Courts of Judicature at Calcutta, Madras, and Bombay respectively, within the respective Limits of the said Towns of Calcutta, Madras, and Bombay, and that all the Officers of the said Courts respectively now established for the Relief of Insolvent Debtors in the East Indies shall be, until removed under the Provisions hereinafter contained, the Officers of the said Courts hereby continued respectively, and that all Rules and Orders not repugnant to the Provisions of this Act now in force in the said Courts respectively, and all Tables of Fees now in force therein, shall, until the same are varied or repealed, continue in force in like Manner to all Intents and Purposes as if the Acts in force with respect to Insolvent Debtors before this Act comes into operation had been continued by this Act.

A Court to be holden once a Month at least in Calcutta, and as often as found neces-sary in Mad-ras and Bom-bay, by any One Judge of the respective Supreme Courts.

And be it enacted, That a Court for the Relief of Insolvent Debtors shall be holden once a Month at least throughout the Year, and oftener if need be, in Calcutta, and so often as may be found necessary within the Towns of Madras and Bombay, by any One Judge of the said Supreme Courts of Judicature respectively; and it shall be lawful for each of the said Courts to sit for the Despatch of Business at one and the same Time with the said Supreme Court of its Presidency; and every Advocate and Attorney of the said Supreme Courts at Calcutta, Madras, and Bombay respectively shall be entitled to practise in the way of his Profession in the Court for the Relief of Insolvent Debtors of that Presidency, and no other Persons shall practise as Advocates or Attornies in the said Courts for the Relief of Insolvent Debtors; and the said Supreme Courts of Judicature respectively shall have Power from Time to Time to make Rules to regulate the Proceedings of the Courts hereby continued for the Relief of Insolvent Debtors to be holden within their respective Jurisdictions, and from Time to Time to vary and repeal, in whole or in part, any of the Rules and Orders and any Table of Fees now in force in the said Courts respectively for the Relief of Insolvent Debtors in the East Indies, and especially to provide in what Manner Notice shall be given to the Creditors of Parties applying for Relief under this Act, and in what Cases besides those mentioned in this Act Costs may be awarded, and shall prepare and cause to be sealed with their respective Seals a sufficient and proper List of Fees to be charged and received by the Officers of the said Courts for the Relief of Insolvent Debtors of their respective Presidencies, and shall certify under their Seals, and transmit to the President of the Board of Commissioners for the Affairs of India, Copies of such Rules and Lists of Fees to be laid before Her Majesty for Her Royal Approbation, Correction, or Revision; and other Copies of the same shall at all Times be fixed in conspicuous Places in the Courts for the Relief of Insolvent Debtors; and no other Fee or Gratuity

The several Powers of this Act extended, with certain Exceptions, to the Settlement of Prince of Wales Island, Singapore, and Malacca.
