BY COMMAND OF THE POST MASTER GENERAL.

NOTICE TO THE PUBLIC.

GENERAL POST OFFICE, MAY 1847.

The Post Master General having been informed by the Court of Directors of the East India Company, that on and after the first June next, persons in this country may forward private correspondence by the Government Express from Bombay to Calcutta, and Madras; all persons desirous of availing themselves of this privilege will be required to mark upon the covers of their letters the words "by Express from Bombay," and in addition to this special address it will not be necessary that all letters intended to be forwarded by the way of Southampton should be so endorsed as hitherto.

The postage to be charged in India on the delivery of letters sent by this Express, will be, in addition to the ordinary inland rates,

One rupee for every letter not exceeding half a tola in weight.

Two rupees for every letter above half a tola, but not exceeding one tola in weight.

Four rupees for every letter above one tola, but not exceeding two tolas in weight, two tolas being the maximum weight of letters to be conveyed by Express.

On Newspapers .- Each newspaper office in Calcutta and Madras will be allowed to receive two newspapers at the ordinary rates of Inland postage; on all other newspapers forwarded by Express, a postage of five Rupees each will be charged, and no newspaper will be received for the Express exceeding three tolas in weight.

N. B. - One tola and a quarter is nearly equivalent to half an ounce avoirdupois.

6th. "We have lately had occasion to address the following observations to the Government of Madras on the

subject of Memorials from our Officers, which we now transcribe as being equally applicable to your Presidency:—
"We regret to observe, that a practice has of late been adopted, of addressing to us Memorials in a printed form,

which have been circulated from a central point to the different Stations of the Army for the purpose of being adopted and signed by Officers individually. This practice is opposed in principle to the Regulations of the Service forbidding all combinations for the attainment of any object whatever, and must be entirely discontinued:

"It has long been a standing Order for the conduct of our proceedings in England, that no printed Memorial be received. We snow direct, that a similar rule be established in India; and further, that it be generally understood, that if any Officer has occasion to adress a Memorial to us, it must not be in the terms of a Circular, but in the lan-

guage of the Memorialist himself.

"We have had occasion to remark, that questions have been raised in Memorials to us affecting the general Regulations and system of our Service, which ought not to have been brought before us on the individual applications of our Officers.

"It is our anxious desire to avoid all interference with the privilege of addressing Memorials to us, but we must at the same time intimate our expectation, that Memorials will be addressed to us only on matters which immediately affect the interests of the Memorialist.

"We need scarcely repeat on this occasion the injunctions heretofore given, that Memorials shall be received and

forwarded to us only when couched in temperate and respectful language,"

LEGISLATIVE.

The 2nd September, 1848.

The following Act passed by the Governor General of India in Council on the 2d of September 1848, is here-by promulgated for general information.

ACT No. XIX, or 1848.

For better defining the Law as to revision of the sen-tences of Subordinate Criminal Courts in the Presi-dencies of Bengal and Madras.

Whereas it has been doubted how far Section V. Regulation IX. 1831, of the Bengal Code, is repealed by Act XXXI. 1841, and what power the Foujdaree Adawlut at Madras has under Section XXXV. Act VII. 1843, It is enacted as follows:

I. So much of Section V. Regulation IX. 1831, of the Bengal Code, as is now in force, and also Section XXXV. Act VII. 1843, are repealed.

XXXV. Act VII. 1843, are repealed.

II. The Nizamut Adawlutin the Presidency of Bengal, and Foujdaree Adawlut in the Presidency of Madras, in any case in which it shall appear to either of them, upon a review of the Abstract Statements or Calendars of prisoners punished without reference, that the sentence passed is one which cannot lawfully be passed on a person convicted of the offence, as stated in the Abstract Statement or Calendar, shall annul the sentence; and shall certify to the subordinate Court the sentence or sentences which may lawfully be passed for such offence; and thereupon the subordinate Court shall pass a new sentence according to Law, and shall amend the record in accordance therewith. the record in accordance therewith.

The said Nizamut Adawlut or Foujdaree Adawthe said Nizambr Adawlut of Polylarce Adaw-lut, in any case in which it shall appear to either of them, upon a review of the Abstract Statements or Calendars of prisoners punished without reference, that the verdict or judgment, pronounced on any prisoner was not warranted by the evidence, or that his sentence was too severe, may, if it thinks fit, require the Judge of the Court in which the conviction was had to certify under his hand all the evidence taken in the case affecting such prisoners, with any observations which the Judge may be desirous of making in explanation of the verdict, judgment or sentence; and thereupon the Nizamut Adawlut or Foujdarce Adawlut, as the case may Nizamut Adawlut or Fouldarce Adawlut, as the case may be, may annul such verdict, judgment, and sentence, if the verdict or judgment shall appear to it not warranted by the evidence, or mitigate the sentence, if it shall appear too severe; and in either case shall certify its proceedings to the Court in which the conviction was had, which shall thereupon make such orders as are conformable to the decision of the Nizamut Adawlut, or Fouldarce Adawlut, and, if necessary, amend the record in accordance therewith. cord in accordance therewith.

IV. Instead of proceeding under this Act, the said Nizamut Adawlut or Foujdaree Adawlut may, whenever it thinks fit, call for the whole record of any criminal trial in any subordinate Court, and pass thereon such orders as it thinks fit, but not so as to enhance the punishment awarded, or punish any person acquitted in the subordinate Court.

The following Draft of a proposed Act was read in Council for the first time on the 26th of August 1848.

For securing Military Pensions and Superannuation Allowances.

Whereas it is expedient to consolidate and extend the operation of the law, as to the exemption of Military Pensions and other Superannuation allowances from seizure under process of law, It is enacted as follows:

I. Regulation XII. 1814, of the Bengal Code, and Act XXXI. 1845, are repealed.

Act XXXI. 1845, are repealed.

II. The reduced pay or pension, however called, of any Invalid Officer, Soldier, Sailor, or Retainer of the Army or Navy, in the Military or Naval Service of the East India Company, and also any monthly or yearly pension or pecuniary allowance to any person, in consideration of past services and present infirmities or old age, granted by authority of the Governor General in Council, or of the Governor or Governor in Council, or Lieutenant Governor of any Presidency or Place within the territories under the Government of the East India Company, and also the pension of any Out-Pensioner of Chelsea or Greenwich Hospital granted by authority of the Commissioners of Chelsea or Greenwich Hospital respectively, and also all money due or to become due on account of any such pension or allowance, shall be exempt from seizure, attachment or sequestration by process of any Court within the said territories, at the instance of a creditor for any demand against the Pensioner, or in satisfaction of a decree or order of any such Court.

III. All assignments, agreements, orders, sales and securities of every kind made by any such Pensioner, in respect of any money not payable at or before the making thereof, on account of any such pension, or for giving or assigning any future interest therein, are null and void.

IV. This Act shall not apply to a convergence of the c

Void.

IV. This Act shall not apply to any process of any Court established by Royal Charter, issued out of such Court before the passing of this Act, or to any assignment, agreement, order, sale or security by any such Pensioner, made before the passing of this Act in respect of a Chelseaor Greenwich pension, or a pension or allowance granted in the Presidency of Madras, or before the 27th December 1845, in respect of a pension or allowance granted in the Presidency of Bombay, or before the 27th May 1814, in respect of a pension or allowance granted in the Presidency of Bengal.

The following Draft of a proposed Act was read in Council for the first time on the 2d of September 1848-

ACT No .or 1848.

For improving the jurisdiction of the Sudder Fouj-darce Adawlut of Bombay, and for amending Section XXXVI. Regulation II. 1827 of the Bombay Code.

Whereas the jurisdiction of the Sudder Foujdarce Adawlut of the Presidency of Bombay has been impaired by its removal to the Island of Bombay within the jurisdiction of the Supreme Court of Judicature there, for remedy thereof it is enacted as follows;

I. The Sudder Foujdarce Adawlut of the Presidency of Bombay, and the several Officers thereof, shall have the same authority in all respects, and all persons may be proceeded against and punished for contempt or disobedience of the lawful orders of the Court, or for resistance to the lawful authority of any Officer in execution of any process or order of the Court, as if the Court were held in the Zillah nearest to the Island of Bombay.

Court were held in the Zhian heatest to the Zanaca Bombay.

II. The Acts and Orders of the said Sudder Foujdaree Adawlut, and of its Officers in execution of any process or order of the Court, shall not be liable to question in the Supreme Court of Judicature at Bombay, further or otherwise than they might severally be questioned in the said Supreme Court, if the said Sudder Foujdaree Adawlut were held in the Zillah nearest to the Island of Bombay.

III. Any Criminal Court having cognizance of any offence under Sectiou XXXVI. Regulation II. 1827 of the Bombay Code, may issue a warrant under the hand of the Judge, or one of the Judges, and the seal of the Court, for the arrest of the person accused; and may commit him to gaol unless security be given to the satisfaction of the Court for his appearance to answer the charge. charge.

IV. Offenders against Section XXXVI. Regulation II. 1827 of the Bombay Code, may be tried and punished for the offence, after they have ceased to belong to the establishment of the Court to which they belonged at the time of committing the offence.

cil resolves, that the following amended Draft on the subject be published for general information.

ACT No. -- of 1848.

An Act for the appointment of an Administrator General in Bengal.

Whereas it is expedient to disconnect the administra-tion of the Estates of British Subjects dying intestate in the Presidency of Fort William in Bengal from the Office of Ecclesiatical Registrar of the Supreme Court

Office of Ecclesiatical Registrar of the Supreme Court there, It is enacted as follows:

1. Whenever after the passing of this Act any British Subject shall die intestate within the Presidency of Fort William in Bengal, or the Territories subordinate to the said Presidency, or to become subordinate thereto, and on the return of the citation issued from the received and the control of the citation of the control of the cont to, and on the return of the citation issued from the proper Ecclesiastical Court, no next of Kin or Creditor shall appear and make out their claim to the Administration of the Effects of the deceased to the satisfaction of thesaid Court, and also, whenever the Executor or Executors, appointed by the will of any British Subject dying therein, shall refuse to prove the Will, the Administrator General created by this Act shall apply for, and the said Court shall grant to him, instead of the Ecclesiastical Registrar, such Letters of Administration or Ad Colligenda Bona as to such Court shall seem meet; by virtue whereof the said Administrator General shall collect the assets of the deceased, and bring them for safe custody into the said Court, and account for them as herein provided.

H. All Letters of Administration or Ad Colligenda

II. All Letters of Administration or Ad Colligenda Bona, granted to the Ecclesiastical Registrar of the Supreme Court; and all Probates, granted to such Officer, of Wills appointing the Ecclesiastical Registrar of the Supreme Court by that description, or him and his successors, Executors thereof; and all Estates, Effects and Interests, vested in the said Ecclesiastical Registrar by virtue thereof; and all books, papers and documents belonging to him or in his possession, or under his controll by virtue of such Letters or Probates, shall, by this Act, and without other grant, be transferred to the Administrator General by this Act created; who shall be to all intents and purposes such Administrator, Executor, or Grantee, in his new character of Administrator General, as the Ecclesiastical Registrar of the Supreme Gourt was; and shall have all the same powers as the said Ecclesiastical Registrar might exercise at the time of the passing of this Act, as such Administrator, Executor or Grantee. II. All Letters of Administration or Ad Colligenda

the time of the passing of this Act, as such Administra-tor, Executor or Grantee.

111. The Ecclesiastical Registrar at the time of the passing of this Act shall be first Administrator General, and upon the passing of this Act shall cease to be Ec-clesiastical Registrar; and as such Administrator Gene-ral shall be entitled to receive or retain all Commission to which he was entitled as Ecclesiastical Registrar at the time of the passing of this Act on any such grants as the time of the passing of this Act on any such grants as aforesaid.

IV. On all future vacancies of the Office, the Ad-

ministrator General shall be appointed by the Governor General of India in Council; and shall be one, who either has been admitted and is at the time of such appointment an Advocate or an Attorney of the said Su-preme Court, or at the time of such appointment is qualified to be so admitted.

V. After the passing of this Act, the Administrator General shall be deemed in that capacity an Officer of the said Supreme Court, and shall not be otherwise accountable to it than any ordinary Executor, Administrator, or Grantee of Letters Ad Colligenda Bona, as the

countaint contraction of Letters Ad Colligenda Bona, as the case may be.

VI. Every Administrator General shall give Security by Bond to the East India Company, himself for one lack of Rupees, with two or more Sureties jointly and severally for another lack of Rupees, for the due execution of his said Office; and shall not be required by the said Supreme Court to enter into any Administration Bond, or to give other Security to that Court on the grant of any such Letters as aforesaid.

VII. The Administrator General shall receive for the discharge of his duties as such Administrator General under all such grants of Letters as aforesaid made after the passing of this Act, or on Probates of Wills so granted after the passing of this Act, wherein he is named Executor by virtue of his Office, instead of the Commission heretofore received by the Ecclesiastical

Registrar, a Commission calculated after the rate of Three Rupees in every Hundred Rupees which he shall actually distribute, or which he shall set apart and invest as herein provided, for the benefit of the parties ultimately entitled thereto, if the same are not immediately payable; and, out of the said Commission of Three Rupees in the Hundred, shall defray the expences of the necessary Establishment, and all other charges to which the said Office may be subject.

VIII. No person, other than the Administrator Gen-

No person, other than the Administrator General, shall be entitled to charge any Commission or Agency, as Executor of any Will, of which Probate shall have been granted to him in the said Presidency after the eral, shall be passing of this Act, or as Administrator of any Effects whereof Administration shall have been granted to him in the said Presidency after the passing of this Act.

IX. The Assets belonging to the Estates administered

by the said Administrator General shall be kept by him in the Treasury of the East India Company, or otherwise kept and invested by him, in such manner as the Go-

wise kept and invested by him, in such manner as the Governor General of India in Council shall from time to time by his order in writing direct; which order shall be published in the Calcutta Gazette, and shall be full authority, protection and indemnity in all Courts whatsoever, for such keeping and investing.

X. The said Administrator General shall enter into books to be kept by him for that purpose separate and distinct accounts of each Estate, and of all such sums of Money, Bonds and other Securities for Money, Goods, Effects and things, as shall come to his hands or to the hands of any persons employed by him, or in trust for hands of any persons employed by him, or in trust for him under this Act; and likewise of all payments made by him on account of the said Estates, and of all debts due by or to the saine, specifying the dates of such receipts and payments respectively; which said books shall be keptin the Registrar's Office, and shall be open for the inspection of all such persons, practitioners in the said Courts and others, as may have occasion to inspect the same, at office hours; paying such reasonable fee as may be from time to time fixed therefore by the Governor General of India in Council, and published in the Calcutta Gazette, and no more.

XI. The Administrator General shall twice in every year, that is, on the First day of March and on the Twenty-second day of October, or on the First day on which the said Court shall be sitting after those days, exhibit and deliver in open Court a true and perfect Schedule, of all sums of Money, Bonds or other Securities received on account of each Estate remaining under his charge, together with the payments made thereout, handsof any persons employed by him, or in trust for

his charge, together with the payments made thereout, and the balances; and also of all Administrations whereof the balances shall have been paid over to the persons entitled to the same, since the period of exhibiting the last Schedule, specifying the amount of such balances, last Schedule, specifying the amount of such balances, and the persons to whom paid; which shall be filed of record in the said Court, and shall, within fourteen days afterwards, be published in the Calcutta Gazette by the said Administrator General, who shall likewise cause copies thereof in triplicate to be delivered to the Chief Secretary of the said Presidency; and the same shall be transmitted by the Governor of the Presidency to the Court of Directors of the East India Company, for publication in the London Gazette.

XII. When the said Schedules are delivered to the

XII. When the said Schedules are delivered to the Supreme Court of Judicature at Fort William in Bengal,

Supreme Court of Judicature at Fort William in Bengal, duplicates thereof shall also be laid before the Governor General of India in Council, who shall refer the same to such person or persons as he may from time to time appoint an Auditor or Auditors for that purpose.

XIII The Auditor or Auditors shall examine such Schedules, and report to the said Governor General in Council whether they contain a full and true account of every thing which ought to be inserted therein, and whether the Books by this Act directed to be kept by the Administrator General are always and regularly kept and Administrator General are duly and regularly kept, and whether the Assets are duly kept and invested in such

whether the Assets are duly kept and invested in such manner as is by Law prescribed.

XIV. Every Auditorshall have power to summon as well the Administrator General as any other person or persons whose presence he may think necessary, to attend him from time to time; and to examine the Administrator General or other party or parties if he shall think fit, on Oath or Solemn Affirmation to be by him administered; and to call for all Books, Papers and Documents which may appear to him to be necessary for the purposes of the said reference: and if the Administrator General, or other said reference: and it the Administrator General, or other person or persons when summoned shall refuse or without reasonable cause neglect to attend, or to produce any Books, Papers or Documents required, or shall attend and refuse to be swarn or make a Solemu Affirmation when by law an Affirmation may be substituted for an Oath, or shall refuse to be examined, the Auditor or Auditors shall certify such neglect or refusal in writing to the

Supreme Court of Judicature at Fort William in Bengal; and every person so refusing or neglecting shall thereupon be punishable, in like manuer as if such refusal or neglect had been in contempt of the said Su-

XV. If on such reference and examination it shall appear that the said Schedules are correct, and that the provisions of this Act have been compiled with, the costs and expenses of such reference shall be defrayed proportionably by all the Estates, the accounts of which are then under examination, which costs and proportions shall be ascertained and settled by the Auditor or Auditors, subject to the approval of the Governor General in Council; and shall be paid out of the said Estates accordingly by the Administrator General.

XVI. If upon any such reference and examination the Auditor or Auditors shall see reason to believe that the said Schedules do not contain a true and correct ac-

the said Schedules do not contain a true and correct ac-count of the matters therein, or which ought to be there-in contained, he or they shall report accordingly to the Governor General of India in Council, specifying the substance of the objections thereto; and the said Go-vernor General in Council shall thereupon refer the same to the consideration of the Advocate General of the East to the consideration of the Advocate General of the East India Company in Bengal, who shall thereupon proceed summarily by petition for an account against the said Administrator General, or against a late Administrator General after his removal from Office, or against his personal representatives in case of his death, in respect of all or any of the Estates then or form-rly under his care as the said Advocate General shall think fit; and shall have power to exhibit interrogatories to the said Administrator General, or other person or persons defendants, who shall be bound to answer the same as fully as if the same had been contained in a Bill filed for the as if the same had been contained in a Bill filed for the like purpose; and the Court shall have power on any such petition filed to examine orally the parties before it and all witnesses, or to refer the accounts to be taken in the ordinary way; and the costs of the Advocate Gene-ral, when such are directed to be paid, shall be defrayed either by the defendant or defendants, in case he or they either by the defendant or defendants, in case he or they shall be decreed to pay the costs, or out of the Estates rateably as the said Court shall direct; and the Court shall have power to order the Administrator General, or other person or persons defendants, to receive his or her costs out of the said Estates if it shall think fit.

XVII. The said Court shall have power on such periods.

XVIII. Every person who, having been sworn or having taken a Solemn Affirmation under this Act, shall wilfully give false testimony upon any examination au-thorized by this Act, shall be deemed guilty of perjury; and if convicted thereof, shall be liable to fine and impri-sonment, or to fine or imprisonment; which imprison-ment may be at the discretion of the Court with or without

hard labour, and may extend to two years. Ordered, that the said Draft be re-considered at the first meeting of the Legislative Council of India after the 2d

day of October next.
