NOTIFICATION.

GENERAL DEPARTMENT.

With the view of bringing uniformity in the method of conducting public examinations in the native languages at this Presidency, and identity in the standard of proficiency to be attained by Civil and Military officers and public servants generally undergoing examination, the Hon'ble the Governor in Council has, in concurrence with His Excellency the Commander in Chief, determined to abolish the present practice of naming for every examination committee new and different Members, and has resolved to appoint a permanent committee of five Members, one of whom shall be the President, and one the Secretary to the committee.

The Military officers who have been selected by His Excellency the Commander in Chief will, as hitherto, while on such committee, be considered on duty.

The committee will assemble three times in each year, viz. on the 10th of January, the 10th of May, and the 10th October.

This arrangement refers solely to the committee assembled at the Presidency, and is not intended to interfere with any Standing or General orders applicable to Officers who may be authorized to submit themselves for examination at outstations.

And £ 10 for any vessel not conveying the last Overland Mail, but bringing an *Overland newspaper* of the latest date, not already received in the Colony, and which shall be delivered within 80 days after publication and be made public in the exchange room immediately after the arrival of the said vessel.

The postage to be charged in India on the delivery of letters sent by this Express, will be, in addition to the ordinary inland rates.

One rupee for every letter not exceeding half a tola in weight.

Two rupees for every letter above half a tola, but not exceeding one tola in weight.

Four rupees for every letter above one tola, but not exceeding two tolas in weight, two tolas being the maximum weight of letters to be conveyed by Express.

On Newspapers.—Each newspaper office in Calcutta and Madras will be allowed to receive two newspapers at the ordinary rates of Inland postage, on all other newspapers forwarded by Express, a postage of five rupees each will be charged, and no newspaper will be received for the Express exceeding three tolas in weight.

N. B.—One tola and a quarter is nearly equivalent to half an ounce avoirdupois.

The 22d January 1848.

The following Act passed by the Governor General of India in Council on the 23d January 1848, is hereby promulgated for general information.

Act No. I. of 1848.

An Act to regulate the proceedings in certain Cases of Forgery.

It is hereby enacted, that within the Territories subject to the Presidency of Fort William in Bengal except the local limits of the Courts established by Her Majesty's Charter, the Magistrates of the several Zillahs and Cities shall not receive any charges of Forgery, or of procuring or causing Forgery, or of fraudulently issuing and publishing as true or otherwise fraudulently giving effect to, or attempting to give effect to false and fabricated Deeds and Papers, knowing the same to be false and fabricated, which may be preferred by parties to Civil or Criminal cases in respect to Deeds and Papers offered in evidence in such cases against the adverse parties to such cases, or other person except as provided in the next following Section.

II. And it is hereby enacted, that in cases pending before any Civil or Criminal Court (except the Court of the Magistrate, or of any Officer exercising the committing powers of a Magistrate) in which there may appear to the Court sufficient grounds for sending for investigation to the Magistrate a charge of any of the offences specified in Section I. of this Act, the Court shall send the party or parties accused in custody to the Magistrate, together with the evidence and documents relevant to the charge, and shall take a recognizance from each of the witnesses, who have given such evidence to appear before the Magistrate, who shall thereupon receive such charge and proceed with it in the usual course.

Provided always, that nothing herein contained shall be construed to affect the powers vested in Sessions Judges in cases of Forgery, by Section 6, Regulation II. of 1807, of the Bengal Code.

III. And it is hereby enacted, that the powers vested by Clause 2, Section 14, Regulation XVII. of 1817, of the said Code, in Zillah and City Judges, of committing persons chargeable with Perjury or Subornation of Perjury in cases pending before such Judges, are hereby vested in Principal Sudder Ameens in Civil cases pending before them, and the Principal Sudder Ameens and the Magistrates are hereby authorized and required to proceed in the manner in which the said Judges and Magistrates are authorized and required to proceed by the said Clause.

IV. And it is hereby enacted, that it shall be competent to the Sessions Judges to try persons committed by themselves as Civil Judges under the provisions of the said Clause for Perjury or Subornation of Perjury any Law to the contrary notwithstanding.

V. And it is hereby enacted, that for the purposes of this Act, the expression Civil Courts shall be held to include all Revenue Officers acting judicially

Act No. — 1848

*An Act to remove, certain restrictions on the Salt Trade.*

It is hereby enacted, that Sections 49 and 50, of Regulation X. of 1819, of the Bengal Code, and so much of Section 48 of the same Regulation, as affects the importation of Salt into Behar from the North Western Provinces, shall be repealed from the

II. And it is further enacted, that from and after the day abovementioned, no Duty or Customs shall be leviable upon Salt, imported into the North Western Provinces of the Presidency of Bengal, from the other Provinces of the said Presidency, any thing contained in Act No. XIV. of 1843, to the contrary notwithstanding.

Ordered, that the Draft now read be published for general information.

Ordered, that the said Draft be re-considered at the first meeting of the Legislative Council of India after the 22d day of March next.
