The following Draft of a proposed Act was read in Council for the first time on the 5th of December 1851.

ACT No. - OF 1851.

An Act for improving and regulating the Streets, Roads, and Drains within the Town and Local Limits of Madras.

Whereas many of the Streets, Thoroughfares, Drains, and Public Places within the Town and limits of Madras require to be widened and improved, and whereas it is expedient that better provision should be made for the removal of nuisances and obstructions within the said Town and limits, It is enacted as follows:

I. The Justices of the Peace acting within and for Justices may require lands to be given up and sold for certain purposes.

The said Town and limits of Madras, with the sanction of the Governor of Fort Saint George for the time being in Council, shall at all times have power and authority to require any lands within the said town and limits to be sold or given up, by all parties interested in such lands, for the purpose of widening, altering, or improving any existing public Road, Street, or other Thoroughlare or Drain, or for making any new public Road, Street, or other Thoroughlare or Drain.

Notice of inNotice of inThe probability of take any of the lands which by this tention to take any of the lands which by this Act they are authorized to purchase or take, they shall give notice thereof in writing to all the parties interested in such lands, or to the parties enabled by this Act to sell and convey or release the same, or such of the said parties as shall, after diligent inquiry, be known to the said Justices, or their Surveyors, and by such notice shall demand from such parties the particulars of their estate and interests in such lands, and of the claims made by them in respect thereof; and every such notice shall state the particulars of the lands so required, and that the said Justices are willing to treat for the purchase thereof, and as to the compensation to be made to all parties for the damage that may be sustained by them by reason of the execution of the works.

Services of Notices on owners and occupiers.

All notices required to be served by the said Justices upon the parties interested in or entitled to sell any such lands, shall either be served personally on

such parties, or left at their last usual place of abode, if any such, after diligent enquiry, can be found, and in case any such parties shall be absent from the Presidency of Madras, or cannot, after diligent enquiry, be found, shall also be left with the occupiers of such lands, or, if there be no such occupier, shall be affixed upon some conspicuous part of such lands.

IV. It shall be lawful for the said Justices to agree with the owners of any lands by this Power to pur-Act authorized to be taken, and which shall be required for the purposes of chase land by athis Act, and with all parties having any estate or inter-est in such lands, or by this Act epabled to sell and cert in such lands, or by this Ace eparted to sen and convey the same, for the absolute purchase, for a con-sideration in money, of any such lands, or such parts thereof as they shall think proper, and of all estates and interests in such lands of what kind soever.

It shall be lawful for all parties, being seised, possessed of, or entitled to any such lands, or any estate or interest therein, disability enabled to selland convey. to sell and convey or release the same to the said Justices, and to enter into all necessary agreements for that purpose; and particularly it shall be lawful for all or any of the following parties so seised, possessed, or entitled as aforesaid, so to sell, convey, or release; (that is to say) all corporations, tenants in tail or for life, married women seised in their own right or entitled to dower, guardians, committees of lunatics and idiots, trustees or feoffees in trust for charitable or other purposes, executors and administrators, and all parties for the time being entitled to the receipt of the rents and profits of any such lands in possession, or subject to any estate in dower, or to any lease or interest for life, or for lives and years, or for years, or any less interest; and the power so to sell and convey or release as aforesaid may lawfully be exercised by such parties, other than married women entitled to dower, or lessees for life, or for lives and years, or for years, or for any less interest, not only on behalf of themselves and their respective heirs, executors, administrators and successors, but also for and on behalf of every person entitled in reversion, remainder, or expectancy after them, or in defeasance of the estates of such parties, and as to such married women, whether they be of full age or not, as if they were sole and of full age, and as to such guardians, on behalf of their wards, and as to such committees, on behalf of the lunatics and idiots of whom they are the committees respectively, and that to the same extent as such wives, wards, lunatics, and idiots, respectively, could have exercised the same power under the authority of this Act if they had respectively been under no disability, and as to such trustees, executors, and administrators, on behalf of their cestui que trusts, whether infants, issue unborn, lunatics, femes covert, or other persons, and that to the same extent as such cestui que trusts, respectively, could have exercised the same powers under the authority of this Act, if they had respectively been under no disability.

The purchase money or compensation to be paid

Amount of compensation in case of parties under disability to be as-certained by va-luation, and paid into the Bank.

for any lands to be purchased or taken from parties under any disability or incapacity, and not having power to sell or convey such lands, except under the Provisions of this Act, and the compensation to be paid for any permanent damage or injury to any such

lands, shall not, except where the same shall have been determined by the verdict of a jury, be less than shall be determined by the valuation of two able practical surveyors, one of whom shall be nominated by the said Justices, and the other by the other party; and if such two Surveyors cannot agree in the valuation, then by such third Surveyor as the said Governor in Council shall, upon application of either party, after notice to the other party, for that purpose nominate; and each of such two Surveyors, if they agree, or, if not, then the Surveyor nominated by the said Governor in Coun-

cil, shall annex to the valuation a declaration in writing, subscribed by them, or him, of the correctness thereof; and all such purchase money or compensation shall be deposited with the Sub-Treasurer of the Government of Fort Saint George, with the privity of the Accountant General of the said Presidency of Madras, for the benefit of the parties interested, in manner hereinafter mentioned.

If parties fail to treat, or in case of dispute, question to be settled as af-

ter mentioned.

VII. If, for twenty-one days after the service of such notice, any such party shall fail to state the particulars of his claim in respect of any such land, or to treat with the said. Justices in respect thereof, or if such party and the said Justices shall not agree as to the amount of the

compensation to be paid by the said Justices for the interest in such lands belonging to such party, or which he is by this Act enabled to sell, or for any damage that may be sustained by him by reason of the execution of the works, the amount of such compensation shall be settled in the manner hereinafter provided for settling cases of disputed compensation.

notice before summoning Jury; the notice to contain an offer, &c.

VIII. Before the said Justices shall issue their Warrant for summoning a Jury for settling any case of disputed compen-sation, they shall cause their Survey-or to value the lands required, and the said Surveyor, if the land is private property, or, being land of the

East India Company, any substantial improvement shall have been made in the value thereof, shall cause an estimate to be made of such private property, or of any such improvement, and the said Justices shall then give not less than ten days' notice to the other party of their intention to cause such Jury to be summoned, and in such notice the said Justices shall state the sum of money at which the same has been valued as aforesaid, and which they are willing to give for the interest in such lands sought to be purchased by them from such party, and for the damage to be sustained by him by the execution of the works; and if such sum of money be accepted by such party, the same shall be paid to him on his executing a conveyance of the said lands as hereinafter mentioned.

IX. In every case in which any such question of disputed compensation shall be requir-Warrant for ed to be determined by the verdict of summoning Jury to be addressed to a Jury, the said Justices shall issue their Warrant to the Sheriff, requiring the Sheriff. him to summon a Jury for that pur-pose, and such Warrant shall be under the hands and seals of such Justices, or any two of them, and if such Sheriff be interested in the matter in dispute, such application shall be made to the Coroner of Madras, and every such Sheriff or Coroner shall have power, if he think fit, to appoint a deputy or assessor.

X. Throughout the enactments contained in this Act relating to the reference to a Jury, where the term "Sheriff" is used, the Provisions anplicable to Sheprovisions applicable thereto shall be held to apply to every Coroner, or riff to apply to Coroner. other person lawfully acting in his place.

XI. Upon the receipt of such Warrant, the Sheriff shall summon a Jury of twenty-four Jury to be indifferent persons, duly qualified to summoned. act as petit jurymen in the Supreme Court of Judicature at Madras, to meet at a convenient time and place, to be appointed by him for that purpose, such time not being less than fourteen nor more than twenty-one days after the receipt of such Warrant, and such place not being more than eight miles distant from the lands in question, unless by consent of the parties interested, and he shall forthwith give notice to the Justices of the time and place so appointed by him.

XII. Out of the Jurors appearing upon such summons, a Jury of twelve persons small be drawn by the Sheriff, in such manner Jury to be empannelled. as Juries for trials of issues joined in the Supreme Court of Judicature at Madras are by law required to be drawn, and if a sufficient number of Jurymen do not appear in obedience to such summons, the Sheriff shall return other indifferent men duly qualified as aforesaid, of the byestanders, or others that can specify be procured, to make up the Jury to the number aforesaid, and all parties concerned may have their lawful challenges against any of the Jurymen, but no such party shall challenge the array.

of actions at Law, and if either party so request in writing, the Sheriff shall summon before him any person considered necessary to be examined as a witness touching the matters in question, and on the like request the Sheriff shall order the Jury, or any six or more of them, to view the place or matter in controversy, in like manner as views may be had in the trial of actions in the said Supreme Court.

NIV. If the Sheriff make default in any of the matters hereinbefore required to be done by him in relation to any such trial or enquiry, he shall forfeit five hundred Rupees for every such offence, and such penalty shall be recoverable by the said Justices by action in the Supreme Court of Judicature at Madras; and if any person summoned and returned upon any Jury under this Act, do not appear, or if appearing he refuse to make oath, or in any other manner unlawfully neglect his duty, he shall, unless he show reasonable excuse to the satisfaction of the Sheriff, forfeit a sum not exceeding one hundred Rupees, and every such penalty payable by a Sheriff or juryman shall be applied by the said Justices in satisfaction of the costs of the enquiry, so far as the same will extend, or to the account of the assessment fund; and in addition to the penalty hereby imposed, every such juryman shall be subject to the same regulations, pains, and penalties as if such Jury had been returned for the trial of an issue joined in the said Supreme Court.

XV. If any person duly summoned to give evidence upon any such enquiry, and to whom a tender of his reasonable expenses shall have been made, fail to appear at the time and place specified in the summons, without sufficient cause, or if any person, whether summoned or not, who shall appear as a witness, refuse to be examined on oath touching the subject matter in question, every person so offending shall forfeit to the party aggrieved a sum not exceeding one hundred Ru-

XVI. Not less than ten days' notice of the time

XVII. If the party claiming compensation shall be resident within the said Presidency of Madras, and shall not appear at the time appointed for the enquiry, the Sheriff and the said Jury shall proceed in the said enquiry ex-parte, and the party claiming compensation shall be bound by such

the party claiming compensation shall be bound by such ex-parte proceedings, and the verdict and judgment recorded thereon, as if he had been present thereat.

XVIII. Before the Jury proceed to enquire of and assess the compensation or damage in respect of which their verdict is to be given, they shall make oath that they will truly and faithfully enquire of and assess such compensation or damage, and the Sheriff shall administer such oaths, as well as the oaths of all persons called upon to give evidence.

XIX. Where such enquiry shall relate to the value

of lands to be purchased, and also to compensation claimed for injury Sums to be paid for purchase of lands and for dadone or to be done to the lands held to be asmage, to be as-sessed separately. therewith, the Jury shall deliver their verdict separately for the sum of money to be paid for the purchase of the lands required for the works, or of any interest therein belonging to the party with whom the question of disputed compensation shall have arisen, or which, under the provisions herein contained, he shall be enabled to sell and convey, and for the sum of money to be paid by way of compensation for the damage, if any, to be sustained by the owner of the lands, by reason of the severing of the lands taken from the other lands of such owner, or otherwise injuriously affecting such lands, by the exercise of the powers of this Act.

XX. The Sheriff before whom such enquiry shall Verdict and Judgment to be held, shall give judgment for the purchase money or compensation asseconded. Sessed by such Jury, and the verdict and judgment shall be signed by the Sheriff, and being so signed shall be kept by the Clerk of the Peace among the records of the General or Quarter Sessions of the said Town of Madras, and such verdicts and judgments shall be deemed records, and the same or true copies thereof shall be good evidence in all Courts and elsewhere; and all persons may inspect the said verdicts and judgments, and may have copies thereof, or extracts therefrom, on paying for each inspection thereof eight annas, and for every one hundred words copied or extracted therefrom four annas, which copies or extracts the Clerk of the Peace is hereby required to make out, and to sign and certify the same to be true copies.

XXI. On every such enquiry before a Jury, where Costs of the enquiry how to be for a greater sum than the sum previborne. ously offered by the said Justices, all the costs of such enquiry shall be borne by the said Justices, but if the verdict of the Jury be given for the same, or a less sum than the sum previously offered by the said Justices, or if the owner of the lands, being resident within the said Presidency, shall have failed to appear at the time and place appointed for the enquiry, having received due notice thereof, one-half of the costs of summoning, empannelling, and recording the Jury, and of taking the enquiry, and recording the verdict and judgment thereon, in case such verdict shall be taken, shall be defrayed by the owner of the lands, and the other half by the said Justices, and each party shall bear his own costs, other than as aforesaid, incident to such enquiry.

XXII. The costs of any such enquiry shall, in case of difference, he settled by the Taxing Officer of the said Supreme Court at Madras, on an order of the same Court, to be obtained on petition in a summary way, on application of either party, and such costs shall include all reasonable costs, charges, and expenses incurred in summoning, empanuelling, and returning the Jury, taking the enquiry, the attendance of witnesses, the employment of Counsel and Attornies, recording the verdict and judgment thereon, and otherwise incident to such enquiry.

XXIII. In all cases when money shall be paid or required to be paid by the said Justinal Justices to any person, as a compensation, and costs. the same shall be paid by the said Justices out of the assessment fund, and the said money paid as a compensation as aforesaid, shall be subject to the same use or uses, and the same charges, liens, or incumbrances in all respects, as the interest or property for which such compensation shall be paid were subject at the time of the payment thereof.

XXIV. If any such costs shall be payable by the Payment of costs. said Justices, and if within seven days after demand such costs be not paid to the party entitled to receive the same, such party may

apply to any Judge of the said Supreme Court for an order directed to the said Justices, and requiring them to pay the said costs out of the assessment fund, and any Judge of the said Supreme Court shall issue such order accordingly, and in default of payment, the said costs shall be recoverable by distress of the goods and chattels of the said Justices, or any one of them, and any Judge of the said Supreme Court may issue his warrant of distress accordingly; and if any such costs shall be payable by the owner of the lands, or of any interest therein, the same may be deducted and re-tained by the said Justices out of any money awarded by the Jury to such owner, and the payment or deposit of the remainder, if any, of such money, shall be deemed payment and satisfaction of the whole thereof, or if such costs shall exceed the amount of the money so awarded or determined, the excess shall be recoverable by distress, and the said Justices shall issue their warrant accordingly.

XXV. The said Sheriff shall be allowed for every warrant to his bailiff for summoning Sheriff's fees. every Jury, ten rupees and no more, and for every return of a Jury four rupees and no more, and for attending the said Jury, or the empannelling thereof, fifteen rupees and no more, and such fees shall be paid as hereinbefore provided.

XXVI. The purchase money or compensation to be paid for any lands to be purchased or taken by the said Justices from any Compensation to absent parties party who, by reason of absence from to be determined a Surveyor the said Presidency, is prevented from appointed by two Justices. treating, or who cannot, after diligent enquiry, be found, and the compensa-

tion to be paid for any permanent injury to such lands, shall be such as shall be determined by the valuation of such able practical Surveyor as two Justices shall nominate for that purpose, as hereinafter mentioned.

XXVII. The said two Justices, upon such proof as Two Justices shall be satisfactory to them that any to nominate a such party is, by reason of absence from treating, or cannot, after diligent enquiry, be found, after due notice to him for that purpose, shall, by writing under their hands, nominate an able practical Surveyor, not being the Surveyor of the said Justices, for determining such compensation as aforesaid, and such Surveyor shall determine the same accordingly, and shall annex to his valuation a declaration in writing, subscribed by him, of the correctness thereof.

XXVIII. Before such Surveyor shall enter upon the duty of making such valuation as Declaration to aforesaid, he shall, in the presence of be made by the Surveyor. such Justices, or one of them, make and subscribe the declaration following at the foot of such nomination (that is to say,)

"I, A. B., do solemnly and sincerely declare, that I will faithfully, impartially, and honestly, according to the best of my skill and ability, execute the duty of making the valuation hereby referred to me.

" Made and subscribed in the presence of And if any Surveyor shall corruptly make such declaration, or having made such declaration shall wilfully act contrary thereto, he shall be guilty of a misdemeanor.

XXIX. The said nomination and declaration shall be annexed to the valuation to be made by such Surveyor, and shall be Valuation, &c. to be produced to preserved together therewith by the the owner of the said Justices, and they shall at all times produce the said valuation and other documents, on demand, to the owner of the lands comprised in such valuation, and to all other parties interested therein.

XXX. All the expenses of and Expenses to be incident to every such valuation shall be borne by the said Justices out of borne by promothe assessment fund.

XXXI. In estimating the purchase money or com-pensation to be paid by the said Jus-yand compension of the cases aforesaid, ney and compeu-sation, how to be regard shall be had by the Justices, or estimated Surveyor, as the case may be, not only to the value of the land to be purchased or taken by the said Justices, but also to the damage, if any, to be sustained by the owner of the lands, by reason of the severing of the lands taken from the other lands of such owner, or otherwise injuriously affecting such other lands by the exercise of the powers of this Act. XXXII. If the purchase money or compensation Purchase mo-which shall be payable in respect of any land or any interest therein pur-

conflicting claimchased or taken by the said Justices ants, and persons under disability, to be deposited from any corporation, tenant for life or in tail, married woman seised in her with Sub-Treaown right or entitled to dower, guar-dian, committee of lunatic or idiot. trustee, executor or administrator, or person having a partial or qualified interest only in such lands, and not entitled to sell or convey the same except under the provisions of this Act, or if conflicting claims are set up to such money or compensation, the same shall be paid to the Sub-Treasurer of the Government of Fort St. George, with the privity of the Accountant General of the said Presidency, to be placed to the account there of such Accountant General ex-parte the said Justices; and such monies shall remain so deposited until the same, under some decree or order of the said Supreme Court of Madras, be ordered to be paid or otherwise applied to, or for the benefit of the parties entitled thereto; and the receipt of the said Accountant General shall be a sufficient discharge to the said Justices for the

monies so paid by them as aforesaid. XXXIII. Such money may be so applied as afore-orders for ap-cation and in-Orders for ap-plication and in-vestment meanpetition of the party who would have while. been entitled to the rents and profits of the lands, in respect of which such money shall have been deposited; and until the money can be so applied, it may, upon the like order, be invested by the said Accountant General, in the purchase of Government or real securities, and the interest, dividends, and annual proceeds thereof, may be paid to the party who would for the time being have been entitled to the rents and profits of the lands.

XXXIV. All sums of money which may be payable by the said Justices in respect of All sums pay-able under conthe taking, using, or interfering with any lands under a contract or agreetract with persons not absolutely enment with any person who shall not be entitled to dispose of such lands, or to Sub-Treasurer. of the interest therein contracted to be sold by him, absolutely for his own benefit, shall be paid to the said Sub-Treasurer, with the privity of the said Accountant General, in manner aforesaid, and it shall not be lawful for any contracting party, not entitled as aforesaid to retain to his own use any portion of the sums so agreed or contracted to be paid for, or in respect of the taking, using, or interfering with any such lands, but all such monies shall be deemed to have been contracted to be paid for and on account of the several parties interested in such lands, as well in possession as in remainder, reversion, or expectancy; provided always, that it shall be in the discretion of the said Supreme Court to allot to any tenant for life, or for any other partial or qualified estate, for his own use, a portion of the sum so paid to the Sub-Treasurer as aforesaid, as compensation for any injury, inconvenience, or annoyance which he may be considered to sustain, independently of the actual value of the lands to be taken, and of the damage occasioned to the lands held therewith, by reason of the taking of such lands, and the making of the works.

XXXV. Where any purchase money or compensa-Supreme Court tion paid to the Sub-Treasurer as aforesaid, under the provision of this Act, may direct application of money shall have been paid in respect of any in respect of leases or reversions as they may a life or lives and years, or any estate in lands less than the whole fee simple thereof, or of any reversion dependent on any such lease or estate, it shall be lawful for the said Supreme Court of Madras, on the petition of any party interested in such money, to order that the same shall be laid out, invested, accumulated, and paid in such manner as the said Court may consider will give to the parties interested in such money the same benefit therefrom as they might lawfully have had from the lease, estate, or reversion in respect of which such money shall have been paid, or as near thereto as may be.

XXXVI. Upon deposit with the Sub-Treasurer, in Upon deposit being made, the bowner of fire lands to convey, or in default the lands to vest in the said Justices.

The purchase money or compensation agreed or awarded to be paid in respect of any lands purchased or taken by the said Justices under the provisions of this Act, the owner of such lands, including in such term all parties by this Act enabled to sell or convey lands, shall, when required so to do by the said Justices, duly convey such lands to the said

the said Justices, duly convey such lands to the said Justices, or as they shall direct; and in default thereof, or if he fail to adduce a good title to such lands to their satisfaction, it shall be lawful for the said Justices, if they think fit, to execute a deed poll, under the hands and scals of the said Justices, or any two of them, containing a description of the lands in respect of which such default shall be made, and reciting the purchase or taking thereof by the said Justices, and the names of the parties from whom the same were purchased or taken, and the deposit made in respect thereof, and declaring the fact of such default having been made, and thereupon all the estate and interest in such lands of or capable of being sold and conveyed by the party between whom and the said Justices such agreement shall have been come to, or as between whom and the said Justices such purchase money or compensation shall have been determined by a Jury, or by a Surveyor appointed by two Justices as herein provided, and shall have been deposited as aforesaid, shall vest absolutely in the said Justices of the Peace from time to time acting within and for the said Town and limits, upon trust for the purposes of this Act, and as against such parties, and all parties on behalf of whom they are hereinbefore enabled to sell and convey, the said Justices shall be entitled to immediate possession of such lands.

If the owner of any such lands purchas-Where parties refuse to convey, or do not show ed or taken by the said Justices, or of any interest therein, on tender of the purchase money or compensation title, or cannot be found, the pureither agreed or awarded to be paid in chase money to be respect thereof, refuse to accept the deposited same, or neglect or fail to make out a title to such lands, or to the interest therein claimed by him, to the satisfaction of the said Justices, or if he refuse to convey or release such lands, as directed by the said Justices, or if any such owner be absent from the Presidency, or cannot, after diligent enquiry, be found, or fail to appear on the enquiry before a Jury, as herein provided for, it shall be lawful for the said Justices to deposit the purchase money or compensation payable in respect of such lands, or any interest therein, with the Sub-Treasurer, in the name and with the pri-vity of the Accountant General of the said Presidency, to be placed to his account there, to the credit of the parties interested in such lands (describing them so far as the said Justices can do) subject to the control and disposition of the said Supreme Court.

XXXVIII.

Upon deposit being made, a receipt to be given, and the lands to vest upon a deed poll being executed.

Upon any such deposit of money as last aforesaid being made, the said Sub-Treasurer shall give to the said Justices, or to the party paying in such money by their direction, a receipt for such money, specifying therein for what and for whose use (described as aforesaid)

the same shall have been received, and in respect of what purpose the same shall have been paid in; and it shall be lawful for the said Justices, if they think fit, to execute a deed poll, under their hands, or the hands of any two of them, containing a description of the lands in respect whereof such deposit shall have been made, and declaring the circumstances under which, and the names of the parties to whose credit such deposit shall have been made, and thereupon all the estate and interest in such lands of the parties for whose use and in respect whereof such purchase money or compensation shall have been deposited, shall vest absolutely in the said Justices of the Peace from time to time acting within and for the said Town and limits, upon trust for the purposes of this Act, and as against such parties they shall be entitled to immediate possession of such lands.

XXXIX. Upon the application by petition of any Application of party making claim to the money so monies so deposited as last aforesaid, or any part thereof, or to the lands in respect whereof the same shall have been so deposited, or any part of such lands, or any interest in the same, the said Supreme Court may, in a summary way, as to such Court shall seem fit, order such money to be laid out, or invested, or may order distribution thereof, or payment of the dividends thereof, according to the respective estates, titles, or interests of the parties making claim to such money or lands, or any part thereof, and may make such other order in the premises as to such Court shall seem fit.

XL. If any question arise respecting the title to the lands in respect whereof such monies shall have been so paid or deposited as aforesaid, the parties respectively in possession of such lands, as being the owners thereof, or in receipt of the rents of such lands, as being entitled thereto at the time of such lands being

owners thereby of interesting to the tens of such lands being purchased or taken, shall be deemed to have been lawfully entitled to such lands, until the contrary be shown to the satisfaction of the said Supreme Court; and unless the contrary be shown as aforesaid, the parties so in possession, and all parties claiming under them, or consistently with their possession, shall be deemed entitled to the money so deposited, and to the dividends or interest of the securities purchased therewith, and the same shall be paid and applied accordingly.

XLI. In all cases of monies deposited with the Sub-Treasurer under the provisions of this Act (except where such monies shall ed.

Act except where such monies shall ave been so deposited by reason of the wilful refusal of any party entitled

thereto to receive the same, or to convey or release the lands in respect whereof the same shall be payable, or by reason of the wilful neglect of any party to make out a good title to the land required), it shall be lawful for the said Supreme Court to order the costs of the following matters, including therein all reasonable charges and expenses incident thereto, to be paid by the said Justices (that is to say,) the costs of the purchase or taking of the lands, or which shall have been incurred in consequence thereof, other than such costs as are herein otherwise provided for, and the costs of the investment of such monies in Government or real securities, and also the costs of obtaining the proper orders for any of the purposes aforesaid, and of the orders for the payment of the dividends and interest of the securities upon which such monies shall be invested, and for the payment out of Court of the principal of such mo-nies, or of the securities whereon the same shall be invested, and of all proceedings relating thereto, except such as are occasioned by litigation between adverse claimants.

XLII. Conveyances of lands to be purchased under the provisions of this Act, may be according to the form in Schedule (A) to this Act annexed, or as near thereto as the circumstances of the case will admit, or by deed in any other form which the said Justices may think fit, and all conveyances made according to the form in the

said Schedule, or as near thereto as the circumstances of the case will admit, shall be effectual to vest the lands thereby conveyed in the said Justices of the Peace from time to time acting within and for the said Town and limits upon trust for the purposes of this Act, and shall operate to merge all terms of years attendant by express declaration, or by construction of law on the estate or interest so thereby conveyed, and to bar, and to destroy all such estates tail, and all other estates, rights, titles, remainders, reversions, limitations, trusts, and interests whatsoever, of and in the lands comprised in such conveyances, which shall have been purchased or compensated for by the consideration therein mentioned; but although terms of years be thereby merged, they shall in equity afford the same protection as if they had been kept on foot, and assigned to a trustee for the said Justices to attend the reversion and inheritance.

XLIII. The costs of all such conveyances shall be borne by the said Justices, and such costs shall include all charges and expenses incurred, on the part as well of the seller as of the purchaser, of all conveyances and assurances of any such lands, and of any outstanding terms or interests therein, and of deducing, evidencing, and verifying the title to such lands, terms, or interests, and of making out and furnishing such abstracts and attested copies as the said Justices may require, and all other reasonable expenses incident to the investigation, deduction, and verification of such title.

XLIV. If the said Justices and the party entitled to any such costs shall not agree as to the amount thereof, such costs shall be taxed by the taxing Officer of the said Supreme Court, upon an order of the same Court, to be obtained on petition in a summary way by either of the parties; and the said Justices shall

way by either of the parties; and the said Justices shall pay what the said taxing Officer shall certify to be due in respect of such costs to the party entitled thereto, or in default thereof the same may be recovered in the same way as any other costs payable under an order of the said Court, or the same may be recovered by distress, in the manner hereinbefore provided in other cases of costs; and the expense of taxing such costs shall be borne by the said Justices, unless upon such taxation, one-sixth part of the amount of such costs shall be disallowed, in which case the costs of such taxation shall be borne by the party whose costs shall be so taxed, and the amount thereof shall be ascertained by the said taxing Officer, and deducted by him accordingly in his certificate of such taxation.

XLV. No party shall at any time be required to sell or convey to the said Justices a part only of any house or other building, if such party be willing and able to sell and convey the whole thereof.

XLVI. It shall be lawful for the said Justices to purchase or redeem the interest of the Power to remortgagee of any such lands which may be required for the purposes of deem mortgages. this Act, and that whether they shall have previously purchased the equity of redemption of such lands or not, and whether the mortgagee thereof be entitled thereto in his own right, or in trust for any other party, and whether he be in possession of such lands by the virtue of such mortgage or not, and whether such mortgage affect such lands solely or jointly with any other lands not required for the purposes of this Act, and in order thereto, the said Justices may pay or tender to such mortgagee the principal and interest due on such mortgage, together with his costs and charges, if any, and also six months' additional interest, and thereupon such mortgagee shall immediately convey his interest in the lands comprised in such mortgage to the said Justices, or as they shall direct, or the said Justices may give notice in writing to such mortgagee that they will pay off the principal and interest due on such mortgage at the end of six months, computed from the day of giving such notice; and if they shall have given any such notice, or if the party entitled to the equity of redemption of any such lands shall have given six months' notice of his intention to redeem the same, then, at the expiration of either of such notices, or at any intermediate period, upon payment or tender by the said Justices to the mortgage of the principal money due on such mortgage, and the interest which would become due at the end of six months from the time of giving either of such notices, together with his costs and expenses, if any, such mortgage shall convey or lease his interest in the lands comprised in such mortgage to the said Justices of the Peace acting within and for the said Town and limits, upon trust for the purposes of this Act.

XLVII. If in either of the cases aforesaid, upon of such payment or tender, any mert-Deposit gagee shall fail to convey or release his mortgage money on refusal to acinterest in such mortgage as directed by the said Justices, or if he fail to adduce a good title thereto, to their satisfaction, then it shall be lawful for the said Justices to deposit with the said Sub-Treasurer, in the manner provided by this Act in like cases, the principal and interest, together with the costs, if any, due on such mortgage, and also if such payment be made before the expiration of six months' notice as aforesaid, such further interest as would at that time become due; and it shall be lawful for them, if they think fit, to execute a deed poll, duly stamped in the manner hereinbefore provided, in the case of the purchase of lands by them; and thereupon, as well as upon such conveyance by the mortgagee, if any such be made, all the estate and interest of such mortgagee, and of all persons in trust for him, or for whom he may be a trustee, in such lands, shall vest in the said Justices of the Peace from time to time acting within and for the said town and limits, upon trust for the purposes of this Act, and they shall be entitled to immediate possession thereof, in case such mortgagee were himself entitled to such possession.

XLVIII. If any such mortgaged lands shall be of less value than the principal, interest, and costs secured thereon, the value Sum to be paid when mortgage exceeds the value of such lands, or the compensation to of the lands. be made by the said Justices in respect thereof, shall be settled by agreement between the mortgagee of such lands and the party entitled to the equity of redemption thereof on the one part, and the said Justices on the other part, and if the parties aforesaid fail to agree respecting the amount of such value or compensation, the same shall be determined as in other cases of disputed compensation; and the amount of such value or compensation, being so agreed upon or determined, shall be paid by the said Justices to the mortgagee, in satisfaction of his mortgage debt, so far as the same will extend, and upon payment or tender thereof, the mortgagee shall convey or release all his interest in such mortgaged lands to the said Justices of the Peace from time to time acting within and for the said town and limits, upon trust for the purposes of this Act.

XLIX. If, upon such payment or tender as aforesaid being made, any such mortgagee fail Deposit of moso to convey his interest in such mortney on failure to gage, or to adduce a good title thereto convey or deduce a good title. to the satisfaction of the said Justices, it shall be lawful for them to deposit the amount of such value or compensation with the Sub-Treasurer, in the manner provided by this Act in like cases, and every such payment or deposit shall be accepted by the mortgagee in satisfaction of his mortgage debt, so far as the same will extend, and shall be a full discharge of such mortgaged lands from all money due thereon; and it shall be lawful for the said Justices, if they think fit, to execute a deed poll, duly stamped, in the manner hereinbefore provided in the case of the purchase of lands by them; and thereupon such lands, as to all such estate and interest as were then vested in the mortgagee, or any person in trust for him, shall become absolutely vested in the said Justices from time to time acting within and for the said limits, upon trust for the purposes of this Act, and they shall be entitled to immediate possession thereof, in case such mortgagee were himself entitled to such possession; nevertheless, all rights and remedies possessed by the mortgagee against the mortgagor, by virtue of any bond or covenant, or other obligation, other than the right to such lands, shall remain in force in respect of so much of the mortgage debt as shall not have been satisfied by such payment or deposit.

If a part only of any such mortgaged lands be to be paid required for the purposes of this Act, Sum to be paid where part only of and if the part so required be of less mortgaged lands value than the principal money interest, and costs secured on such lands, and the mortgagee shall not consider the remaining part of such lands a sufficient security for the money charged thereon, or be not willing to release the part so required, then the value of such part, and also the compensation (if any) to be paid in respect of the severance thereof or otherwise shall be settled by agreement, between the mortgagee and the party entitled to the equity of re-demption of such land on the one part, and the said Justices on the other; and if the parties aforesaid fail to agree respecting the amount of such value or compensation, the same shall be determined as in other cases of disputed compensation, and the amount of such value or compensation, being so agreed upon or determined, shall be paid by the said Justices to such mortgage in satisfaction of his mortgage debt, so far as the same will extend, and thereupon such mortgagee shall convey or release to the said Justices of the Peace from time to time acting within and for the said town and limits, upon trust for the purposes of this Act, all his interest in such mortgaged lands, the value whereof shall have been so paid, and a memorandum of what shall have been so paid shall be endorsed on the deed creating such mortgage, and shall be signed by the mortgagee, and a copy of such memorandum shall at the same time (if required) be furnished by the said Justices, at their expense, to the party entitled to the equity of redemption of the lands comprised in such mortgage deed.

LI. If, upon payment or tender to any such mortgagee of the amount of the value or Deposit of mocompensation so agreed upon or deterney when refused mined, such mortgagee shall fail to on tender. on tender. convey or release to the said Justices, or as they shall direct, his interest in the lands in respect of which such compensation shall so have been paid or tendered, or if he shall fail to adduce a good title thereto, to the satisfaction of the said Justices, it shall be lawful for the said Justices to pay the amount of such value or compensation to the Sub-Treasurer, in the manner provided by this Act in the case of monies required to be deposited with such Sub-Treasurer as aforesaid, and such payment or deposit shall be accepted by such mortgagee in satisfaction of his mortgage debt, so far as the same will extend, and shall be a full discharge of the portion of the mortgaged lands so required from all money due thereon; and it shall be lawful for the said Justices, if they think fit, to execute a deed poll, duly stamped in the manner hereinbefore provided, in the case of the purchase of lands by them, and thereupon such lands shall become absolutely vested in the said Justices of the Peace from time to time acting within and for the said town and limits, upon trust for the purposes of this Act, as to all such estate and interest as were then vested in the mortgagee, or any person in trust for him, and in case such mortgagee were himself entitled to such possession they shall be entitled to immediate possession thereof; nevertheless every such mortgagee shall have the same powers and remedies for recovering or compelling payment of the mortgage money, or the residue thereof (as the case may be) and the interest thereof respectively, upon and out of the residue of such mortgaged lands, or the portion thereof not required for the purposes of this Act, as he would otherwise have had or been entitled to for recovering or compelling payment thereof, upon or out of the whole of the lands originally comprised in such mortgage.

Compensation to be usade in certain cases if mort-gage paid off before the stipulated time.

LII. Provided always that in any of the cases hereinbefore provided with respect to lands subject to mortgage, if in the mortgage deced a time shall have been limited for payment of the principal money thereby secured, and under the provisions hereinbefore contained the mortgagee

shall have been required to accept payment of his mortgage money, or of part thereof, at a time earlier than the time so limited, the said Justices shall pay to such mortgagee, in addition to the sum which shall have been so paid off, all such costs and expenses as shall be incurred by such mortgagee in respect of, or which shall be incidental to, the re-investment of the sum so paid off, such costs, in case of difference, to be taxed, and payment thereof enforced in the manner herein provided with respect to the costs of conveyances; and if the rate of interest secured by such mortgage be higher than at the time of the same being so paid off can reasonably be expected to be obtained on re-investing the same, regard being had to the then current rate of interest, such mortgagee shall be entitled to receive from the said Justices, in addition to the principal and interest hereinbefore provided for, compensation in respect of the loss to be sustained by him by reason of his mortgage money being so prematurely paid off, the amount of such com-pensation to be ascertained in case of difference as in other cases of disputed compensation; and until payment or tender of such compensation as aforesaid, the said Justices shall not be entitled as against such mortgagee to possession of the mortgaged lands under the provision hereinbefore contained.

LIII. If any lands shall be comprised in a lease for a term of years unexpired, part only of lands under lease taken, the rent to be apportioned.

LIII. If any lands shall be comprised in a lease for a term of years unexpired, part only of which lands shall be required for the purposes of this Act, the rent payable in respect of the lands comprised in such lease shall be apportioned between

the lands so required and the residue of such lands; and such apportionment may be settled by agreement between the lessor and lessee of such lands on the one part, and the said Justices on the other part, and if such apportionment be not so settled by agreement between the parties, such apportionment shall be settled by any Judge of the said Supreme Court, and after such appor-tionment the lessee of such lands shall, as to all future accruing rent, be liable only to so much of the rent as shall be so apportioned in respect of the lands not required for the purposes of this Act, and as to the lands not so required, and as against the lessee, the lessor shall have all the same rights and remedies for the recovery of such portion of rent as, previously to such apportionment, he had for the recovery of the whole rent reserved by such lease, and all the covenants, conditions, and agreements of such lease, except as to the amount of rent to be paid, shall remain in force with regard to that part of the land which shall not be required for the purposes of this Act, in the same manner as they would have done in case such part only of the land had been included in the lease.

Severance of the lands required from those not required, or otherwise by reason of the execution of the works.

LV. If any such lands shall be in the possession of any person having no greater interest therein than as tenant for a year on from year to year, and if such person having no greater interest therein than as tenant for a year of from year to year, and if such person having a person from year to year, and if such person having the required to give up possession of any lands so occupied by him before the expiration of his term or interest therein, he shall be entitled to compensation for the value of his unexpired term or interest in such lands, and for any just allowance which ought to be made to him by an in-ooming tenant, and for any

loss or injury he may sustain; or if a part only of such lands be required, compensation for the damage done to him in his tenancy, by severing the lands held by him, or otherwise injuriously affecting the same, and the amount of such compensation shall be determined by any Judge of the said Supreme Court, in case the parties differ about the same; and upon payment or tender of the amount of such compensation, all such persons shall respectively deliver up to the said Justices, or to the person appointed by them to take possession thereof, any such lands in their possession required for the purposes of this Act.

Where greater interest claimed than from year to year, lease to be produced.

LVI. If any party having a greater interest than as respect of any unexpired term or interest under any lease or grant of any such lands, the said Justices may re-

or grant in respect of which such claim shall be made, or the best evidence thereof in his power; and if after demand made in writing by the said Justices, such lease or grant, or such best evidence thereof, be not produced within twenty-one days, the party so claiming compensation shall be considered as a tenant holding only from year to year, and be entitled to conpensation accordingly.

By what Justices the powers of this Act shall be exercised.

LVII. The powers and authority by the preceding Sections of this Act given or reserved to the Justices of the Peace from time to time acting within and for the said Town and limits, and the trusts re-

spectively reposed in them as aforesaid, shall be exercised and performed by all the said Justices, or the major part of them, for the time being, acting as aforesaid in sessions assembled, unless the contrary shall be expressly provided by any of such Sections; and the said Justices shall have a common seal, and shall sue and be sued at law and in equity by the name of the Justices of the Peace acting within and for the Town and local limits of Madras, and the lands purchased and taken under the provisions of this Act shall be held by the said Justices from time to time acting as aforesaid upon trust for the improvement of the said Town and limits, according to the true intent and meaning of this Act, and for no other purpose whatever.

Power to remove projections and encroach-ments upon the

LVIII. The said Justices, or any two of them, or their Surveyor, shall cause notice in writing to be given to the owner or occupier of any building or land within the said Town and limits from which any gallery, balcony, roof, weather frame, spout, gutter, or other thing shall in future be made, which shall overhang or jut

into, or in any way project or encroach upon any public road, street, or other thoroughfare, that he do take down, remove, alter, or regulate the same, in such man-ner as the said Justices, or their said Surveyor, shall, by the said notice, require, and in case such owner or occupier shall refuse or neglect so to do for the space of fifteen days next after such notice shall have been given to him, the person or persons disobeying such notice shall be punishable on conviction before any two of the said Justices by fine not exceeding five hundred Rupees; and it shall be lawful for the said Justices, or their Surveyor, to enter any lands or buildings for the purpose of taking down or removing, or causing to be taken down and removed, any such gallery, balcony, roof, weather frame, spout, gutter, or other thing, projecting, over-hanging, or encroaching as aforesaid, and to remove or take down the same, or cause the same to be removed or taken down, and to sell and dispose of the materials thereof in like manner as is hereinafter directed concerning the taking down of ruinous buildings; provided always, that the person or persons to whom such notice shall be given, may, within fourteen days after the re-ceipt thereof, appeal therefrom to the said Justices, or the major part of them, assembled at the General Quarter Sessions, who shall have power to quash, alter, or confirm the same, and to make such order with respect to the costs thereof as to them shall seem just; provided also, that tiled roofs or weather frames of at least twelve feet high, above the surface of any public road, street, or other thoroughfare, may be projected to the extent of two feet over the same.

LIX. It shall be lawful for the said Justices, or their Surveyor, with the approbation of the said Justices, so assembled as aforesaid, to give permission in writing to the owner or occupiers of buildings in Certain projections into street permitted. public-thoroughfares, twenty-five feet in width and upwards, and of buildings in exposed situations, within the said Town and limits, to project tiled roofs or weather frames from the upper stories of their houses, to the extent of three feet beyond their foundation, or over any public road, street, or other thoroughfare.

LX. Where any scaffolding shall be used in or near any public road, street, or other tho-roughfare, in building, repairing, or As to scaffoldings. altering any house or building within the said Town and limits, it shall be lawful for any two of the said Justices, or their Surveyor, if they or he shall think fit so to do, to give notice in writing to the owner or occupier of such house or building, or other person directing the works, to cause such scaffolding masked or covered on the outside thereof so as to prevent anything falling therefrom to the injury of persons passing below, and if the owner, occupier, or other person as aforesaid, shall neglect to obey such notice, within a reasonable time after receiving the same, such offender shall be punishable on conviction before the said Justices, or the major part of them assembled at the General Quarter Sessions as aforesaid, by fine not exceeding five hundred Rupees.

LXI. The tiles of roofs within the said Town and limits shall be properly secured, so as As to the tiles to prevent their falling, to the injury of on the roofs of passengers, on any public road, street, or other thoroughfare, and the owner or occupier of any house the tiles of which are not so secured, shall, if he neglect to secure the same within one week after having received notice so to do from any two of the said Justices, or their Surveyor, be punishable, on conviction before such Justices, or the major part of them assembled at their General Quarter Sessions, by fine not exceeding five hundred rupees.

LXII. It shall be lawful for any two of the said Justices, or their Surveyor, to give no-As to water fall-ing from houses tice in writing to the owner or occu-pier of any house or building within upon the streets. the said town and limits, from which water may fall on any public road or ground, to put up such gutters, pipes, or channels for catching and conveying the water elsewhere, as may be necessary, and on noncompliance with such notice within one week from the time of receiving the same, the offender shall be punishable before such Justices, or the major part of them, assembled at the General Quarter Sessions, by fine not exceeding five hundred rupees.

LXIII. When any building or wall, or any part thereof, at or near any public road, street, or other thoroughfare, in any part of the said Town and limits, shall part of the said Town and limits, shall be considered by the said Justices or their Surveyor to be in a ruinous condition, and dangerous to passengers, or to the occupiers of the neighbour-ing buildings, it shall be lawful for the said Justices, or their Surveyor, to cause a sufficient boarding or protection to be put up for the safety of all passengers, and the said Surveyor shall cause notice in writing to be given to the owner and occupier of the said building or wall, if they or either of them be known and resident within the said limits, and if not, cause a notice to be affixed to the door or other exposed part of such building or wall, requiring such owner or occupier to repair or pull down the same within fourteen days from the date of such notice; and if such occupier or owner do not begin to repair or take down the same within such term of fourteen days, and complete the same as soon as the case will admit, it shall be lawful for the Surveyor to the said Justices to cause such building, or so much thereof as may be ruinous, to be taken down, and removed, or repaired, rebuilt, or otherwise secured, in such manner as shall be requisite, and to sell and dispose of the materials thereof, and by and out of the monies arising by the sale thereof to reimburse himself and all persons by him employed for the purpose, all the charges of putting up such boarding, and of taking down and removing such building, and of selling the said materials as aforesaid; and the surplus of such monies, if any, shall be paid to the owner of such house or building, upon personal demand thereof made by such owner; and if no such demand be made, then to the said Justices, for the benefit of the person or persons entitled thereto; and if no demand shall be made to the said Justices for the money so paid in or before the expiration of twelve months from the receipt thereof by the said Justices, the same shall be added to and become part of the said assessment fund.

LXV. In case any part of the land constituting the Useless roads public streets or roads, or other thomay be taken possession of by Golimits shall become useless and unrecessary for the purpose of a public highway, it shall be lawful for the said Governor in Council to direct the Collector of Madras to take possession thereof for the use of the Honorable the East India Company, and the said Collector shall take possession thereof accordingly.

LXVI. Every Head Builder, Master Carpenter, Master Mason, or labourer, who shall, in erecting, rebuilding, or repairing, altering, or adding to any building within the said town and limits, knowingly offend against the provisions of this Act, shall be punishable, on conviction before such Justices, or the major part of them assembled at the General Quarter Sessions, by fine not exceeding five hundred rupees.

LXVII. The amount of all fines and penalties, and costs in the nature of fines and penalties, and ties, that may be incurred and payable under this Act, shall be levied by Warrant under the hands and scals of two or more of the said Justices so assembled, and when received shall be added to and form part of the said assessment fund; and if on such distress property belonging to such offenders sufficient to make good the penalty be not found, such offender shall or may be committed by Warrant under the hands and scals of two or more of the said Justices so assembled, to the house of correction, with or without hard labour, at the discretion of the said Justices, for any time not exceeding three months, unless the said penalty be sooner paid.

LXVIII. No distress levied by virtue of this. Act shall be deemed unlawful, nor shall be deemed unlawful, nor shall the party making the same be deemed a trespasser, on account of any proceedings relating thereto, nor shall such party be deemed a trespasser ab initio on account of any irregularity afterwards done by him; but all persons aggrieved by such irregularity may recover for the special damage only by action on the case, and not by any other action whatever.

LXIX. If any party shall have committed any irregularity, trespass, or other wrongful Tender of a-proceedings in the execution of this mends. Act, or by virtue of any power or authority thereby given, if before action brought in respect thereof such party tender sufficient amends to the party injured, such last mentioned party shall not recover in any such action, and if no such tender shall have been made, it shall be lawful for the defendant in such action, by the leave of the Court where such action shall be pending, at any time before issue joined, to pay into Court such sum of money as he shall see fit; thereupon such proceedings shall be had as in other actions when the defendant is allowed to pay money into Court.

LXX. No action or suit shall be commenced against any person or persons for any thing done in pursuance of this Act until twenty-one days after notice in Notice of ac-tion to be given. Limitation of acwriting of an intention to bring such action or suit has been given to the person or persons against whom such action or suit shall be brought, nor after the expiration of three calendar months next after the act committed, and the defendant in every such action or suit may plead the general issue, and give this Act and any special matter in evidence at the trial, and that the matter or thing for which such action or suit is brought was done in pursuance and by the authority of this Act, and if the said matter or thing appear to have been so done, or if it shall appear that such action or suit was brought before the expiration of twenty-one days after such notice was given as aforesaid, or that suffi-cient satisfaction was made or tendered before such action was brought, or if any such action or suit be not commenced within the time herein for that purpose limited, then the Court, in every such action or suit, shall find for the defendant therein, and if a verdict be found for the defendant, or if the plaintiff in any such action or suit become non-suited, or discontinue, or suffer a discontinuance of any such action or suit, or if in any such action or suit judgment be given for the defendant therein on demurrer, or by default or otherwise, then, and in any of the cases aforesaid, the defendant shall have judgment to recover double costs of suit, and shall have such remedy for recovering the same as any defendant may have by law for costs in other cases.

LXXI. The following terms and expressions whereever used in this Act shall have the
several meanings hereby assigned to
them, unless there be something either
in the subject or context repugnant to such construction; that is to say—

Words importing the singular number only, shall include the plural number, and words importing the plural number only, shall include the singular number.

Words importing the masculine gender only, shall include females.

The word "month" shall mean calendar month.

The word "lands" shall extend to lands, tenements, and hereditaments of any tenure, and also messuages and other erections, and buildings thereupon.

The word "lease" shall include an agreement for a lease.

The word "oath" shall include affirmation in the case of Quakers or Hindoos, or other declaration or solemnity lawfully substituted for an oath, in the case of any other persons exempted by law from the necessity of taking an oath.

The words "Assessment Fund" shall mean the monies received by the said Justices by virtue of any Act or Acts of Parliament, or of the Legislative Council of India, whereby the said Justices are authorized and empowered to make, raise, and levy an Assessment or Assessments on the owners or occupiers of Houses, Buildings, and Grounds in the said Town and limits.

The following Extract from the Proceedings of the Hon'ble the President of the Council of India in Council, in the Legislative Branch of the Home Department, under date the 12th December 1851, is published for general information.

Read a second time the Draft of a proposed Act dated the 16th November 1849, and published in the Calcutta Guzette of the 21st November 1849, to amend the law for the dismissal of Pleaders in Bengal.

Resolution .- The President in Council resolves that the following amended Draft on the subject be published for general information.

ACT No. - of 1851.

An Act to amend the Law relating to Pleaders in Bengal.

Whereas the laws in force relating to Pleaders, practising in the Courts of the East India Company, in the Presidency of Fort William in Bengal, require amendment, it is enacted as follows:

- I. Clause 4, Section V. Regulation XXVI. of 1814, and Sections VI., VII., VIII., X., XI., XIII., XIV., XV., Clause 3 Section IX., and Clause 6 Section XX. of Regulation XXVII. of 1814, and Section XVIII. Regulation X. of 1829, of the Bengal Code, and Sections X. and XI. of Act I. of 1846, are hereby repealed.
- II. Any Pleader practising in the said Courts of the said Presidency shall be liable to dismissal on proof of his conviction by a competent Court of a Criminal offence, or on proof of a declaration by a competent Court, that he has knowingly committed a breach of trust, or for fraudulent or dishonest conduct in the discharge of his professional duty.
- III. When any Pleader is charged by any person or Court with any offence or misconduct, rendering him liable to dismissal, the Court competent to make an order for his dismissal shall serve or cause to be

served upon such Pleader a copy of the charge or charges brought against him, and also a notice of the day appointed by the said Court for the hearing of such charge or charges, and such copy and notice shall be served upon the said Pleader at least 20 clear days before the day appointed for such hearing, and on the hearing of the said charge or charges the Court shall receive all such relevant evidence as shall be properly tendered by or on behalf of the Court or party bringing the charge or charges, or by the said Pleader, and shall proceed to adjudicate on the said charge or charges in a summary way, and shall record its decision, and the reasons on which the same is grounded. Provided always, that the Court which is competent to dismiss a Pleader shall also be competent to bring a charge or charges, and proceed against him as aforesaid, and may also hear and adjudicate upon such charge or charges in manner hereinbefore mentioned.

IV. The power of dismissing Pleaders practising in either of the Sudder Courts of the said Presidency is vested in the Judges of those Courts respectively; the power of dismissing Pleaders practising in the Courts of the Zillah Judges, or in Courts subordinate to them, in the said Presidency, is vested in the Zillah Judges respectively.

V. An appeal from the order of any Zillah Judge, for the dismissal of a Pleader, may be made to the Sudder Dewanee Adawlut, according to the Rules in force for the admission of appeals.

VI. It shall not be lawful for any of the said Courts of the said Presidency to impose any fine on any Pleader practising in the said Courts, except such fine as may be imposed under the Provisions of Act XXX. of 1841.

The following Draft of a proposed Act was read in Council for the first time on the 12th December 1851. - of 1851. ACT No. -

An Act for securing the Abkarry Revenue of Madras.

For better securing the Abkarry Revenue of the Town and Suburbs of Madras, It is enacted as follows:

- I. Regulation I. of 1813 of the Madras Code, and so much of Clause 159 of an Act of Parliament num-bered Chapter LH. of the Statutes passed in the thirty-ninth year of King George the Third, as relates to the sale of Arrack or other spirituous liquors within the Town of Madras, and to the punishment of un-licensed traders in spirits or spirituous liquors within the said Town, are repealed.
- II. The collection of the Revenue arising from the retail sale of spirituous or fermented liquors within the Town and Suburbs of Madras, shall be under the charge of the Collector of Madras, who shall per-form the duties connected therewith under the control of the Board of Revenue.
- III. The Collector may appoint Conicopolies, Pygusts, Jemadars, Peons, and other Officers for collection of the said Revenue and prevention of smuggling; and the Officers so appointed, besides their ordinary respective designations, shall be styled "Abkarry Officers."
- 1V. Every person who shall sell by retail any spirituous or fermented liquors within the Town and

Suburbs of Madras without a licence for that purpose under the hand and seal of the Collector of Madras, shall be liable to a fine not exceeding five hundred rupees for each sale, but this enactment shall not apply to wholesale dealers selling such small quantities of Beer, Wine, or Spirits, as may appear to the Collector to be intended only as samples.

V. A sale of European Spirits in a less quantity than two and a half gallons old Wine measure. (i. e. one dozen quart bottles,) and of Arrack or Rum, or any other Spirits manufactured to the eastward of the Cape of Good Hope, in a less quantity than one quart, and of English and Foreign Beer or Wine in a less quantity than six quart bottles and of Toddy in a less quantity than one quart, shall be deemed a retail sale within the meaning of this Act.

VI. The Board of Revenue shall have authority at all times to regulate the form and provisions of licences to be granted under this Act, and to alter and add to the conditions thereof; and each licence shall distinctly specify the kind or kinds of liquor the holder is authorized to sell, the manner in which and source whence such liquor is to be supplied to him, the excise duty not exceeding rupees 3-8-0 per gallon, which he shall pay upon it, whether it be provided by the Offi-cers of Government or otherwise, or should a fee up-on the licence be substituted for the said excise duty, the amount of such fee. The licence shall further specify the district or place, street or road, and house or shop in which the sale is to be carried on.

VII. The sale of Arrack or Rum, or other country Spirits, or of Toddy, in quantities larger than those specified for each article in Section V. of this Act, is prohibited; and every person who shall act in breach of this prohibition shall be hable to the fine prescribed in Section XV. for the illicit possession of these articles, but this prohibition does not apply to the sale of spirituous or fermented liquors imported into Madras under passes from the Collector, or other Officer duly empowered in that behalf, and supplied by wholesale to licensed retail dealers, or to the sale of Rum under bond for exportation by sea, and covered by a certificate to that effect.

VIII. Every person taking out a licence for the retail sale of spirtuous or fermented liquors or intoxicating drugs under this Act, shall execute a counterpart engagement in exact conformity with the tenor of such licence.

IX. The Collector may withhold or recall a licence, if any of the conditions upon which the licence is granted be not complied with, or with the sanction of the Board of Revenue for any other cause, giving fifteen days' notice of such withdrawal; and any person selling by retail any spirituous or fermented liquor within the "Town and Suburbs of Madras," whilst such licence is withheld, or after it is recalled, shall be subject to all the penalties provided by this Act for the unlicensed sale of spirituous or fermented liquors.

No spirituous liquor manufactured Eastward of the Cape of Good Hope shall be removed from the Sea Custom House to any Warehouse, Shop, or private dwelling, or from one Warehouse, Shop, or private dwelling to another, without the Permit of the Collector of Madras, which Permit must accompany all liquors so removed, but persons having paid the Sea Custom Duty shall be entitled to dispose of such liquor by wholesale for exportation beyond the limits of Madras and its Suburbs, such export to be made under Permits, to be granted by the Collector of Madras at his discretion, and on proof to his satisfaction that the Spirits are intended to be exported.

XI. All spirituous liquors manufactured by the European method of distillation shall, when imported into the Town and Suburbs of Madras by land, be placed under the charge of the Collector of Sea Customs, who will have them guaged and tested. The

said liquors may be either kept in the custody of the Importer on his furnishing security for its exportation or sale, under the provisions of Section II. Act XXXII. of 1845, or in the joint custody of the Collector of Sea Customs and the Importer, or it may be de-posited in the Sea Custom Warehouse on payment of the usual Warehouse rent. When kept in such joint custody, or deposited in such Warehouse as aforesaid, no security for its exportation or sale shall be required, and the amount and nature of the secu-rity required to be furnished when such liquors are kept in the custody of the Importer shall be fixed by the Governor of Fort St. George in Council, who shall also determine the time to be allowed for its expor-

XII. It shall not be lawful for the Justices to grant a licence to open or establish, or keep open any Lodging House, Boarding House, Eating House, Punch House, Coffee Room, Tavern, Hotel, or any other House of Public Entertainment within their other House of Public Entertainment, within their Jurisdiction, in which any spirituous or fermented liquor may be sold to any person who has not taken out a licence for the retail sale of such liquor, and any such licence granted by the Justices shall be-come void whenever the licence for the retail of such liquor granted to such person shall be withheld or recalled by the Collector under this Act. Provided always, that on the representation of the Superintendent of Police to the Collector, that any such house of public entertainment as aforesaid is kept as a disorderly house, or that the keeper thereof is for any reason, or in consequence of misconduct, (such reason or misconduct to be specially assigned by the Superintendent,) unfit to receive or retain any such licence, then and in such case the said Collector shall forthwith revoke any licence already granted by him to such keeper of any such house of public entertain-

XIII. The Collector, after demand made in writing, may levy any arrears of Tax, duty, or fee, due on account of any license granted under this Act, by distress and sale of the Goods and Chattels of the person from whom the same is due, provided that no such arrears shall be recoverable after the end of two years next after the same shall have become due, or next after an acknowledgment of the same in writing shall have been given by the person by whom the same is payable.

A breach of any of the conditions of a license granted under this Act shall, besides forfeiture of the license, be punishable by a fine not exceeding Fifty Rupees, and such fine shall be recoverable from the licensed dealer, notwithstanding that such breach may have been owing to the default or carelessness of the servant or other person in charge of the shop or place of sale.

XV. Any person, not being a licensed dealer, baving in his possession, and any person carrying within the Town and Suburbs of Madras any greater quantity of spirituous or fermented liquors, (excepting English and Foreign Beer, Wine, and Spirits,) than the quantity specified for each article in Section V., and not being protected by a Pass or Permit from the Collector, or other Officer duly empowered in that behalf, shall be liable to a fine not exceeding Five Hundred Rupees.

XVI. Beside the penalties above specified for the illicit sale, possession, and carrying of spirituous or fermented liquors, all such liquors found in the possession of any offender against this Act shall be seized and confiscated, together with the Vessels, Packages, and Coverings in which such liquors are found, and the animals and conveyances used in carrying them shall also be liable to seizure and confiscation.

XVII. Any Abkarry Officer above the rank of Peon, may enter, inspect, and search at any time, by

day or by night, for any of the purposes contemplated in this Act, the house or shop in which any heensed retail dealer shall carry on the sale of spirituous or fermented liquor under this Act.

XVIII. Every person, holding a licence for the retail sale of spirituous or fermented liquors, shall keep such licence at the house or shop specified in the licence, and shall show the licence on the demand of any Abkarry Officer who shall desire to see the same; and any licensed dealer who shall refuse or be unable to produce his licence on the demand of any Abkarry Officer, shall be liable to a fine not exceeding Two Hundred Rupees.

XIX. Any Abkarry Officer may stop and detain any person having possession of or carrying in any Public Road, Street, Thoroughfare, or place, or in any open shop, any spirituous or fermented liquors without a Pass, or otherwise liable to confiscation under this Act, and may seize the liquors, with the Vessels, Packages, and Coverings in which the liquors are found, and the animals and conveyances used in carrying them.

XX. If the Collector has good reason to believe, either from information given by any Abkarry Officer or other person, to be taken down in writing, or from his own knowledge, or from the proceedings in any other case, that any spirituous or fermented liquor, liable to confiscation under this Act, is kept or concealed in any place, the Collector, by Warrant under his hand, may empower any Abkarry Officer, above the rank of Jemedar of Peons, between sunrise and sunset, but always in the presence of a Constable or other Officer of the Peace, to enter into every such place where any such liquor is suspected to be kept or concealed, and to seize and carry away such liquor, and in case of resistance, to break open any door, and to force and remove any other obstacle to such entry, search, seizure, or removal, as aforesaid, and to arrest and detain the owner or occupier of the premises, with all parties whom he suspects to be concerned in the unlawful keeping or concealing of such liquor whom he shall find on the premises. Provided that where there is ground to suspect that such liquor is unlawfully concealed in any apartment of the women, in houses belonging to the classes whose women do not appear in public, the Officer charged with the execution of the Warrant shall follow as closely as may be the rules for the seizure of property so concealed adopted by the Supreme Court of Judicature at Fort St. George.

XXI. All Constables and other Ministerial Officers of the Peace are required to aid the Abkarry Officers in the due execution of this Act upon Notice given or request made by any such Abkarry Officer; and any Officer who, without lawful excuses, shall refuse or neglect to assist as aforesaid, on being required to do so, shall be liable to the penalty prescribed by Section XXIX. of this Act for Abkarry Officers conviving at the escape of a person arrested under this Act.

XXII. Whenever an Abkarry Officer, duly authorized under this Act, shall arrest any person, or shall seize any spirituous or fermented liquor, or shall enter any house or shop for the purpose of searching for such illicit liquors, he shall carry the person arrested, with the illicit liquors seized, with all convenient despatch to the Collector, and shall, within twenty-four hours thereafter, make a full report to the Collector of all the particulars. And the Collector, after such further inquiry as he deems necessary, shall forthwith either release the person arrested, or send him in custody to the Superintendent of Police, or one of his Deputies.

XXIII. Every person who shall maliciously give false information against any person, for being engaged in the unlicensed sale of spirituous or fermented liquors, or for having in his possession, or carrying, or

in respect of there being in any house or shop any spirituous or fermented liquors, in contravention of this Act, shall be liable to a fine not exceeding Five Hundred Rupees, or to imprisonment in the Common Jail for a period not exceeding six months, or to both.

XXIV. Every person who shall obstruct or molest any Abkarry Officer, or any person acting in aid of such Officer, in the due execution of this Act, shall be liable to a fine not exceeding Five Hundred Rupees, and such person shall be further liable, if any affray or breach of the peace shall happen in consequence of his resistance, on conviction of the same before a competent tribunal, to such punishment as is prescribed by Law for cases of affray and Breach of the Peace, in addition to the penalty above prescribed for resistance of process.

XXV. Any Abkarry Officer who shall delay carrying to the Collector any person arrested, or any illicit liquors seized under this Act, or who shall neglect to report the particulars of an arrest, seizure, or search within twenty-four hours thereafter, shall be liable to a fine not exceeding Two Hundred Rupees.

XXVI. Any Abkarry Officer who shall vexatiously and unnecessarily seize the goods or chattels of any person on the pretence of seizing or searching for illicit spirituous or fermented liquors, or who shall vexatiously and unnecessarily arrest any person, or commit any other excess not required for the execution of his duty, shall be liable to a fine not exceeding Five Hundred Rupees.

XXVII. The provisions regarding Distilleries and Stills in Sections IV. V. VI. Regulation I. of 1820, of the Madras Code, and Act XXXII, of 1845, shall apply and be in force within the town and suburbs of Madras, except that the powers vested in the Criminal Judge by Section IV. Clause 5, and Section IX. Clause 9, Regulation I. of 1820, of the Madras Code, and in the Session Judge and Subordinate Judge of the Zillah, by Sections IV. V. Act XXXII, of 1845, shall be exercised within the said Town and Suburbs by the Superintendent of Police, and not by any such Criminal Session or Subordinate Judge.

XXVIII. It shall be competent to the Governor of Fort Saint George in Council, or to any Officer duly empowered by him in that behalf, to revise from time to time the forms of licences to be granted under Section IV. Regulation I. of 1820, of the Madras Code, for the establishment of Distilleries for manufacturing Rum, Arrack, or other Spirits, by process of distillation similar to the European process, and to introduce into such forms of licences such provisions and stipulations as may seem to be advisable, anything in Section II. Act XXXII. of 1845 to the contrary notwithstanding.

XXIX. Any Officer employed in the Abkarry Department who shall unlawfully release or connive at the escape of any person arrested under this Act, or connive at the sale of spirituous or fermented liquors without a licence, or by any licensed dealer contrary to the terms of such licence, or act in a manner inconsistent with his duty, for the purpose of enabling any person to do anything whereby any of the provisions of this Act may be evaded or broken, or the Abkarry Revenue be detrauded, shall be liable to a fine not exceeding Five Hundred Rupees.

XXX. Any Officer employed in the Abkarry Department who shall ask or take any gratuity not authorized by any law or order of Government, or of the Board of Revenue, in consideration of doing or of omitting to do any act in his official capacity, and any person who shall offer a bribe to any such Officer, in order to induce such Officer to act in a manner inconsistent with his duty, shall be liable for every such offence to a fine not exceeding Five Hundred Rupees.

XXXI. When any Goods or Chattels shall be seized by an Abkarry Officer, as liable to confiscation under this Act, such seizure shall, upon information

exhibited by order of the Collector, be heard and determined in a summary manner by the Superintendent of Police, or one of his Deputies, who shall cause the persons to whom such Goods and Chattels belong to be summoned to appear, and upon their appearance, or default, shall examine into the cause of the seizure thereof, and give judgment; and, if such jugdment shall be for confiscation of the Goods or Chattels seized, shall issue his warrant to the Collector for the sale or disposal thereof, according to such orders as the Collector may receive from the Board of Revenue.

XXXII. Whenever any Goods or Chattels shall be seized as aforesaid, and within one calendar month no person shall appear before the Collector to claim the same, the Superintendent of Police, or one of his Deputies, shall examine into the cause of the seizure, at a place and time of which notice shall have been given by the Collector in the Fort St. George Gazette, and give judgment for the confiscation of such of the Goods and Chattels as upon such examination shall appear to him liable to forfeiture; and upon confiscation thereof shall issue his warrant for the disposal of them, as if the owner had been summoned to attend before the said Superintendent, or one of his Deputies.

XXXIII. All fines leviable under this Act shall be adjudged by the Superintendent of Police, or one of his Deputies, any of whom, upon information exhibited before him by order of the Collector, shall, within three calendar months next after the act by which the fine was incurred, and not afterwards, summon the parties accused, and upon their appearance or default, shall examine into the matter, and upon due proof made thereof by the voluntary confession of the parties, or by the oath or solemn affirmation (in cases wherein a solemn affirmation is receivable by law instead of an oath), of one or more creditable witnesses, shall give judgment accordingly; and, in default of payment of any fine to which an offender is adjudged, he shall be liable, by Warrant of the said Superintendent of Police, or one of his Deputies, to imprisonment in the Common Jail for a period not exceeding six months, or until the fine be sooner paid.

XXXIV. Whenever any person shall be convicted of an offence against this Act after having been previously convicted of a like offence, he shall be liable, in addition to the penalty attached to such offence, to imprisonment in the Common Jail, for a period not exceeding six months, and a like punishment of imprisonment not exceeding six months shall be incurred, in addition to the punishment which may be inflicted for a first offence, upon every subsequent conviction after the second.

XXXV. One half of all fines levied from persons convicted of the illicit possession, carrying, or sale of spirituous or fermented liquors, and of the proceeds from the sale of liquors, vessels, packages, conveyances, stills, &c., confiscated under this Act, shall, upon adjudication of the case, be awarded in such proportion as the Superintendent of Police, or one of his Deputies, adjudicating as aforesaid, may think proper, to the Officer or Officers who apprehended the offender, or seized the illicit liquois or other articles, and the other half shall be given to the informer; and if no fine be realized, the Board of Revenue may grant such reasonable reward, not exceeding the sum of Two Hundred Rupees, as may appear to them fit. Provided that the Board of Revenue may determine, by General Order, what class of Abkarry Officers shall receive rewards, and what classes shall have no title to share therein.

· XXXVI. All fines levied under this Act, the disposal of which is not especially provided for, shall belong to Government; but the Officer adjudicating the case may grant any portion thereof, not exceeding one half, as rewards to informers, or as compensation to parties injured by any proceedings under this Act.

XXXVII. No writ of Certiorari shall be issued at the suit of any party out of the Supreme Court of Judicature, to supersede, stay, remove, or in any wise affect any information or judicial proceeding before the Superintendent of Police, or any of his Deputies, in pursuance of this Act; and no judgment thereupon shall be quashed; except for error of law apparent on the face of the judgment.

XXXVIII. All actions and prosecutions to be instituted against the Collector, or any Abkarry Officer, or any person acting in aid of any such Officer, for anything done in pursuance of this Act, shall be tried and determined in the Civil Courts established by the East India Company in the Zillah of Chingleput, notwithstanding that the cause of action, in respect of which such action is brought, arose, or the defendant therein reside, within the limits of the Town of Madras, and every such action shall be brought within three Calendar Months after the fact committed, and not afterwards, and notice in writing of such action, and of the cause thereof, shall be given to the defendant one Calendar Month at least before the commencement of the action, and no plaintiff shall recover in any such action, if tender of sufficient amends shall have been made before such action brought, or if after action brought, a sufficient sum of money shall have been paid into Court with costs by or on behalf of the de-

XXXIX. The Collector, in respect of the duties to be performed by him under this Act, shall have power to spunish any contempt committed in his presence in open Cutcherry by the imposition of a fine not exceeding Two Hundred Rupees, commutable, if not paid, to imprisonment in the Common Jail for a period not exceeding one month. Provided that an appeal from any order passed under this Section, shall lie to the Board of Revenue, and the decision of the Board thereon shall be final.

XL. The following words and expressions in this Act shall have the several meanings hereby assigned to them, unless there be something either in the subject or context repugnant to such construction, that is to say, words importing the singular number only shall include the plural, and words importing the plural number only shall include the singular, words importing the masculine gender only shall include females. The words "Collector of Madras" shall mean the Officer who may at any time be charged with the superintendence and collection of the Public Revenue within the Town of Madras, although such Officer may not be officially designated "Collector of Madras." The words "Town and Suburbs of Madras," shall include the Town of Madras, the limits of the Supreme Court of Judicature at Madras as declared and described by the 12th Section of Regulation II. of 1802, of the Madras Code, and the district comprised within eight miles beyond any part of those limits.

The following Extract from the Proceedings of the Hon'ble the President of the Council of India in Council, in the Legislative Branch of the Home Department, under date the 12th December 1851, is published for general information.

Read a second time the Draft of a proposed Act, dated the 11th July 1851, and published in the Calcutta Gazette of the 16th July 1851, for summary suits for arrears of rent, and sales of saleable tenures to be held within the judicial district in which the lands are situated.

Resolution .- The President in Council resolves that the following amended Draft on the subject ba published for general information :-

For the trial of Summary Suits for Arrears of Rent, and for the Sales of Saleable Tenures, within the Judicial District in which the Lands are situated.

Whereas by Regulation VIII, of 1831 of the Bengal Code, the hearing and decision of summary suits or claims relating to arrears or exactions of rents were transferred from the Judges of the Zillah or City Courts to the Collectors of the several Districts; and whereas by Regulation VII. of 1832, of the Bengal Code. the superintendence of the sales of Putnee Talooks, and other saleable tenures of the class specified in Clause 1, Section 8, Regulation VIII. of 1819, was transferred to the Collector or Deputy Collector of Land Revenue, or Head Assistant to the Collector or Deputy Collector, subject to an appeal to the Commissioner of Revenue for the Division; and whereas by Act VIII. of 1835 the conduct of sales of Talooks or other saleable tenures in execution of summary decrees for rent, in conformity with Regulation VII. of 1799, was transferred to the Collectors of Land Revenue; and whereas doubts have been entertained as to the District within which such summary suits or claims should be decided, and such sales made, by reason that the jurisdiction of the several Zillah and City Courts is not conterminous with the jurisdiction of the several Collectors of Land Revenue,-It is enacted as follows :-

I. No order in any such summary suit, and no such sale made as aforesaid, which has not been questioned before a Court of competent judicature before the passing of this Act, on the ground of having been decided or made by a Collector having no jurisdiction therein, shall be liable to be annulled or disputed on that ground.

II. Where the lands which are the subject of such summary suits or such sales as aforesaid, are situate in a judicial district other than that of the Collector or Deputy Collector who receives the sudder malguzarree of such lands, all such summary suits and sales as aforesaid shall be tried and decided, or made by the Collector or Deputy Collector who has jurisdiction in the greater part of the judicial district in which the

lands are situated.

III. Where the lands which are the subject of such summary suits or such sales as aforesaid are situate in a judicial district which is divided into two or more Collectorate districts, all such summary suits and sales as aforesaid shall be tried and decided, or made by the Collector or Deputy Collector who has jurisdiction in that part of the judicial district in which the lands are situated.

IV. Sections 9, 11, 13, 15, and 17 of Regulation VIII. of 1819, of the Bengal Code, shall be applicable to sales of under tenures under the Provisions of Act

VIII. of 1835.

An Act for consolidating and amending the Regulations of the Calcutta Police.

For consolidation and amendment of divers Rules. Ordinances, and Regulations which from time to time have been passed in Council, and registered in the Supreme Court, for the good order and civil government of the Presidency and Settlement of Fort Wil-

liam in Bengal, It is enacted as follows:

1. The Rules, Ordinances, and Regulations for the good order and civil government of the Settlement of Fort William in Bengal, passed in Council, and registered in the Supreme Court, on the several dayshereinafter mentioned, are repealed, but not so as to revive any other Rules, Ordinances, and Regulations thereby repealed.

Justice of the Peace, charged with having in his possession, or in his premises with his knowthing stolen or unlawfully ob-tained, and shall declare that he received the same

from some other person, or that he was employed as a carrier, agent, or servant to convey the same for

some other person, such Justice shall cause every such person, and also if necessary every former or pretended purchaser, or other person through whose possession the same shall have passed, to be brought before him and examined, and shall examine witnesses upon oath touching the same, and if it shall appear to such Justice that any person shall have had posbelieve the same to have been stolen or unlawfully obtained, such person shall be deemed guilty of a mis-demeanor, and shall be liable to a penalty not exceeding one hundred rupees, or, in the discretion of the Justice, may be imprisoned, with or without hard labour, for any time not exceeding three Calendar months. Every such person shall be deemed to have had possession of such thing at the time and place when and where the same shall have been found or seized, and the possession of a carrier, agent, or servant shall be deemed to be the possession of the person who shall have employed such carrier, agent, or servant, to keep or convey the same.

V. If information shall be given on oath to a Justice of the Peace that there On suspicion of goods is reasonable cause for suspectbeing stolen or unlaw-fully obtained, Justice that anything stolen or unlaw-fully obtained is concealed or may grant search-war-

lodged in any dwelling-house, rant. building, or other place, such Justice, by special war-rant under his hand, directed to any police officer or constable, may cause such dwelling-house, building, or other place, to be entered and searched at any time of the day, or by night, if power for that purpose be given by such warrant; and the said Justice, if it shall appear to him necessary, may empower such police officer or constable, with such assistance as may be found necessary, (such constable having pre-viously made known his authority,) to use force for the effecting of such entry, whether by breaking open doors or otherwise, and if upon search thereupon made any such thing shall be found, then to convey the same before a Justice, or to guard the same on the spot, until the offenders are taken before a Justice, or otherwise dispose thereof in some place of safety, and moreover to take into custody, and carry before the said Justice, every person found in such house or place, who shall appear to have been privy to the deposit of any such thing, knowing or having reasonable cause to suspect the same to have been stolen, or otherwise unlawfully obtained.

tendent, Deputy Superintendent, or Inspector belonging to the Calcutta Police, that there is reasonable cause for suspecting that any stolen property is con-

cealed or lodged in any dwelling-house or other place, and the said Superintendent, Deputy Superintendent, or Inspector shall have good grounds for believing that, by reason of the delay in obtaining a search-warrant, the property is likely to be removed, the said Superintendent, Deputy Superintendent, or Inspector, in virtue of his office, may search for specific articles alleged to have been stolen in the houses and places specified; provided always that a list of the articles stolen or missing be delivered and taken down in writing, with a declaration, stating that the robbery has been committed, and that the informant has good ground to believe that the property is deposited in such house or place; and provided further that the person who lost the goods, or his representative, accompany the officer in the search, and that no goods be taken upon such search which are not identified by the person who lost them, or his representative.

VIII. of Act XXI. of 1839 is VII. Section hereby repealed, and all persons Extension of Act XXI. charged with the offence of of 1839 to the offence feloniously receiving goods or of receiving stolen pro-

perty when the value of the property does not exceed twenty rupees. In the property does not exceed twenty rupees. the value of the property stolen or received does not, according to the belief of the Justice, exceed twenty rupees, and all the powers and provisions of Act XXI. of 1839, except Section VIII. aforesaid, shall apply, so far as they are applicable, to the trial and conviction of any person charged under this Section with the offence of feloniously receiving goods or money, knowing the same to be stolen; provided always, and if it shall appear to the said Justice that such person has been previously convicted of, or is in the habit of receiving stolen goods, knowing the same to be stolen, the said Justice shall commit such person for trial

VIII. Every person who is accessory, before or after the fact, to any felony which is punishable on summary conviction before any Justice or Justices, is liable to be tried and convicted summarily before such

Justice or Justices, on his own confession, or the oath of one or more credible witnesses, and the convicting Justice or Justices shall have power to sentence any such accessory to imprisonment, with or without hard labour, for any time not exceeding six Calendar months, or in his or their discretion, instead of trying him, to commit him for trial to the Supreme Court of Judicature, or other Court having authority to try him.

IX. Whenever any boy, under the age of sixteen years, is convicted before a Jus-Punishment for boys. tice of the Peace, either of simple larceny under the said Act XXI. of 1839, or, under this Act, of feloniously re-

ceiving goods or money, knowing the same to be stolen, or of being an accessory to any felony which is punishable on summary conviction before any Justice, the said Justice, if he thinks fit, may sentence him to receive corporal punishment not exceeding twelve stripes of a light rattan, instead of sentencing him to imprisonment.

X. Any person who shall commit any assault, for-

cible entry, or other injury ac-Cases of assault, forcible entry, or other in-jury, not being felony. cible entry, or other in-jury, not being felony, against the person or property of any person whatsoever, shall be liable, on conviction thereof before a Justice of the Peace, to a fine not exceeding one hundred rupees, and the said Justice may award the whole or any part of such fine to the party or parties aggrieved, by way of satisfaction for such injury, or, in the discretion of such Justice, such person shall be imprisoned, with or without hard labour, for any time not exceeding four Calendar months.

Persons charged with recent assault may be apprehended by Po-lice without warrant, though assault not committed in view of Police.

XI. Any Deputy Superintendent or Inspector of Police may take into custody, or authorize a Constable to take into custody, without warrant, any person who within the said Town shall be charged by any other person with committing an aggravated assault, in every case

in which such Deputy Superintendent or Inspector of Police shall have good reason to believe that such assault has been committed, although not within view of such Deputy Superintendent or Inspector, and that by reason of the recent commission of the offence, a warrant could not have been obtained for the appearance of the offender.

XII. If complaint shall be made before any Justice that any person has within the said Town unlawfully taken or caused to be taken away, or has unlawfully enticed away, any married woman or female child unmarried, such female

hild being under the age of thirteen years, out of the possession or protection and against the will of the husband of such married woman, or of the father, mother, or guardian of any such child, or any other person who has the lawful order, keeping, education, or government of such female child, for the purpose of living in adultery with her, or for purposes of prosti-tution, or of deflowering, or disposing of her in marriage, against the will of her husband, father, mother, or guardian, or such other person as aforesaid respectively, it shall be lawful for the said Justice to make an order for the immediate restoration of such married woman or female child to her husband, father, mother. guardian, or such other person as aforesaid, as the may be, and to compel compliance with such order, and, if it be necessary to use force for that purpose, any Deputy Superintendent or Inspector of Police, duly authorized by the Justice in that behalf, with such assistants as he may deem necessary, may break open doors, or otherwise compel compliance with the same, and the said Justice may commit any person charged with taking any married woman or female child as aforesaid, for any of the purposes aforesaid, for trial before the Supreme Court of Judicature.

Keeping open houses of public entertainment without licence.

Within the said Town, wherein provisions, liquors, or refreshments of any kind shall be sold or consumed, (whether the same shall be kept or retailed therein or procured elsewhere,) without a licence for the same being first had and obtained from and under the hand of two Justices of the Peace, shall be liable, on conviction thereof before any of the said Justices, to a penalty not exceeding one hundred rupees for every day that such unlicensed house or place of public resort or entertainment is kept open.

XIV. Two or more of the said Justices shall from time to time hold licensing Sessions, for the purpose of granting licences.

Such houses or places of public resort and entertainment as aforesaid, and the said licences may be granted by the said Justices for the term of one year, subject to the restriction contained in Section XII. Act XI. of 1849, and upon such conditions to be inserted in every such licence as the Justices from time to time shall order, for securing the good behaviour of the keepers of the said houses or places of public resort or entertainment, and the prevention of drunkenness and disorder among the persons frequenting or using the same.

Penalty for parties not conforming to the tenor of their licence.

character, to meet or remain therein, or who shall wilfully harbour or conceal any Seaman or Apprentice who shall have deserted, knowing or having reason to believe such Seaman or Apprentice so harboured or concealed to be a deserter, shall be liable to a penalty not exceeding one hundred rupees, and shall be liable to forfeiture of his licence, in addition to any other penalty or punishment that shall be imposed on him.

Taking spirits, &c. attempt to take or throw, into the Great Gaol, or into the House of Correction of Calcutta, any quantity of spirituous liquors, wine, or intoxicating drugs, without the licence or consent of the Jailor or Keeper of such Gaol or House of Correction respectively, shall be liable, for every such offence, on conviction before a Justice of the Peace, to a penalty not exceeding fifty rupees, or, at the discretion of the said Justice, to imprisonment, with or without hard labor, for any period not exceeding two months.

XX. Every person who shall have been committed to the Great Gaol or House of Correction, or who shall be in custody at any Police Office or Station, and who shall unlawfully break or escape from such Gaol, House of Correction, Police Office, or Station, shall be liable for every such offence, on conviction before a Justice of the Peace, to imprisonment, with or without hard labour, for any period not exceeding three months, and such imprisonment shall commence and take effect from and after the expiration of any other sentence of imprisonment under which such person may be imprisoned at the time of committing the offence aforesaid.

XXI. Every person who shall be found drunk in Riotous or indecent behaviour.

Any Constable or Peace Officer belonging Rogues and vaga-bonds. to the Calcutta Police may take into custody, without a warrant, any person who shall be found between sunset and sunrise armed with any dangerous or offensive instrument whatsoever, with intent to break or enter into any dwelling-house or other building whatsoever, or any loose, idle, or disorderly persons whom he shall find disturbing the public peace, or whom he shall have good cause to suspect of having committed, or being about to commit any felony, misdemeanor, or breach of the peace, or any reputed thief, whom he shall find between sunset and sunrise on board any boat in the river, or lying or lonering in any bazar, street, road, yard, thoroughfare, or other place, and not giving a satisfactory account of himself. or any person having in his possession without lawful excuse (the proof of which excuse shall lie on such person), any picklock, key, crow, jack, bit, or other implement of house-breaking, or any person found between sunset and sunrise having his face blackened, or otherwise disguised, with intent to commit any felony, or any person who shall be found between sunset and sunrise in any dwelling-house or other building whatsoever, with intent to commit any felony therein; and every such offender, on conviction before a Justice, either on his own confession, or on the evidence of one or more credible witnesses, shall be liable, at the discretion of the said Justice, to be imprisoned, with or without hard labour, for any term not exceeding three Calendar months.

XXIII. Every person who shall beg or apply for alms or relief in any public road, street, or thoroughfare, or who shall expose or exhibit any sores, wounds, bodily ailment or deformity in such roads, streets, or public thoroughfares, with the object of exciting charity, or of obtaining alms or relief, or who shall, anywhere within the Town, seek for or obtain alms or relief by means of any false statements or pretences, shall, for every such offence, on conviction before a Justice, be liable to imprisonment, with or without hard labour, for any period not exceeding one Calendar month.

XXIV. If any Superintendent or Deputy Superintendent or Inspector of Police shall report, in writing to the Chief Magistrate of Calcutta, or other head of the Police, that

there are good grounds for believing any house, build-ing, room, or other place within the Town to be kept or used as a common gaming-house or place, and if two or more persons shall make outle or solemn affirmation before a Justice of the Peace that the premises complained of are commonly reported and believed to be kept or used as a common gaming-house or place, the Chief Magistrate, or other head of the Police, by an order in writing, may authorize a Deputy Superintendent or Inspector of Police to enter any such house, building, room, yard, or place, with such constables as he shall deem requisite to accompany him, and if necessary to use force for the purpose of effecting such entry, whether by breaking open doors or otherwise, and to take into custody and search all persons found therein, and to seize all tables and instruments of gaming found in such house, building, room, or place, or on the persons of any of those found therein, and also to seize all moneys and securities for money found in any such house, building, room, yard, or place, and the owner or keeper of the said gaming-house, or place, or other person having the care and management thereof, shall be liable, on conviction before a Justice of the Peace, to a penalty not exceeding one hundred rupees. or, at the discretion of the said Justice, to imprisonment, with or without hard labour, for any time not exceeding three Calendar months, and upon conviction of any such offender all such tables and instruments of unlawful games shall be destroyed or otherwise disposed of by order of the Justice before whom the conviction is had, and all the moneys and securities for money so found shall be forfeited to Government, and every person found on such premises, and who shall not be the owner or keeper or other person having the care or management of the said gaming-house or place, shall be liable, on conviction before a Justice of the Peace, to a penalty not exceeding fifty rupees.

XXV. It shall not be necessary, in support of any information for gaming in, or for suffering any games or gaming in, or for keeping or managing or being concerned in the management or conduct of any common gaming-house or place, under this Act, to prove that any person found playing at any game was playing for any money, wager, or stake.

XXVI. Where any cards, dice, balls, counters, tables, or other instruments of gaming, used in playing any unlawful game, are found in any house, building, room, or place, suspected to be used as a common gaming-house or place, and entered by an order issued under this Act, or about the person of any who are found therein, it shall be evidence, until the contrary is made to appear, that such house, building, room, or place is used as a common gaming-house or place, and that the persons found in the house, building, room, or place where such tables or instruments of gaming shall have been found, were playing therein, although no play was actually going on, in the presence of the Superintendent, Deputy Superintendent, Inspector, or Constable entering the same as aforesaid.

ACT No. XVI. of 1851.

An Act for the Trial of Receivers of Stolen Property. For the trial of Receivers of Stolen Property where

the principal is tried, or where the Property is found in their possession, or where the receiving takes place,

It is enacted as follows :-

I. Every person who receives any Chattel, Money, Valuable Security, or other Property whatsoever, knowing the same to have been feloniously or unlawfully stolen, taken, obtained, or converted, whether charged as an accessory after the fact to the felony, or with a substantive felony, or with a misdemeanor only, may be dealt with, indicted, tried, and punished in any place in which he shall have, or shall have had, any such property in his possession, or in any place in which the party guilty of the principal felony or misdemeanor may by law he tried, or in the place where he actually received such property.

An Act to repeal Act No. II. of 1848, and to confer certain Powers on the Commissioners for the Improvement of the Town of Calcutta.

Whereas by Section of Act No. 1852, it is, among other things, enacted that certain funds therein mentioned should be applied by the Commissioners for the improvement of the Town of Calcutta in the formation of Tanks and Aqueducts, for the convoyance of water to all parts of the Town, in the opening and widening of Streets and Squares in the Town; in filling up stagnant pools of water, holes in the earth, and all receptacles for filth and rubbish, and in removing obstructions on the roads, and to the free circulation of air; in cleansing, repairing, lighting, and watering the roads and streets; in constructing new drains and sewers, and cleansing and repairing, or filling up and abolishing old drains and sewers; and improving and embellishing the said Town generally; And whereas it is expedient that the said Commissioners should be invested with further

powers for the effectual accomplishment of the purposes aforesaid, It is hereby enacted as follows:

and may alter and widen narrow streets, regard being had to the compensation of owners of lands which may be required to be vested in the said Commissioners for any such purposes. Provided always, that it shall not be lawful for the said Commissioners, or any other person, to make or lay out any new street, unless the same, being a carriage road, be at least 50 feet wide, exclusive of the drains at the sides thereof, or, not being a carriage road, be at least 20 feet wide, exclusive of the drains at the sides thereof.

sent of the said Governor of Bengal, may, by agreement or in conformity with the provisions of Act XXII. of 1847, purchase or take absolutely, or on lease for such

terms as they may think fit, any water-works, streams of water, lands, fixtures, or other property, which the said Commissioners may deem it necessary to purchase or take for any work or purpose which they are required or authorized to do and execute under this Act, or the said Act No. of 1852, and when the said Commissioners take and purchase any lands for the purposes of this Act otherwise than with the consent of the owners and occupiers thereof, they shall, in exercising the powers so given, be subject to the provisions and restrictions contained in the said Act No. XXII, of 1847, and the said Commissioners shall make to the owners and occupiers of, and all other parties interested in, any such lands taken for the purposes of this Act, full compensation for the value of the lands so taken, and for all damages sustained by such owners, occupiers, and other parties, by reason of the exercise, as regards such lands, of the powers vested in the Commissioners by this Act, and the amount of such compensation shall be determined in the manner provided by the said Act No. XXII. of 1847, for determining questions of compensation with regard to lands purchased or taken under the provisions thereof; and all the provisions of the said Act No. XXII. of 1847 shall be applicable to determine the amount of any such compensation, and to enforce the payment or other satisfaction thereof.

VII. The Commissioners, by and with the con-sent of the Governor of Bengal,

may sell or dispose of any lands or nissioners to sell other property vested in or acquired by them under the powers herein, or in the said Act No. XXII. of 1847, contained, which it may appear to the Commissioners may be

properly sold or disposed of, and for completing and carrying any such sale of lands into effect, the Commissioners may make and execute a conveyance of the lands sold and disposed of as aforesaid unto the purchaser, or as he shall direct, and such conveyance shall be under the hands of three of the Commissioners, and under the seal of the Commissioners, and a receipt under the hands of three of the Commissioners shall be a sufficient discharge to the purchaser of any such lands for the purchase money in such receipt expressed to be received, and the money to arise from such sale shall be applied to such of the purposes of this Act as the Commissioners shall think fit.

VIII. The said Commissioners may from time to

Power to Commissioners to improve and cleanse, or to dis-continue drains, &c. time, as they shall see fit, widen, deepen, embank, alter, arch over, amend, clean, and scour out all or any of the sewers or drains within the said Town, as may be necessary,

and also cleanse and drain off into any sewers or drains, or otherwise abate all stagnant pools, ditches, tanks, and other receptacles of foul water and fitth, existing within the said Town, whether the same be the private property of any person or persons or other-wise, and the said Commissioners, if they shall think fit, may take up, stop, fill in, and discontinue any sewers or drains which they shall deem useless or unnecessary

IX. Every Commissioner, and the Surveyor to the Power to Com-

missioners to enter, examine, and lay open houses, lands, &c., for that pur-pose. Compensation in certain cases.

Commissioners, with such subordinate Officers or persons as they may require, shall, when it shall be necessary or convenient for the purpose of making any survey or examination of any sewers or drains, or of making or repairing, or cleans-

ing any, sewers, drains, or works within the said Town, or of carrying into execution any of the powers entrusted to the Commissioners by this Act, or Act of 1852, have full power and authority, at all reasonable hours in the day time, to enter, examine, and lay open, or to direct their subordinate Officers to enter, examine, and lay open, any house, building, or other erection, or any lands, without being liable to any action at Law or suit in Equity, or any other legal proceedings or molestation whatsoever, for or on account of such entry, examination, or works, or of anything done, or to be done in any part of such house, building, erection, or land, in pursuance of this Act. Provided always, that except in cases of emergency, none of the persons abovementioned shall enter, examine, or lay open any house, building, or other erection, or lands, which may be occupied at the time, unless with the consent of the occupier thereof, without previously giving the said occupier 24 hours' notice of their intended entry, and of the object thereof. Provided also, that compensation shall be made for any damage occasioned by such entry and works to all persons other than the owners and occupiers of any land or building in respect of which any private drain or sewer, or the state of drainage shall be inspected, cleansed, or repaired, and other than the owners or occupiers of any premises where any nuisance may exist, and other than the person who may have caused such nuisance; and provided also, that in case no nuisance shall be found to exist in or on the house, building, or other erection, or lands so entered, examined, and laid open as aforesaid, the said Commissioners shall, out of the rates and taxes aforesaid, cause the said house, building, or other erection, or lands, to be restored to the same state and condition, in all respects, as the same were in before they were so entered, examined, or laid open.

X. If any house, building, or wall, or anything

Power to Commissioners in case of ruinous or dangerous buildings.

affixed thereon, within the limits of the said Town, be deemed by the Commissioners, or their Surveyor, to be in a ruinous state, or badly built, or likely to fall, and also dan-

gerous to passengers or the occupiers of neighbouring buildings, such Surveyor shall immediately cause a proper board or fence to be put up, for the protection of passengers, and shall cause notice in writing to be given to the owner of such house, building, or wall, or other thing, if he be known and resident within the said limits, and shall also cause such notice to be put on the door or other conspicuous part of the said premises, or otherwise to be given to the occupier thereof (if any), requiring such owner or occupier forthwith to take down, secure, or repair such house, building, wall, or other thing, as the case shall require; and if such owner or occupier do not begin to repair, take down, or secure such house, building, wall, or other thing, within the space of three days after such notice has been given or up as aforesaid, and complete the same as speedily as the nature of the case will admit, the said Commis-sioners shall with all convenient speed cause all or so much of such house, building, wall, or other thing, as shall be in a ruinous condition, or badly built, or likely to fall, and also dangerous as aforesaid, to be taken down, repaired, rebuilt, or otherwise secured, in such manner as shall be requisite; and all the expenses of putting up every such fence, and of taking down, repairing, rebuilding, or securing such building, wall, or other thing, shall be paid by the owner thereof, if such owner can be found within the said limits, and if, on demand of the expenses aforesaid, he neglect or refuse to pay the same, then such expenses may be levied by distress on the goods and chattels of the owner of the said house, building, wall, or other thing, and any two Commissioners may issue their warrant of distress accordingly.

XI. If any such house, building, wall, or other thing, or any part of the same, be pulled down by virtue of the powers aforesaid, the Commissioners may sell the materials thereof, or so much of the same as shall be pulled down, and apply the proceeds of such sale in payment of the expenses incurred in respect of such house, building, wall, or other thing, and the Commissioners shall restore any overplus arising from such sale to the owner of such house, building, wall, or other thing, on demand; nevertheless the Commissioners, although they sell such materials for the purpose aforesaid, shall have the same remedies for compelling the payment of so much of the said expenses as may remain due after the application of the proceeds of such sale, as are hereinbefore given to them for compelling the payment of the whole of the

said expenses.

XII. The said Commissioners, by and with the con-sent of the Governor of Bengal, Power to Commay construct, make, and lay, or missioners to make cause to be constructed, made, and canals, aqueducts, sewers, drains, &c. laid, such reservoirs, canals, aqueducts, channels, tanks, sewers, drains, bridges, banks, conduits, machinery, engines, waste-gates, stop-gutes, stop-cocks, sluices, tunnels, water-pipes, and other works, as shall, in their opinion, be necessary and proper for obtaining water and supplying the same to the said Town, and for the effectual draining and cleansing of the said Town, and for the properly flushing and cleansing out such sewers in and under, across all or any of the streets therein, whether dedicated to the public use or not, and if needful through and across all underground cellars and vaults which they may find under any of the said streets, doing as little damage as may be; and also to cause such and so many rings and openings to be made or left in the sides of the said sewers as will be sufficient for the making or branching any drain or drains from any or all of the houses built, and which may probably be built, adjoining, or near thereto, into any of the said sewers, as the said Commissioners shall think necessary for that purpose; and in case it shall be found necessary for completing any of the aforesaid works, to build, carry, continue the same in, into, through, or over any enclosed lands, or

other place, not being a public way, it shall be lawful

for the said Commissioners to build, carry, or continue the same in, into, through, or over the said lands or other places accordingly, and the said Commissioners shall cause such sewers to communicate with and empty themselves into any public river, stream, canal, or watercourse, whether within or without the said Town, or shall cause the refuse from such sewers to be conveyed by an appropriate channel to the most convenient site for its deposit, collection, and sale, and its application as manure for agricultural purposes, or otherwise, as they shall deem most expedient, but so that the same shall in no case become a public nuisance or annoyance to the neighbourhood.

XIII. For the purpose of constructing any aque-ducts for bringing water to the

Power to Commissioners when constructing drains and aqueducts with-out the Jurisdiction of Supreme Court.

Town of Calcutta from any place without the local limits of the jurisdiction of Her Majesty's Supreme Court of Judicature, or for the purpose of making sewers or drains to communicate with or empty them-

selves into any public sewer, lake, stream, canal, or water-course, without the said limits, it shall be lawful. whenever a plan for any such aqueduct, sewer, or drain shall have been approved by the Governor of Bengal, for every Commissioner, and for the Surveyor and Secretary to the Commissioners, with such Assistants as they may require, to exercise in the construction of such aqueduct, sewer, or drain, throughout the line of country through which the said aqueduct, sewer, or drain is to run, all the powers which by this Act it is lawful for them to exercise within the said local limits, and which may be necessary for the con-struction of such aqueduct, sewer, or drain, without being subject to any action or molestation whatever for so doing; and it shall also be lawful for any Magistrate of any district through which the said aqueduct, sewer, or drain is to run, in furtherance of the construction of such aqueduct, sewer, or drain, to do such acts as it is by this Act lawful for a Magistrate of the Town of Calcutta to do in furtherance of any work to be executed by the said Commissioners within the said local limits.

XIV. It shall be lawful for the said Commissioners, instead of executing any of the Power to Com-missioners to exe-cute works by conworks which by this Act they are authorized to execute by themselves, their Servants, and Assistants, to execute the same by contract with

any individual or Company who may be willing to undertake the same, and in that case it shall be lawful for such individual or company to exercise and enjoy all the powers and privileges which by this Act it is lawful for the said Commissioners to exercise and enjoy in the execution of any such works, Provided always, that no Commissioner or Officer, or Servant of the Commissioners, shall be in any wise concerned or in-terested in any contract or work made with or executed for the Commissioners, and if any such Commissioner, or Officer, or Servant, be so concerned or interested, or shall under colour of his office or employment exact, take, or accept any fee or reward what-soever, other than his proper salary, wages, fees, and allowances, he shall be incapable of afterwards holding or continuing in any office or employment under the Commissioners, and shall forfeit and pay the sum of Company's Rupees five hundred, which may be recovered by any person, with full costs of suit, by action of debt.

XV.

Power to Commissioners to con-tract for supply of water, and to grant leases for that purpose.

The said Commissioners may, with the con-sent and approbation of the said Governor, contract and agree with any person for supplying the said Town, or any part thereof, with water, and may also, with the like consent and approbation, grant to any person contracting to supply

the said Town, or any part thereof, with water, a lease, for any term not exceeding twenty-one years, of any water-works, machinery, streams, waters, lands, tenements, easements, rights, privileges, and advantages, belonging to or acquired by, or which may belong to or be acquired by, or be vested in the said Commissioners, under any of the powers or authorities in this or any other Act contained, so as to enable such person or persons so contracting the more effectually and efficiently to procure and supply water in pursuance of any such Contract or agreement; and every such lease so to be granted by the said Commissioners may be made subject to such conditions and stipulations as to the supplying water, for the purposes of this Act, or any of them, as may be agreed upon between the respective parties thereto. Provided always, that no lease or contract made in pursuance of the powers hereinbefore contained shall be valid or effectual, for any purpose whatsoever, unless the said Governor's approval of the same shall be testified by writing, endorsed on such lease or contract, under the hand of the Secretary to the Government of Bengal.

XVI. It shall be lawful for the said Commissioners,

Power to Commissioners to enter on lands adjacent to works, &c.

their Secretary, Surveyor, or other Officer, subject to the restrictions in this Act contained, to enter upon the lands of any corporation or

person adjoining to, or being within the distance of one hundred yards of the works by this Act authorized to be made, or any part thereof, for the purpose of depositing upon such lands, or any part thereof, any soil, gravel, sand, lime, brick, stone, or other materials, or for any other purposes connected with the formation of the said works, without making any previous payment, tender, or deposit, the said Commissioners, their Secretary, Surveyor, or other Officer, doing as little damage as may be in the exercise of the several powers hereby granted to them, and making compensation for such temporary occupation or temporary damage of the said lands to the owners and occupiers thereof, from time to time, and as often as any such temporary occupation shall be taken, or any such temporary damage done, and making compensation to the owners also for the permanent injury (it any) to such lands; and in case the parties differ respecting the amount of the compensation, or the respective shares of several claimants of compensation, then and in every such case the said disputes respectively shall be settled and adjusted by arbitration, or by the verdict of a Jury, summoned and assembled in manner provided in Act No. XXII. of 1847, Provided always, that before the said Commissioners make any such temporary use as aforesaid of the lands adjoining or lying near to the said works, they shall give fourteen days' notice of such their intention to the owners and occupiers of such lands, and shall separate and set apart by sufficient fences so much of the lands as shall be required to be used as aforesaid from the other lands adjoining thereto.

XVII. The said Commissioners shall make full com-

Power to Commissioners to make out compensation

pensation out of the rates and taxes to be levied by them to all persons sustaining any damage by reason of the exercise of any of the powers vested in the Commissioners,

other Officers or Servants, under and by virtue of this Act.

XVIII. It shall be lawful for the said Commis-

Power to Commissioners to proin certain secute cases.

sioners to direct any prosecution before any Court or Justice of the Peace for any public nuisance whatsoever which shall be permitted or suffered within the said Town,

and to order proceedings to be taken for the recovery of any penalties, and for the punishment of any persons offending against the provisions of this Act, and to direct and order the expenses of such prosecutions and other proceedings to be paid and borne by and out of the funds placed at their disposal under the provisions of this or any other Act.

XIX. It shall be lawful for the said Commissioners,

Power to Commissioners to prefer bill of indictment in certain cases.

if they shall not think fit to take any other proceedings prescribed by this Act, to prefer any bill of indictment or information, or to take any other proceedings against

any person who shall obstruct or molest the said Commissioners or their Secretary, Surveyor, or other Officer or servant, or any workman or other person employed by them in the performance and execution of their or his duty, under or by virtue or in consequence of this Act, or who shall steal, take, or carry away, or wilfully deface or injure any property, article, or thing belonging to the said Commissioners, and in every such case it shall be sufficient to state generally the property, article, or thing, in respect of which such proceeding shall have been taken, to be the property of the said Commissioners.

XX. It shall be lawful for any of the Commission-

Power to Com-missioners to arrest unknown offenders without warrant.

ers, their Secretary, Surveyor, Inspectors, Overseers, or any servants or persons employed by them, and for any Inspector of Police, or Policeman employed in the said

Town, and such other person or persons whom he or they shall call to his or their assistance, without any summons, or warrant, or other authority than this Act, to seize and detain any unknown person who shall commit any offence against the provisions of this Act, and to take him before any Justice of the Peace, who is hereby required to proceed and act with respect to such offender or offenders according to the provisions of this Act.

XXI. The Commissioners, or any one of them, or any person appointed by them for Power to Com-

missioners to enter and inspect bazars, slaughter-houses, &c., and to seize unwholesome articles exposed for sale.

that purpose, may, at all reasonable times, with or without Assistants, enter into and inspect any market, building, shop, stall, or place, kept or used for the sale of butcher's meat, poultry, fish, or vegetables, or as a slaughter-house, and may

examine any animal, carcase, meat, poultry, game, flesh, fish, or vegetables which may be therein, and in case any animal, carcase, meat, poultry, game, flesh, fish, or vegetables appear to be intended for the food of man, and to be unfit for such food, may seize, remove, and destroy the same, at the expense of the owner thereof, or the owner, occupier, or farmer of any such public market, bazar, slaughter-house, or private shop or stall within the Town, wherein the same shall be exposed, or allowed to be exposed for sale.

proper precautions against danger, by shoreing up and protecting the adjoining houses, and shall fix and place, or cause to be fixed and placed, such and so many bars, chains, or posts, across or in any of the said streets, to prevent the passing and repassing of carriages, carts, or other vehicles, cattle, or horses, during the time of such works and repairs or horses, during the time of such works and repairs or horses, during the time of such works and repairs or horses, and their said Surveyor, shall cause any sewer or drain, or other works, during the construction or repair thereof by them, to be well and sufficiently lighted during the night, to prevent accidents.

Said Commissioners shall provide lamps for lighting such parts of the said Town as the said Commissioners shall consider to require the same, and shall keep the said lamps in fit order for public use, and shall keep and employ a sufficient number of persons to cleanse, prepare, repair, and light the same, and shall also from time to time, as shall be required, increase or otherwise alter the number and situation of the said lamps, as to them shall appear necessary for the lighting of the said Town.

XXIX. The said Commissioners, and their said

Surveyor, and other Officers, shall cause all the public streets of the Commissioners to keep Town clean, remove dirt, &c. said Town, together with the foot-pavements or foot-paths therein, from time to time to be properly swept and cleansed and all dust, dirt, soil, ashes, rubbish, and filth of every sort, which may be found thereon, to be collected and removed therefrom at convenient hours and times, and shall cause all or any of the privies, cess-pools, and drains within the said Town to be cleansed and emptied in a sufficient and proper manner by the owners or occupiers of the premises; and the said Surveyor, or other subordinate Officer of the Commissioners, shall give such orders and directions to the owners and occupiers aforesaid as to the said Surveyor or other Officer as aforesaid, acting under the orders and control of the said Commissioners, shall appear

XXX. The said Commissioners, and the owners of any private drains in the said Town, shall, by providing proper traps, or other coverings, or by ventilation, or by such other ways and means as shall be practicable for that purpose, prevent as far as possible the effluvia of sewers and drains from exhaling

from gully-holes, gratings, or any other openings what-

soever of drains or sewers in streets or other places, and in case the owner of any private sewer or drain shall neglect or delay so to do, the Surveyor of the said Commissioners shall give him notice to prevent as far as possible the effluvia of such sewer or drain from so exhaling, and if the same shall not be done by such owner within ten days after such notice shall have been given him, the said Surveyor shall forthwith provide and apply proper traps or other coverings, of such other means as aforesaid, so as effectually to prevent such effluvia from exhaling, and the expense incurred thereby shall be paid by the owner of such sewer or drain, to be recovered in manner hereinafter mentioned.

XXXI. If upon the representation of the Surveyor of the Commissioners, and after

Commissioners to issue certificates, prohibiting improper burial-places. of the Commissioners, and after inquiry by such other ways and means as the Commissioners may think fit to direct, the said Commissioners shall certify, (such cer-

tificate to be published in the Government Gazette, and in one of the English and Bengallee newspapers respectively, usually circulated within the town,) that any burial-ground situated within the said Town is in such a state as to be dangerous to the health of persons living in the neighbourhood thereof, or that any church or other place of public worship within the Town is dangerous to the health of persons frequenting the same, by reason of the state of the vaults or graves within the walls of or underneath the same, and that sufficient means of interment exist within a convenient distance from such burial-ground, church, or place of public worship, it shall not be lawful, after a time to be named in such certificate, to bury, or permit, or suffer to be buried, any further corpses or coffins in, within, or under the ground, church, or place of worship to which the certificate relates, except in so far as may be allowed by such certificate, and whosoever, after notice of such certificate, buries, or causes, permits, or suffers to be buried, any corpse or coffin, contrary to this enactment, shall for every such offence be liable, on conviction before a Justice of the Peace, to a penalty not exceeding Company's Rupees two hundred.

XXXII. No vault or grave shall be constructed or

No vault or burialplace henceforth to be constructed without leave of Commissioners. made within the walls of or underneath any church or other place of public worship built in the said Town after the passing of this Act, and no burial-ground shall be made or formed within the said Town

after the passing of this Act without the consent of the Commissioners first had and obtained, and whosoever shall bury, or cause, permit, or suffer to be buried any corpse or coffin in any vault, grave, or burial-ground constructed, made, or formed contrary to this enactment, shall for every such offence be liable to a penalty not exceeding Company's Rupees five hundred, which may be recovered by any person, with full costs of suit, in an action of debt.

XXXIII. The said Commissioners, when executing

Commissioners, when executing works, to provide convenient roads, drains, &c. for use of adjoining lands, when present roads, sewers, are stopped, &c. any works hereby authorized to be made, shall, at their own expense, make and provide a sufficient number of convenient roads, ways, watering-places, wells, water-courses, drains, and channels for the irrigation and for the use of the adjoining lands, and for irrigating the same in those parts where the

present roads, ways, watering-places, wells, water-courses, drains, and channels shall and may be taken away or interrupted, injured, or rendered inconvenient or useless by reason of the execution of the said works, and in case of any difference arising between the said Commissioners and the owners of such adjoining lands, such difference shall be settled by arbitration

or by the verdict of a jury summoned and assembled in manner provided in Act No XXII. of 1847.

Commissioners to sue and be sued in name of Secretary; execution not to be sucd out till after six months; Secretary to be re-imbursed.

XXXIV. The Commissioners or any one of them may sue and be sued at law and in equity in the name of their Secretary for the time being, and no action or suit to be brought or commenced by or against such Secretary in manner aforesaid, shall abate or be discontinued by the death, resignation, or removal

It shall be lawful for the Chief Magistrate of Police to grant to any person (whom he shall deem fit and proper) a licence for the sale or keeping in deposit, within the limits of the said Town, any quantity of imported or Indian-manufactured gunpowder not exceeding fifty pounds, or any quantity of gun-cotton not exceeding twenty pounds, on such conditions as shall be specified in the licence; and any person who shall be guilty of a breach of any of such conditions shall, on conviction before a Justice of the Peace, be liable to a forfeiture of his licence, and of all gunpowder or gun-cotton so kept in deposit contrary thereto, and also to a fine not exceeding Rupees two hundred.

TAHI. Every such licence as is mentioned in the preceding Section shall be in force for a period of one year
only, and no longer, but shall be renewable by the said
Chief Magistrate at his discretion on the same or any
other terms and conditions; and such licence shall also
provide for the transit and carrying of gunpowder from
one place to another within the limits of the said Town,
in such manner and in such quantity as shall be deemed
advisable for the safety of the inhabitants and of property within the said Town, and every person offending
against such provisions shall be liable to a fine not exceeding rupees fifty.

LIV. Any Justice of the Peace, on credible information laid before him on, oath or solemn affirmation, that gunpowder or gun-cotton, or mixed materials for making the same contrary to the provisions of this Act, are suspected to be stored, kept, or possessed by any person, may issue his warrant, authorizing any Police Officer to search in the daytime any house, shop, magazine, or other building or place in which he has reasonable ground to suspect any gunpowder or gun-cotton to be manufactured, sold, or kept, or any boat, carriage, cart, or other vehicle in which any gunpowder, gun-cotton, or materials for manufacturing the same, may be suspected to be carried, or any person suspected of carrying the same contrary to such licence, or to the provisions of this Act, and all gunpowder, gun-cotton, or materials for manufacturing the same, found on such search, shall, together with the vessels or receptacles in which they may be stored, be immediately seized and brought before a Justice of the Peace, with whom the same shall be kept till it shall be adjudged whether the same shall be forfeited.

LV. The five last preceding Sections shall not extend to any Government magazine, or store, or building for the making or deposit of gunpowder, or gun-cotton, under the authority or for the use of the Government, or to any gunpowder or gun-cotton for the use of Her Majesty's or the Fast India Company's Troops, or otherwise for the service of Government, or to any of Her Majesty's vessels of war, or the vessels of the Indian Navy, or of the East India Company's Marine, or to any other vessel within the River Hooghly, laden with gunpowder for importation or exportation.

LVI. Commanders of merchant vessels entering the River Hooghly shall, on or before the arrival of their vessels off Moyapore, deposit in the magazine at that place all gunpowder intended for the ship's use from on board their respective vessels, exceeding the quantity of fifty pounds, which quantity they shall be permitted to retain in their vessels for the purpose of firing salutes or signals in case of distress, and the gunpowder so deposited shall be again delivered on board on the return of the respective vessels from Calcutta in prosecution of the outward voyage, and commanders of merchant vessels in the River Hooghly, having on board their vessels gunpowder or gun-cotton for importation (not being gunpowder belonging to the Government), exceeding the quantity of fifty pounds, shall also deposit

the same, on or before the arrival of their vessels off Moyapore, in the magazine of that place, under charge of an Officer belonging to the Customs at that place, or such other person as the Governor of Bengal may appoint, and the proprietors or consignees of such gunpowder or gun-cotton, or their agents, whenever they shall desire to remove the same from the magazine, shall make application to the Collector of Sea Customs for authority to do so, which application, when it be intended that such gunpowder or gun-cotton shall be lodged in any place, or be laden in any boat or other conveyance within the limits of the said Town, shall be accompanied by a written order of permission, signed by a Justice of the Peace to that effect, and when it be intended that such gunpowder or gun-cotton shall be exported by sea, the Commanders of vessels, or the proprietors or their agents, by whom it shall have been deposited in the magazine, shall make application to the Collector of Sea Customs for permission so to export it; and the Collector of Sea Customs shall comply with such applications aforesaid, except where the exportation of ammunition shall require, under the provisions of Act XVIII. of 1841, a licence from a public Officer, other than the Collector of Sea Customs, in which case the Collector of Sea Customs shall not comply with the application unless it be accompanied by the licence of such public Officer; and on or before the removal of all gunpowder or gun-cotton from the magazine, the Collector of Sea Customs shall, and he is hereby authorized to levy a fee, the rate of which shall not be exceeding two annas per pound, for all gunpowder or gun-cotton that has been lodged therein, which fee (not to exceed the rate of two annas per pound as aforesaid) shall be taken to cover all charges for the safe custody of the gunpowder or gun-cotton during the period it has remained or shall remain in the magazine; provided also, and it is hereby enacted, that the Governor of Bengal shall be at liberty to authorize such arrangement to be made by letting or otherwise contracting for the custody of the magazine, and for the collection and appropriation of the fee which may be charged for gunpowder or gan-cotton stored therein, as he may think proper, subject however to all the restrictions and rules imposed by this Section in respect to the removal from the magazine of gunpowder therein stored.

LVII. For every act done or omitted to be done contrary to the provisions in the last preceding Section of this Act, by the Commander of any merchant vessel in the port of Calcutta, the Commander aforesaid shall forfeit the sum of two hundred rupees, and the Collector of Sea Customs is hereby empowered to enforce the said penalty; provided also, and it is hereby enacted, that the Collector shall not grant a Port-clearance for any vessel in which such penalty shall have been incurred until it shall have been paid; and the Collector of Sea Customs is hereby empowered to search for any quantity of gunpowder which he may have reason to believe to be on board a merchant vessel in the port of Calcutta, contrary to the provisions of this Act, and to seize it, and detain it as forfeited to Government, to be dealt with as the Governor of Bengal shall think right to direct.

LVIII. When any person shall have been convicted under the provisions of this Act, Provision for repair to the provision for repair to the provision for repeat the noise of this Act, and shall not, within seven days afpetition of offences. The such conviction, discontinue the nuisance, or cease to commit the offence for which he was so convicted, such person shall be again liable to the penalties and punishments provided by this Act for such nuisance or offence, and may be again convicted or sentenced under this Act accordingly, and in cases where by the provisions of this Act offenders are required to have notice given them to remove the obstruction or nuisance previous to being liable to the penalties imposed by this Act, if such parties being once warned shall be convicted, and shall again offend against the provisions of this Act, it shall not be necessary to repeat the notice aforesaid, but the parties may be summoned at once.

LIX. Any person who shall wilfully obstruct or Obstruction of any of them, or their Officers, surveyor, or other Officer or worktheir Officers. man employed by them under the

provisions of this Act, or any person or company with whom they may have contracted under the provisions of this Act, or any person employed by them in the performance or execution of any duty or thing which they are respectively required or authorized to do under this Act, shall, for every such offence, on conviction before a Justice of the Peace, forfeit and pay any sum not exceeding one hundred rupees, or, in the discretion of the said Justice before whom he is convicted to imprisonment for a period not exceeding three months.

LX. No person shall be liable to the payment of any penalty or forfeiture imposed by virtue of this Act for any offence complained of before a Justice of the Peace, unless the complaint re-No person liable for penalty unless complaint made

within three months. specting such offence shall have been made before such Justice within three months next after the commission of such offence.

Manner in which damages, costs, and expenses are to be

LXI. In all cases where any damages, costs, or expenses are by this Act directed to Manner in which be paid, and the method of ascerdamages, costs, and expenses are to be ascertained. taining the amount, or of enforcing the paying thereof, is not provided for, such amount in case of dispute and determined by arbitration, in

like manner as is provided for proceeding by arbitration under Act No. XXII. of 1817, and if the parties caunot agree upon two persons or arbitrators, or the arbitrators fail to pronounce their award as aforesaid, then by any two Justices of Calcutta, and if the amount so ascertained be not paid by the said Commissioners, or by the other party hable to pay the same, as the case may be, within seven days after demand thereof, the amount may be recovered by action of debt or on the case in her Majesty's said Supreme Court of Judicature, or the Calcutta Court of Small Causes.

LXII. The said Commissioners shall publish short particulars of the several offences

Commissioners to for which any penalty or punishment publish short parti-culars of offences. vants of the said Commissioners, and of the amount of every such penalty and punishment, and shall cause such particulars to be painted on a board, or to be printed upon paper, and posted on a board in English and Bengallee, and shall cause such board to be hung up or affixed in some conspicuous place in the Office of the Secretary of the said Commissioners, and when any such penalties are of local application, shall cause such boards to be affixed in some conspicuous place of the immediate neighbourhood to which such penalties are applicable, or have reference, and such particulars shall be renewed as often as the same or any part thereof are obliterated or destroyed.

LXIII. Every penalty or forfeiture imposed by this

Act, or any expense incurred by the said Commissioners in respect of any All penalties not otherwise provided may be recovered before Magistrate; private drains, sewers, doors, or other things as aforesaid, the recovery of which is not otherwise form of procedure.

provided for, may be recovered by summary proceeding before any Justice of the Peace of Calcutta, and on complaint being made to any such Justice, he shall issue his summons requiring the party complained against to appear before him at a time and place to be named in such summons, and every such summons shall be served on the party offending, either in person or by leaving the same at his usual or last known place of abode, and upon the appearance of the party complained against, or in his absence, after proof of the due service of such summons, it shall be lawful for such Justice to proceed to the hearing of the complaint, which complaint shall be reduced to writing, and upon

LXV. No distress levied by virtue of this Act shall be deemed unlawful, nor shall any party making the same be deemed a trespasser, on account of any defect or want of form in the summons, No distress unform, &c. conviction, warrant of distress, or other proceeding relating thereto, nor shall any such party be deemed a trespasser ab initio on account of any irregularity afterwards committed by him, but all persons aggrieved by such defect or irregularity may recover full satisfaction for the special damage in an action on the case in Her Majesty's said Supreme Court, or in the Calcutta Court of Small Causes.

LXVI. The Justice of the Peace by whom any such penalty or forfeiture shall be im-How penalties are to be applied. posed may, when the application thereof is not otherwise provided for, award not more than one-half thereof or any less sum to the informer, if he shall think fit so to do, and shall award the remainder or the whole thereof to the said Commissioners, to be by them applied to the purposes of this Act as to them shall appear fit, and shall order the same to be paid over to the Secretary of the said Commissioners for that purpose, whose receipt shall be a good and sufficient dis-

LXVII. It shall be lawful for any Justice of the Peace to summon any person to appear before him as a witness in any Power to Justice to summon matter in which such Justice shall witnesses; penalty for not appearing. have jurisdiction under the provisions of this Act, at a time and place to be mentioned in such summons, and require from him on oath or solemn affirmation that he will testify the truth in such matter; and if any person so summoned shall, without reasonable cause, refuse or neglect to appear at the time and place appointed for that purpose, having been paid or tendered a reasonable sum for his expenses, if from distance or any other cause he shall be lawfully entitled to claim such expenses, or if any person appearing shall refuse to be examined on his oath or solemn affirmation according to law, or to give evi-

dence before such Justice, every such person shall for

every such offence forfeit and pay a sum not exceeding

fifty rupees.

LXIX. The following words and expressions in this
Act shall have the several meanings Meaning of words hereby assigned to them, unless there be something in the subject or context repugnant to such construction; (that is to say,) words importing the singular number shall include the plural number, and words importing the plural number shall include the singular number; words importing the masculine gender only shall include females; the word "person" shall include corporations, whether aggregate or sole; the words "oath," "affirmation," and "solemn affirmation," when used alone shall include oath or affirmation or other declaration lawfully substituted for an oath in such case by any legislative Act of the Governor General of India in Council, or by any Act of the Parliament of Great Britain extended to In-dia; the word "street" shall include any public square, circus, street, court, alley, foot-path, highway, lane, road, thoroughfare, public passage, or other public place within the said Town; the word "lands" shall include messuages, buildings, walls, tenements, and hereditaments of any tenure, as well as lands; the words "the said Commissioners" shall mean the Commissioners for the time being appointed under the provisions of Act of 1852; and the word "month" shall mean No calendar month.

In addition to the regulated proportion of Doolies for Native Troops, on a march, the Officer Commanding a Regiment or Detachment may procure by Requisition and Indent on the Commissariat Department, or by Contingent Bill where no Commissariat Agent is present, such additional Carriage for Sick, (Carts, Bullocks, or Tattoos,) as may be actually required, to the extent of five men in every hundred of the actual marching strength, without requiring the sanction of His Excellency the Commander in Chief and Government.

2. All Extra Sick Carriage beyond this amount will require the sanction of the Commander in Chief and Government, according to existing Orders.

No. 32 of 1852.—The Right Hon'ble the Governor in Council is pleased to republish the following General Order by the Most Noble the Governor General of India, dated Camp Shahjehanpoor, the 20th December 1851:—

The Most Noble the Governor General is pleased to publish the following paragraphs of a Despatch from the Hon'ble the Court of Directors to the Governor of Bengal, No. 122, dated 29th October last:—

Letter deted 28th June 1851, No. 99.

10. Forward, with reference to Court's orders in letter No. 5 of 1851, a letter from the Governor General, explaining his views as to the number and rank of Officers at present authorized to be withdrawn from Regimental, for Staff of detached duty.

"14. Agreeably to the proposal of the Governor General, as noticed in your letter of the 22nd July 1850, the Rule which limits the simultaneous withdrawal from Regiments of Native Infantry to six Officers for Staff and detached employments, was so far relaxed as to admit under particular circumstances of a seventh being withdrawn.

- "This latitude, however, was designed only for cases of emergency. The general Rule, fixing the limit at six, is that which we are desirous of maintaining, and which is applicable to the Armies of the three Presidencies.
- "15. We cannot doubt that by availing yourselves of the services of Madras Officers, and reducing, as far as possible, detached employments which can be dispensed with, you will henceforth be enabled to avoid the necessity, which we greatly deprecate, of withdrawing a seventh Officer from any Regiment."

With reference to our letter to Bengal of the 25th April last, No. 51, we have now to apprise you that by a Royal Grant, dated on the 26th September 1851, of which a copy is enclosed, Her Majesty has been pleased to grant to the East India Company the booty and plunder taken in the City of Mooltan and at the Forts of Mooltan and Chineoute, in trust, as to one-half part thereof for the proper use of the said Company towards their expenses in the said operations, and as to the other half part thereof for the use of the Commander-in-Chief, the Generals, and other Officers, Non-Commissioned Officers, and Privates, who served in the Punjaub during the war, after deducting the amount which they have severally received as donation of batte under the orders conveyed in our letter of the 18th July 1849 to be distributed to and amongst them, according to the users of the army in Judia July 1849, to be distributed to and amongst them, according to the usage of the army in India.

2. We have now the satisfaction of conveying to you our resolution to present to the Troops which served in the Punjanb during the war, the moiety of the booty which Her Majesty has been graciously pleased to place at our dis-

3. You will take the necessary measures for distributing the amount of this booty agreeably to the terms of the Grant, after deducting from the share or shares occurring to each Officer and Soldier the amount of the donation of batta which he has received under the Order above specified.

Victoria, by the Grace of God, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Paith.

To all to whom these presents shall come, greeting. Whereas the Commissioners of Our Treasury have represented unto Us that it had been made to appear to them by a report of Our Procurator General, that it was stated in a Memorial addressed to Our said Commissioners by the East India Company, that a rebellion against the Government of the Punjaub having broken out at Mooltan, in the East Indies, in the month of April, in the year of Our Lord 1848, headed by the Dewan Moolraj; and the Sikh Sirdars having declared their inability to coerce the rebels, a force composed of Our Troops, and of Troops of the East India Company, was employed for this purpose; that on the 2nd day of January in the year of Our Lord 1849, the Fort of Mooltan, after a practicable breach had been made therein, surrendered to the said Troops, and that on the 8th day of February in the said year of Our Lord 1849, the Fort of Chineoute also surrendered to them; and booty was taken in the said fortified City and Forts, consisting of jewels and other property, the sale proceeds of which have been realized by the Prize Agents emloyed for collecting the booty, or have been otherwise realized, amounting to the sum of Rupees 12,43,511-3-11; that in addition certain Ordnance and Ordnance Stores were taken in the said Fort of Mooltan, the value of which, according to the rates charged for such articles at the said Company's Arsenal in Bengal, is Rupees 66,412-10-8, making altogether a total of Rupees 13,09,923-14-7.

That the Memorialists having taken into their consideration the services performed by the Forces serving in the Punjaub, in the late operations, including those engaged in the capture of Mooltan, and the delay which would necessarily arise before a distribution could take place of any booty which We might be graciously pleased to grant, they resolved on the 18th of July in the said year of Our Lord 1849, that the Officers and Soldiers of those Forces should at the earliest possible period receive a pecuniary reward of not less amount than six months' batta; they therefore instructed the Government of India forthwith to pay to the Commander-in-Chief, the Generals, and other Officers, Non-Commissioned Officers, and Privates who served in the Punjaub during the Campaign, a donation equal to six months' full batta, on the understanding, that, if thereafter any booty which may have been captured in such Campaign should be made over to them, there should be deducted from any share of such Prize Money which might become payable to any individual a sum equivalent to the batta paid to him under those instructions, unless such share should be of less value than that sum;—in the latter case all that was to be repaid to the said Company's Treasury was to be the amount of the Prize Money, however small it might be. The Memorialists, therefore, prayed that Our said Commissioners would be pleased to recommend unto Us to grant to them all such booty and plunder, stores, provisions, and things as were found in, or taken in the said operations against Mooltan and Chineoute, as to the one-half part of the value thereof for the proper use of the Memorialists towards their expenses, and as to the one-half part of the value thereof for the proper use of the Memorialists towards their expenses, and as to the other half part thereof for the use of the Commanders, Officers, and Men belonging to the Forces employed in the said operations, after deducting the amount which they have already received as donation of batta, as aforesaid, and
