NOTIFICATIONS.

ECCLESIASTICAL DEPARTMENT.

Bombay Castle, Sth June 1892.

No. 30.—With reference to Government Notification No. 27, dated 1st July 1885, the following Notification by the Government of India, Home Department (Ecclesiastical), No. 170, dated 3rd June 1892, is republished :—

" Corrigendum.

The following alteration in Part I of the revised Ecclesiastical Rules promulgated by Home Department Notification No. 103, dated the 20th June 1885, is published for general information:

Rule IX .-- Substitute the following for this rule :

Where there is a resident Chaplain, he is responsible for the arrangements for digging a grave, and shall ordinarily arrange for the preparation of a coffin. Should he find or anticipate difficulty in making private arrangements for the preparation of a coffin, he should apply in military stations to the senior Military officer and in civil stations to the chief local Magistrate to make the necessary arrangements; and these officers are authorized to direct any local Public Works officer to supply all that is necessary. The local Public Works officer would usually be the Executive Engineer of Military Works in military stations and the Civil Executive Engineer in civil stations; but the senior Military officer in a military station and the chief local Magistrate in a civil station may in cases of emergency direct the Civil Executive Engineer or the Military Works Executive Engineer respectively to make the necessary arrangements. The resident Chaplain is in all such cases responsible that timely notice is given to the Government officers who may be called upon to arrange for the preparation of a coffin.

The senior Military officer in a military station and the chief local Magistrate in a civil station may, should the resident Chaplain report that private arrangements for the preparation of coffins are not feasible, issue a general order on the Executive Engineer, Military Works, and the Civil Executive Engineer, respectively, to prepare coffins upon the requisition of the resident Chaplain. The expenditure incurred by the Executive Engineer will be held in his miscellaneous advance account till repaid by the officer under whose special or general order it was incurred.

During the absence of the resident Chaplain from the station, the senior Military officer in a military station and the chief local Magistrate in a civil station shall be responsible for the arrangements for digging graves and preparing coffins."

No. 4776.—Whereas it appears to the Governor of Bombay in Council that land is required to be taken by Government at the expense of the Municipality of Bombay for a public purpose, viz., for the construction of a public street and for provision of frontage land; it is hereby declared that for the above purpose a piece of land, measuring more or less 4,460 square yards and forming portion of the New Revenue Survey No. $\frac{2}{4100}$, and bounded on the north by the property of Kushaba and Balaji Chapaji Kalay, on the south by a street, on the east by De Lisle Road, and on the west partly by the remaining portion of the property of Govardhandass Khimji and partly by the property of Thucker Vasonji Premji, is required within the Town and Island of Bombay.

GENERAL DEPARTMENT.

Bombay Castle, 2nd June 1892.

No. 1812.—In exercise of the power conferred by Act I of 1870, the following Rules for Quarantine against Cholera have been made by the Government of Bombay, with the previous sanction of the Governor General in Council: they have effect from the 30th ultimo in the Ports of Aden, Perim and the Somáli Coast as a temporary measure :—

- I.—The Commander of every vessel, including buggalows or other native craft, arriving from the Arabian Coast between Aden and Babelmandeb and from the African Coast between Suakim and Guardafui shall, before entering the harbour, indicate by signal the port from which such vessel has come.
- II.—Such Commander shall not, except as hereinafter provided, allow any communication, either with the pilot boat, except orally, or with the shore, or with any other vessel or boat in the harbour.
- III.—Immediately on arrival the Commander shall cause the letter R of the Commercial Signal Code to be hoisted, and shall keep the said flag flying during his stay in port or until authorized by the Health Officer to haul it down. If communication with the shore is not desired, the vessel shall anchor at such place as may be pointed out by the Port authorities, having regard to the season of the year. If communication with the shore is desired, the Health Officer shall go alongside the vessel, and, after all necessary enquiries, shall direct the Commander to take the vessel to the quarantine anchorage duly appointed and notified in that behalf by the Resident, there to remain for a period of seven, days from the date of arrival, or for the shorter period prescribed in Rule IV, and undergo disinfection, which should apply as well to crew, passengers, effects, and susceptible goods.
- IV.—If the Health Officer of the Port has sufficient evidence that no cases of a suspicious nature have taken place on board during the voyage, and if the vessel is besides in good hygienic condition, the duration of the quarantine will be diminished according to the following scale :—

- V.—If during the period a vessel is at the quarantine anchorage aforesaid any case or cases of cholera should occur on board, the said vessel shall remain in quarantine for a period of seven days from the date of the last case occurring, and be subject to all the prohibitions provided for in Rule III.
- VI.—When any vessel has been placed in quarantine as aforesaid, the Health Officer may direct the removal of so many of the passengers and crew as may not be suffering from illness, and whose services may not be required on board the vessel, to such particular spots as may from time to time be selected by the Resident as places of quarantine, there to remain for a period of seven days. If a case of cholera occurs among such passengers and crew during any such period, they shall remain in a place of quarantine for a period of fifteen days from the date of the occurrence of the last case of such illness.
- VII.—Any mails or cargo which may be brought by any vessel so arriving shall be landed under such precautions as the Health Officer may deem necessary to prevent the spread of the disease.
- VIII.—It will be the duty of the Port Officer to facilitate the conveyance to all vessels in quarantine of such supplies of provisions, stores and other articles as may be required by those on board. Such supplies will be placed on the boats of the vessels in quarantine to be subsequently removed by members of their crews.
- IX.—All vessels arriving at Aden, Perim and the Somáli Coast which may have communicated with vessels coming from the Arabian Coast between Aden and I.—149

Babelmandeb and from the African Coast between Suakim and Guardafui shall be subjected to the same quarantine as vessels arriving at Aden, Perim and the Somáli Coast from the Arabian Coast between Aden and Babelmandeb and from the African Coast between Suakim and Guardafui.

X.—All vessels which have undergone quarantine in the manner above prescribed should have the fact clearly stated on their Bills of Health.

No. 1862.—In exercise of the power conferred by Act I of 1870, the following Rules for Quarantine against Plague have been made by the Government of Bombay, with the previous sanction of the Governor General in Council: they have effect from the 3rd instant in the Ports of Aden, Perim and the Somáli Coast as a temporary measure :—

- I.—The Commander of every vessel, including buggalows or other native craft, arriving from Bassorah shall, before entering the harbour, indicate by signal the port from which such vessel has come.
- II.—Such Commander shall not, except as hereinafter provided, allow any communication, either with the pilot boat, except orally, or with the shore, or with any other vessel or boat in the harbour.
- III.—Immediately on any such arrival being signalled, the Health Officer of the Port shall go alongside the vessel and ascertain by enquiry from the Commander whether any person on board is suffering, or has during the voyage suffered, from plague, and if the Health Officer is satisfied by such enquiry that no person on board is suffering, or during the voyage has suffered, from plague, he shall direct the Commander to take the vessel to the quarantine anchorage, duly appointed and notified in that behalf by the Resident, there to remain for a period of seven days from the date of arrival in the harbour. The Health Officer shall also direct the Commander to prohibit, during the period for which the vessel remains at the quarantine anchorage as aforesaid, all communication, except such as is hereinafter provided for, between such vessel and the shore, or other vessels and boats in the harbour.
- 1V.—If the Health Officer shall have reason to believe at the time when the vessel arrives in the harbour that any person on board is suffering, or during the voyage has suffered, from plague, he shall direct the Commander to take the vessel to the quarantine anchorage as aforesaid, and there to remain for a period of fifteen days from the day of arrival in the harbour; and shall further direct that during such fifteen days, intercourse between the said vessel and the shore or other vessels and boats in the harbour shall be prohibited as provided in Rule III.
- V.—If during the period a vessel is at the quarantine anchorage aforesaid any case or cases of plague should occur on board, the said vessel shall remain in quarantine for a period of fifteen days from the date of the last case occurring, and be subject to all the prohibitions provided for in Rules III and IV.
- VL-When any vessel has been placed in quarantine as aforesaid, the Health Officer may direct the removal of so many of the passengers and crew as may not be

suffering from illness, and whose services may not be required on board the vessel, to such particular spots as may from time to time be selected by the. Resident as places of quarantine, there to remain for a period of seven days, or if the vessel has been placed in quarantine for fifteen days, for a period of fifteen days. If a case of plague occurs among such passengers and crew during any such period, they shall remain in a place of quarantine for a period of fifteen days from the date of the occurrence of the last case of such illness.

- VII.—Any mails or cargo which may be brought by any vessel so arriving shall be landed under such precautions as the Health Officer may deem necessary to prevent the spread of the disease.
- VIII.—It will be the duty of the Port Officer to facilitate the conveyance to all vessels in quarantine of such supplies of provisions, stores and other articles as may be required by those on board. Such supplies will be placed on the boats of the vessels in quarantine to be subsequently removed by members of their crews.
- IX.—All vessels arriving at Aden, Perim and the Somáli Coast which may have communicated with vessels coming from Bassorah shall be subjected to the same quarantine as vessels arriving at Aden, Perim and the Somáli Coast from Bassorah.
