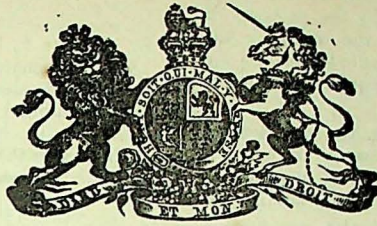

## PART I.

### Government Notifications, Appointments, &c.

#### NOTIFICATIONS.

##### REVENUE DEPARTMENT.

*Bombay Castle, 20th June 1892.*

No. 5107.—Government Notification No. 5846, dated 20th July 1885, published at pages 905 to 909 of the *Bombay Government Gazette* of the 23rd idem, Part I, declaring certain lands in the Kárwár Táluka of the Kánara District to be proposed Reserved Forests under Section 4 of the Indian Forest Act, No. VII of 1878, is hereby cancelled.

No. 5123.—His Excellency the Governor in Council is pleased, under Section 2 of the Indian Forest Act, No. VII of 1878, as amended by Act No. V of 1890, to appoint the officer for the time being in charge of the Remount-Rearing Depôt at Ahmednagar to be a Forest Officer, and, under Section 75 of the same Act, is pleased to appoint the

said officer to do all acts and exercise all powers that are prescribed by the Act or by rules made under it to be done by a Forest Officer or by any Forest Officer: such powers to be exercised in respect of the Reserved Forest known as the "Narayan Dev" Kuran in the Ahmednagar District, which has been transferred to the charge of the Army Remount Department to be utilized as a grazing ground for young stock.

No. 5143.—Whereas it appears to the Governor of Bombay in Council that land is required to be taken by Government at the expense of the Municipality of Bombay for a public purpose, viz., for the erection of a latrine, in the village of Warli, in the City of Bombay; it is hereby declared that for the above purpose a piece of land measuring more or less 150 square yards and which forms a

portion of the New Revenue Survey No. 31<sup>1/2</sup>, bounded on the north and east by the property of Mr. Janardan Parshotam, on the south by the property of Mr. Bhaskar Jagannath and on the west by the Warli Road, is required within the aforesaid village of Warli.

This declaration is made under the provisions of Section 6, Act X of 1870, to all whom it may concern, who are hereby warned not to obstruct or interfere with persons employed on the land.

A plan of the abovementioned plot can be seen at the office of the Collector of Land Revenue, Customs and Opium, Bombay.

No. 5143A.—Whereas it appears to the Governor of Bombay in Council that land is required to be taken by Government at the expense of the Municipality of Bombay for a public purpose, viz., for the erection of a latrine, in the village of Warli, in the City of Bombay; it is hereby declared that for the above purpose the following two plots of land are required within the aforesaid village of Warli, viz. :—

Plot A.—A piece of Fazindári land or ground measuring more or less 108 square yards and which forms a portion of the New Revenue Survey No.  $\frac{1}{3206}$ , bounded on the north and east by the property of Messrs. Atmaram Jagannath, Ramchandra Dadaji, Vishvanth Govindji and others, on the south by the property of Mr. Varjivandas Madhowdas and on the west by the property of Purshotam Madhowji.

Plot B.—A piece of Fazindári land or ground measuring more or less 51 square yards and which forms a portion of the New Revenue Survey No.  $\frac{3}{3206}$ , bounded on the north by the property of Purshotam Madhowji, on the south and east by the property of Messrs. Atmaram Jagannath, Ramchandra Dadaji, Vishvanath Govindji and others, and on the west by the Warli Road.

This declaration is made under the provisions of Section 6, Act X of 1870, to all whom it may concern, who are hereby warned not to obstruct or interfere with persons employed on the land.

A plan of the abovementioned plots of land can be seen at the office of the Collector of Land Revenue, Customs and Opium, Bombay.

No. 2079.—In exercise of the powers conferred by Sections 9, 13 and 18 of the Factories Act, 1881, as amended by Act XI of 1891, the Governor in Council is pleased to make the following rules and orders in supersession of the rules contained in Notification No. 2972, of 10th September 1881 (published in the *Bombay Government Gazette* for 1881, Part I, pages 503-504), viz. :—

1. These rules and orders may be cited as  
Short Title. "The Bombay Factories Rules, 1892."

Interpretation. 2. In these rules and orders:

(a) words and expressions which are defined in the Indian Factories Act, 1881, as amended by Act XI of 1891, have the same meaning as in the said Act, as so amended;

(b) "the Act" means the Act aforesaid, amended as aforesaid.

3. Every occupier of a factory shall, on every day on which work is carried on in the factory provided in factories. he occupies, have available at the said factory for the use of the persons employed therein, free of cost to them, a water-supply consisting of at least twice as many gallons of water as there are persons employed in the factory. Of the whole supply, at least as many gallons as there are persons employed in the factory shall be fit for potable purposes and the remainder shall be fit for purposes of washing.

4. In order to determine whether the water-supply provided in any factory under Rule 3 is fit for the purposes therein mentioned, the Inspector may take, free of cost, such samples of it as he may from time to time require for analysis.

5. Every factory shall be ventilated to the satisfaction of the Inspector. To prevent overcrowding, the minimum space to be provided for each person employed in any room of a factory shall be a floor area of 36 superficial feet, and a breathing area of 500 cubic feet. No factory shall be considered ventilated unless ventilating openings are provided in the proportion of 10 square feet for each person employed in any room and the openings are such as to admit of a continued supply of fresh air: Provided that it shall be in the discretion of the Inspector to waive the rule as to the measurement of the ventilating openings, when he is satisfied that the ventilation is good and the enforcement of the exact measurement of ten feet for each person would be an unnecessary hardship. The reasons for waiving the rule shall, however, be recorded in writing.

6. If in a factory where cotton-pressing or any other process is carried on, by which dust is generated and caused to be inhaled by the persons employed in such factory to an injurious extent, and it appears to the Inspector that such inhalation

Prevention of inhalation of dust generated in certain factories.

might be wholly or to a great extent prevented, he may direct the occupier of such factory to adopt measures for preventing, as far as possible, such inhalation.

7. All the inside walls of the rooms of every factory, and all the ceilings or tops of such rooms (whether such walls, ceilings or tops be plastered or not), and all the passages and staircases of every factory, if they have not been painted with oil or varnished once at least within seven years, shall be lime-washed by the occupier of the factory once at least within every fourteen months, to date from the period when last lime-washed; and if they have been so painted or varnished, shall be washed by the said occupier with hot water and soap once at least within every fourteen months, to date from the period when last washed.

8. Where it appears to the Governor in Council that the enforcement of the provisions of Rule 7 is not necessary for insuring the cleanliness of any class of factories or parts thereof or that the said provisions are by reason of special circumstances inapplicable to any class of factories or to parts thereof, he may, by notification in the *Bombay Government Gazette*, exempt such class of factories or parts thereof from the said provisions.

9. Every factory shall be kept by the occupier thereof in as cleanly a state as is compatible with the nature of the work carried on therein and free from effluvia arising from any drain, privy or other nuisance.

10. Every factory shall be provided by the occupier thereof with latrine and urinal accommodation for its operatives, and in such manner that the accommodation for females shall be apart and screened from the divisions for males. The divisions for females shall be marked in the vernacular in conspicuous letters "For Females only." Those for males shall be similarly marked "For Men only." Apart from the urinal accommodation latrines shall be provided with seats in the proportion of one to every fifty or fraction of fifty operatives employed.

11. Every order passed by an Inspector under Rule 6 or under Section 12 (c) of the Act shall be recorded by him in writing and a copy thereof signed by the Inspector shall be delivered by him to the occupier of the factory to which the order relates or, in his absence from the factory, to his principal agent or manager in charge of the factory. The Inspector shall state clearly in the order what is required to be done and shall specify a reasonable time within which effect shall be given to his requisition, and shall further give notice that, if within the time so specified effect is not given to the said requisition, the person responsible for the neglect will be prosecuted under Section 15 of the Act.

12. Every factory shall be visited by an Inspector at least once in every three months in which work is carried on therein.

Provisions as to inspection of factories. For the purpose of verifying the register kept as prescribed by Rule 19, the Inspector shall examine the children employed in the factory during their working-hours only; but for the purpose of satisfying himself that the said children are allowed the lawfully prescribed intervals for food and rest, he may examine the children and the said register during any such interval.

13. Every order passed by an Inspector under Section 4 (c) of the Act shall be in writing and a copy thereof signed by the Inspector shall be delivered by him to the occupier of the factory or, in his absence from the factory, to his principal agent or manager in charge of the factory.

14. Any occupier of a factory on whom or on whose agent or manager an Inspector serves an order under Rule 6 or under Section 12 (c) of the Act, may, within seven days after receipt of such order, appeal, if the factory is in the city of Bombay, to the Collector of Bombay and, if the factory is without the city of Bombay, to the Collector of the district in which it is situated or, if the Collector is himself the Inspector, to the Commissioner to whom such Collector is subordinate. No second appeal shall lie from an order passed on appeal, but the Governor in Council may review any order made by an Inspector under Rule 6 or Section 12 (c) of the Act or any order passed by any authority on appeal from any such order, and may pass any order thereon which he may think proper.

15. Every appeal preferred under Rule 14 shall be made in writing in the form of a memorandum of appeal briefly setting forth the reasons on which such appeal is based and bearing a court-fee stamp in accordance with Article 11, Schedule 2 of the Court-fees Act.

16. Every such appeal shall be heard at as early a date as may be convenient, due notice of which shall be given to the appellant and to the Inspector whose order is appealed against. The appellate authority shall make, or cause to be made, in such manner as he may see fit, such inquiry, if any, as shall appear to him to be necessary to enable him to decide the appeal.

17. If an order of an Inspector under Rule 6 or Section 12 (c) of the Act is set aside or altered in appeal, or by the Governor in Council on review, the Inspector shall as early as possible deliver to the person concerned an intimation of the result of the appeal or review and such amended order, if any, as the decision of the appellate authority or of the Governor in Council renders necessary.

18. At the end of every quarter every Inspector shall forward to Government a full report of the results of each inspection made by him during the quarter and of his examination of the premises and machinery and of the registers of the children employed, together with a statement of all orders passed by him under Sections 4 (c) and 12 (c) of the Act and No. 6 of these Rules and of all prosecutions instituted by him or with his sanction under Section 15 of the Act and their result.

19. The occupier of every factory in which children are employed shall keep, in the form A hereto appended, a register of the children employed in such factory and of their respective employments.

20. Notices of accidents shall be sent, as required by Section 13 of the Act, to the following authorities, viz. :

(a) if the accident occurs in the city of Bombay, to the Inspector appointed under the Act for that city ;

(b) if the accident occurs in the Kirkee Gunpowder Factory, to the officer commanding the Kirkee station ;

(c) if the accident occurs elsewhere, to the District Magistrate.

Such notice shall be in the form B hereto appended ; and shall be sent :

(d) within one hour of the accident, if death has been caused or is known to be likely to be caused, or if a limb is broken ; and

(e) in any other case, within twelve hours of the time when it is known that the injuries caused are such as to require the sending of a notice under Section 13 of the Act..

## JUDICIAL DEPARTMENT.

*Bombay Castle, 17th June 1892.*

No. 3236.—With reference to and in modification of the rules regarding the remuneration and duties of the Law Officers of Government, published in the Notifications noted in the margin, the Governor in Council is pleased to make the following additions to the said rules, and to direct that they shall come into force as hereinbelow prescribed, that is to say,

I.—To come into force at once :—

The following clause added to Rule 6, namely :

“(c) to appear on behalf of Government in all appeals to the High Court from decisions of the Presidency Magistrates, when required to do so by Government, on the motion of the Solicitor to Government as Public Prosecutor.”

II.—To come into force on the next occurrence of a vacancy in the office of Advocate General :

(a) The following words added to Rule 2, namely :

“including projects of legislation. He is not responsible for the correct preparation of the drafts of Bills, but when called on to advise upon Bills which are under the consideration of Government, it is his duty to indicate any defects he may detect in the drafting thereof and to suggest such modifications as he may deem necessary therein, as well as to advise generally upon the proposed measures.”

(b) The words “the Solicitor to Government as Public Prosecutor, and” inserted after the word “advise” in Rule 4, and the words “either of those officers” substituted for the words “the latter” in the same rule.

(c) The following clause and proviso added to Rule 6, namely :

“(d) to appear on behalf of Government in any case, civil or criminal, which comes before the High Court with reference to any decision, order or proceeding of a Court situated without the City of Bombay, when required to do so by Government, on the motion of the Legal Remembrancer or otherwise :

“Provided that for every case in which he is called upon to appear under clause (d), the Advocate General shall be entitled to a fee as Counsel of such amount as shall from time to time be fixed by Government.”

No. 3374.—The following Notification by the Government of India in the Home Department is republished for general information :—

## “POLICE.

*Simla, the 15th June 1892.*

No. 336.—In exercise of the power conferred by section 2, sub-sections (1) and (2), of the Police Act (III of 1888), and of all other powers enabling him in this behalf, the Governor General in Council is pleased to create a general police district embracing all the lands for the time being occupied by the North-Western Railway, including the portions situate in the States of Patiala, Nabha and

Kapurthala, but excluding the portions situate in British Baluchistan and the territories administered by the Agent to the Governor General in Baluchistan as such Agent, all lands occupied by stations, out-buildings and for other railway purposes being included, and to direct the enrolment under Act V of 1861 of a police force for service therein.

The Governor General in Council is also pleased to appoint the Lieutenant-Governor of the Punjab to discharge within the general police district aforesaid the functions of the Local Government under Act V of 1861, the Code of Criminal Procedure, 1882, and any other enactment relating to police for the time being in force in the lands aforesaid or in any part thereof.

## MARINE DEPARTMENT.

No. 59.—The following Notice to Mariners received from the Political Agent, Cutch, is published for general information :—

“Cutch.

*Gulf of Cutch.*

From the 23rd April 1892 a new light is exhibited from the newly constructed light-house at Navalal.

It is a fourth order fixed catadioptric light. Its arc of illumination is E.N.E. bounded by the south to W.S.W. 180°, and its focal plane is 58 feet above mean sea level. It is visible in clear weather for 15 miles.”

No. 60.—The following Notice to Mariners issued by the Port Officer, Rangoon, on the 27th May 1892, is published for general information :—

“Bay of Bengal—Approaches to Chittagong.

It has been reported that the South Patches buoy off Cox Bazaar has broken adrift and was last seen in the vicinity of the Dolphin Shoal to the westward of Kutubdea Light-house.”

No. 61.—The following information received from the Collector and Political Agent, Kolaba, is published for general information :—

“The red buoy on the north side of the ‘Whale Reef’ off Rájpurí Point at the entrance of the Janjira Harbour was removed for the south-west monsoon on the 21st May 1892.”

No. 62.—In accordance with the provisions of Section 74 of the Bombay Port Trust Act, 1879, the following alterations which the Trustees of the Port of Bombay propose to make in the existing bye-laws for the regulation and management of the

Port Trust Docks are published for the information of all persons whom they may concern :—

“The word ‘wet’ to be struck out from the title and preamble of the Dock Bye-laws and also from the reference made to them in the preamble to the bye-laws added for the government of the Merewether Dry Dock.

“Bye-law No. 34A to be cancelled and the following substituted :

“34A. No cargo, goods, ballast, ashes or other substance, or rubbish shall be thrown or allowed to fall into the dock channels or dock or from any pier or quay, and if when discharging, unloading, loading or handling such cargo from or into any vessel or otherwise, howsoever, any cargo, goods or substance falls as aforesaid, the master of the vessel so discharging, unloading or loading or handling such cargo, goods or substance as aforesaid, as well as the stevedore and ship’s officer in charge of the unloading or loading or handling of such cargo, goods or substance, and in any other case the person who for the time being had charge of the said cargo, goods or substance, shall be liable to a penalty in respect thereof not exceeding Rs. 100.

“34B. In the event of any such cargo, goods or substance being thrown or allowed to fall as mentioned in the foregoing bye-law, the master of such vessel as aforesaid and the stevedore and ship’s officer in charge or in any other case, the person in charge of the said cargo, goods or substance as mentioned in the foregoing bye-law, shall immediately take measures to have the said cargo, goods or substance taken out of the water, and in the event of failure to do so within eighteen (18) hours from the receipt of notice by the Dock Superintendent calling upon any such party or parties to take such steps as aforesaid, the master of the said vessel and the party or parties aforesaid shall be liable to a fine not exceeding Rs. 100, and the Dock Superintendent may remove such cargo, goods and substance at the expense of such defaulting party or parties as aforesaid and such expenses shall be recovered from such party or parties. In the event of any such cargo, goods or substance being thrown or falling as aforesaid, the master of the said vessel and the party in whose charge the cargo, goods or substance

were at the time shall be responsible for all damage which may occur in consequence.

“34C. In the event of any cargo, goods or substance being thrown or allowed to fall as mentioned in the foregoing bye-laws, the master of the vessel as aforesaid and the stevedore and ship’s officer in charge of the unloading or loading as aforesaid, and in any other case the person who for the time being had charge of the cargo, goods or substance, shall forthwith give notice of the occurrence and furnish all particulars connected therewith to the Dock Superintendent.

“The word ‘Prince’s’ to be struck out from bye-law No. 54.

“In bye-law No. 84 the word ‘bridge’ to be cancelled wherever it occurs and the words ‘bridges and caissons’ substituted.

“The words ‘without authority’ to be inserted between the words ‘shall’ and ‘be’ in the first line of bye-law No. 128.”

No. 63.—In exercise of the power conferred by Section 3 of the Indian Merchant Shipping Act (VII of 1880) as amended by the Deck and Load Lines Act (XVII of 1891) and with the previous sanction of the Governor General in Council, His Excellency the Governor in Council is pleased to exclude native craft not square-rigged from the operation of Chapter II of the said Indian Merchant Shipping Act.

“The buoys of Murdeshwar and Bhatkal were removed from their position for the ensuing monsoon on the 16th and 20th May 1892 respectively.”

## PART I.

### Notification.

#### GENERAL DEPARTMENT.

*Bombay Castle, 24th June 1892.*

No. 2119.—In exercise of the power conferred by Act I of 1870, the following Rules for Quarantine against Cholera have been made by the Government of Bombay, with the previous sanction of the Governor General in Council: they have effect from the 20th instant in the Ports of Aden, Perim and the Somali Coast as a temporary measure:—

- I.—The Commander of every vessel, including buggalows or other native craft, arriving from Jibuti shall, before entering the harbour, indicate by signal the port from which such vessel has come.
- II.—Such Commander shall not, except as hereinafter provided, allow any communication, either with the pilot boat, except orally, or with the shore, or with any other vessel or boat in the harbour.
- III.—Immediately on arrival the Commander shall cause the letter R of the Commercial Signal Code to be hoisted, and shall keep the said flag flying during his stay in port or until authorized by the Health Officer to haul it down. If communication with the shore is not desired, the vessel shall anchor at such place as may be pointed out by the Port authorities, having regard to the season of the year. If communication with the shore is desired, the Health Officer shall go alongside the vessel, and, after all necessary enquiries, shall direct the Commander to take the vessel to the quarantine anchorage duly appointed and notified in that behalf by the Resident, there to remain for a period of seven days from the date of arrival, or for the shorter period prescribed in Rule IV, and undergo disinfection, which should apply as well to crew, passengers, effects, and susceptible goods.

IV.—If the Health Officer of the Port has sufficient evidence that no cases of a suspicious nature have taken place on board during the voyage, and if the vessel is besides in good hygienic condition, the duration of the quarantine will be diminished according to the following scale:—

V.—If during the period a vessel is at the quarantine anchorage aforesaid any case or cases of cholera should occur on board, the said vessel shall remain in quarantine for a period of seven days from the date of the last case occurring, and be subject to all the prohibitions provided for in Rule III.

VI.—When any vessel has been placed in quarantine as aforesaid, the Health Officer may direct the removal of so many of the passengers and crew as may not be suffering from illness, and whose services may not be required on board the vessel, to such particular spots as may from time to time be selected by the Resident as places of quarantine, there to remain for a period of seven days. If a case of cholera occurs among such passengers and crew during any such period, they shall remain in a place of quarantine for a period of fifteen days from the date of the occurrence of the last case of such illness.

VII.—Any mails or cargo which may be brought by any vessel so arriving shall be landed under such precautions as the Health Officer may deem necessary to prevent the spread of the disease.

VIII.—It will be the duty of the Port Officer to facilitate the conveyance to all vessels in quarantine of such supplies of provisions, stores and other articles as may be required by those on board. Such supplies will be placed on the boats of the vessels in quarantine to be subsequently removed by members of their crews.

IX.—All vessels arriving at Aden, Perim and the Somali Coast which may have communicated with vessels coming from Jubiti shall be subjected to the same quarantine as vessels arriving at Aden, Perim and the Somali Coast from Jubiti.

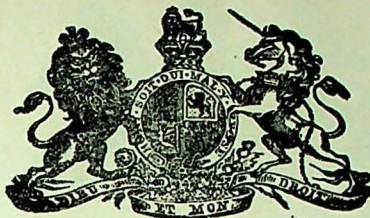
X.—All vessels which have undergone quarantine in the manner above prescribed should have the fact clearly stated on their Bills of Health.
