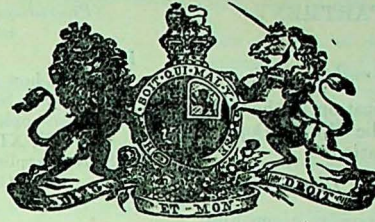

*Rules for enabling Railway Commissioners to carry into effect the provisions of Chapter V of the Indian Railways Act, 1890, and for regulating proceedings before such Commissioners and for prescribing the fees to be taken in relation to such proceedings.*

In exercise of the powers given him by section 34 of the Indian Railways Act, 1890, and of all other powers enabling him in that behalf, the Governor General in Council is pleased to make the following rules for enabling Railway Commissioners to carry into effect the provisions of Chapter V of that Act and for regulating proceedings before such Commissioners, and for prescribing the fees to be taken in relation to such proceedings:

## PRELIMINARY.

*Interpretation.*

1. In the construction of these rules, and of the forms in the first schedule thereto, words importing the singular number shall include the plural, and words importing the plural number shall include the singular; and, unless a different intention appears from the context, the following terms shall have the respective meanings hereinafter assigned to them; that is to say,—

‘person’ shall include any company or association or body of individuals, whether incorporated or not:

‘the Code’ shall mean the Code of Civil Procedure, 1882, as amended by subsequent enactments:

‘the Act’ shall mean the Indian Railways Act, 1890:

‘plaintiff’ and ‘defendant’ shall respectively mean the persons named as such respectively in the applications hereinafter referred to; and terms defined by the General Clauses Acts, 1868 and 1887, or either of them, the Code, or the Act, shall have the same meanings as are assigned to them by those Acts respectively.

2. In the application of the Code to proceedings under these rules the following expressions shall, unless a different interpretation be required by these rules or

the context, have the meanings hereinafter assigned to them; that is to say,—

‘the Court’ and ‘the Court in which the suit is instituted’ shall respectively mean the Commissioners:

‘the Judge’ shall mean the Law Commissioner:

‘such officer as it appoints in this behalf’ shall mean the Registrar.

*Registrar and Deputy Registrar.*

3. (1) A Registrar of the Railway Commissioners (in these rules referred to as the Registrar) shall be appointed by the Governor General in Council, and his office shall be open daily during office hours and shall be located,—

(a) when the Commissioners are not sitting, in the building occupied by the establishment of the Secretary to the Government of India in the Legislative Department, and,

(b) when the Commissioners are sitting, in such place as the Commissioners may appoint.

(2) When the Commissioners are not sitting, and with their permission when they are sitting, the Registrar’s office may be closed on days on which the office of the Secretary to the Government of India in the Legislative Department is authorised by him to be closed.

(3) The Commissioners shall have a common seal (to be used by every Railway Commission appointed under the Act) which shall be kept in the custody of the Registrar at his office.

4. The Governor General in Council may from time to time, as occasion may require, appoint a Deputy Registrar to discharge temporarily all or any of the functions of the Registrar.

*Computation of time.*

5. The provisions of section 7 of the General Clauses Act, 1887, shall, so far as they can be made applicable, be applied in the computation of time for the purposes of these rules.

## PROCEEDINGS BEFORE REFERENCE TO RAILWAY COMMISSION.

*Applications under Chapter V of the Act to the Governor General in Council.*

6. (1) Every application to the Governor General in Council under Chapter V of the Act for the reference of a case to a Railway Commission must be addressed by the applicant to the Secretary to the Government of India in the Legislative Department. It must be in writing, or printed, and signed by the applicant or his recognised agent, and shall be according to one of the Forms A in the first schedule hereto or to

the like effect, and it must be indorsed with the name and address of the applicant, and, if there is a legal adviser acting for him in the matter, with the name and address of such legal adviser.

(2) If the application be for a reference to the Commissioners as arbitrators under section 28, clause (b) or clause (c), of the Act, it must be signed by all the parties to such reference or their respective recognised agents, and it shall be according to Form A, No. 1, in the said schedule or to the like effect.

(3) In every other case the application shall be according to Form A, No. 2 in the said schedule, and shall be accompanied by a copy of the plaint therein referred to, which plaint must be signed and verified in accordance with the provisions of sections 51 and 52 of the Code.

7. (1) The Governor General in Council before answering the application may, if he shall think fit, refer the same to the railway administration against which it is made, so as to afford the administration an opportunity of making observations thereon: and he will, in such case, give the applicant notice that the application has been so referred, and upon his request and at his expense will furnish him with a copy of the observations (if any) made thereon by the railway administration.

(2) The applicant shall be at liberty, within seven days after he shall have received such copy, to reply thereto as he may be advised.

8. After consideration of the application and the observations (if any) which may have been made by the railway administration thereon and by the applicant in reply, the Governor General in Council will determine whether or not the application should be referred to a Railway Commission for decision.

9. Should the Governor General in Council be of opinion that the application ought not to be referred to a Railway Commission, the applicant will be informed accordingly.

10. (1) Should the Governor General in Council be of opinion that the application ought to be referred to a Railway Commission, the respective parties thereto will be so informed, and the application will be made over to the Registrar and be filed by him.

(2) The Governor General in Council may make such reference subject to any conditions which he may think fit to impose on the applicant as to security for costs or otherwise.

11. (1) Whenever in the opinion of the Governor General in Council, a Railway Commission ought to be appointed,

he will by notification appoint such a Commission and specify the case or cases thereby referred to the Commissioners.

(2) The time and place of the sitting for the first hearing of each such application shall be notified by the Registrar in the *Gazette of India* and to the respective parties to the application.

PROCEEDINGS AFTER REFERENCE TO RAILWAY COMMISSION.

*Proceedings before the Commissioners as arbitrators.*

12. (1) Each of the parties to any application under section 28, clause (b) or clause (c), of the Act may, at any time within thirty days after the issue of the notification referring the application to a Commission, file with the Registrar a written statement of his case, and the Registrar shall receive all such statements and place them on the record.

(2) Any two or more of the parties to the reference may concur in filing the same written statement.

(3) If all the parties concur in the same written statement, no evidence shall be required or received in support thereof, and the Commissioners shall proceed to hear and determine the questions in difference on the assumption that all the statements contained in such written statement are true, and that all the facts necessary for such determination sufficiently appear in such written statement and the application or one of them, and they shall thereupon proceed to make and sign their award.

(4) Should none of the parties to the reference file any such written statement as aforesaid, the application shall, for the purposes of the hearing and determination of the case, be deemed to be a written statement concurred in by all the parties.

(5) If the parties do not all concur in the same written statement, the Commissioners shall as soon as conveniently may be after the expiration of the said period of thirty days, or such further time as may have been granted by any enlargement thereof, hereinafter called the prescribed period, fix the time and place for the first hearing of the reference.

(6) Should any of the parties omit, or neglect to file or concur in a written statement, he shall not be permitted to adduce any evidence at the hearing of the reference, but he shall nevertheless be permitted to cross-examine any witnesses produced by any other party in an adverse interest, and shall be entitled to argue any question at issue as he may be advised.

(7) The provisions of sections 114, 115, and 116 of the Code shall apply to all such written statements as aforesaid.

(8) Every such written statement shall be according to one of the Forms B in the first schedule hereto or to the like effect.

*(Proceedings after Reference to Railway Commission.—Rules 13-19.)*

13. (1) The party filing any such written statement as aforesaid shall along therewith leave with the Registrar a memorandum of the documents (if any) which he proposes to adduce in evidence at the hearing of the reference, and as many copies on plain paper of such written statement and memorandum as there are other parties to the reference, and four others for the use of the Court.

(2) The Registrar shall sign such memorandum and copies if on examination he shall find them correct.

(3) The Registrar shall, at any time after the expiration of the prescribed period and before the first hearing of the reference, deliver to each of the parties who shall apply therefor a signed copy of all memoranda and written statements filed by any of the other parties to the reference.

(4) The Registrar shall cause the title of the case and a list of the written statements filed therein, with the names of the parties filing them respectively, to be entered in a book to be kept for the purpose and called 'The Register of References to Arbitration,' and such entries shall be numbered in every according to the order of the notifications referring the cases respectively.

14. On and after the day appointed for the first hearing of the reference, the proceedings shall be conducted in all respects as if the case were being heard under an order of reference made under section 508 of the Code, and the Commissioners were an arbitrator appointed under section 507 of the Code; and all the provisions of the Code in respect of references to arbitration shall apply to such proceedings, subject nevertheless to the provisions of these rules, and to the following additional modifications, that is to say:

(a) no time shall be fixed or be deemed to have been fixed for the delivery of the award which may be delivered at any time after the first hearing which the Commissioners may think proper;

(b) none of the provisions of sections 509, 510, 511 and 512 of the Code shall apply to any such reference;

(c) for the purposes of sections 520, 521 and 522 of the Code 'the Court' shall mean the High Court to which in the case in question an appeal lies under section 31 of the Act.

(d) for all other purposes of such reference 'the Court' shall mean the Commissioners.

*Proceedings before the Commissioners otherwise than as arbitrators.*

15. Every application referred to a Railway Commission (other than an application under section 28, clause (b), or clause (c), of the Act) shall be called a suit, and shall be deemed to have been instituted by the filing by the Registrar of

the application when made over to him by the Governor General in Council under rule 10.

16. Subject to the provisions of these rules, every such suit shall be conducted in all respects as if the same were a civil suit instituted in a Court of competent jurisdiction in accordance with the provisions of the Code, and, save as hereinafter mentioned, all the provisions of Part I of the Code shall apply to all such suits.

17. None of the provisions of Chapters II, IV, IX, XIX and XX of the Code shall apply to any such suit.

Non-application to suits of Chapters II, IV, IX, XIX and XX of Code.

18. The proviso at the end of section 36 of the Code shall not apply to any such suit.

*Plaint.*

19. (1) Sections 48, 54 to 57 (both inclusive), 61 and 62 of the Code shall not apply to any such suit.

(2) For section 49 of the Code the following shall be substituted, namely:

'49. The plaint must be distinctly written or printed in English, and shall be according to one of the Forms C in the first schedule to these rules or to the like effect.'

(3) For section 50 of the Code the following shall be substituted, namely:

'50. The plaint must contain the following particulars:

- (a) the name of the Court;
- (b) the name, description and place of residence of the plaintiff;
- (c) the name, description and place of residence of the defendant;
- (d) a plain and concise statement of the circumstances constituting the cause of action, and where and when it arose;
- (e) a demand of the relief which the plaintiff claims; and
- (f) a statement of the manner in which the defendant is or claims to be interested in the question, showing that he is liable to be called upon to answer the plaintiff's demand:

'Provided that, where a railway administration is plaintiff or defendant in any such suit, it shall be sufficient to name such administration in the plaint without any further description or place of residence:

'Provided also that for all purposes of the suit the principal office in India of such administration shall be deemed to be its place of residence.'

(4) For section 53 of the Code the following shall be substituted, namely:

*(Proceedings after Reference to Railway Commission.—Rules 20-22.)*

‘58. (1) Within thirty days after the issue of the notification referring the application to a Commission, the plaintiff shall file with the Registrar a memorandum of the documents (if any) which he proposes to adduce in evidence at the hearing, and he shall at the same time present as many copies on plain paper of the plaint and memorandum of documents as there are defendants, and four others for the use of the Court.

‘(2) The Registrar shall sign such memorandum and copies if on examination he shall find them correct.

‘(3) The Registrar shall thereupon file the plaint and place it upon the record.

‘(4) The Registrar shall also cause the particulars mentioned in section 50 to be entered in a book to be kept for the purpose and called ‘the Register of Suits;’ and such entries shall be numbered in every year according to the order in which the plaint is admitted.’

(5) For section 59 of the Code the following shall be substituted, namely:

‘59 If the plaintiff sues upon a document in his possession or power, he shall at the time of filing the said memorandum deliver the document or a copy thereof to be filed with the plaint.’

(6) For section 63 of the Code the following shall be substituted, namely:

‘63. A document which ought to be entered in the said memorandum, and which is not entered accordingly, shall not, without the leave of the Court, be received in evidence on the plaintiff’s behalf at the hearing of the suit.

‘Nothing in this section shall apply to any document produced for cross-examination of the defendant’s witnesses, or in answer to any case set up by the defendant or handed to a witness merely to refresh his memory.’

20. (1) As soon as conveniently may be after the plaintiff has presented such memorandum and copies of the plaint as aforesaid, the Registrar shall cause each defendant to be served with a summons requiring him, within thirty days from the service thereof, to put in his answer (if any) to the said plaint.

(2) Every such summons shall be according to the Form D in the first schedule hereto, and shall be signed by the Registrar and sealed with the seal of the Court, and shall be accompanied by one of the copies of the plaint and memorandum of documents mentioned in rule 19, clause (4).

(3) Every such summons may be served by forwarding the same by post in a registered cover addressed to the defendant, or, where the defendant is a railway administration or a com-

pany, to the manager or agent of the administration or the chairman or secretary of the company at its principal office in India.

*Answer.*

21. (1) Within thirty days from the service of the said summons the defendant shall file with the Registrar his answer, if any, to the plaint, and leave with him four copies of the same for the use of the Court. The answer shall contain a clear and concise statement of the facts which form the ground of defence, or of any objections relied upon. It shall be taken to admit all facts stated in the plaint which are not expressly denied. It shall be divided into paragraphs numbered consecutively, and shall be signed and verified in accordance with the provisions of sections 51 and 52 of the Code. It shall be indorsed with the name and address of the defendant and if there is a legal adviser acting for him in the matter, with the name and address of such legal adviser. It shall be according to Form E in the first schedule or to the like effect.

(2) The defendant filing any answer shall along therewith file with the Registrar a memorandum of the documents (if any) which he proposes to adduce in evidence at the hearing of the suit, and leave with him four copies of such memorandum for the use of the Court.

(3) The defendant shall at the same time present to the Registrar a plain paper copy of such answer and memorandum of documents as aforesaid, and the Registrar shall sign such copy if on examination he shall find it correct.

(4) The defendant shall as soon as may be after the filing of his answer deliver to the plaintiff or his recognised agent such signed copy as last aforesaid.

(5) A document which ought to be entered by any defendant in the said memorandum, and which is not entered accordingly, shall not, without the leave of the Court, be received in evidence on his behalf at the hearing of the suit.

Nothing in this clause shall apply to any document produced for cross-examination of the plaintiff’s witnesses, or in answer to any case set up by the plaintiff in his reply, or handed to a witness merely to refresh his memory.

(6) Should any defendant omit to appear and answer within the time specified in the summons, or such further time as may have been granted by any order of enlargement of time made under these rules, he shall be taken to have admitted all the facts stated in the plaint, and shall not be permitted to adduce any evidence at the hearing of the suit, but he shall nevertheless be at liberty to cross-examine any witness produced by the plaintiff, and shall be entitled to argue any question at issue as he may be advised.

*Reply.*

22. (1) Within thirty days from the delivery of the answer or the last of the answers to the plaintiff he shall file his

reply (if any) with the Registrar, and leave with him four copies of the same for the use of the Court. The reply may object to the said answers or any of them as being insufficient, stating the grounds of such objection, or deny the facts stated therein, or any of them, or state any other facts in answer to the allegations contained in such answer. It shall be taken to admit all facts stated in the answer and not inconsistent with the plaint which are not expressly denied. It shall be signed and verified in accordance with the provisions of sections 51 and 52 of the Code, and shall be according to one of the Forms F in the first schedule or to the like effect.

(2) The plaintiff shall within the time aforesaid deliver to each defendant who has appeared and answered the plaint a signed copy of his reply.

*Consent cases.*

23. The parties may, by consent in writing filed with the Registrar, dispense with the formal proceedings hereinbefore mentioned, or some portion of them, and orders by consent may be drawn up, and, if approved by the Commissioners, may be signed by them.

*Written statements.*

24. (1) The parties may, at any time before or at the first hearing of the suit, tender written statements of their respective cases, and the Court shall receive such statements and place them on the record.

(2) The provisions of sections 114, 115 and 116 of the Code shall apply to all such written statements.

(3) Save as aforesaid, no written statement or other pleading shall be received without special leave of the Commissioners.

*First hearing.*

25. (1) As soon as the pleadings are complete, the Commissioners shall appoint a time and place for the first hearing of the suit.

(2) The Registrar shall, in addition to the notification required by rule 11, clause (2), cause a summons to be served upon each of the parties to the suit, requiring him to appear in person or by his pleader at the time and place specified in such summons for the settlement of issues in the suit.

(3) Every such summons shall be signed by the Registrar and sealed with the seal of the Court.

(4) The provisions of sections 72 to 95 of the Code, both inclusive, shall apply to all the summonses hereinbefore mentioned and the service thereof, but, save as aforesaid, Chapter VI of the Code shall not apply to any suit under these rules.

(5) Every document other than a summons required by these rules to be served upon or delivered to any party may be so served or delivered by forwarding the same by post in a

registered cover addressed to such party, or his recognised agent, or, where such party is a railway administration or a company, to the manager or agent of the administration or the chairman or secretary of the company at its principal office in India.

(6) In the computation of time under these rules every document so forwarded by post as aforesaid shall be deemed to have been delivered by the party delivering the same when put into the post or handed to some proper officer of the Post Office for the purpose of being posted, and to have been delivered to the party to whom the same is addressed in due course of post, unless he shall prove that it was not in fact delivered to him or at his residence until some later time.

26. (1) In the application of Chapter VII of the Code to suits under these rules for the words 'fixed for the defendant's appearance and answer,' or any words tantamount thereto wherever they occur, the words 'appointed for the first hearing of the suit' shall be substituted.

(2) None of the provisions of sections 99A, 101, 103 and 107 of the Code shall apply to any such suit.

(3) For sections 100 and 102 of the Code the following shall be substituted, namely:

100. If any party appears and any other party does not appear, the Court may either—

(a) proceed *ex parte* as to the party not appearing;

(b) direct a second summons to be issued and served on the party not appearing; or

(c) postpone the hearing of the suit to a future day to be fixed by the Court, and direct notice of such day to be given to the party not appearing.

(4) Save as hereinbefore appears, nothing in Chapter VIII of the Code shall apply to any suit under these rules.

Substitution of new section for section 146, non-application to suits of section 155, and amendment of section 157 of the Code.

27. (1) For section 146 of the Code the following shall be substituted, namely:

146. At the first hearing of the suit the Court shall, after reading the pleadings and the written statements, if any, and hearing the allegations made by the parties or their pleaders respectively, ascertain upon what material propositions of fact or of law the parties are at variance, and shall thereupon proceed to frame and record the issues on which the right decision of the case appears to the Court to depend.

When issues both of law and of fact arise in the same suit, and the Court is of opinion that the case may be disposed of on the issues of law only, it shall try those issues first, and for that purpose may, if it thinks fit, postpone the settle-

*(Proceedings after Reference to Railway Commission.—Rules 20-22.)*

58. (1) Within thirty days after the issue of the notification referring the application to a Commission, the plaintiff shall file with the Registrar a memorandum of the documents (if any) which he proposes to adduce in evidence at the hearing, and he shall at the same time present as many copies on plain paper of the plaintiff and memorandum of documents as there are defendants, and four others for the use of the Court.

Procedure on filing plaintiff.

(2) The Registrar shall sign such memorandum and copies if on examination he shall find them correct.

(3) The Registrar shall thereupon file the plaintiff and place it upon the record.

(4) The Registrar shall also cause the particulars mentioned in section 59 to be entered in a book to be kept for the purpose and called 'the Register of Suits,' and such entries shall be numbered in every year according to the order in which the plaintiff is admitted.

(5) For section 59 of the Code the following shall be substituted, namely:

59 If the plaintiff sues upon a document in his possession or power, he shall at the time of filing the said memorandum deliver the document or a copy thereof to be filed with the plaintiff.

Production of document on which plaintiff sues.  
Delivery of document or copy. List of other documents.

(6) For section 63 of the Code the following shall be substituted, namely:

63. A document which ought to be entered in the said memorandum, and which is not entered accordingly, shall not, without the leave of the Court, be received in evidence on the plaintiff's behalf at the hearing of the suit.

Inadmissibility of document not produced when plaintiff filed.

'Nothing in this section shall apply to any document produced for cross-examination of the defendant's witnesses, or in answer to any case set up by the defendant or handed to a witness merely to refresh his memory.'

20. (1) As soon as conveniently may be after the plaintiff has presented such memorandum and copies of the plaintiff as aforesaid, the Registrar shall cause each defendant to be served with a summons requiring him, within thirty days from the service thereof, to put in his answer (if any) to the said plaintiff.

Service of summons.  
Copy of statement to be annexed thereto.

(2) Every such summons shall be according to the Form D in the first schedule hereto, and shall be signed by the Registrar and sealed with the seal of the Court, and shall be accompanied by one of the copies of the plaintiff and memorandum of documents mentioned in rule 19, clause (4).

(3) Every such summons may be served by forwarding the same by post in a registered cover addressed to the defendant, or, where the defendant is a railway administration or a com-

pany, to the manager or agent of the administration or the chairman or secretary of the company at its principal office in India.

*Answer.*

21. (1) Within thirty days from the service of the said summons the defendant shall file with the Registrar his answer, if any, to the plaintiff, and leave with him four copies of the same for the use of the Court. The answer shall contain a clear and concise statement of the facts which form the ground of defence, or of any objections relied upon. It shall be taken to admit all facts stated in the plaintiff which are not expressly denied. It shall be divided into paragraphs numbered consecutively, and shall be signed and verified in accordance with the provisions of sections 51 and 52 of the Code. It shall be indorsed with the name and address of the defendant and if there is a legal adviser acting for him in the matter, with the name and address of such legal adviser. It shall be according to Form E in the first schedule or to the like effect.

(2) The defendant filing any answer shall along therewith file with the Registrar a memorandum of the documents (if any) which he proposes to adduce in evidence at the hearing of the suit, and leave with him four copies of such memorandum for the use of the Court.

(3) The defendant shall at the same time present to the Registrar a plain paper copy of such answer and memorandum of documents as aforesaid, and the Registrar shall sign such copy if on examination he shall find it correct.

(4) The defendant shall as soon as may be after the filing of his answer deliver to the plaintiff or his recognised agent such signed copy as last aforesaid.

(5) A document which ought to be entered by any defendant in the said memorandum, and which is not entered accordingly, shall not, without the leave of the Court, be received in evidence on his behalf at the hearing of the suit.

Nothing in this clause shall apply to any document produced for cross-examination of the plaintiff's witnesses, or in answer to any case set up by the plaintiff in his reply, or handed to a witness merely to refresh his memory.

(6) Should any defendant omit to appear and answer within the time specified in the summons, or such further time as may have been granted by any order of enlargement of time made under these rules, he shall be taken to have admitted all the facts stated in the plaintiff, and shall not be permitted to adduce any evidence at the hearing of the suit, but he shall nevertheless be at liberty to cross-examine any witness produced by the plaintiff, and shall be entitled to argue any question at issue as he may be advised.

*Reply.*

22. (1) Within thirty days from the delivery of the answer or the last of the answers to the plaintiff he shall file his

Form of reply and time for filing and delivery thereof.



*(Proceedings after Reference to Railway Commission—Rules 23-27.)*

reply (if any) with the Registrar, and leave with him four copies of the same for the use of the Court. The reply may object to the said answers or any of them as being insufficient, stating the grounds of such objection, or deny the facts stated therein, or any of them, or state any other facts in answer to the allegations contained in such answer. It shall be taken to admit all facts stated in the answer and not inconsistent with the plaint which are not expressly denied. It shall be signed and verified in accordance with the provisions of sections 51 and 52 of the Code, and shall be according to one of the Forms F in the first schedule or to the like effect.

(2) The plaintiff shall within the time aforesaid deliver to each defendant who has appeared and answered the plaint a signed copy of his reply.

*Consent cases.*

23. The parties may, by consent in writing filed with the Registrar, dispense with the formal proceedings hereinbefore mentioned, or some portion of them, and orders by consent may be drawn up, and, if approved by the Commissioners, may be signed by them.

*Written statements.*

24. (1) The parties may, at any time before or at the first hearing of the suit, tender written statements of their respective cases, and the Court shall receive such statements and place them on the record.

(2) The provisions of sections 114, 115 and 116 of the Code shall apply to all such written statements.

(3) Save as aforesaid, no written statement or other pleading shall be received without special leave of the Commissioners.

*First hearing.*

25. (1) As soon as the pleadings are complete, the Commissioners shall appoint a time and place for the first hearing of the suit.

(2) The Registrar shall, in addition to the notification required by rule 11, clause (2), cause a summons to be served upon each of the parties to the suit, requiring him to appear in person or by his pleader at the time and place specified in such summons for the settlement of issues in the suit.

(3) Every such summons shall be signed by the Registrar and sealed with the seal of the Court.

(4) The provisions of sections 72 to 95 of the Code, both inclusive, shall apply to all the summonses hereinbefore mentioned and the service thereof, but, save as aforesaid, Chapter VI of the Code shall not apply to any suit under these rules.

(5) Every document other than a summons required by these rules to be served upon or delivered to any party may be so served or delivered by forwarding the same by post in a

registered cover addressed to such party, or his recognised agent, or, where such party is a railway administration or a company, to the manager or agent of the administration or the chairman or secretary of the company at its principal office in India.

(6) In the computation of time under these rules every document so forwarded by post as aforesaid shall be deemed to have been delivered by the party delivering the same when put into the post or handed to some proper officer of the Post Office for the purpose of being posted, and to have been delivered to the party to whom the same is addressed in due course of post, unless he shall prove that it was not in fact delivered to him or at his residence until some later time.

26. (1) In the application of Chapter VII of the Code to suits under these rules for the words 'fixed for the defendant appear and answer,' or any words tantamount thereto wherever they occur, the words 'appointed for the first hearing of the suit' shall be substituted.

(2) None of the provisions of sections 99A, 101, 103 and 107 of the Code shall apply to any such suit.

(3) For sections 100 and 102 of the Code the following shall be substituted, namely:

100. If any party appears and any other party does not appear, the Court may either—

- (a) proceed *ex parte* as to the party not appearing;
- (b) direct a second summons to be issued and served on the party not appearing; or
- (c) postpone the hearing of the suit to a future day to be fixed by the Court, and direct notice of such day to be given to the party not appearing.

(4) Save as hereinbefore appears, nothing in Chapter VIII of the Code shall apply to any suit under these rules.

Substitution of new section for section 146, non-application to suits of section 155, and amendment of section 157 of the Code.

146. 29. None of the provisions of section 199, or of sections 207 to 216, both inclusive, of the Code shall apply to any suit under these rules.

Non-application to suits of sections 199 and 207 to 216 of Code.

30. Every order for costs made by the Commissioners shall be made subject to taxation thereof, and such costs shall be taxed by the Registrar, or by such other person as the Commissioners may direct, upon the order of the Commissioners under which the costs are payable, and, unless it shall be otherwise directed by such order, shall be taxed as between party and party.

Costs.

## GENERAL PROVISIONS.

*Review.*

31. (1) Every application to the Governor General in Council, under the proviso to section 39 of the Act, to re-appoint the Commissioners for the purpose of hearing an application for a review of their decision must, unless the Governor General in Council shall in any particular case see fit to enlarge the time for making such application, be made within six weeks after the said decision has been communicated to the parties.

(2) Every such application to the Governor General in Council must be addressed to the Secretary to the Government of India in the Legislative Department, and shall be according to Form A, No. 3, in the first schedule, or to the like effect.

(3) The proceedings upon every such application will be governed as nearly as may be by the provisions of rules 6 to 11, both inclusive.

*View.*

32. In any case in which, in the opinion of the Commissioners, a view is necessary or desirable, it may be had by one or more Commissioners as they may direct.

View.

*Depositing maps, plans and other documents.*

33. The parties shall leave with the Registrar one week before the day fixed for the first hearing of the suit or reference any maps, plans, sections, time-tables and other documents which are referred to in any pleading or written statement filed therein, or which may be useful in explaining or supporting the same.

Depositing maps, plans and other documents.

*Notice of discontinuance.*

34. When any application referred to the Commissioners is withdrawn or settled, the applicant shall immediately give notice of the withdrawal or settlement to the Registrar.

Notice of withdrawal or settlement of application.

*Enlargement of time.*

35. (1) When the Commissioners who are to decide an application are not sitting, the Registrar, and when they are sitting the Commissioners, may enlarge the time appointed by any of these rules for doing any act or taking any proceeding in relation to the application, and any such enlargement may be granted, although the request therefor is not made till after the expiration of the time so appointed.

(2) All applications for enlargement of the time for doing any act or taking any proceeding under these rules, and all applications under Chapter X of the Code prior to the first hearing of the suit or reference, shall be made in the first instance to the Registrar, who shall have in respect of such applications all the powers of the Court:

Provided that every decision of the Registrar under this rule shall be subject to appeal to the Law Commissioner, who may either hear and decide such appeal himself or refer the same to the Commissioners for their decision, and in either case such decision shall be final.

(3) Notice of appeal to the Law Commissioner from any decision of the Registrar under this rule must be given to be Registrar and the opposite party or his pleader within forty-eight hours from the date of the decision appealed from.

*Transmission of documents by post.*

36. Pleadings and other documents required by these rules to be filed with the Registrar may be sent by post in registered covers addressed to the Registrar to the Railway Commissioners, and prepaid.

Sending of documents by post to Registrar.

*Formal objections.*

37. No orders of the Commissioners shall be reversed or substantially varied, nor shall any case be remanded in appeal, or

Orders of Commissioners not to be reversed.

*(General Provisions.—Rules 38-40. The First Schedule.—Forms.)*

any proceeding defeated or impeded, on account of any error, defect or irregularity, whether in the decision or in any order passed in the suit or otherwise, not affecting the merits of the case or the jurisdiction of the Court.

*Appeals.*

38. (1) Subject to the provisions of sections 31 and 32 of the Act and of these rules, an appeal shall lie to the High Court from every order of the Commissioners as if it were an original decree of a Court immediately subordinate thereto.

(2) Save as hereinafter mentioned, all the provisions of Chapter XLI of the Code shall apply to all such appeals.

(3) Nothing in section 551 of the Code shall apply to any such appeal.

(4) For section 553 of the Code the following shall be substituted, namely:

‘553. The day so fixed shall be notified by the Registrar of the High Court in the *Gazette of India*, and a copy of such notification shall be served on the respondent or on his pleader in the High Court in the manner provided in Chapter VI for the service on a defendant of

a summons to appear and answer; and all rules applicable to such summons, and to proceedings with reference to the service thereof, shall apply to the service of such notification.’

*Incidental proceedings.*

39. (1) All the provisions of Part II of the Code, except Chapter XXIII, and section 396 of Code to suits and references. shall apply to all suits and references under these rules.

(2) Save as herein provided, the provisions of the Code shall not apply to any such suit or reference.

(3) In every case not herein or in and by the Act provided for the general principles of practice in the High Court shall be adopted and applied by the Commissioners.

*Table of fees.*

40. The fees, a table whereof is in the second schedule hereto, may be demanded and taken in respect of the proceedings before the Commissioners.

Stamps representing the fee for an office copy shall be affixed to the application for the copy.

The paper bearing stamps representing any other fee must have enclosed thereon a description of the proceeding in respect of which the fee was paid.

Every stamp filed must be cancelled in accordance with the law and rules for the time being in force for the cancellation of court-fee stamps.

*Tolls.*

1. No tolls will be levied on goods imported into the port for transhipment on through bills of lading, or goods which are manifested for transhipment by the importing vessel.

Packages of Coffee brought into Aden by sea, ready packed and marked, for export to foreign ports, will be treated as transhipment cargo.

Goods imported into the port which are not for transhipment, but shipped direct on board the exporting vessel, without landing, will be treated as transhipment cargo.

*Wharfage.*

2. Transhipment goods referred to in clause 1, if placed on the wharves, &c., belonging to the Port Trust, will be liable to the usual wharfage fees for landing and shipping.

*Time from which rent is chargeable.*

3. Import goods will be allowed on the wharves five clear days free of rent after landing, after which period rent will be charged as shown in column 8.
4. Export goods brought for shipment will be allowed five clear days free of rent, if the goods be kept in the open on the wharf, after which period rent will be charged as shown in column 8.
5. Goods brought for shipment but which may not be shipped but removed from the wharf inland, will be charged rent from the date on which they are brought for shipment.
6. Part shipments shut out owing to no fault of the shipper, but because of the vessel being full, shall, if removed inland, receive benefit of the free days, as if the goods had been taken by the vessel.
7. Shut-out cargo brought back to the wharf will not be liable to further wharfage on the shipment of goods, and such cargo will be allowed to lie on the wharf free of rent for 48 hours.
8. Warehouse rent will be levied at the rates detailed in column 8, from the date on which the goods are placed in the warehouse.
9. When goods lying on the wharf are removed to the warehouse at the instance of the Board, after the expiration of the free days allowed, a charge at the rates detailed in column 9 of the above table will be levied.
10. In computing the number of free days allowed, Sundays and close holidays will be omitted.

*Night and Holiday Work.*

11. The charge for permitting entry or exit of goods on the Port Trust wharves at night, or on Sundays or close holidays, will be double wharfage rate, provided the minimum charge shall not be less than one rupee.

*Mooring Fees.*

12. Mooring fees for the use of vessels will be levied as under :—

- (1.) Vessels liable to payment of port-dues at the rate of annas 4 per 100 tons under the Indian Ports Act of 1889, Rs. 1-8-0 per diem.
- (2.) Vessels entering the Inner Harbour for letters, or fresh provisions, or coals for steaming, cooking or condensing, or for repairs and leaving within 24 hours, provided no passenger or cargo be embarked or disembarked, Rs. 5 per diem.
- (3.) Other vessels Rs. 3 per diem after 48 hours after arrival: provided vessels discharging entire cargo and loading entire cargo will be allowed seven days free for each operation.

*Miscellaneous Charges.*

13. For weighing or measuring of goods on Port Trust wharves, annas 3 per ton, or part thereof, will be charged, and a further charge of Rs. 2 per day will be made if a Clerk is employed.
14. For each certificate of weight or measurement, Re. 1.
15. For each certificate relating to the import or export of goods, Rs. 2.
16. For true copy of Manifests, Pass-notes, receipts, &c., for every 360 words or fraction of 360 words, annas 8.
17. For conducting public sale of goods, Rs. 1-8-0 per cent. on the proceeds in addition to actual expenditure of account of hire of coolies, &c., and advertising charges.

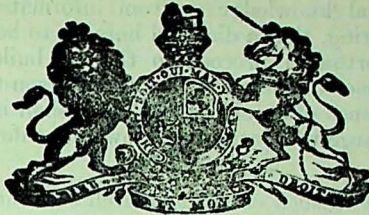

#### NOTIFICATION.

No. 6480.—With reference to the foregoing Notification the following Rules framed under Section 14 of the Glanders and Farcy Act (XX of) 1879, for the Cantonment and the Municipal District of Karáchi, and sanctioned by the Governor in Council, are published for general information:—

1. The Inspector appointed under Section 4 shall, whenever he has reason to believe, from personal knowledge or from information given by any person and taken down in writing, that a diseased horse is to be found in any building, enclosure or place, forthwith proceed to the said building, enclosure, or other place, and in the presence of the owner or other person then in charge, or, if he is absent, in the presence of an officer of Police, shall inspect the said premises and execute and discharge the duties and powers conferred on him under the Act.

The Inspector may in such entry and search be accompanied by a Veterinary Surgeon or such Police officers as he considers necessary, or by both.

The owner of the premises or person in charge at the time shall give free ingress to the Inspector and shall in every possible way facilitate the search; and he shall be entitled subsequently to receive from the Inspector a statement in writing of the grounds of entry and, in the event of his premises being infected, shall receive written instructions as to his liabilities and duties under the Act signed by the Inspector.

2. The Inspector shall seize and hand over to the Police for detention any horse which he considers diseased or which he reasonably suspects of being so. Such animal shall, as soon as possible, and with the exercise of due precautions against contagion to other horses and men, be examined by a Veterinary Surgeon and dealt with under the Act.

Such precautions shall comprise, in the case of a discharge from the nose, the wearing of a nosebag and, in the case of open sores, the covering up of the same, so far as is practicable, with disinfecting powder and cloths and bandages during removal along public roads; and such removal shall, unless there be any sufficient reason to the contrary, be at night. These precautions shall be enforced in all cases where horses have to be moved for examination or disposal under the Act.

3. The owner or person in charge of a horse which he believes, or has reason to believe, to be diseased, shall report the case within twenty-four hours to the Inspector or to a Police officer (who shall at once inform the Inspector) and may remove the animal to any isolated building within fifty yards of the stable or to a remote part of the building, enclosure or other place, where the animal has been standing; and shall keep it, as much as is possible, within these limits, away from other horses. He shall detain in the stable, until the granting of a license for removal, any horse which has been in contact with or near the diseased animal.

Except as provided in these rules, no person shall intentionally or negligently cause or permit any diseased horse to stray or to be worked, led, or driven, in a public thoroughfare, road, street or place.

4. Except as provided in Section 11, no horse shall be removed from an infected building, enclosure, or other place, without license from an Inspector; and such license shall not be granted until the Inspector considers there is no danger of such horse becoming diseased and, on careful examination, has found it free from any indication of Glanders or Farcy, and has seen that it (and such gear as it is wearing) has been washed over with a strong solution of phenyle or chloride of zinc or some other recognized disinfectant.

If considered necessary by the Veterinary Surgeon, license may be granted for use only on condition that the animal for the period of one week shall not be allowed to mix with other horses and shall be picketed apart.

5. The owner or person in charge of any building, enclosure, or other premises which have been occupied by any diseased horse shall, within seven days, carry out such disinfection of such building, enclosure, or other premises and destruction of dung, litter, and waste food, gear, and other articles in or near to the premises, as may be prescribed by the Veterinary Surgeon.

In all cases dung, surplus food, and litter from the infected stable, also clothing and other gear which has been used by or been in contact with the diseased horse, shall be consumed or disinfected by fire; temporary building materials such as thatch of grass or leaves, bamboo walls and matting shall be burned, if the position admits of this being done with safety, and (after complete removal of all dung, temporary fittings and other articles for destruction by fire) the wood-work of the stable shall be thoroughly washed with boiling water, the walls, wood-work and ceiling shall be scraped and lime-washed with freshly mixed quicklime and water, to which shall be added crude carbolic acid in the proportion of half a pint to a bucketful of lime-wash, and the flooring shall be removed to a depth of two feet and not renewed for the space of two weeks, the removed earth being burnt and replaced by fresh earth. The whole of the interior shall then be fumigated with burning sulphur, chlorine, carbolic vapour, or some other gaseous disinfectant.

6. On a certificate from the Veterinary Surgeon that a horse is diseased, it shall be destroyed humanely in the presence of the Inspector and the carcass disposed of by burning under supervision of the Police. Excepting with the sanction of the Police and for the purpose of burning it, no person shall remove the carcass or any portion of it.

7. In the event of disinfection of premises and destruction of gear, fittings, dung and other articles condemned by the Inspector not being carried out by the owner within the period of seven days, they shall be carried out by the Inspector under Police supervision and the expenses shall be recovered from the owner of the premises in the manner prescribed by Section 9.

8. The Superintendent of Police, Karáchi, may award to the Inspector, at whose instance any conviction is obtained under the Act, a sum not exceeding half the amount of any fine imposed.

#### NOTIFICATION.

No. 6481.—With reference to Notification No. 6479 dated the 18th November 1892, applying the Glanders and Farcy Act, 1879, to the local areas contained within the limits of the Cantonment and the Municipal District of Karáchi, and the Port of Karáchi, the Governor in Council is pleased to make the following rules under Section 14 of the Act for the Port of Karáchi:—

1. In these rules the words "horse" and "diseased" have the same meaning as they have, respectively, in the Glanders and Farcy Act, 1879, which Act is hereinafter referred to as "the Act."

2. The master of any vessel which arrives in the Port with one or more horses on board shall give information thereof to the pilot in charge.

3. The pilot in charge shall thereupon deliver to the master a printed copy of Sections 2, 10 and 11 of the Act, and the master shall give such copy to the owner or person in charge of the horse or horses.

4. If the pilot in charge or any officer of Police or of the Customs Department, who goes on board the vessel, has reason to believe that the horse or any of the horses on board is diseased, he shall at once give information thereof—

(a) to the master of the vessel, and

(b) to the Harbour Sergeant of Police.



5. If the master of the vessel has reason to believe that the horse or any of the horses on board is diseased, or if information to that effect is given to him under Rule 4, he shall prevent the horse or any of the horses from being disembarked until an Inspector under the Act has inspected the said horse or horses.

6. When information is given to the Harbour Sergeant of Police under Rule 4, he shall cause the same to be taken down in writing and shall at once cause the writing to be forwarded to an Inspector under the Act.

7. If any officer of Government shall have reason to believe that any horse which is being landed or has just been landed from the port at any wharf, dock, bandar or other place is diseased, the person in charge of such horse shall, upon the requisition of such officer, keep the said horse and all other horses, if any, landed with it, separate, at or near the spot where it has been landed, until an Inspector under the Act has inspected the said horse or horses. The officer making such requisition shall forthwith give information to the nearest superior officer of Police, who shall cause the same to be taken down in writing and at once forward the writing to an Inspector under the Act.

8. An Inspector under the Act, whenever he has reason to believe, from personal knowledge or from information given by any person and taken down in writing, that a diseased horse is to be found on board any vessel in the port, shall forthwith proceed to the said vessel and shall, in the presence of the master or of some other officer of the vessel and of the owner or person in charge of the horse, if present, inspect the said horse and all other horses, if any, on board and exercise and perform the powers and duties conferred and imposed upon him by the Act.

The Inspector shall, when thus making an entry and search of any such vessel, be accompanied by the Port Veterinary Surgeon or by such Police officer or officers as he may think necessary.

The master and every officer of the vessel and the owner or person in charge of the horse or horses shall give free access to the Inspector and the persons, if any, accompanying him, and shall in every way facilitate his inspection and search.

9. If, through any unforeseen circumstances, the services of the Port Veterinary Surgeon should not be immediately available, application will be at once made by the Inspector to any other Veterinary Surgeon appointed by Government for the purposes of the Act.

10. Every horse which a Veterinary Surgeon appointed for the purposes of the Act certifies in writing to be diseased shall be removed between midnight and 5 o'clock A.M. to the Municipal Kiln near old Koombarwara, to be there immediately destroyed.

11. Licenses for the removal of horses which have been with a diseased horse will be granted by an Inspector under Section 11 of the Act on the following conditions, *viz.* :—

(1) That the horse to be removed shall be taken direct, under such precautions as the Inspector deems fit to prescribe, to a place to be prescribed by the Inspector, where it can conveniently be isolated.

(2) That whilst so isolated the horse shall be inspected from time to time, at intervals of not more than a week, by the Port Veterinary Surgeon.

(3) That the horse shall continue at the appointed place in isolation for so long as the Port Veterinary Surgeon deems it necessary to have it under treatment or observation.

12. When the Inspector gives notice under Section 9 of the Act to the owner or master of a vessel to have the same disinfected, such disinfection shall be regulated as follows, *viz.* :—

(1) *In the case of a steam vessel.*—The steam hose superheated to be turned on and carefully applied to every part of the deck, hold or other place which has been occupied by a horse or horses. The deck, hold or other place to be thereupon washed with a lime wash containing carbolic acid in the proportion of one ounce to a gallon of the lime wash. All iron work to be scalded and disinfected with the solution of carbolic acid in the proportion of one ounce to the gallon of hot water. This is to be followed by free ventilation of the hold.

(2) *In the case of a sailing ship or of a steam-ship unprovided with a steam hose.*—The same procedure as above, except that scrubbing with hot water may be substituted for the use of a steam hose.

(3) *In every case.*—Buckets and feeding troughs to be scrubbed with hot water and thoroughly disinfected with a carbolic solution in the same proportion as laid down in Clause (1).

13. In any such notice as aforesaid, the Inspector shall direct that all bedding, fodder, ropes and other gear, which have been in use or worn by a diseased horse, shall be burnt.

14. In order to satisfy himself that any such notice as aforesaid has been duly complied with, the Inspector, accompanied by the Port Veterinary Surgeon, shall inspect the ship; and if the said notice has not, in his opinion, been duly complied with, port clearance shall, on his requisition, be refused to the vessel by the Customs authorities until either the notice has been, in the Inspector's opinion, duly complied with, or the Inspector has himself caused his orders to be given effect to, and has recovered the expense (if any) thereby incurred, under Section 9 of the Act.

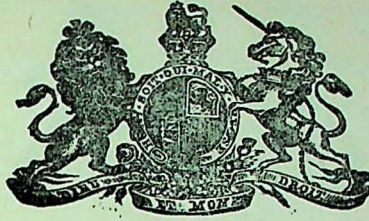
