NOTIFICATIONS.

GENERAL DEPARTMENT.

Bombay Castle, 8th August 1888.

No. 2755.—The following Notification is published for general information:—

" NOTIFICATION,

In exercise of the power conferred by Section 7 of the Aden Pilgrims and Paupers Regulation, 1887, the Political Resident at Aden, with the previous sanction of His Excellency the Governor of Bombay in Council, hereby prohibits, with effect on and from the 1st day of October 1888 —

- (a) the conveyance to Aden by any Ship-master or other person from any port or place and in any vessel or means of conveyance whatever, of any indigent person;
- (b) the landing at Aden of any indigent person from any vessel whatever; I.—190

(c) the rendering of aid by any Shippingmaster or other person to any indigent person to land at Aden and the wilful permission of the landing of any such person at Aden on the part of any Shipping-master or other person.

This prohibition applies only to indigent persons, whether pilgrims or not, who are natives of Asia or Africa.

The Aden Pilgrims and Paupers Regulation, 1887, was published in the Gazette of India for 1887, Part I, page 437, and in the Bombay Government Gazette for 1887, Part I, pages 755-56.

JUDICIAL DEPARTMENT.

Bombay Castle, 4th August 1888.

No. 4227.—In substitution of the ame: ded Rule 48, defining the cases in which the Public Prosecutor in Sind shall appear, and sanctioned in Government Notification No. 2180 of 30th March 1883, the following rule is sanctioned:—

- "48 (1) The Public Prosecutor for Sind will ordinarily appear in the Sadar Court:
- (a) in every case submitted to that Court under Section 374 of the Criminal Procedure Code for confirmation; and
- (b) in every appeal against an acquittal; and
- (c) in every appeal against a conviction heard by the Sadar Court under Section 423 of the said Code, if the accused (or where there are several accused persons, any one of the accused persons) is represented by Counsel, whether a barrister or a pleader; and
- (d) in every criminal case which the Sadar Court transfers from any Subordinate Court for trial before itself; and
- (e) in any criminal case in which he may be specially instructed to appear by the Magistrate of a district, or by the Commissioner in Sind, or by Government; and
- (f) in any criminal case in which the Sadar Court desires him to appear or intimates its opinion that he ought to appear.
- "(2) He will conduct, in person or through his Assistant, all the duties of Public Prosecutor for the Karáchi District, and, when so directed by Government or by the Commissioner in Sind, or in special circumstances when there is not time to communicate with the Commissioner in Sind, by the District Magistrate, will appear on behalf of the Crown in any criminal case in any other part of the province.
- "When the District Magistrate gives such sanction he shall submit a full report of the circumstances making this necessary to the Commissioner in Sind."

No. 52.—The following Bye-law No. 30A, made by the Trustees of the Port of Bombay under Section 73 of the Port Trust Act, 1879, has been added to the Bye-laws for the Regulation and Management of the Wet Docks of the Trust:—

"No. 30A.—A vessel desiring to discharge coal overside may be allowed to do so should the Dock Superintendent be able to allot a berth where injury is not likely to be done to another ship or to cargo by coal dust, but should, before the whole of the coal is discharged, there be in the opinion of the Dock Superintendent a prospect of injury from its dust, the vessel must be removed either to another berth, should one be available, at which injury from coal dust is unlikely, or out of the Dock, as the Dock Superintendent may direct.

This is to apply not only to ordinary vessels, but to those of lines having preferential berths and also to those discharging coal under Dock Bye-law No. 19."

Special Pensions to Chief and Superintending Engineers.

RESOLUTION-By the Government of India, Department of Finance and Commerce.

Read-

Paragraph 2 of Resolution by the Government of India in this Department, No. 449, dated 18th April 1884.

Despatch to Her Majesty's Secretary of State for India, No. 16-P. W., dated 20th March 1888.

Despatch from Her Majesty's Secretary of State for India, No. 21 P. W., dated 17th May 1888.

By the Resolution in this Department of the 18th April 1884, special additional pensions of Rs. 2,000 and Rs. 1,000 respectively were authorised as rewards for approved service for Civil Engineers who might render three years' service as Chief Engineer or as Superintending Engineer. It was not, however, decided whether the service qualifying for these special Pensions must be substantive service, or whether periods of temporary service might be included. On this question being raised, the opinions of selected officers were obtained and submitted to the Government of India, and after consideration of them, and in accordance with the principle laid down in the Civil Pension Code that two officers cannot count service for pension at one time in the same appointment, the Secretary of State was requested to allow active service, both substantive and temporary, to count as service qualifying for these special pensions, periods of furlough being excluded.

RESOLUTION.—This proposal has been sanctioned by Her Majesty's Secretary of State for India. In future, therefore, all service, whether temporary or substantive, will count as service

towards the extra pensions, but periods passed on leave, other than privilege leave, will be excluded.

Periods of three months and under, during which an officer merely officiates as a purely temporary measure, will not count.

2. It is important, however, to bear in mind that these extra pensions cannot be claimed as a matter of right, but that they will only be granted, at the discretion of the Government of Iudia, as rewards of approved services.

ORDER.—Ordered, that a copy of this Resolution be forwarded* to the Public Works Department for information and guidance, and that the Resolution be published in the Supplement to the Gazette of India.

From-The ACCOUNTANT GENERAL, BOMBAY; To-All Collectors and TREASURY OFFICERS.

It has been arranged, in consultation with the Commissioner of Customs, Salt, Opium and Abkári, that the pay of all Abkári Inspectors and Sub-Inspectors on Rs. 50 per month and below, whose appointment and promotion are regulated by the Collectors of the districts in which they are posted, should be drawn on establishment bills signed by the Collector, instead of on separate bills, in the form for personal salaries, as has lately been the practice.
