"CERTIFICATES OF IDENTITY TO BE GIVEN TO INDIAN STUDENTS AND OTHERS VISITING ENGLAND.

No. 2831-2842.

Extract from the Proceedings of the Government of India in the Home Department (Public), under date Calcutta, the 8th December 1899.

RESOLUTION.

The Secretary of State for India has brought to the notice of the Government of India that it not infrequently happens that natives of India, students or others, who have proceeded to England, desire to obtain passports to enable them to travel to foreign countries in which the possession of a passport is necessary or desirable, and that difficulty often arises from want of evidence to show that the applicant is a British subject and therefore entitled to a passport. Appeals for assistance are also frequently addressed to His Lordship by destitute Indians who desire to return to their country and by students who, owing to embarrassed circumstances, are unable to complete their course of education.

2. In order to enable the Secretary of State to deal with such cases satisfactorily, the Governor General in Council has decided that it is necessary to press upon Indian students and others visiting England the desirability of providing themselves, before their departure from India, with an authoritative certificate of identity, in the form appended to this Resolution, signed by the head of the district (in a Presidency Town, the Commissioner of Police) in the case of residents of British India and by the Political Officer in that of residents of Native States. For a student the certificate should be signed by the head of his last school or college and countersigned by the District Officer (in a Presidency Town, the Commissioner of Police) or Political Officer, as the case may be.

PROSPECTUS OF THE DASARA EXHIBITION OF 1909.

Introductory.—With the sanction of the Government of His Highness the Maharaja of Mysore. the Committee issue the following prospectus in connection with the Exhibition of 1909.

- 2. Opening of the Exhibition.—This year the Exhibition will commence on Monday 18th October 1909 and close on Sunday 31st. The Cattle Show will begin on Monday 25th October and close on Thursday 28th. It may be observed that the show generally offers a good opportunity for people desirous of purchasing good specimens of Mysore cattle
- 3. Object of the Exhibition.—The primary aim of the Committee is to it art to the Exhibition an educative character and to bring together articles, machinery and processes, the use of which it is desirable to bring to the notice of the raiyat, the artizan and the manufacturer by actual demonstration. But as the Exhibition of a single specimen may not afford full information, and may not be sufficiently attractive to the visiting public, articles intended for sale will also be admitted.

Articles on sale versus samples.—Articles on a larger scale sent merely for sale will have to be kept in separate stalls and under the charge of the exhibitors or their agents. There is no objection to the sale of actual exhibits, but they will not be allowed to be removed from the Exhibition grounds till the termination of the show. Articles admitted for purposes of sale alone may be removed after purchase. No article will be allowed to leave the Exhibition grounds without a gate pass.

- 4. Plan of the buildings.—A plan of the Exhibition grounds showing buildings and the extent of covered and open space available is appended to this prospectus. Those who desire to have special facilities for the sale of articles or demonstration of processes, are requested to place themselves in communication with the Secretary to the Exhibition Committee.
- Horticultural Show .- The Horticultural Show comprising "class" and "group," etc., mentioned in the first section of the prospectus, will be held on the 25th October 1909, and kept open till the close of the following day,
- 6. Lectures and demonstrations.—Lectures will be delivered by competent persons in English and Kanarese on subjects connected with Industry, Agriculture, Health and Sanitation, the value of Agricultural implements and machines, their cost, construction and repairs. Arrangements will also be made for holding a competition on the Exhibition grounds in Ploughing, Weaving and processes connected therewith. The exact time and the place of the lectures and demonstration will be announced later on by handbills and notices.
- 7. Donations.—The Committee would thankfully accept donations for awarding prizes or medals from individuals or associations desiring to give an impetus to any special branch of Agriculture or Industry.
- Classification of exhibits.-The classification of exhibits will be according to the price list subjoined to the prospectus and entries in several sections should be made in the application forms prescribed.

- 9. Open to all India.—The Committee invite exhibits from all the districts in the State as well as from outside. They also appeal to the various agricultural departments and associations in other parts of India, Burma and Ceylon to help them with exhibits and suggestions.
- 10. Judges.—Leading raiyats and non-official gentlemen will be invited to assist the Committee in judging the exhibits.
- 11. Admission fees for visitors.—An admission fee of annas two per head will be levied each time a person enters the Exhibition buildings. Season tickets will be issued at Re. 1 per head. These are not transferable, but books of eight single tickets may be had also at Re. 1 per book. If possible, return railway season tickets between Bangalore and Mysore at a reduced rate which will admit to the Exhibition for the whole season, will be arranged for.

RULES AND REGULATIONS.

- 1. Noxious articles.—Explosives or any substance noxious or dangerous will not be admitted by the Committee.
- 2. Particulars re exhibits.—Intending exhibitors are requested to send to the Secretary to the Exhibition Committee, particulars of exhibits they intend to forward and the amount of space which their exhibits may take up in the necessary entry form appended to this prospectus. Forms may also be obtained from the District, Divisional and Taluk Officers or from the Secretary to the Committee; plain paper of foolscap size may also be used provided all the headings in the form are properly copied and filled up and separate sheets should be used for each section.
- 3. Applications from exhibitors.—Applications should reach the Secretary not later than 15th September 1909. Each application should contain a Post Card on which the address and Post town of the exhibitor are legibly written.
- 4. Lists from taluks.—Deputy Commissioners of Districts with the District Committee, Sub-Divisional Officers and Amildars of Taluks are requested to convene, as early as possible, a meeting of the leading artizans, raiyats and merchants residing within their respective charges, to explain to them fully the object and scope of the Exhibiton, to carefully acquaint them with the Rules and Regulations drawing particular attention to such paras as 2, 3, 10, etc., to distribute to them forms of applications, to have them filled up by intending exhibitors, compile them, and to forward them to the Secretary.
- 5. Articles not cnumerated.—The classified list of prizes will show the nature of articles which can compete at the Exhibition. Articles not specially enumerated in the prize list may, however, be admitted by the Committee at their discretion.
- 6. No fees to be charged for exhibits.—No fees will be charged for the admission or registration of exhibits or for the space allowed for them.
- 7. Acceptance of exhibits.—The Committee reserve to themselves absolute discretion as regards the acceptance or rejection of exhibits and the allotment of space covered or uncovered.
- 8. Delivery of exhibits.—Articles intended for the Exhibition may be brought by the exhibitor or his agent or servant and delivered at the exhibition grounds or sent by Post or Railway, and all Taluk and District exhibits should be sent through the Deputy Commissioners of Districts.
- 9. Payment of freight and transport charges.—No exhibits in respect of which the necessary freight or transport charges have not been paid by the exhibitor, will be accepted by the Committee.
- 10. List of particulars.—All packages received or delivered and all implements and machinery intended for the Exhibition must bear a label specifying name and number of exhibits and the registered number of the exhibitor and must be addressed to the Secretary. They must contain a list in duplicate showing the name or description of the article, its price, the place of production or manufacture, name of the manufacturer or exhibitor; in the case of exhibits in the agricultural section, essential particulars such as—
 - 1. The season of sowing.
 - 2. The soil on which they are grown.
 - 3. The quantity of seed per acre.
 - 4. The manure used.
 - 5. Whether any irrigation is required.
 - 6. The time required for the maturing of the crop.
 - 7. The average yield per acre.
 - 8. Any other interesting details regarding cultivation should be given.
- 11. Exhibits which have already won prizes.—Exhibits which have won prizes or medals in the Mysore Exhibitions of 1906, 1907 and 1908 shall be precluded from competing for prizes, though there is no objection to their being accepted for purposes of show or sale.

- 12. Date of delivery of exhibits: Intending exhibitors are requested to send the exhibits so as to reach Mysore on the 25th September 1909, from which the date the Committee will arrange to take charge of exhibits. BUT NO EXHIBITS WILL BE RECEIVED AFTER THE 5TH OCTOBER 1909.
- 13. Belated exhibits.—Articles that are not delivered at the Exhibition Hall in the time fixed may be admitted at the discretion of the Committee subsequent to the dates mentioned in para 12, but shall not be entitled to compete for prizes.
- 14. Perishable articles.—Vegetables, fruits, and other perishable articles may, however, be delivered at the Exhibition Hall till 7 P.M., on the 24th October 1909.
- Admission of exhibits.—No exhibits will be admitted without a pass signed by the Secretary or members of the Committee on duty at the Exhibition grounds.
- Responsibility of exhibitors.—Exhibitors will have to pay every expense of transit, delivery, fixing and removing their exhibits and they must either personally or by their agents or servants superintend their reception and removal, in default of which, the Committee reserve to themselves the right of doing whatever may be considered necessary at the expense of the exhibitor.
- Committee accept no responsibility.—No responsibility will be accepted by the Committee as to any damage or loss howsoever occurring.
- Special facilities.—Exhibitors are requested to mention in their applications whether they wish to illustrate practically any processes of manufacture or the working of any implement or machinery and, if so, to state briefly the nature of the demonstration and any special facilities
- 19. Special arrangement to be made at the exhibitors' expense.—If the exhibitors require any special arrangements to be made (or have to mount their machinery) they must carry them out at their own expense, but the Committee will be glad to give such aid as may be possible in the shape of getting skilled or unskilled manual labour at the exhibitors' expense. The expenses of demonstrating machinery and implements should be borne by the exhibitor except where special arrangements have been made with the Committee.
- Valuable exhibits .-- All valuable exhibits must be forwarded under the charge of an attendant.
- 21. Exhibits unaccompanied by men in charge.—Exhibitors who are unable to attend personally or send their agents in charge of exhibits may make special arrangements with the Committee for the exhibition of their goods on payment in advance in full of the estimated expense.
- 22. Weighing of exhibits.—The Committee entrust the work of receiving the exhibits to responsible officials. But as the goods are landed near the Exhibition grounds by special arrangements, it is not possible to weigh every consignment before taking delivery of it. So exhibitors are requested to take every possible precaution in packing their exhibits and to send to the Committee in time an accurate list of exhibits sent by them. Exhibitors who wish that their consignments should be weighed at the Railway Station before delivery, should intimate their wish to the Secretary in time and remit in advance a special fee of Re. 1 on each consignment to be thus weighed.
- 23. Acknowledgment of exhibits.—Receipt of exhibits will be acknowledged by return of the duplicate list mentioned in para. 10 to the exhibitor duly signed by the Secretary. No other kind of receipt will be sent. Any differences between the list and the articles actually received will be noted in the duplicate list.
- Free pass to exhibitors.—In cases in which the owners themselves are in charge of exhibits, the necessary free pass will be given.
- Free admission to bona fide raiyats and artizans.—Raiyats and artizans unable to pay fees, belonging to the Mysore State or from outside, who produce certificates of identification signed by their respective Taluk Officers in Form B appended to this prospectus, will be admitted free.
- 26. Space for exhibits on sale.—Accommodation will be found within the Exhibition grounds, as far as possible, for articles intended for sale. But those who wish to send articles on a large scale would do well to have temporary booths put up at their own cost in the Exhibition grounds by previous arrangements with the Committee.
- 27. Articles on sale.—Articles on sale or those sold should in every case have cards attached to them notifying the same.
- Removal of exhibits.—All exhibits must be removed within a week after the close of the Exhibition. Exhibits remaining after that time will be disposed of as the Committee deem fit. Perishable articles will be allowed to be removed at the option of the owner or purchasers within 24 hours after the opening of the Exhibition.

- 29. Exhibits on loan.—Works of art and articles of special merit including those of antiquarian interest will be thankfully received. Gentlemen willing to lend them are requested to place themselves in communication with the Secretary or any of the members of the Committee who will inform them of the acceptance of the offer and will make necessary arrangements in connection with the exhibition of articles.
- 30. Exhibits belonging to departments of Government.—Articles or cattle exhibited by any department of Government will not be eligible for money prizes or medals, but may be awarded certificates of merit. This rule does not preclude Government servants or pupils of Industrial Schools from competing for prizes if the exhibits are manufactured by themselves.
- 31. Admission of live-stock.—All cattle and sheep brought for this show will be located in a convenient place before the first selection and only such of the animals as are selected will be permitted to be picketed in the sheds provided at the show-yard according to breed, age and size, etc.
- 32. Accommodation for cattle.—Accommodation will be provided free of cost for about 150 head of cattle.
- 33. Grant for fodder.—A sum of 4 annas will be given for each head of cattle selected, per day, for the four days from 25th to 28th, both days inclusive.
- 34. Admission to the show grounds.—Only pass or ticket-holders will be allowed to the show grounds, while the cattle are judged.
- 35. Practical test.—Working cattle may, at the owners' option, be subjected to a practical test as to their powers of draught. They must be the bona fide property of the exhibitor.

Single bullocks will also be tested both for riding and draught purposes at the owners' option.

- 36. Care-taker.—Each animal or lot competing separately must be in charge of a care-taker who will remain in charge of the exhibit and must be ready to lead it out at any time as required by the Committee.
- 57. Distribution of awards.—Prizes and medals will be distributed at the close of the Exhibition. This year, it is proposed to hold a distribution of prizes in the Exhibition grounds on or about the 30th October 1909.
- 38. Number of Judges.—The Judges in each class or group will not be less than three, but no prizes will be awarded unless in the opinion of the Judges the exhibits merit the reward. Judges cannot compete for prizes in classes or sections in which they are Judges.
- 39. Photograph of articles exhibited.—No article exhibited may be copied, photographed, drawn or reproduced in any manner without the special permission of the exhibitor and the Committee. General photographs of the stalls may, however, be taken with the permission of the Committee.
- 40. Committee's decision final.—The Committee have full power to make rules for the conduct of the Exhibition under these Regulations and their decision is final in all cases.
- 41. Acceptance of rules.—All persons who become exhibitors shall be held to signify their assent to and acceptance of the foregoing Rules and Regulations and also of such other Rules as the Committee may hereafter issue, not inconsistent with these Regulations.
- 42. Communications re the Exhibition.—All communications regarding the Exhibition should be addressed to the Secretary to the Mysore Dasara Industrial and Agricultural Exhibition Committee, Mysore.

No. 5 Ry.—Whereas an application has been made by the Shivrajpur Syndicate, Limited, of Bombay, to the Local Government, for an order empowering them to construct, maintain and work, in supersession of their existing Monorail Concession a line of tramway between Champaner Road Station on the Bombay, Baroda and Central India Railway and Shivrajpur, a distance of about 183 miles, and whereas the Buroda Durbar have consented to the construction, maintenance and working of such portion of the proposed line of tramway as traverses the lands of that State between Champaner Road Station and the border of the British District of the Panch Maháls, and whereas the District Local Board, Panch Maháls, have given their consent to the construction of the proposed line of tramway traversing that District, and whereas the Local Government have no objection to such use of the provincial road between Champaner Road Station and Shivrajpur as may be found necessary for the purposes of the tramway, and whereas it appeared to the Local Government expedient and proper that the said application should be granted, and whereas a draft of a proposed Order authorizing the construction, maintenance and working of the said tramway in British territory was published in the Bombay Government Gazette under notification in the Public Works Department (Railway Branch), No. 4, dated 4th August 1908, and the Local Government, after considering such objections and suggestions as have been made with respect to the said draft, are of opinion that the said application, so far as it relates to British territory and subject to the conditions and restrictions herein below expressed should be granted: Now in exercise of the power conferred by Section 6, sub-section (3), of the Indian Tramways Act, 1886 (XI of 1836), the Governor in Council is pleased to make an Order accordingly as follows :-

ORDER.

Order made under Section 6 of the Indian Tramways Act, 1886 (XI of 1886), by the Governor of Bombay in Council, with the previous sanction of the Governor General in Council, authorizing the Shivrajpur Syndicate, Limited, of Bombay, to construct, maintain and work a tramway under the conditions of the said Act in supersession of, and in that portion of British territory traversed by, their existing Monorail Concession between Champaner Road Station on the Bombay, Baroda and Central India Railway and Shivrajpur.

PRELIMINARY.

Short title.

- 1. This Order may be cited as the Shivrajpur Tramway Order, 1909.
- 2. The several words and expressions to which meanings are assigned by the Indian Interpretation clause.

 Tramways Act, 1886, have in this Order the same respective meanings: Provided that in this Order the expression "the tramway" or "the undertaking" shall mean the tramway and works and undertaking by this Order authorized except where the context may require a different meaning; and the words "the Act" shall mean the said Indian Tramways Act, 1886; and the "provincial road" shall mean the provincial British section of the public road between Champaner Road Station on the Bombay, Baroda and Central India Railway and Shivrajpur.
- 3. (1) The tramway authorized by this Order shall be constructed, maintained and Law applicable to the tramway. worked subject to the provisions of the Act and of the rules framed by this Government under that Act and published at pages 691 to 694 of Part I of the Bombay Government Gazette dated the 16th July 1896, or of any other rules from time to time in force under the Act, and of this Order.

(2) But no powers or rights shall be deemed to have been conferred on the Promoters or to have been relinquished by Government except as in this Order expressly provided.

PROMOTERS.

4. The Shivrajpur Syndicate, Limited, of Bombay, shall be the Promoters for the Promoters.

Provided that if the undertaking is transferred by the said Shivrajpur Syndicate, Limited, to any other person or persons, or to a Company, with the previous assent of the Governor in Council, under clause 62, then, and in such case, the term "the Promoters" shall be held to mean such person or persons or Company, as the case may be.

CONSTRUCTION OF TRAMWAY AND USE OF PROVINCIAL ROAD.

Authority to Promoters to construct, maintain and work the tramway.

Authority to Promoters to construct, maintain and work the tramway hereinafter described with all proper establishments, rails, bearings, stations, offices, works, rolling stock and conveniences connected with the tramway or required for the purposes thereof.

6. The tramway authorized by this Order is a single line, with necessary passing places, within the District of the Panch Mahals. The tramway will start at Champaner Road Station of the Bombay, Baroda and Central India, Bailway situated in

bescription of the trainway tramway will start at Champaner Road Station of the Bombay, Baroda and Central India Railway situated in Baroda territory and run thence along the side of the public and provincial road for a distance of about 600 yards, and thence, deviating from the road, run along an independent alignment south of the said road. At about 21 miles 6 chains (road mileage) it will cross the road to the north side, and recross to the south side at about 32 miles, 30 chains (road mileage). Thence it will run along the side of the road to about 33 miles, 26 chains (road mileage) from which point it will run by an independent alignment to the Shivrajpur Mines. The total length of the tramway will be about $18\frac{3}{4}$ miles of

which the part in British territory authorized by this Order is about 17 miles.

Dates for commencement, completion and opening of tramway.

The promoters shall substantially commence the construction of the said tramway within six calendar months from the date of this Order and shall complete and equip the same in every respect for its opening and working for public traffic (both passenger and goods) to the satisfaction of the Local Government and shall open it for such public traffic within two years from the date of this Order: Provided that the tramway or any portion of it shall not be opened for public traffic except in accordance with section 12 of the Act.

(2) In the event of the said Promoters failing to commence the construction, and to complete and equip the tramway and open it to public traffic as provided in the first paragraph of this clause, then in any such case the Local Government shall be at liberty to revoke this Order, and the tramway (including the permanent way, the rolling stock and all the buildings and works of every description connected therewith) may be dealt with under the provisions of the Act relating to the discontinuance of tramways as a tramway whereof the discontinuance has been proved to the satisfaction of the Local Government. And the Local Government shall thereafter be at liberty to enter into any arrangements with any other person or persons or bodies for the construction, maintenance and working of a tramway between Champaner Road Station and Shivrajpur.

Gauge of tramway.

8. The tramway shall be constructed on a gauge of 2 feet 6 inches.

Ruling gradient of the tramway shall nowhere exceed 1 in 80. Where the gradient of the portion of the provincial road utilized for the tramway exceeds the aforesaid limit, and it is impossible or undesirable to construct a separate embankment for the tramway within road land limits, the Promoters may lower or raise the road embankment and alter any bridge to the extent necessary to obtain the limiting grade, such works being executed under arrangements to be made with the Government Engineer in charge of the road. The cost of such alterations shall be borne by the Promoters.

Standard dimensions to be Minimum and Standard dimensions prescribed by the Railway Board for 2 feet 6 inches gauge railways (Railway 1907) except where specifically provided for differently in this Order, and no departure therefrom shall be permitted without the prior sanction in writing of the Local Government.

purposes of any building or erection connected therewith, the side of the provincial road on which their present monorail track is laid between 32 miles 30 chains and 33 miles 26 chains (road mileages): Provided always that—

(i) any additional earthworks, culverts and other works for the purposes of the tramway constructed by the Promoters within the road limits shall be constructed, maintained, and kept in repair to the satisfaction of the Government Engineer in charge of the road and so as not to interfere in any way with the efficient drainage of the road; and the cost of all such additional works shall be borne by the Promoters except as otherwise agreed to by the Local Government;

(ii) earth or ballast required for the purposes of the construction or maintenance of the tramway may be excavated, free of charge, from the existing borrow pits alongside the road only to the extent and subject to such stipulations as may be approved by the Government Engineer in charge of the road acting under competent authority;

(iii) nowhere shall the sleepers of the tramway project above the surface of the provincial road metalling so as to endanger or interfere with, the ordinary traffic of the road, and the permanent way of the tramway shall not interfere in any way with the efficient drainage of the road always provided that the proper formation of the road is maintained by the Road Authority;

(iv) when the roadway in the metalled portions of the road is raised or lowered by the Promoters to ease gradients, under clause 9, the Promoters shall re-metal at their own cost, to the satisfaction of the Government Engineer in charge of the road the roadway so raised or lowered;

(v) the tramway rail, nearest the metalled portion of the road, shall be nowhere

less than 7 feet from the centre of such metalled portion;

 (vi) any loop-lines, turn outs, or sidings that may be provided shall be emplaced on the side of the tramway furthest from the metalled portions of the road;

(vii) there shall nowhere be a less width of roadway clear of the inner rail of the tramway than 13 feet, thus allowing for a minimum width of metalling of 12 feet;

- (viii) the metalling of the roadway shall not be interfered with more than is absolutely necessary for the proper construction or maintenance of the tramway; and, in all cases, where such metalling has been so interfered with, it shall be repaired and made good with all reasonable promptitude by, and at the cost of, the Promoters to the satisfaction of the Government Engineer in charge of the road;
- (ix) the Promoters shall maintain and keep in repair to the satisfaction of the Government Engineer in charge of the road the metalling of the road along-side the inner rail of the tramway up to a distance of 2 feet from such rail; and shall also forthwith repair, make good, and reinstate, to the satisfaction of the Government Engineer aforesaid, any other portion of the road which shall, at any time, be in any way damaged by reason of any fault of the Promoters or of any accident to or upon the tramway;
- (x) if for the purposes of the road any addition to or alteration of any road bridge is, in the opinion of the Government Engineer in charge of the road, rendered necessary by the tramway, the same shall be carried out by, and at the cost of, the Promoters to the satisfaction of the said Engineer;
- (xi) the Promoters may stack road metal and other materials for the construction or maintenance of the tramway within the limits of the road boundaries but the same shall be stacked in such a manner as, in the opinion of the Government

Engineer in charge of the road, will not impede or endanger the traffic on the said road, or interfere with or cause inconvenience to the stacking of the road materials.

- (xii) the portion of the road which the Promoters are not authorized by or under this Order to use for the purpose of the tramway shall be left free and unencumbered for ordinary traffic, and no obstruction whatever shall be placed thereon or caused thereto without the previous written consent, which may be revoked at will, of the Government Engineer in charge of the road.
- (1) The rails of the tramway shall be of steel, weighing not less than 24 lbs. per yard : provided that the 18 lbs. rails of the existing Description of permanent way monorail track may be utilized till they need renewal, the to be used. axle loads over the sections where they are used being restricted to 4 tons. The rails shall be connected by suitable fish-plates, fish-bolts and nuts. All rails shall be laid on sound and suitable sleepers and secured thereto in a workman-like manner, and the line shall be fully ballasted with sound ballast.
- (2) In villages and at all level crossings of district or village roads, the metal of the road shall be maintained flush with the level of the top of the rails to the satisfaction of the said Government Engineer, and at such places either grooved or double rails shall be used or other suitable arrangement be made to effect the same object to the satisfaction of the Government Engineer in charge of the road. At all places where double rails are used, such rails shall be kept properly secured to each other by distance
- 13. In all cases where, in the opinion of the Government Engineer in charge of the road, the existing road bridges on the length of the provincial road to be utilized for the tramway are not sufficiently strong to carry the tramway, the Promoters shall make, at their own cost, such additions to or alterations of any such bridges as may be required by the said Engineer, and the work shall be carried out and completed to his satisfaction:

Provided that the Promoters may, at their option, construct at their own cost, for the purposes of the tramway, separate bridges of such design and in such manner as shall first be approved by the said Engineer and shall complete the same to the satisfaction of the said officer.

- The Local Government shall have the power of determining, from time to time, the situation and dimension of all stations, station Stations and buildings. yards, junctions, offices, warehouses, houses for employés, conveniences and works to be constructed in connection with or as part of the tramway.
 - All the crossing stations and junctions of the tramway shall be provided with such signals, as may be considered necessary by the Local Signals. Government.
- (1) The Promoters bind themselves to provide, at their own cost and to the satisfaction of the Local Government, suitable level Provision of level crossings, crossings wherever the tramway crosses district and village gates and gatemen. roads, and at such other places as the Local Government or any officer appointed by the Local Government in this behalf may, from time to time, direct.
- (2) The Promoters shall, at their own cost, provide gates with gate-keepers' lodges, and shall maintain, at their own cost, gate-keepers at such level-crossings or bridges crossed by the tramway as the Local Government may, from time to time, direct.
- The Promoters shall, within three calendar months of being called upon by the Local Government to do so, be bound to provide at their own expense, fencing on either or both sides of the tramway or of the roadway where it is utilized for the tramway, at any place where this is considered by Government essential for public safety and shall carry out and complete the work in such manner and in such time as the Local Government may direct.
- (1) Such additional land (over and above that the free use and enjoyment of which the Local Government have agreed to grant to the Promoters in terms of clause 11 of this Order) which may Provision of additional land in the possession of Government. the possession of Government.

 be in the possession of Government, as may be required by the Promoters and considered by the Local Government as necessary for the purposes

of the undertaking shall be provided by the Local Government free of cost to the

Promoters. Provided that if such land is required for excavating earth, ballast or building material, the Promoters shall pay to the Collector of the District the usual fees for so excavating.

(2) Any such land which may subsequently be considered as not needed for the purposes of the undertaking shall be restored to the Local Restoration of land when no Government. It shall rest with the Local Government longer required. to decide at any time whether any particular land is or ig not required for the purposes of the undertaking.

(1) Such additional land (over and above that the free use and enjoyment of which the Local Government have agreed to grant to the Promoters in terms of clause 11 of this Order) as may be required by the Promoters for the purposes of the undertaking, which may be in private occupation shall, if Government are satisfied that it is absolutely necessary that such land be acquired and that adjacent or alternative and cheaper land will not suffice instead for the said purposes, be acquired by Government on behalf of the Promoters under the Land Acquisition Act and when the cost of acquisition of any land exceeds the rate of Rs. 150 per acre so much of such rate as is in excess of Rs. 150 shall be borne by the Promoters, but in any other case the whole cost of acquisition shall be borne by Government. Provided that if such land is

(2) The Promoters shall not sell or dispose of any land acquired by the Local Government on their behalf. Any such land which may subsequently be considered as not needed for the purposes of the undertaking shall be restored to the Local Govern-

ment free of cost or any encumbrances. It shall rest with the Local Government to decide at any time whether any such land is or is not required to be retained by the Promoters for the purposes of the undertaking.

Utilization of material from the Promoters' mines.

20. The Promoters shall be at liberty to utilize for the purposes of the undertaking, free of any fees, earth, ballast, or building material excavated or removed from their mines at Shivrajpur.

21.

Conditions under which works within road boundaries shall be carried out by Promoters.

The Promoters shall employ a sufficient number of competent overseers and foremen capable of setting out and supervising the several works of the tramway within road boundaries and the Government Engineer in charge of the road, acting under superior authority, shall have power to stop the construc-

tion of any work when such adequate supervision is not provided. The Government Engineer shall similarly have power to stop any work, when it is not being executed according to plans which may be approved by him in accordance with the provisions of this Order, or when the work which is being carried out is not, in his opinion, of good quality. And any work so stopped for any of these reasons shall not be re-commenced unless and until the Promoters shall have satisfactorily met the objections of the said Government Engineer.

> PAYMENT BY PROMOTERS OUT OF CAPITAL, OF INTEREST DURING CONSTRUCTION OF LINE, AND OF COMMISSION.

Payment of commission out of capital by the Promoters of a commission of 5 per cent. on the subscribed capital of the undertaking, which commission shall cover all expenses incurred by them (other than the cost of registration and stamps) of, or in connection with, the floating of the undertaking.

MOTIVE POWER.

23. The vehicles used on the tramway may be moved by steam or such other motive power as the Local Government may, from time to time, authorize in writing.

ROLLING STOCK.

24. Every vehicle used on the tramway shall be of a pattern approved by the Local Design of rolling stock.

Government, and every carriage for the conveyance of passengers shall be constructed in such a manner as, in the opinion of the Local Government, will be proper and sufficient to enable passengers to enter thereinto and to descend therefrom in safety, and shall provide for their accommodation therein in such a manner as the Local Government may consider suitable.

25. The type of locomotives to be used on the tramway shall be approved by the Local Government, who also reserve to themselves the right to order the provision of cowcatchers on all engines. If wood fuel is to be used, every locomotive shall be fitted with efficient spark arresting apparatus.

Brakes.

26. All engines and vehicles shall be fitted with efficient brakes to the satisfaction of the Local Government.

SPEED.

27. The maximum speed shall not exceed that which may, from time to time, be authorized in writing by the Local Government.

MAINTENANCE AND WORKING OF TRAMWAY.

writing to the Promoters, call upon the Promoters to show cause why any portion of such tramway should not be closed for traffic to enable such work or works to be carried out in safety. After considering the necessity for closing such portion of the tramway, as well as any objections or suggestions which may be made by the Promoters, the Local Government or such person or persons as the Local Government may appoint by general or special order for the purpose, may direct that the Promoters shall close any portion of the tramway for such a period of time, and under such other conditions as in the circumstances of the case may appear to be necessary. The Promoters shall be bound to comply with such directions, and allow the work referred to therein to be carried out: Provided that, unless otherwise directed, any portion of the tramway which it may be necessary to remove in order to the carrying out of such work shall be removed and reinstated by, or at the expense of, the Local Government, the Local Authority, the Road Authority, or the person or persons, as the case may be, by whom the work is carried out.

- Conditions on which Promoters allowed to interfere with structures in or on land occupied or to be occupied by the tramway. Should be interfered with or that the position of any one of them should be altered, the Promoters shall give notice in writing to the Local Authority and the Road Authority, and to any officer or any person in charge of, or interested in, the thing or things to be interfered with or altered, and shall also submit an application to the Local Government, and after considering the application of the Promoters, as well as any objections or suggestions that may be made with reference to such application, the Local Government or such person or persons as the Local Government may appoint by general or special order for the purpose, may pass such order on the application as in the circumstances of the case may appear fit: Provided that the Promoters shall not in any case be entitled to require any interference with, or alteration of, any sewer or drain, or the position thereof.
- Power to make temporary the provision contained in clause 29 of this Order, or when, from any other reason, it is in the opinion of the Local Government necessary or expedient to remove or discontinue the use of the tramway or any part thereof, the Promoters, subject to such conditions and in accordance, in all respects, with such regulations as the Local Government may, from time to time, make, may construct and muintain, so long as occasion may require, a temporary tramway in lieu of the tramway or part of the tramway removed or discontinued.
 - 32. Trains shall only be worked on one or other of the systems prescribed by the Government of India in their General Rules and Regulations for Railways.
 - 53. In thick, foggy or tempestuous weather, detonator signals shall be used in Detonator signals.

 - 34. No train shall be run between sunset and sunrise, except with the previous consent of the Local Government and upon such conditions as may be approved by them.
- 35. (1) During foggy weather, every train shall exhibit one white head-light in front and a red tail-light and two red side-lights in rear of the train, and every engine running alone, during foggy weather, shall exhibit one white head-light in front and at least one red tail-light.
- (2) The same train and engine lights shall also be used when any train runs between sunset and sunrise.
 - 36. There shall be at least one brake van, with a competent person in charge of it, to each train, and more shall be attached whenever found necessary and whenever the Local Government shall require it.
- 37. The Promoters shall keep the metalled surface of the length of the road Metalled surface of road to be utilized for the tramway, and also the portions of the road kept clear.

 ore. They shall also remove accumulations of cinders and ashes to outside road limits.
- 38. The Promoters shall not, without the consent in writing of the Government Engineer in charge of the road, or of the Local Authorities, as the case may be, cut down or lop any tree growing along or by the side of the length of the road utilized for the tramway, provided that in case of emergency, the Promoters may remove or lop the branches or any portion of a tree which projects or hangs in such a manner as to be a source of danger or impediment to the tramway traffic.

TRAFFIC.

39. The Promoters shall carry with reasonable despatch, to the satisfaction of the Local Government, all passengers, passengers' luggage, parcels, fuel, minerals, and all descriptions of goods seeking transport by the tramway, for which their rolling stock may, in the opinion of the Local

Government, be sufficient and suitable: Provided that the Promoters shall be at liberty to refuse to carry any person suffering from any infectious or contagious disorder, and any dangerous or offensive goods within the meaning of section 16 of the Act.

- 40. The goods considered to be dangerous and offensive within the meaning of section 16 of the Act shall be those listed from time to time as such in the General Rules for open lines of Railway in British India in force on the Bombay, Baroda and Central India Railway.
- 41. The Promoters shall run at least one train daily for the conveyance of passengers, and goods, in each direction of the tramway, unless, owing to accident or other cause, they establish, to the satisfaction of the Local Government, their inability to do so.
- 42. In all trains carrying passengers, provision shall be made for two or more classes of passengers, two classes only, namely, an upper class and a lower class, being provided in the first instance. If at any time the Promoters shall desire to make provision for more than these two classes, such additional provision shall not be made unless and until the Promoters' application to make such provision and the maximum rates of fares for passengers to be conveyed by such additional kind of accommodation are duly sanctioned by the Local Government by a further Order.

Classification of goods.

43. At the outset, the classification of goods for the purpose of carriage on the tramway shall be as follows:—

First Class-All goods not in the Second Class.

Second Class-Manganese ore, coal, sand, stone, bricks, lime and firewood.

But the Local Government reserve power after the tramway has been opened to public traffic for 5 years to call upon the Promoters to submit proposals for a revised classification in supersession of that now sanctioned, and failing agreement within 3 months between the Local Government and the Promoters on a fresh classification, the Local Government reserve power to order the adoption of the classification in force, from time to time, on the Bombay, Baroda and Central India Railway.

- 44. The tolls authorized to be levied shall be paid to such persons and at such places upon or near to the tramway, and in such manner and Tolls leviable by Promoters. under such regulations as the Promoters may by notice annexed to the list of tolls exhibited under sub-section (2) of section 15 of the Indian Tramways Act, 1886, with the previous sanction of the Local Government, appoint. At the outset, the maximum rates of fares for passengers, passengers' luggage and parcels and tariff charges for goods shall not exceed those specified in the schedule annexed to this Order. Full control over charges of all kinds on the use of the tramway is reserved to the Local Government, who may, should it be considered desirable, require special charges to be made in respect to the carriage of food-grains, salt and fuel. Government also reserve power after the tramway has been opened to public traffic for 5 years to call upon the Promoters to submit proposals for a revised schedule of maximum fares and charges in supersession of that now sanctioned and failing agreement within 3 months between the Local Government and the Promoters on a fresh schedule, the Local Government reserve power to order the adoption of a maximum schedule 25 per centum in excess of the schedule for similar services in force, from time to time, on the Bombay, Baroda and Central India Railway; and Government further reserve the power also to impose the minimum schedule in force on the Bombay, Baroda and Central India Railway should the tramway ever become a through route between two lines of railway.

The Local Government shall have absolute power, for the purposes of this clause, to decide whether any preference, advantage, prejudice or disadvantage is undue or unreasonable.

INSPECTION, OPENING AND CLOSING OF TRAMWAY.

- 43. The undertaking and all works, stock, appliances and accounts appertaining thereto shall at all times be open to the inspection and examination of any person or persons whom the Local Government may appoint for that purpose, and the Officer making it.
- 47. The tramway or any portion or siding or extension thereof, or addition thereto, shall not be opened for public traffic until after an Engineer appointed in this behalf by the Local Government has inspected it and certified it to be fit for such traffic and the Local Government have communicated their approval in writing to such opening.

Should experience appear to the Local Government to prove that Police are required at any or all the stations on the tramway, the Local Government shall provide and maintain for the preservation of law and order such a force of Police as they may, in consultation with the Promoters, consider necessary. Three-tenths of the cost of any Police so provided and maintained including incidental expenses appertaining thereto, shall be borne by the Local Government and the remaining seven-tenths by the Promoters.

Should the Promoters desire at any time to have a telegraph line erected along the tramway, the Local Government will use their good offices to have the same constructed and maintained by the Imperial Telegraph Department, on the same terms as regards charges for rent and maintenance, and on the same general conditions as may be, from time to time, in force in the case of State Railways. If a telegraph line be so provided, the Promoters shall work the line in strict accordance with the rules which have been or which from time to time may be authorized by the Governor General in Council for the adoption and working of licensed railway telegraph lines in British India.

57. In the event of any work required by the Act or by this Order to be done by the Promoters not being done by them, the Local Govern-On Promoters' default, works may be executed by the Local ment may cause a notice to be served on the Promoters

requiring them, within a period to be prescribed in the said Government. notice, to execute the said work, and if within the period so prescribed such requisition is not complied with, the Local Government may cause such work to be done, and the cost thereof shall be recoverable from the Promoters. The certificate of the Government Engineer or other officer in charge of such work shall be conclusive evidence that all expenses referred to in such certificate have been incurred in carrying out such work, and the Promoters shall not be at liberty to dispute the same.

58. (1) If the Promoters fail to observe any condition or direction contained in or made under this Order, they shall, for each such failure Penalty for failure of Proto observe the same, be liable to a penalty which may moters to comply with orders. extend to two hundred rupees and, in the case of a continuing failure, to a further penalty which may extend to fifty rupees for each day after the first during which such failure continues.

- (2) When the Promoters have through any act of omission become liable for any penalty under this clause, the penalty shall become recoverable by suit in the District Court having jurisdiction in the place where the act of omission or any part thereof occurred.
- (3) The Local Government may remit the whole or any part of any penalty to which the Promoters become liable under this clause.

the expiration of any subsequent period of ten years, subject to the same notice and on and from such determined date of purchase this Order shall be held to be determined and Its provisions to have ceased to be of effect, and on that date the Promoters, without acquiring or having the right to any compensation or payment in respect of the undertaking except as to the purchase-money hereinafter specially provided, shall relinquish and give up to the Local Government possession of the tramway together with all land which, being the property of Government may have been made over for the purposes of the undertaking (so far as the same has not then been already restored to the Local Government), as also any land which being in private occupation the Local Government may have acquired for the Promoters (also so far as the same has not then been already restored to the Local Government) and such other land or lands which the Promoters may have acquired by private negotiation for the bond fide purposes of the undertaking, as may then be utilized for the undertaking, together with all the stations, station yards, sidings, crossing places, bridges, viaducts, offices, warehouses, houses for employes, fixed machinery, conveniences, works, bridges, rails, fixtures and plant erected or being on the land to be relinquished and given up under this clause or in anywise belonging to the undertaking or any part thereof, and all the rolling stock, moveable machinery, live stock, carriages, vehicles, plant and articles belonging to the undertaking and appropriated, either as regards purposes of construction or otherwise, to the said undertaking or any part thereof or any of the works or adjuncts thereof, and shall also deliver to the Local Government all plans, books, surveys, sections, printing, writings and documents whatsoever in anywise connected with, or with the construction of, the undertaking, or any of the works or adjuncts thereof inclusive as aforesaid. All the particulars mentioned in this clause shall, at the time when the Local Government shall under this clause become entitled to the delivery thereof, so far as then already not belonging to the Local Government, become their absolute property free, both as between the Local Government on the one hard and the Promoters on the other and as between the Local Government and the encumbrances (if any), from all encumbrances whatsoever created by the Promoters, and the Local Government shall not be affected by any charge or encumbrances of any kind created by the Promoters on any moveable or immoveable property, which during the continuance of this Order shall be in the possession of the Promoters, whether belonging to the Local Government or to the said Promoters.

The price to be paid by the Local Government for the undertaking on its purchase, as hereinabove provided for, shall be the sum Purchase price payable by Local representing in the currency of the time being the aggregate Government. of (25) twenty-five times the average annual net earnings of the undertaking for the (3) three calendar years immediately preceding the date of purchase decided on as above provided for, subject to a maximum of 120 and a minimum of 100 per centum of the capital cost, the said net earnings being proved to the satisfaction of the Local Government or failing agreement the matter will be determined by arbitration under the clause in that behalf hereinafter contained and the said amount of purchase-money shall be held to be payable to the said Promoters at the Government Treasury, Bombay, on the date determined on for such purchase. Provided, however, that the amount shall not be paid by the Local Government until such time as the net earnings of the undertaking for the calendar year immediately preceding the date of purchase are definitely known, but the payment shall not be delayed beyond the thirtieth day of April following the date of purchase, and the Local Government shall pay to the said Promoters, in addition to the purchase-money calculated as above, a further sum representing interest at the rate of three per centum per annum on the amount of purchase money calculated as above for the period from the date of purchase up to and inclusive of the day on which the said purchase-money, together with the further amount representing interest thereon at the rate and for the period herein mentioned, shall be tendered for payment to the said Promoters.

ARBITRATION.

65. If any dispute, question or controversy shall at any time arise either between the Local Government and the Promoters, or the Local Authorities Arbitration. and the Promoters, touching this Order, or any clause or thing herein contained, or the construction hereof, or any matter connected with this Order, or the operation of the same, or the rights, duties, or liabilities of any of the parties in relation to the premises, then and in every such case the matter in difference, unless special provision shall have been made in this Order for the settlement of the matter so in difference, shall be referred to two arbitrators or their umpire, pursuant to and so as with regard to the mode and consequence of the reference, and in all other respects to conform to the provisions in that behalf contained in the Code of Civil Procedure, 1908, or any subsisting statutory modification thereof, and upon every such reference the arbitrators and umpire shall respectively have power to examine witnesses upon oath or affirmation, and either to fix, settle, and determine the amount of cost of the reference and award respectively or incidental thereto to be paid by both parties making the reference or by either party, or to direct the same to be taxed either as between solicitor and client or otherwise, and to direct and award where and by and to whom such costs shall be paid and every or any such reference may be made a rule of Court on the application of either the Local Government, the Local Authorities or the Promoters, and either the Local Government, the Local Authorities or the Promoters may instruct Counsel to consent thereto for the other party.

RESOLUTION-By the Government of India, Home Department.

The Rules issued under the Indian Arms Act, 1878, were originally published with the Home Department Notification No. 518, dated the 6th March 1879. As the result of successive amendments and additions during the past thirty years, these rules have become most intricate and confusing, and it is believed that in their present form they cause inconvenience to the officers who have to administer them as well as to the public, especially to those who are connected with the trade in arms and ammunition. The Governor General in Council has therefore caused them to be codified in a clearer form. The revised rules have been circulated to local Governments and Administrations for their opinions; and a large number of minor amendments suggested by them have been adopted. The rules as finally approved by the Governor General in Council are now published for general information, in supersession of those hitherto in force. The changes which have been made in the rules are, for the most part, only such as are necessary in order to make them clear or in consequence of administrative changes, such as the formation of the North-West Frontier Province, the creation of new districts in the Punjab and the formation of the province of Eastern Bengal and Assam.

THE RULES.

Short Title.

- 1. These rules may be called the Indian Arms Rules, 1909.

- 2. In these rules, unless there is anything repugnant in the subject or context—
- (a) all words and expressions, which are defined in the General Clauses Act, 1397, shall have the meanings respectively assigned to them thereby: and the provisions of sections 9, 10 and 13 to 19 of the said Act shall be deemed to apply as if these rules were an enactment made by the Governor General in Council after the commencement of the said Act;
- (b) all references to the 'Magistrate of the District' shall, in the case of Aden, be construed as referring to the Assistant Resident.

4. For the purposes of the definition of 'military stores' contained in section 4, all sections of the Act are extended, throughout British India, to all lead, sulphur and saltpetre.

- 8. (1) A license shall not be granted for the import by sea or river or land-
- (a) of rifles of 303 or of 450 bore or parts of or fittings for rifles of such bores or, save as otherwise provided by rule 31, of ammunition which can be fired from such rifles;
- (b) save by special order certified under the signature of a Secretary to the Government of India in the Home Department or, so far as the district of Ajmer-Merwara is concerned, in the Foreign Department, of rifles, or parts of or fittings for rifles, of any other bore;
- (c) of any fire-arms or ammunition into Burma through the melium of the Post Office.
- (2) Nothing in sub-rule (1), clause (b), shall be deemed to limit or otherwise affect the power to grant, save as otherwise provided by rule 7, a license for the import of rifles, or parts of or fittings for rifles, which, in the opinion of the authority granting the license, are intended in good faith for sporting rurposes.

9. (1) Save as otherwise provided by rules 6 to 8, a license may, subject to the provisions of sub-rule (2), be granted for the import Import of arms, ammunition or military stores into certain ports. by sea-

- 11. (1) Save as otherwise provided by rules 6 to 8, and subject to the provisions of rule 33, sub-rule (2), a license for the import by land or river, otherwise than into Ajmer-Merwara, of arms, ammunition or military stores may be granted,
- (a) where the arms, ammunition or stores are consigned to a Presidency-town or to Rangoon, by the Commissioner of Police, or
- (b) where they are consigned to any other place, by the Magistrate of the district in which such place is situated.
- (2) Where arms belonging to any person who-
 - (a) resides in a Native State in India, and
 - (b) is exempted under schedule I from the necessity for taking out a license in respect of such arms,

are imported solely for the purpose of repair, the Political Agent for such State may grant a similar license, which shall also cover the re-export to such State of such arms.

- (3) Where the arms, ammunition or stores are imported from a Native State, a copy of the license shall be forthwith sent to the Political Agent for such State.
- (4) Where the arms, ammunition or stores are imported by road or river and consigned to a district not on the frontier of British India, a copy of the license shall be forthwith sent to the Magistrate of the district into which they cross such frontier; and such Magistrate may, in his discretion, require the licensee to produce them for his inspection before allowing them to leave the district.
- (5) Where the arms, ammunition or stores are imported by rail, a copy of the license shall be forthwith sent by the authority granting it to the railway authorities at the place to which such arms, ammunition or stores are consigned.

Form IV.

- Import of arms, ammunition or military stores into Ajmer-Merwara of arms, ammunition or military for the import into the district of Ajmer-Merwara of arms, ammunition or military stores may be granted-
 - (a) under the signature of the Secretary to the Government of India in the Foreign Department, or

- (c) the license is not identical in substance with the copy sent to the railway authorities, such authorities shall not deliver the consignment and shall forthwith inform the nearest Magistrate.
- Production and delivery of import 14. (1) The consignee of arms, ammunition or military stores imported under a license shall
 - (a) where the consignment crosses the frontier by land or river, produce the license, within six days of such crossing, before the Magistrate of the district into which the consignment so crosses, or other officer empowered by him in this behalf; and
 - (b) in any case in which the consignment is imported by land or river, deliver the license, within six days of the arrival of such consignment at its destination—
 - (i) in any Presidency-town or Rangoon, to the Commissioner of the Police, or

- as may be specified or described therein.
- (3) A license may be granted at any of the ports mentioned in clause (a) or clause (b) of sub-rule (1) for the export by sea of saltpetre or lead to the ports of Akyab or Moulmein.
- (4) A copy of every license of the nature referred to in clauses (a), (b), (c) and (d) of sub-rule (2) and in sub-rule (3) shall be forthwith sent—
 - (a) where the arms, ammunition or stores are consigned to any Presidency-town or Rangoon to the Commmissioner of Police, or
 - (b) where they are consigned to any other place, to the Magistrate of the district in which such place is situated.

(i) to any port in any Native State in India, or

- (ii) subject to the provisions of sub-rule (3), to any port, other than a British port, in any other foreign territory.
- (2) A license shall not be granted under sub-rule (1) for export to any such port on these a-board of Arabia as is referred to in clause (ii) of that sub-rule, other than a port in the political charge of the Resident—
 - (a) at Aden,
 - (b) in the Persian Gulf, or
 - (c) in Turkish Arabia.

shall forthwith produce such license or pass upon the demand of any Magistrate or of any Police officer of a rank not below that of officer in charge of a police-station.

(2) Nothing in sub-rule (1) shall be deemed to limit or otherwise affect the power of any authority empowered to grant or renew a license to grant or renew it upon any condition, not inconsistent with the said sub-rule, with respect to the production of such license.

Free

- 39. (1) Every license granted or renewed under these rules shall, save as herein otherwise expressly provided, be chargeable with the fee (if any) indicated on the appropriate form set forth in Schedule VII.
- (2) Where any arms, other than-
 - (a) cannon, or
 - (b) rifles falling within the prohibition contained in rule 8,

or any ammunition or military stores are imported under a license into any British port and re-exported thence and re-imported into any of the ports specified in rule 9 or in rule 10, the necessary licenses for such re-export under rule 16 and for such re-import under rule 9 or rule 10 shall be respectively chargeable with a fee of one rupee only.

- (3) The Government of India may, by general or special order, grant exemption from, or reduction of, the fee payable in respect of any license.
- (4) The fee payable in respect of the grant or renewal of any license of the nature hereinafter referred to may, by general or special order of the local Government, be remitted or reduced
 - (a) for the import, transport or possession of sulphur in reasonable quantities proved to the satisfaction of the Local Government to be required in good faith for medicinal, agricultural, manufacturing or industrial purposes other than the manufacture of ammunition;
 - (b) for the export to a Native State of ammunition required for the use of a public railway or other public work;
 - (c) under rule 11, to any person for the import of any arms, ammunition or military stores in reasonable quantities proved to the satisfaction of the authority granting the license to be required in good faith for the protection of person or property.
- (5) The fee payable in respect of the grant or renewal of any license in form VII may be remitted subject to the condi ions stated in each case, as follows namely:—
 - (a) Under the signature of a Secretary to the Government of Madras, Bombay or Bengal in respect of ammunition exported to a Native State for the use of a public railway or other public work.
 - (b) By all Political Officers authorised to grant licenses in form VII, in the case of arms and ammunition exported for the personal use of persons of the classes mentioned in Schedule I.
- (6) The fee payable in respect of the grant or renewal of any license in form VII shall be remitted in the case of all licenses in that form issued by the Commissioner of Police in Madras or Bombay, the Deputy Commissioner of Police in Calcutta or by the District Magistrates of Mecrut and Rawalpindi.
- (7) The fee payable in respect of a license in form VII granted by the District Magistrate of Malabar for export to Mahé shall be reduced to one rupee in every case in which the value of the consignment does not exceed twenty rupees.
 - 40. Where a license granted or renewed under these rules is lost or accidentally destroyed, the Fees payable for duplicates. authority empowered to grant such license may grant a duplicate—
 - (a) where the original license was granted without the payment of any fee to a cultivator or other like person, free of all fee;
 - (b) where such original license was granted on the payment of a fee not exceeding one rupee, on payment of a fee of the same amount; or
 - (c) in any other case, on payment of a fee of one rupee.

Collection and refund of fees.

- 41. (1) All fees payable under rule 39 or rule 40 shall be collected by impressed stamps.
- (2) The Government may, by general or special order, direct in regard to any application for a license or duplicate in respect of which a fee is payable—
 - (a) that the application shall be written upon an impressed stamp of a value equal to such fee and that in such case the license or duplicate shall be granted or renewed on plain paper or,
 - (b) that the license shall be written upon an impressed stamp, to be supplied by the applicant, of a value equal to such fee, and that in such case, the application may be written on plain paper.
- (3) Where a fee of not less than one rupee payable under these rules has been collected and the application for the grant or renewal of a license or duplicate is refused, the value of the fee shall be refunded, upon application for the same being made within two months from the date of such refusal.

BY THE REGISTRAR, CO-OPERATIVE CREDIT SOCIETIES, BOMBAY PRESIDENCY.

No. 1996.—The following Bye-laws of the Surat District Urban Co-operative Union, Limited, registered under the Co-operative Credit Societies Act (X of 1904), vide this office Notification No. 175 of 17th June 1909 in the Bombay Government Gazette dated 24th June 1909, are published for general information:—

Bye-laws of the Surat District Urban Co-operative Union, Limited.

Preliminary.

- 1. These Bye-laws may be called the Bye-laws of the Surat District Co-operative Urban Union, Limited.

 Name and address of the Society.
- 2. (a) The name of the Society shall be the Surat District Co-operative Urban Union, Limited.
 - (b) and its registered address shall be Surat City.

Objects and Purposes.

- 3. The objects for which the Society is established are to promote the Agricultural and Industrial prospects of the District and to raise funds for the same.
 - 4. The purposes for which the funds of the Society will be applied are :-
 - (a) lending money to members of the Society and to other registered societies.
 - (b) financing as well as organizing the local manufactures of the Surat District.
 - (c) establishing and maintaining stores for distributing all kinds of articles.

Membership.

- 5. After registration of the Society any person may be admitted to the membership of the Society on the following terms, viz.:—
 - (a) That he apply for membership by a written application duly signed by him in the form to be prescribed by the Committee.
 - (b) That he take up, and thereafter own, at least one share of the Society.
 - (c) That he be accepted by the Committee.
 - (d) That he be a resident of Surat District.
- 6. A member of the Society shall cease to be so on his ceasing to hold any share of the Society. And shares are for members only.

Loans.

- 7. Members of the Society may obtain loans from it on such terms and conditions as are prescribed below, viz.:—
 - (a) That they pay on such loans interest at a rate not less than one pie per rupee per month, until another rate is fixed at an annual general meeting of the Society. For the purpose of calculating interest for fractions of a month a period of 16 days or more shall be regarded as a complete month and a period of less than 16 days shall be regarded as half a month.
 - (b) That they be able to furnish one or more sureties approved by the sub-committee or give such other security as the sub-committee may deem sufficient.
 - (c) That the amount of such loans never exceed Rs. 1,000 in any year to an individual member.
 - (d) A member of the Committee shall not vote on his own application for a loan,
 - (e) Loans may be made repayable either in a single payment or by instalments as the subcommittee may direct.
 - (f) In the event of any loan or instalment of a loan not being paid by a member on the due date fixed for repayment, compound interest at two pies per rupee per month shall be recoverable on the amount overdue. When such repayment is not received on due date, the sub-committee or any person authorized in this behalf by the sub-committee shall in writing require the borrower, his surety or each of his sureties to pay, and in the event of the payment being delayed for one month, the sub-committee shall take steps to recover the amount due with the interest, unless they are satisfied that the borrower has shown sufficient reason for non-payment. Borrowers, who fail to give a satisfactory reason for non-payment within one month of their due date, shall not be entitled to receive another loan from the Society.

- (g) A member applying for a loan must state the amount of loan, the purpose for which and the period during which it is required and the nature of the security offered. In dealing with such application the sub-committee may refuse the loan, or sanction the loan applied for, or sanction a loan for a smaller sum or for a longer or a shorter period or with altered conditions as to security.
- (h) When a loan granted to a member for a specific purpose is misapplied, the sub-committee shall have power to recall before due date the whole loan, with interest to date of repayment. The sub-committee's decision as to the fact of misapplication shall be final.
- (i) When a person, who has stood as surety for a loan, dies or becomes in the sub-committee's opinion unfit or ceases to reside in the district, the sub-committee by a notice signed by two members and the Manager may require the borrower to find another surety within 15 days. If the borrower fail to find another surety when so required, the loan shall become repayable immediately with interest to date of re-payment.
- 8. Loans may be made to any registered Rural Co-operative Society in the Bombay Presidency for such periods and at such rates of interest as the sub-committee think proper, subject to any general directions conveyed in resolutions passed at a general meeting.

The mode of holding General Meetings, &c.

- 9. (1) The annual general meeting of the Society shall be held in July each year,
- (a) to elect officers,
- (b) to pass the balance sheet,
- (c) to dispose of any other general business of the Society that the Chairman may allow to be brought before the meeting.
- (2) Any other general meeting of the members of the Society may be held at any time, for the disposal of any special business of the Society.
- 10. Ten clear days' notice in case of the annual general meeting and seven clear days' notice in case of any other general meeting shall be given by publication of a written notice at the office of the Society and in one or more local newspapers and by furnishing it by post to each member at his last registered address, specifying the time and place of meeting and the business to be transacted thereat.
- 11. Twenty-five or one-third of the members of the Society, whichever may be less, shall form a quorum.
 - 12. The Chairman shall be elected from the members present at the meeting.

Right of Voting at a General Meeting of the Society.

- 13. (a) Every member holding 24 shares or less shall have one vote.
- (b) Every member holding 25 or more shares shall have two votes.
- (c) In case of equality of votes the Chairman shall have a casting vote in addition to the ordinary vote or votes to which he is entitled.
- (d) Members may vote by proxy given to a member, provided that the proxy empowering the member so to vote is in a form to be prescribed by the Committee, bears on the face of it the date of its execution and is attested by a member of the Committee.

Manner of making, altering and abrogating Bye-laws.

- 14. Bye-laws may be made, altered or abrogated hereafter in accordance with a resolution passed at a general meeting of the Society provided that—
 - (a) 'Twenty clear days' notice of any proposal to make, alter or abrogate a Bye-law or Bye-laws has been given by the Committee;
 - (b) Such notice states definitely the proposal to be brought before the meeting.

Rights and Liabilities of Membership.

- 15. (a) The liability of a member shall be limited to the amount unpaid on his share or shares.
- (b) Any member shall have the right to inspect the registers and accounts of the Society during office hours.

Mode of appointment and removal of Committees, &c.

16. The Committee shall consist of a Chairman and not less than seven other members, elected by a general meeting of the Society and removeable thereby. They shall retire together annually, but be re-eligible at once, and continue till the election.

17. Four of them shall form a quorum.

18. In the absence of the permanent Chairman, a Chairman may be elected at every such meeting from among the members present. The Chairman shall have a second or casting vote in case of equality of votes.

19. The Committee shall arrange for the management of the affairs of the Society, with one

or more sub-committees according as the requirements of the Society may necessitate.

20. Each sub-committee shall consist of not less than 4 members (of whom three shall form a quorum), who shall be elected from amongst the members of the Committee by a general meeting of the Society and may be removed thereby. They dissolve ipso facto with such Committee.

Duties and powers of the Committee, &c.

21. The Committee may exercise all the powers conferred upon the Society under the Act (X of 1904) for the management of its affairs subject to these bye-laws and resolutions passed by a general meeting of the Society.

22. The sub-committees shall manage all the affairs of the Society as shall be entrusted to them from time to time by the Committee and in duties specified in these bye-laws, as belonging

specially to them, they shall yet be subject to the Committee's absolute authority.

- 23. And they shall be responsible for the proper application of the funds at their disposal to the purposes of the Society in exercise of such powers as may be invested in them under the bye-laws and under resolutions passed at a general meeting of the Society or a meeting of the Committee and shall account for the same.
- 24. The Committee may appoint a Secretary, if deemed necessary. The sub-committee shall have the power to appoint such officers and other staff as may be necessary for each section and to pay them for their services subject to any resolution passed by the Committee as to the amount of their remuneration. They shall also have power to suspend and dismiss them.
- 25. All acts done by the Committee or sub-committees or by any individual officer shall, notwithstanding that it was afterwards discovered that there was some defect in the appointment of such Committee, sub-committee or officer, be as valid as if the Committee, sub-committee or officer had been duly appointed.

Raising of Capital.

- 26. Capital may be raised by the Committee in one or more of the following ways:
- (a) by shares,
- (b) by deposits,
- (c) by loans.
- 27. The capital by shares shall not exceed Rs. 2,00,000 divided into 10,000 shares of Rs. 20 each, and the capital by loans including deposits from non-members shall not exceed Rs. 1,25,000, without a resolution respectively of a general meeting.

Mode of Custody and Investment of Funds.

- 28. The funds at the disposal of the Society shall be employed first in loans to members and then to other registered societies and in establishing and maintaining stores and in financing and organizing local manufactures and in investing the balance.
- (a) The amount invested in establishing and maintaining stores and in financing and organizing local manufactures shall not exceed Rs. 50,000 without the special sanction of a general meeting of the Society.
- (b) For the purpose of stores and organization of the local manufactures a lump sum (subject to para. (a) of this Bye-law) may be obtained from the Banking section which shall charge for account purposes interest at 6 per cent. per annum on only sum so advanced from time to time.
- Each sub-committee shall have under it a Manager, honorary or stipendiary, who shall keep in his hands at the end of a day not more than a sum fixed by the Committee, the balance being invested as directed by the Act.

Mode of keeping Accounts.

- 31. In addition to the accounts and books required to be kept by Rules 9 and 10 of the Government of Bombay Rules under the Act, special registers of stores, &c., shall be kept in such forms as may be prescribed by the Committee. Departures from the "model" forms shall be subject to the Registrar's approval.
- 32. The balance sheet shall be published on or before the 15th July of each year and a copy thereof sent to the Registrar before the 25th July.

Matters incidental to the Management of Business.

33. The Committee shall have power to allot shares, issue share-certificates, make calls, transfer shares, pay the value of a share or shares or interest, and do all such act or acts as may be 34. Shares may be forfeited to the Society for default in payment of a call thereon after 15 clear days' notice by post.

35. No disbursement for contingent expenses shall be made by a Manager, except under the authority of a resolution of the sub-committee concerned, which shall obtain sanction of the Committee for any item for which the disbursement is to exceed Rs. 50.

Deposits.

- 36. (a) Deposits shall bear interest not exceeding 5% per annum and may be received from both members and non-members, under such particular conditions as may be ordinarily laid down by the Committee. Deposits from non-members shall not exceed Rs. 50,000 without a special resolution of a general meeting. Preference is to be given to members so far as possible.
- (b) Deposits may be either fixed deposits or current deposits. Fixed deposits may not (ordinarily) be withdrawn within a period of one year or more as specified in the depositor's receipt book and shall bear interest not exceeding 5% per annum. Current deposits shall bear interest (ordinarily) at 3\frac{3}{4}\% per annum and may be withdrawn (ordinarily) after 3 days' notice to the Manager.
- 37. Subject to Bye-law No. 26 (and the provisions of this Bye-law), every member has the right to pay money into the Society as fixed or as current deposit. If, however, the sub-committee is at any time of opinion that the Society cannot employ deposits profitably, it may refuse to accept such and may determine the Society's further liability for interest on current deposits, on giving 15 days' notice to each person who has at time a current deposit; provided that, instead of refusing, the sub-committee may accept the deposits on special conditions as to interest, &c.
- 38. Each member shall have a Pass Book in which the Manager shall enter amounts paid to or received from such member, loan and deposit accounts being kept separately therein and in ledger form.

Stores.

- 39. The sub-committee in charge of the stores section shall have authority for the purchase, custody and disposal of stores, including raw materials for the local manufactures and shall do all other business in this connection.
- 40. Articles of stores may be sold for cash or on credit, at the rates settled therefor by the sub-committee and under such special conditions as are ruled by the Committee.

Organization of the local Manufactures.

- 41. The sub-committee in charge of the organization of local manufactures may take such experimental action as may appear necessary for such organization, subject to the conditions laid down for the purpose by the Committee.

 Profits.
- 42. There shall be an annual division of profits earned by the Society through its different sections.

No. 9580/78.—By the Commissioner of Police under the provisions of section 23 of Act No. IV of 1902 to regulate the religious processions during the Ganpati Festival;—

(1) Ganpatis that are to be taken in procession will assemble between the following points on the roads mentioned below up to 4-10 P.M., and will start from these points at that time in the order in which they take up their positions:

Madhavbag and the corner of Kika Street, Null Bazar.

Bhuleshwar, Khabutarkhana and the corner of Kavasji Patel Tank Road.

Khetwadi Main Road, between the corner of Ardeshir Dady Street and Kavasji Patel Tank Road.

Ardeshir Dady Street from the corner of Khetwadi Main Road to Girgaum Back Road.

(2) The principal route for the procession will be as follows:-

From the corner of Kavasji Patel Tank Road down Girgaum Back Road, Sandhurst Road over French Bridge, French Road and Chaupati foreshore.

An alternative route will be from the corner of Kumbhartukda down Thakurdwar Road to Girgaum Road, thence down Girgaum Road to Girgaum Tram Terminus, viâ Charni Road to Girgaum Back Road and onwards by the route laid down above.

These routes will be kept clear of traffic between the hours of 4-10 P. M. and 7-10 P. M.

- (3) No Ganpatis, unless carried singly or by a single individual, will be allowed to be taken through the streets in procession without a pass. If carried in a Palki or other conveyance a pass is necessary.
- (4) No Mela or band with or without a Ganpati will be allowed to proceed through the street without a pass.
- (5) In addition to Mela or band only one cart or carriage for (Chowgada) music and another for spectators or exhibitional purposes will be allowed to accompany a Ganpati. Such carts or carriages will be turned off at the point where the French Road crosses the Chaupati Road.
- (6) No carriages except those conveying Ganpatis and those mentioned in paragraph (5) will be allowed in procession, as they merely cause obstruction and interfere with the crowds on foot.
- (7) All applications for passes must be made to the Head Police Office seven clear days before the passes are required, in order that sufficient time may be allowed the Police to make enquiries regarding such applications; otherwise the issue of passes may be delayed or refused.
- (8) The above rules will apply to the Ganpati processions on the two principal days of the Festival, viz., Gowri and Anant Chaturdashi, Wednesday the 22nd and Tuesday the 28th September 1909, respectively.

- (६) गणपतीं स्या गाड्या आणि ९ व्या पारिप्राफांत सांगितलेल्या गाड्या शिवाय करून इतर गाड्यांपासून रस्यांत अडथळा होऊन पार्यी जाणाऱ्या लोकां स्या झुंडींस अडचण मात्र होत असल्या कारणानें, त्या, मिरबणुकीं बरोबर जाऊं दिल्या जाणार नाहीत.
- (७) पासांबद्दल्स्या अर्जीविषयीं पोलिसास चौकशी करण्यास पुरेसा वेळ मिळावा सण्न असे सर्व अर्ज, पास पाहिजेत असतील त्यास्या निदान सात दिवस आधीं, मुख्य पोलीस आफिसामध्यें सादर केले पाहिजेत, नाहीं तर असे पास मिळण्यास विलंब लागेल, किंवा ते देण्यांत येणार नाहींत.

નં ખર ૯૫૮૦-૭૮.—ગણુપતીના ઐાચ્છવમાં નીકળતા ધર્મસં ખંધી વરધાેડાનું નિયમન કરવાસાર પાલીસ કમિશનરે સન ૧૯૦૨ ના ૪ થા આકેટની ૨૭ મી કલમના ઠરાવાેની રૂચે કાહાડેલું :—

(૧) વરધોડા કાઢાડીને લઈ જવાના સધળા ગણુપતી, હેઠળ લખેલા રસ્તા ઉપરના હેઠળ લખેલે ઠેકાણે સાંજના ૪–૧૦ વાગતા સુધીમાં એકઠા થશે, અને તે વખતે તે ઠેકાણેથી તે એકઠા થયા હોય તે ક્રમમાં નીકળશે :— માધવભાગ અને કોકા સ્ટ્રીટનું નાકું, નળબજાર.

જીવેશ્વર, કણતરખાતું અને કાવસજી પટેલના તળાવના રસ્તાતું નાકું. ખેતવાડી મેનરાડ, આદેશર દાદીસ્દ્રીટતું નાકું અને કાવસજી પટેલના તળાવના રસ્તા એની વચ્ચે. આદેસર દાદીસ્ટ્રીટ, ખેતવાડી મેનરાડના નાકાથી ગીરગામ ખ્યાકરાડ સુધી.

(૨) વરધાહા લઈજવાતા મુખ્ય રસ્તા નાચે પ્રમાણ :—

કાવસજી પટેલના તળાવના રસ્તાને નાકેથી ગીરગામ બ્યાકરાેડ થઇને દ્રેચપુલ ઉપરના સ્યાંડહર્સ્ટ રાેડ ઉપર તથા ત્યાંથી દ્રેચરાેડ ઉપર થઇને ચાેપાટીને કિનારે.

આ શિવાય બીજો એક રસ્તાે નીચે પ્રમાણે છે:--

કુભારતુકડાને નાકેથી ઠાકારદુવાર રોડ થઇને ગીરગામ રોડસુધી, અને ત્યાંથી ગીરગામ રોડ થઇને ગીરગામ દ્રામટર્મિનસ સુધી અને ત્યાંથી ચર્નારાડને રસ્તે ગીરગામ ખ્યાકરાહસુધી અને ત્યાંથી ઉપર કહેલે રસ્તે. સદરહુ રસ્તાઉપરની રાહાદારી સાંજના ૪–૧૦ વાગ્યાથી ૭–૧૦ વાગ્યાસુધી બ'ધ રાખવામાં આવશે.

- (3) એકલાજ લઈજવામાં આવતા હાય એવા અથવા એકજ શખસ લઈ જતા હાય એવા ગણપતા શિવાયના યીજા કાઈપણુ ગણપતાને પાસ વગર રસ્તામાં વરધાડા કાહાડીને લઈજવા દેવામાં આવશે નહિ. પાલખીમાં અથવા બીજા કાઈ જાતના વહાનમાં લઇજવાસાર પણ પાસ લેવા પડશે.
- (૪) ક્રાઇપણુ મેળાને સ્થથવા ટાળાને, પછી તેની સાથે ગણુપતી હોય કે ન હોય તાપણ, પાસવગર રસ્તામાંથી જવા દેવામાં આવશે નહિ.
- (પ) ગણપતીની સાથે, મેળા અથવા ટાળી શિવાય માત્ર એક ચોધડીયાની ગાડી અને બીજી એક માણુસાની અથવા મલખમની ગાડી જવા દેવામાં આવશે. એવી ગાડીઓને જે ઠેકાણું કેંચરાડ ચાપાટી રાહને મળે છે તે ઠેકાણું વરધાડામાંથી જીદી પાડવામાં આવશે.
- (६) ગણપતીની ગાડીએ અને ૫ મા પારેચાકમાં કહેલી ગાડીએાશિવાય બીજી ગાડીએાથી રસ્તામાં અડચ**ણ ય**ઇને પગે ચાલનારા લોકોને હરકત થવાના સંભવ રહે છે, સંખબ તેમને વરધાડાની સાથે જવા દેવામાં આવશે નહિ.
- (૭) પાસમાટે કરેલી અરજીની ચાકસી કરવાસાર પાલીસને પુરતા વખત મળે તેટલા સાર એવી સઘળી અરજીએા જે દિવસે પાસ જોઇતા હાય તેથી સાત દિવસ આગમચ મુખ્ય પાલીસ ઑફિસમાં કરવી. નહિ તા એવા પાસ મળવામાં ઢીલ થશે અથવા તે આપવામાં આવશે નહિ.
- (૮) ઉપરની કાનૂના ગણપતીના એાચ્છવના ખે સુખ્ય દિવસે, એટલે ગારી, ખુધવાર તા. રર મી માહે સપ્ટેમ્પર ૧૯૦૯ ને રાજ અને અનંત યાદસ, મંગળવાર તારી ખ ૨૮ મી માહે સપ્ટેમ્પર, સન ૧૯૦૯ ને રાજ નીકલનારા વરધાડાને લાયુ પડશે.
