# GOVERNMENT NOTIFICATIONS, APPOINTMENTS, &c.

# NOTIFICATIONS.

GENERAL DEPARTMENT.

Bombay Castle, 14th September 1909.

No. 4814.—In exercise of the powers conferred by section 0, sub-section (1), clause (p), of the Indian Ports Act, 1903 (XV of 1903), and with the previous sanction of the Governor General in Council, the Governor in Council is pleased to make the following rules in respect of sleeping sickness occurring on vessels arriving or lying at ports in the Bombay Presidency including Sind and Aden:—

# Rules.

- 1. In these rules,
- (1) "Health Officer" means any person appointed by Government, either by name or by virtue of fils office, to be Health Officer of a port, and includes any person appointed by Government, either by name or virtue of his office, to perform any of the duties of a Health Officer of a port;
- (2) "Master," when used with reference to a vessel, means any person (except a pilot or harbour master) having for the time being charge or control of the vessel;
- (3) "Port Officer" includes any person acting under the authority of Government in charge of port discipline;

- (4) "Sleeping sickness" includes the stage of the disease known as trypanosomiasis.
- 2. The master of every vessel arriving at any port in the Bombay Presidency including Sind and Aden from a port beyond India shall-
  - (a) if the vessel has on board any person suffering or suspected to be suffering from sleeping sickness, or
  - (b) if any case or suspected case of sleeping sickness has occurred, or if any person has died or is suspected to have died from sleeping sickness on board within the twelve days immediately preceding the arrival of the vessel,

report every such case or death to the pilot or other boarding officer at the earliest opportunity, who shall cause to be hoisted (in the port of Bombay itself before passing the Prongs Lighthouse) the following signal:

During the day the Code Flag over "L" (a square flag of yellow and black borne quarterly) of the Commercial Code and during the night three white lights in a vertical line, one over the other, not less than thee feet apart, placed irrespective of any particular mast,

and shall anchor the vessel in the place appointed for the purpose.\* He shall not allow any of the passengers or crew to leave the vessel until pratique is granted.

- So long as the abovementioned signals provided for by Rule 2 are shown, no tindal or other person in charge of, or navigating any boat shall, without the permission of the Port Health Officer, attempt to make such boat fast to, or take it alongside such vessel, when she is anchored in the place referred to in Rule 2 or while she is flying the signal referred to in the same rule.
- The crew and passengers of all vessels arriving from the East Coast of Africa or other infected places shall be medically inspected on arrival at a port in the Bombay Presidency including Sind and Aden and shall be dealt with as laid down in Rule 9.
- 5. The master of a vessel coming under these rules, and any person to whom these rules apply, shall comply with all the directions which the Port Health Officer considers it necessary to give under these rules.

-The penalty for disobedience is prescribed in sub-section (3) of section 6 of the said Act, viz., a fine which may extend Note.—T

- 6. Nothing in these rules shall be deemed to prevent a vessel whose master is unwilling to submit to these regulations from proceeding to sea, provided that there has been no communication between such vessel and the shore or with any other vessel in the port.
- 7. If the vessel be at anchor within port limits when such disease first breaks out or such death occurs, the master shall promptly give information to the Port Officer.
- 8. The pilot or other boarding officer shall promptly report to the Port Officer the circumstances of the case brought to his notice in accordance with Rule 2, and the Port Officer shall immediately forward any report so made to the Health Officer.
- 9. Whenever the Health Officer receives the notice referred to in Rule 8 he shall without unnecessary delay proceed on board and examine the vessel, and the master shall give him every facility for the examination of the passengers and crew. The inspection by the Health Officer will ordinarily take place between sunrise and sunset.
- On the completion of the inspection prescribed by Rule 9 such of the passengers and crew as are found to be free from sleeping sickness shall be allowed to land.
- If a case of sleeping sickness occurs on any vessel after she has entered dock or has been moored at a wharf, the master shall forthwith cause information thereof to be given to the Dock Master or Superintendent of the wharf, who shall communicate the information to the Health Officer (through the Port Officer) and to the Superintendent of Police, and shall be responsible that the sick person is isolated as far as possible, and that free communication with the wharf is stopped until the Health Officer has inspected the vessel.

- 12. The Health Officer shall remove to a place appointed for the purpose\* in a building permanently and effectually protected from access to biting flies by means of fine wire gauze netting, every person found on board suffering from or suspected to be suffering from sleeping sickness, and every such person shall be detained for observation and treatment in the said hospital or place or any other hospital or place to which the removal of such persons may be authorized by Government and shall be isolated in such a manner as will prevent as far as possible the communication of the disease to other persons by the agency of biting flies, and shall continue to be so detained and isolated until a medical officer authorized on this behalf by Government certifies that he is not suffering from sleeping sickness or that having suffered from the disease he has been cured.
- 13. The Health Officer shall inform the Municipal Health Officer in every case in which a person suffering or suspected to be suffering from sleeping sickness is removed under his orders to a hospital or other place within Municipal limits and in cases in which the disease has not been definitely diagnosed at the time of removal, shall also report to the Municipal Health Officer whether the diagnosis is confirmed or not.
- 14. All persons removed to hospital or kept under observation at any place shall obey and conform to the rules, regulations and orders for the time being in force at such hospital or place.

No. 4834.—It is hereby notified that Government will assemble at Mahábaleshvar on Monday the 11th October 1909.

- No. 1174-P.—The following notification issued by the Government of Madras, Local and Municipal Department, is published for general information:—
  - "Whereas the Governor in Council is satisfied that there is danger of an outbreak of plague at Tirumalai, Tirupati and Tiruchanur in the Chendragiri taluq of the North Arcot district, if pilgrims from the infected taluqs of the Salem and Coimbatore districts and other parts in the Madras Presidency and outside the Presidency declared to be infected with plague are permitted to visit those places on the occasion of the ensuing Sri Venkateswaraswani Brahmotsavam festival:
  - In exercise of the powers delegated to him under the Epidemic Diseases Act, 1897, the Governor in Council prohibits the attendance at the said festival and at Tirumalai, Tirupati and Tiruchanur, of persons from the said parts from the 16th to the 26th September 1909 and from the 10th to the 24th October 1909, and further directs that between the said dates no tickets to travel by railway shall be sold at the stations of Gudupalli, Kuppam, Mulanur and Patchur on the Madras and Southern Mahratta Railway and the stations of Singanallur, Podanur, Coimbatore, Tudiyalur, Mettupalaiyam, Mangalore, Elattur, West Hill, Calicut, Kallayi and Feroke on the South Indian Railway for the stations of Pakala, Panapakam, Chendragiri, Tirupati West, Tirupati East, Chirtanur, Renigunta, Yerpedu, Kalapasti, Yellakuru, Puttur, Taduku, Pudi, Peddapadu, Mamanduru, Settigunta and Koduru on the Madras and Southern Mahratta Railway to any person intending or believed to be intending to be present.
  - All persons proceeding to the said festival in contravention of this notification will be turned back.
  - 2. Notification No. 184-P., published on page 541 of Part I-A of the Fort St. George Gazette dated 31st August 1909, is hereby cancelled."

# JUDICIAL DEPARTMENT.

Bombay Castle, 10th September 1909.

No. 5151.—In exercise of the authority vested in him by sections 12 and 41 (1) of the Code of Criminal Procedure, 1898, the Governor in Council is pleased, until further orders,

(1) to confer all the powers conferred by the said Code on a Magistrate of the Second Class on the following gentlemen, respectively, in the Násik District, viz. :-

Mr. Budhmal Kevalchand,

Trimbak Ganesh Chandwadkar, Trimbak Baburao Pethe,

Madhavrao Narayan Joglekar, Mahamad Saheb Ahmad Saheb Khatib,

Haji Abdul Gafur Haji Ibrahim, Nilkanthrao Achyut Deshpande.

All Magisterial powers conferred under any section of the Code of Criminal Procedure, 1898, on these Magistrates in the Násik District by any previous notifications and not hereby continued, are withdrawn.

And in exercise of the authority with which he is invested under section 15 of the said Code His Excellency in Council is pleased-

(2) to direct that the following Magistrates in Násik do sit together as a Bench, viz. :-

Mr. Budhmal Kevalchand.

Trimbak Ganesh Chandwadkar,

(a) Honorary Magistrates.

Trimbak Baburao Pethe, Madhavrao Narayan Joglekar, Mahamad Saheb Ahmad Saheb Khatib, Haji Abdul Gafur Haji Ibrahim,

Nilkanthrao Achyut Deshpande.

- (b) all Stipendiary Magistrates having jurisdiction in Násik;
- (3) to invest the said Bench with the powers specified in Part II of Schedule III of the Criminal Procedure Code, 1898, as the Ordinary Powers of a Magistrate of the Second Class, and also with the following additional powers :-

(i) Power to make orders prohibiting repetitions of nuisances (section 143),
(ii) Power to make order under section 144,
(iii) Power to hold inquests (section 174),
(iv) Power to take cognizance of offences upon complaint [section 190 (1) (a)],
(v) Power to take cognizance of offences upon Police reports [section 190 (1) (b)],

(vi) Power to make order as to first offenders (section 562);

- (4) to direct that, except only in the following classes of cases, viz. ;-Offences punishable under-
  - (a) Chapter VII, Indian Penal Code (concerning the Army and Navy), (b) Chapter VIII, Indian Penal Code (against Public Tranquillity),
    (c) Chapter IX, Indian Penal Code (by or relating to Public Servants),
    (d) Chapter XV, Indian Penal Code (relating to Religion),

(e), Offences designated in column 8 of Schedule II to the Code of Criminal Procedure. 1898, as triable exclusively by the Court of Sessions,

the said Bench shall, within the limits of the Násik City Municipal District, as defined by Government Notification No. 1631 of 11th June 1874, exercise all the powers hereinbefore conferred on them, in all cases transferred to them for trial by the Magistrate of the District or by the Sub-Divisional Magistrate, to whom, subject to the general control of the Magistrate of the District, they are subordinate.

The Governor in Council is further pleased, under section 261 of the said Code,-

- (5) to empower the said Bench to try in a summary way all or any of the offences specified in the said section as being so triable;
- (6) to authorise the said Bench to prepare all records required by section 263 of the said Code and all judgments required by section 264 of the said Code by means of an officer appointed in this behalf by the Sub-Divisional Magistrate, Násik Čity.
