NOTIFICATIONS.

"FINANCE DEPARTMENT.

LEAVE AND LEAVE ALLOWANCES.

No. 5246-P., dated Simla, the 18th October 1909.

RESOLUTION-By the Government of India, Finance Department.

The rules appended to this Resolution, which have been approved by His Majesty's Secretary of State for India, regulate the grant of study leave (1) to officers of the Geological Survey of India and the Indian Civil Veterinary Department in supersession of the existing orders on the subject, and (2) to officers of Scientific and Technical Departments for which no rules have yet been drawn up to facilitate study or visits to works. The orders do not apply to officers of the Indian Medical Service, the Public Works Department, and the Indian Educational Service, who will continue to be subject to the rules now in force as regards their respective departments. In the case of officers of the Indian Forest Service the orders regarding the study of Forestry in Europe contained in the Resolution of the Government of India in the Revenue and Agriculture Department, No. 4-F.,* dated the 13th February 1892, as amended by the Resolution of the Government of India in the same Department, No. 2-F., dated the 18th January 1894, will remain

in force, but in special cases, where those orders are not suitable for application, officers of the Indian Forest Service may be granted study leave by the Government of India under the rules appended to this Resolution.

Ordered that this Resolution be published in the Gazette of India.

Rules for the grant of Study Leave to Officers of Scientific and Technical Departments.

The following rules relate to study leave only. They are not intended to meet the case of officers deputed to other countries at the instance of Government either for the performance of special duties imposed upon them, or for the investigation of specific problems connected with their technical duties. Such cases will continue to be dealt with on their merits under the provisions of Article 85 of the Civil Service Regulations, and it will be for the Government of India to decide on the recommendation of the Local Government or the Head of the Department, as the case may be, whether an officer shall be placed on deputation (with the approval of the Secretary of State) or granted study leave in accordance with the following rules. The rules do not apply to officers of the Indian Educational Department, the Indian Medical Service, the Public Works Department, and the Indian Forest Service except in special cases where the existing rules regarding the study of Forestry in Europe on furlough are not suitable for application.

RULES.

1. Extra furlough for the purpose of study leave may be granted to officers by the Government of India on the recommendation of the Head of the Department or of the Local Government under whom the officer applying for leave is serving. The Government of India will require to be satisfied in each case that the knowledge sought to be acquired is of sufficient importance to warrant the grant of study leave. Such leave will not ordinarily be granted to officers of less than five years' service, or to officers within three years of the date at which they have the option of retiring on pension.

NOTE.-Extra furlough for the purpose of study may be granted by the Government of India on the recommendation of the Director to any graded officer of the Geological Survey who has completed more than three and less than 18 years' service.

2. The total period of study leave granted during an officer's service will not exceed 12 months in all.

3. Study leave will not be granted more than twice in an officer's service. This restriction, however, does not apply to an officer who has part of his furlough converted into study leave under rule 8.

4. The minimum period of leave granted solely as study leave will be six months. The time spent on the journey to and from India by an officer whose study leave has not been combined with any other kind of leave will reckon as study leave, but the lodging allowance specified in rule 9 will be granted during the period of study only.

5. Study leave can be combined with any other kind of leave, provided that the period occupied in study is not less than two months, and that in the case of leave on medical certificate the Medical Board at the India Office certifies that the officer is fit for study. The total period of absence from India will be limited to two years unless an extension beyond that period is necessary on grounds of health, and is otherwise admissible under the leave rules. Further, when study leave is combined with any other kind of leave, the total period of such combined leave must not, except in special cases, be less than six months.

6. An officer whose study leave is combined with any other kind of leave will be required to take his period of study leave at such a time as to retain, at its conclusion, a balance of other previously sanctioned leave sufficient to cover his return journey to India.

7. Except as provided in rule 8, all applications for study leave shall be submitted with the audit officer's certificate to the Head of the Department through the prescribed channel, and the course or courses of study contemplated and any examination a candidate proposes to undergo, shall be clearly specified therein.

8. Officers on furlough or other leave who wish to have part of it converted into study leave should address the Under Secretary of State, India Office, and should attach a statement showing how they propose to spend the study leave. Similarly officers on furlough or other leave who desire to have it extended for purposes of study should address the Under Secretary of State, but in addition to the statement of the proposed study, they must support their applications with documentary evidence of their having obtained the approval of the authorities concerned in India to their applying for an extension of leave.

9. A lodging allowance at the rate of 6s. a day will be granted for the period spent in prosecuting a definite course of study at a recognised institution or in any definite tour of inspection

of any special class of work. Special cases, in which on account of exceptional circumstances a higher rate of lodging allowance, or the grant of travelling expenses in addition to lodging allowance, is considered necessary, will be referred to the Secretary of State for his orders.

10. On completion of study, the certificates of examinations passed or the certificates of special study, which must show the dates of commencement and termination of the course, with any remarks by the instructor, shall be forwarded to the Under Secretary of State, India Office. In the case of definite courses of study at a recognised institution the lodging allowance will be payable at the India Office on claims submitted by the officer from time to time, supported by proper certificates of attendance. When the programme of study approved by the Government of India under rule 7 above does not include or does not consist entirely of such a course of study, the officer shall submit to the India Office a diary showing how his time has been spent, and a report indicating fully the nature of the methods and operations which have been studied, and including suggestions as to the possibility of applying such methods or operations to India. The Secretary of State will decide whether the diary and report show that the time of the officer has been properly employed, and will determine accordingly for what period the lodging allowance referred to in rule 9 above may be granted.

11. Study leave will count as service for promotion and pension, but except so far as it may be taken during privilege leave not for furlough or any other leave. It will not affet any leave which may already be due to an officer; it will count as extra furlough, and will not be taken into account in reckoning the aggregate amount of furlough taken by the officer towards the maximum period of six years admissible under Article 299 of the Civil Service Regulations.

12. An officer on privilege or combined leave may be permitted to commence a course of study before the end of his privilege leave, and to count the period of privilege leave so spent as part of his study leave without forfeiting his privilege leave allowance during such period. With this exception an officer, during study leave, will draw furlough pay. If he is a military officer in civil employ he will be entitled to draw furlough pay at civil rates for a portion of his study leave equal to one-twelfth of his service under civil rules, and for the remainder either (1) at the military rate, or (2) if furlough is due to him under civil rules, at the rate admissible under those rules; in the latter case a corresponding portion of the ordinary furlough earned under civil rules which is at his credit will be treated as if it had been earned under military rules.

13. On an application for study leave being sanctioned the Government of India will inform the India Office of the particulars of the case and it will be necessary for the officer concerned to place himself in communication with the Secretary of State who will arrange any details and issue any letters of introduction that may be required.

No. 979, dated Simla, the 22nd October 1909.

With reference to Army Department Notification No. 865,* dated the 11th September 1909, publishing the draft of a notification which it is proposed to issue in exercise of the powers conferred by sections 25, 26 and 27 of the Cantonments Act, 1889 (XIII of 1889), and in modification of Army Department Notification No. 941, dated the 8th October 1909, notice is given that the said draft will be taken into consideration by the Governor-General in Council on or after the 11th day of January 1910, instead of on or after the 11th day of November 1909 as previously notified.

Any objection or suggestion which may be received from any person with respect to the draft before the date fixed aforesaid, will be considered by the Governor-General in Council.

No. 1324-r.—The following notification issued by the Government of Madras, Local and Municipal Department, is published for general information :—

"Whereas the Governor in Council is satisfied that there is danger of an outbreak of plague at Hosabettu village (Manjeshwar) in the Kasargod taluq of the South Canara district, if pilgrims are permitted to visit that place on the occasion of the ensuing Shashti festival:

In exercise of the powers delegated to him under the Epidemic Diseases Act, 1897, the Governor in Council prohibits pilgrimage to the said festival from the 4th to the 18th December 1909, inclusive, and further directs that, between the said dates, no tickets to travel by railway shall be sold within the South Canara district for the station of Manjeshwar on the South Indian Railway to any person intending, or believed to be intending, to be present at the said festival.

All persons proceeding to the said festival in contravention of this notification will be turned back."

No. 75.—The following amendments made by the Trustees of the Port of Bombay under section 73 of the Bombay Port Trust Act, 1879 Bom. VI of 1879), in the By-laws of the Bombay Port Trust, and published by them in Part II of the Bombay Government Gazette of the 12th, 19th and 26th August 1909, have been approved by Government with effect from the 1st of October 1909 and are published in accordance with the provisions of the said Act :—

Amendments.

(1) After No. 25 of the By-laws for the Storage of Merchants' Gunpowder and other Explosives, the following shall be inserted :---

"25A. No keg or barrel containing more than 25 pounds of gunpowder shall be received into the Magazine."

(2) For the scale of rates for the wharfage, landing and storage of gunpowder and other explosives following No. 42 of the said By-laws the following shall be substituted :--

JUDICIAL DEPARTMENT.

Bombay Castle, 26th October 1909.

No. 5997.—In exercise of the powers conferred by section 51 of the Provincial Insolvency Act, 1907 (III of 1907), the Governor in Council is pleased to sauction the following rules framed by the High Court of Judicature at Bombay under the said section for carrying into effect the provisions of the said Act, namely :—

Rules.

I. These Rules may be called "The Bombay Provincial Insolvency Rules, 1909", and shall apply to all proceedings under the Provincial Insolvency Act, 1907, in any Court subordinate to the High Court of Judicature at Bombay. They shall come into force on the 1st day of December 1900 and shall apply to all proceedings thereafter instituted and, as far as may be, to all proceedings then pending.

II. The forms mentioned in these rules are the forms in the Appendix hereto and shall be used with such variations as circumstances may require.

III. (1) In these rules unless there is anything repugnant in the subject or context,

"the Act " means the Provincial Insolvency Act, III of 1907;

"the Court" includes a Receiver when exercising the powers of the Court in accordance with Section 52 of the Act;

"Receiver" means a Receiver appointed by the Court under Section 18 (1) of the Act ;

"Interim Receiver" means a Receiver appointed by the Court under Section 13 (2) of the Act;

" proved debt" means the claim of a creditor so far as it has been admitted by the Court.

(2) Save as otherwise provided all words and expressions used in these Rules shall have the same meaning as those assigned to them in the Act.

Pelilions.

IV. (1) Every insolvency petition shall be entered in the Register of Insolvency Petitions to be maintained in all Courts exercising Insolvency Jurisdiction and shall be given a serial number in that Register and all subsequent proceedings in the same matter shall bear the same number.

(2) Every petition, application, affidavit or order in any proceeding under the Act or under these Rules shall be headed by a cause-title in Form No. 1.

V. (1) When an insolvency retition presented by a creditor is admitted, the creditor shall within seven days thereafter furnish a copy of the position for service on the debtor or, if there are more debtors than one, as many copies as there are debtors, and the chief ministerial officer of the Court shall sign the copy or copies if on examination he finds them to be correct.

(2) The copy shall be served together with the notice of the order fixing the date for hearing the petition on the debtor or upon the person upon whom the Court orders notice to be served.

VI. A debtor's petition shall be in Form No. 2, and a creditor's petition shall be in Form No. 3.

VII. If a debtor against whom an insolvency petition has been admitted dies before the hearing of the petition, the Court may order that notice of the order fixing the date for hearing the petition shall be served on his legal representative or on such other person as the Court may think fit in a manner provided for the service of summons.

Proof of Debls.

VIII. (i) Unless otherwise ordered all claims shall be proved by affidavit in Form No. 7 in the manner provided in Section 25 of the Act, provided that before admitting any claim the Court may call for further evidence.

(2) The affidavit may be made by the creditor or by some person authorised by him, provided that if the deponent is not the creditor, the affidavit shall state the deponent's authority and means of knowledge.

(3) As soon as may be after proof of any debt is tendered the Court shall by order in writing admit the creditor's claim in whole or in part or reject it, provided that when a claim is rejected in whole or in part the order shall state briefly the reasons for the rejection.

(4) A copy of every order rejecting a claim, or admitting it in part only, shall be sent by the Court by registered post to the person making the claim within seven days from the date of the order.

IX. In any case in which it shall appear from the debtor's statement that there are numerous claims for wages by workmen and others employed by the debtor, it shall be sufficient if one proof for all such claims is made either by the debtor, or by some other person on behalf of all such creditors. Such proof should be in Form No. 8.

Schedule of Creditors.

X. As soon as the schedule of creditors has been framed a copy thereof shall, if a Receiver has been appointed, be supplied to him, and all subsequent entries and alterations made therein shall be communicated to the Receiver.

Schemes.

XI. (1) If a debtor submits a proposal under Section 27 (1) of the Act, the Court shall fix a date for the consideration of the proposal and notice thereof together with a copy of the terms of the proposal shall be sent to every creditor who has proved.

(2) At the meeting for the consideration of the proposal the debtor shall be entitled to address the Court in person or by pleader in support of the proposal and every creditor who has proved shall be entitled in person or by pleader to question the debtor and to address the Court.

Receivers.

XII. (1) Every Receiver or interim Receiver other than an Official Receiver shall be required to give such security as the Court thinks fit.

(2) The Court shall not require an Official Receiver to give security.

XIII. The Court may remove or discharge any Receiver other than an Official Receiver, and any Receiver or *interim* Receiver so removed or discharged shall, unless the Court otherwise orders, deliver up any assets of the debtor in his hands and any books, accounts or other documents relating to the debtor's property which are in his possession or under his control to such person as the Court may direct.

(2) If an order of adjudication is annulled, the Receiver (if any) shall, unless the Court otherwise orders, deliver up any assets of the debtor in his hands and any books, accounts or other documents relating to the debtor's property which are in his possession or under his control to the debtor or to such other person as the Court may direct.

XIV. Every Receiver or *interim* Receiver shall be deemed for the purpose of the Act and of these Rules to be an officer of the Court.

XV. (1) Every application to the Court made by a Receiver of an *interim* Receiver shall be in writing.

(2) The Court may order that notice of any application by the Receiver and of the date fixed for the hearing of the application shall be sent by registered post to all creditors who have proved.

XVI. (1) The remuneration of Receivers other than Official Receivers shall be in such proportion to the amount of the dividends distributed as the Court may direct, provided that it does not exceed five per centum of the amount of the dividends.

(2) If a Receiver other than the Official Receiver has been appointed in an Insolvency in which the Court makes an order approving a proposal under Section 27 (7) of the Act, the remuneration to be paid to the Receiver shall be fixed by the Court, and the order approving the proposal shall make provision for the payment of the remuneration and shall be subject to the payment thereof.

XVII. The Receiver in making his report shall state whether in his opinion any of the facts mentioned in Section 44, Sub-section (3) of the Act exist and if the debtor makes a proposal under Section 27 (1) of the Act, the Receiver shall state in his report whether in his opinion the proposal is reasonable and is likely to benefit the general body of the creditors and shall state the reasons for his opinion.

XVIII. If the Court directs, the debtor shall furnish the Receiver or, if a Receiver has not been appointed, the Court, with a trading account, and an account showing all monies and securities paid, disposed of or encumbered, or recovered by or from the debtor or on his account and his income and the rource thereof for such period as the Receiver or, if a Receiver has not been appointed, the Court may direct, provided that the Receiver shall not without the previous sanction of the Court direct the debtor to furnish accounts for more than two years before the date of the presentation of the insolvency petition.

XIX. The Receiver shall keep a cash book and such books and other papers as are necessary to give a correct view of his administration of the estate, and shall submit his accounts at such times and in such forms as the Court may direct. Such accounts shall be audited by such person or persons as the Court may direct. The costs of the audit shall be fixed by the Court and shall be paid out of the estate.

XX. The Official Receiver shall deposit all valuable securities for safe custody with the Názir and whenever a sum exceeding Rs. 500 shall stand to the credit of any one estate, the Official Receiver shall give noise thereof to the Court, and unless it shall appear that a dividend is about to be immediately declared, he shall obtain the Court's order to invest the same in a Promissory Note of the Government of India.

Dividends.

XXI. No dividend shall be distributed by a Receiver without the previous sanction of the Court.

XXII. The amount of the dividend may at the request and risk of the creditor be transmitted to him by post.

Discharge.

XXIII. (1). An application for discharge shall not be heard until after the schedule of creditors has been framed.

(2). Every creditor who has proved shall be entitled in person or by pleader to appear at the hearing and oppose the discharge provided that he has served upon the insolvent and upon the Receiver

(if any) not less than 7 days before the date fixed for the hearing a notice stating the ground of his opposition to the discharge.

(3). A creditor who has not served the prescribed notices shall not, unless the Court otherwise directs, be permitted to oppose the discharge of the debtor; and a creditor who has served the prescribed notices shall not be permitted, unless the Court otherwise directs, to oppose the discharge on any ground not specified in the notice.

(4). At the hearing of the application the Court may hear any evidence which may be tendered by a creditor who has served the prescribed notices, or by the Receiver, and also any evidence which may be tendered on behalf of the debtor and shall examine the debtor, if necessary, for the purpose of explaining any evidence tendered and may hear the Receiver, the debtor, in person or by pleader, and any creditor, in person or by pleader, who has served the prescribed notice.

Notices.

XXIV. (1). The notices to be given under Sections 12 (2), 16 (7), 27 (1), 39 (4), 42 (3) and 44 (1) of the Act shall be published in the *Bombay Government Gazette*, in English, and, if the Court so directs, in one English and one Vernacular newspaper, and copies of the notices in English and in the language of the Court shall be affixed to the Notice-board of the Court.

(2). The notices to be given under Sections 12 (2), 27 (1), 39 (4) and 44 (1) of the Act shall be published and affixed in the manner provided in paragraph (1) of this Rule not less than 14 days before the date fixed for the hearing of the application, the consideration of the proposal, the limit of time fixed for proving claims or the hearing of the application for discharge as the case may be.

(3) Notice of the date fixed for the hearing of an insolvency petition under Section 12 (1) of the Act shall be sent by the Court by registered post, if the petition is by the debtor, to all creditors mentioned in the petition, and if the petition is by a creditor, to the debtor, not less than 14 days before the said date.

(4) Notice of the date fixed for the consideration of a proposal under Section 27 (1) of the Act shall be sent by the Court by registered post to all creditors who have tendered proof of their debts not less than 14 days before the said date.

(5) Notice of the date fixed for the hearing of an application for discharge under Section 44 (1) of the Act shall be despatched by the Court by registered post to all persons whose names have been entered in the schedule of creditors not less than 14 days before the said date.

(6) The notice to be given under Section 33 (4) of the Act shall be sent by the Receiver by registered post to all persons whose claims to be creditors have been notified but not proved not less than one calendar month before the limit of time fixed for proving claims.

(7) The notice to be given under Section 24 (3) of the Act shall be served only on the debtor and on the creditors whose names appear in the schedule of creditors and may, if the Court so directs, be served on any or all such creditors by registered post.

(3) It shall not be necessary to give notice of the date to which the hearing of a petition or of an application for discharge or the consideration of a proposal is adjourned.

Summary Administration.

XXV. When an estate is ordered to be administered in a summary manner under Section 48 of the Act, the provisions of the Act and rules shall, subject to any special direction of the Court, be modified as follows, namely :--

- (i) There shall be no advertisement of any proceedings in a local paper.
- (ii) The petition and all subsequent proceedings shall be endorsed "Summary Case."
- (iii) The notice of the hearing of the petition to the creditors shall be in Form No. 15.
- (iv) The Court shall examine the debtor as to his affairs but shall not be bound to call a meeting of creditors, but the creditors shall be entitled to be heard and to cross-examine the debtor.
- (v) The appointment of a Receiver will often not be necessary, and the Court may act under Section 23 of the Act in order to reduce the cost of the proceedings.

Imprisonment.

XXVJ. Before sentencing a debtor under the powers conferred by Section 43, clause (2), the Court shall call on the debtor to show cause why an order should not be passed against him under that section.

Costs.

XXVII. (1) All preceedings under the Act down to an including the making of an order of adjudication shall be at the cost of the party prosecuting them; but when an order of adjudication has been made, the costs of the petitioning creditor shall be taxed and be payale out of the estate.

(2) Before making an order in the insolvency petition presented by a debtor the Court may require the debtor to deposit in Court a sum sufficient to cover the costs of sending the prescribed notices of the hearing of petition.

(3) No costs incurred by a debtor of, or incidental to, an application to approve a composition or scheme shall be allowed out of the estate if the Court refuses to approve the composition or scheme.

(4) Whenever a creditor presents an insolvency petition he shall deposit in Court the sum of Rs. 150 to cover expenses. Such deposits shall be paid out of the first available assets realized.

Fresh Petition.

XXVIII. No insolvent who has had his petition dismissed shall be allowed to present a fresh petition without a special application to the Court with an affidavit stating the cause of dismissal and the grounds of such new application, and a copy of such affidavit shall be served on the opposing oreditors four clear days before the application to the Court is heard.

Inspection of Proceedings.

XXIX. All insolvency proceedings may be inspected at such times and subject to such restrictions as the Court may prescribe by the Receiver, the debtor, any creditor who has proved or any legal representative on their behalf.

Pleaders' Fees.

XXX. The fees allowed to pleaders as costs in any proceedings under the Act shall be such as are allowed under the rules of the Court for a miscellaneous proceeding.
