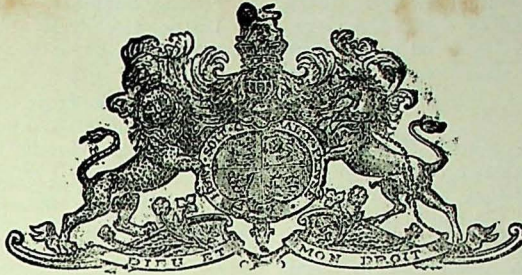

Notifications under the Bombay Local Boards and District Municipal Acts.

GENERAL DEPARTMENT.

Bombay Castle, 10th February 1898.

No. 827.—In exercise of the powers conferred by Sections 5, 7, 8 and 14 of the Bombay District Municipal Act Amendment Act, 1884, the Governor in Council is pleased to declare the local area forming the town of Máheji in the Páchora Táluka of the Khándesh District, and comprised within the limits hereinbelow described, a temporary municipal district from fifteen days before the Paush Shuddh Purnima to the 30th April in every year, and to direct that the powers and duties conferred and imposed by Bombay Act VI of 1873, as amended by Bombay Act II of 1884, on municipalities shall, in the said temporary municipal district, be respectively exercised and discharged by a municipality specially constituted for the time being, and consisting of seven commissioners, who shall be nominated by the Commissioner, C. D.

The local limits of the area to be included in the said temporary municipal district shall be as follows:—

North—Survey Nos. 10, 5 and 6 of the village of Chinchkheda; also an imaginary line across the Girna river from west to east.

South—A line running through Survey No. 84 of the same village and across the bed of the river Girna.

East—Survey Nos. 3, 2 and 1 of the same village, the village itself, and Survey No. 83 of that village.

West—The west bank of the Girna river.

dated the 18th August 1897, and duly published in the manner prescribed by Section 10 of the Bombay District Municipal Act Amendment Act, 1884, that it was proposed to alter the limits of the Dohad Municipality in the manner specified in the said Proclamation; and whereas the objections submitted to the said proposal are in the opinion of the Governor in Council insufficient, His Excellency in Council is pleased, in exercise of the powers conferred by Section 5 of the said Act, to alter the limits of the said municipal district accordingly, and to declare that the said municipal district shall, on and from the date of this Notification, be bounded in the manner hereinafter shown:—

North—Survey Nos. 33, 13, 15, 639 and 640 beyond the Railway Station.

East—Survey Nos. 619, 617, 612, 614, 493, 491, 490, 446, 445, 444.

South—The Dadhi Mati River.

West—Survey Nos. 153, 80, 75, 74, 719, 385, 45 and 44.
