Proclamation.

No. 180.—Whereas by a Proclamation No. 4342, dated the 7th September 1897, published at page 73 of the *Bombay Government Gazette* for 1897, Part I-A, in English and in the *Khāndesh Vaibhav* in Marāthi on the 8th October 1897, and posted up on the 30th September 1897 in conspicuous places situated within the limits of the Rāver

Municipality, it was duly announced, under Section 10 of the Bombay District Municipal Act Amendment Act, 1884, that it was proposed to alter the limits of the Municipal District of Rāver in the manner specified in the said Proclamation; and whereas no objections have been made to the said proposal, His Excellency the Governor in Council is pleased, in exercise of the powers conferred by Section 5 of the said Act, to alter the limits of the said municipal district accordingly, and to declare that the said municipal district shall, on and from the 15th February 1898, be bounded in the manner hereinafter shown:—

North—Survey No. 835, a road between Survey Nos. 835 and 642, Survey No. 642, a road between 642 and Survey No. 1, Survey Nos. 1, 2, a road between Survey No. 2 and Survey No. 9, Survey Nos. 9, 10, 11, 171, 172, 178, 174, 175, 179, a road between 179 and 182, and Survey No. 182.

East—Survey No. 184, a road between Survey Nos. 184 and 239, Survey No. 239, a road between Survey No. 239 and Survey No. 259, Survey Nos. 259 and 331.

South—Zodga-Asirgad Road and Survey Nos. 572 and 637.

West—Survey Nos. 633, 634, 635, and the portion of Survey No. 640, which lies to the west of the Municipal stone boundary marks.
