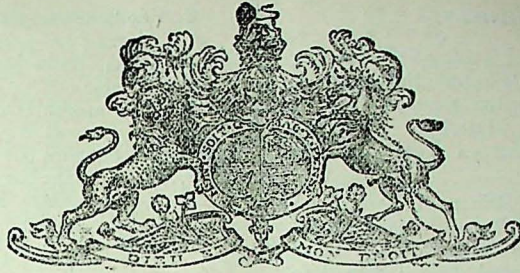

No. 2079.—In exercise of the power conferred by Section 27 of the Bombay Local Boards Act of 1884, His Excellency the Governor in Council is pleased to appoint the following officers to be Presidents of the Táluka Local Boards in the Khándesh District noted against their names :—

No. 2080.—Whereas the persons entitled to make nominations and to vote for the election of municipal commissioners for the municipal district of Sinnar have neglected to avail themselves of their electoral privileges, although duly called upon for the said purposes in accordance with the rules issued in Government Notification No. 3060, dated the 29th August 1891, His Excellency the Governor in Council is hereby pleased to declare, in exercise of the power conferred by the first clause of Section 13 of Bombay Act II of 1884, that the provisions of Sections 11 and 12 of the said Act are unsuitable to the said municipal district.

2. His Excellency the Governor in Council is further pleased to direct, under the second clause of the said section, that the Municipality in the

said municipal district shall, from the 1st instant and thereafter until further orders, consist entirely of nominated commissioners who shall be nine in number, subject to the following conditions :

- (1) that the nine commissioners shall be appointed by the Commissioner, C. D., the Assistant or Deputy Collector for the time being in charge of the Sinnar Táluka being one of the commissioners so appointed ;
- (2) that not more than six of the entire number of nine commissioners shall be salaried servants of Government ;
- (3) that three at least of the said nine commissioners shall be persons who are not salaried servants of Government.
