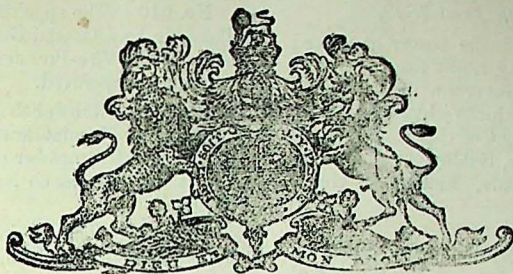

Proclamation.

No. 2309.—Whereas it was announced by a Proclamation No. 6723,* dated the 2nd December 1897, and duly published in the manner prescribed by Section 10 of the Bom-

bay District Municipal Act Amendment Act, 1884, that it was proposed to alter the limits of the Mahád Municipality in the manner specified in the said Proclamation; and whereas no objections have been made to the said proposal, the Governor in Council is pleased, in exercise of the power conferred by Section 5 of the said Act, to alter the limits of the said Municipal District accordingly, and to direct that the said Municipal District shall, on and

from the date of this Notification, be bounded in the manner hereinafter shown:

North—A line coinciding with the northern boundary of Survey Nos. 5, 6, 3, 43, 42, 57, 56, 79, 80, 81, 82 and 83 of the village of Mahád.

West—A line starting from Survey No. 146 of Mahád and passing along the eastern bank of the river Gándhari, crossing the bed of that river near the south-western point of Survey No. 5 of Mahád, then running along the eastern boundary of Survey No. 78 of the village of Pále, and then again crossing the bed of the river to join the north-eastern point of Survey No. 5 of Mahád

South—The river Sávitri.

East—A line concurrent with the eastern boundaries of Survey Nos. 84, 85, 101, the tank situated between Survey Nos. 101 and 102, and of Survey No. 102 of Mahád.
