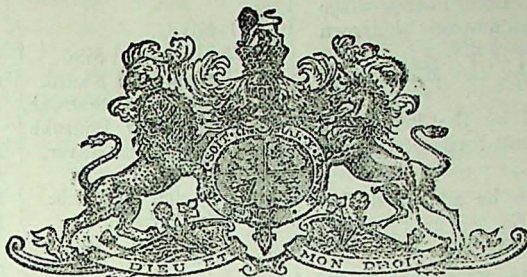

Notifications under the Bombay Local Boards and District Municipal Acts.

GENERAL DEPARTMENT.

Bombay Castle, 18th January 1898.

No. 315.—The Sávda Táluka of the Khándesh District having now been abolished and the two new tálukas of Ráver and Yával constituted in its stead, so much of the Notification No. 8248 of 20th October 1884 as relates to the Sávda Táluka is hereby declared cancelled with effect from 1st April 1898. And in exercise of the powers conferred by Sections 4, 6, 7, 8, 13, 27 and 69 of the Bombay Local Boards Act, 1884, the Governor in Council is pleased to pass the following orders with regard to the establishment of Local Boards in these two new tálukas:—

1. The members of the first Local Boards to be established under the Act in the said two tálukas of Ráver and Yával shall commence their terms of office on 1st April 1898.

2. There shall be one Táluka Local Board for each of the said two new tálukas of Ráver and Yával.

3. The constitution of each of the said Táluka Local Boards shall be as follows:—

His Excellency the Governor in Council is further pleased to declare that paragraph 7 of the said Notification No. 8248 of 20th October 1884 is hereby cancelled with effect from the 1st May 1898, and that the constitution of the District Local Board of Khándesh shall from that date be as follows:—

- 17, i.e., one to be elected by each of the Táluka Local Boards of the district from amongst their own members respectively ;
- 19 Elective Members. { 1 to be elected by the Municipality of Dhulia ;
1 to be elected by the holders of entire alienated villages within the district.

20 Nominated Members to be appointed by Government.
