## Notifications under the Bombay Local Boards and District Municipal Acts.

#### GENERAL DEPARTMENT.

Bombay Castle, 18th January 1890.

No. 315.—The Sávda Táluka of the Khándesh District having now been abolished and the two new talukas of Raver and Yaval constituted in its stead, so much of the Notification No. 8248 of 20th October 1884 as relates to the Sávda Táluka is hereby declared cancelled with effect from 1st April 1898. And in exercise of the powers conferred by Sections 4, 6, 7, 8, 13, 27 and 69 of the Bombay Local Boards Act, 1884, the Governor in Council is pleased to pass the following orders with regard to the establishment of Local Boards in these two new tálukas :-

- 1. The members of the first Local Boards to be established under the Act in the said two talukas of Raver and Yaval shall commence their terms of office on 1st April 1898.
- There shall be one Táluka Local Board for each of the said two new tálukas of Ráver and Yával
- 3. The constitution of each of the said Taluka Local Boards shall be as follows :-
