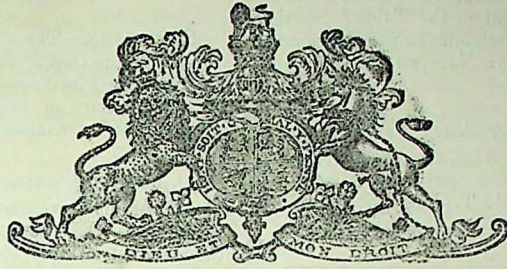

### Notifications under the Bombay Local Boards and District Municipal Acts.

#### GENERAL DEPARTMENT.

*Bombay Castle, 17th June 1898.*

No. 3468.—Whereas the term of office of the present commissioners of the Kálol Municipality terminates on the 7th July 1898; and whereas it is convenient that the term of office of the commissioners of the said municipality should be extended; His Excellency the Governor in Council is pleased, in exercise of the power conferred by Section 18 of the Bombay District Municipal Act Amendment Act, 1884 (as amended by Section 1 of Bombay Act I of 1888), to direct that the term of office of the present commissioners of the municipality aforesaid be extended to the 31st December 1898.

#### Proclamation.

No. 3492.—Whereas for the reasons hereinbelow stated the Governor in Council is pleased, under the provisions of Section 10 of the Bombay District Municipal Act Amendment Act, 1884, to announce that it is proposed to declare that the local area included within the municipal limits of Kálol in the district of Panch Maháls shall cease to be a Municipal District from the 1st January 1899.

2. All persons who entertain any objections to the said proposal should submit the same, with the reasons therefor in writing, to the Secretary to Government, General Department, Bombay, within two months from the date of the publication of this Notification.

The reasons for this proposal are—

- (1) The population of the town is 4,096 only.
- (2) The revenue is less than Rs. 4,100, and is contributed chiefly by agricultural cess-payers, and after providing for establishment and education charges, leaves a margin insufficient for sanitation and useful public works.
- (3) The substitution of a Sanitary Committee, while meeting with popular approbation, should sufficiently safeguard the public health.
