PART VI.

BILLS OF THE GOVERNMENT OF INDIA.

LEGISLATIVE DEPARTMENT.

The following Bill was introduced in the Council of the Governor General of India for the purpose of making Laws and Regulations on the 2nd September, 1898 :-

No. 8 OF 1898.

A Bill to amend the Law relating to Arbitration.

WHEREAS it is expedient to amend the law relating to arbitration by agreement without the intervention of a Court of Justice; It is hereby enacted as follows :

1. (1) This Act may be Short title, extent and called the Indian Arbitracommencement. tion Act, 1839.

(2) It extends to the whole of British India; and

(3) It shall come into force at once.

This Act shall apply only in cases where, if the subject-matter sub-Application. mitted to arbitration were

the subject of a suit, the suit could be instituted in a Presidency-town:

Provided that the Local Government may, by notification in the local official Gazette, declare this Act applicable in any other local area as if it were a Presidency-town :

repealed as regards any local area to which this Act may hereafter be applied by notification under the last foregoing section, with effect from the date of such notification :

Provided that nothing in this Act shall affect [52 and 53 y arbitration pending in a Presidency-town at its s. 25.] any arbitration pending in a Presidency-town at its commencement or in any local area at the date of its application as aforesaid, but shall apply to every arbitration commenced after the commencement of this Act or the date of its application, as the case may be, under any agreement previously made.

- (a) "the Court" means, in the Presidencytowns, the High Court and, elsewhere, the Court of the District Judge; and
- (b) "submission" means a written agreement to submit present or future differences to arbitration, whether an arbitrator is named therein or not.

5. A submission, unless a different intention is [Ibid., s. 1.] Submission to be irrevoc- expressed therein, shall be able except by leave of Court. by irrevocable, except leave of the Court.

6. A submission, unless a different intention [Ibid., s. 2.] Provisions implied in is expressed therein, shall submissions. be deemed to include the provisions set forth in the first schedule, in so far as they are applicable to the reference under submission.

7. The parties to a submission may agree that the reference shall be to Reference to arbitrator appointed by third person. an arbitrator or arbitrators to be appointed by a person designated therein.

The parties to a submission may agree that any dispute arising between them in respect of the subject-matter of the submission shall be referred to an arbitrator appointed by the Calcutta Chamber of Commerce.

ourt in 8. (1) In any of the point an following cases:

- (a) where a submission provides that the reference shall be to a single arbitrator, and all the parties do not after differences have arisen, concur in the appointment of an arbitrator;
- (b) if an appointed arbitrator refuses to act, or is incapable of acting, or dies, and the submission does not show that it was intended that the vacancy should not be supplied, and the parties do not supply the vacancy;
- (c) where the parties or two arbitrators are at liberty to appoint an umpire or third arbitrator and do not appoint him;
- (d) where an appointed umpire or third arbitrator refuses to act or is incapable of acting or dies, and the submission does not show that it was intended that the vacancy should not be supplied, and the parties or arbitrators do not supply the vacancy;

any party may serve the other parties or the arbitrators, as the case may be, with a written notice to appoint an arbitrator, umpire or third arbitrator.

(2) if the appointment is not made within seven clear days after the service of the notice, the Court may, on application by the party who gave the notice, appoint an arbitrator, umpire or third arbitrator, who shall have the like power to act in the reference and make an award as if he had been appointed by consent of all parties.

(1b11., r. 6.] 9. Where a submission provides that the Power for parties in certain cases to supply achieved arbitrators, one to be appointed by each party, then, unless a different intention is expressed therein,—

> (1) if either of the appointed arbitrators refuses to act, or is incapable of acting, or dies, the party who appointed him, may appoint a new arbitrator in his place;

> (2) if, on such a reference, one party fails to appoint an arbitrator, either originally or by way of substitution as aforesaid, for seven clear days after the other party, having appointed his arbitrator, has served the party making default with a written notice to make the appointment, the party who has appointed an arbitrator, may appoint that arbitrator to act as sole arbitrator in the reference, and his award shall be binding on both parties as if he had been appointed by consent:

> Provided that the Court may set aside any appointment made in pursuance of this section.

10. (1) The arbitrators or umpire acting under [52 & 53 a submission shall, unless Vict., c. 49, a different intention is 22.] expressed therein,—

- (a) have all the powers of a Civil Courter in respect of the summoning and examining of witnesses and the issuing of process for the production of documents;
- (b) have power to state a special case for the opinion of the Court on any question of law involved; and
- (c) have power to correct in a submission or award any clerical mistake or error arising from any accidental slip or omission.

(2) Every proceeding before an arbitrator or XLV of 1880. arbitrators under this Act shall be deemed to be a judicial proceeding with the meaning of the Indian Penal Code.

11. (1) When the arbitrators or umpire have [XIV of 1882, Award to be signed and filed. Award to be signed and filed. thereto or any person claiming under him, cause it, or a signed copy of it, to be filed into the Court, and notice of the filing shall be given to the parties to the submission.

(2) Where the arbitrators or umpire state a [*Ibid.*, s. 17.] special case under Section 10, sub-section (1), clause (b), the Court shall deliver its opinion thereon; and such opinion shall be added to, and shall form part of, the award.

12. The time for making an award may, from [52 & 23, Power for Court to time to time, be enlarged Viet., c. 49, s. enlarge time for making by order of the Court, 9.] award. whether the time for making the award has expired or not.

13. (1) The Court may from time to time remit [*Ibid.*, s. 10.] Power to remit award. the award to the reconsideration of the arbitrators or umpire.

(2) Where an award is remitted under subsection (1), the arbitrators or umpire shall, unless the Court ortherwise directs, make a fresh award within three months after the date of the order remitting the award.

14. (1) An award on a submission, on being filed [*Ibid.*, s. 42.] Award when filed to be enforceable as a decree. forceable as if it were a decree of the Court :

Provided that, where an arbitrator or umpire [*Ibid.*, s. 11 has misconducted himself, or an arbitration or (2).] award has been improperly procured, the Court may set aside the award.

(2) An award may be conditional or in the alternative.

Illustration.

A dispute concerning the ownership of a diamond ring is referred to arbitration. The award may decree that the party in possession shall pay the other party rupees one thousand, the said sum to be reduced to rupees five, if the ring is returned within fourteen days.

17. The forms set forth in the second schedule, or forms similar thereto, Forms. with such variations as the circumstances of cach case require, may be used for the respective purposes there mentioned, and, if used, shall not be called in question.

18. The High Court Power for High Court to make rules. may make rules consistent with this Act as to-

- (a) the filing of awards and all proceedings consequent thereon or incidental thereto;
- (b) the filing and hearing of special cases and all proceedings consequent thereon or incidental thereto; and,
- (c) generally, all proceedings in Court under this Act.

THE FIRST SCHEDULE.

Provisions to be implied in submissions.

If no other mode of reference is provided, the reference shall be to a single arbitrator.

II. If the reference is to two arbitrators, the two arbitrators may appoint an umpire at any time within the period during which they have power to make an award.

III. The arbitrators shall make their award in writing within three months after entering on the reference, or after having been called on to act by notice in writing from any party to the submission, or on or before any later day to which the arbitrators, by any writing signed by them, may from time to time enlarge the time for making the award.

IV. If the arbitrators have allowed their time or extended time to expire without making an award, or have delivered to any party to the submission, or to the umpire, a notice in writing stating that they cannot agree, the umpire may forthwith enter on the reference in lieu of the arbitrators.

V. The umpire shall make his award within one month after the original or extended time appointed for making the award of the arbitrators has expired, for on or before any later day to which the umpire, by any writing signed by him, may from time to time cularge the time for making his award.

VI. The parties to the reference, and all persons claiming through them respectively, shall, subject to the provisions of any law for the time being in force, submit to be examined by the arbitrators or umpire on oath or affirmation in relation to the matters in dispute, and shall, subject as aforesaid, produce before the arbitrators or unpire all books, deeds, papers, accounts, writings and documents within their possession or power respectively which may be required or called for, and do all other things which during the proceedings on the reference the arbitrators or umpire may require.

VII. The witnesses on the reference shall, if the arbitrators or umpire think fit, be examined on oath or affirmation.

VIII. The award to be made by the arbitrators or umpire shall be final and binding on the parties and the persons claiming under them respectively.

IX. The costs of the reference shall be in the discretion of the arbitrators or umpire, who may direct to and by whom, and in what manner, those costs or any part thereof shall be paid, and may tax or settle the amount of costs to be so paid or any part thereof, and may award costs to be paid as between solicitor and client.

STATEMENT OF OBJECTS AND REASONS.

THIS Bill has been drawn on the lines of the English Arbitration Act of 1880, and is the outcome of certain representations received from the Chambers of Commerce at Rangoon, Karáchi and Cawnpore. The proposal thus made has been circulated for opinion and has elicited very general support, including that of the Beugal, Madras and Bombay Chambers of Commerce, the Bengal National Chamber of Commerce and the British Indian Association.

The case for legislation is based upon the inadequacy of the existing law. The provisions on the subject, which are now to be found in the Contract and Specific Relief Acts, amount to this, that, if a person who has contracted to refer to arbitration any dispute that may arise between him and another, refus s to do so, his contract will be a bar to his afterwards bringing a suit in respect of the matter which he originally agreed so to refer. These provisions are, however, of a negative kind and ineffective in practice, for the recusant party has, as a rule, only to remain inective in order to rehe. ond the reach of the other party. The Code of Civin Procedure, no doubt, aims at wh t is required, but the sections in point are defective in that-

(1) they have been held to apply only to disjutes which have arisen at the time of the agreement to refer, and not to disputes which may arise in the future ; and

(2) they require the agreement to refer either to name the particular arbitrator or to leave the Court to appoint one.

3. The first of these defects has been to some extent removed by the recent Full Bench ruling of the Bombay High Court in the case of Fazulbhoy Mehrali Chinoy v. The Bombay and Persia Steam Navination Company, Limited, I. L. R. 20 Bom. 232, in which it was held that the Code does apply to future disputes. But the second defect remains, with the result that the case of an agreement to refer, for example, "to the arbitration of a person to be nominated by the Bengal Chamber of Commerce," is appar-'is apparently unprovided for. Moreover, it is uncertain whether the other High Courts will follow the Bombay Judges, while the ruling of the latter itself shows that the provisions of Chapter XXXVII of the Code, which it is proposed to supersede, require revision in view of the many conflicting decisions regarding them which are to be found in the Law Reports.

4. The measure is drawn so as to apply in the first instance to the Presidency-towns alone and to be ca able of further extension should that be deemed desirable.


