THE CHARITABLE ENDOWMENTS ACT, 1890.

IN THE MATTER OF THE KHA'N BAHA'DUR PESTONJI SORABJI CHARITABLE DISPEN-SARY FUND IN CONNECTION WITH THE CHARITABLE DISPENSARY AT POONA.

Scheme.

Whereas in the year 1861 a fund was raised by the friends and admirers of the late Khán Bahádur Pestonji Sorabji consisting of Rs. 10,500 ten thousand and five hundred which was supplemented by Rs. 7,000 seven thousand rupees contributed by the said Khán Bahádur Pestonji Sorabji himself and his son the late Sardár Khán Bahádur Padamji Pestonji, both of which sums were, in accordance with the wishes of the said donors, to be applied to the Charitable purposes of a Dispensary in Poona City known as the Khán Bahádur Pestonji Sorabji charitable Dispensary, Poona, and to be held in Trust as a Fund for the endowment of the said Dispensary ; And whereas the aggregate of the said sums, viz. Rs. 17,500, so forming the said Fund, has been invested in Government of India Stock Certificate of the $3\frac{1}{2}$ per cent. Loan of 1865, bearing the No. $\frac{13}{123}$ of the nominal value of Rs. 17,500 and standing in the name of the Accountant General, Bombay;

And whereas the persons acting in the administration of the said trust being the Collector and Magistrate of Poona, Khán Bahádur Dorabji Padamji, the Civil Surgeon, Poona, the City Magistrate, Poona, the Assistant Collector in charge, Haveli Táluka, Ráo Bahádur K. V. Raste, and Ráo Sáheb Ganpatrao Vinayak Sanglikar and the Accountant General, Bombay, applied under

Section 6 of the Charitable Endowments Act, 1890, for an order vesting the said security in the Treesurer of Charitable Endowments upon the terms mentioned in the said application and set out in the recital hereinafter appearing ;

Raste, and Ráo Sáheb Ganpatrao Vinayak Sanglikar, and the Accountant General, Bombay, heretofore acting in the administration of the said Trust, have applied to the Government of Bombay to settle a scheme for the administration of the said property; And whereas the following scheme has been settled by

the Governor of Bombay in Council with the concorrence of the said persons so acting as aforesaid :

Now under Section 5 of the Charitable Endowments Act, 1890, it is hereby declared that the following scheme has been settled and shall come into operation from the date the securities so as aforesaid became vested in the Treasurer of Charitable Endowments for the Bombay Presidency :-

Scheme.

The annual income of the property so as afore-said vested in the Treasurer of Charitable Endowments for the Bombay Presidency shall be administered by the Collector and District Magistrate, Poona, for the time being, that is to say, by each person successively exercising the functions of the office of Collector and District Magistrate, Poona, and shall be by him applied when received to the support of the Khán Bahádur Pestonji Sorabji Charitable Dispensary, Poona, by transferring, pay-ing or handing the same to Her Majesty's Accountant General, Bombay, for the time being, for the purpose of being credited or disposed of by him towards the cost of the maintenance of the said Dispensary and a certificate under the hand of the said Accountant General for the time being that the said income so paid has been so credited or disposed of shall be a sufficient and good discharge to the said person administering the Fund as aforesaid in respect of the execution of the said Trust and the due administration of the said Trust moneys by him.

To-The Secretary, Chamber of Commerce, Madras, Bombay,

I am directed by His Excellency the Governor General in Council to request that the Chamber of Commerce will be good enough to favour the Government of India with an expression of their opinion upon a proposal to take power from the Legislature to raise the limit of the paper currency reserve, which is held in Government securities, from eight to ten crores of rupces.

2. The maximum limit of the invested reserve was raised on the last occasion in 1890 from six to eight crores by Act XV of 1890, and in accordance with the requirements of the Currency Act the

increases to the investment from time to time were separately notified, the limit of the investment having been raised to seven crores by the Notification in this Department No. 5900,* dated 19th December 1890, and to eight erores by the Notification No. 4861, dated 3rd December 1891.

3. The considerations involved in the question of an increase in the currency investment were fully discussed in 1890, and the history of the subject was brought down to 1889 in my letter to the Chambers of Commerce, No. 6468, dated 23rd December 1889, a copy of which is enclosed. The following table gives the figures of the circulation of paper currency for all India from 1887-88:

The above figures indicate that the total circulation of currency notes has steadily increased since the year 1887-88 and has now reached a figure about double that of the year 1889-00. But the Government of India are of opinion that these figures of total circulation show the increase as larger than can be considered to be the normal increase which may, with due regard to the caution desirable in the discussion of the question now under consideration, be counted on as certain to continue. In the first place, the Government balances during the past two years have been unusually high and a great portion of the excess balances, held in the Government Reserve Treasuries in currency notes, is included in the circulation. Secondly, the figures include the notes held by the Presidency Banks at their head offices, but the demands for encashment of notes so held are occasionally so large that a considerable portion of them cannot be treated as permanently in circulation.

4. On the grounds above explained, it is considered that for the present purpose it is desirable, in order to prevent all risk of over-estimating the permanent circulation, to exclude the balances of currency notes in the head offices of the Presidency Banks and in the Reserve Treasuries from the total circulation. After such exclusion the figures for 1889-90 and subsequent years in the table in paragraph 3 will stand as follows:

From this table it is observed that when the last increase to the investment was discussed towards the end of 1889, the circulation (excluding balances in the Reserve Treasuries and the head offices of the Presidency Banks) amounted to only about 13 to 13½ crores, while during the three years ending 1894-95 the minimum circulation has been well above 18 crores.

5. On a consideration of the figures given above, it appears to the Government of India that the circulation of currency notes has now attained a level about 50 per cent. higher than in the year

The 1889-90, and that it will be quite safe now to raise the limit of the investment to ten crores. figures might indeed justify an even greater increase in the investment, but the Government of India do not desire to go to the full limit of safety. An investment of the reserve to the extent of ten erores would represent only about 50 per cent, of the average circulation as given in paragraph 4. The pro-posed increase would therefore appear to leave a fully sufficient margin to secure the immediate convertibility of the note even during a commercial crisis. and securities, the general credit of Government is pledged for the con-

vertibility of the note under section 21 (1) of the Paper Currency Act.

6. The proposal which His Excellency the Governor General in Council is disposed to make now is to take power from the Legislature to increase the limit of the investment from eight to ten crores, and for the reasons above explained, he considers, subject to the opinions he may receive from the Presidency Banks and the Chambers of Commerce, that this power may be used with safety on some convenient occasion when it may be possible to carry out the operation without affecting the public market.

7. I am to say that His Excellency in Council will be glad to be favoured with the views of the Chamber as early as may be convenient.

The above figures indicate that the total circulation of currency notes has steadily increased since the year 1887-88 and has now reached a figure about double that of the year 1889-90. But the Government of India are of opinion that these figures of total circulation show the increase as larger than can be considered to be the normal increase which may, with due regard to the caution desirable in the discussion of the question now under consideration, be counted on as certain to continue. In the first place, the Government balances during the past two years have been unusually high and a great portion of the excess balances, held in the Government Reserve Treasuries in currency notes, is included in the circulation. Secondly, the figures include the notes held by the Presidency Banks at their head offices, but the demands for encashment of notes so held are occasionally so large that a considerable portion of them cannot be treated as permanently in circulation.

4. On the grounds above explained, it is considered that for the present purpose it is desirable, in order to prevent all risk of overestimating the permanent circulation, to exclude the balances of currency notes in the head offices of the Presidency Banks and in the Reserve Treasuries from the total circulation. After such exclusion the figures for 1889-90 and subsequent years in the table in paragraph 3 will stand as follows:

From this table it is observed that when the last increase to the investment was discussed towards the end of 1889, the circulation (excluding balances in the Reserve Treasuries and the head offices of the Presidency Banks) amounted to only about 13 to $13\frac{1}{2}$ erores, while during the three years ending 1894-95 the minimum circulation has been well above 18 erores.

5. On a consideration of the figures given above, it appears to the Government of India that the circulation of currency notes has now attained a level about 50 per cent. higher than in the year 1889-90, and that it will be quite safe now to raise the limit of the investment to ten crores. The figures might indeed justify an even greater increase in the investment, but the Government of India do not desire to go to the full limit of safety. An investment of the reserve to the extent of ten crores would represent only about 50 per cent. of the average circulation as given in paragraph 4. The proposed increase would therefore appear to leave a fully sufficient margin to secure the immediate convertibility of the note even during a commercial crisis. As previously explained in paragraph

6. The proposal which His Excellency the Governor General in Council is disposed to make now is to take power from the Legislature to increase the limit of the investment from eight to ten crores, and for the reasons above explained, he considers, subject to the opinions he may receive from the Presidency Banks and the Chambers of Commerce, that this power may be used with safety on some convenient occasion when it may be possible to carry out the operation without affecting the public market.

7. I am to say that His Excellency in Council will be glad to be favoured with the views of the Directors as early as may be convenient.

I am directed by His Excellency the Governor General in Council to request that the Chamber of Commerce, Madras will be good enough to favour the Government of India with an expression of its opinion upon a proposal to increase the portion of the paper currency reserve which is invested in Government securities.

2. When the issue of a Government paper currency was first considered by the Government of India in 1860, it was proposed to fix the limit of the portion of the reserve which might be invested in Government securities at a fixed proportion—two-thirds—of the value of notes in circulation. But it was decided that the safer and sounder principle was to prescribe a fixed sum as the limit, that sum being somewhat less than the smallest aggregate amount of notes which experience had proved to be necessary for the monetary transactions of the country. It was considered that notes to this amount at least would always be outstanding, and that consequently it would not be necessary to keep coin in reserve for the purpose of cashing them. When this principle was adopted it was contemplated that it would be necessary to vary the limit in accordance with the circumstances of the times, and that the maximum sum that might be invested in Government securities would be fixed from time to time by legislation. In the Paper Currency Act of 1861, the sum to be so invested was fixed at four crores of that just was fixed, and that the investment in Government securities bore a much smaller propor-

tion to the total reserve than when the Act of 1861 was first brought into operation, the limit was raised to six crores. The minimum circulation of each year from 1862 to 1870 will be found in the statement appended. The maximum limit of investment in Government securities is still six crores of rupees.

3. Since 1870 the note circulation has greatly increased, as will be seen from the statement attached. In that year the minimum circulation was about eight and three-quarter crores of rupees, but since 1880-81 the minimum circulation has never fallen as low as 12 crores; for the last five years the minimum has exceeded 13 crores; and in the present year it approaches 16 crores. There is no reason to doubt that the minimum circulation in the future will continue to be at least 50 per cent. in excess of the minimum of 1870. With a minimum circulation in the present year of say $15\frac{2}{4}$ crores, the investment of the reserve remaining at six crores, the sum held in coin and bullion amounts to about nine and three-quarter crores.

4. The primary consideration in dealing with this question must be the necessity of securing the immediate convertibility of the note under all circumstances to which we can reasonably look forward. His Excellency in Council has no doubt that the reserve held in coin and bullion at the present time is more than sufficient to secure convertibility under all ordinary conditions, and the question to be decided is whether or not it is necessary to maintain the present high rate of reserve with a view to possible difficulties of the future which may never arise. In connection with this aspect of the case, I am to call the attention of the Chamber to section 21 (1) of the Paper Currency Act, 1882, under which the general credit of Government is pledged for the convertibility of the note. The currency reserve would, therefore, be supplied in case of need by the cash balance at the disposal of the Government of India, and the note would not cease to be convertible, even if the currency reserve was exhausted, so long as the Government of India could spare funds from the general cash balance at its disposal. The proposal which has been under the consideration of the Government of India is to take power from the Legislature to increase the amount of the invested reserve to eight crores of rupees, but it is not intended for the present to increase the investment by more than one crore, any further increase up to the limit of eight crores being made only if and when circumstances are favourable; and it is possible that even the increase of one crore might not be made for some time.

5. I am to say that His Excellency in Council will be glad to be favoured with the views of the Chamber as early as may be convenient.

I am directed to acknowledge the receipt of your letter No. 5318-A. of the 7th instant, with accompaniment, and in reply to say that the subject-matter thereof having received the careful consideration of the Committee of the Bombay Chamber of Commerce, the proposal to take power from the Legislature to raise the limit of the paper currency reserve from eight to ten crores of rupees meets with their entire approval, and the Committee will be glad to learn that early legislative action has been taken to give it effect.

In compliance with the request made in your letter No. 5319-A. of 7th instant my Directors have considered the proposal to raise from eight to ten crores of rupees the limit fixed for investment in Government securities of the coin and bullion held as the paper currency reserve, and I have now to submit the views they have adopted.

It is understood that in determining the proportion of the reserve that may be invested in securities, the Government of India are guided to a great extent by the principle followed in the Bank of England Act of 1844, viz., that the amount of notes issued on Government securities shall be maintained at a fixed sum well within the limit of the smallest amount which experience has proved to be necessary for the monetary transactions of the country, and that all additional notes issued shall be backed by an equivalent amount of coin or bullion. This principle is a safe guide in a country like England where a fairly accurate estimate can be formed of the lowest point to which the circulation is ever likely to fall; but in India, the general mass of the people have little confidence in paper money, and it is difficult to say where a run on the reserve might stop.

There is, therefore, under the present method of regulating the fiduciary issue, a possible danger that Government may at times be tempted for the sake of profit to invest in securities a larger proportion of the note reserve than is consistent with safety : but my Directors are pleased to observe that on this as on former occasions the Government of India, in estimating from past experience the smallest future issue, allow a wide margin for possible fluctuations. An investment of the reserve to the extent of ten erores would represent only about 54 per cent of the minimum circulation of the last three official years excluding the balances of the Reserve Treasuries and the head offices of the Presidency Banks. The proposed increase of securities in the paper currency reserve should therefore leave a stock of coin and bullion sufficient to ensure convertibility of the notes under all circumstances for which it appears necessary to provide.

It is also satisfactory to note that, on this as on former occasions, it is the intention in increasing the securities in the reserve to select some convenient opportunity when it may be possible to carry out the operation without affecting the public market; and no doubts would have been entertained as to the prudence of the proposed measure, were it not that the substitution of securities for coin in the paper currency reserve may interfere with the policy adopted when the Indian Mints were closed to the free coinage of silver.

As to the merits of this policy my Directors express no opinion. They assume that it is the desire of Government to raise gradually, and eventually to fix within convenient limits, our sterling exchange; and I have to point out that, as Government securities are exported and imported, the lock up of two crores of securities in the currency reserve, in whatever form it be effected, must tend to lower or to curtail a rise in sterling exchange, because it will promote imports from or curtail exports to London. The release of the coin will have a like effect on exchange; because much of the money will sooner or later enter the markets that rule the balance of foreign indebtedness. The arguments that support this view are intricated but it may suffice to say that the sterling value of the rupee currency on its present footing is regarded, or rather determined, much in the same way that the values of inconvertible paper currencies are settled: and it is generally admitted that it would be imprudent for any Government with an inconvertible paper currency of depreciated value to make additions to its circulation merely for the sake of realizing interest on these additions, especially if that Government had a heavy foreign debt bearing interest on the foreign debt might exceed the gain in interest from the addition to the money in circulation : and as the proposed substitution of securities for coin in the paper currency reserve is practically an addition to the monetary circulation made with the object of securing interest profiz, it would appear to be contrary to what is generally accepted as sound policy.

While holding these opinions regarding the effect of the proposed measure on sterling exchange, my Directors can conceive of a position of affairs arising under present currency arrangements in which the proposed increase in the monetary circulation would not only be innocuous but desirable. When a currency is interchangeable with sterling money for foreign payment purposes at or about

transit cost, as all currencies are where sterling 'exchange is fixed with convenient limits, the currency is self-regulating. Any deficiency makes it profitable for Banks to import money and any excess leads to an export of money. But in India the currency has no self-adjusting power. It has no fixed specie export point, while its fixed specie import point (1s. 4d. plus transit charges) is far beyond the present range of exchange; and this want of elasticity might create a stringency at a time when the Reserve treasury balances were low, which would best be met by an addition to the currency such as Government propose to make. The stringency might occur suddenly and require prompt relief, and, under these circumstances, I have to suggest, for the consideration of His Excel-lency the Governor General in Council, that the power contemplated should be obtained from the Legislature, but should be reserved either for use in an emergency such as above described or until the currency is made automatic. the currency is made automatic.

In reply I am directed to say that the subject of your letter has had the careful consideration of my Directors, and that they desire to express their entire approval of the proposal submitted for their opinion. The tables of figures given in your letter, and specially those contained in paragraph 4, seem to my Directors to show that this proposed increase to the Government securities in the paper currency reserve may be adopted with safety, and is as fully warranted as any previous addition which has been made to this portion of the reserve.

I have the honour, by desire of my Directors, to acknowledge receipt of your letter No. 5319-A., dated 7th ultimo, and to say in reply that they are of opinion that the cash balance held in the Currency Department may be reduced by two crores with perfect safety.

I am to say further that my Directors are of opinion that the market would be less disturbed by the transaction if the amount, instead of being invested by purchase of interest-bearing promissory notes of the Government of India in the open market, were transferred direct from the Currency to the Treasury Department, as a book debt, when next the Government have occasion to raise a loan for public works. It is presumed that the object of having a portion of the currency money invested in Government bonds is, that coin may be the more readily obtained by the sale of such bonds, which are already negotiable, rather than by the more formal procedure of the issue of a fresh loan.

My Directors are, however, of opinion that a sufficient amount of bonds for this purpose is already held, whereas if a portion were held as a book debt, the amount could at any time be retransferred from the Treasury to the Currency, and so avoid any sudden disturbance of the market by sale of bonds.

The interest-bearing promissory notes of the Government of India afford no additional security to holders of currency notes which are on demand promissory notes, and are equally secured with the other notes by the credit of the Government of India.

I have the honour to acknowledge receipt of your letter No. 531S-A., dated the 7th November 1895, asking for an expression of opinion from this Chamber upon a proposal to take power from the Legislature to raise the limit of the paper currency reserve which is held in Government securities from eight to ten crores of rupees.

In reply I have the honour to state that this Chamber sees no objection to the proposal in so far as it will affect the proportion of cash to be held in order to make good the issue of currency notes.

The view taken by the Chamber is that the Government, after mature consideration in consultation with the best authorities, can decide what proportion of cash should be held (whether one-half of the notes in circulation, or any other ratio) in order to convince the public that on presentation of the notes for payment there will be no danger of their not being paid, even in times of panic, and the Chamber is almost unanimous in thinking that there is no necessity to hold any other security as a guarantee for such payment. For instance, if the note circulation be at present twenty erores, and if ten crores be held in cash, there is no danger whatever of any fear of non-payment arising in the minds of holders of currency notes—even in a commercial crisis or a great war.

The currency note being payable on demand is not, in the opinion of this Chamber, rendered any more secure by Government holding as security for its prompt payment Government securities which are not payable on demand, or even at any time, except at the option of Government. It seems almost unnecessary to add that if the public for any reason become imbued with the feeling that Government is about to become unable to meet its engagements, and if in consequence of that feeling there is a rush to realise currency notes, then in that case Government securities, which are unredeemable, will be unsaleable, and will therefore be useless as a reserve for securing the repayment of the 'on demand' liabilities of Government.

The Chamber considers, in fact, that the only security for the repayment of the note issue should be actual cash, and that the proper proportion of cash to liabilities can only be determined by experience, and the most important factor in the calculation will always be the state of the financial credit of the Government of India, and finally of the Government of Great Britain. As a matter of fact, currency notes are in India at present looked upon by all classes, with comparatively few exceptions, as actual money, and only the best informed people ever trouble themselves about the amount of cash held against them.

With regard to what should be done with the cash not required by the Currency Department, the Chamber is of opinion that it should be paid to the Government of India to enable it to avoid borrowing in future, whereby the general credit of that Government would be strengthened and the pockets of the taxpayer saved.

The proposal to set free two crores of rupees is one to which objection has been taken in other quarters, on the ground that the Barbour Exchange Scheme would be affected thereby. Although it expresses no opinion upon the wisdom of that scheme, including the closing of the Mints, the Chamber considers that this step having been taken, and the success of the measure having been declared to be dependent upon the contraction of the currency, any fresh action is to be deprecated which would cause it to be said that the scheme had not had a fair trial. It appears to be established that such contraction has not yet taken place owing to the unexpected supply of hoarded rupees — and as this supply must have its limit, the flooding of the market by two crores would appear to be contrary to the recently declared policy of Government.

The Committee of the Chamber of Commerce direct me to acknowledge receipt of your letter No. 5318-A., dated 7th November last, calling for an expression of opinion upon a proposal to take power from the Legislature to raise the limit of the paper currency reserve which is held in Government securities from eight to ten crores of rupees.

The Committee considered this proposal of sufficient importance to place before the members of the Chamber of Commerce, and to invite their individual opinions thereon. These replies have now been received, and show that the opinion of members is divided as to the merits of the proposal as well as to the expediency of such a measure being undertaken by the Government of India.

I am to say further that those who are in favour of Government taking the power to increase the paper currency reserve from eight to ten crores of rupees, as suggested, think that such an operation, if attempted, would need to be carried out with very great caution, and only when a favourable opportunity occurred."

BRUSSELS INTERNATIONAL EXHIBITION, 1897.

For the Government of British India.

The International Exhibition at Brussels in 1897 is under the distinguished patronage of the King and of the Royal Family, and has the financial support of the Government, of the town of Brussels, and of the province of Brabant. A joint stock company 'Brussels Exhibition' has undertaken the management of the affair, and it will be responsible for the undertaking financially.

The 'Moniteur Belge' of the 20th December 1895 has published the Royal Decrees appointing the Government Commissioners and the Members of the Committee of Organization. The object of the Exhibition is to gather together all industrial progress, to invite producers to various competitions, and to reward the winners. The principal branches of human activity will form the subject of special study, and questions or desiderata will be put by special Committees, who have been instructed to draw up the programme of each section.

There will be fourteen sections, viz. :

- 1. Fine Arts.
- 2. Social Economy.
- 3. Hygiene.
- Preservation of life and property from fire and shipwreck (sauvetage).
- 5. Industrial and decorative arts.
- 6. Lighting, heating and their appliance.
- 7. Electricity-Traction.
- 8. Warfare.
- 9. Industrial manufactures, plant processes and products.
- 10. Sporting material.
- 11. Drill, popular games.
- 12. Agricultural and Horticultural competitions limited to certain periods.
- 13. Practical education, female industries and handwork.
- 14. Commerce Colonies.

The divisions of the international competitions will offer a series of particular exhibitions, each one of which will be contined to subjects of the same category. In each of these sub-divisions a competition will be held having for its object the solution of that problem which constitutes a desideratum in respect to the group which has entered into the competition. Rewards in kind will be given for the solution of the problems.

In addition to these competitions, by the constitution of the foreign sections, there will be an exhibition in which the different countries will be able to freely exhibit their products. The Government allows the use of the 'Cinquantenaire' Park with its museums and offices for the Exhibition.

The king desirous of showing his kindly interest in the undertaking, places the Royal domain at Tervueren at the disposal of the Exhibition. There will be gathered together the produce of the independant state of the Congo, the games referred to in section 11, as well as various anusements.

The Cinquantenaire Park will be connected with the Royal chateau at Tervueren by an electric tramway traversing a new avenue which will be, on account of its great size and picturesque scenery, one of the finest arteries of the capital.

The different Committees will meet at a very early date to decide on their programmes as well as about the general classification. These papers, together with the invitation to producers and various information regarding the exhibition, will be issued in continuation of this note.

Rules for the Sheriff's Office.

EXTENT OF LIMITS FOR EXECUTION OF PROCESS BY SHERIFF.

1. The Sheriff shall ordinarily execute the process of the High Court in the island of Bombay, Cross *alias* Gibbet and Butcher's Islands and the coasts and harbours thereof respectively, and shall not be compellable to execute process beyond the said limits.

Upon occasions when it shall be necessary to execute process beyond the said ordinary limits, the Sheriff shall grant his special warrant to such person or persons as a Judge shall direct; and in order to prevent any improper use or abuse of the process of the Court, the party issuing the same shall give such security for its proper execution as the Judge shall direct.

DELIVERY AND SERVICE OF SUMMONS AND OTHER PROCESS.

2. The Sheriff shall not receive for service summonses to appear and answerdelivered to him after twenty-one days from the filing of the plaint or order of amendment, except by order of a Judge.

3. The Sheriff shall note on every summons or other process the date on which it was delivered to him, and on every warrant the name of the party or attorney subscribed to the process.

4. No summons or other process shall be served or executed on a Sunday, •Christmas Day, or Good Friday, except by leave of a Judge.

For such service or execution effected or attempted on the days aforesaid, the Sheriff shall be entitled to an extra fee of 15 rupees.

5. The Sheriff shall not be required to serve any summons or other process at an Attorney's office after four o'clock P.M.

6. Parties in person shall serve all summonses and other process through the Sheriff.

7. If the summons or other process has to be served or executed on any person, not being a European or certified by the Attorney issuing the summons or process to be well acquainted with the English language, the Sheriff shall at the time of such service or execution likewise serve such person with a true translation in the vernacular language with which such person is familiar of such summons, or other process, and of any endorsement there may be thereon respectively, and where on the execution of any warrant, or order of attachment against the houses, lands, or tenements of any person, it is necessary to affix the warrant shall, if such person be not a European or certified as aforesaid, cause to be affixed in some conspicuous place on the premises a true translation of such warrant, or order in the vernacular language with which such person is familiar.

8. Whenever a summons or other process is received from any other Court for service within the local limits of the Ordinary Original Civil Jurisdiction of the High Court, the Sheriff shall serve the same and return the original process, accompanied by an affidavit of the Bailiff serving the process and also of the person or persons if any pointing out to him the party on whom the process has been served to the said Court.

WARRANTS OF ARREST AND OF ATTACHMENT.

9. With every warrant of arrest before or after judgment there shall be deposited with the Sheriff the sum of Rs. 2 for the intermediate subsistence of the judgment-debtor, pursuant to Section 339 of the Code of Civil Procedure. 10. Any person arrested and any property attached before judgment shall be released from arrest and attachment by the Sheriff immediately on his being served with a certificate issued by the Prothonotary that sufficient security has been taken by that officer.

11. Under every warrant of arrest and of attachment before or after judgment the Sheriff shall receive or levy the sums if any mentioned therein, and a sufficient sum for interest (where interest is payable) besides his own fees and poundage.

12. The payment of the moneys in the preceding rule specified shall entitle the person against whom the warrant has been issued to his release and to the release of his property immediately after the Sheriff has satisfied himself by search in his office that no other warrants under which he or his property could be detained have been lodged.

13. Every person arrested who is not released under the preceding rule, shall, as soon as practicable, be brought before a Judge for an order of committal or otherwise. A note of the purport of the order, and the rate of subsistence allowance fixed (if any) shall be endorsed on the warrant of arrest by the Judge's Clerk in attendance, and authenticated by him with his initials. Upon production in the Prothonotary's Office of the warrant with an endorsement, ordering a committal, a separate warrant shall be issued for the commitment of the person, in which the rate of subsistence allowance fixed as aforesaid shall be specified.

14. If it shall at any time be necessary that a person in custody of the Sheriff should be brought up before the Court or Judge, the application for that purpose shall be supported by an affidavit and by the production of the Sheriff's return of having executed the writ of attachment or warrant of arrest. The officer having the custody of the Sheriff's return shall cause the same to be produced before the Court or Judge on a requisition to him in writing by the person making the application.

15. When the Sheriff receives a warrant to arrest a person already in his custody on civil process, he shall forthwith bring the person before a Judge for an order of committal. The Judge may then apportion the subsistence allowance between the detaining creditors in such manner as he thinks just.

16. The Sheriff shall receive all money tendered to him under any warrant of arrest and shall, unless ordered to the contrary, pay the same to the judgment-creditor who took out the warrant, and notify to the Prothonotary such payment in execution of a decree or order.

In all other cases, whenever the Sheriff shall receive moneys under warrants of attachment or realize assets by sale or otherwise from the property of the judgment-debtor, he shall forthwith certify to the Court the amount and date of such receipt or realization, and shall hold the same until the further order of a Judge or the Prothonotary.

17. In all cases in which orders to withdraw attachments are made, the Attorney or party at whose instance the same are made shall file true copies thereof in the Sheriff's office.

18. If a surety be desirous of rendering the principal, or if a principal be desirous of surrendering himself, such surety or principal shall give notice to the Sheriff to attend in Chambers at the time of the render or surrender inorder that the Sheriff may take immediate charge of the principal.

19. For the purpose of Section 264 and Section 274, Clause 2, and Section 289 and Section 319 of the Code of Civil Procedure, the Sheriff shall beat a Battáki on the premises at the time action is taken under the abovementioned. sections.

GENERAL RULES AS TO SALES.

20. The Sheriff shall, unless the contrary be specially ordered, execute all warrants under decrees and orders of the Court for the attachment and sale of moveable and immoveable property.

21. The Sheriff shall prepare the Proclamations required by Section 287 of the Code of Civil Procedure in the case of the intended sales of moveable property.

22. On receipt from the Commissioner of the proclamation of sale of immoveable property, the Sheriff shall publish it in such of the English and Vernacular newspapers as he may deem proper.

23. Every sale of immoveable property by the Sheriff shall be made subject to the following conditions, *videlicet* :---

- 1st.—The highest bidder shall be the purchaser. If any dispute arise between two or more bidders, the lot in dispute shall be put up again at some preceding bidding.
- 2nd.—The person who shall be declared to be the purchaser shall deposit immediately twenty-five per cent. on the amount of his bid, and in default the property shall forthwith be again put up and sold.
- 3rd.—The balance of the purchase-money shall be paid by the purchaser before the closing of the Sheriff's office on the fifteenth day from the day of sale, or if the fifteenth day be a Sunday or other close holiday, then on the first office day after the fifteenth day, and in default of payment within such period the deposit, after defraying expenses of the sale, shall be forfeited and the property shall be re-sold, and the defaulting purchaser shall forfeit all claim to the property or to any part of the sum for which it may subsequently be sold. If the proceeds of the re-sale be less than the price bid by such defaulting purchaser, the difference shall be leviable from him under the rules contained in Chapter XIX of the Code of Civil Procedure for the execution of a decree for money.
- 4th.—The sale shall not become absolute until the same has been confirmed by the Court.
- 5th.—If the sale be set aside by the Court, or if the judgment-debtor have no saleable interest whatever in any lot sold under these conditions, the purchaser shall be entitled to receive back his purchase-money with or without interest as the Court may direct.
- 6th.—The right, title and interest only of the said in the above described property is sold by the Sheriff.
- 7th.—The sale is made under and subject to all other provisions contained in the Code of Civil Procedure relative to sales in execution of decrees.

24. In the above rules the term Sheriff shall include the Sheriff or Deputy Sheriff or other officer who may be appointed to execute the process of the Court.

Rules for the Taxing Office.

1. The Taxing Officer shall tax the bills of costs on every side of the Court (except the Appellate Side) and in the Insolvent Court. He shall also tax all such attorneys' bills of costs as he may be directed to tax by a Judge's order on consent of the parties, or on the application of any party chargeable with the bill.

2. Every bill of costs shall be lodged for taxation in duplicate and shall be written on ruled foolscap paper, of the ordinary size, leaving a margin of half an inch all round for convenience of binding. One of the bills so lodged will be retained and after taxation will be filed as the record in the Taxing Office; in the other the deductions made are to be entered by the Attorney or his clerk attending taxation.

3. Every bill of costs shall be properly dated throughout, and shall show in a column for the purpose the money paid out of pocket. In matters under the Testamentary and Intestate Jurisdiction there shall be a statement at the head of every bill showing the amount under which the estate has been sworn.

4. Every bill of costs shall be accompanied by vouchers regularly numbered and references to the corresponding numbers given in the bill itself and every item of disbursement, and the cause thereof shall be distinctly specified. No payment out of pocket will ordinarily be allowed except on production of the necessary voucher, or in case of Counsel's fees without the signature of the Counsel that the fee has been paid.

5. Every bill of costs shall be certified by the signature of the attorney from whose office it is issued. A bill of costs when paid shall be the property of the client.

6. Copying charges only will be allowed for copies of pleadings, orders of Court, affidavits and the like in briefs. Drawing charges will be allowed for proofs and observations so far as they are relevant and necessary.

7. Before taxation of costs one day's notice shall be given to the opposite party. Provided that no notice shall be necessary in any case when the defendant has not appeared in person or by his Attorney or guardian.

8. In the taxation of costs as between party and party the costs of and incidental to the attendance of Counsel on summonses or other matters in ordinary civil suits before a Judge in Chambers shall not be allowed unless the Judge shall certify that it was a fit case for the employment of Counsel.

9. When on the presentation of a plaint to a Judge a question arises as to whether the subject-matter of the plaint or any part thereof constitutes a cause of action, or whether the right of action is barred by limitation or whether the Court has jurisdiction to entertain the suit and Counsel appears on behalf of the Plaintiff, and if the Judge certify that it was a fit case for the employment of Counsel, the costs of and incidental to such employment may be dealt with as costs in the cause.

10. In taxing the bills of attorneys between attorney and client the Taxing Officer shall allow no other or larger general retaining fee than 5 gold mohurs, nor allow the same to be repeated oftener than once every twelve months, and no other or larger fee than 2 gold mohurs as a special retaining fee although such fees may have been given by the special orders or directions of the client himself. No retaining fee to Counsel shall be allowed on taxation as between party and party.

11. The costs of one Counsel only shall be allowed on taxation between party and party in the following cases :--

- (a) Short causes.
- (b) Long causes set down as undefended.

(c) Long causes, in which the opposite party does not appear and in which an *ex-parte* decree is obtained.

(d) Appearances for any formal party to a suit, e. g., a trustee or stake-holder who only appears to submit to the order of the Court and to ask for his costs.

(e) Matrimonial suits.

(f) Hearings on further directions and costs when there is no contest. 12. In the taxation of costs between party and party in suits transferred from the Presidency Court of Small Causes for trial in the High Court under the provisions of Act I of 1895 and in suits founded on contract filed in the High Court, in which the amount claimed in the High Court does not exceed Rs. 2,000, the costs of instructing one Counsel only on each side will be allowed, but otherwise the costs (unless undefended) will be taxed as in a defended long cause. When the amount claimed in a suit transferred to or filed in the High Court exceeds Rs. 2,000, but a decree is passed for an amount not exceeding Rs. 2,000, the plaintiff shall be entitled as against the defendant to the costs of instructing one Counsel only.

13. Undefended short causes shall on taxation be treated as motions.

14. The charge for printing proceedings in appeal to be allowed to Attorneys on taxation shall be four annas per folio of seventy-two words for each copy allowable on taxation. Such charge is to cover preparing copy for the printer, examining the proofs, and the printer's charges.

15. Any party entitled to be furnished with a printed copy shall not be allowed any charge in respect of a written copy unless the Court or a Judge shall otherwise direct.

16. A respondent's Attorney shall be allowed on taxation between party and party for briefing proceedings in appeal the amount paid by him as his contribution towards the expenses of printing, and when the sum so paid is less than the sum which would be allowed for copying proceedings he shall be allowed in addition to the sum so paid the difference between such sum and the sum which he would have been allowed for copying the proceedings.

17. A printed copy shall be allowed on taxation between party and party to the respondent's Attorney on payment of the proportionate charges.

18. In all cases where proceedings are printed, a charge of 4 annas per folio of 72 words shall be allowed on taxation for each copy where a written copy would have been allowed.

19. An Attorney who has furnished a copy of a document made for the purposes of a suit to the opposite party or his Attorney on payment of half or other due proportion of the translation charges shall also be entitled to charge in his bill a fee of 4 annas per folio of 72 words for such copy.

20. The fees allowed for drawing any pleading or other document shall nelude any copy made for the use of the Attorney or client.

21. All such just and reasonable charges and expenses as appear to have been properly incurred in procuring evidence and the attendance of witnesses are to be allowed.

22. No allowance is to be made for any inspection unless it is shown to the satisfaction of the Taxing Officer that there were good and sufficient reasons for making such inspection.

23. The costs of and incidental to the attendance of Counsel before the Commissioner shall be allowed in the taxation of costs as between party and party in all cases in which the Commissioner shall certify such attendance to be proper, and in no other case.

24. No costs are to be allowed on taxation which do not appear to the Taxing Officer to have been necessary or proper for the attainment of justice or defending the rights of the party or which appear to the Taxing Officer to have been incurred through overcaution, negligence, or mistake, or merely at the desire of the party.

25. In dealing with fees or allowances which are discretion ry, the Taxing Officer, in exercise of such discretion, shall take into consider tion the other

fees and allowances to the Attorney and Counsel, if any, in respect of the work to which any such allowance applies, the nature or importance of the suit or matter, the amount involved, the interest of the parties, the fund or persons to bear the costs, the general conduct and costs of the proceedings and all other circumstances.

26. Where a suit or matter shall not be brought on for trial or hearing, the costs of and consequent on the preparation and delivery of briefs shall not be allowed if the Taxing Officer shall be of opinion that such costs were prematurely incurred.

27. Such costs of procuring the advice of Counsel on the evidence in any cause or matter as the Taxing Officer shall in his discretion think just and reasonable, and of employing Counsel to settle pleadings and such special affidavits as the Taxing Officer shall in his discretion think proper to be settled by Counsel are to be allowed, but a separate fee is not to be allowed for each affidavit but one fee for all the affidavits proper to be so settled which are or ought to be filed at the same time.

28. If the hearing of a suit or appeal shall extend over more than one day and shall occupy either on the first day only or partly on the first and partly on a subsequent day or days more than five hours without being concluded, the Taxing Officer may allow on the expiration of the first five hours such a refresher as he may think proper, not exceeding 10 gold mohurs to the leading Counsel and 8 to the second (if two Counsel are engaged), and a further refresher after the expiration of each subsequent five hours while the suit or appeal continues at hearing. Provided that in cases of extra difficulty and importance it shall be in the power of the Taxing Master to allow a higher refresher than those mentioned above for every clear day subsequent to that on which the five hours shall have expired.

29. The Taxing Officer shall have authority to arrange and direct what parties are to attend before him on taxing of costs to be borne by a fund or estate, and to disallow the costs of any party whose attendance such officer shall in his discretion consider unnecessary in consequence of the interest of such party in such fund or estate being small or remote or sufficiently protected by other parties interested.

30. Any party who may be dissatisfied with the allowance or disallowance by the Taxing Officer in any bill of costs taxed by him of the whole or any part of any item or items may at any time before the allocatur is signed deliver to the other party interested therein and carry in before the Taxing Officer an objection in writing to such allowance or disallowance specifying therein by a list in a short and concise form the item or items or part or parts thereof objected to, and may thereupon apply to the Taxing Officer to review the taxation in respect of the same.

31. Upon such application the Taxing Officer shall reconsider and review his taxation upon such objections, and he may if he shall think fit receive further evidence in respect thereof, and if so required by either party he shall state either in his certificate of taxation or allocatur or by reference to such objections the grounds and reasons of his decision thereon and any special facts or circumstances relating thereto.

32. Any party who may be dissatified with the certificate or allocatur of the Taxing Officer as to any item or part of an item which may have been objected to as aforesaid may, before the allocatur is signed, apply to a Judge at Chambers for an order to review the taxation as to the same item or part of an item, and the Judge may thereupon make such order as to him may seem just, but the certificate or allocatur of the Taxing Officer shall be final and conclusive as to all matters which shall not have been objected to in manner aforesaid. Provided that the Taxing Master shall not be bound to delay the signing of the allocatur more than twenty days from the date of the certificate.

38. Such application shall be heard and determined by the Judge upon the evidence which shall have been brought in before the Taxing Officer, and no

further evidence shall be received upon the hearing thereof unless the Judge shall otherwise direct.

34. In all cases of taxation between party and party the bill shall be lodged for taxation between party and party and also between Attorney and client.

35. Except when a bill is taxed between party and party whenever onesixth part of the bill shall be taken off by taxation, the Attorney shall pay all costs whatever attending the taxation including the costs of the Attorney (if any) employed in contesting the bill, and the same shall be deducted by the Taxing Officer.

Rules for the Office of Commissioner for taking Accounts, &c.

GENERAL RULES.

1. When any decree or order of reference is brought into the office of the Commissioner, the party bringing in the same or his Attorney shall take out a warrant appointing a time, to be fixed by the Commissioner, for the purpose of the Commissioner's taking into consideration the matter of the said decree or order, and shall serve the same on all necessary parties or on their Attorneys.

2. Services of summonses, notices, orders, or other proceedings upon any party concerned in such reference who is not represented by an Attorney shall be made in the manner provided by the Code of Civil Procedure unless the Commissioner otherwise directs.

3. At the time appointed for considering the matter of the said decree or order the Commissioner shall proceed to regulate as far as may be the manner of its execution and shall give such directions as may be necessary.

4. If any party concerned in such reference who shall have been duly served with notice of a meeting shall not attend the meeting or any adjournment thereof, the Commissioner shall be at liberty to proceed *ex-parte* as regards such party.

5. In cases where it is not expedient or practicable for the Commissioner to proceed by reason of the refusal or neglect of a party to do some act required to be done, the adverse party upon notice, and the Commissioner's certificate of the fact, may apply to the Court for an order that the party served do the act required within a certain time, or that a writ of attachment may issue against him on default, and the Court shall thereupon make such order as to it may seem proper.

6. In any suit or matter for the administration of the estate of a deceased person, no party other than the executor or administrator shall, unless by leave of the Commissioner, be entitled to appear (except at his own risk as to costs) in the Commissioner's office on the claim of any person not a party to the suit or matter against the estate of the deceased person in respect of any debt or liability.

7. The Commissioner shall be at liberty in all matters referred to him to obtain the process of the Court to compel the attendance of witnesses or for the production of any document which he may desire to inspect, and to examine such witnesses on oath or solemn affirmation touching the matters referred to him as he shall think proper.

8. In all matters referred to him, the Commissioner shall be at liberty, upon the application of any party interested, to make a separate report or reports from time to time as to him shall seem expedient, the costs of such separate reports to be in the discretion of the Court.

9. When the Commissioner shall make a separate report of debts or legacies, he shall be at liberty to make such certificate as he thinks fit with respect to the state of the assets; and every person interested shall thereupon be at liberty to apply to the Court as he shall be advised.

10. The Commissioner, if he thinks fit, shall make a special report concerning any matter or thing arising in or about the matter referred to him, in order that the opinion of the Court may be taken therein, or with respect thereto, and such special report shall be brought before the Court by such parties as the Commissioner shall direct by motion on notice that such special report may be confirmed, discharged, or varied by order of the Court, or that any directious may be given thereon; and on the hearing of such motion the same may be confirmed, discharged, or varied as the Court shall deem just, or such directions may be given as shall appear to be necessary or expedient in that behalf.

11. When any report of the Commissioner made in pursuance of any order of the Court shall have been signed by him, the same shall be forthwith transmitted by him to the Prothonotary, and the report shall thenceforth be binding on all the parties to the proceedings, unless discharged or varied, either in Chambers or in Court according to the nature of the case, upon application by summons or motion made within twenty days after the filing thereof. Provided that the Court or a Judge may, for sufficient cause, allow such application to be made after the expiration of such twenty days.

This and the last preceding nine rules shall also apply to a Special Commissioner.

12. An Attorney shall be at liberty to furnish to the Commissioner an unofficial translation of any Exhibit put in before him. Should the correctness of any such unofficial translation be challenged the Commissioner may on reference to the Interpreter in attendance decide the point and amend the translation, if necessary, or may require the document or any portion of it to be officially translated.

13. Managing and Articled Clerks of Attorneys may on the written authority of their employers appear and act for their employers in any case before the Commissioner for which such authority is given, but the Commissioner may require the attendance of the Attorney on the record or Counsel instructed by him whenever he thinks fit. The Commissioner shall have power subject to an appeal to the Judge in Chambers to exclude from the aforesaid privilege any Clerk whom he may consider incompetent or to have abused such privilege.

14. In any case in which no proceedings have been taken in the office of the Commissioner for a period of three years in any reference pending before him, he shall certify the same to the Prothonotary and remove the reference from his file, and the reference shall not be restored without an order of the Court or a Judge.

RULES RELATING TO RECEIVERS, CONSIGNEES, MANAGERS, GUARDIANS AND COMMITTEE.

15. Where an order is made directing a Receiver to be appointed, the person appointed shall unless otherwise ordered first give security to the satisfaction of the Commissioner duly to account for what he shall receive on account of the rents and profits for the receipts of which he is appointed, at such periods as the Court or the Commissioner shall appoint, and to account for and pay the same as the Court shall direct, or to be answerable for what he shall receive in respect of any other property for the getting in and collection of which he is appointed, and to account for and pay the same as the Court shall direct.

16. A Receiver shall be allowed such remuneration for receiving such rents and profits, or for getting in and collecting such other property as the

Court or Judge shall direct. The Commissioner also in special cases may allow the Receiver the necessary expenses of management.

17. In the absence of any direction of the Court to the contrary, a Receiver shall file his accounts in the office of the Commissioner on the first day after the expiration of a year from the date of his appointment, and on the same day in every subsequent year.

18. 82. The Commissioner shall, when the attendance of the judgment-debtor can conveniently be procured, issue a summons calling upon him to attend upon a day therein named and to produce and lodge with the Commissioner all titledeeds and other documents affecting the property proposed to be sold which may be in his possession or power. Such documents shall (if produced) be left with the Commissioner and shall be subject to his directions both as to their custody pending the sale and their ultimate destination, such directions being subject to appeal to the sitting Judge in Chambers.

83. If the judgment-debtor attend upon the day named in the summons the Commissioner shall examine him on any matter affecting his title to the attached property. The judgment-creditor may also examine him on any matter relating thereto. If the judgment-debtor fails to attend on the summons or if no summons has been issued, the Commissioner may proceed *ex-parte*. RULES RELATING TO THE AUDIT OF THE ACCOUNT OF OFFICERS OF THE HIGH COURT.

90. The Commissioner shall audit the accounts of the Registrar Appellate Side, the Official Trustee and the Sheriff.

91. The accounts of the Master and Registrar in Equity and Commissioner (including his accounts as a Special Official Trustee) shall be audited by an Auditor deputed by the Accountant-General of Bombay for that purpose.

92. Such audits shall be made half-yearly as soon after the 30th June and 31st December in each year as may be practicable, and the Auditor shall in each case report the result of the audit to the Chief Justice.

93. Should any question or matter of difference arise between the Auditor and the officer whose accounts he is auditing as to any item in such accounts such question or matter of difference shall be referred by the Auditor to the Chief Justice or such other Judge as he may appoint. The Auditor and the officer whose accounts are under audit shall be entitled to be heard personally on such question or matter of difference before the Chief Justice or such other Judge as aforesaid in his private Chamber at the Court House.

94. The term "Commissioner" shall throughout the above rules include "Assistant Commissioner," and in case of the temporary absence of the Commissioner and Assistant Commissioner any other qualified officer, authorised by the Chief Justice to perform the duties usually performed by the Commissioner or Assistant Commissioner whether in connection with sales or otherwise.
