I have the honour to forward herewith for the information of Government translation of Provincial Decree No. 80 of 20th July issued by the Local Government here and published in 'Boletim Official' No. 80, dated 21st July 1896.

Translation of Provincial Decree No. 80 of 20th July published in 'Boletim Official' No. 80 of 21st July 1896.

The ratepayers having frequently and in different forms manifested the necessity of abolishing or substituting the taxes 'Contribution on Houserent and Income' because the former was not suitable owing to the absence of element of wealth

as well as owing to deficient commercial movement to give impulse to urban buildings, and the latter burdened the small industries which otherwise require protection;

Considering that these two taxes, which include in a greater part ratepayers less wealthy or poor only, produce an enormous debt most of which is unrecoverable;

Considering the absolute necessity of promoting the development of the industry of commerce and navigation, the principal sources of public wealth;

Considering the present circumstances of the Treasury cannot favour this development with the sacrifice of the receipts which are at present collected;

Considering that it is indispensable to remove, if not completely to destroy, the obstacles which more visibly oppose the desired purpose, such as the taxes which directly fall on industry or on capitals raised for its development;

Considering that the simplification of taxation is always advantageous both to the Government and to the ratepayers, relieving at the same time from direct taxation the poorer people;

Having heard the Secretary of Fazenda and making use of the authority granted me in Decree dated 22nd May 1896, I am hereby pleased to decree the following:

Art. 1.—The taxes 'Contribution on Houserent and Income' sanctioned per Decrees Nos. 2 and 3 of 1st September 1981 are abolished. Art. 2.—The additional tax on land property sanctioned per Decree No. 6 of 1st September 1881 is increased from 5 to 10 per cent.

Art. 3.—An additional tax of 5 per cent. will be levied on land property to meet the charges of the revision or modification of the taxation, which after completion of those works will cease to be collected.

Art. 4.—An additional impost of 20 per cent. will be levied on import duties collected by the Customs.

Section 1.—The additional impost of 20 per cent. on Customs duties will be reduced to 10 per cent. on national produce imported by foreign vessels and on foreign produce imported by national vessels.

Section 2.—National produce imported by Portuguese vessels will be exempt from this additional impost.

Art. 5.—Capital raised for the purpose of developing rising industries or for creating others within a period of five years from the publication of this decree will be exempt from impost of 10 per cent. on the use money paid for the loan.

Section 1.—This exemption will be granted by orders of the Governor General on proposition of the Secretary of Fazenda after duly ascertaining how the capital raised has been applied.

Section 2.—The creditor shall register in the Fazenda office a statement for record declaring what industry the capital is intended for. This registration will be endorsed and declared without any effect when the exemption referred to in this article has been granted, or will be converted into a direct manifest when it is known that the capital has been applied for other purpose than that declared, the creditor in this case paying double impost for the time the declaration was incorrectly manifested.

Art. 6.—A premium of 10 per cent. will be awarded on capital employed in factories that may be established in this State within the period of eighteen months from the date of publication of this decree, in every case when the capital is or exceeds fifteen thousand rupees, including in this calculation the land, buildings, and machinery. This premium will be awarded within the first month such factories commence working.

Section 1.—Produce exported by such factories or others that may be started in future shall enjoy the benefit of 'Drawback' on the original material used in their manufacture.

Section 2.—Special rules shall fix the formalities to be followed in conceding the 'Drawback' referred to.

Art. 7.—A premium of thirty thousand rupees will be awarded to the first Firm who within eighteen months from the date of publication of this decree establishes a regular steamer service under the Portuguese flag between any ports and those of Portuguese India (Goa, Marmagao, Daman and Diu). This premium will be increased by 50 per cent. if this service extends to other Portuguese ports besides those already referred to in Portuguese India or in case the Firm is national.

Section 1.—This premium will be awarded when the Firm have really established a regular navigation service for a space of one year, and which at the time of receiving the premium money shall bind themselves with due formalities and guarantees to continue the same service for at least six years.

The authorities and other persons to whom this may concern should so understand and comply.

RESOLUTION—By the Government of India, Public Works Department.

Rules relating to the packing and testing of cylinders or flasks containing liquefied carbonic acid gas.

Read-

Letter from the Director General of Railways, No. 281-T., dated 3rd July 1895.

Letters from the Secretary, Public Works Department, India Office, No. P. W. 1658, dated 1st November 1895, and No. P. W. 422, dated 27th March 1896, enclosing reports by the Board of Trade and by the Committee appointed by the Secretary of State, to consider the question of the conveyance by railway of compressed gas in cylinders.

Despatch to Secretary of State No. 46 Railway dated the 9th June 1896,

Observations.—Liquid carbonic acid gas has been excluded from the item 'gas, compressed' in the list of goods declared dangerous in rule 14 of Part II of the open line general rules of 1895, provided the gas is secured 'in wrought iron cylinders or solid drawn steel flasks without seam or joint, certified by competent authority to withstand a pressure of 250 atmospheres (3,750 lbs.).'

2. Owing to the bursting of a cylinder while being transhipped at the Amritsar Station on the North-Western Railway, the question of issuing revised directions in regard to the packing and testing of cylinders and flasks containing liquefied carbonic acid gas has been under careful consideration, and the set of rules accompanying this circular has been drawn up.

These rules have not been finally decided upon as certain points are still under reference to the Secretary of State; but as they have been formulated

under the advice of experts in consultation with those engaged in the trade, it is improbable that they will undergo any very appreciable modifica-tion; and in order to avert the recurrence of an accident similar to that which occurred at Amritsar, the Government of India consider it essential, in the interests of the trade as well as for the safety of the public, that some clearly defined precautions should be adopted without further loss of time.

RESOLUTION .- The Governor General in Council is accordingly pleased to sanction provisionally, with effect from 1st January 1897, the accompanying rules for adoption on open lines of all railways directly administered by Government, and desires that the administrations of other railways may also be moved to adopt the rules.

Rules to regulate the carriage by rail in India of liquefied compressed carbonic acid gas in wrought iron cylinders or solid drawn steel flasks—

- (a) The cylinders or flasks used should be capable of enduring a test pressure of 3,750 lbs. per square inch without deformation, and should be re-annealed and re-tested after annealing every two years. By deformation it is to be understood that no sudden stretch occurs under testing in a water-jacket furnished with a gauge glass, and that the total external bulk of the cylinder or flask is not increased after test by more than I per cent.
- (b) The valve should be protected by an outer metal cap screwed on to the head of the cylinder
- (c) The cylinders or flasks should either be packed in separate boxes or be completely cased in a fibrous covering not less than half an inch thick.
- (d) The amount of gas to be filled in each cylinder or flask should not exceed two-thirds by weight of its water capacity.
- (e) The date, the letter 'A. and R. T. 3,750 lbs., and a mark indicating the firm and individual responsible for such annealing and re-testing are to be stamped on the neck or shoulder of each cylinder or flask in order to indicate the date of re-testing and re-annealing
- (f) No consignment of compressed gas in cylinders or flasks should be accepted for carriage by rail unless the consignor has given a written declaration that the above rules have been complied with.

(g) The Railway Administration should take every precaution against exposing the cylinders or flasks when charged with gas to excessive heat, either in wagons, or by exposure to the direct rays of the sun.
