#### NOTIFICATIONS.

#### GENERAL DEPARTMENT.

Bomlay Castle, 7th October 1896.

No. 4416 .- The following General Order by the Government of India, No. 1070 dated 25th September 1806, is republished :-

#### "JUDICIAL.

No. 1070.—A draft of certain rules and enactments which, in exercise of the powers conferred by Sections 25, 26 and 27 of the Cantonments Act (XIII of 1889) and of all other powers in this behalf, it is proposed to make for, and apply to, all cantonments in British India, except Aden, is published" in the Supplement to the Gazette of India of the 26th instant for the information of all persons likely to be affected thereby, as required by the said Act; and notice is hereby given that the said draft will be taken into consideration by the Governor General in Council on or after the first day of January 1897.

2. Any objection or suggestion which may be received from any person with respect to the draft before the date above mentioned will be considered by the Governor General in Council."

#### Bombay Castle, 23rd October 1896.

No. 4712 .- It is proposed to vary the rules framed by Government under Section 35 of the Bombay Boiler Inspection Act, 1891, [and published in Government Notification No. 515, dated the 3rd February 1896, at pages 94 to 102 of the Bombay Government Gazette for 1896, Part I,

by substituting for clause (d) of Rule 2 of the said rules the following clause:—

"(d) The words defined in Section 3 shall be deemed to have respectively the same meaning as is given to them by the Act, provided that wherever in these rules service with engines and boilers is required as a qualification for admission to an examination under Section 21, the word 'engine' or 'boiler' shall be held to include any locomotive engine or boiler used upon, or appertaining to, any railway within the meaning of that word as defined in Section 3, clause (4), of the Indian Railways Act, 1890."

2. Notice is hereby given that the foregoing draft rule will, with any suggestions or objections relating thereto, which may be received before the 1st December 1896, be taken into consideration on or after the said date.

#### Bombay Castle, 27th October 1896.

No. 4764.—In exercise of the powers conferred by sub-section (2) of Section 58 of the Pilgrim Ships Act, 1895, the Governor in Council is pleased, with the previous sanction of the Governor General in Council, to make the following rules to regulate—

- (a) the local limits within which and the time and mode at and in which pilgrims shall be embarked at the port of Bombay, and
- (b) the time within which a pilgrim ship shall depart after commencing to take pilgrims on board.

#### Rules.

Time at which pilgrims aball be embarked on any pil-grim ship—

- (a) if it is in dock more than six hours before the time fixed for the departure of that ship from the dock, or
- (b) until he has been medically inspected.
- (2) Any pilgrim or other person committing a breach of this rule shall be punished with fine which may extend to Rs. 200.
- 2. (1) When the time has arrived at which the mbarkation is under Section 32 permitted to commence, every pilgrim, after he has been medically inspected, shall, on producing a ticket in the prescribed form, be embarked forthwith on the pilgrim ship to which the ticket applies—
  - (a) if the ship is in dock, by proceeding at once on board by a passage leading direct to the ship, or
  - (b) if the ship is in mid-stream, by proceeding immediately to the ship by such direct route and by such boat as shall be indicated in this behalf by the Health Officer of the Port.
  - (2) Any pilgrim or other person committing a breach of this rule shall be punished with fine which may extend to Rs. 100.

3. (1) Every pilgrim ship shall depart from dock within six hours

Time within which pilgrim ship shall depart from dock after commencing to take pilgrims on board. dock within six hours from the time at which the embarkation of pilgrims has under Section 32 of the said Act been

permitted to commence.

(2) The master of a pilgrim ship committing a breach of this rule without lawful excuse or wilfully shall be punished with fine which may extend to Rs. 200, and when the breach continues with a further fine which may extend to Rs. 20 for every day after the first during which the breach continues.

No. 4764A.—In exercise of the powers conferred by Section 32 of the Pilgrim Ships Act, 1895, the Governor in Council is pleased to fix the time and place at which and the manner in which pilgrims shall be medically inspected under the said section by directing as follows, viz.:—

Time at which inspection is to take place.

- (1) The medical inspection of pilgrims for embarkation on each pilgrim ship—
- (a) shall, unless in any case the Health Officer otherwise directs, commence on the day specified in the notice given under Section 8 of the Pilgrim Ships Act, 1895, as the day proposed for the sailing of the ship, not later than the hour at which the officer to whom such notice has been given under the said section, permits the embarkation of pilgrims on such ship to commence; and
- (b) shall, unless in any case the Health Officer otherwise directs, close not less than half an hour before the time at which the ship is required to leave her berth.

Provided that, if it be impossible to complete the medical inspection of the total number of pilgrims for embarkation on any ship on the day on which embarkation on that ship is permitted to commence, the medical inspection shall be continued after surrise on the following day, as soon as arrangements have been made for the embarkation in midstream of inspected pilgrims in accordance with the rules in force under section 58 (2) of the said Act.

(2) The said medical inspection shall take place in a shed at Malet Ban-

Local limits within which medical inspection is to take place. in a shed at Malet Bandar adjoining the Prince's Dock, distinguished by a board affixed at the en-

trance thereto and bearing the words "Pilgrim Shed."

(3) (1) No pilgrim shall be embarked without re-inspection, if after medi-

Pilgrims not proceeding direct to the ship after medical inspection not to be embarked without re-inspection, re-inspection, if after medical inspection he has left the place fixed under section 32 of the said Act, and has not proceeded as aforesaid directly to the ship.

(2) Any pilgrim or other person committing a breach of this rule shall be punished with fine which may extend to Rs. 100.

No. 4764-B.—The following Extract from a letter from the Government of India, Home Department, (Sanitary), No. 151, dated 15th June 1896, is published for general information:—

"6. The last point dealt with in the Secretary of State's Despatch, dated 5th December 1895 to which it is necessary specially to refer, is referred to in the remark in paragraph 5 that it would be well to declare in Article 67 (now Rule 66) of the Regulations that the fixed dues payable on arrival at Camaran and at Jedda, and none others, should be included in the cost of tickets issued to pilgrims. This suggestion has been acted on, and I am to explain, for the information of the Governor in Council, that by 'fixed dues' appear to be meant the 4 piastres landing charge at Camaran, and a sanitary fee of Rs. 1-13-0 levied at Jedda. These fees should, therefore, be included in the cost of the ticket, and I am to request that, with the permission of His Excellency the Governor in Council, this may be done and, if necessary, the intention to do so notified under the orders of the Government of Bombay for the information of the pilgrims."

No. 4801.—The following General Order by the Government of India, No. 1160, dated 23rd instant, is republished:—

#### "JUDICIAL.

No. 1160.—In exercise of the powers conferred by section 25 of the Cantonments Act (XIII of 1889), the Governor-General in Council is pleased to extend to the Cantonment of Poona the provisions of section 434, sub-section (1), and section 473 of the City of Bombay Municipal Act (III Bo. C. of 1888) in the medified form set forth below, namely,—

- '(1) In the event of the Cantonment of Poona being at any time visited or threatened by an outbreak of any dangerous disease among the inhabitants thereof, the General Officer of the Command, if he thinks that the provisions of the law at the time in force are insufficient for the purpose, may, with the previous sanction of the Local Government,—
- (a) take such special measures, and

(b) by public notice, prescribe such temporary regulations to be observed by the public or by any person or class of persons,

as he may think necessary to prevent the outbreak of such disease or the spread thereof.

'(2) Whoever commits a breach of any such temporary regulation prescribed as aforesaid shall be deemed to have committed an offence punishable under section 188 of the Indian Penal Code.'

No. 7269.—The following General Rule made by Her Majesty's High Court of Judicature at Bombay under Section 15 of the Statute 24 and 25 Vic., Cap. 104, for regulating the practice and proceedings of all Criminal Courts subject to its jurisdiction, has received the sanction of the Governor in Council and is published for general information:—

#### (To be inserted as Circular 98 at page 77 of the High Court Criminal Circulars.)

98. Commissions sent for execution to any place where the language is different from that of the Court issuing them should be accompanied by translations in the language of such place, or in English.

No. 7309.—The following General Rule made by Her Majesty's High Court of Judicature at Bombay under Section 15 of the Statute 24 and 25 Vic., Cap. 104, for regulating the practice and proceedings of the Courts of all Magistrates subject to the jurisdiction of the High Court, has received the sanction of the Governor in Council, and is published for general information:—

### (To be inserted as Circular 30-A, in Chapter III of the High Court Criminal Circulars.)

30A. The Honourable the Chief Justice and Judges regret to observe that the trial of cases is at times unnecessarily and unduly protracted. Their Lordships, therefore, desire to point out, for the guidance of all Magistrates, that it is their duty to despatch their criminal work with the least possible delay, it being essential for the proper administration of justice that it should be promptly dealt with. As far as possible, criminal work should be given precedence over other work, cases in which the accused are in custody being taken up for disposal in preference to those in which the accused are on bail. Magistrates should so arrange for the despatch of their criminal work that the hearing of one case should, as much as possible, not be allowed to interfere with the hearing of another, each one being fixed for hearing for distinct days, due regard being had to their probable duration. Every effort should be made to minimise delay and hardship to the parties and witnesses. When a case is once commenced, it should be heard de die in diem and completed with every possible despatch, the whole or as much of the working day as could be spared being devoted to its hearing. Witnesses remaining over from one day should be examined at the first sitting of the Court on the following day. The practice of taking up a case for an hour or so and then dropping it again should be avoided, and cases should be disposed of, as far as possible, in continuous sittings. Adjournments should as a rule be avoided, specially when the accused are likely to be prejudiced thereby, and if from any unavoidable cause an adjournment is deemed indispensable, it should be for as short a time as possible.

In any case a trial once commenced should be continued from day to day, except on Sundays,

and other days when the Public Treasuries are closed and days when native usage absolutely requires the intermission of all business. Every Court should sit daily and punctually at the hour appointed for its opening, unless prevented by circumstances, which should be recorded in its proceedings.

When a Magistrate is on tour, every care should be taken to let the parties and witnesses know the place as well as the time for their appearance, which should be fixed so as to obviate, as far as practicable, the inconvenience, which must be caused to them by their being called away to long distances from their residences, and the hearing of cases should, as far as possible, be completed at the appointed place without obliging them to move from camp to camp with the Magistrate.

No. 1805-E-A.—In exercise of the power conferrd by the additional rule (6-D) under the Indian Arms Act (XI of 1878), published in the Notification of the Government of India in the Home Department No. 1303-Public, dated the 5th September 1895, the Governor General in Council is pleased specially to empower the Commissioner in Sind to grant licenses to export by sea, from the port of Karachi, sporting shot guns, machinery for manufacturing ammunition for the same (including machines for loading and recapping cartridges), cartridge cases, and percussion caps, not intended for sale or for military purposes, but for the private use of the consignee, to ports within the political jurisdiction of the Political Resident in Turkish Arabia.

#### Bombay Castle, 19th October 1896.

No. 115.—In accordance with the provisions of Section 74 of the Bombay Port Trust Act, 1879, the following bye-laws which the Trustees of the Port of Bombay propose to make for the regulation of Railway Trains working through and in the neighbourhood of the Port Trust Docks and on all sidings connected with the Docks, are published, for the information of all persons whom they may concern:—

- 1. No trains, engines or wagons may be run over any Port Trust siding on Sundays, New Year's Day, Good Friday, the Queen-Empress' Birthday and Christmas Day, or between sunset and sunrise, unless special arrangements have been made beforehand between the Railway and Port Trust officials concerned.
- 2. No trains, engines or wagons may be moved over any Port Trust sidings unless led by a bell-man.

If a bell-man is not in attendance when a train enters a Port Trust siding, the driver shall stop and whistle until the bell-man comes up.

When a train is about to move on any Port Trust siding and no bell-man is in attendance, the driver shall whistle and not start until a bell-man comes, up.

- 3. The bell-man shall walk not more than ten feet ahead of the train, engine or wagons, and shall ring his bell without intermission.
- 4. Drivers shall regulate the speed to keep the train not more than ten feet behind the bell-man. In no case is the speed to exceed four miles an hour
- 5. When leading a train, engine or wagons, if the bell-man sees any obstacle, impediment, person, animal or vehicle on the line, he must at once signal to stop by holding up both arms.
- Drivers and mukádams shall keep a sharp look-out for signals from the bell-man, and if they see any obstacle, impediment, person, animal or vehicle on the line, whether the bell-man signals or not, they shall stop.
- 7. In crossing the Frere Road, two police rámosies or peons must be present, one on each side of the line, to stop all road traffic clear of the line.

The bell-man shall not lead a train and drivers shall not proceed across the road until the two men have been posted.

8. Level-crossing gates shall be kept shut across the siding, except to allow engines, trains or wagons to pass.

The gatemen shall be present when trains are passing to prevent the gates being moved until the road is clear.

 The bell-man shall not lead a train up to a level-crossing until the gates have been properly epened.

- 10. No train, engine or wagon may stand on a level-crossing. If a train is obliged to stop on a level-crossing and is impeding road traffic, it must be divided and the road cleared (see Rule 8) until the train is ready to proceed.
- 11. Road traffic must not be stopped for more than one train at a time.
- 12. Where there is a double line, trains, engines and wagons must not be moved over a level-crossing in both directions at once.

#### Bombay Castle, 24th October 1896.

No. 4729.—The following letter from the British Consul, Goa, No. 5 dated the 19th October 1896, is published for general information:—

"With reference to my telegram of the 17th instant, which reads as follows:

'From yesterday five days' quarantine against passengers from Bombay arriving by rail or sea. Same applies to passengers from south travelling by Shepherd's steamers,'

which I beg to confirm; I have now the honour to inform you that the rules have been modified and are as follows:

- 1st.—Passengers by steamer from Bombay stopping in Goa will be subject to five (5) full days' quarantine from the time of their arrival.
- 2nd.—Passengers by steamers from Bombay proceeding by rail into British India will be kept in quarantine until they can be forwarded, but arrangements will be made for them to proceed with their luggage by the first available train.
- 3rd.—Passengers by steamers from south ports stopping in Goa will be kept under medical inspection for twenty-four hours.
- 4th.—Passengers by steamers from south ports proceeding by rail will be subject to the conditions mentioned in Rule 2.
- 5th.—First and Second Class passengers from Bombay by rail will be granted free pratique.
- 6th.—Third Class passengers from Bombay by rail will be subject to five days' quarantine, inclusive of the time occupied on the journey.
- 7th.—Steamers on arrival will be allowed to come alongside and discharge passengers and cargo, but only overside communication will be allowed between the staff on board and that on shore.
- 8th.—Through goods in transit will not be detained.
- 9th.—Goods for local stations will be disinfected and detained twenty-four hours."


