No. 7.—The following Notification by the Government of India in the Home Department is republished for general information:—

"HOME DEPARTMENT.

PUBLIC.

Calcutta, the 27th December 1893.

No. 1915.—The Right Honourable Victor-Alexander Bruce, Earl of Elgin and Kincardine, P.C., LL.D., Lord Bruce of Kinloss and Lord Bruce of Torry, in the Kingdom of Scotland, and Baron Elgin, of Elgin, in the United Kingdom, is expected to arrive at Aden on or about the 15th proximo and at Bombay on or about the 20th idem, to assume the office of Viceroy and Governor General of India.

The Resident at Aden will receive the Earl of Elgin with all the honours and distinctions which are due to the Viceroy of India.

His Excellency the Governor of Bombay will make arrangements, in communication with the Naval authorities, for the landing and reception of the Earl of Elgin at Bombay with all the honours and distinctions which are due to the Viceroy of India.

An Aide-de-Camp of the Viceroy will proceed to Bombay to attend upon the Earl of Elgin throughout his journey from Bombay to Calcutta.

One of the principal Civil Officers of each Government or Administration will be deputed to meet the Earl of Elgin as he enters the limits of such Government or Administration, and will remain in attendance upon His Lordship until he passes beyond those limits.

At the Railway stations at which halts are made for rest and refreshment, Civil and Military Officers will be in attendance. There will also be a Guard of Honour upon the platform.

Should the Earl of Elgin make any stay at Allahabad, His Honour the Lieutenant-Governor of the North-Western Provinces will make all arrangements, in communication with the Military authorities, for His Lordship's reception in a suitable manner.

At stations between Bombay and Howrah, other than those mentioned in the two preceding paragraphs, the attendance of officers is dispensed with.

Proper police precautions will be taken at all the stations along the line at which the train stops.

Upon the Earl of Elgin's arrival at the Howrah terminus of the East Indian Railway, His Lordship will be received by the Secretaries to the Government of India and by the Military Secretary and Aides-de-Camp to the Viceroy.

The following officers will also be in attendance upon the Howrah Railway platform:—

The Commissioner of Burdwan.

One of the Secretaries to the Government of Bengal.

The Brigadier-General Commanding the Presidency District with the District Staff.

The Commissioner of Police, Calcutta.

The Chairman of the Commissioners of Calcutta.

The Sheriff of Calcutta.

The Magistrate of Howrah.

A Guard of Honour of Native Infantry will be drawn up at the Howrah terminus.

The Earl of Elgin, attended by his personal staff, by the Secretaries to the Government of India, by the Military Secretary and Aide-de-Camp of the Viceroy, will proceed to Government House in the Viceroy's carriages escorted by the Body Guard.

The line of route will be lined throughout by troops under the orders of the Brigadier-General Commanding the Presidency District.

A Royal salute will be fired from the ramparts of Fort William as the cortège appears upon the Hooghly Bridge.

A Guard of Honour of British Infantry and a Guard of Honour of the Administrative Battalion, Presidency Volunteers, will be drawn up opposite the grand entrance of Government House.

The Earl of Elgin will be received as he alights from the carriage at the foot of the grand staircase by His Honour the Lieutenant-Governor of Bengal attended by his personal staff.

All the Civil and Military Officers of Government at the Presidency will be in attendance upon the grand staircase of Government House. Consular Officers and other Representatives of Foreign Governments at Calcutta, and all non-official gentlemen, are invited to be present upon the grand staircase.

His Excellency the Viceroy and Governor General, attended by his personal staff and the Members of the Governor General's Council, will receive the Earl of Elgin at the top of the grand staircase, and will conduct His Lordship to the Throne Room.

The troops will then be withdrawn.

Full dress will be worn by Civil and Military Officers, and morning dress by all gentlemen not entitled to wear uniform.

The date and hour of the Earl of Elgin's arrival at Howrah and the ceremonial to be observed on his assumption of the office of Viceroy and Governor General of India will be notified hereafter.

SAVINGS BANKS.

Calcutta, the 30th December 1893.

It is hereby notified for general information that, with effect from 1st April 1894, the rate of interest on deposits in the Post Office and Presidency Savings Banks will be reduced from 3½ to 3¼ per cent. per annum. From that date interest will accordingly be allowed for each calendar month at the rate of three pies on every complete sum of six rupees contained in the lowest balance at credit of each account between the close of the fourth day and the end of the month: Provided that no interest will be allowed on any sum exceeding the maximum limits of deposit prescribed in the Resolution of the Government of India in this Department No. 367*, dated the 18th January 1889, and in the existing Rules.

2. The Governor General in Council reserves the right to alter the rate of interest now fixed at any time.

SERVICE AND OTHER FUNDS.

Resolution of the Government of India in this Department No. 4096, dated 31st October 1883.

RESOLUTION.—In the Resolution of 31st October 1883 it was laid down that the balance held by the Government at credit of the Bengal and Bombay Uncovenanted Service Family Pension Funds (excepting always the Life Assurance Branch of the Bombay Fund) in excess of the amount on which a privileged rate of interest is payable, should carry interest at the ‘market rate.’

The interest at present allowed under the designation ‘market rate’ is 4 per cent. a year. The Governor General in Council is now pleased to give notice that from and after 1st July 1894, the rate of interest allowed under the above designation shall, until further orders, be 3½ per cent. per annum.

ORDER.—Ordered, that this Resolution be communicated to the Directors of the Bengal Un-

covenanted Service Family Pension Fund; the Government of Bombay for communication to the Directors of the Bombay Uncovenanted Service Family Pension Fund; the Comptroller and Auditor General; the Comptroller, India Treasuries; and the Accountant General, Bombay.

No. 2.—His Excellency the Right Honourable the Governor in Council is pleased to prescribe the following rules for the examination of officers of the Forest Department in the Bombay Presidency, in supersession of the rules contained in

No. 5142, dated 29th September 1880, published at page 782 of the *Bombay Government Gazette* of 30th idem, Part I.

No. 5510, dated 3rd August 1886, published at page 649 of the *Bombay Government Gazette* of 5th idem, Part I.

Government Notification No. 2878, dated 4th June 1880, published at pages 535 and 536 of the *Bombay Government Gazette* of 10th idem, Part I, as amended by Government Notifications noted in the margin:—

1. Forest officers will be required to pass examinations in the following subjects:—

- (a) Languages (according to the Lower and Higher Standards prescribed for Junior Civilians).
- (b) Land Revenue.
- (c) Forest Law.
- (d) Procedure and Accounts.

2. Examinations in all the subjects will be held in April and October of every year before the Central Committee for Departmental Examinations, to which a Conservator of Forests or a Deputy Conservator of Forests in charge of a Circle will be appointed from time to time as an additional member. Examinations in languages alone will be held every quarter before the Central Committee for Vernacular Examinations.

3. Every officer shall present himself for examination according to the Lower Standard in the language of the division in which he is serving at

the latest at the first meeting of the Central Committee after he has been nine months in the service in this country, whether as Assistant Conservator of Forests, Second Grade, or as Extra Assistant Conservator of Forests, Fourth Grade, and he shall be placed under stoppages of 10 per cent. of his pay, should he fail to pass within 18 months of the date of his joining the service in the Presidency.

4. No officer will be eligible for promotion out of the grade of Assistant Conservator of Forests, Second Grade, or of Extra Assistant Conservator of Forests, Fourth Grade, as the case may be, until he has passed a further examination in the language of his division, according to the Higher Standard, and has qualified in—

- (a) Land Revenue
- (b) Forest Law
- (c) Procedure and Accounts

according to the tests prescribed in Rule 6.

5. For the purposes of these rules, the following languages shall be held to be those of the different Forest Circles:—

Central	Maráthi.
Southern	...	{	Ratnágiri, Kolába and Maráthi. Belgaum. Dhárwár, Bijápúr and Kánarese. Kánara.
Northern	...	{	East and West Thána.. Maráthi. Surat and the Panch Gujaráti. Maháls.
Sind	Sindhi.

In the case of the Circles against which two languages are entered the language of the division in which the Forest officer is serving will be the language in which he will be required to pass.

6. The tests in Land Revenue, Forest Law, and Procedure and Accounts will be as follows:—

Land Revenue.

Act No. V of 1879, entitled the Bombay Land Revenue Code, Chapters I and II; of Chapter V, Sections 37 to 44; of Chapter VI, Section 62, Clause 2; and Chapter IX; Rules 35 to 37, 91 to 98B (Trees) and 100 to 106 (Boundary marks) of the Rules under Section 214 of the Bombay Land Revenue Code.

Forest Law.

Act No. VII of 1878, the Indian Forest Act, 1878, as modified up to date, with all the rules published and in force at the time being under different sections of that Act.

Procedure and Accounts.

Not more than 12 questions from—

- (a) Such portions of the Forest Department Code as have been applied to the Bombay Forest Department.
- (b) The standing orders and rules of the Forest Department of the Presidency.

(c) Rules which have been published under the Sea Customs Act, 1878, the Arms Act XI of 1878, the A'bkári Act V of 1878 and are in force at the time being and apply to the Forest officers in the Forest Department of the Presidency.

7. In addition to the examination above described any officer of the Forest Department below the rank of a Conservator of Forests, and not being a Deputy Conservator of Forests in charge of a Forest Circle, who may be transferred from one division to another division, in the language of which he has not passed either according to the Lower or Higher Standard, will be required to pass an examination according to the lower standard in the vernacular of his new division, within one year of his transfer; and in the event of his failing to do so, a reduction of 10 per cent. will be made from his salary until he has qualified, or has been transferred to another division, in the vernacular of which he has previously passed.

8. Officers of the Upper Controlling Staff of the Forest Department may, with the previously obtained permission of Government, offer themselves

for examination in any one or more of the languages of the Forest Circles of the Presidency mentioned above in addition to those in which they may be required to pass under Rules 4 and 7 and in the event of their passing will be entitled to the following language allowances:—

Rs. 250 for passing in the Lower Standard.

Rs. 500 for passing in the Higher Standard, subject to a deduction of any allowance already drawn for passing in the same language by the Lower Standard.

THE MADRAS AND BOMBAY ARMIES ACT, 1893.

[56 AND 57 VICTORIA, CHAPTER 62.]

An Act to amend the Law relating to the Madras and Bombay Armies.

[5TH DECEMBER, 1893.]

Be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) The offices of Commander-in-Chief of

Abolition of office of provincial Commander-in-Chief in India.

the forces in the Presidencies of Madras and Bombay respectively, and of Military Secretary to the Government of each of those Presidencies, are hereby abolished, and all things which by or under any Act of Parliament are required or authorised to be done by, to, or before any of the officers whose offices are hereby abolished, shall or may be done by, to, or before such officer as the Commander-in-Chief of the forces in India, with the approval of the Governor General of India in Council, may appoint in that behalf, and the Commander-in-Chief of the forces in India shall, for the purposes of section one hundred and eighty of the Army Act, be deemed to be the Commander-in-Chief in each Presidency in India.

(2) The military control and authority exercisable by the Governors in Council of the Presidencies of Madras and Bombay shall cease to be exercised by those Governors in Council, and shall be exercisable by the Governor General of India in Council, and all things which by or under the Army Act are required or authorised to be done by, to, or before the Governor in Council of the Presidency of Madras or of Bombay, shall or may be done by, to, or before the Governor General of India in Council.

(3) The officers holding at the commencement of this Act the offices of Commanders-in-Chief of the forces in the Presidencies of Madras and Bombay shall cease to be Members of the Council of the Governors of Madras and Bombay respectively.

2. The Acts specified in the schedule to this Act are hereby repealed to the extent in the third column of that schedule mentioned.

3. This Act shall come into operation at such date as the Governor General of India in Council may by Notification in the *Gazette of India* fix in that behalf.

4. This Act may be cited as the Madras and Bombay Armies Act, 1893.

Sir,—With reference to the certificates at foot of the establishment pay bill (Form 6, page 272, C. A. C.), I have the honour to point out, for the information and guidance of all officers preferring bills, that the month referred to by the words “(the last preceding month)” in Certificate No. 1 is that immediately preceding the month in which the bill is preferred for payment, *e.g.*, the bill for the salaries earned by the labour of November, which is not due for payment until the 1st of December (Article 26, C. A. C.) should have November entered in Certificate No. 1.

2. The three certificates need only be given in the case of the general establishment bill of the month, while in that of bills for arrears of pay the whole of Certificates Nos. 1 and 2, with the exception of the words “Received contents” in Certificate No. 1, should be scored out.

3. The instructions given in paragraph 1 above are applicable to Certificate No. 1 on the obverse of the travelling allowance bill (Form No. 9, page 277, C. A. C.).

POLITICAL DEPARTMENT.

Bombay Castle, 13th January 1894.

No. 212.—The Right Honourable the EARL of ELGIN and KINCARDINE, P.C., LL.D., appointed by Her Majesty the Queen-Empress to be Viceroy and Governor-General of India, is expected to arrive in Bombay at about 2 P.M. on the 20th January 1894, by the P. & O. S. N. Company's Steamship *Rome*, and will be received on arrival with all the Naval and Military honours due to his high position.

2. As soon as the *Rome* is signalled from the Light House three guns will be fired from the Saluting Battery at intervals of ten seconds.

3. At 4-0 P.M. a deputation consisting of the Chief Secretary to Government, the Military Secretary to His Excellency the Governor and one of His Excellency's Aides-de-Camp will proceed on board the *Rome* under arrangements to be made by the Director of the Royal Indian Marine.

4. The Earl of Elgin will leave the *Rome* at 4-15 P.M. and the Director of the Royal Indian Marine should be requested to consult with His Excellency the Naval Commander-in-Chief, or with the Senior Naval Officer at the Station in the absence of His Excellency, and to act in concert with him in arranging the details of His Lordship's disembarkation at the Apollo Bandar. The arrangements for landing at the Bandar will be made by the Director of the Royal Indian Marine. All other arrangements on the Bandar will be made by the Public Works Department.

5. On His Lordship's arrival at the steps of the Bandar, a Salute of 31 guns will be fired from the Saluting Battery. A Guard of Honour of British Infantry with Band and Colours will be drawn up, and the road from the Bandar

to the Victoria Terminus will be lined by troops of the Garrison. A Guard of Honour of Bombay Infantry with Band and Colours will be at Government House, Malabár Point.

6. His Lordship will be received at the Bandar by His Excellency the Commander-in-Chief and Staff; by His Excellency the Commander-in-Chief of Her Majesty's Naval Forces in India, if in Bombay; by the Chief Justice of Bombay, the Lord Bishop, the Members of Council, the Judges of the High Court, the Additional Members of the Council of His Excellency the Governor for making Laws and Regulations, the Vice-Chancellor of the University of Bombay, the Roman Catholic Archbishop, the Secretaries to Government, the Archdeacon of Bombay, the Senior Naval Officer at the Station, in the absence of His Excellency the Naval Commander-in-Chief, the Brigadier-General Commanding the Bombay District, the Naval Officers Commanding any of Her Majesty's Ships in Harbour, if able to attend on shore, the Director of the Royal Indian Marine, the Private Secretary and the Staff of His Excellency the Governor, the Municipal Commissioner, the Under Secretaries to Government, and the Heads of Departments, Civil and Military, the Sheriff of Bombay, or by such of the above high officials as are then in the Presidency Town, for whom a space marked A will be reserved.

7. The Consular representatives of Foreign Governments and the President of the Bombay Municipal Corporation are invited to be present on the occasion, and a space marked B will be reserved for them at the Bandar.

8. All other officers of Her Majesty's Services, Civil, Naval, Military and the Royal Indian Marine, and officers belonging to Corps of Volunteers, then in Bombay, as well as members of the Municipal Corporation of Bombay who are desirous of attending will be provided with seats as far as space is available. To all such who wish to attend cards of admission to space C will be supplied on application to the Executive Engineer of the Presidency. The same officer will also issue cards of admission to space A to any Heads of Departments, not specified by name in paragraph 6, who may intimate that they will be present. For all other officials and persons mentioned in paragraphs 6 and 7 no cards will be necessary. As far as accommodation in space D is available it will be allotted to any Ladies or Gentlemen who may apply for tickets to the Executive Engineer. The arrangements at the Bandar will be made by the Public Works Department.

9. As the Municipal Corporation of the City of Bombay has expressed its desire to present an address to His Excellency on his arrival, a space marked E will be reserved on the Bandar to which the Viceroy and Governor-General elect will be conducted, and where he will be received by the representatives of the Corporation. The Executive Engineer will send a card of admission to each member of the Corporation whose name is communicated to him by the President of the Corporation.

10. His Lordship will, after the presentation of the address, proceed to Government House, Malabár Point, escorted by a Detachment of His Excellency the Governor's Body Guard and the Bombay Light Horse, *via* Rampart Row, Hornby Row, Cruickshank Road, Kalbadevi Road, Parel Road, Grant Road, Gowallia Tank Road, Gibbs Road and the Ridge. No procession of carriages will be formed. The Commissioner of Police will maintain order and keep the streets clear.

11. His Lordship will be received by His Excellency the Governor on the steps of the staircase at Government House.

12. Full Dress will be worn by all officers of Government entitled to wear uniform: and morning dress by all others.
