REVENUE DEPARTMENT.

Bombay Castle, 13th November 1894.

No. 9297.—In exercise of the powers conferred by Sections 9, 10 and 19 of the Bombay A'bkári Act, 1878, His Excellency the Governor in Council is pleased to pass the following orders, subject to which the Collector may permit the import into export from the Settlement of Aden of liquor on payment of the duty and on the terms hereinafter prescribed:—

(1) Import duty shall be leviable on all liquor other than

- (a) liquor removed direct from the A'bkári warehouse to a vessel for re-export or transhipment to ports not within the limits of the Settlement, or
- (b) liquor removed for transport from one A'bkári warehouse to another within the limits of the Settlement, or
- (c) liquor supplied by licensed dealers from their stock lying in the A'bkári warehouse:
 - (i) for the use of sea-going vessels on their leaving Aden for ports not within the limits of the Settlement, or
 - (ii) for the use of vessels of Her Majesty's Royal Navy during their stay in the harbour, or for the voyage.

(2) The rates of the duty on payment of which the importation into the Settlement of Aden of the liquors specified in the table subjoined may be permitted, shall be as set forth in respect thereof in the said table.

(3) The terms on which importation of liquor into the said Settlement may be permitted are as follows:

- (a) All liquor on import shall be deposited in a warehouse in charge of the A'bkári Department and the duty shall be paid on the removal of the same from the said warehouse.
- (b) The owner of the liquor imported shall clear the same within three years from the date of deposit in the A'bkári warehouse.

Exportation.

(4) The exportation of liquor from the said Settlement may be permitted on payment of the duty payable on importation in respect of such liquor. Provided that if the Collector is satisfied that the duty payable on the import or manufacture of the said liquor has already been paid thereon or that the said liquor is being exported direct from the stock deposited on import in the A'bkairi warehouse, he may permit the export thereof without the payment of duty in respect of the export thereof,

No. 9297-A.—In exercise of the powers conferred by Section 19, clauses (c) and (d), of the Bombay A'bkári Act, 1878, His Excellency the Governor in Council is pleased to direct that the rates at which duty shall be levied on liquor manufactured within the Settlement of Aden shall be as follows:—

All liquor of a strength above 50° U.P. and under 25° U.P. shall be charged the duty on 25° U.P.

No. 9297-B.—Under Section 19, clause (e), of the Bombay A'bktir Act, 1878, it is hereby directed that duty shall be levied on the transport of liquor from any one port within the Settlement to any other port therein at the rates prescribed for the import of such liquor. Provided that the Collector may, if satisfied that duty on the import or manufacture of the said liquor has been levied thereon within the Settlement, permit the transport thereof without payment of duty in respect thereof Provided further that if the owner undertakes to produce an acknowledgment for the said liquor from the Collector of A'bkári at the place to which the liquor is to be conveyed, the Collector may permit the transport of liquor for removal from one A'bkári warehouse to another within the limits of the said Settlement.

2. No duty is leviable on the transport or removal by land of duty-paid liquor from any one place to another within the Settlement.

No. 9297-C.—In exercise of the powers conferred by Sections 17 and 47 of the Bombay A'bkári Act, V of 1878, His Excellency the Governor in Council is pleased to direct that in the Settlement of Aden no country liquor exceeding in quantity five Imperial gallons, and no intoxicating drug exceeding in quantity half an Indian ser or 40 tolas, shall be sold by retail to one and the same person in the aggregate on any one day, or be possessed by any person without license or permit obtained from a competent authority under the Act.

No. 9297-D.—In exercise of the powers conferred by Section 30 of the Bombay A'bkári Act, 1878, His Excellency the Governor in Council is pleased to make for the Settlement of Aden the following rules and orders :—

Licenses for the sale of imported Foreign Liquor.

(1) No license for the sale within the Settlement of Aden of imported foreign liquor shall have any validity unless it has been granted :

- (a) by the Collector acting under the orders of the Commissioner ;
- (b) on payment of a fee of Rs. 450; and
- (c) in the Form D annexed to these rules, and subject to the restrictions and conditions therein set forth.

(2) Every license granted in accordance with the rule last preceding shall be for a period commencing from the date thereof and ending with the 31st July next following the said date.

(3) No such license shall authorise a sale-

- (a) other than that of imported spirits, wines and liquors on which import duty at the rates prescribed by Government has been paid, or
- (b) elsewhere than at such one place only as a shall be specified in the license.

License for the manufacture and sale of Country Liquor.

(1) No license for the manufacture and sale of country liquor within the Settlement of Aden shall have any validity unless it has been granted :

- (a) by the Collector acting under the orders of the Commissioner;
- (b) on payment of a fee of Rs. 200 ; and
 - (c) in the Form E annexed to these rules, and subject to the restrictions and conditions therein set forth.

(2) Every license granted in accordance with the rule last preceding shall be for a period commencing from the date thereof and ending with the 31st July next following the said date.

(3) No such license shall authorize a sale of country liquor elsewhere than at such one place only as shall be specified in the license.

Licenses for the manufacture and sale of Intoxicating Drugs.

Every license granted for the manufacture and sale of intoxicating drugs shall contain the several particulars and shall also contain and be subject to the conditions and restrictions set forth in the Form F annexed to these rules.

No fee shall be charged for any license or permit issued in respect of intoxicating drugs.

Every license granted in accordance with the rule last preceding shall be for a period commencing from the date thereof and ending with the 31st July next following the said date.

License for the sale of imported Foreign Wines, Spirits and Liquors.

Be it known that , resident at , hereinafter called the Licensee, in consideration of the payment by him of a fee of Rupees four hundred and fifty, receipt whereof is hereby admitted, is hereby authorized by the Collector of A'bkau at

to sell imported foreign or Europe ardent spirits, liquors, wines, beer, porter, and other malt liquor from the date of the issue of this license, to the thirty-first day of July 189, subject to the conditions hereinafter mentioned, that is to say:

(1) That the licensee shall not sell or permit the sale on his behalf of any spirits, liquors, wines, beer, porter, or other malt liquors in any place other than his shop situated in and registered in the Government Grant Book under No.

(2) That there shall not be at any time during the continuance of this license any door or other means of ingress or egress into or out of the said shop, except at such entrance facing the main road as shall have been approved by the Collector in this behalf, and that the licensee shall not permit any person to enter or leave the said shop by any entrance other than the entrance approved as aforesaid.

(3) That no person shall be employed or permitted by him to sell any spirits, liquor, wines, beer, porter, and other malt liquors, unless and until the Collector has authorised in writing endorsed on this license the employment by him of such person, and that the said licensee shall forthwith dismiss from his service any person so employed by him on being required by the Collector so to do.

(4) That he shall produce this license to the Commissioner, Collector, any Magistrate or A'bkári Officer demanding such production.

[PART I

(5) That he shall not mix or permit any other person under his control to mix any substance with any of the spirits, liquors, wines, beer, porter, and other. malt liquors authorised to be sold by him, and that on demand by the Commissioner, Collector, any Magistrate or A'bkári Officer, he shall deliver up a sufficient quantity of such spirits, liquors, wines, beer, porter and other malt liquors for analysis.

6) That he shall not sell or permit to be sold on his behalf any rum weaker than eighteen degrees under-proof.

(7) That he shall keep regular accounts in such form as may from time to time be prescribed by the Collector in this behalf, showing for each day all quantities of liquor received into his shop of each kind or sold therein, together with a description of the marks, brands, seals and labels on corks, bottles and casks of all liquors received and sold and shall hold all such accounts and all stocks of liquors open to the inspection of the Commissioner, Collector and all Magistrates and A'bkári Officers.

(8) That he shall not keep any liquor elsewhere than on the premises in which he is licensed to sell.

(9) That he shall not allow any person to drink to intoxication on the said premises, and that he shall not sell any spirits, liquors, wines, beer, porter or other malt liquors to any person who is in a state of intoxication.

(10) That he shall not permit any entertainment such as concerts, dances, &c., to take place in the said premises without the previous sanction in writing of a Magistrate.

(11) That he shall not permit gambling, drunkenness or disorderly conduct in his said premises or permit persons of notoriously bad character to resort thereto.

(12) That he shall give immediate information to the police of all persons resorting to the said premises whom he has reason to suspect have committed or been concerned in the commission of any cognizable offence, and of all irregularities tending to disturb the public peace therein.

(13) That he shall not receive any ornaments or other property in barter or pawn for any such liquor as aforesaid.

(14) That he shall not between 9 P.M. and sunrise, without the special permission of the Commissioner in writing, open or keep open his pre-mises for the sale of any such liquor as aforesaid or sell or permit the sale of any liquor therein.

(15) That he shall not sell any such liquor as aforesaid to or for any non-commissioned officer or soldier serving regimentally or to or for any member of the family of any such person without a permit from the Officer Commanding the Corps to which such person belongs or from some other officer appointed by him to grant permits under the Cantonment Act XIII of 1889, Section 13.

(16) That he shall not sell any such liquor as aforesaid for removal from his premises to any seaman of Her Majesty's Royal Navy or Indian Marine or of the Mercantile Service.

(17) That he shall not sell for removal from the premises any such liquor as aforesaid to any member of any Native troop or to any public or private follower or servant of any officer of any grade in the service of Government or to any member of the family of such person except under a pass, in the case of public followers from the Officer Commanding the Corps or from the head of the department to which such person belongs, or in the case of a private servant from his master.

(18) That he shall have constantly fixed up in a conspicuous part of the front of his shop a sign-board bearing in legible characters in English the number of this license, his name and the words "Licensed to sell spirits, liquors, wines, beer, porter or other malt liquor."

(5) That I shall not mix or permit any other person under my control to mix any substance with any of the spirits, liquors, wines, beer, porter, and other malt liquors authorised to be sold by me, and that on demand by the Commissioner, Collector, any Magistrate or A'bkári Officer, I shall deliver up a sufficient quantity of such spirits, liquors, wines, beer, porter and other malt liquors for

(6) That I shall not sell or permit to be sold on my behalf any rum weaker than eighteen degrees under-proof.

(16) That I shall not sell any such liquor as aforesaid for removal from my premises to any seaman of Her Majesty's Royal Navy or Indian Marine or of the Mercantile Service.

(17) That I shall not sell for removal from the premises any such liquor as aforesaid to any member of any Native troop or to any public or private follower or servant of any officer of any grade in the service of Government, or to any member of the family of such person, except under a pass, in the case of public followers from the Officer Commanding the Corps or from the head of the department to which such person belongs, or in the case of a private servant from his master.

(2) That he shall not keep any stills except so many and such as the Collector may in writing endorsed on this license specify, and that he shall not work or permit to be worked any still between sunset and sunrise.

(3) That he shall not in distilling use or permit the use of any materials except mowra, dates, figs, raisins, rice, or molasses (jagri) of the best quality.

(4) That he shall not in distilling use or permit the use of, or put into the spirit after it has been made, any ingredients noxious to health.

(5) That he shall not put or permit to be put into the spirit after it has been gauged, tested and removed from the distillery, any sugar, colouring matter or other foreign substance or liquid other than water.

(6) That he shall not manufacture country liquor below 50° under-proof or above 25° underproof ; and the strength of the liquor manufactured shall be as near as possible of a strength of 25° U. P. or 50° U. P.

(7) That all liquor distilled at the distillery shall immediately on manufacture be stored in the warehouse attached to the distillery, and that the said warehouse shall remain under double lock and in joint charge of the licensee and an officer of the A'bkári Department.

(8) That he shall not remove or cause to be removed any liquor from the distillery premises until the liquor has been gauged and measured and until duty has been recovered thereon, and that

the removal shall take place in decordance with the rules prescribed by the Commissioner. ...(9) That he shall pay duty at the following rates on Equor manufactured and removed from the warehouse attached to the distillery :

Not above 50° under-proof - Rs. two and annas five per Imperial gallon.

- Not above 25° under-proof-Rs, three annas seven and pies six per Imperial gallon.

(14) That no person shall be employed or permitted by him to sell any country liquor unless and until the Collector has authorized, in writing endorsed on this license, the employment by him of such person, and that he shall forthwith dismiss from his service any person so employed, on being required so to do by the Collector.

(15) That he shall not sell or permit the sale on his behalf to one and the same person on any one day country liquor exceeding in the aggregate five Imperial gallons unless under the authority and in accordance with the terms of a special order duly made in this behalf under Section 17 of the Bombay Λ 'bkar Act.

(16) That he shall not without the permission of the Collector sell or permit the sale on his behalf of country liquor to any European, whether Military or Civil, or to any Native soldier, or for removal to any regimental or departmental lines.

(17) That he shall not open or keep open his shop or make sales therein between 9 o'clock P.M. and sunrise, and that he shall not harbour any person in or during that interval.

(18) That he shall not allow any person to drink to intoxication in his said shop, and that he shall not sell any country higher to any putton who is in a state of intoxication.

(19) That he shall not permit gaming, drunkenness or disorderly characters in the said distillery or in his said shop.

(20) That he shall give immediate information to the Police of all persons resorting to his shop whom he has reason to suspect have committed or been concerned in the commission of any cognizable offence and also of all irregularities tending to disturb the public peace therein.

(21) That he shall not receive any ornaments or other property in barter or pawn for the country liquor which he is licensed to sell.

(22) That on demand by the Commissioner, Collector, any Magistrate or Abkári Officer, he shall deliver up a sufficient quantity of such country liquor for analysis as may be required from the still or from his shop.

(23) That he shall have constantly fixed up in a conspicuous part of the front of his shop a signboard bearing in legible characters in the English and Arabic languages his name and the words "Licensed to sell country liquor," and that he shall also keep constantly fixed on the door of the distillery a sign-board bearing his name and the words "Licensed to manufacture Country liquor."

(24) That he shall not sell country liquor at . the distillery.

(25) That he shall keep accounts of all liquor manufactured by him and removed by him to his shop and the quantities sold daily and the stock in hand, and shall produce the said account for inspection whenever required by the Collector or any subordinate whom the Collector may depute for that purpose, and shall also furnish such returns and information as may from time to time be called for by the Collector.

(3) That I shall not in distilling use or permit the use of any materials except mowra, dates, figs, raisins, rice or molasses (jagri) of the best quality.

(4) That I shall not in distilling use or permit the use of or put into the spirit after it has been made any ingredients noxious to health.

(5) That I shall not put or permit to be put into the spirit after it has been gauged, tested and removed from the distillery, any sugar, colouring matter or other foreign substance or liquid other than water.

(6) That I shall not manufacture country liquor below 50° under-proof or above 25° underproof, and that the strength of the liquor manufactured shall be as near as possible of a strength of 25° U. P. or 50° U. P.

(7) That all liquor distilled at the distillery shall immediately on manufacture be stored in the warehouse attached to the distillery and that the said warehouse shall remain under double lock and in joint charge of myself and an officer of the A'bkári Department.

(S) That I shall not remove or cause to be removed any liquor from the distillery premises until the liquor has been gauged and measured and until duty has been recovered thereon; and that the removal shall take place in accordance with the rules prescribed by the Commissioner.

(9) That I shall pay duty at the following rates on liquor manufactured and removed from the warehouse attached to the distillery :
