No. 8417A.—The following rule made by the Sadar Court in Sind under Section 16 of Bombay Act XII of 1866 has been sanctioned by His Excellency the Right Honourable the Governor in Council with effect from the date of this Notification and is hereby published for general information:—

Rule.

"The fee prescribed by Rules 2 and 19 of the rules made by the Sadar Court in Sind, under Section 16 of Bombay Act XII of 1866, for the qualification and admission of proper persons to be Pleaders in the Courts in the Province of Sind and published at pages 226 and 227 of the Bombay Government Gazette of the 16th March 1876, shall hereafter be Rs. 250 instead of Rs. 15."

No. 8470.—The following Order of Her Majesty in Council approving the Rules made ander the Colonial Courts of Admiralty Act, 1890, by the Judge of the Sadar Court of Sind for regulating the procedure and practice in cases brought before the District Court of Karáchi under the Colonial Courts of Admiralty Act, 1890, is published for general information:—

" AT THE COURT AT BALMORAL,

The 15th day of October, 1894.

PRESENT:

THE QUEEN'S MOST EXCELLENT MAJESTY.

LORD PRESIDENT. LORD CHAMBERLAIN. Mr. BRYCE.

Whereas there was this day read at the Board certain Rules made under the Colonial Courts of Admiralty Act, 1890, by the Judge of the Sadar Court of Sind for regulating the procedure and practice in cases brought before the District Court of Karáchi:

Her Majesty having taken into consideration the said Rules (a copy of which is hereunto annexed) was pleased by and with the advice of Her Privy Council to approve the same.

- Rules for Regulating the Procedure and Practice in Cases brought before the District Court of Kara'chi under the Colonial Courts of Admiralty Act, 1890, and the Indian Act XVI of 1891, entitled the Colonial Courts of Admiralty (India) Act.
- 1. In the construction of these rules, the following terms shall (if not inconsistent with the context or subject-matter) have the respective

- meanings hereinafter assigned to them; that is to say:—
 - 'The Court' shall mean the District Court of Karachi.
 - 'Judge' shall mean the Judge of the said Court.
 - 'Registrar' shall mean the Chief Clerk appointed to be the Admiralty Registrar of the said Court.
 - 'Registry' shall mean the office of the said Chief Clerk or Admiralty Registrar.
 - "The Nazir of the Court' shall mean the Nazir of the District Court, and all processes of the Court shall be executed by him or by one of the officers subordinate to him.
 - 'Code' means the Code of Civil Procedure, or other law in force for the time being, regulating the procedure of the said Court.
 - 'Suit' shall mean any suit, action, or other proceeding instituted in the said Court in its jurisdiction under the Colonial Courts of Admiralty Act.
 - 'Affidavit' shall, in addition to its ordinary meaning, include a statement in writing on solemn affirmation wherever by law'a person may make a solemn affirmation instead of an oath.
 - 'Party' includes for purposes of Court procedure not only the party himself, but his legal representative (Barrister, Solicitor, or Pleader) duly admitted to practise before the District Court of Karáchi, under the rules in force for the time being as to the admission of Pleaders to practise in the Sadar and District Courts.
- 2. These rules shall if previously approved by Her Majesty in Council, come into operation on the 1st day of January 1895, and shall apply to all suits instituted on and after that day.

Institution of Suits.

3. A suit shall be commend I by a plaint drawn up, subscribed and verified according to the provisions of the Code, and the practice throughout shall, as far as is compatible with those rules, be that laid down in the Code.

Warrants.

- 4. When a suit is instituted in rem, any party may, on filing an affidavit, obtain from the Court a warrant for the arrest of the property proceeded against.
- 5. In a suit of necessaries and in a suit of wages, the national character of the vessel proceeded against shall be stated in the plaint; and in a wages suit against a foreign vessel, notice of the institution of the suit shall be given to the Consul of the State to which the vessel belongs if there be one resident in Karáchi; or in Bombay if there be no such Consul residing in Karáchi, and either a copy of the notice and an affidavit of service thereof or an affidavit that there is no such resident Consul shall be annexed to the plaint.

- 6. When it seems advisable, the Court may allow the warrant to issue though the affidavit or plaint may not contain all the required particulars, and in a suit of wages may also waive the service of the notice.
- 7. Every warrant shall be served by the Názir or his Bailiff. The party obtaining the order for the issue of the warrant shall, within six days from the service thereof, file all the affidavits or other evidence necessary to prove the service thereof in the Registry.
- 8. In suits in rem, service of summons or warrant against ship, freight, or cargo on board, is to be effected by nailing or affixing the original summons or warrant for a short time on the main mast or on the single mast of the vessel, and on taking off the process by leaving the copy of it issued under the provisions of the Code nailed or affixed in its place.
- 9. If the cargo has been landed or transhipped, service of the summons or warrant to arrest the cargo and freight shall be effected by placing the summons or warrant for a short time on the cargo, and, on taking off the process, by leaving the true copy aforesaid upon it.
- 10. If the cargo be in the custody of a person who will not permit access to it, service of the summer's or warrant may be made upon the custodian under the usual rules as to the service of a summons or corresponding order in execution proceedings contained in the Code.

Suits in rem by default.

- 11. If, on the date fixed for hearing, no appearance is made for the defendant in the suit, the Court may proceed ex parte, and if appearance is made, the Court will proceed in the usual manner under the Civil Procedure Code.
- 12. If the suit proceeds cx parts and the Judge is satisfied that the plaintiff's claim is well founded, he may pronounce for the claim and may order the property to be sold with or without previous notice and the proceeds paid to the Názir, or may make such order as he shall think just.

Entry of appearance.

- 13. A party, desiring to enter an appearance in any suit, shall file a written statement before the day set down for the first hearing or settlement of issues.
- 14. The written statement shall contain, besides the name of the party, an address in Karachi, at which it shall be sufficient to leave all instruments and documents in the suit, in addition to the details required in written statements by the Code.

Security.

15. If security is to be given in the Registry, it shall be given according to the rules and practice of the Court as to security in the case of an attachment before judgment in an ordinary civil suit.

Releases.

16. Property arrested by warrant shall only be released under the authority of an order in writing issued by the Court to be called a release.

- 17. A party at whose instance any property has been arrested may, before an appearance has been entered, obtain the release thereof by filing an application to withdraw the warrant.
- 18. A party may obtain the release of any property by paying to the Nazir the sum in which the suit has been instituted.
- 19. Cargo arrested for the freight only may be released by an order of the Judge in Chambers upon proof, by affidavit, of the value of the freight, and on payment of the amount of the freight to the Názir.
- 20. In a suit of salvage, the value of the property under arrest shall be agreed to or proved by affidavit to the satisfaction of the Judge in Chambers before the property is released.
- 21. When security shall have been given in the sum in which the suit has been instituted, or such sums shall have been paid into Court and if the suit be one of salvage when the value of the property arrested shall have been proved to the satisfaction of the Judge in Chambers, he shall grant a release for the property arrested, unless there be a caveat against the release thereof outstanding in the "Caveat Release Book."
- 22. The order of release shall be sent to the Názir, to whom the party on whose application the order of release was made shall pay all costs, charges and expenses attending the care and custody of the property whilst under arrest, and the Názir shall thereupon release the property.

Caveat Release Book.

- 23. A party in a suit, 'desiring to prevent the release of any property under arrest, shall file an application to that effect, duly supported by affidavit, and thereupon a caveat against the release of the property shall be entered in a book to be kept in the registry, called the "Caveat Release Book."
- 24. A party delaying the release of any property by the entry of a caveat shall be liable to be condemned in costs and damages, unless he shall show, to the satisfaction of the Court, good and sufficient reason for having so done.

Caveat Warrant Book.

- 25. A person desiring to prevent the arrest of any property may cause a caveat against the issue of a warrant for the arrest thereof to be entered in the Registry.
- 26. For this purpose, he shall cause to be filed in the Registry a notice, duly signed by himself or his legal representative, undertaking to enter an appearance in any suit that may be instituted against the said property, and to give security in such suit in a sum not exceeding an amount to be stated in the notice, or to pay such sum into the Registry, and a caveat against the issue of a warrant for the arrest of the property shall thereupon be entered in a book to be kept in the Registry called the "Cayeat Warrant Book."

- 27. A party instituting a suit against any property in respect of which a caveat has been entered in the "Caveat Warrant Book" shall, before filing the plaint, serve a copy thereof upon the person on whose behalf the caveat has been entered, and shall annex to the plaint an affidavit of such service.
- *28. Within three days from the filing of the plaint, the person on whose behalf the caveat has been entered shall, if the sum in which the suit has been instituted does not exceed the amount for which he has undertaken, give security in such sum, or pay the same to the Názir, or, if it exceeds that amount, give security in the sum in which the suit has been instituted or pay the same to the Názir.
- 29. After the expiration of three days from the filing of the plaint, if the party on whose behalf the caveat has been entered shall not have given security in such sum or paid the same to the Názir, the plaintiff may ask the Court to proceed with the suit by default and to pass judgment: provided that the Court may, on good cause shown and on such terms as to payment of costs as it may impose, extend the time for giving security or paying the money to the Názir.
- 30. If, when the suit comes before the Court, it is satisfied that the claim is well founded, it shall pronounce for the amount which appears to be due, and may enforce the payment thereof by order and attachment against the party on whose behalf the caveat has been entered and by the arrest of the property, if it then be or thereafter come within the jurisdiction of the Court.
- 31. The preceding rules shall not prevent a party from taking out a warrant for the arrest of any property, notwithstanding the entry of a caveat in the "Caveat Warrant Book," but the party, at whose instance any property in respect of which a caveat is entered shall be arrested, shall be liable to be condemned in costs and damages, unless he shall show, to the satisfaction of the Court, good and sufficient reason for having so done.

Sales by order of the Court.

- 32. Every sale under the decree of the Court shall, unless the Judge shall otherwise order, be made by the Názir in like manner as a sale of moveable property in execution of a decree in an ordinary civil suit, subject to the rules as to Court fees and other fees in force at the time.
- 33. The Nazir shall pay into Court the gross proceeds of sale of any property sold by him, and shall at the same time bring into the Registry the account of sale, with vouchers in support thereof, for taxation by the Taxing Officer of the Court, to whom the same shall be transmitted for that purpose.
- 34. Any person interested in the proceeds may be heard before the Taxing Officer on the taxation of the account of expenses, and an objection to the taxation shall be decided by the Judge of the Court.

Payment of Moneys.

35. All money paid into Court shall be paid to the Názir.

- 36. Money paid into Court shall not be paid out of Court except in pursuance of an order of the Court.
- 37. Security for latent demands shall not, unless the Judge shall otherwise order, be required on the payment of money out of Court.
- 38. A party desiring to prevent the payment of money out of Court shall file a notice, duly supported by affidavit, and thereupon a caveat shall be entered in a book, to be kept in the Registry, called the "Caveat Payment Book."

Applications.

- 39. Forms of applications to be filed in the Registry or the Názir's Office may be obtained on application in the Registry. They may be varied or altered by the Judge at his discretion.
- 40. Every application shall be signed by the party,
- 41. If an application be not properly filled up, the Registrar or the Názir may refuse to receive the same or to act thereon, without the order of the Judge to whom he shall refer the matter, if the party desires this to be done.

Caveats.

- 42. A caveat, whether against the issue of a warrant, the release of property, or the payment of money out of Court, shall not remain in force for more than six months from the date thereof.
- 43. A caveat may be withdrawn by the party on whose behalf it has been entered.
- 44. Application may be made to the Court, or to the Judge in Chambers, to overrule any caveat.
- 45. The fees to be paid in all proceedings, whether in Court fees or in money, shall be regulated by the table of fees and rules sanctioned from time to time for proceedings under the original civil jurisdiction of the District Court of Karáchi.
- 46. The forms used in the Admiralty Division of the Supreme Court in England, under the rules of the Supreme Court, 1883, shall be followed as nearly as the procedure laid down in the Code and by these rules and as the circumstances of each case will allow.
- 47. The other proceedings in suits brought in the Court in the exercise of its jurisdiction under the Colonial Courts of Admiralty Act, 1890, not provided for by these rules, shall be regulated by the rules and practice of the Court in suits brought in it in the exercise of its Ordinary Original Civil Jurisdiction.
