No. 4939.—The following Resolution of the Government of India, Department of Finance and 1.—223

Commence, No. 2498, dated 30th August 1879, is published for general information:—

"Read the Proceedings of the Government of Madras in the Revenue Department, Nos. 487 and 492, for the month of May 1879.

RESOLUTION.—It appears from these Proceedings that a question arose in Madras as to the liability to duty of fire-arms and apparel imported by a passenger as personal baggage, a claim having been made for the exemption from duty upon a gun, because it was the personal property and part of the baggage of a Military Officer.

2. The Government of Madras ascertained on enquiry that in Calcutta the practice was to admit free of duty one gun or rifle belonging to a Military Officer, and that apparel is passed free, except when new and unused, in which case it is charged with duty. At Bombay the practice is to charge duty on arms except those which form part of the owner's official equipment. All apparel intended for personal use, whether new or not, is passed free.

- 3. The Government of Madras has directed the adoption of the practice of the Bombay Custom House, in regard to both arms and apparel.
- 4. As regards arms, the practice of the Bombay Custom House is correct, and should be generally adopted. Only arms of regulation pattern, forming part of the equipment with which, by the rules of the service, an officer entitled to wear diplomatic, military, or public uniform, is bound to provide himself, are free of duty, but this exemption does not extend to other arms with which an officer is not required to furnish himself ex officio. All these should be charged with duty under the Indian Arms Act, unless it can be shown that duty has been paid thereon on previous importation, or that they form part of the obligatory equipment of the officer importing them.
- 5. As regards apparel, too, the practice of the Bombay Custom House is reasonable, but Custom House Officers should exercise judgment and discretion in this matter. It is obvious that a strict rule exempting all new apparel from duty, because it forms part of a passenger's baggage, would open the door widely to evasion of the revenue and illegitimate competition with ordinary trade. Whether new apparel imported as baggage should be exempted from duty or not should depend upon the position of the owner and the circumstances of the case generally."

SIR,

I am directed to acknowledge the receipt of your letter No. 1163, dated the 8th May last, with enclosure, on the subject of the arrival at Aden of the S.S. Madras from Singapore and Penang carrying a number of native passengers in excess of that allowed by 'the Native Passenger Ships Act, 1876.' It is said that, as the S.S. Madras was protected by the certificate granted by the licensing officers at Singapore, no proceedings were instituted under the Act against the master of the ship by the Resident; and His Excellency the Governor of Bombay accordingly considers it advisable that the system under which such certificates are given should be re-considered, and that a communication should be made to the Government of the Straits Settlement on the subject.

- 2. In reply, I am to say that it appears, from the precis forwarded with your letter under acknowledgment, that the points which require consideration in connection with the present case
 - (1) the proper interpretation to be placed upon the term 'between decks' for the purposes of the Native Passenger Ships Act (VIII of 1876); and
 - (2) the question whether the Resident at Aden was correct in holding that the master of the S.S. Madras was protected (under the provisions of section 37) from proceedings under Act VIII of 1876, by virtue of the license granted at the port of departure by the licensing officers at Singapore. the first point, the Solicitor to the Bombay Government appears from the précis to have expressed an opinion that 'the between decks only of the S.S. Madras, i.e., the space between her upper and lower decks, and no more, should be taken into consideration in calculating the number of passengers she is entitled to carry under the Native Passenger Ships, Act, 1876.' As regards the second point, the Solicitor to Government considered that the course adopted by the Resident was in accordance with the provisions of Act VIII of 1876.
 - 3. With reference to the correct interpretation to be placed upon the words 'between decks' for the purposes of the Act, I am to observe that it is scarcely possible, in the absence of the opinion of the Solicitor to the Bombay Government, which should have been forwarded in extenso, to say whether that officer held that in no case should the lower (as opposed to the upper) 'between decks' be calculated in determining the number of passengers which can legally be conveyed under the Act; or whether his opinion, that in the case of the S.S. Madras the lower 'between decks' should not be taken into consideration was been accounted. into consideration, was based on information which came to his knowledge that the space, included in the term 'lower between decks' in that particular vessel, was unfit for passengers.
 - In the former case, I am to say that the Governor General in Council does not consider that the opinion can be sustained. Both from a practical and from a legal point of view, it appears to His Excellency in Council that the expression between decks, as used in the Native Passenger Ships Act of 1876, includes every space comprised between any two habitable decks. This appears clear not only from the expression itself and from the meaning ordinarily attached to it, but also from the way in which it is used in the Act simply as distinguished from the 'upper deck,' or deck which is covered only by an awning, and not as indicating any particular floor or flat of the ship.

The Governor General in Council is unable to perceive any sufficient ground for holding that in the case of a vessel with three decks inclosing two habitable spaces, the upper only of those spaces is to be considered the 'between decks' within the meaning of the Act and not the lower space; and His Excellency in Council entertains little doubt but that the intention of the framers of the Act was that both such spaces should be included in the term 'between decks.'

- 5. While, however, of opinion that the proper interpretation to be placed upon the term 'between decks' is that described in the foregoing paragraph, the Governor General in Council recognizes the fact that the lower space would naturally, as a rule, be less commodious and less well ventilated than the upper; and it might often happen that such lower space would be so unfit for passengers that it could not be calculated as passenger space under Chapters III and IV of the Native Passenger Ships Act. This, however, is a question which should be decided by the officer granting the certificate under section 10 of the said Act, upon whom it devolves to determine whether any particular space, which it is proposed to appropriate to passengers, is fit to be so appropriated. In connection with this point, attention is invited to the letter from this Department No. 175, dated the 4th July 1879.
- 6. With reference to the second point, viz, whether the Resident at Aden was correct in holding that the master of the S.S. Madras was protected (under section 37) from proceedings under the Native Passenger Ships Act, by virtue of the license granted at the port of departure by the licensing officers at Singapore, the Governor General in Council is advised that section 37 of Act VIII of 1876 does not allow the number of passengers on board a ship coming into a British port to exceed the proportion fixed by the Act,

It prescribes that the number must not exceed either the proportion fixed by the Act, or that allowed by any license or certificate granted at the port of departure, i.e., that it must not be greater than the smaller of the two. Under this view the S.S. Madras was not necessarily protected by the license granted at Singapore; and it would have been legally possible for the authorities at Aden to proceed against the master of the vessel under section 37 of the Act, if the vessel came into that port with a number of passengers exceeding that allowed by sections 19, 22 and 49 of Act VIII of 1876. But it may be added, that, inasmuch as the question whether a particular deck in a ship is or is not fit for passengers is one of degree as to which opinions may differ, local officers should be very cautious in regard to the institution of proceedings on the ground that a deck, which had been passed by a Government officer in another British possession is, in their opinion, unfit for the accommodation of passengers. In such a case it would, as a rule, be better to abstain from proceedings against the master of the vessel; and to bring the matter to the notice of Government in order that, if considered expedient, a representation might be made regarding the action of the Colonial authorities.

No. 5582.—Under the provisions of Section XIV. of (Bombay) Act VI. of 1863, the Honourable the Governor in Council is pleased to sanction the following subsidiary rules framed for Public Land Conveyances in Aden, and a Table of Fares for Bullock Carts :-

Subsidiary Rules relating to Public Land Conveyances plying for hire in the Town, Suburb and the Cantonment of Aden.

- Every public land conveyance shall attend for inspection at such times and places as the Assistant Political Resident in charge of the Aden Police may appoint, under penalty of revocation of its license.
- 2. Every bullock cart shall be provided with a break or catch, which shall invariably be used when driving down the Hills, under penalty of revocation of its license.
- Every attendant of a public land conveyance, when engaged in his occupation, shall wear clean and decent dress, consisting of a cap or turban, a coat, and a pair of trowsers or pantaloons.
- The following taxes are leviable on each public land conveyance plying for hire :-

Carriage to carry passengers ... Rs. 3 per month. Bullock cart to carry goods only. " 2

The said tax shall be paid quarterly in advance. Non-payment of the tax in advance will render the license void.

- A fee of one rupee shall be charged for each attendant's license and its accompanying badge.
- 6. Every change of driver or attendant of a public land conveyance shall be notified by the owner thereof to the Assistant Political Resident in charge of the Aden Police.

"DISPOSAL OF ROYAL ENGINEER OFFICERS. Extract from the Proceedings of the Govern-ment of India, Public Works Department, Nos. 1605-27E.—G., dated Simla, the 3rd September 1879.

Read again-

Resolution in the Department of Finance and Commerce No. 2079, dated 31st July 1879.

RESOLUTION.—In paragraph 3 of this Resolution it was announced that the Government of India was not in a position to state the measures that would be taken to reduce the Departmental Staff of Officers of Royal Engineers.

2. Her Majesty's Government has decided that Officers of the Royal Engineers for whom there is no available employment in the Public Works Department, must either take special leave and await an opening for re-employment, or revert to Military duty.

Local Governments and Administrations are, therefore, directed to forward to the Government of India in the Public Works Department the names of all Royal Engineer Officers for whom they have no further employment, intimating at the same time the wishes of the Officers in regard to leave or reversion to Military duty.

4. The conditions of the special leave of absence are as follows :-

(1). This leave will in the first instance extend to two years.

(2). Officers who are granted this special leave in case of their leaving India, must go and return at their own expense, unless called upon to return before the expiry of the period of leave, when their return passage will be

(3). The allowances of an Officer on special leave will be those he would receive if he went. on furlough, when furlough was due to him.

(4). The special leave may be taken in continuation of any other leave except privilege leave, which must be commuted into special

(5). The special leave on the pay specified in clause 3 will count as service in every respect except that, in the case of the Imperial Establishment where furlough has not been earned, the seven years' Indian service shall be subsequently made up, if required.

(6). If furlough is taken within three years of return from special leave, the average emo-luments of an Officer will be calculated as if he had been on duty in India on his last appointment for the portion of the special leave included in the three years.

(7). The special leave will begin from the date on which an Officer is relieved of his duty, and will terminate on the date of his rejoining.

(8). No temporary promotions will be made in succession to Officers accepting these terms."

"No. 851.—The following Military letter from the Right Honourable the Secretary of State for India is published for general information :-

MILITARY. INDIA OFFICE; No. 206. London, 31st July 1879.

To His Excellency the Right Hon'ble the Governor General of India in Council.

My LORD,

Para. 1.—I have received and considered in Council your Military letter No. 130 of the 24th April last, on the question of the grant of passages to officers ordered out for special duty, or on account of the exigencies of the service, and of the pay to be issued for the period of the voyage to India and the voyage home, in the event of the officers returning to this country to avail themselves of the residue of their furlough.

- Your Government observe that you would merely allow officers a free passage out, but not a return passage home, furlough pay only being granted during both periods, but with the privilege of counting those periods as service for pension, and as exclusive of the residue of furlough due. You would also impose no limit to the time with-in which an officer might take the balance of his furlough after the termination of the duty for which he was re-called.
- 3. I accept the views of your Government as thus expressed.

No. 791.—With reference to General Order No. 123, dated 16th February 1870, the following General Order by the Government of India, No. 852 dated 5th September 1879, is republished: -

" PAY AND ALLOWANCES.

No. 852.—In modification of G. G. O. No. 180 dated 8th February 1870, it is notified that a battery sergeant-major or battery quarter-master sergeant of Royal Artillery, or company sergeantmajor of Royal Engineers, is not entitled to the pay provided for those ranks unless he is borne on the strength of his battery or company and mustered as such. When not so mustered, he will be paid as a sergeant, and in such case the difference of pay between that of sergeant and that of the above ranks will be issued to the non-commissioned officer actually performing the. higher duty.

The battery sergeant-major, battery quartermaster sergeant, or company sergeant-major, will, however, retain the pay of his rank when—

(a) on furlough,(b) in hospital,

(c) going through a course of training for the appointment of riding-master (battery sergeant-major and battery quartermaster sergeant only),
