No. 1334.—The following provisional programme of study for the Agricultural classes attached to High Schools is published for general information:—

Students entering the classes must be learning a High School Standard (i.e., one of Standards IV—VII).

At the end of the first year the students will be examined in the subjects mentioned below:—

First Year's Course.

- 1. Chemistry. Preparation and properties of xygen, Hydrogen and Nitrogen. Carbon, its Oxygen, Hydrogen and Nitrogen. Carbon, its varieties and properties. Carbonic Anhydride, its preparation and properties. air and water. Combustion. The Chemistry of
- 2. The Introductory Science Primer No. 1 of the Series by Huxley.
- 3. Elementary Physics. Science Primer No. 3 by Balfour Stewart to the end of page 105 (i.e., omitting Electricity).
- 4. Agriculture by Tanner (Science Primer Series).

Those students only who pass a satisfactory examination will be permitted to enter on the second year's course.

At the end of the second year the students will be examined in the course specified below. No student will be permitted to appear for the examination who has not passed under the A. V. Standard V., before the Public Service Examination Committee.

Second Year's Course.

- 1. Chemistry. Science Primer No. 2 by Roscoe-
- 2. Physics. The whole of Science Primer No. 3.

- Science Primer by Hooker. 4. Botany. (Johnston's Botanical Diagrams should also be studied.)

- 6. Geology by Professor Geikir, Science Primer No. 5.

7. Voluntary subjects in which students may obtain additional certificates:

1. Land Surveying.

2. Drawing.

 Physiology (Huxley's).
 Botany. (The exact course will be specified hereafter.)

Students who pass the examination will obtain certificates, and an additional certificate will be given for each of the voluntary subjects.

- (1). Classes will be formed in December of each year, and the first examination will be held in December 1880.
- (2). Boys taking up the Agricultural Course will be excused the Classical language, and after obtaining a First Class Public Service Certificate will be excused History and Geography lessons.
- (3). Boys who pass in the examination for the second year of the Agricultural class will be eligible for admission to the Civil Engineering College in the lower or non-University Class.
- (4). The Principal of the Poona Civil Engineering College will supply papers for the Annual Examination, and will class the pupils of the several schools in one list according to merit.
- (5). Revenue Officers in filling up appointments for which boys who have passed Anglo-Vernacular Standard V. (Public Service Certificate First Class) or Anglo-Vernacular Standard VII. (Matriculation) are eligible, are invited to give a preference to boys holding the Second Year High School Agricultural Certificate.

No. 5084.—His Excellency the Governor in Council is pleased to publish for general information the following Proclamation which has been issued at Kabul:-

I, General Roberts, on behalf of the British Government, hereby proclaim that the Amir having by his own free will abdicated, has left Afghanistan without a Gov-In consequence of the shameful outrage upon its Envoy and Suit the British Government has been compelled to occupy by force of arms Kabul, the Capital, and to take Military possession of other parts of Afghanistan. The British Government now commands that all Afghan authorities, Chiefs and Sirdars do continue their functions in maintaining order, referring to me whenever necessary. The British Government desires that the people shall be treated with justice and benevolence, and that their religious feelings and customs be respected. The services of such Sirdars and Chiefs as assist in preserving order will be duly recognized. But all disturbers of the peace and persons concerned in attacks upon the British authority will meet with condign punishment. The British Government after consultation with the principal Sirdars, tribal Chiefs, and others representing the interests and wishes of the various Provinces and Cities, will declare its will as to the future permanent arrangements to be made for the good government of the people.

No. 904.—The following General Order by the Government of India, No. 1054 dated 24th October 1879, is republished:—

"ORDNANCE AND EQUIPMENT.

No. 1054.—

- 1. The Government of India having had before them the report of a Special Ordnance Committee appointed under instructions from Her Majesty's Government to consider the question of reducing and systematizing Ordnance Indents on Europe, and the reserves to be maintained in India, are pleased thereon to notify the following orders as applicable to the three Presidencies.
- 2. The established proportion of reserves of Ordnance Stores, as recommended by the Committee and laid down in Appendix XVIII. of their Report, shall in future govern the amount of reserves to be maintained in India, subject to such alterations which from time to time may beconsidered desirable.

- 3. The 'Code of Regulations for the Indian Ordnance Department,' which has received the sanction of the Government of India, shall in future be taken as the standing authority on matters therein treated, and the provisions, with the exception mentioned in paragraph 6 of this order, shall be brought into operation from 1st January 1880.
- 4. The approved 'Regulations for the Equipment of Her Mujesty's Army serving in the Indian Empire, Ordnance Stores,' shall in future be taken as the standing authority on matters therein treated, and the provisions, with the exception already referred to, shall be brought into operation from 1st January 1880.
- 5. Errataembodying Government orders issued subsequent to the date of publication of the 'Code' and 'Regulations' referred to in paragraphs 3 and 4 of this order, are in course of preparation, and will be shortly issued. Meantime, any orders of the Government of India published since the above date, which affect the provisions, &c., of the 'Code' and 'Regulations,' are to be considered as authority for making the necessary modifications.
- 6. Ledgers and forms, termed 'Indian Ordnance Form' (I. O. Form), drawn up for use in connection with the 'Code' and 'Regulations,' shall be brought into operation on the 1st April 1880.
- 7. The authorised vocabularies of Stores in India shall in future be—
 - (a.) The latest War Office edition of the priced Vocabulary of Stores used in Her Majesty's Service.
 - (b.) The Vocabulary of Stores used in Her Majesty's Service, with an Indian Addendum:
- all Ordnance Stores shall in future be described in the nomenclature and under the sectional order of the vocabularies, and no alterations or additions shall be made therein without the authority of the Government of India.
- 8. The accounts in Ordnance Factories shall in future be rendered as provided for in the Ordnance Code, and the statistical information thereon shall be prepared and submitted to Government by Examiners of Ordnance Accounts as laid down in paragraphs 159 to 167 and Appendix XXIII. of the Committee's report.
- 9. Copies of that report, of the Code, Equipment Regulations (with errata), ledgers and forms will be circulated as soon as possible to officers concerned.
- 10. Any remarks and observations regarding the Ordnance Code and Indian Addendum of Vocabulary which local Inspectors General of Ordnance and Magazines may desire to make should be submitted, through the respective Governments under which they are serving, to the Government of India.
- 11. When the 'Code,' 'Regulations,' and Vocabularies have been in operation for one year, Officers Commanding Regiments of Cavalry and Infantry and Batteries of Artillery, as well as all Heads of Departments affected by the rules and regulations, should submit to the Government of India, through the recognized channels, such obser-

vations' and remarks as may assist in supplying omissions, correcting inaccuracies and generally revising these publications, so as to make them more perfectly applicable to the three Presidencies than a first edition of such works can be expected to be."

" PAY AND ALLOWANCES.

No. 1055.—With the sanction of Her Majesty's Government, the following Articles of the Royal Warrant of 1st May 1878 are made applicable to India, with effect from the 1st December 1876, and published for information.

2. In accordance therewith, the following rates of pay and Indian allowances will be admissible to subaltern officers of British Cavalry and Infantry in supersession of those laid down in G. G. O. No. 731 of 12th July 1872:—

 - (b) To a Lieutenant of one of our regiments of Militia, or to a Lieutenant of our Royal Malta Fencible Artillery, under such regulations as may be issued from time to time by our Secretary of State. These officers shall pass such an examination as may be fixed from time to time by our Secretary of State before they receive a Commission as Second Lieutenant.
 - (c) To a non-commissioned officer who is recommended for promotion by our Commander-in-Chief, and who shall have passed such a professional examination as may be fixed from time to time by our Commander-in-Chief with the approval of our Secretary of State.
- '6. A Second Lieutenant of our Cavalry or Infantry may, on the occurrence of a vacancy, receive a commission as Lieutenant under such regulations as may be fixed from time to time by our Commander-in-Chief, with the approval of our Secretary of State.
