and amend the law relating to Ports and Port-charges was referred, have considered the Bill and the papers noted in the margin, and have now the honour to submit this our Report, with the Bill as amended by us annexed thereto.

2. In section 3 we have, at the instance of the Government of Bengal, de-

clared, with reference to enactments in which mention is made of master-attendant, that "port-officer" and "master-attendant" are synonymous expressions. We have also, on the advice of the Bengal Chamber of Commerce and the Calcutta Port Commissioners, omitted the definition of "owner," Chamber of Commerce and the Calcutta Port Commissioners, omitted the definition of "owner," and we have made it clear by the definition of "ton" that the proposed Act is concerned with net, and not gross, tonnage.

3. To section 6, sub-section (1), we have added a clause (clause (p)) in the terms of the second of the additional clauses in Madras Act II of 1872. We have also added a sub-section requiring portrules to be hereafter made after previous publication in the manner set forth in section 6 of the General of t ral Clauses Act, 1887.

- 4. We have not considered it necessary, as suggested in one of the papers before us, to amend section 7 so as to define more clearly the position of the port-officer. In Calcutta the port-officer is not the subordinate of the Port Commissioners. In Bombay he is, and will continue to be, as deputy conservator, the subordinate of the Port Trustees, who hold and will continue to hold the office of Conservator.
- 5. Nor have we considered it expedient, with reference to another paper before us, to modify section 8 so as to require notice of a direction under that section to be in writing. There are circumstances in which notice must be given orally or by signal.
- 6. We have so modified section 14 as to remove an objection to the repeal of Bengal Act III of 1872.
- 7. We have omitted from section 21 the clause which had been suggested by the case reported at I. L. R. 9 Cal. 849. The Trustees of the Port of Bombay accepted the clause, but the Calcutta Port Commissioners, in whose interest the clause was inserted, and the Bengal Chamber of Commerce, have objected to it.
- 8. Certain amendments in section 31 have been proposed by the Trustees of the Port of Bombay, but the difficulties brought to our notice may, in our opinion, be overcome by action under section 4, sub-section (1), clause (c), or by the licensing of certain masters as pilots, or by both means. The case of inland steam-vessels is covered by section 68, sub-section (1), of the Inland Steam-vessels Act, VI of 1884.
- 9. In section 37 of the Bill as revised we have made special provision with respect to the grouping of ports and the levy and expenditure of port-dues in ports which have been grouped either by the Act or in pursuance of powers conferred thereby.
- 10. In section 39 and Schedule I, Part I, we have maintained existing arrangements as regards ballam-boats in the Port of Chittagong.
- 11. In the Second Schedule, Part II, we have inserted the scale of fees proposed by the Madras Chamber of Commerce and Harbour Trust Board, as modified by the Local Government. The medications made by that Government will appear from its order of the 1st instant, which is in the following terms:—
- "The Government entirely approve of the complete separation of Madras from the eastern group of ports as set forth in the draft schedule now proposed by the Chamber of Commerce and the Harbour Trust Board.
- 2. It is observed, however, that the proposed maximum charges on coasting ships and steamers disturb the relation which has hitherto existed between the dues leviable on these two classes of vessels, the latter being at present liable to pay twice as much as the former. The Government think that this proportion should be preserved and would, therefore, raise the maximum charge on coasting steamers calling at Madras to 3 annas a ton.
- 3. The proposed schedule reduces very considerably the rates chargeable on 'foreign vessels' entering the Madras port. The maximum rate now leviable is 8 annas a ton, and the actual charge was 6 annas until it was reduced to $4\frac{1}{2}$ annas by G.O., 27th April 1888, No. 161. A further reduction to 3 annas is now proposed. The future receipts and charges at Madras under the present rates have been estimated by the Presidency Port-officer at Rs. 1,33,200 and Rs. 1,03,900, respectively (in round numbers), as shown below:—

The reduction of item (b) of receipts by one-third would almost entirely destroy the estimated surplus. and the Government consider that this is a loss which the port could not, in the long run, be able to afford. At present no doubt the port is in a prosperous condition, having accumulated a considerable surplus which will operate as a reserve to meet special charges, and which, when invested, will yield an annual income. But this state of things may not last, and it may ultimately be necessary to increase the revenue from port as well as from harbour dues, in order to meet the charges of harbour improvements. Without, therefore, in any way implying that the dues should be raised at present, but on the contrary with every readiness to sanction a further reduction of existing rates with reference to the surplus now in hand should the Chamber and the Harbour Trust Board desire it, the Government consider that a higher maximum should be authorized in the Act. This maximum they would fix at 6 annas a ton.

- 4. Subject to these remarks, the draft schedule will be forwarded for the favourable consideration of the Government of India."
- 12. The Trustees of the Port of Bombay have consented to waive the privilege, which they have exercised since 1873, of fixing the rates of port-dues for that port. Hence the alterations in sections 33, 34, 46 and 47 and in Schedule I, Part III.

A Bill to consolidate and amend the law relating to Ports and Port-charges.

WHEREAS it is expedient to consolidate and amend the law relating to ports and port-charges; It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

Title, commencement and tent.

1. (1) This Act may [Act XII, be called the Indian 1875, ss. 1]
Ports Act, 1889; and

- (2) It shall come into force on the first day of April 1889.
- (3) It shall extend, save as otherwise appears from its subject or context,—
 - (a) to the ports mentioned in the first schedule, and to such parts of the navigable rivers and channels leading to such ports respectively as have been declared to be subject to Act XXII of 1855 (for the regulation of Ports and Port-dues) or to the Indian Ports Act, 1875;

- (b) to the other ports or parts of navigable rivers or channels to which the Local Government, in exercise of the power hereinafter conferred, extends this Act.
- (4) But nothing in this Act shall-
- (i) apply to any vessel belonging to, or in the service of, Her Majesty or the Government of India, or to any vessel of war belonging to any Foreign Prince or State, or
- (ii) deprive any person of any right of property or other private right, except as hereinafter expressly provided, or
- (iii) affect any law or rule relating to the customs or any order or direction lawfully made or given pursuant thereto;
- (5) And nothing in section 31 or section 32 shall apply to any port, river or channel to which the section has not been specially extended by the Local Government.
 - 2. (1) The enactments mentioned in the Act XII, second schedule are here- 1875, s. 8.1 by repealed to the extent

specified in the third column of that schedule.

- (2) All declarations, appointments, requisitions, orders and rules made, authorizations, directions and permissions given, prohibitions issued and notifications published under any of those enactments or under any enactment repealed by any of them shall, if in force at the commencement of this Act, be deemed, so far as may be, to have been made, given, issued and published under this Act: and
- (3) Any enactment or document referring to any such repealed enactment shall, so far as may be, be construed to refer to this Act or to the corresponding portion thereof.

3. In this Act, unless there is something repug-

nant in the subject or context,-

(1) "port" includes also any part of a river or channel in which this Act is for the time being in force:

(2) "port officer" is synonymous with master

attendant.

(3) "vessel" includes anything made for the conveyance by water of human beings or of pro-

perty:

(4) "master," when used in relation to any vessel, means, subject to the provisions of any vessel, means, subject to the provisions of any other enactment for the time being in force, any person (except a pilot or harbour-master) having for the time being the charge or control of the

(5) " pilot" means a person for the time being authorized by the Local Government to pilot

(6) " ton" means a ton as determined or determinable by the rules for the time being in force for regulating the measurement of the net

tonnage of British ships: and
(7) "Magistrate" means a person exercising
powers under the Code of Criminal Procedure, 1882, not less than those of a Magistrate of the second class, and includes, in the towns of Calcutta, Madras and Bombay, a Presidency Magistrate.

CHAPTER II.

POWERS OF THE LOCAL GOVERNMENT.

4. (1) With the previous sanction of the Governor. General in Power to extend or with-draw the Act or certain portions thereof. Council, the Local Government may, by notifi-cation in the official

Gazette,-

(a) extend this Act to any port in which this Act is not in force or to any part of any navigable river or channel which leads to a port and in which this Act is not in force

(b) specially extend the provisions of section 31 or section 32 to any port to which they

have not been so extended;

(c) withdraw this Act, or section 31 or section 32, from any port or any part thereof in which it is for the time being in force.

(2) A notification under clause (a) or clause (b) of sub-section (1) shall define the limits of the

area to which it refers.

(3) Limits defined under sub-section (2) may include any piers, jetties, landing-places, wharves, quays, docks and other works made on behalf of the public for convenience of traffic, for safety of vessels, or for the improvement, maintenance or good government of the port and its approaches, whether within or without high-water-mark, and, subject to any rights of private property therein, any portion of the shore or bank within fifty yards of high-water-mark.

(4) In sub-section (3) the expression "high-water-mark" means the highest point reached by ordinary spring-tides at any season of the year.

5. (1) The Local Government may, with the [Act XII, Alteration of limits of Governor General in Council and subject to

any rights of private property, alter the limits of any port in which this Act is in force.

(2) When the Local Government alters the

limits of a port under sub-section (1), it shall declare or describe, by notification in the official Gazette, and by such other means, if any, as it thinks fit, the precise extent of such limits.

6. (1) The Local Government may, in addition [Act XII; to any rules which it 1875, s. 7.] Power to make portmay make under any other enactment for the

time being in force, make such rules, consistent with this Act, as it thinks necessary for any of the following purposes, namely:

(a) for regulating the time at which, and the manner in which, vessels are to enter or leave any port subject to this Act;

(b) for regulating the berths, stations and anchorages to be occupied by vessels in any

such port;

(c) for striking the yards and top-masts, and for rigging-in the booms and yards, of vessels in any such port, and for swing-ing or taking-in davits, boats and other

things projecting from such vessels;
(d) for the removal or proper hanging or placing of anchors, spars and other things being in or attached to vessels in any such

(e) for regulating vessels whilst taking-in or [Partly new.] discharging passengers, ballast or cargo, or any particular kind of cargo, in any such port, and the stations to be occupied by vessels whilst so engaged;

(f) for keeping free passages of such width as may be deemed necessary within any such port, and along or near to the piers, jetties, landing-places, wharves, quays, docks, moorings and other works in or adjoining to the same, and for marking out the spaces so to be kept free;

(y) for regulating the anchoring, fastening, mooring and unmooring of vessels in

any such port;

(h) for regulating the moving and warping of all vessels within any such port and the use of warps therein;

(i) for regulating the use of the mooring buoys, chains and other moorings in any such port;

(j) for fixing the rates to be paid for the use of such moorings when belonging to the Government, or of any boat, hawser or other thing belonging to the Govern-

(k) for licensing and regulating catamarans [Partly new.] plying for hire, and flats and cargo, passenger and other boats plying, whether for

hire or not and whether regularly or only occasionally in, or partly within and partly without, any such port, and for determining the quantity of cargo or number of passengers to be carried by any such vessel;

(1) for regulating the use of fires and lights

within any such port;

(m) for enforcing and regulating the use of signals or signal-lights by vessels by day or by night in any such port;

(n) for regulating the number of the crew which must be on board any vessel afloat within the limits of any such port;

(o) for regulating the employment of persons engaged in cleaning or painting vessels, or in working in the bilges, boilers or double bottoms of vessels, in any such port; and

(p) for regulating the action to be taken by a master where there is disease or sickness, or a dead body, on board his vessel in any

such port.

The power to make rules under sub-section (1) is subject to the condition of the rules being made after previouss publication:

Provided that nothing in this sub-section shall be construed to affect the validity of any rule in force immediately before the commencement of this Act and continued by section 2, sub-section (2).

CHAPTER III.

PORT-OFFICIALS AND THEIR POWERS AND DUTIES.

7. (1) The Local Government shall appoint some officer or body of Appointment of conserpersons to be conservator of every port subject to this Act, and may suspend or remove such officer

or body.

(2) Subject to any direction by the Local Government to the contrary,-

(a) in ports where there is a port-officer, the port-officer shall be the conservator :

- (b) in ports where there is no port-officer, but where there is a harbour-master, the harbour-master shall be the conservator.
- (3) Where the harbour-master is not conservator, the harbour-master and his assistants shall be subordinate to, and subject to the control of, the conservator.
- (4) The conservator shall be subject to the control of the Local Government, or of any intermediate authority which that Government may appoint.

8, (1) The conservator of any port subject to

this Act may, with re-Power of conservator to spect to any vessel within give and enforce directions for certain specified purthe port, give directions for carrying into effect section 6.

- (2) If any person wilfully and without lawful excuse refuses or neglects to obey any lawful direction of the conservator, after notice thereof has been given to him, he shall, for every such offence, be punished with fine which may extend to one hundred 'rupees, and with further fine which may extend to one hundred rupees for every day on which, after such notice as aforesaid, he wilfully and without lawful excuse continues to disobey the direction.
- (3) In case of such refusal or neglect, the conservator may do, or cause to be done, all acts necessary for the purpose of carrying the direction into execution, and may hire and employ proper persons for that purpose, and all reasonable expenses incurred in doing such acts shall be recoverable by him from the person so refusing or neglecting to obey the direction.
- 9. The conservator of any such port may, in [Act XII, case of urgent necessity, 1675, s. 10.] Power to cut warps and cut, or cause to be cut, ropes. any warp, rope, cable or hawser endangering the safety of any vessel in the port or at or near to the entrance thereof.
- 10. (1) The conservator may remove, or cause [Act XII, to be removed, any tim-1875, s. 11.] Removal of obstructions within limits of port. ber, raft or other thing, floating or being in any part of any such port, which in his opinion obstructs or impedes the free navigation thereof or the lawful use of any pier, jetty, landing-place, wharf, quay, dock, mooring or other work on any part of the shore or bank which has been declared to be within the limits of the port and is not private property.
- (2) The owner of any such timber, raft or other thing shall be liable to pay the reasonable expenses of the removal thereof, and if such owner or any other person has without lawful excuse caused any such obstruction or impediment, or causes any public nuisance affecting or likely to affect such free navigation or lawful use, he shall also be punished with fine which may extend to one hundred rupees.
- (3) The conservator or any Magistrate having jurisdiction over the offence may cause any such nuisance to be abated.

and the master of such vessel shall, upon demand, pay such reasonable expenses as may be incurred in clearing the same.

(2) Any master or other person offending against the provisions of this section shall, for every such offence, be punished with fine which may extend to one hundred rupees.

14. (1) If any vessel is wrecked, stranded or sunk in any such port. Raising or removal of wreck impeding naviga-tion within limits of port, so as to impede, or be likely to impede the navigation thereof, the conservator may cause the vessel to be raised, removed or destroyed.
