PART V.

PROCEEDINGS OF THE LEGISLATIVE DEPARTMENT, BOMBAY.

The following Bill, together with the Statement of Objects and Reasons accompanying it, is published in accordance with Rule 15 of the Rules for the conduct of Business at Meetings of the Council of His Excellency the Governor of Bombay for making Laws and Regulations :—

Bill No. 3 of 1884.

A Bill to amend the Bombay Hereditary Offices Act so far as it relates to Matadárs.

WHEREAS some portions of the Bombay Hereditary Offices Act are found to be unsuited to matádárs, and 'it is therefore expedient to amend the said Act and to enact special provisions for the regulation of the service of matádárs: It is enacted as follows:

Short title.

1. This Act may be cited as "The Matádárs Act, 1884."

It extends to the districts of Ahmedabad, Kaira, Broach and Extent. Surat; but the Governor in Council may, from time to time, by notification in the Bombay Government Gazette, extend its provisions to any village in the Panch Maháls district. It shall come into force at once: Commencement. Provided that every appointment to any patel's office to which this Act applies, made under the provisions of the Bombay Hereditary Offices Act and still in force, Bo III. of shall hold good: 1874.

- (a) until the time when, if this Act had not been passed, such appointment would become vacant or until the expiry of two years from the coming of this Act into force, whichever first occurs, or
- (b) in the case of an appointment which has been made to have effect pending further orders, until such time not exceeding two years from the coming

- (a) the number of distinct matas in the village separately recognized in the Collector's records;
- (b) the name of the representative matádárs of each mata to which a right to hold the office of patel attaches :
- (c) the name of every other matadár directed by the Collector to be entered in the register under section 7 or 9;
- (d) where there are more representative matádárs than one, the order of rotation in which, failing the appointment of an officiator by election, the right to the patel's office is to vest in the said representative matádárs ;
- (e) the number of persons required to officiate as patels contemporaneously;
- (f) a description of the service lands held by the matadárs, showing the area, survey numbers and the assessment thereof, together with the quit-rent, if any, payable and the net amount of revenue alienated by Government:

- (a) if, for any village, no such list exists, or if, in respect of any mata, no matádár's name has been entered in any such list, or if, at the time when this Act comes into force, there is any dispute pending as to the completeness or correctness of any such entry, the Collector shall hold a summary inquiry and shall enter in the register the name of each person who shall appear to him to have been recognized in the records previous to the year 1867 as a matádár of any mata for which such list or entry is wanting or to which such dispute relates;
- (b) if any person whose name should be entered in the register in accordance with any of the foregoing provisions is dead, the name of his nearest heir or of the senior heir, if there are two or more of equal degree, shall be entered in the register instead of his.

(2.) For every such mata of which there is only one registered matádár, the said registered matádár shall be the representative matádár.

- (3.) If there are two or more registered matádárs of any such mata, the Collector shall, as soon as may be after the passing of this Act, by written notice require the said registered matádárs to assemble in his presence for the purpose of determining which of them shall be the representative matádár of the mata.
- (4.) If a majority of the said registered matádárs present in accordance with the said notice agree to the nomination of one of their number to be the representative matádár of the mata, the Collector shall enter the name of the person so nominated in the said register accordingly.
- (5.) If a majority of the said registered matádárs do not agree as aforesaid, the Collector shall enter in the said register as representative matádár of the mata such one of the said registered matádárs as shall appear to him to be the senior male member, or, if there is no male member, the senior female member of the family or of the branch of a family to which the mata belongs.

STATEMENT OF OBJECTS AND REASONS.

The provisions of the Bombay Hereditary Offices Act III. of 1874 are unsuitable to the case of the matádári village watans in Gujarát, because that Act restricts the recognition of watandárs as "representative watandárs" entitled to office in their own right to those who are recorded as heads of families which have actually served, whereas it is admitted to be the custom of matadár watans that all registered matadárs have the right of service, whether they or their ancestors have actually served or not. This Bill has, therefore, been drafted to extend to all registered matadars the rights secured to representative watandárs by Section 40 of Act III. Under Section 14 of the Bill the registered matádárs will exercise the right of election confined to representative watandárs by Section 40 of Act III., but the nomination will be by a majority and not unanimous. On failure of election or nomination, the right to officiate The representative vests in the representative matadár whose turn it is. matádárs are determined by the vote of a majority of registered matádárs in favour of one of their number, failing which the senior male member of the family to which the mata belongs will be registered as representative matadár. If there are two or more representative matadárs in a village, their order of rotation as officiators may be determined by vote of a majority of the representative matadárs, failing which it will be determined by the Collector by lot and not by his own discretion. By Section 6 power is given to the Governor in Council to deal with cases, known to exist, in which though there are two or more matás in a village, the right to the patel's office is found to attach exclusively to one mata. The Bill also makes suitable provision for the term of office, regulates the appointment of deputies, gives a full definition of the disqualifications for the patel's office, and generally substitutes clearer provisions for those sections of Bombay Act III. of 1874 which are repealed so far as affects matádárs.
