The following Bill was introduced into the Council of the Governor General of India for the purpose of making Laws and Regulations on the 7th March 1884, and was referred to a Select Committee:—

#### Bill No. 3 of 1884.

A Bill to amend the Negotiable Instruments Act, 1881.

XXVI of 1881

WHEREAS it is expedient to amend the Negotiable Instruments Act, 1881, in manner hereinafter appearing; It is hereby enacted as follows—

Short Title.

1. This Act may be called the Negotiable Instruments Act, 1884.

  - (b) the last twelve words are repealed.

- 4. In the same Act, section 113, after the Amendment of section words "the person so paying," the words "or his agent in that behalf" shall be inserted.
- 5. After Chapter XVI. of the same Act,

  New chapter added to the following shall be inserted:—

#### "CHAPTER XVII.

" NOTARIES PUBLIC.

Power to appoint no. from time to time, by notification in the official Gazette, appoint any person, by name or by virtue of his office, to be a notary public under this Act and to exercise his functions as such within any local area, and may, by like notification, remove any person so appointed.

The opportunity has been taken to supply certain defects in the Negotiable Instruments Act regarding the appointment and control of notaries public, and to make it clear that a person may be appointed a notary by name or by virtue of an office held by him; that he may be appointed for a limited area and may be removed from his office; and further that rules may be made for the guidance and control of notaries appointed under the Act and may, among other matters, fix the fees payable to such notaries.

  New chapter added to the following shall be inserted:—

#### "CHAPTER XVII.

" NOTARIES PUBLIC.

"138.
