PART V.

PROCEEDINGS OF THE LEGISLATIVE DEPARTMENT, BOMBAY.

The following Report of the Select Committee of the Council of His Excellency the Governor of Bombay on the "Bill to amend the Law for the periodical inspection and the management by competent Engineers of Boilers and Prime Movers in the Presidency of Bombay," and the Bill as amended by the Select Committee are, in accordance with Rule 25 of the Rules for the Conduct of Business at Meetings of the Council, published for general information:—

Report of the Select Committee appointed to consider Bill No. 6 of 1886 (a Bill to amend the Law for the periodical inspection and the management by competent Engineers of Boilers and Prime Movers in the Presidency of Bombay).

We, the Committee appointed to consider the Bombay Boiler Inspection Bill, have the honour to report as follows—

- 2. The Bill has been published in English on 6th August 1886, but the only representation received regarding it is one from the Bombay Millowners' Association dated 13th September 1886.
- 3. We have carefully considered the suggestions made by the Association and have adopted most of them.
- 4. We have retained the definition of "boiler" contained in Bombay Act V. of 1873, which appears to be sufficient for the purpose, and is not open to the objections taken by the Association to the more extended definition used in the English Statute.
- 5. We have not thought it desirable to empower the Millowners' Association to nominate members of the Commissions appointed under Section 5, or of the Board of Examiners appointed under Section 17. But we

would suggest that Government might perhaps ask the Association from time to time to submit the names of persons considered by it to be best qualified for such Commissions or Board, and that in making appointments under Sections 5 and 17 Government might have regard to the views expressed by the Association.

- 6. We have made additions to Sections 6, 7, 17 and 25, in order to meet the wishes of the Association.
- 7. We have also, as suggested by that body, struck out the proviso to Section 23, because it may fairly be presumed that persons who obtained a certificate under Section 17 of Bombay Act V. of 1873, on the ground of efficient service rendered previously to the passing of that Act, are practically efficient after thirteen more years of service and experience. We do not, however, think it desirable to revive the provisions contained in the said Section 17, and which has been very strongly condemned on grounds which appear to us to be sound, by the Examiners appointed under the existing Act. We have not, therefore, adopted the suggestion of the Association that certificates should be granted, without examination, to men who could show that they had successfully worked engines in England for two years.
- 8. As desired by the Association, we have omitted from Section 31 the proposal to charge an annual rate on machinery and works, and have retained the present system of levying a fee for each boiler examined. We have redrafted Section 9 and amended Sections 10 and 11 in harmony with this alteration. The maximum fees prescribed by us are in excess of those laid down in Schedule A of Bombay Act V. of 1873: but there has hitherto been an annual deficit in the working of the Act: and although Government doubtless do not desire to make any profit, there is no reason why they should be subjected to loss. It is probable that the additional revenue derived from the inspection of small boilers will render it unnecessary to raise the fees to the maximum limit allowed by the schedule.
- 9. We agree with the Association that it is undesirable to allow Inspectors to receive consultation fees, and we have, therefore, omitted the provision to that effect in Section 31.
- 10. The Association object to the power reserved to Government by Section 33 to extend the provisions of the Act to prime movers. But it must be remembered that the existing Act does extend to prime movers, and that there is considerable difference of opinion as to the advisability of exempting prime movers from inspection. The Bill proposes to meet the wishes of the Association so far as to try the experiment: but it seems prudent to reserve to Government the power of ordering the inspection of prime movers in any place in which it may be found necessary. It may not be necessary in the large and well managed factories with which the Millowners' Association is concerned: but there may not be the same security against accidents from defective machinery in small factories in the Mofussil.

A Bill to amend the Law for the periodical inspection and the management by competent Engineers of Boilers and Prime Movers in the Presidency of Bombay.

Whereas it is expedient to amend the law for the inspection Preamble. and management of steam-boilers, and of prime movers; It is enacted as follows :-

Preliminary.

1. This Act may be cited as "The Bombay Boiler In-Short Title. spection Act, 1887."

If any notice given under this section relates to two or more boilers used for working one Engine, the inspection of each such boiler shall be fixed to take place on a separate date.

Every person giving a notice under this section shall simultaneously pay the fees prescribed for the inspection by a rule made under section 31.

(f) prescribing the qualifications to be required of candidates at the said examinations, the fees to be paid by them, the forms of the certificates to be granted to them, and the capacity or kind of boiler of which each such certificate shall qualify the holder thereof to be in charge.
